DESCRIPTION

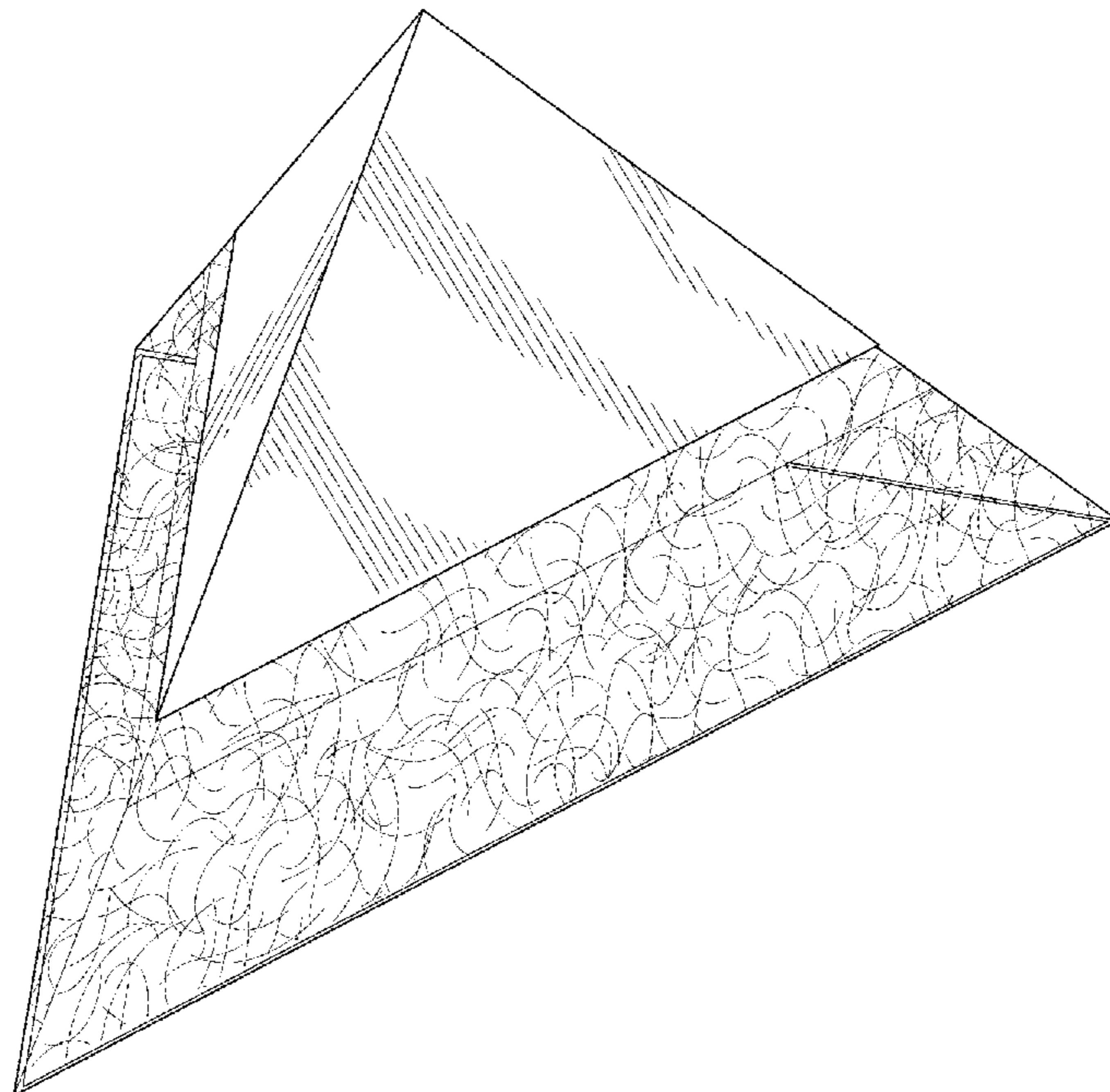
FIG. 1 is front perspective view of a corner cone in accordance with the present invention;

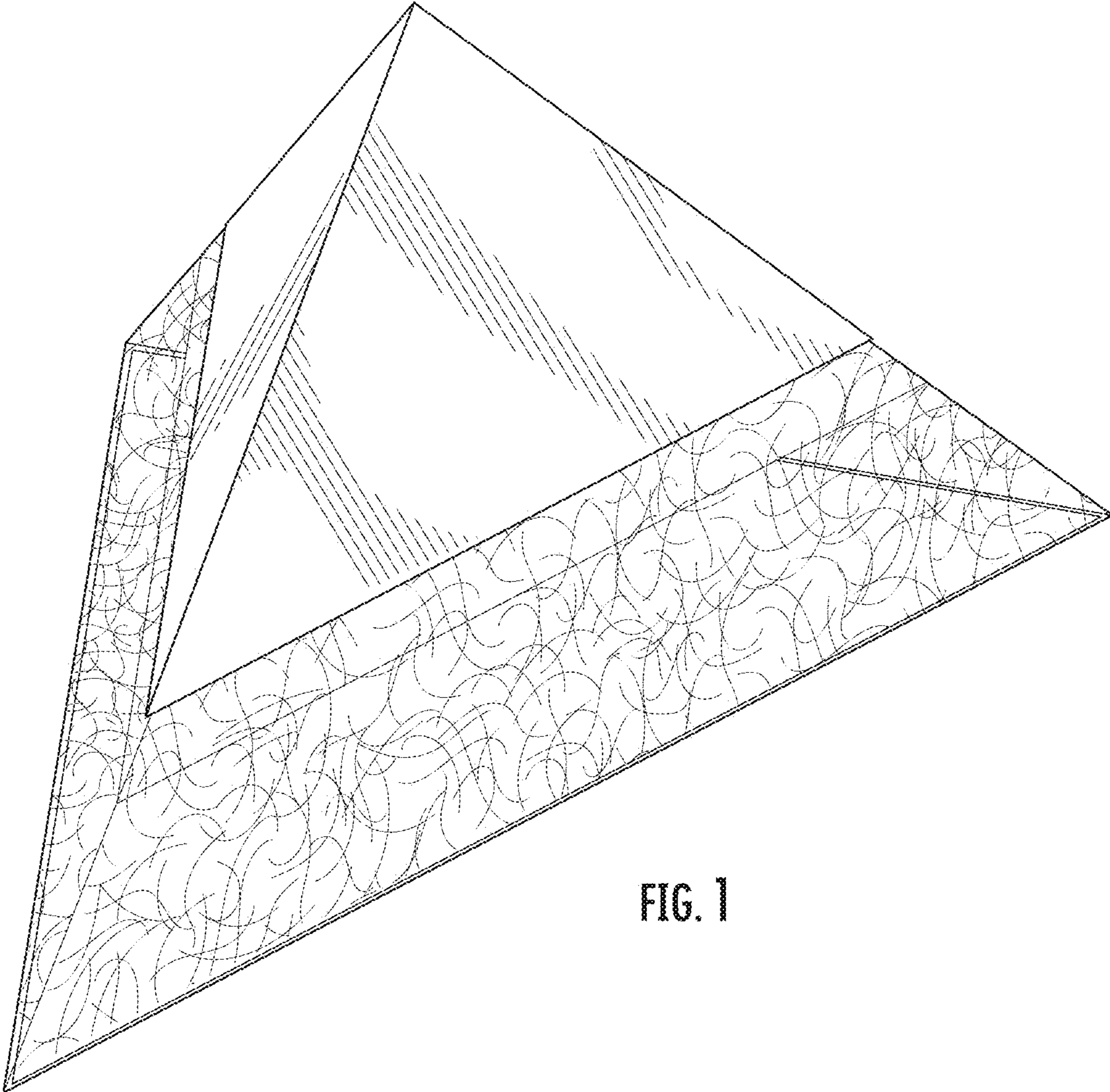

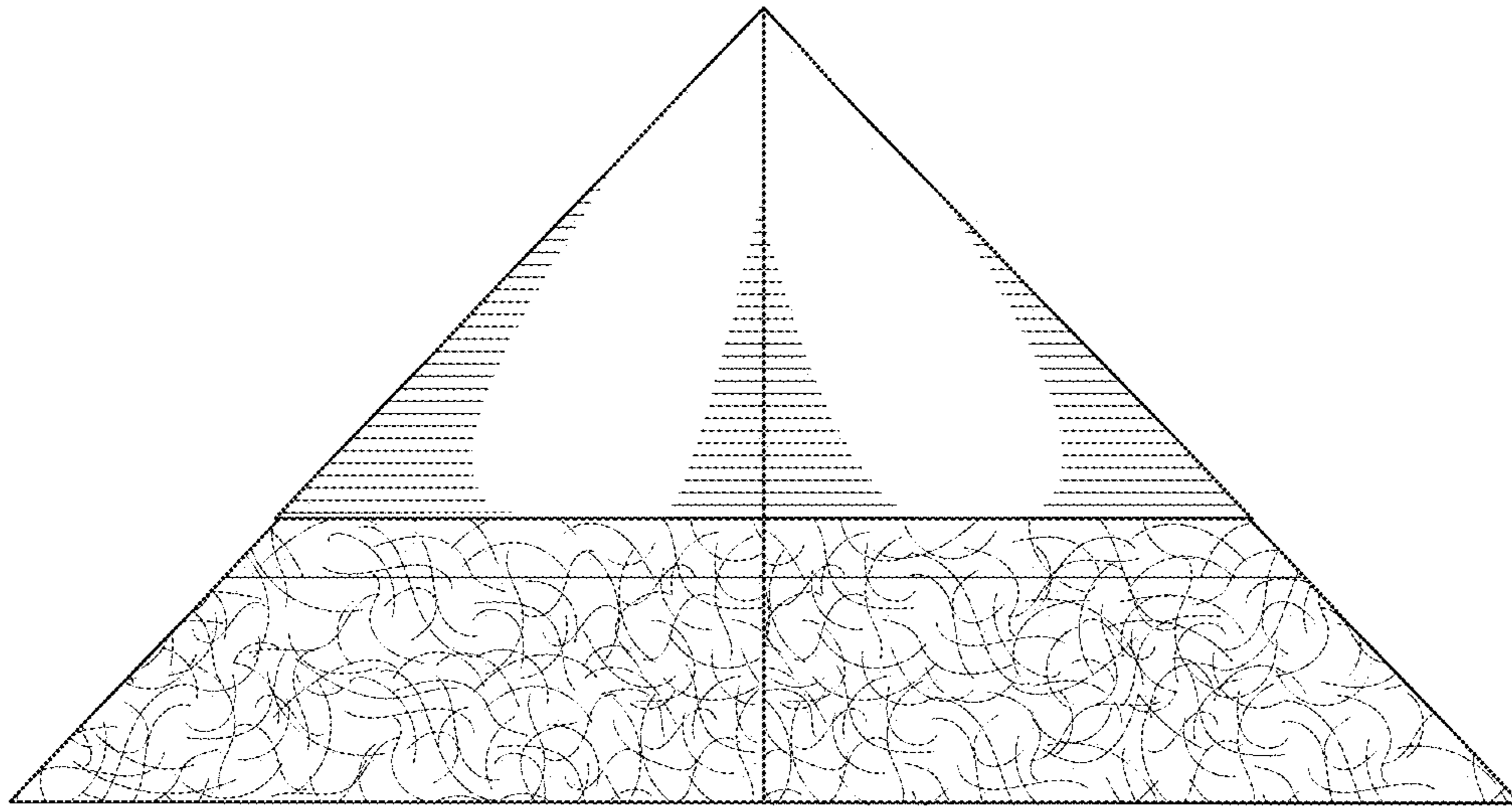

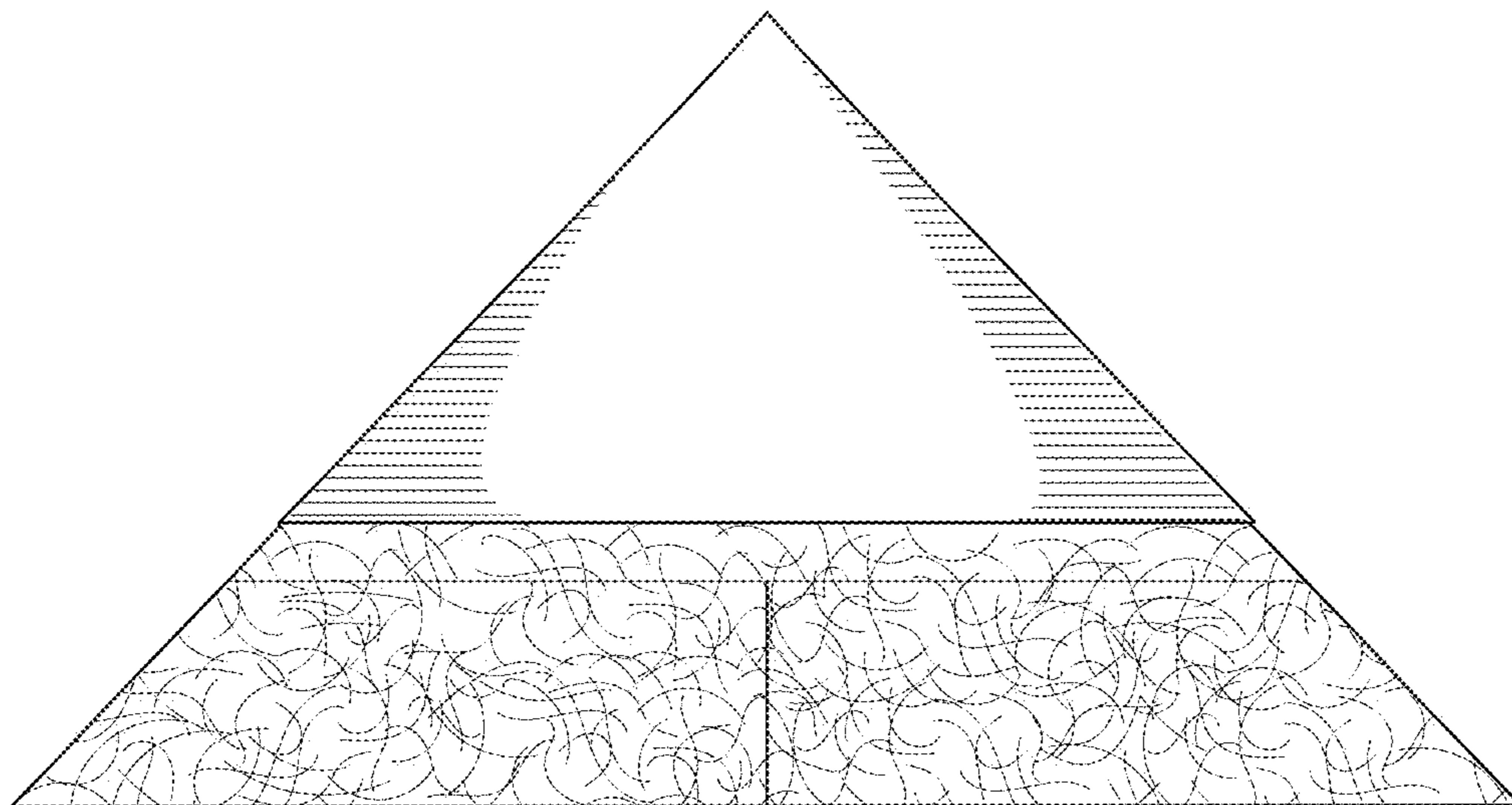

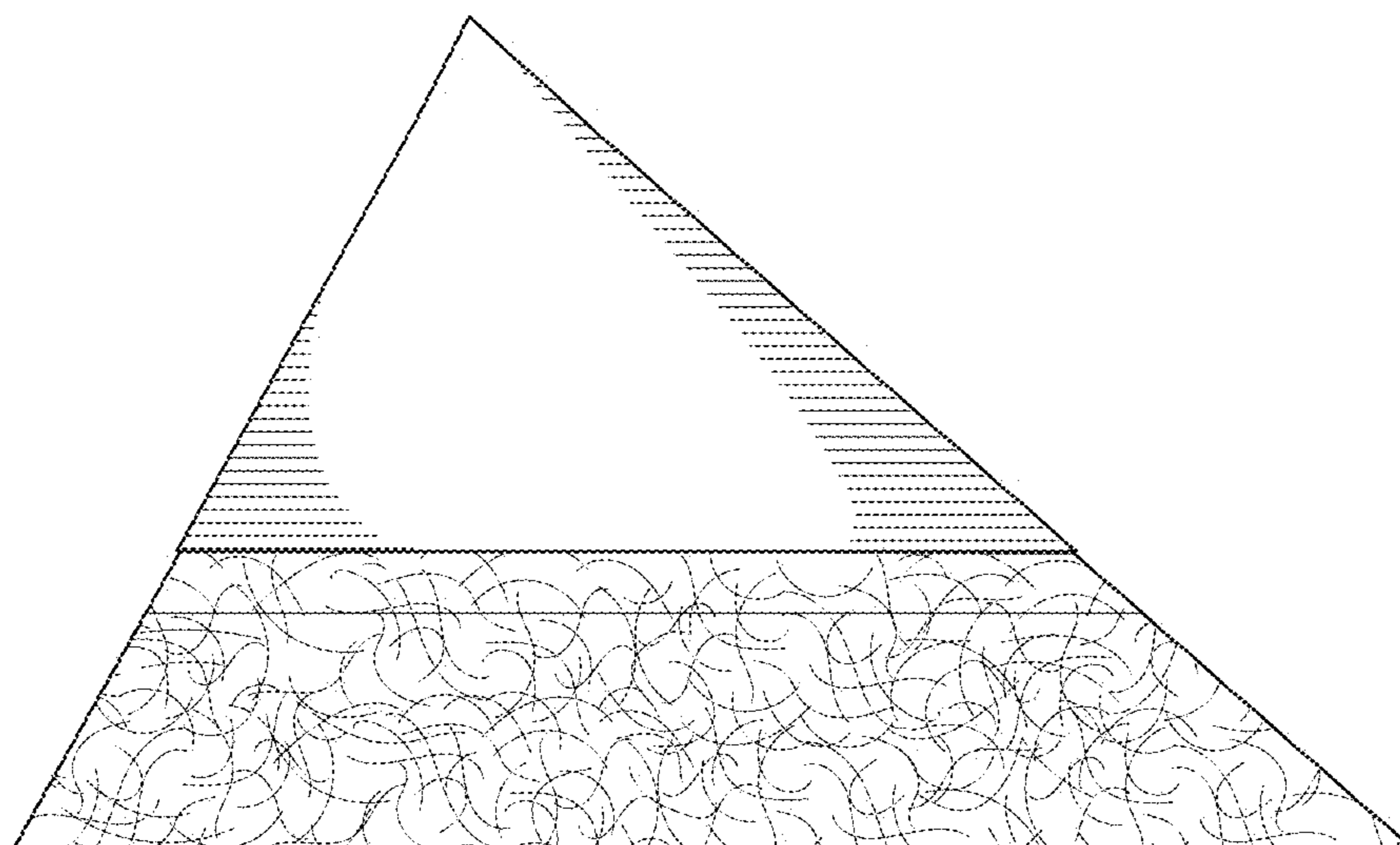

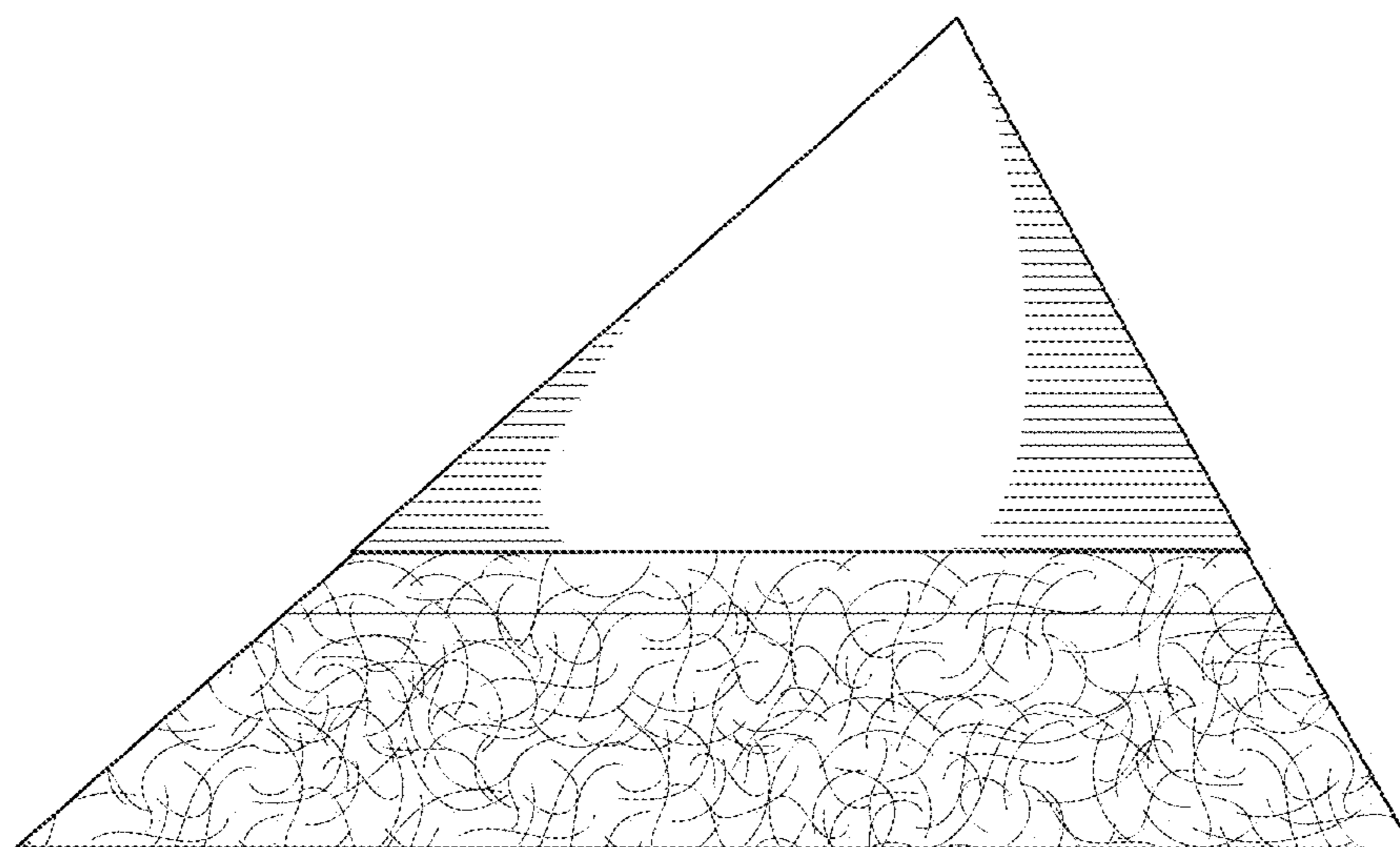

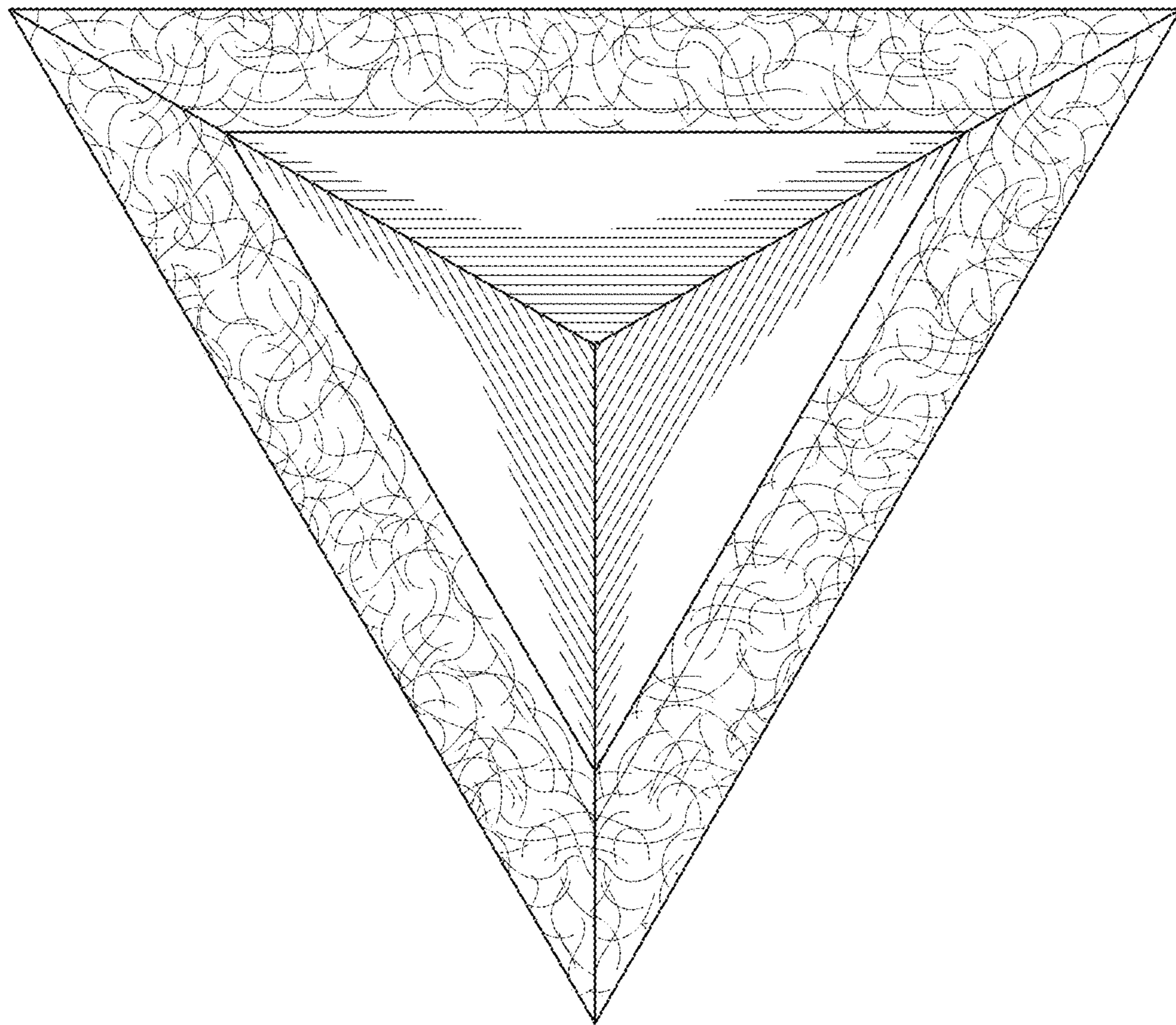

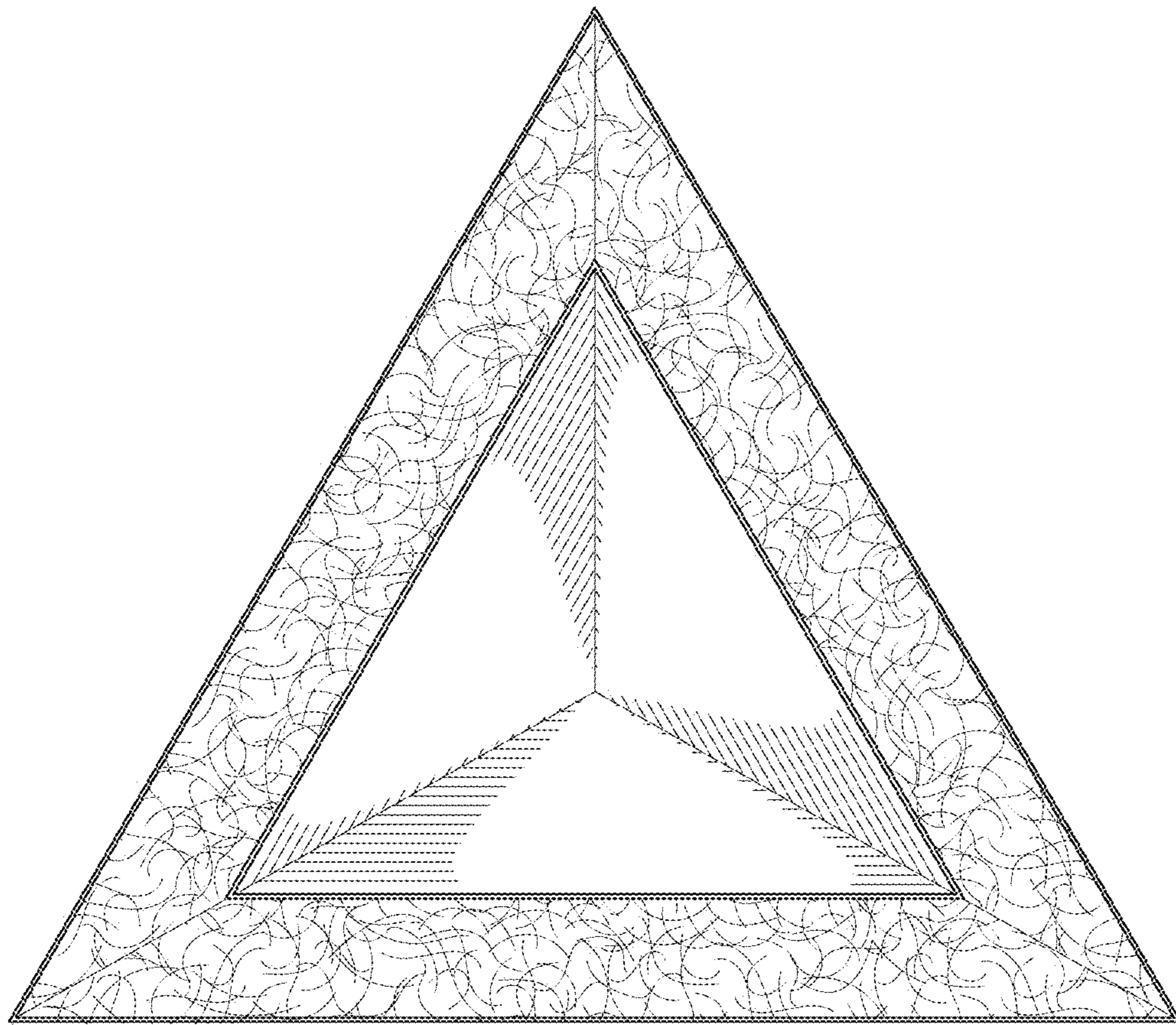
