**DESCRIPTION**

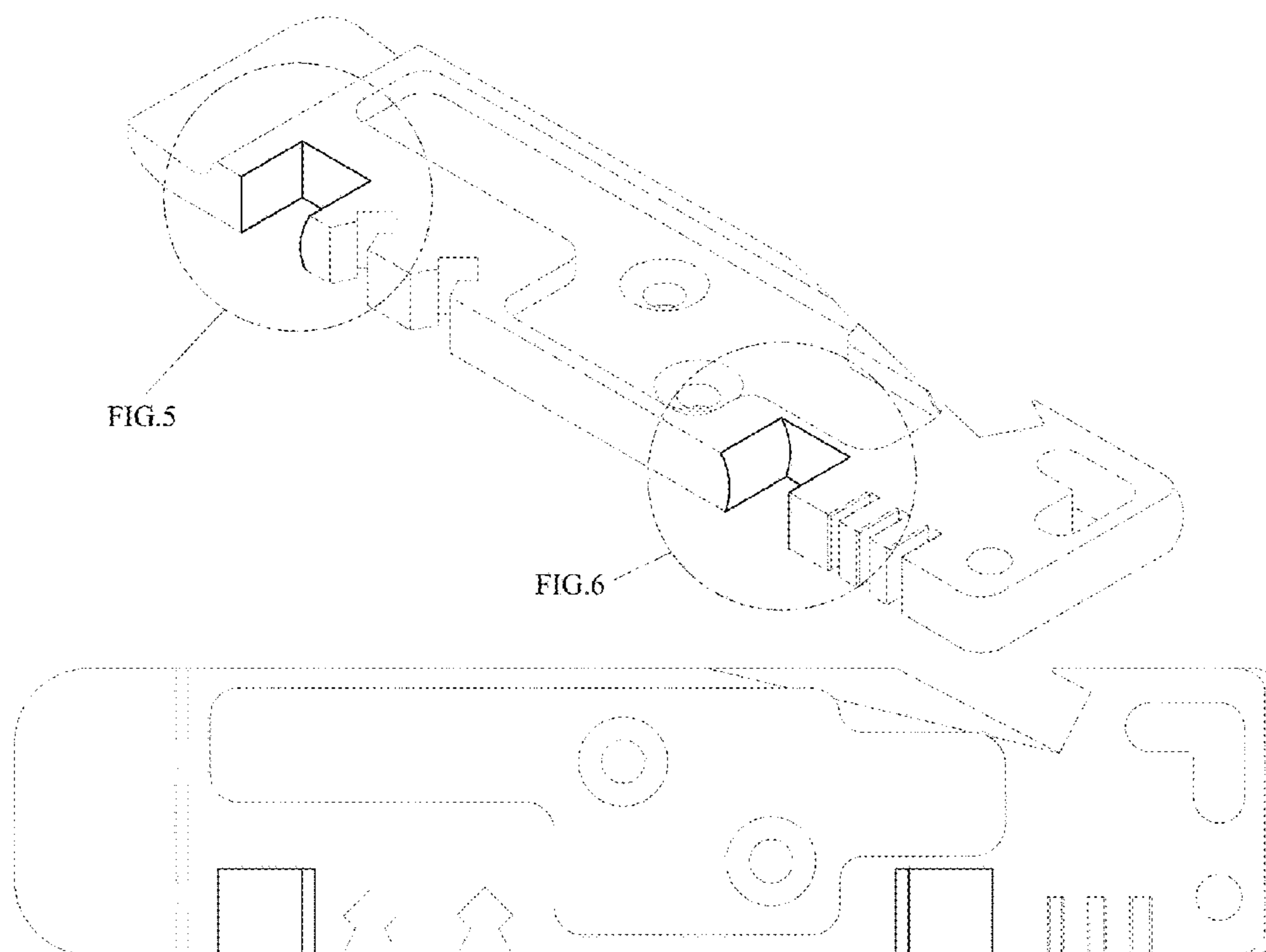
FIG. 1 is a perspective view of a bicycle tool, showing my new design;

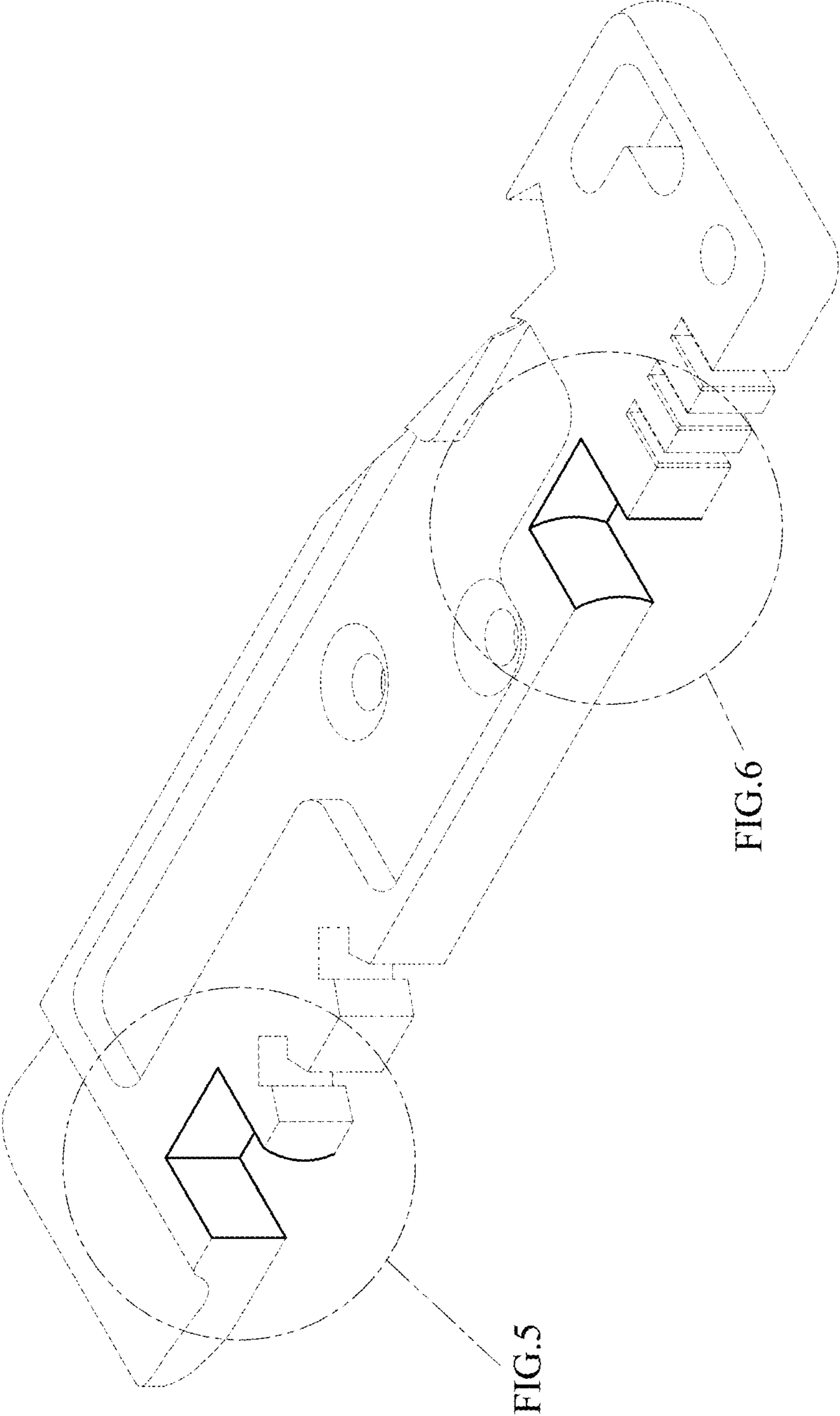

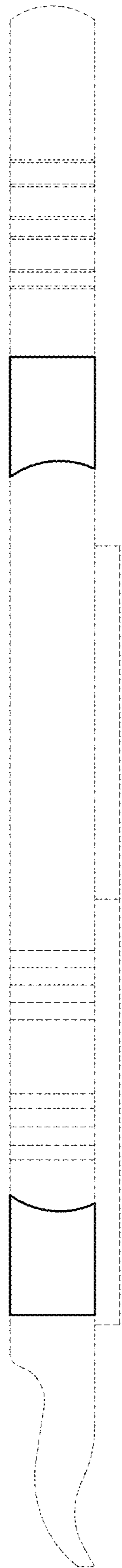

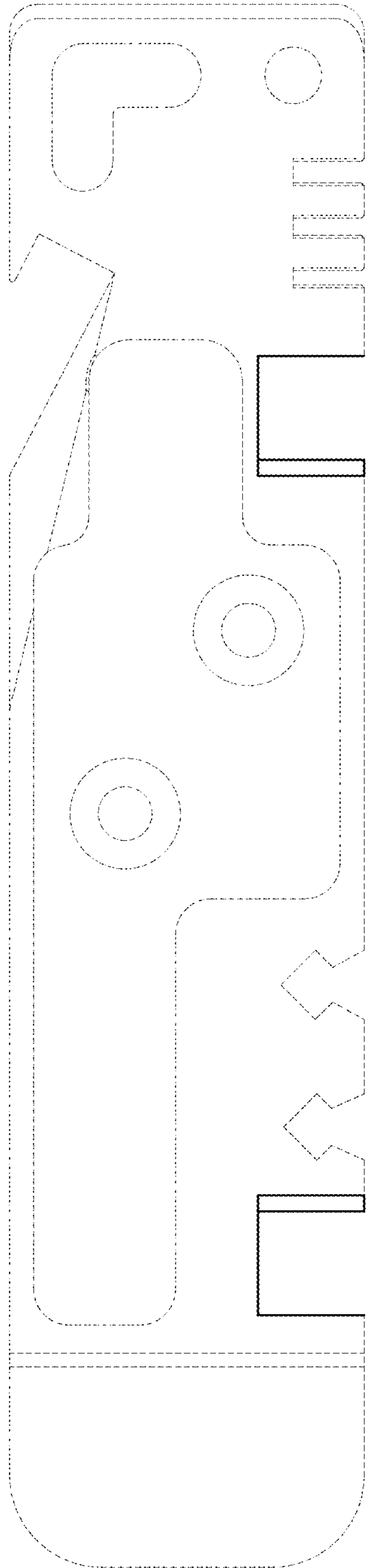

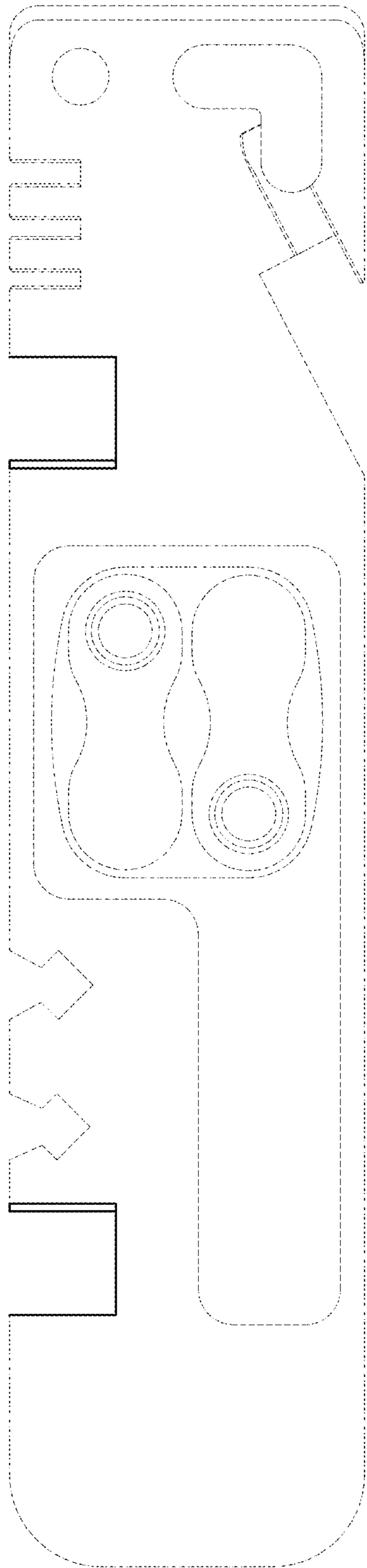

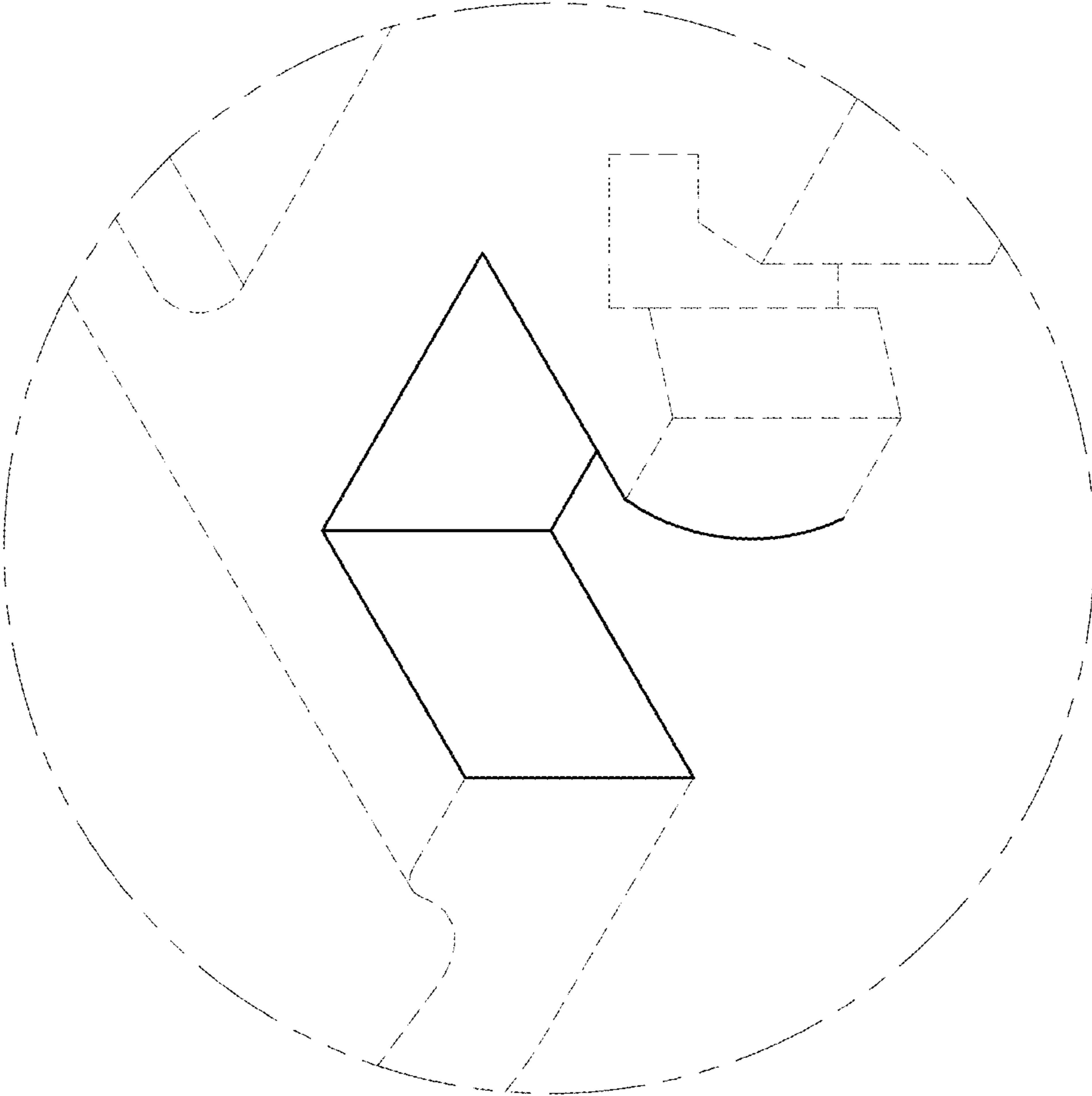

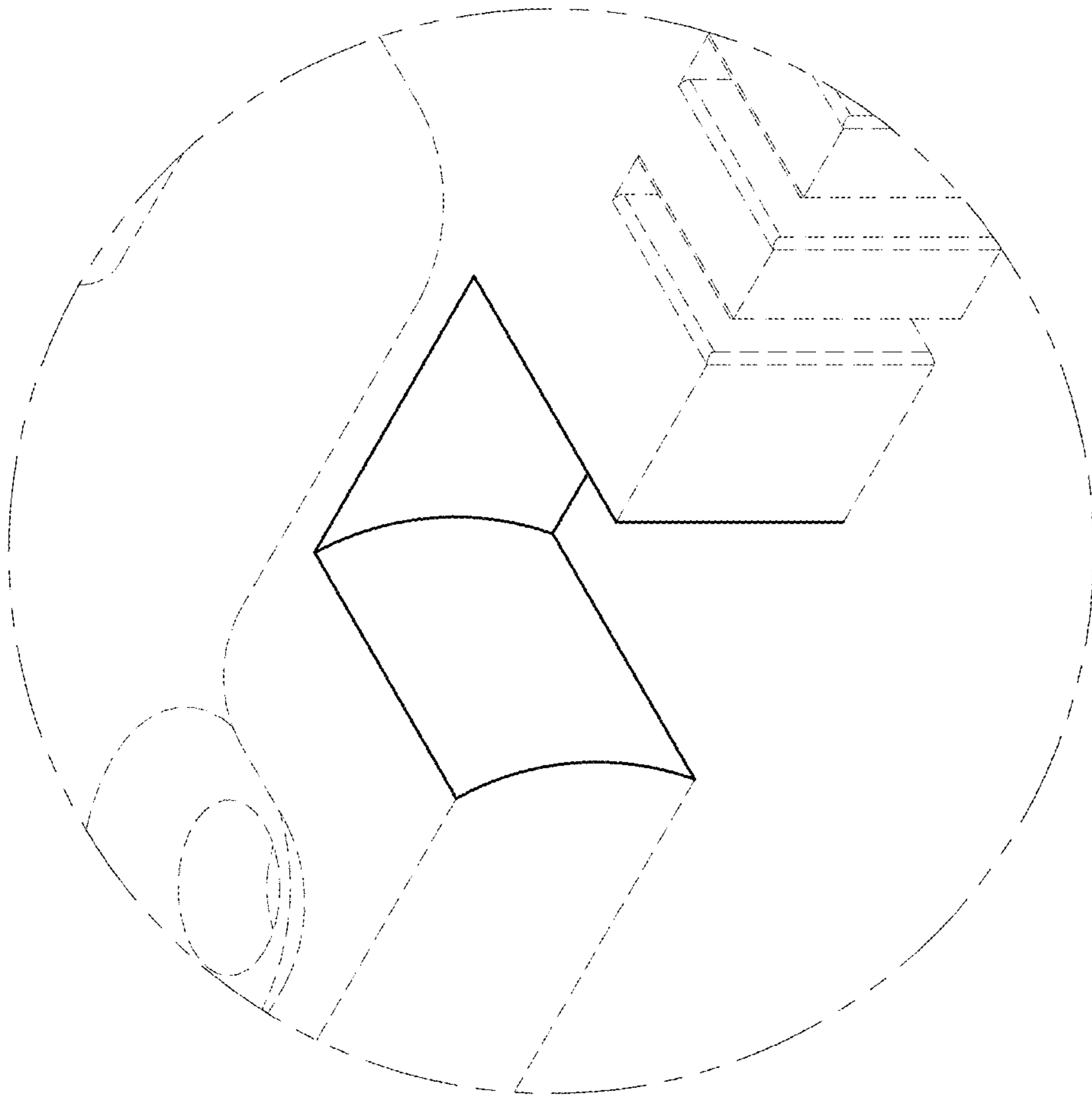

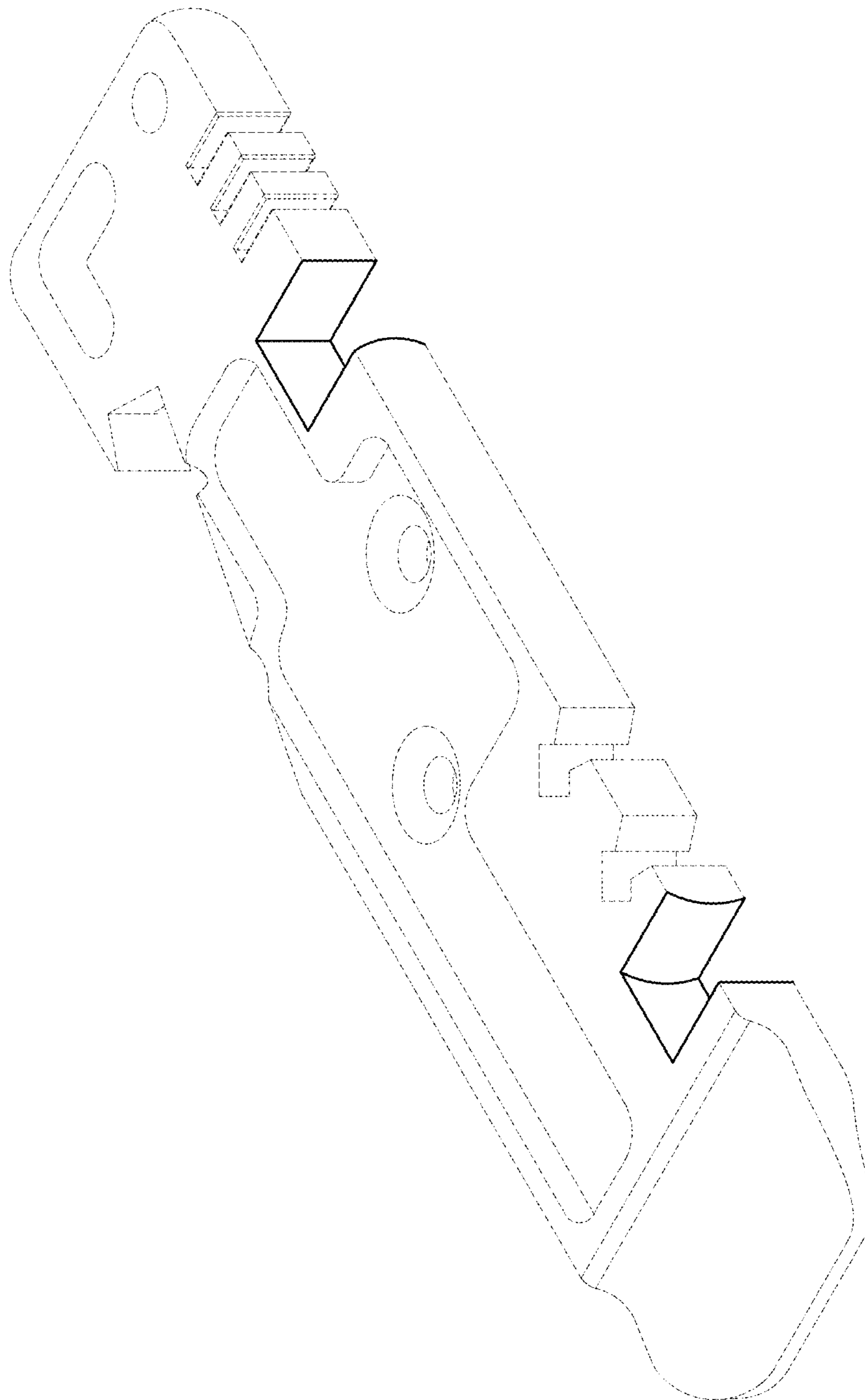
