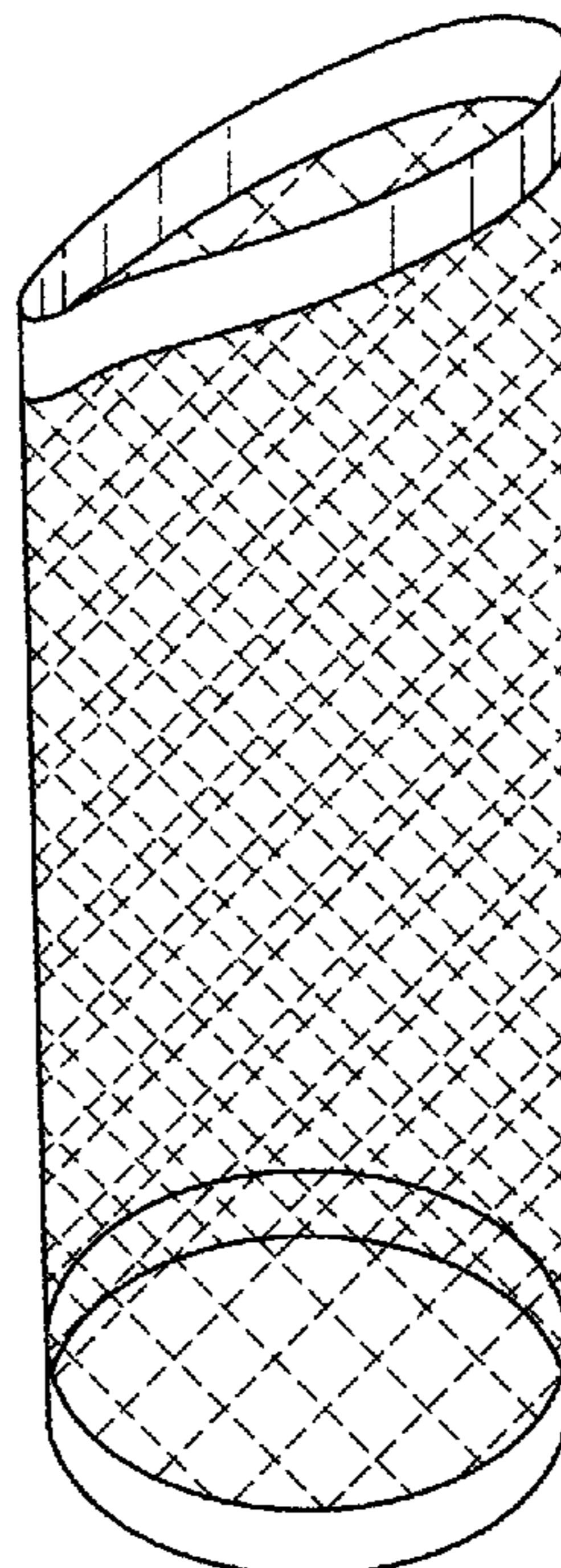
(57) **CLAIM**

The ornamental design for a decorative sleeve for spray bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a decorative sleeve for spray bottle showing my new design; FIG. 2 is a left side view thereof; FIG. 3 is a right side view thereof; FIG. 4 is a top view thereof; FIG. 5 is a bottom view thereof; FIG. 6 is a front view thereof; FIG. 7 is a back view thereof; and, FIG. 8 is a perspective view thereof with an illustration of the environment of fitting with a spray bottle. 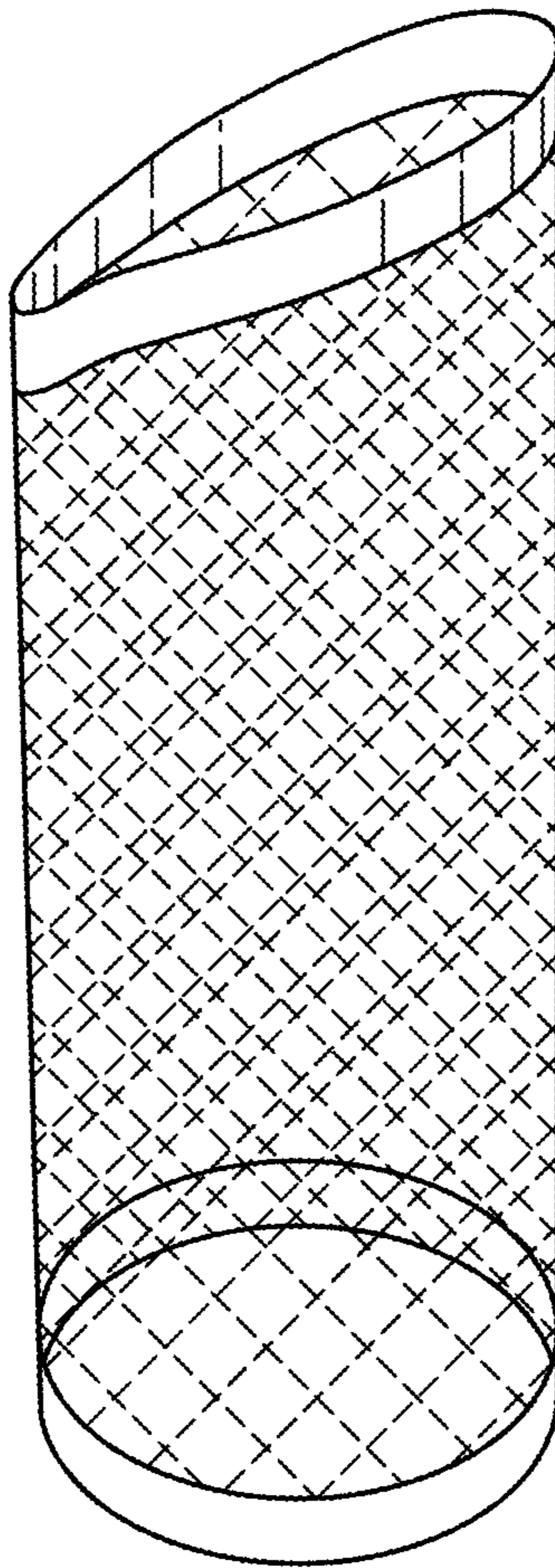

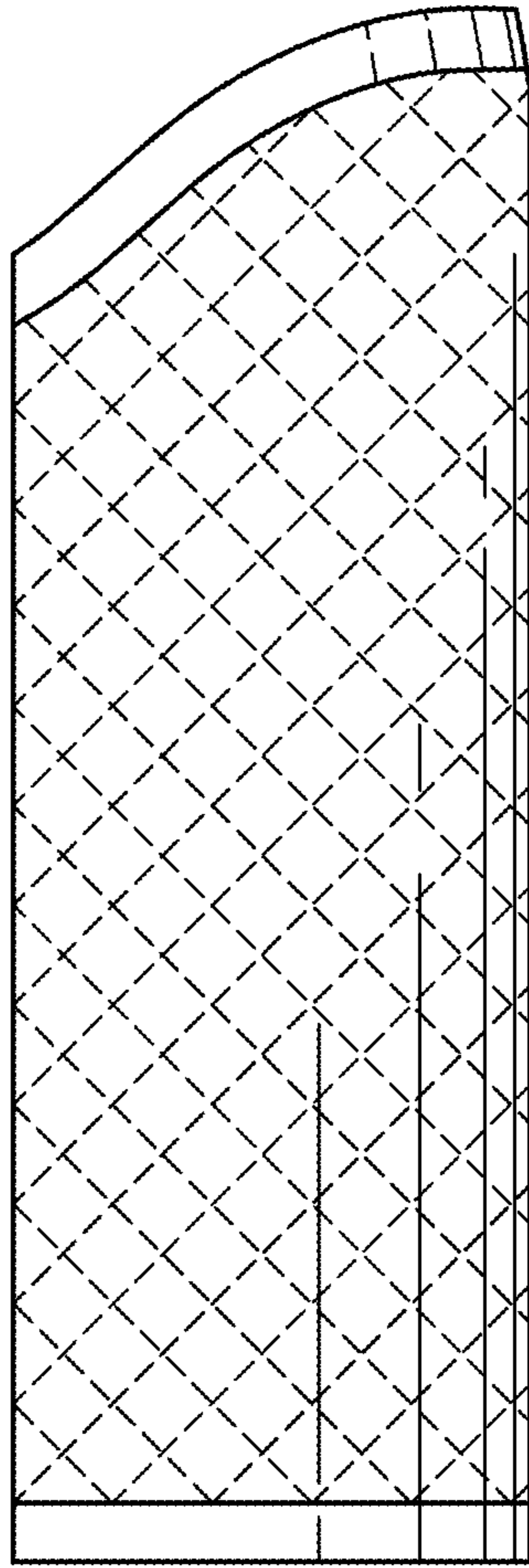

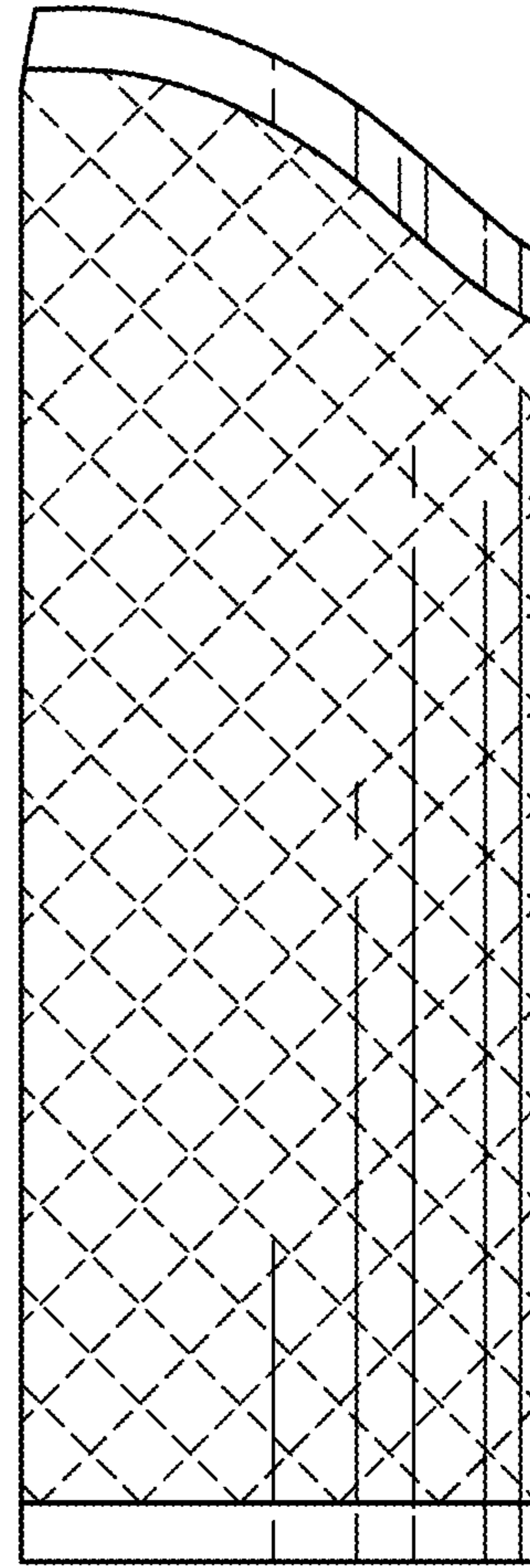

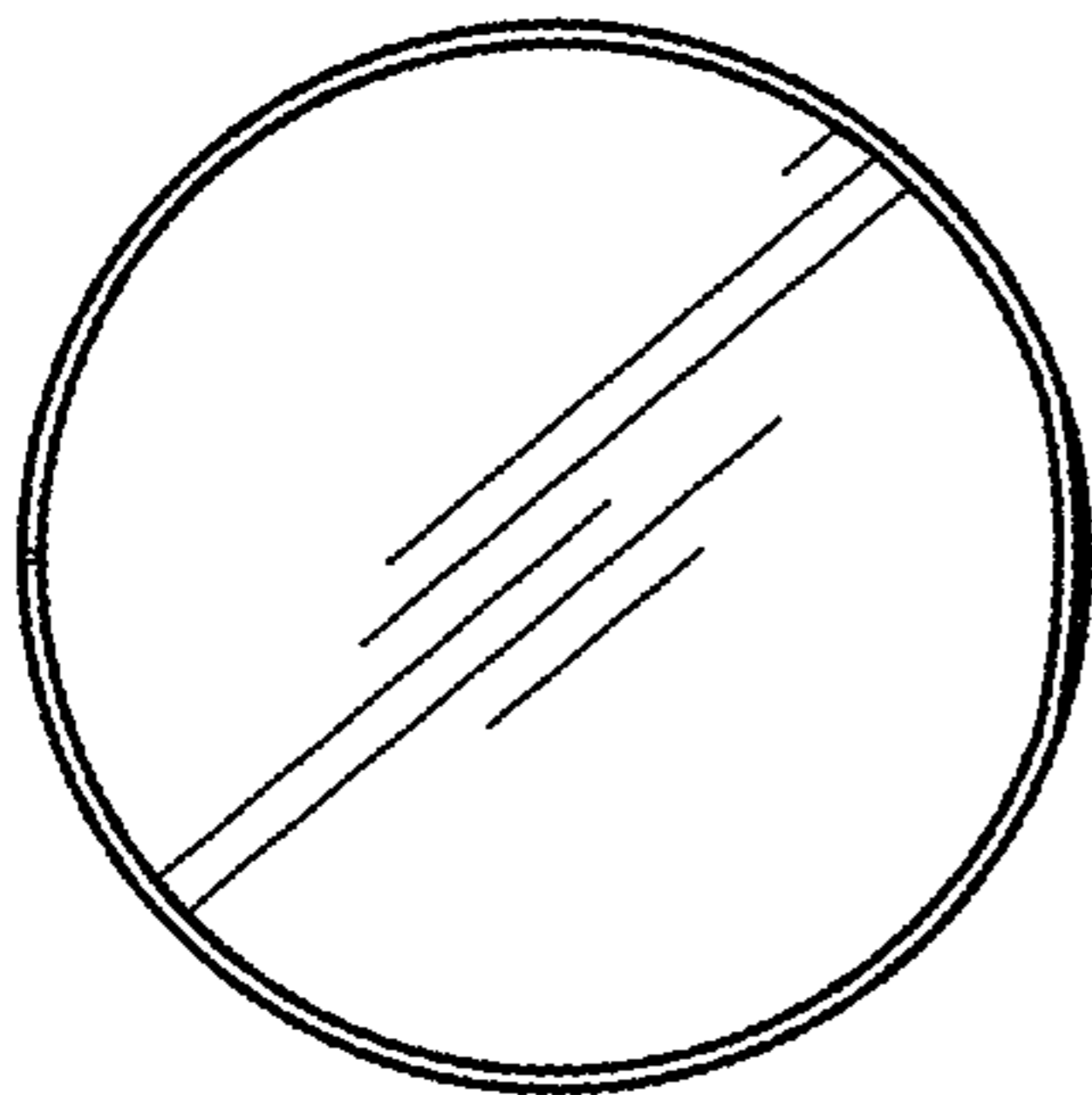

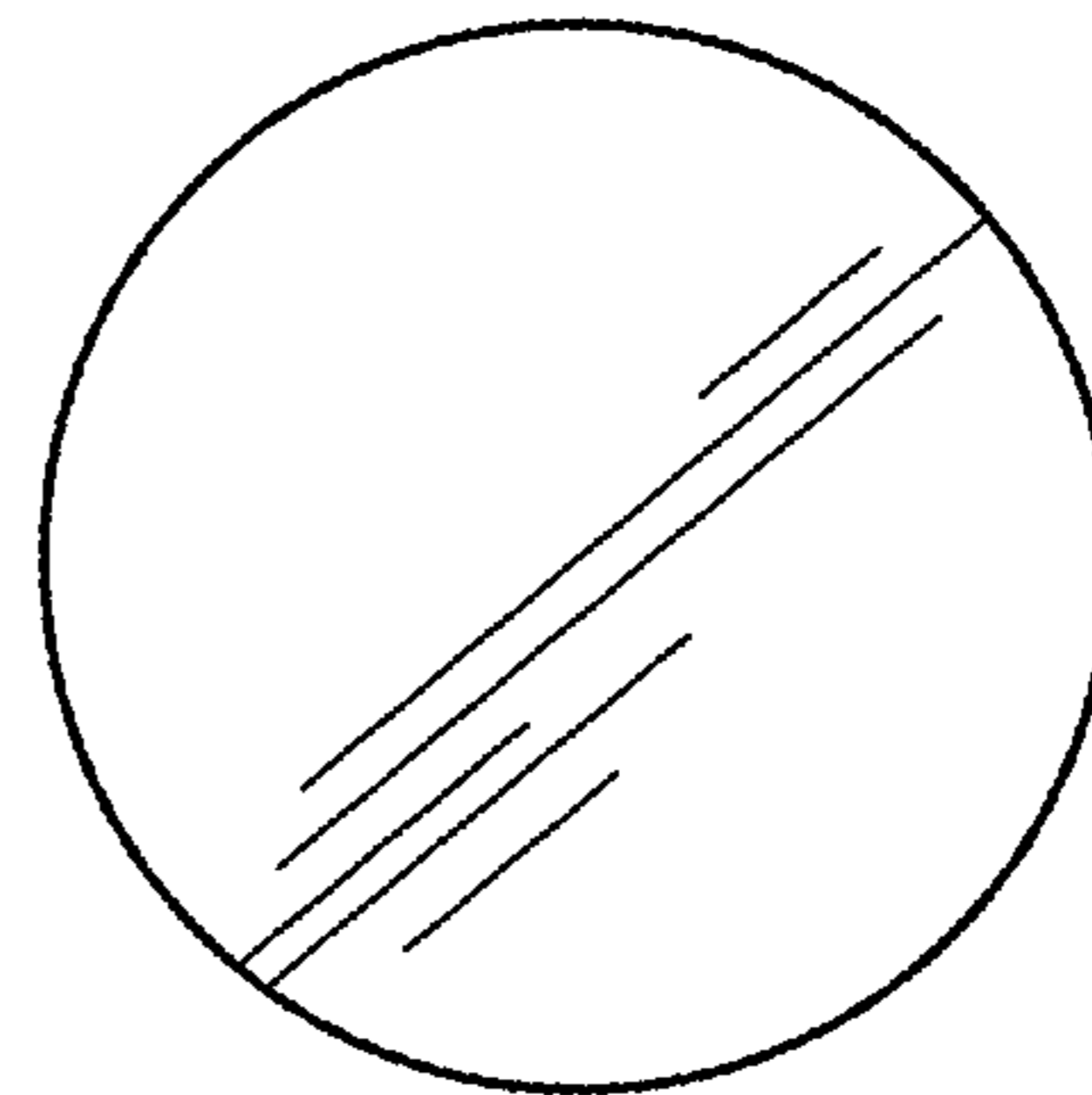

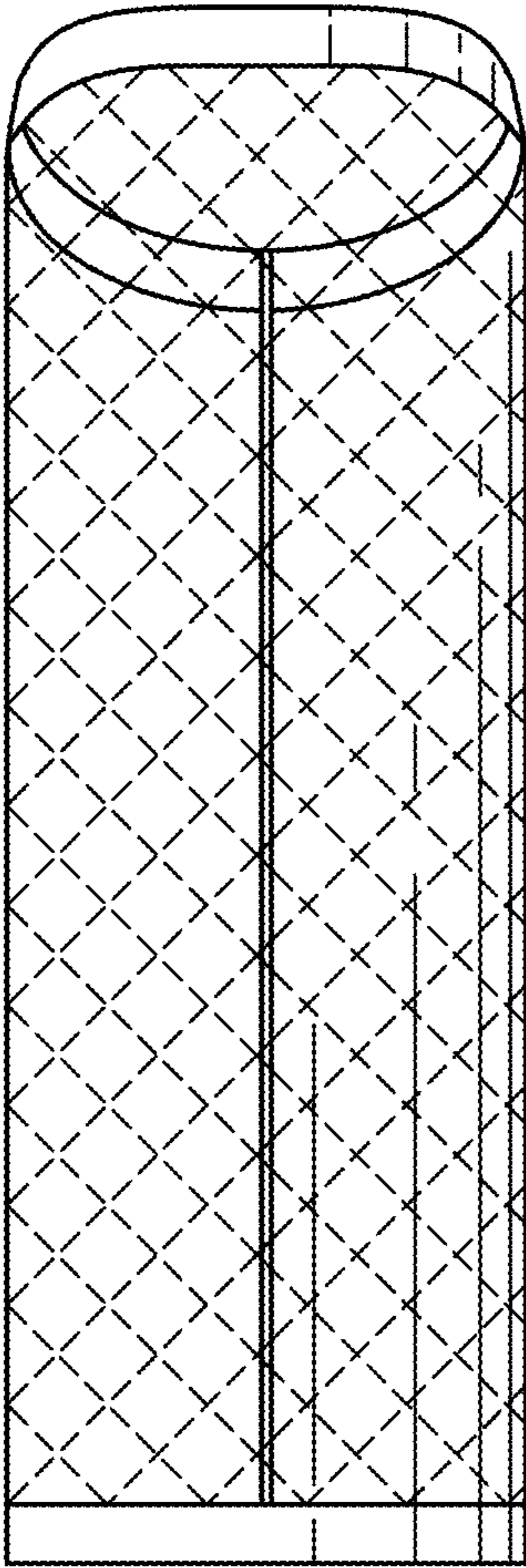

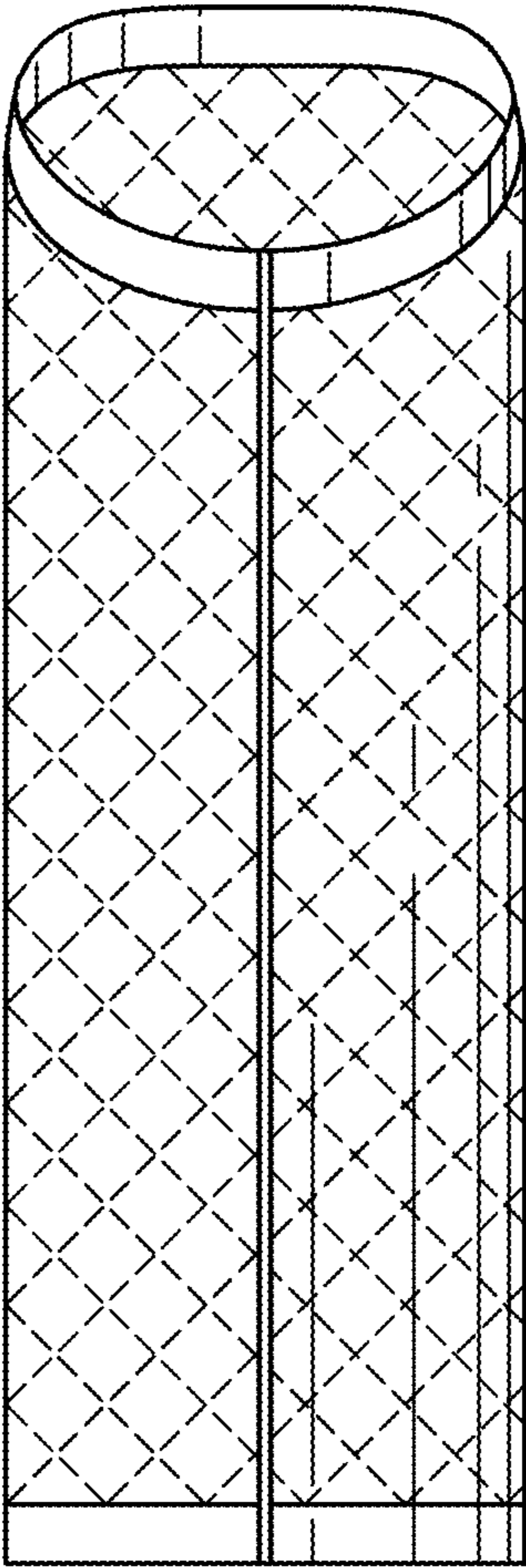

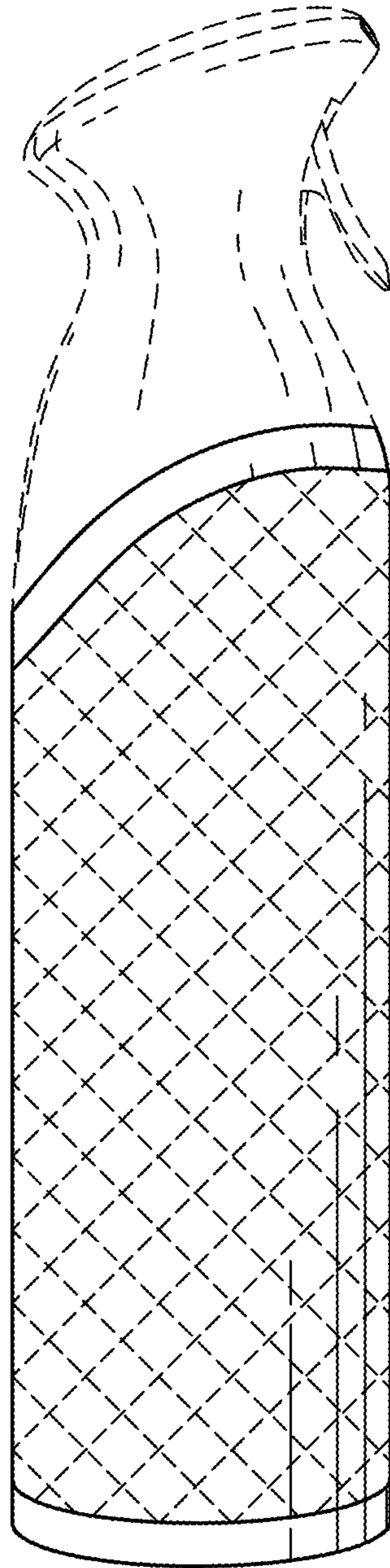
