The ornamental design for a box for lightbulbs, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a box for light bulbs showing my new design;  
FIG. 2 is a front elevation view of the box of FIG. 1;  
FIG. 3 is a rear elevation view of the box of FIG. 1;  
FIG. 4 is a right side elevation view of the box of FIG. 1;  
FIG. 5 is a left side elevation view of the box of FIG. 1;  
FIG. 6 is a top plan view of the box of FIG. 1; and,  
FIG. 7 bottom plan view of the box of FIG. 1.  
The dashed broken lines illustrate portions of the box for light bulbs and form no part of the claimed design.

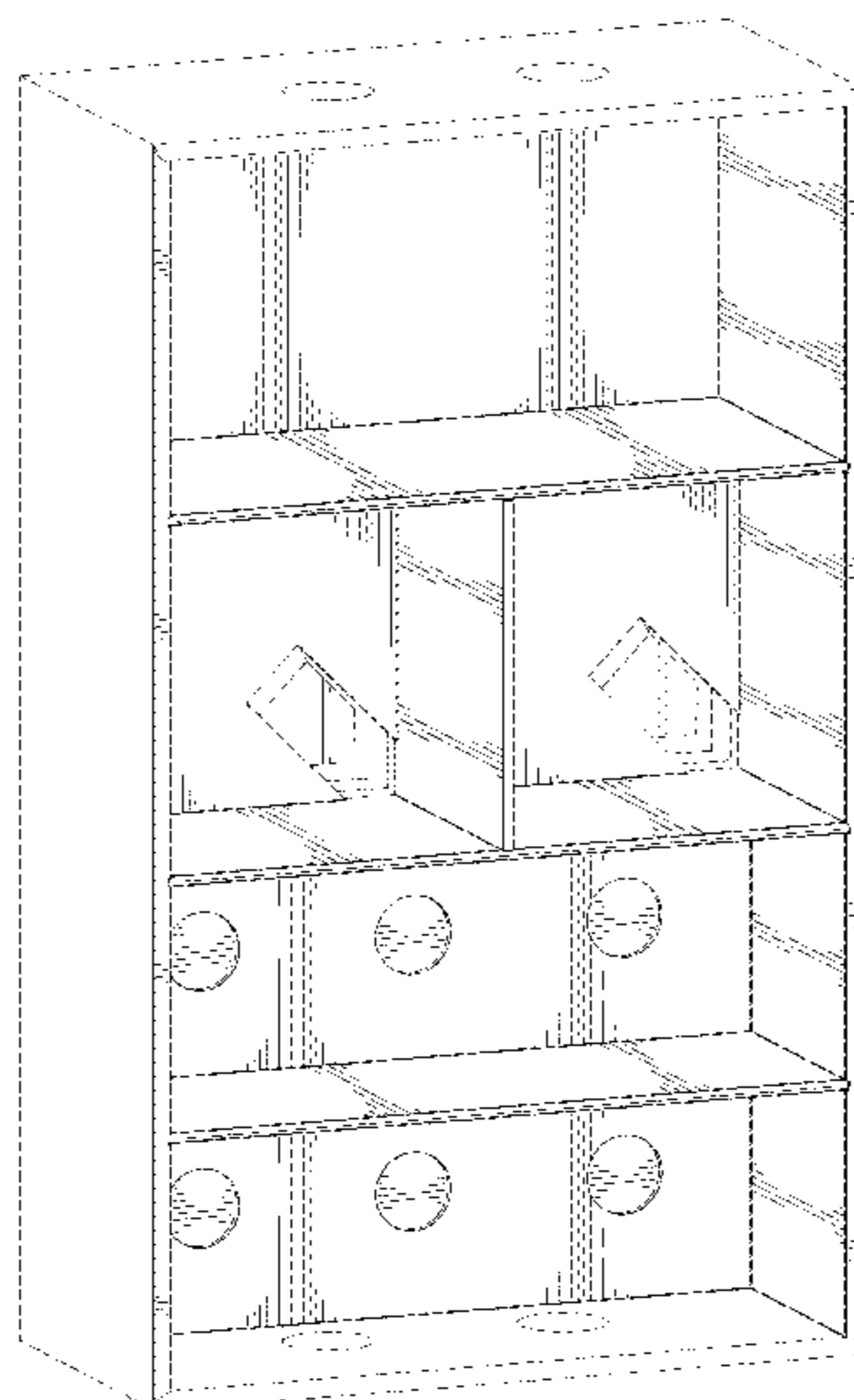

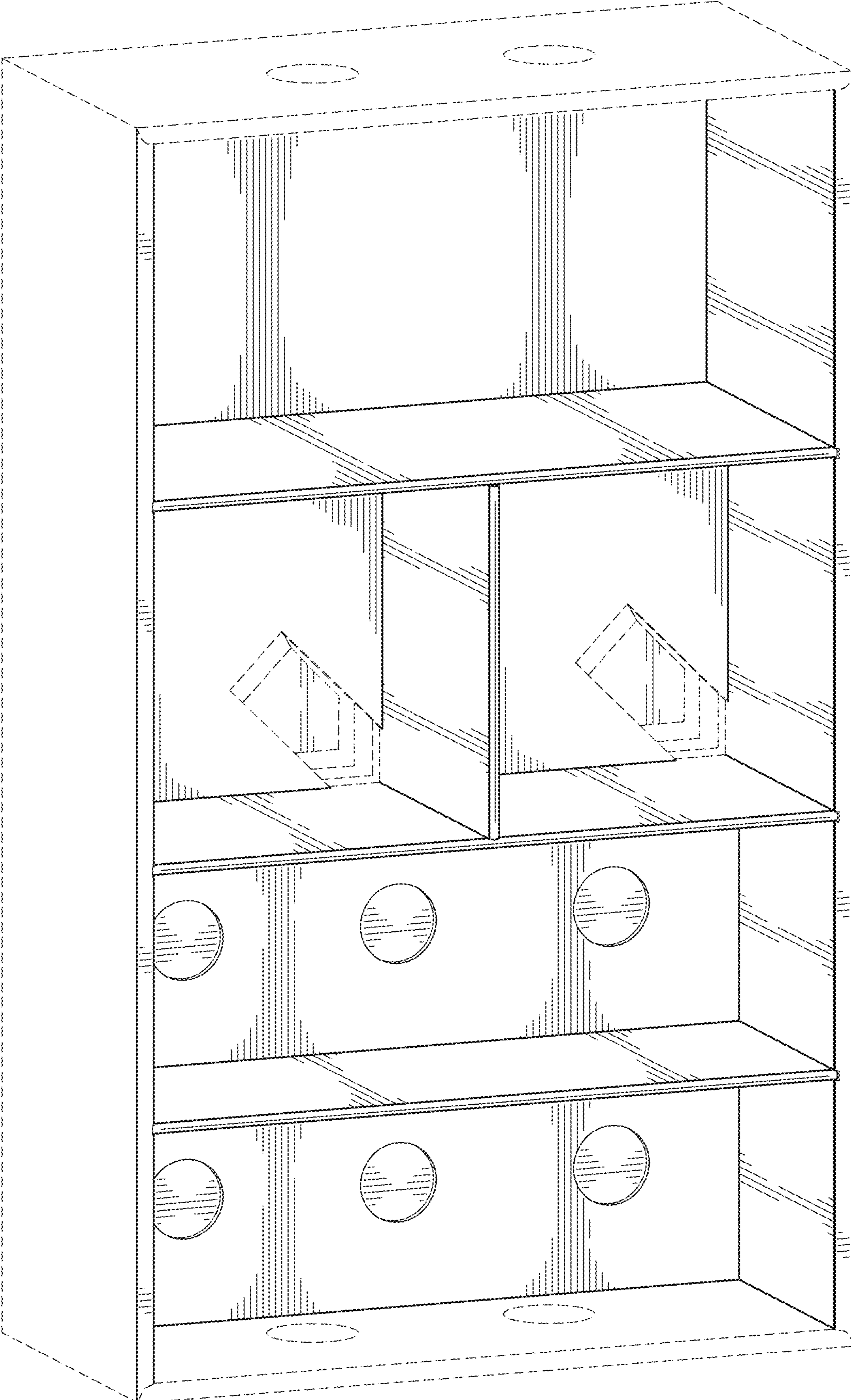

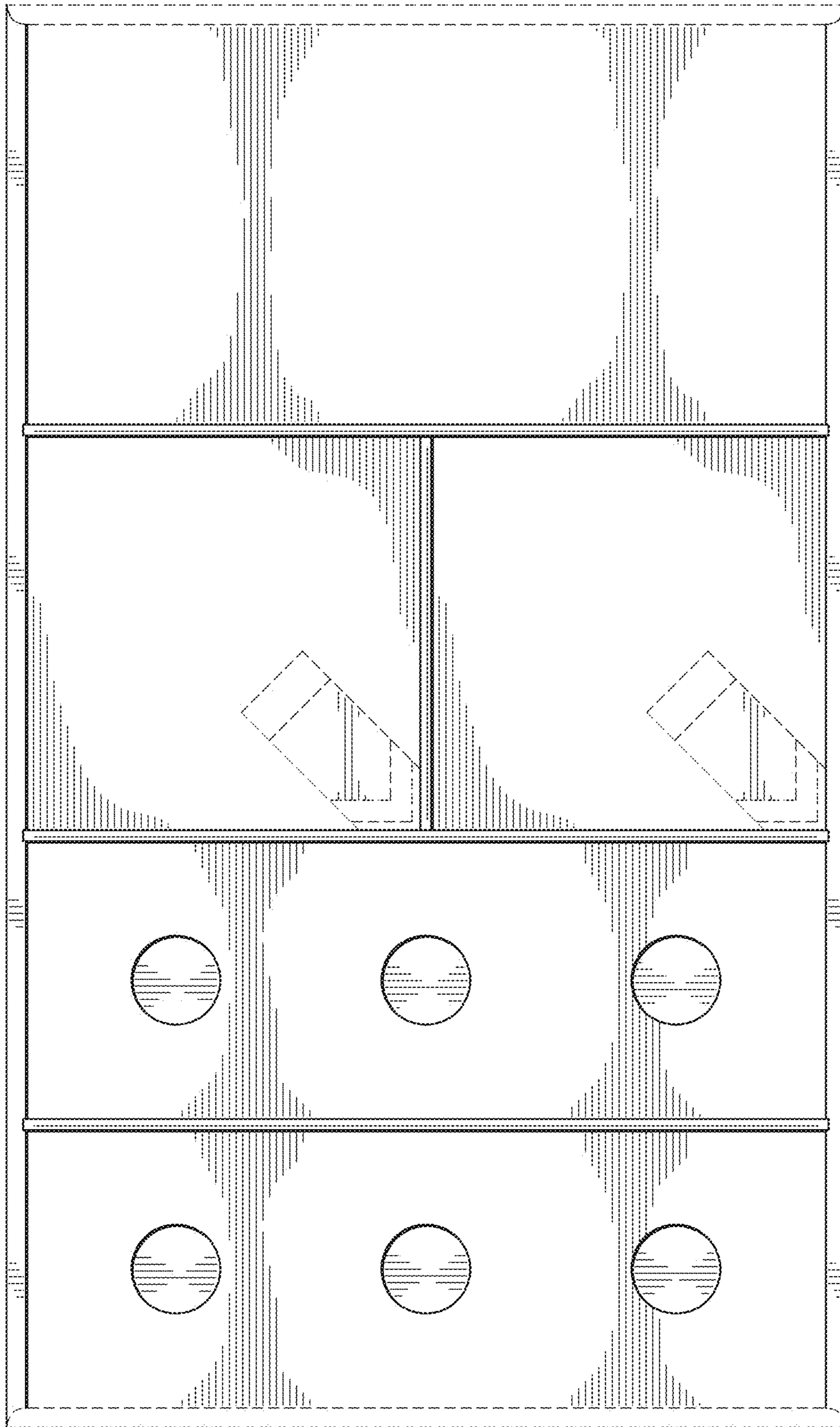

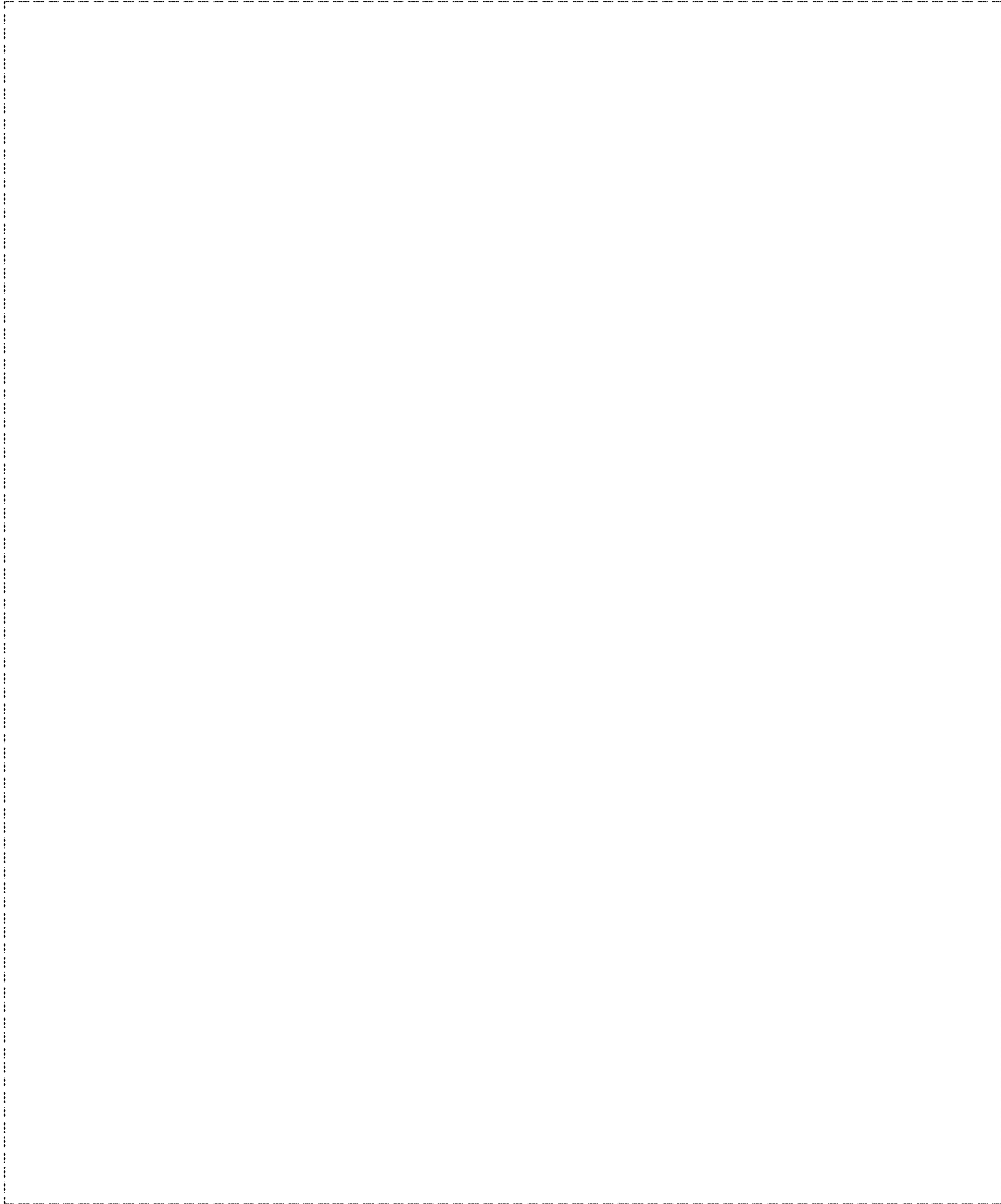

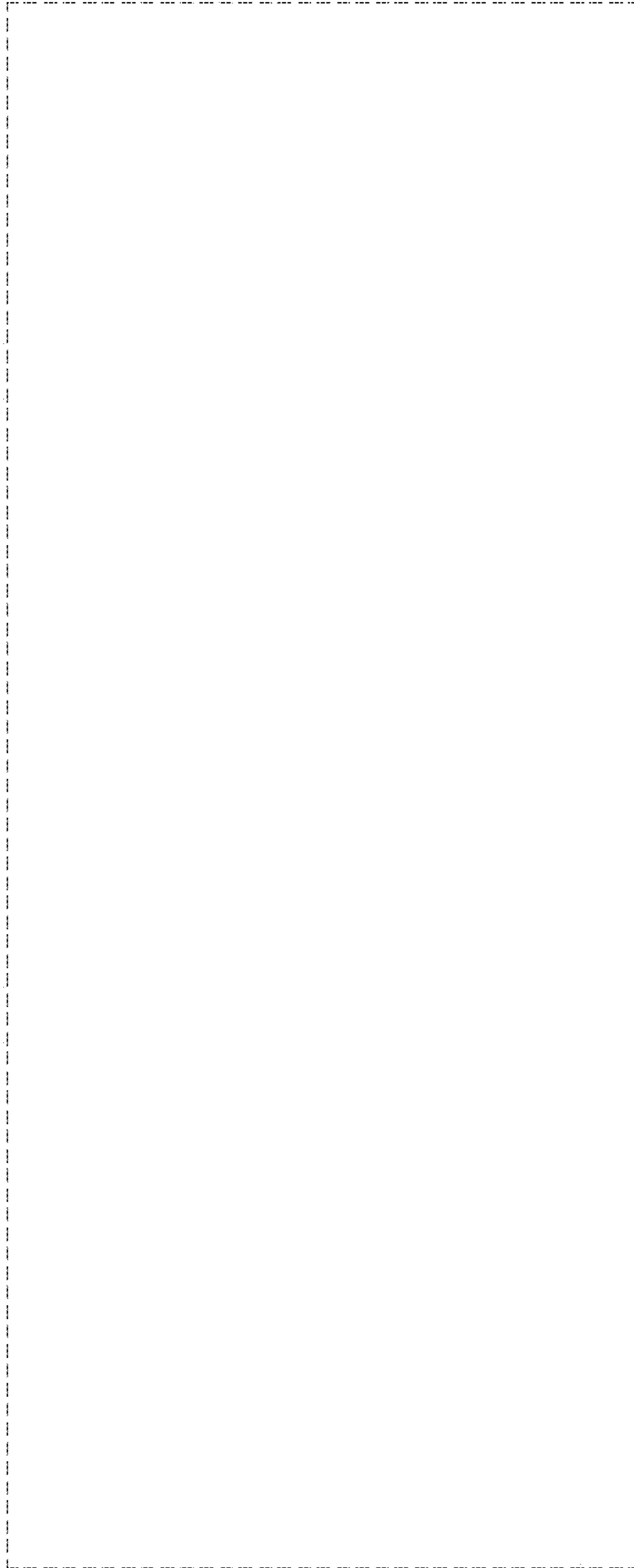

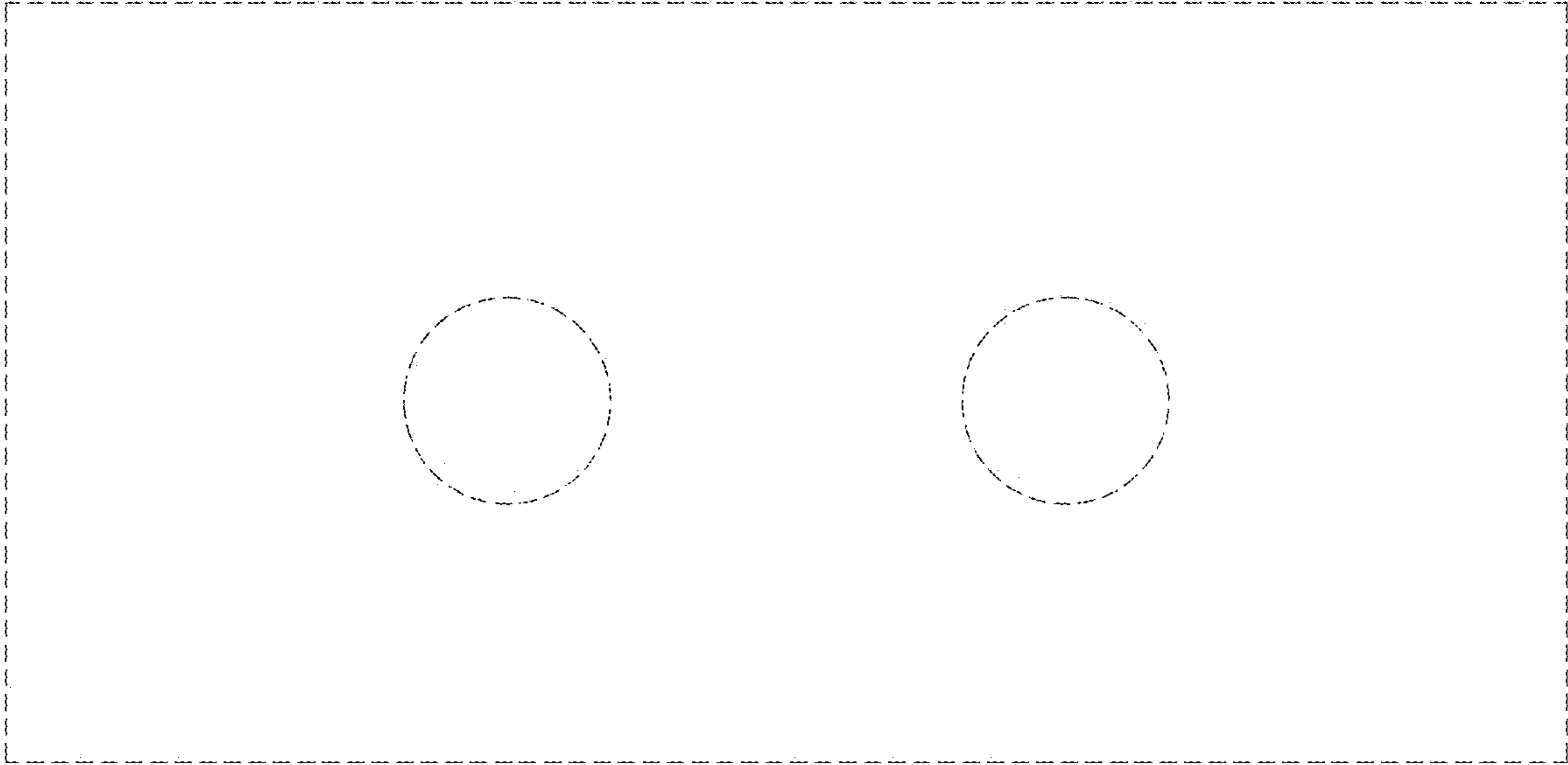

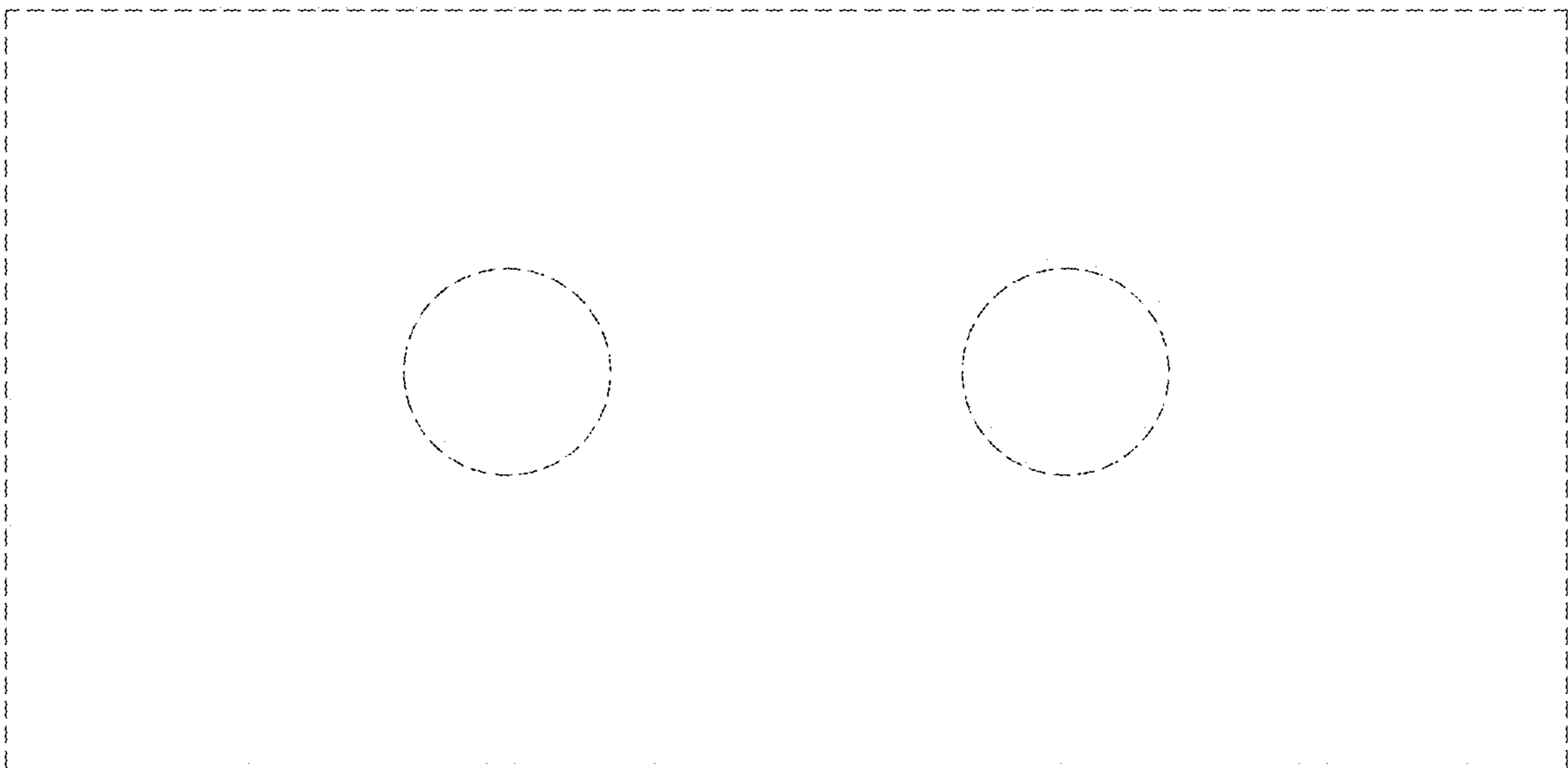
