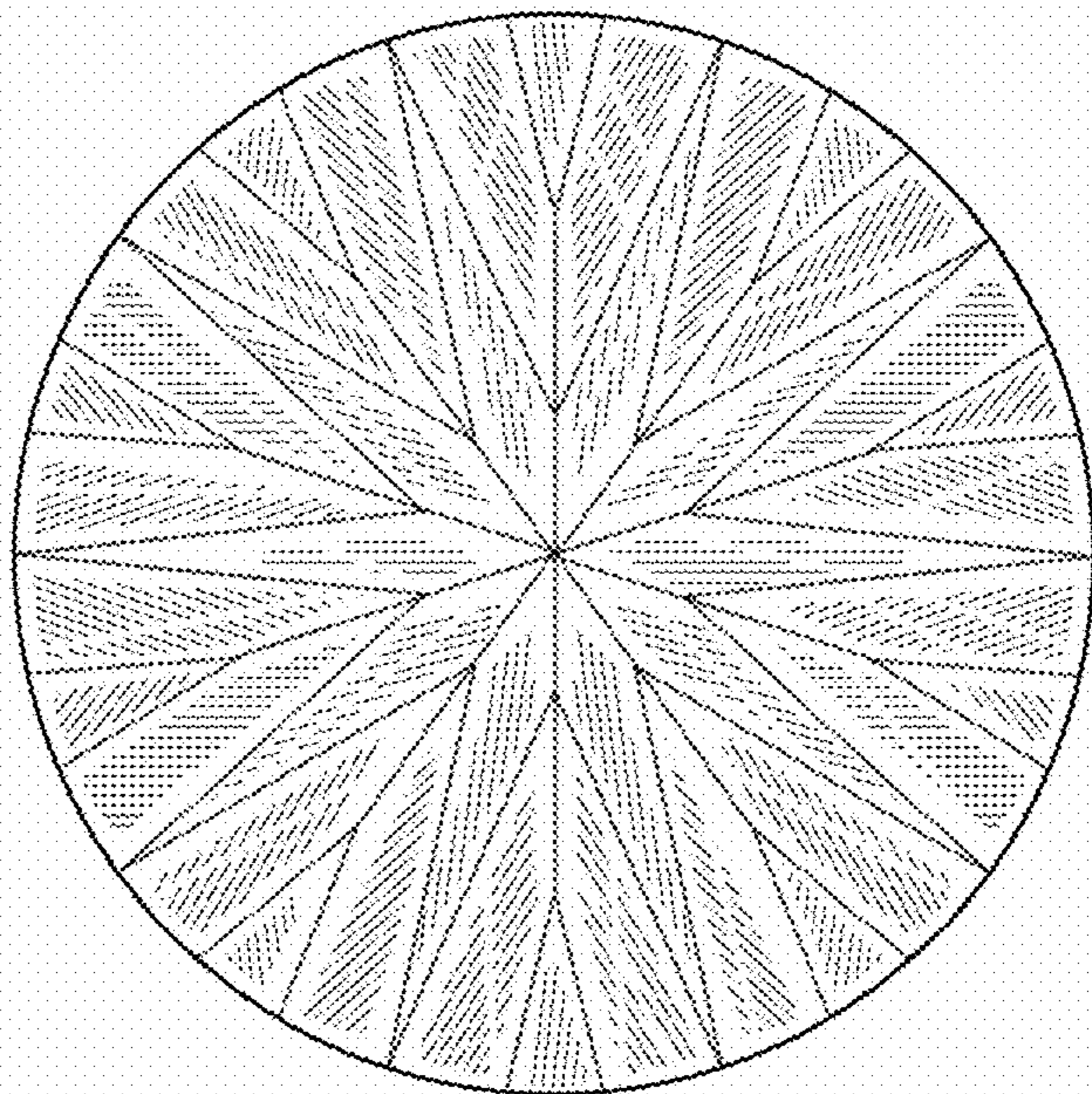
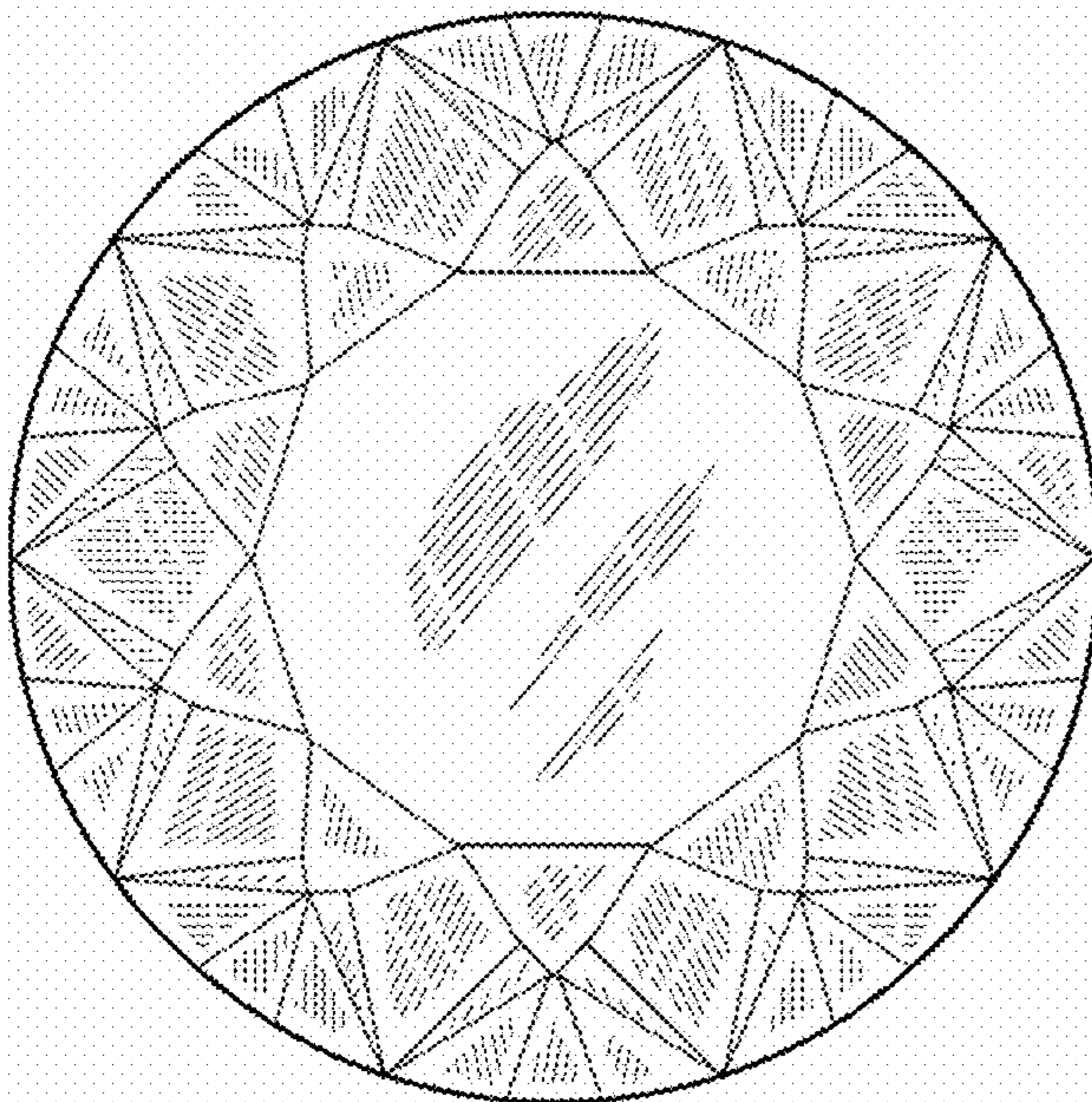
1. Diamond

**1.2** is a top view thereof; and,

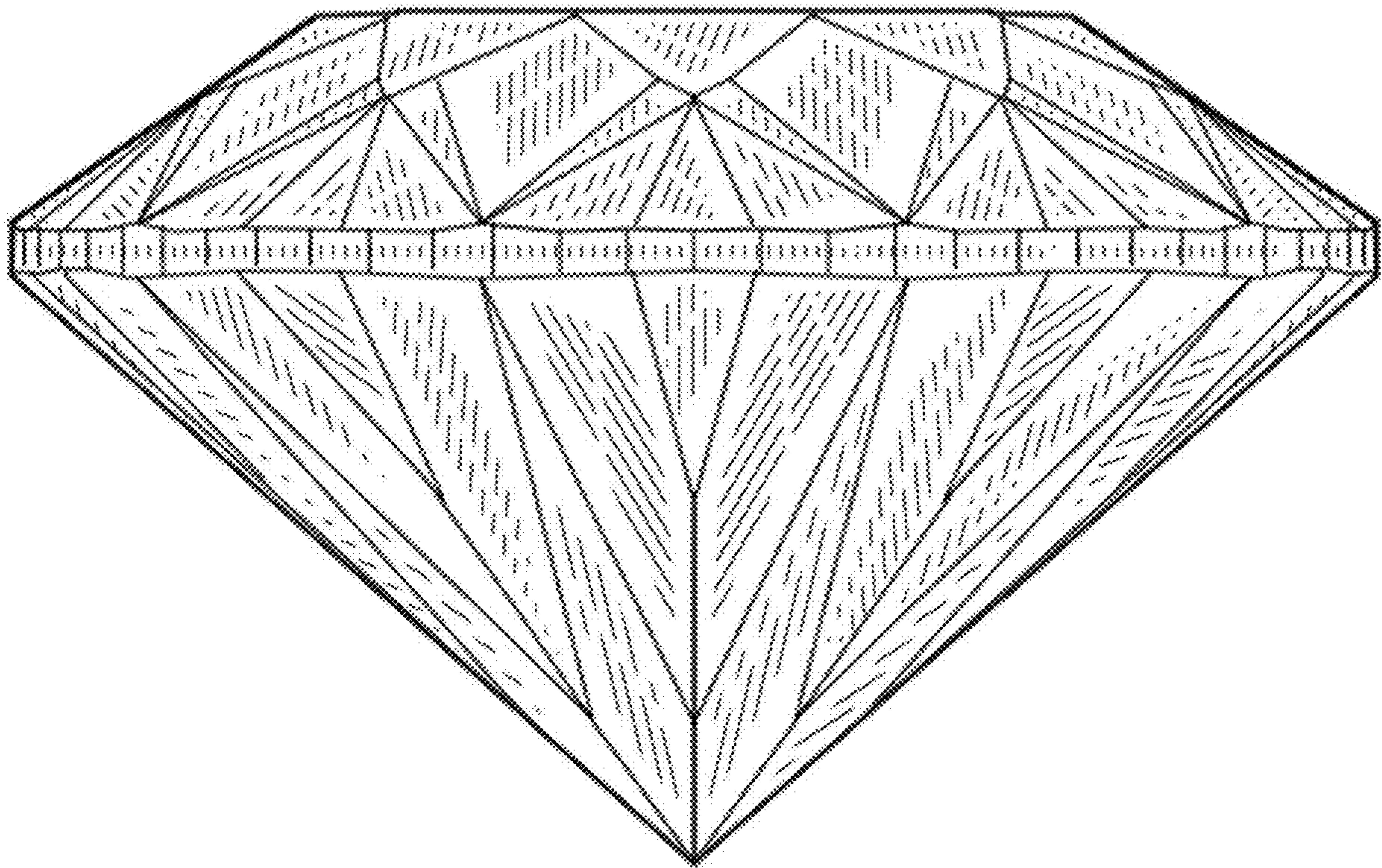

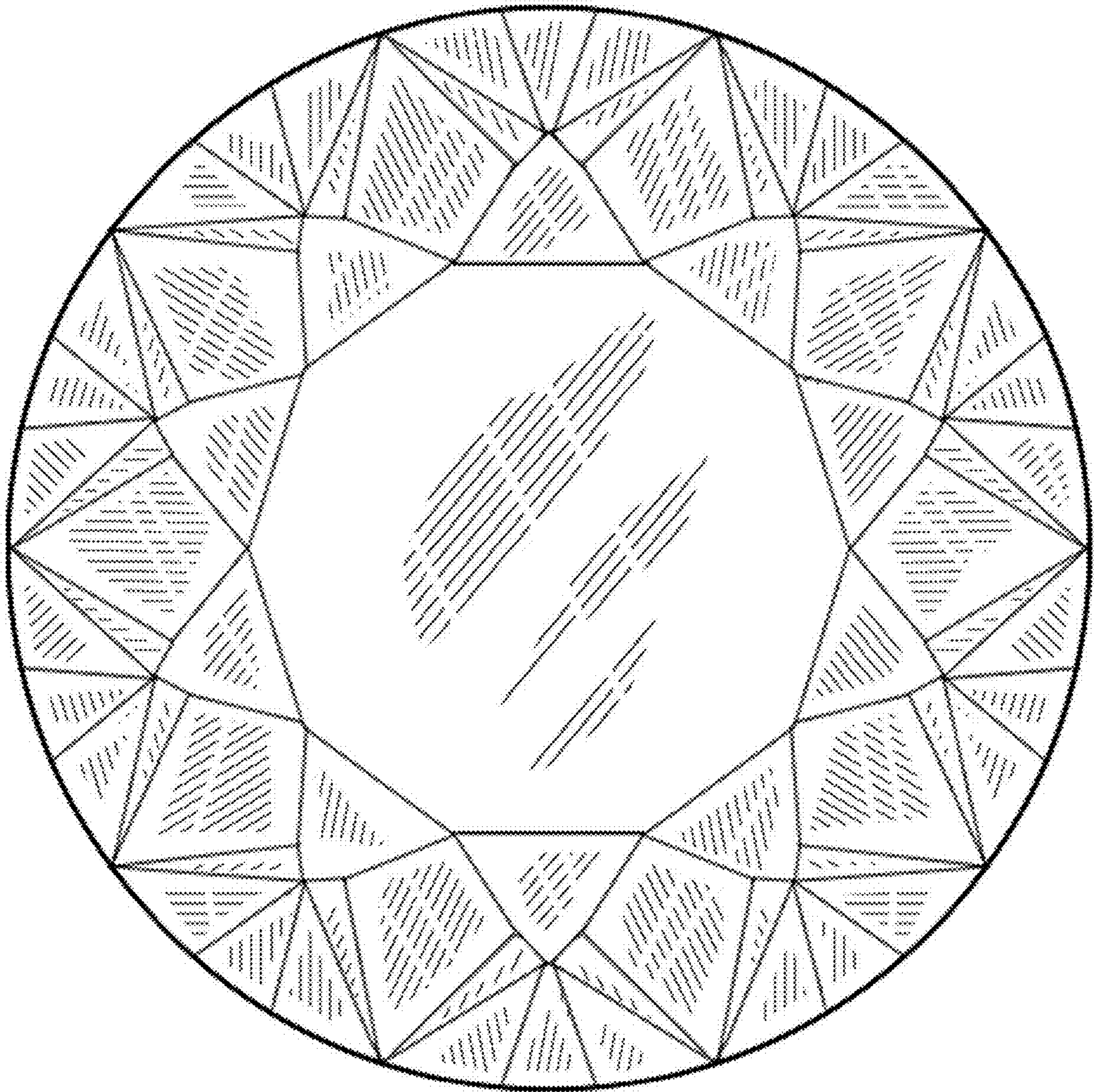
