(57) **CLAIM**

The ornamental design for a vehicle rear upper bumper cover, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a vehicle rear upper bumper cover, showing our new design;

FIG. 4 is a top plan view thereof;

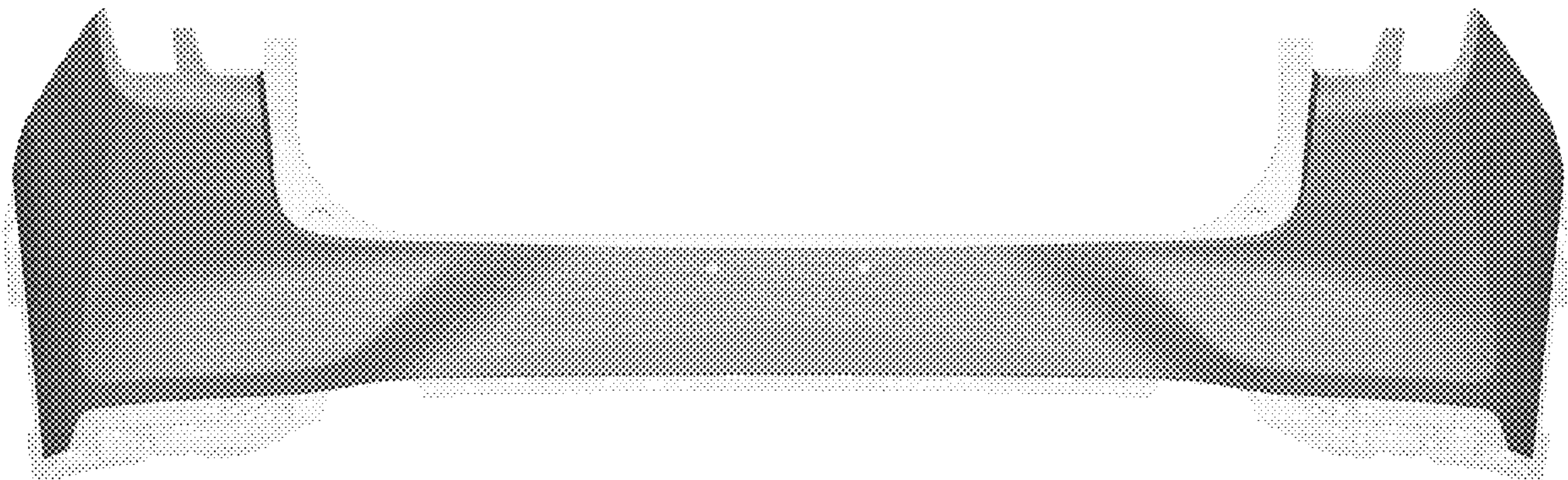
FIG. 5 is a bottom plan view thereof;

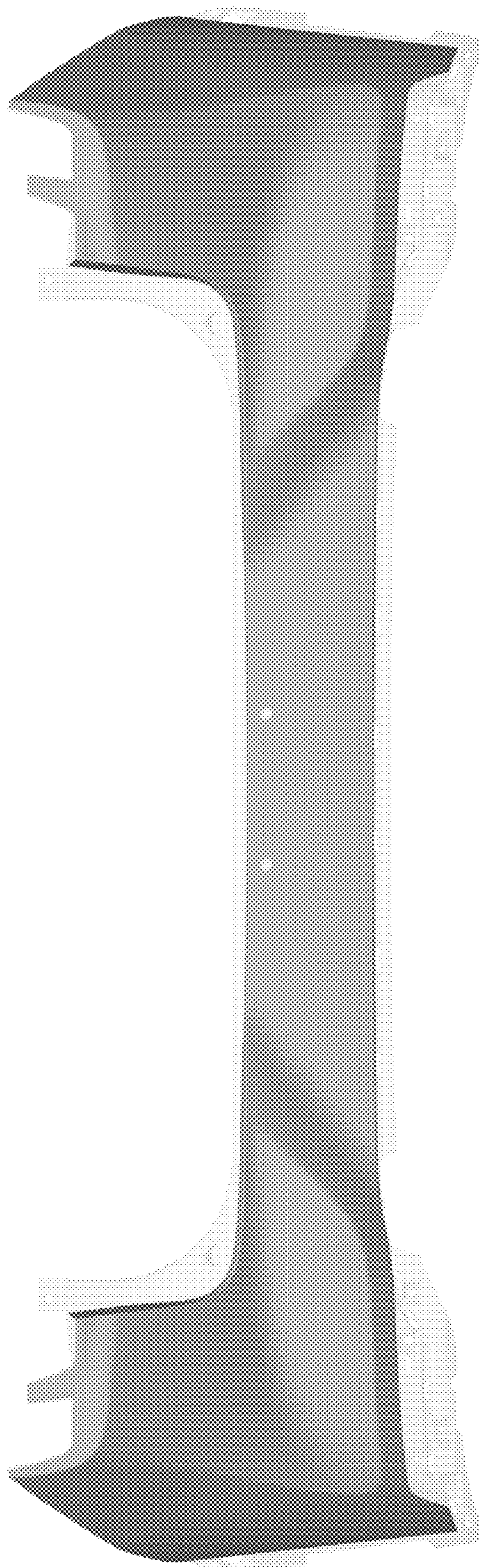

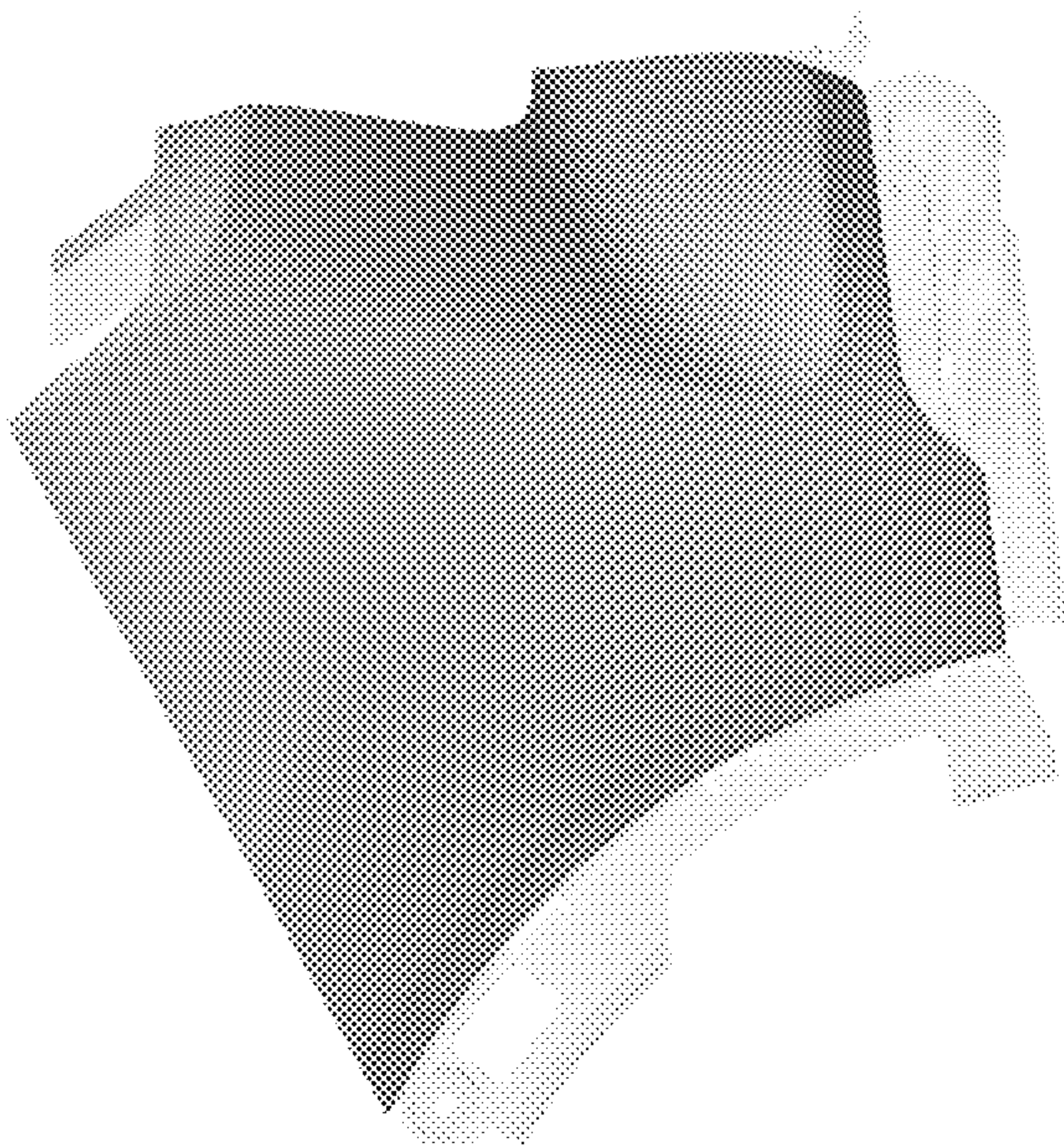

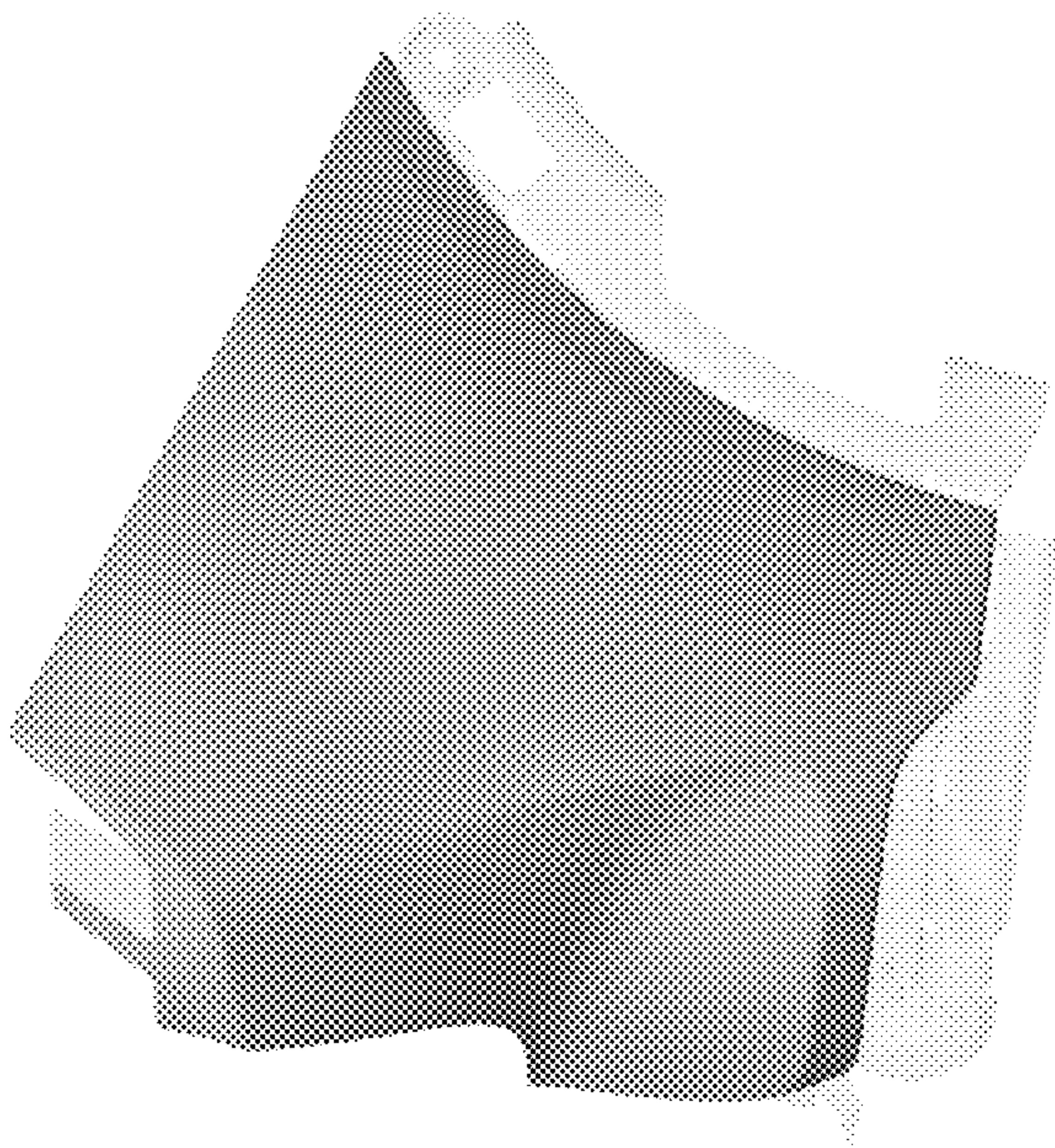

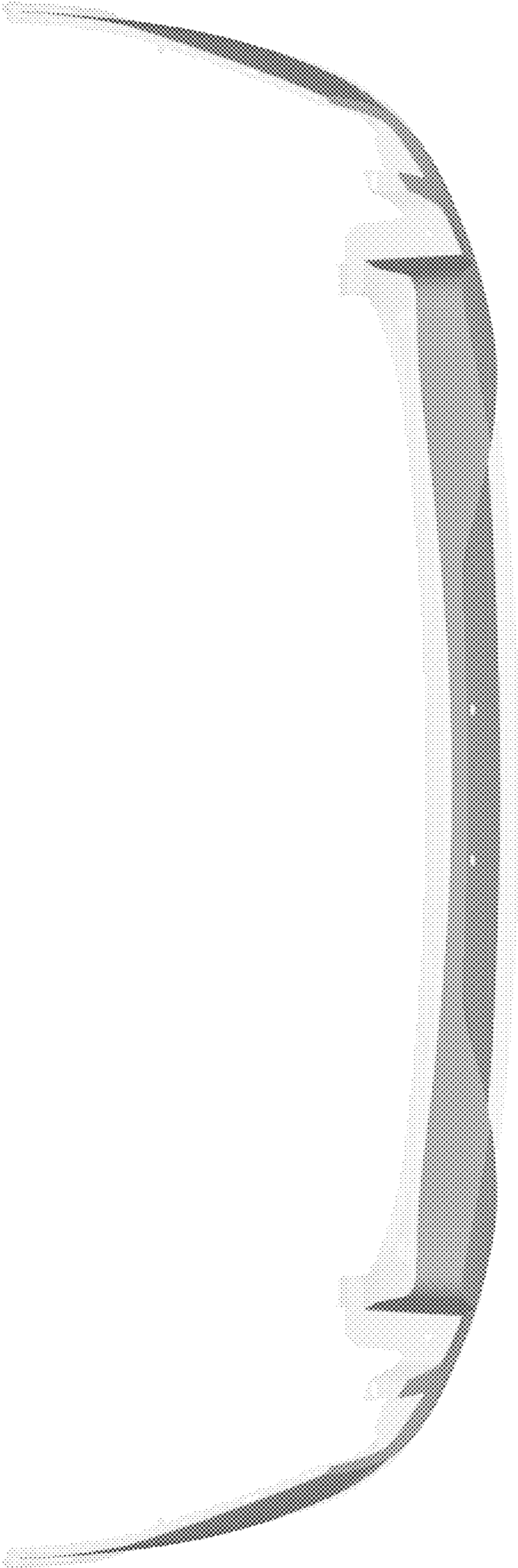
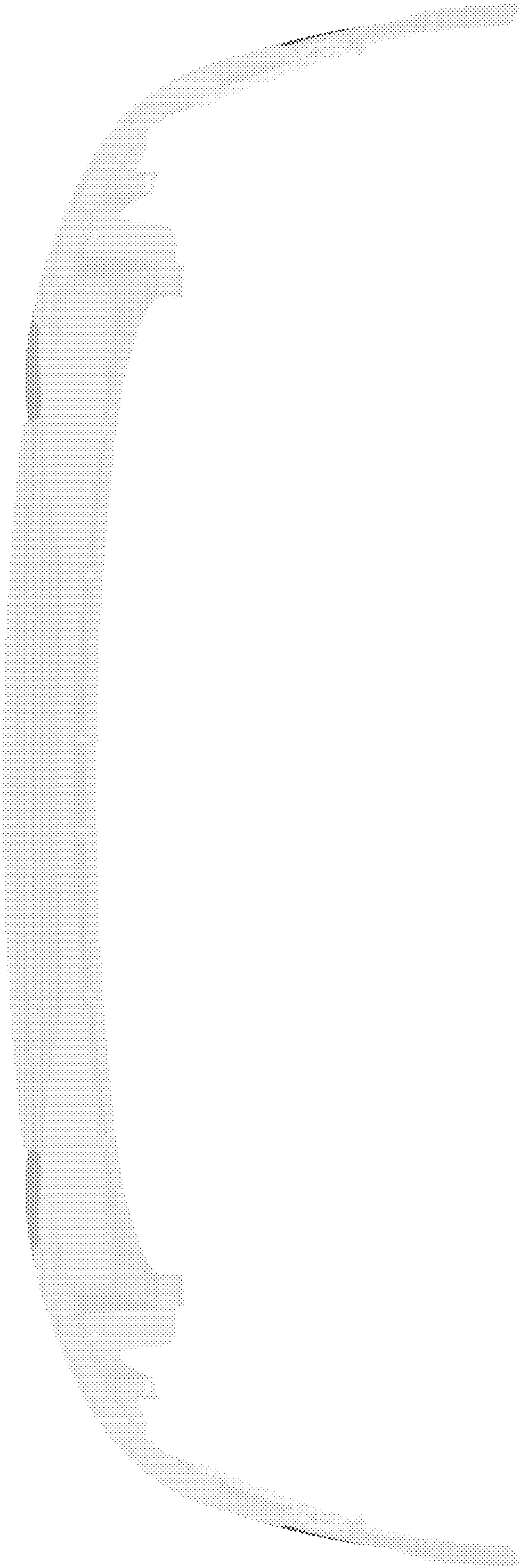

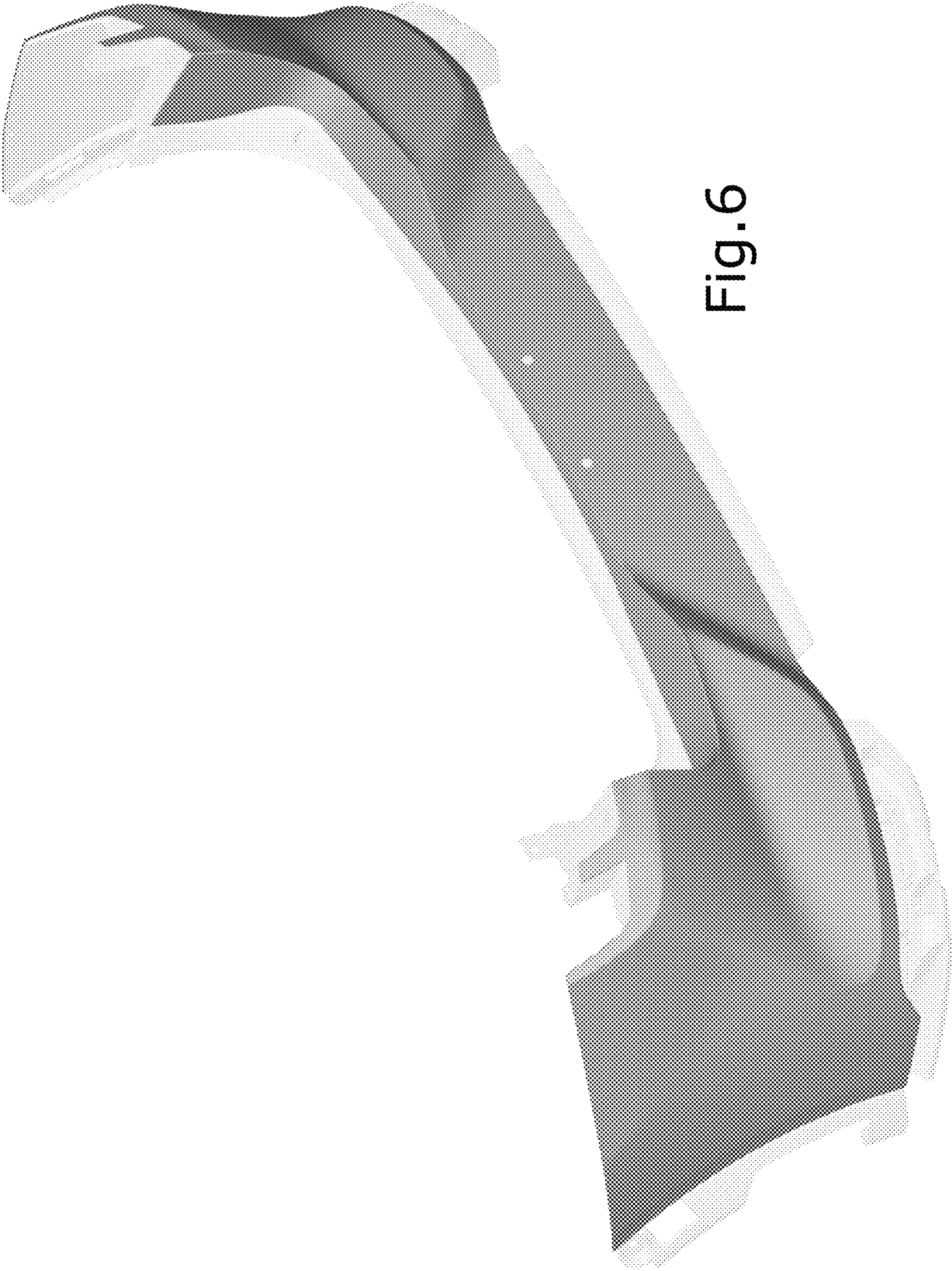
