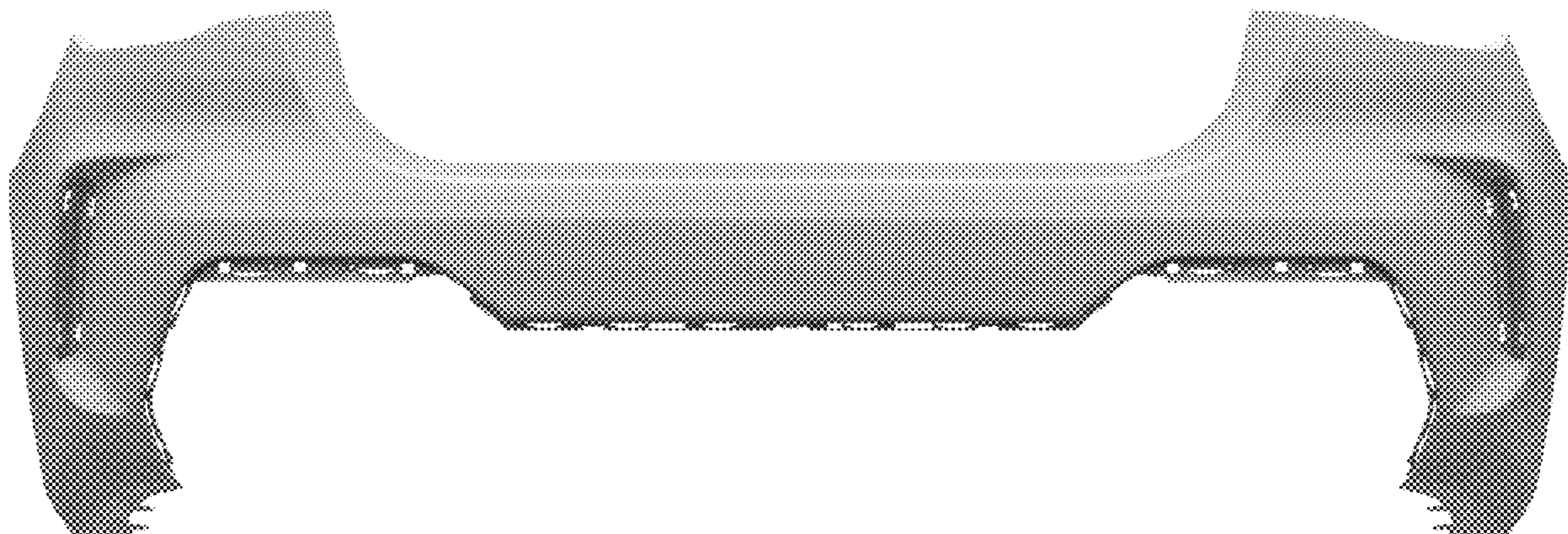
FIG. 1 is a front view of a rear bumper for a vehicle according to the design;

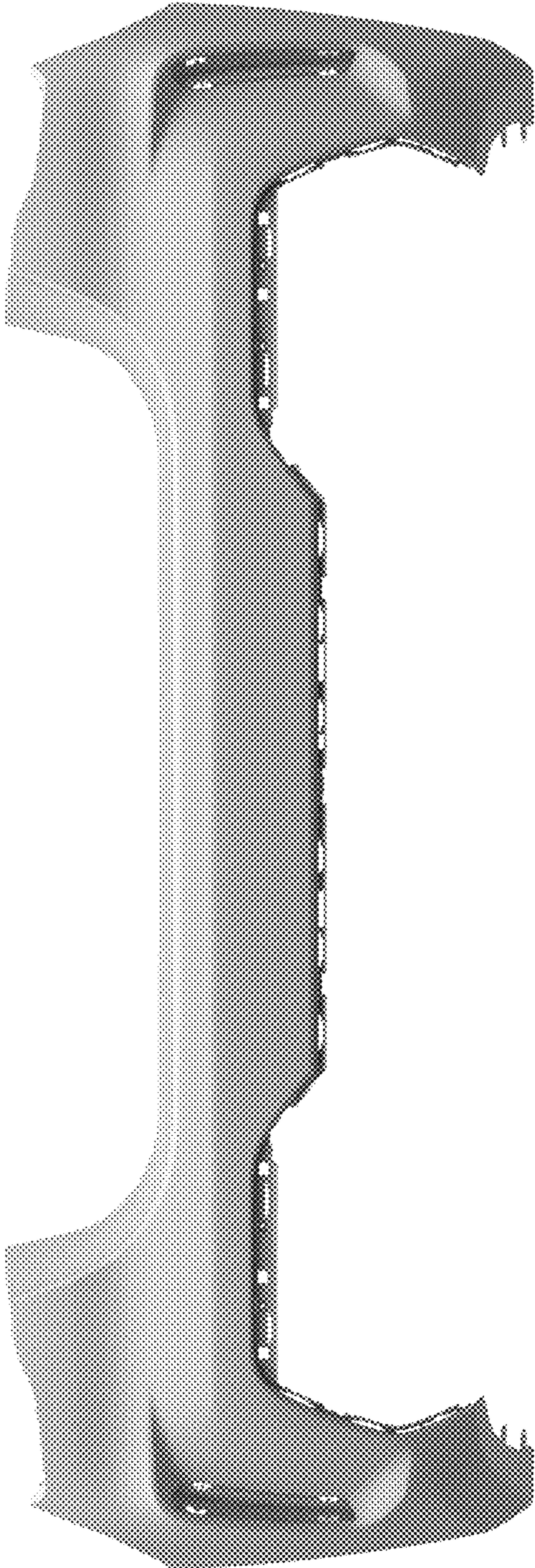

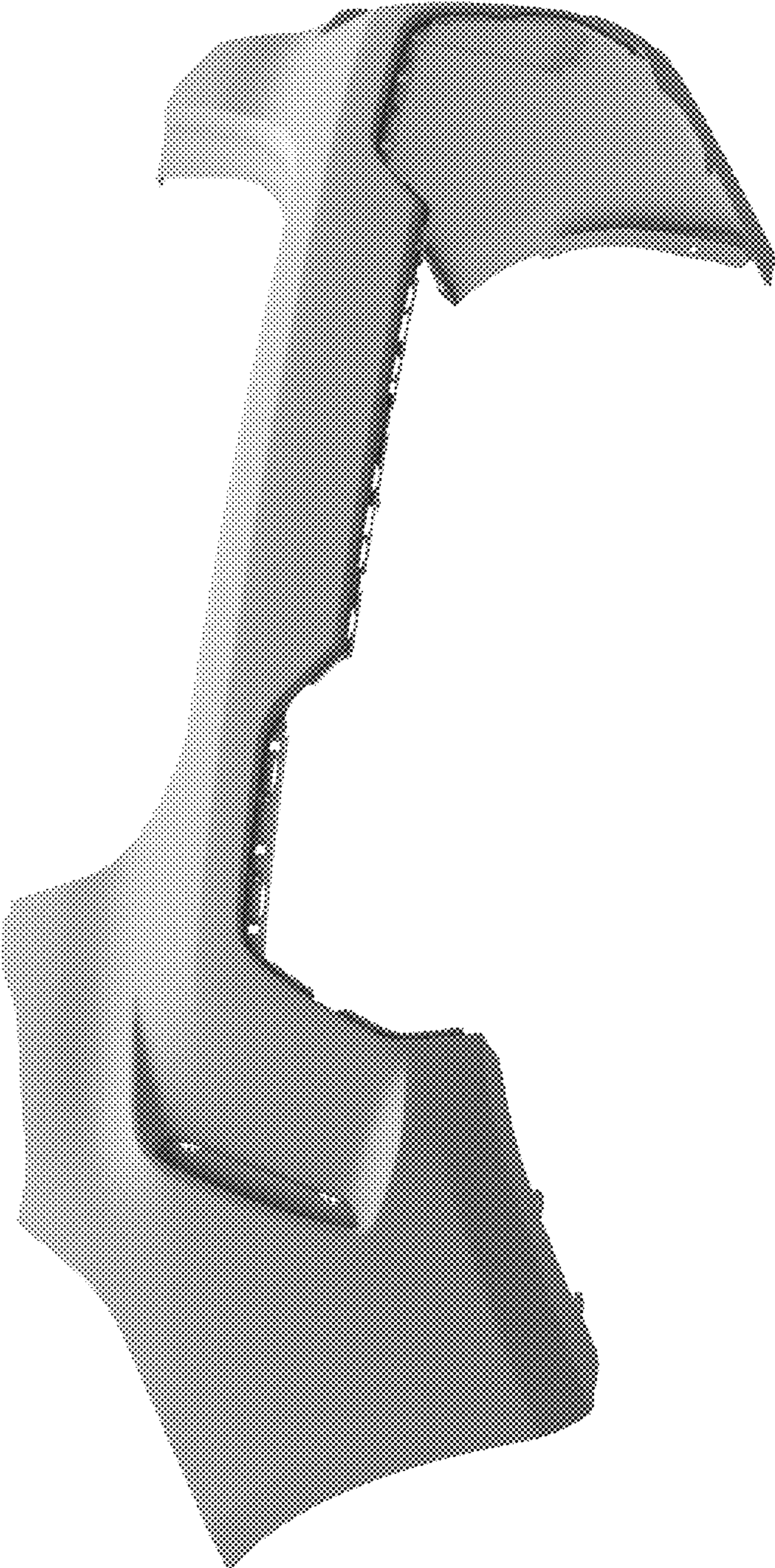

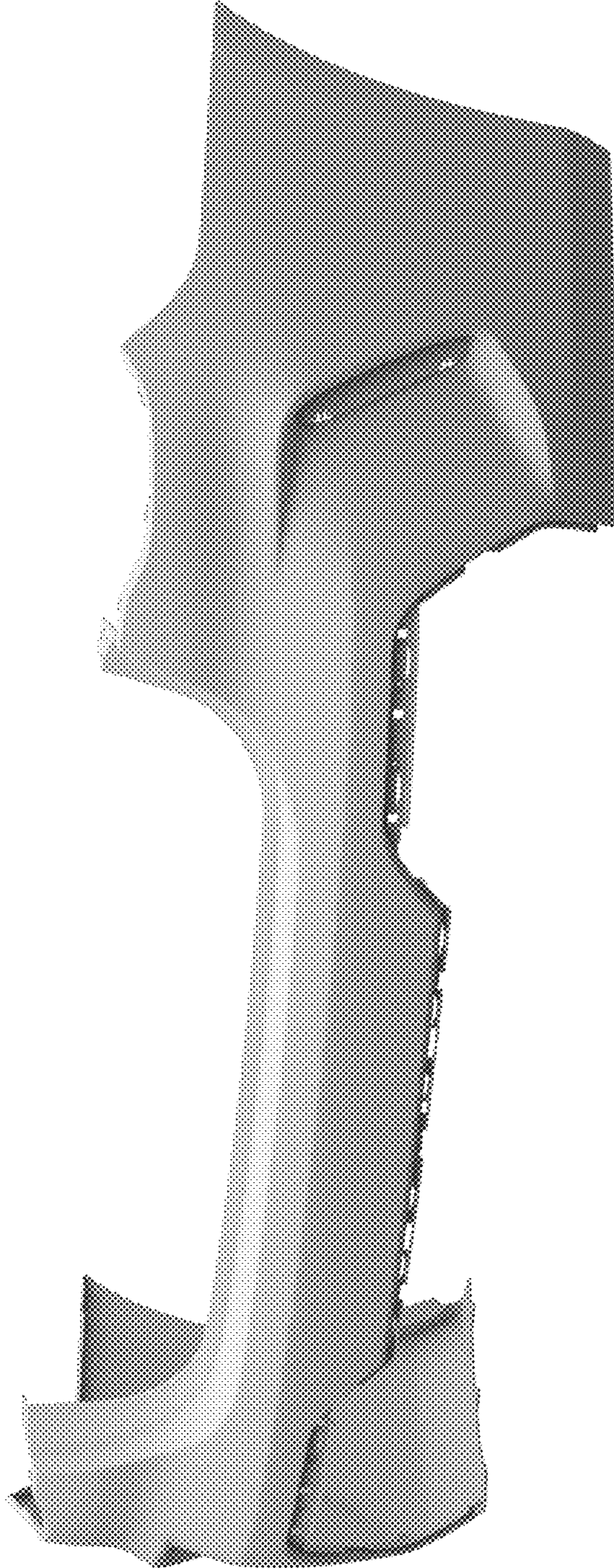

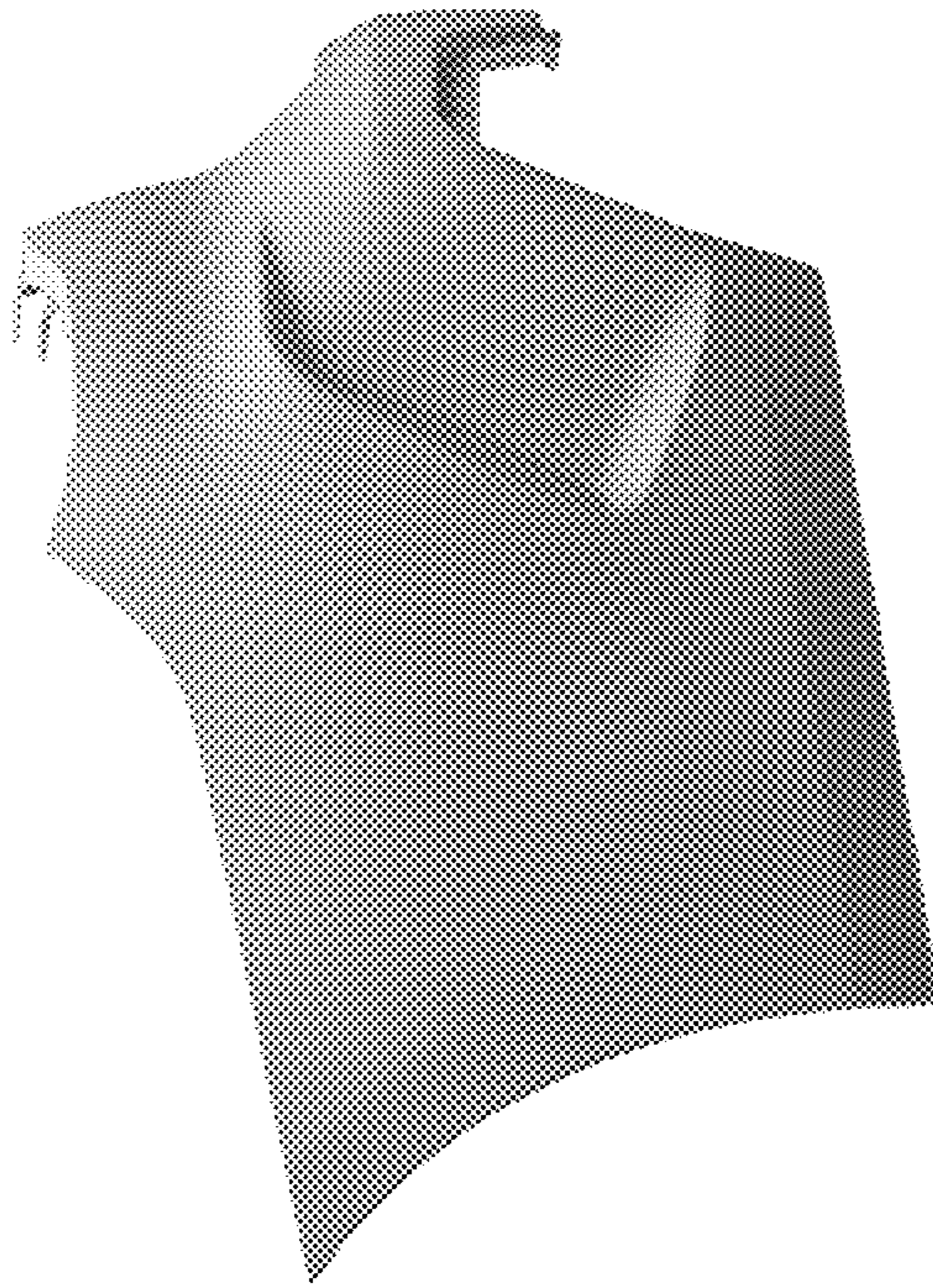

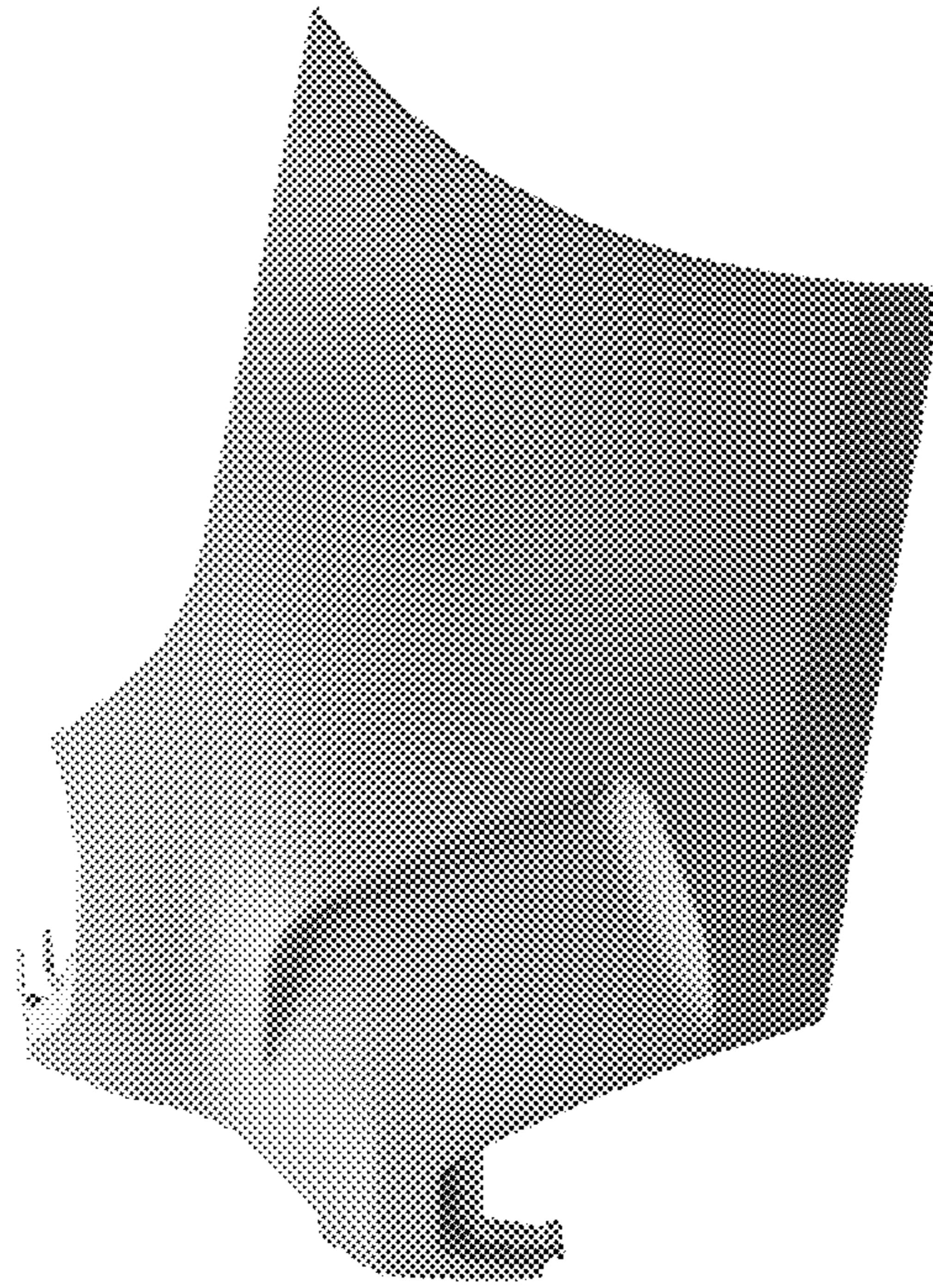

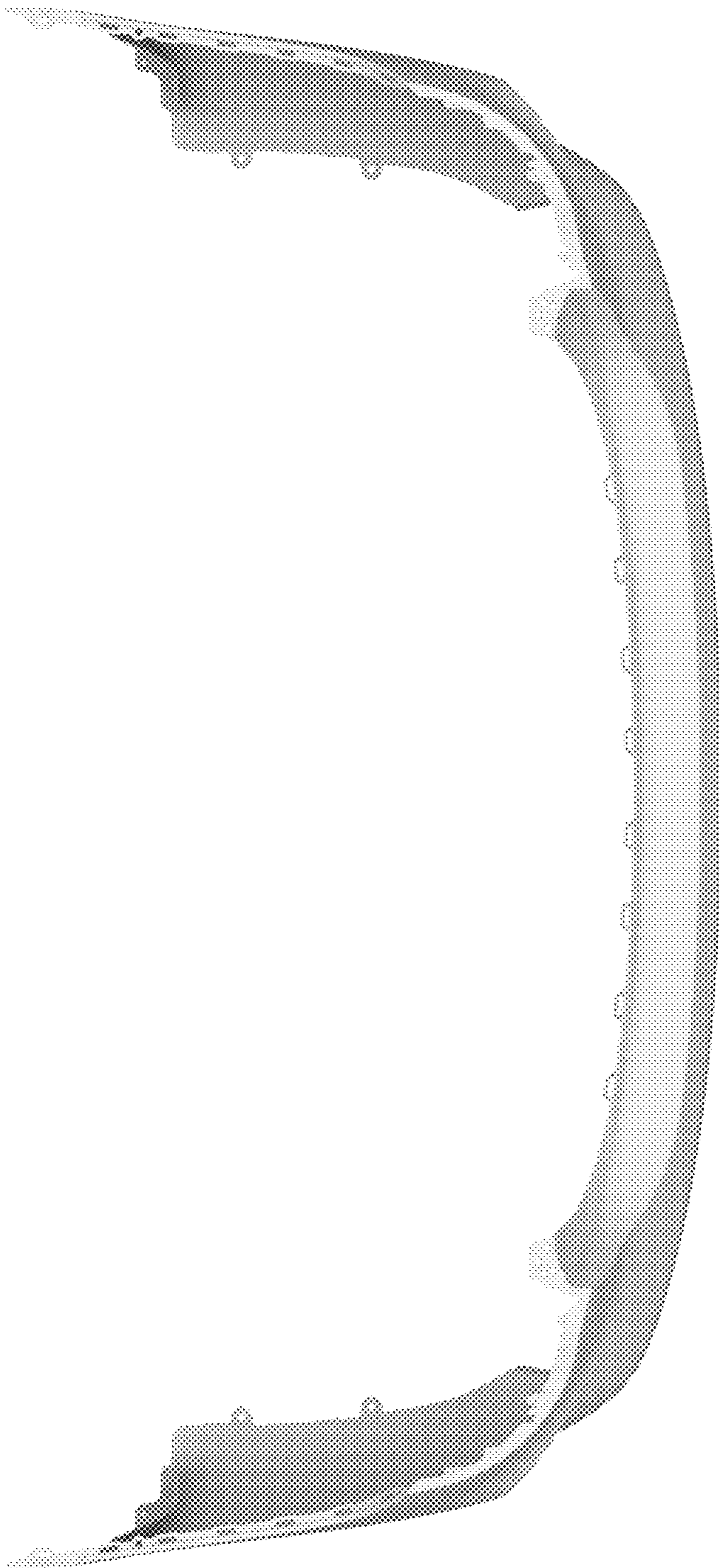

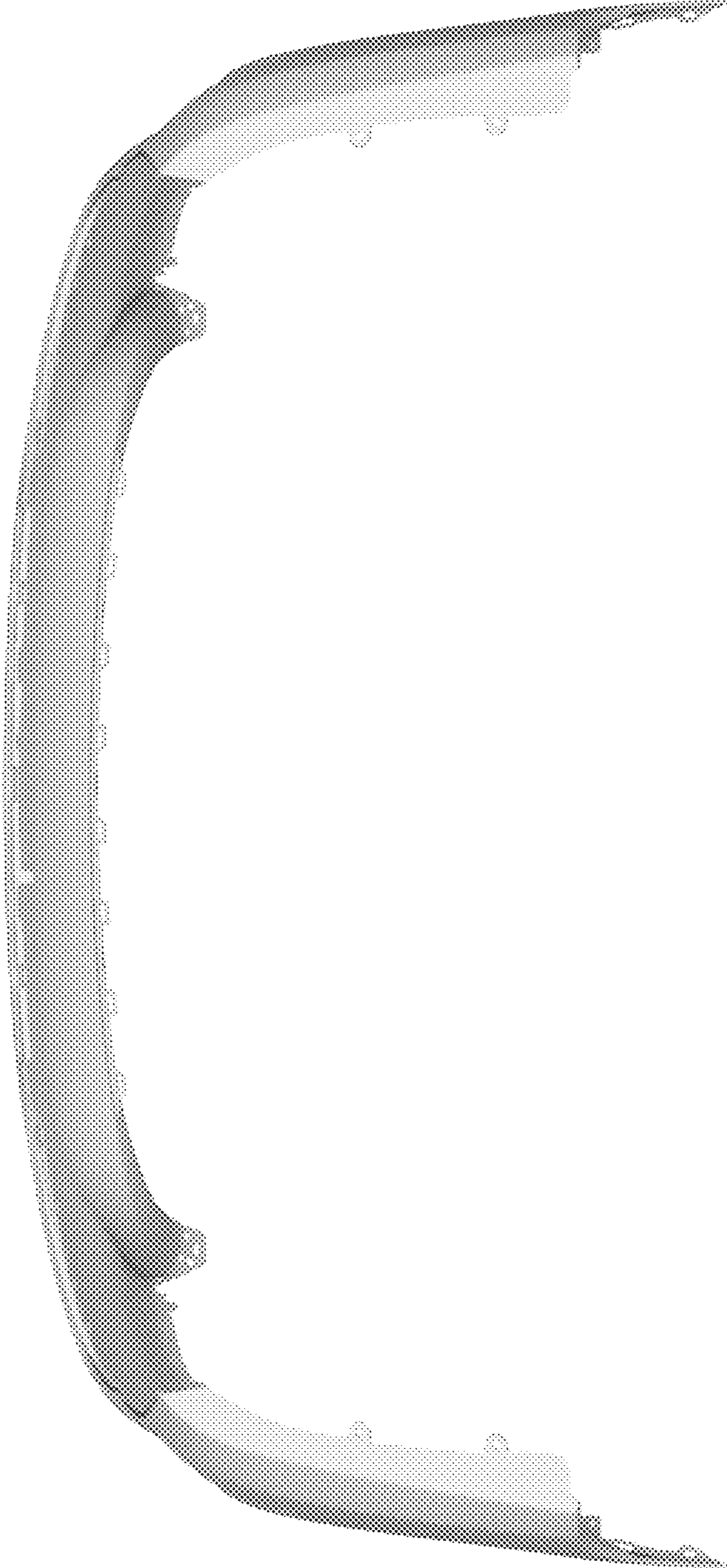

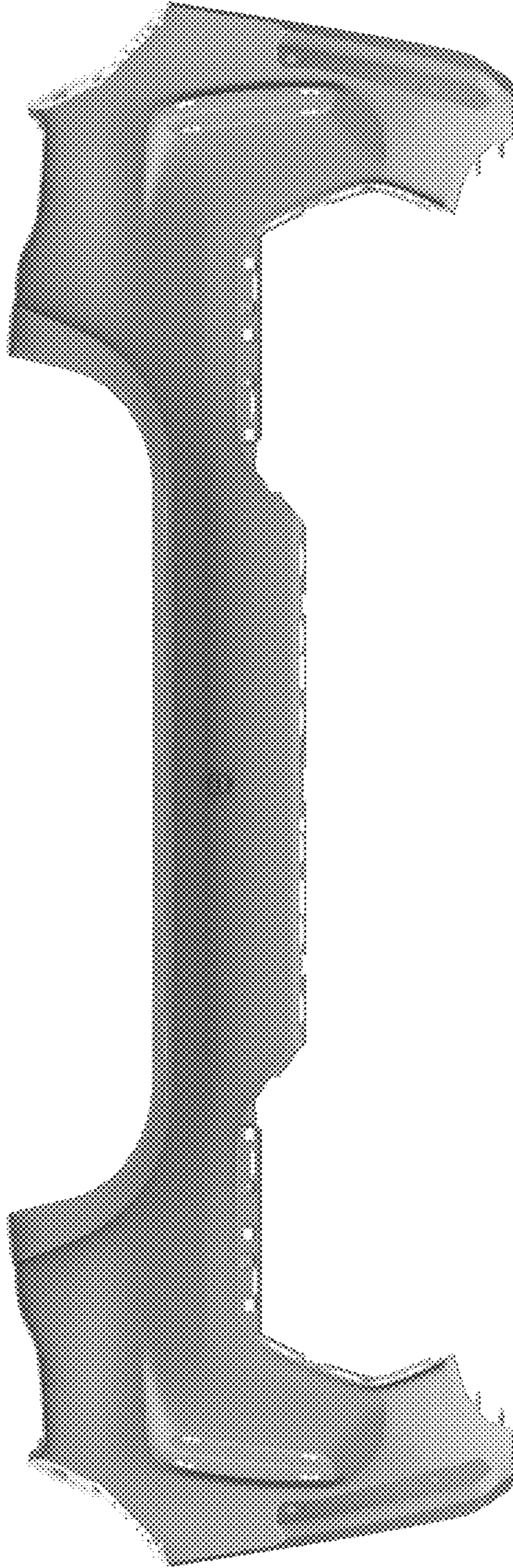
