(57) **CLAIM**

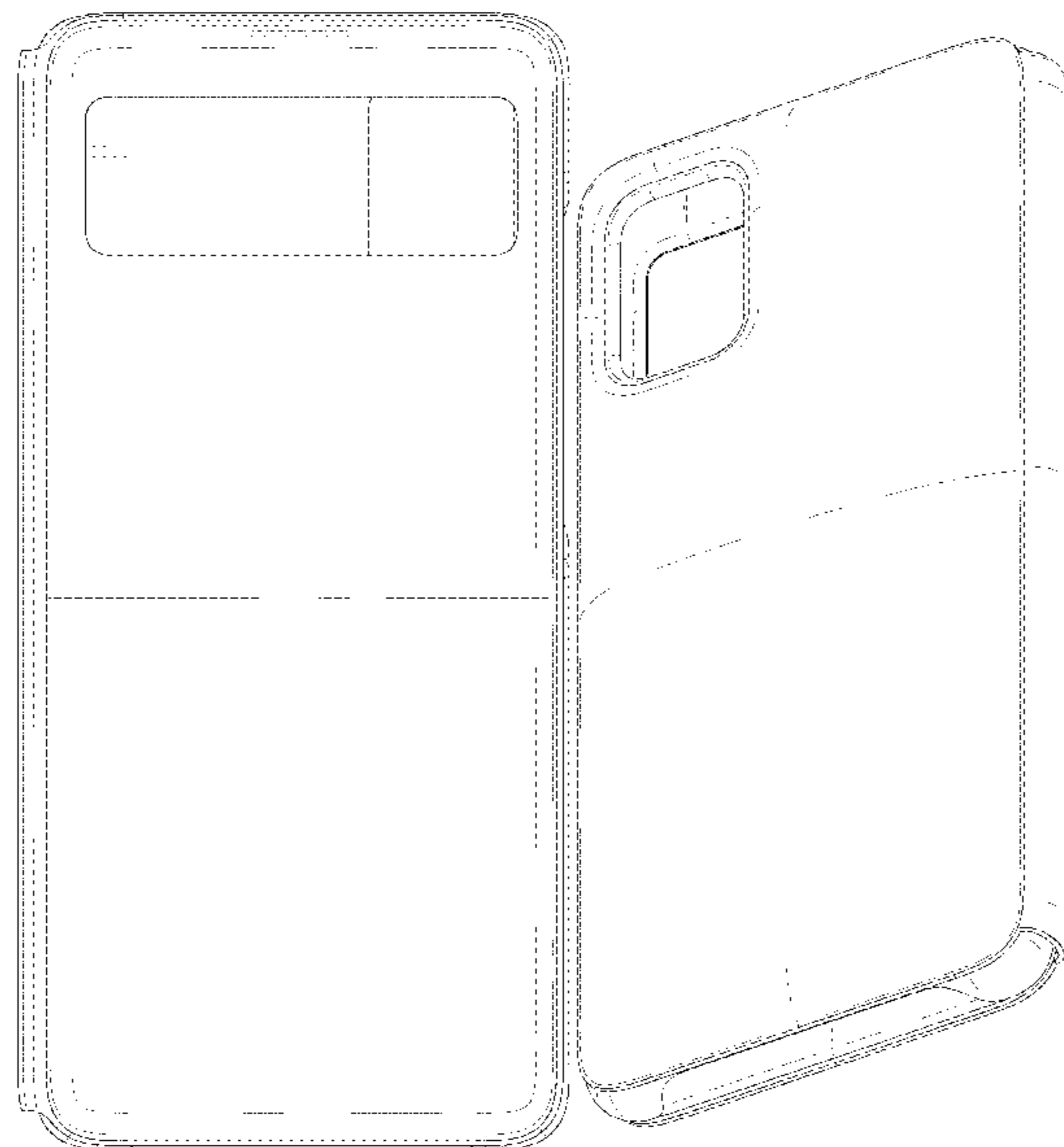
The ornamental design for a case for electronic communications device, as shown and described.

DESCRIPTION

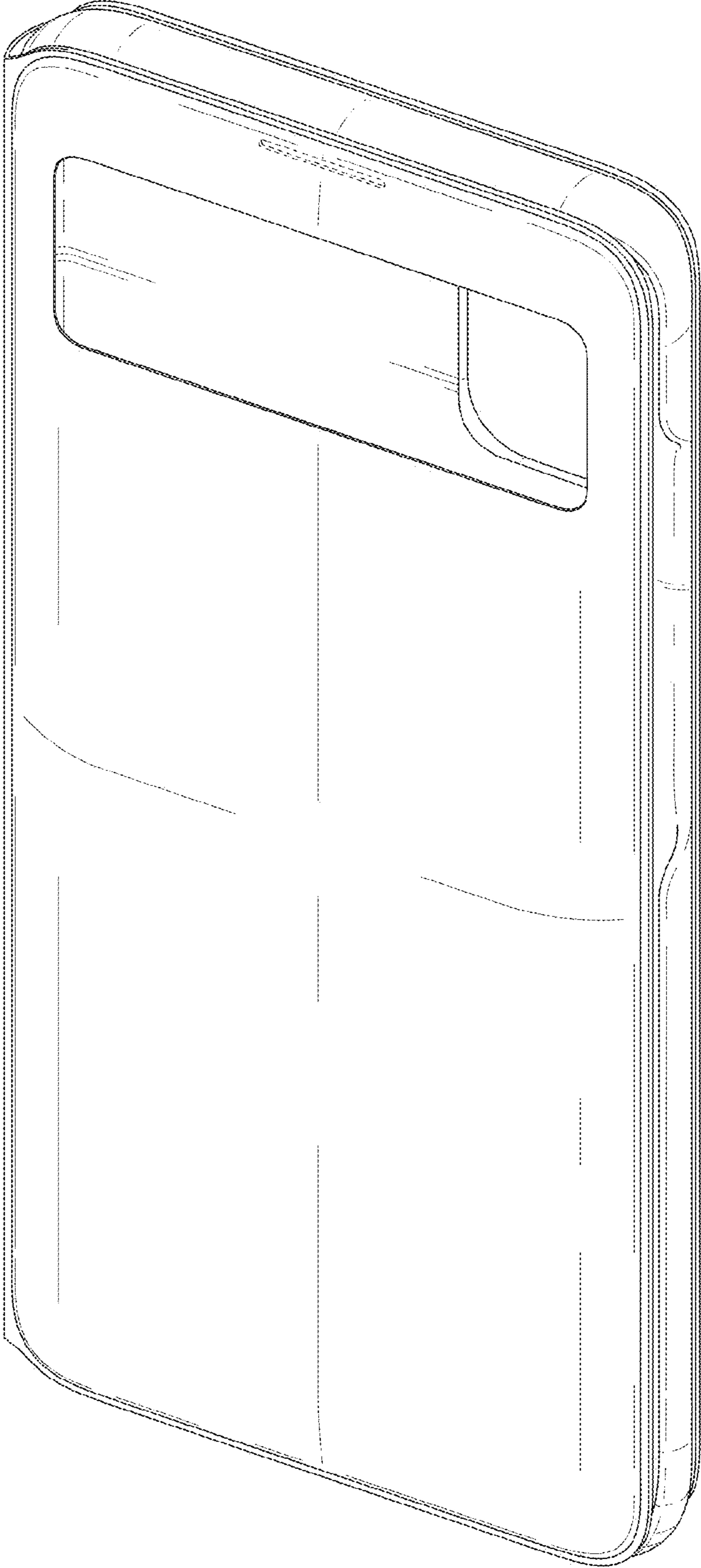

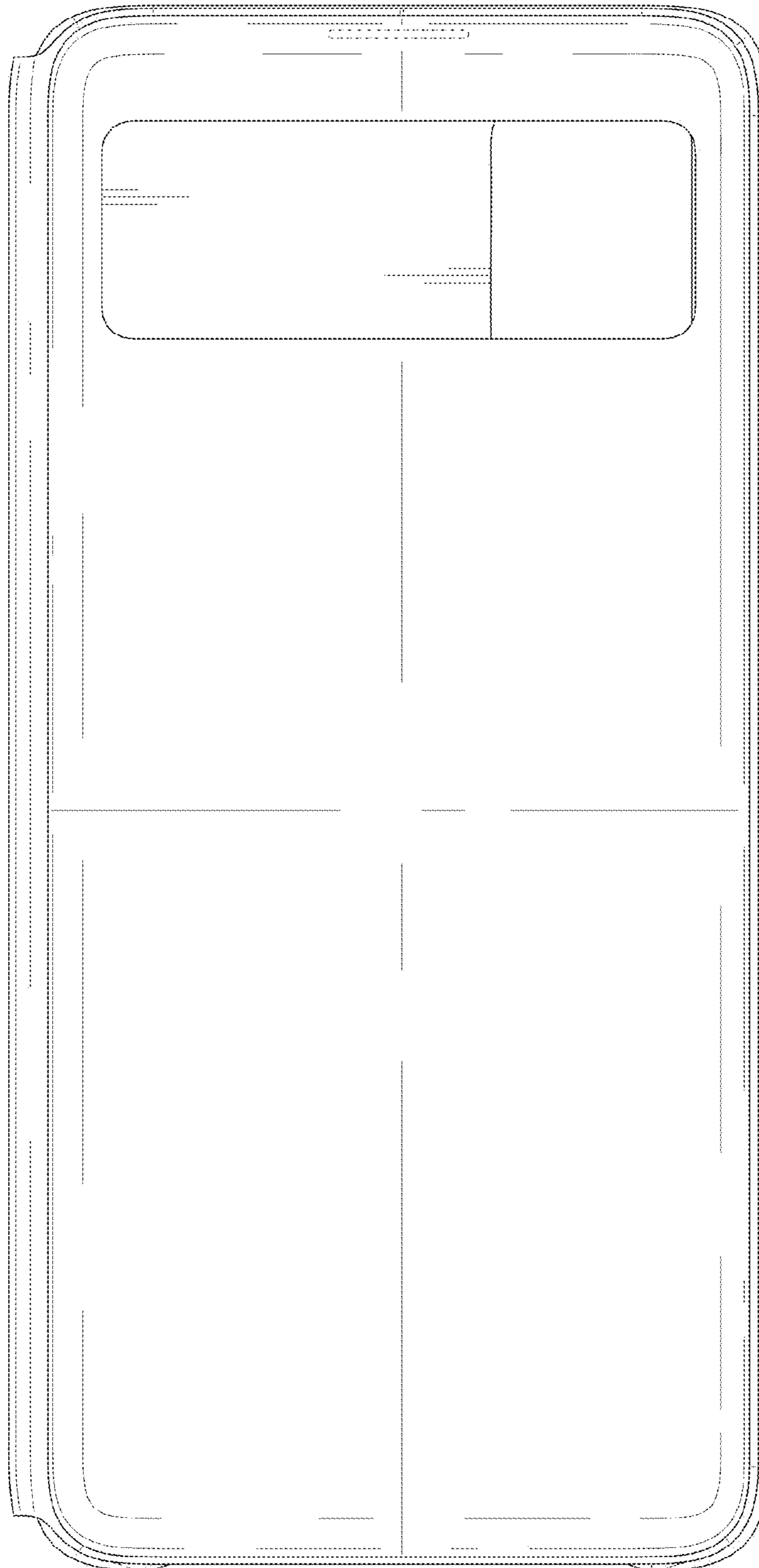

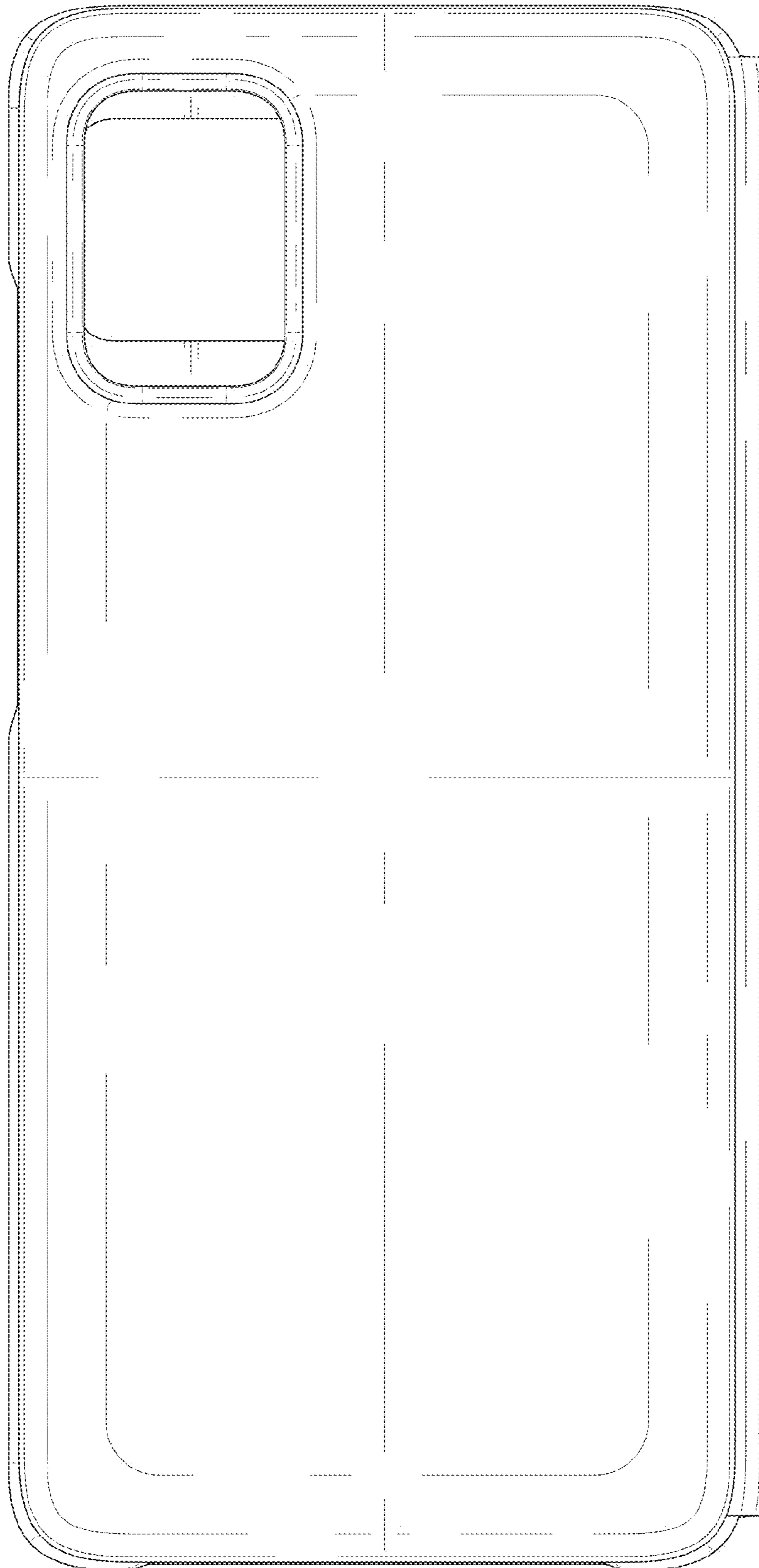

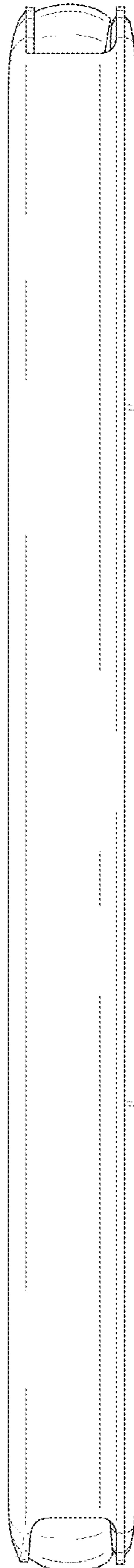

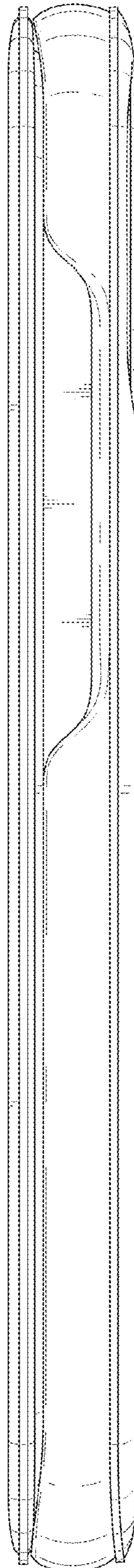

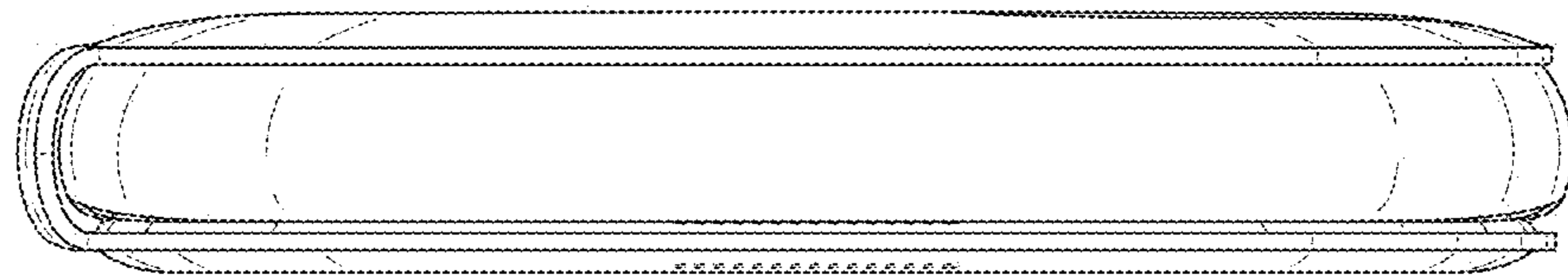

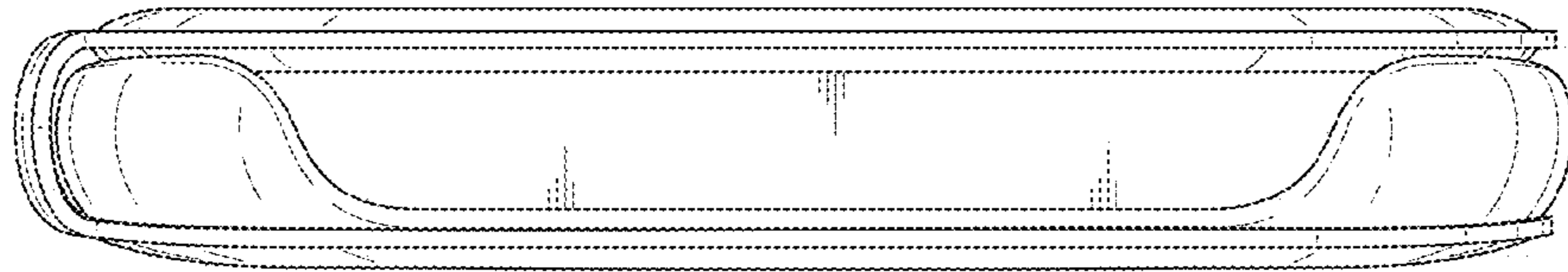
