FIG. 7 is a bottom plan view thereof.

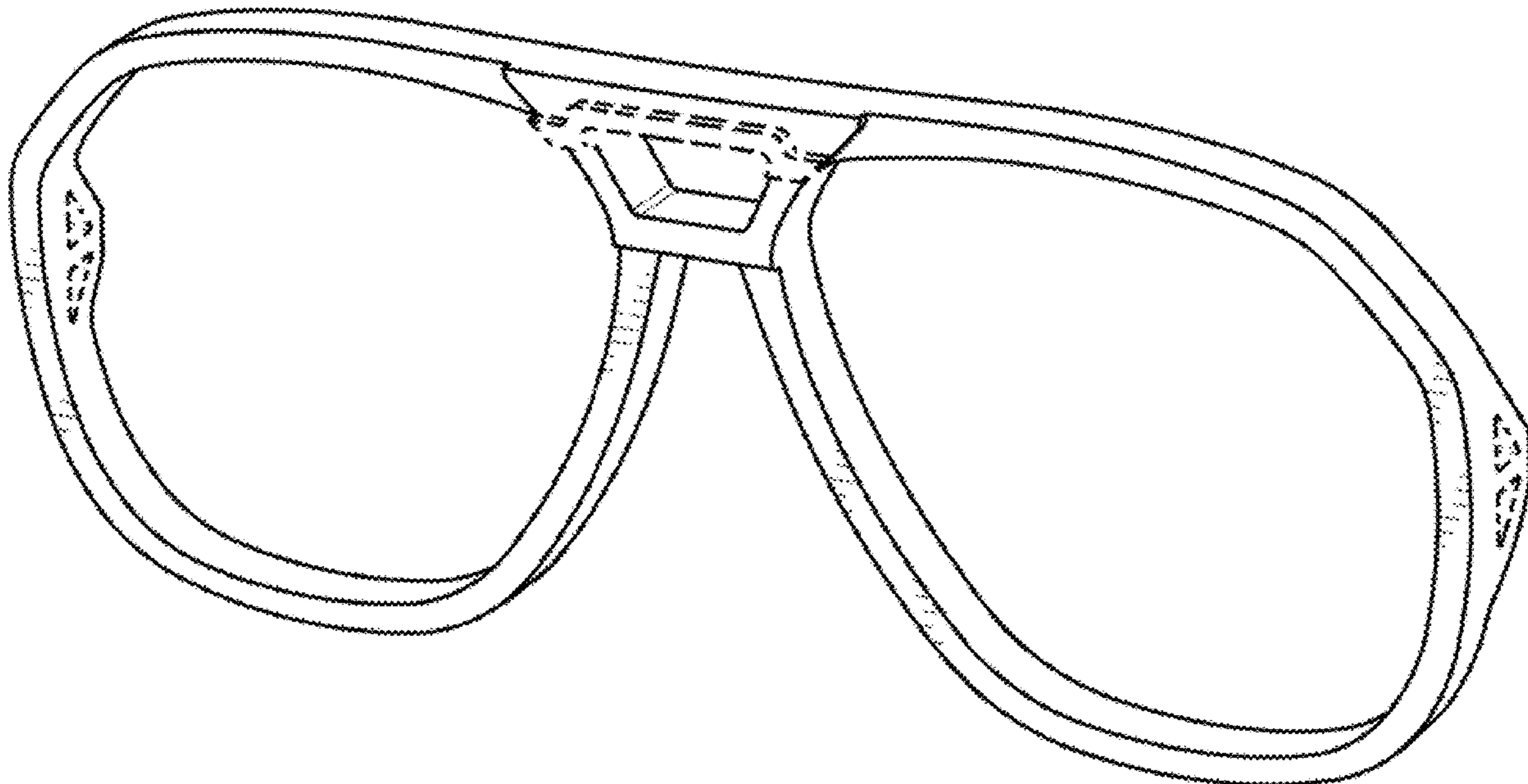
The broken lines in the drawings depict portions of the armless eyewear and form no part of the claimed design.

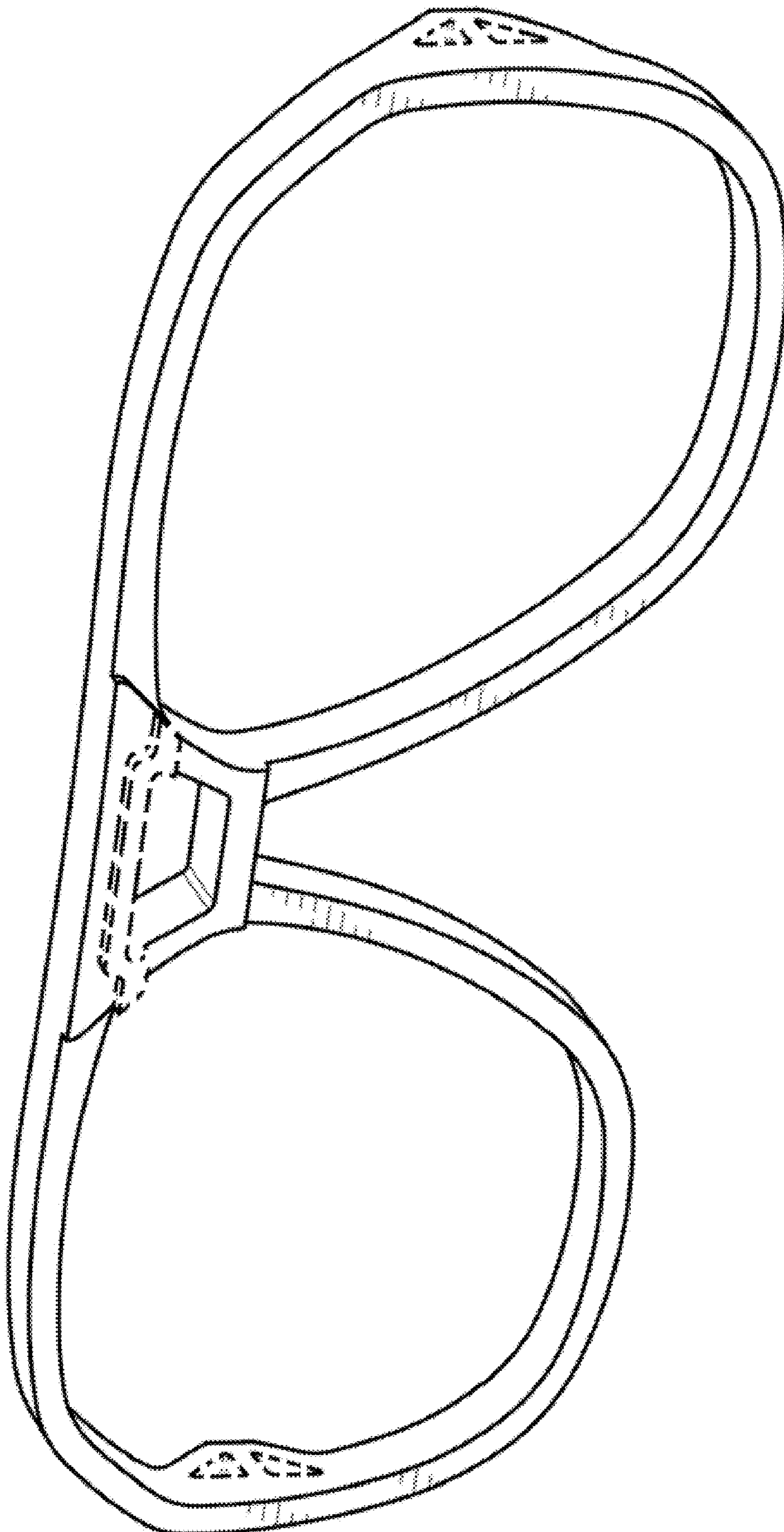

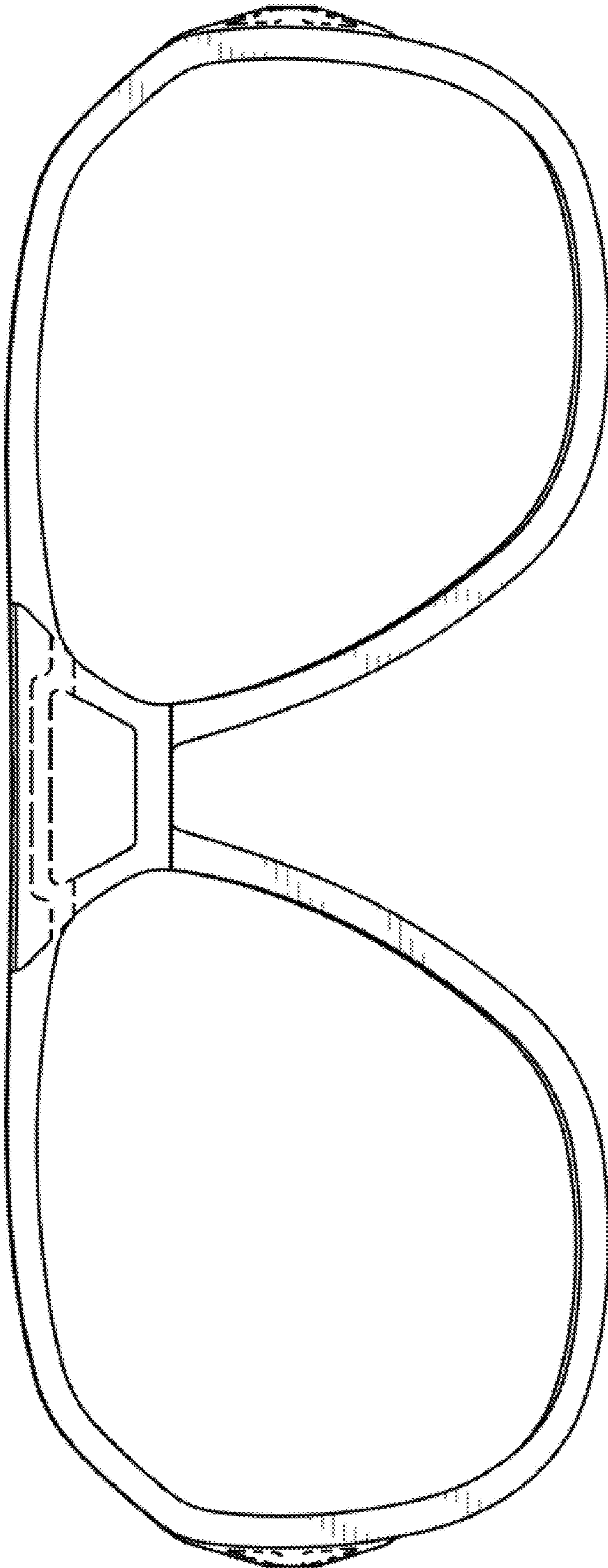

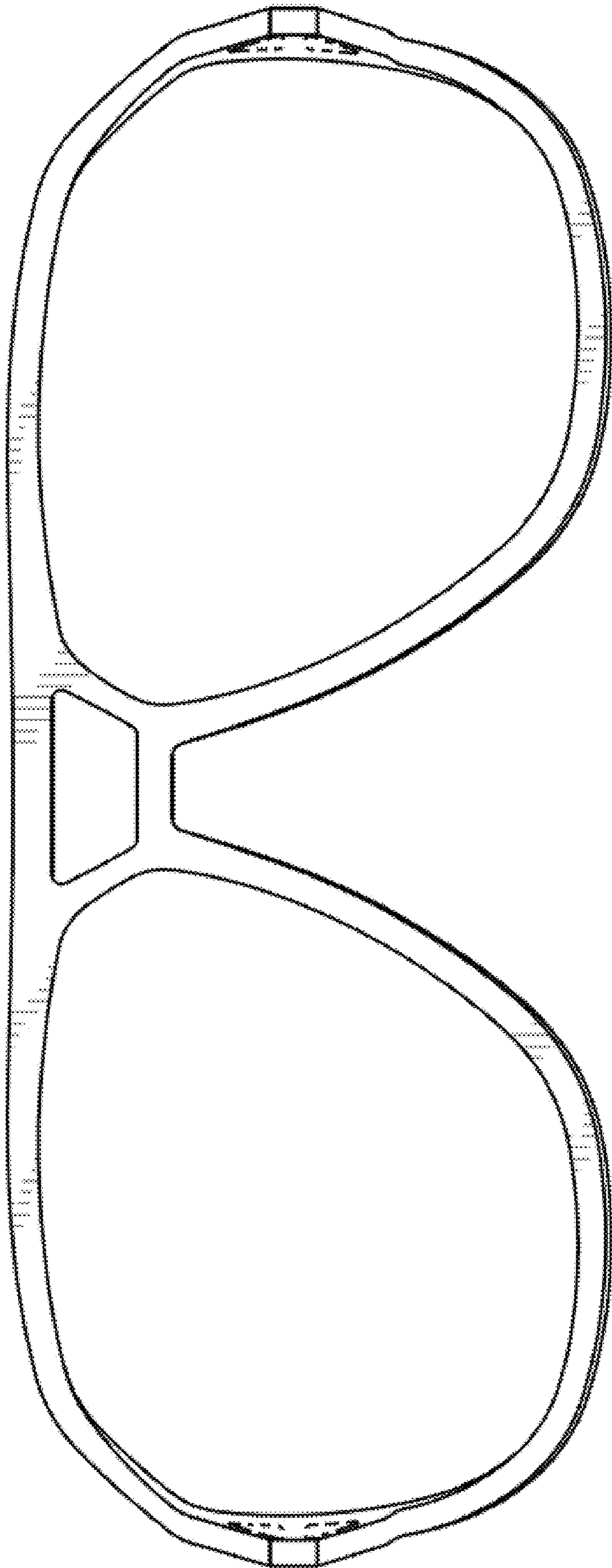

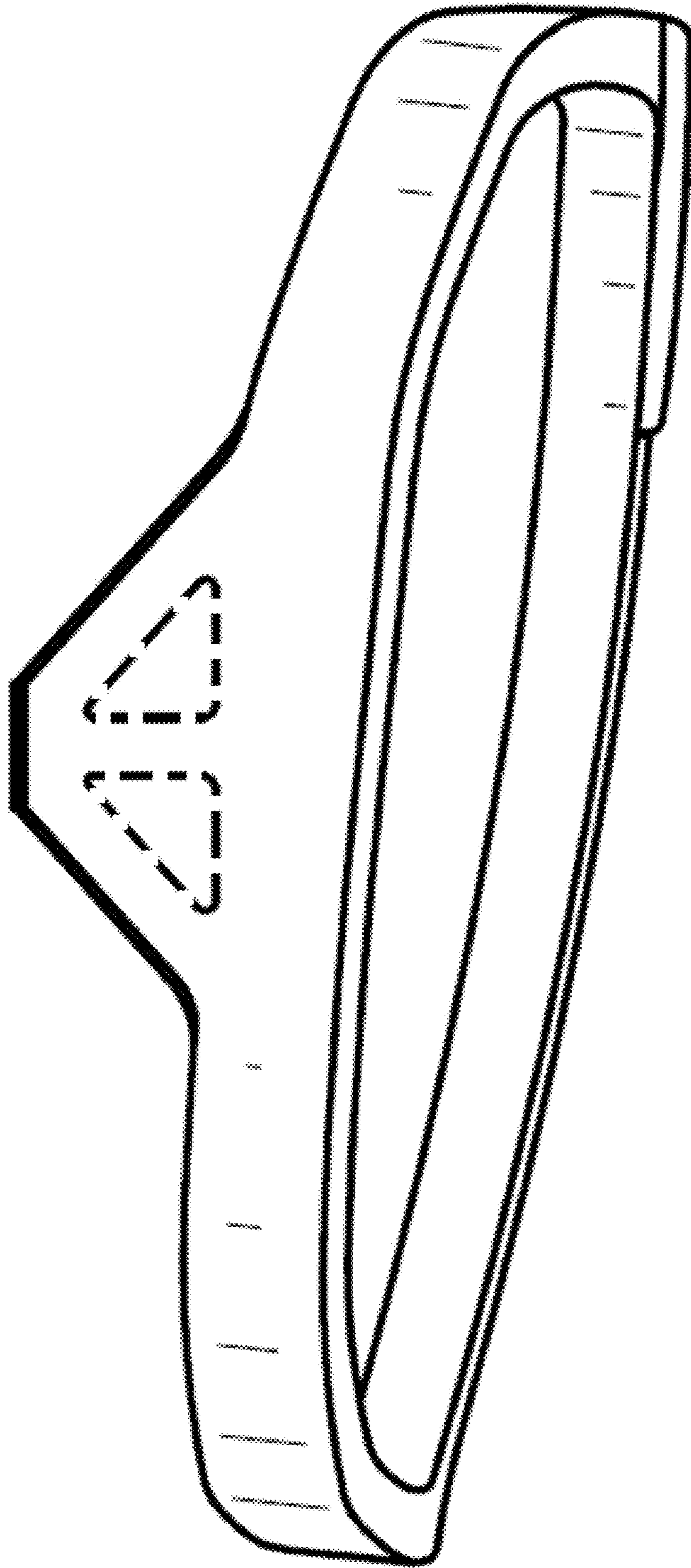

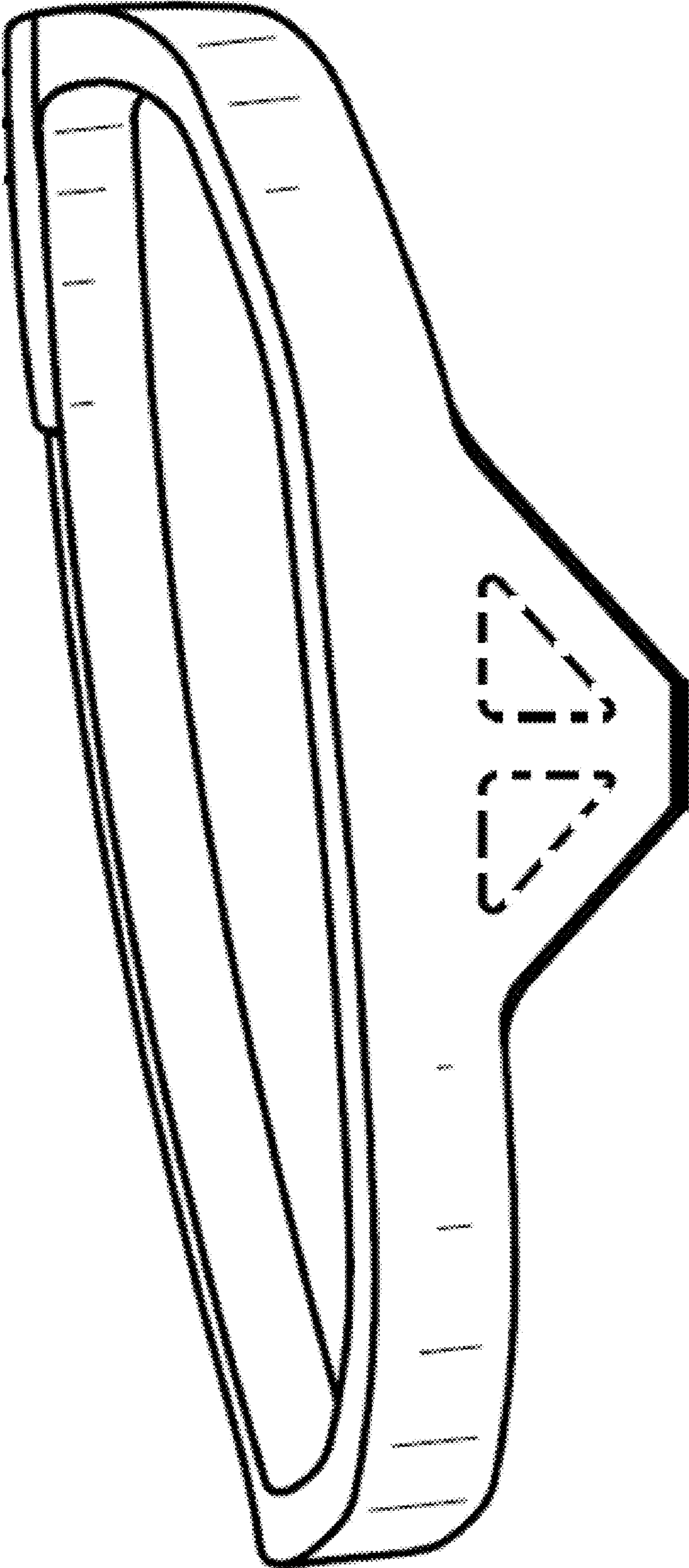

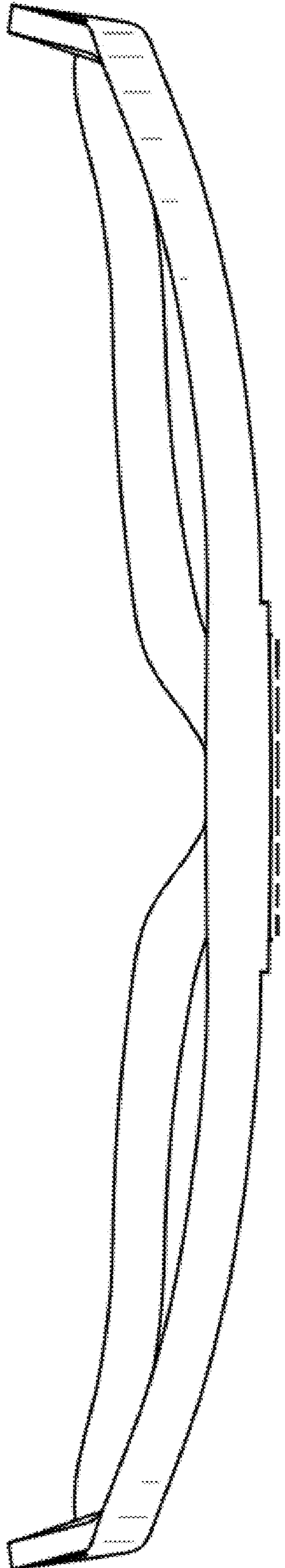

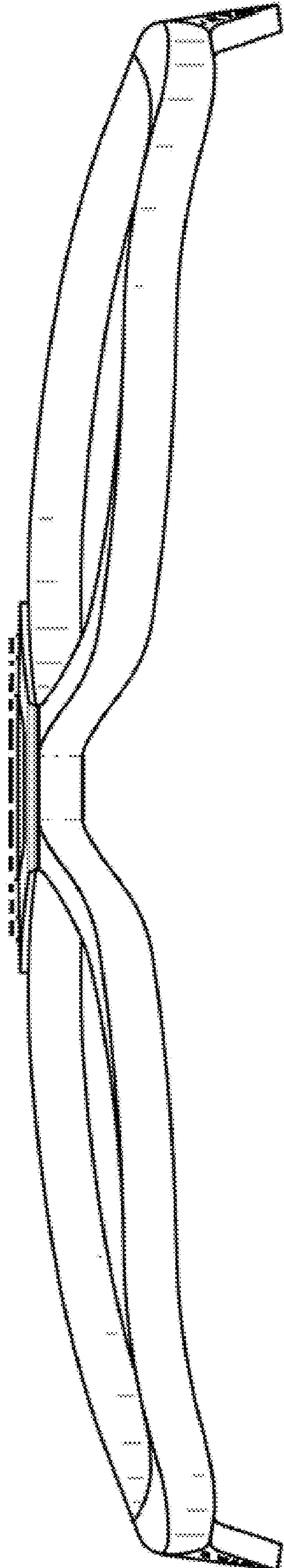
