(57) **CLAIM**

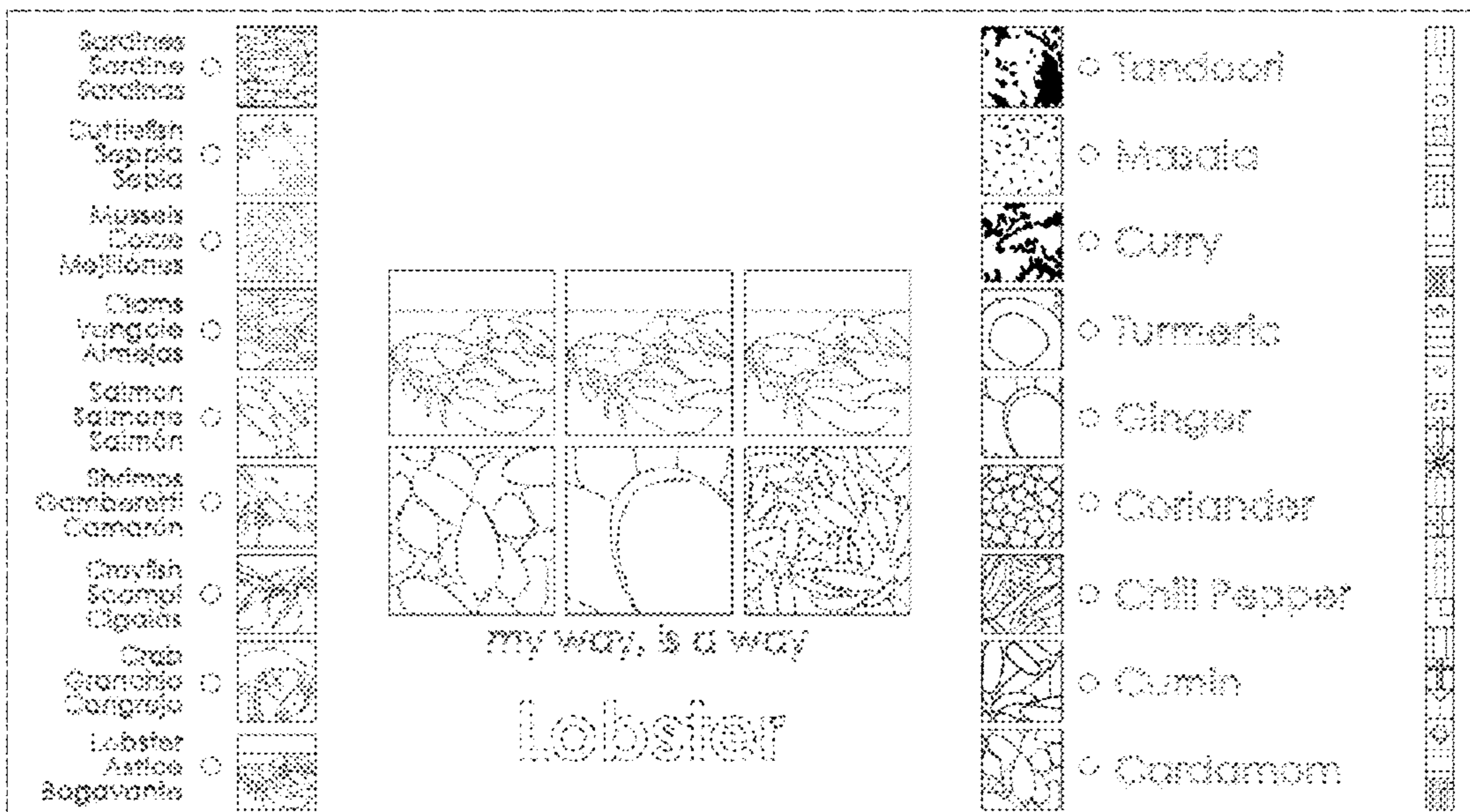
The ornamental design for a label, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a label, showing my new design;
 FIG. 2 is a back view thereof;
 FIG. 3 is a left side view thereof, the right side view being identical thereto; and,
 FIG. 4 is a top view thereof, the bottom view being identical thereto.

The uneven length broken lines illustrate the boundary of the claimed design and form no part thereof. The even length broken lines illustrate portions of the label that form no part of the claimed design.

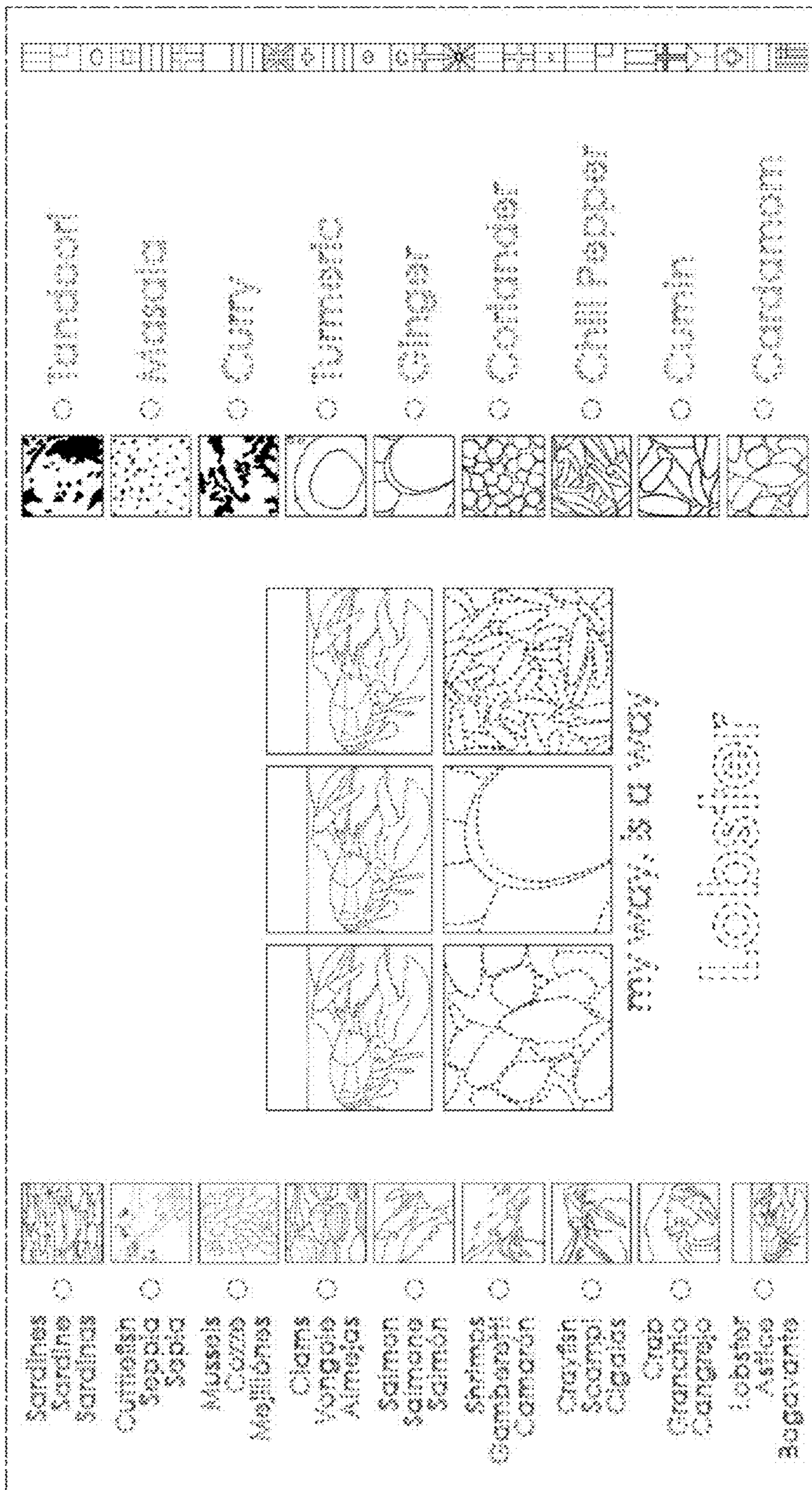

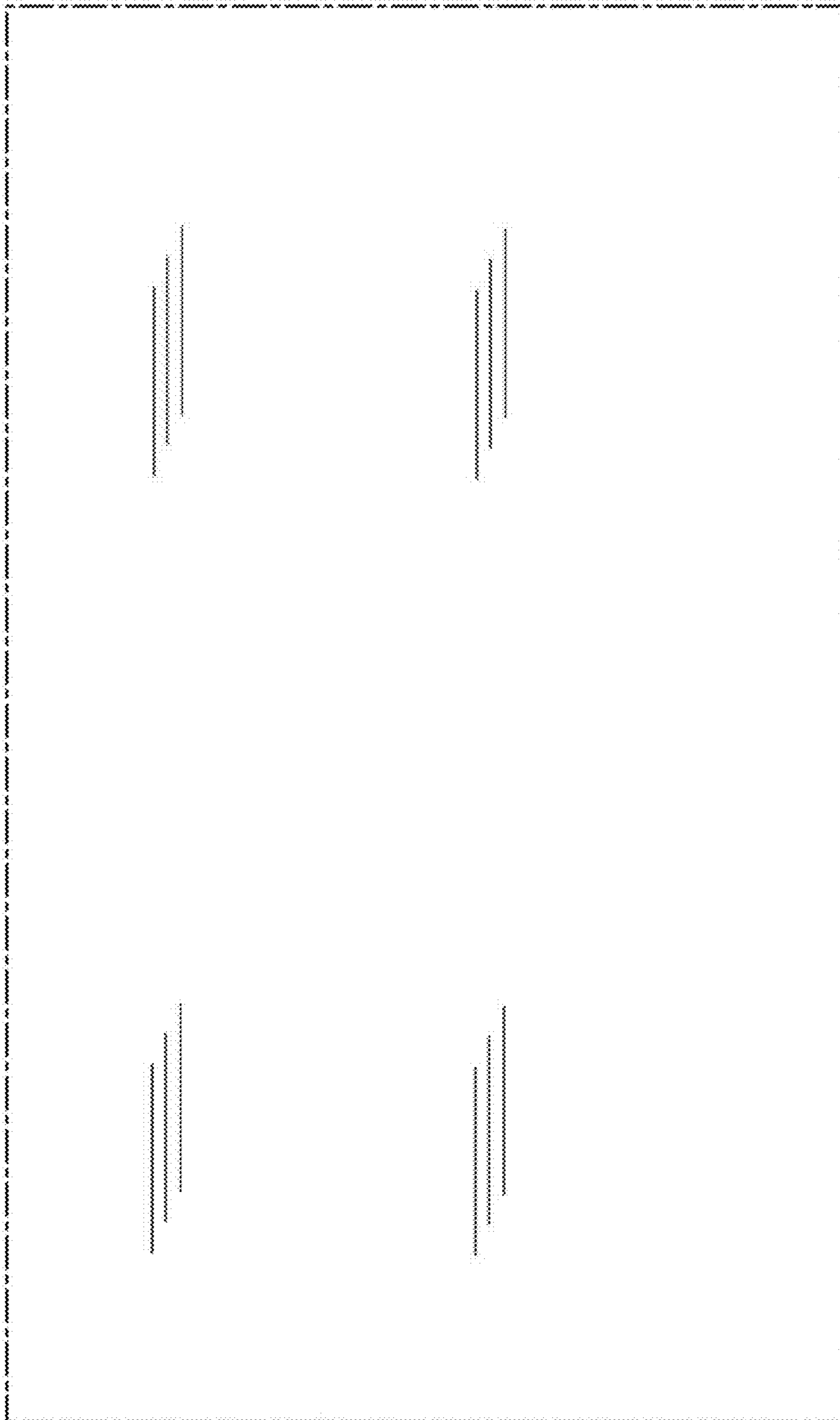

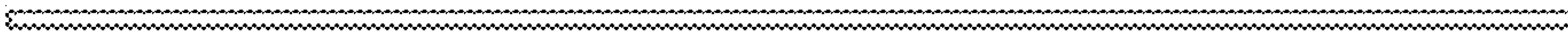
