FIG. 1 is a front view of gold armor showing our new design, shown in color;

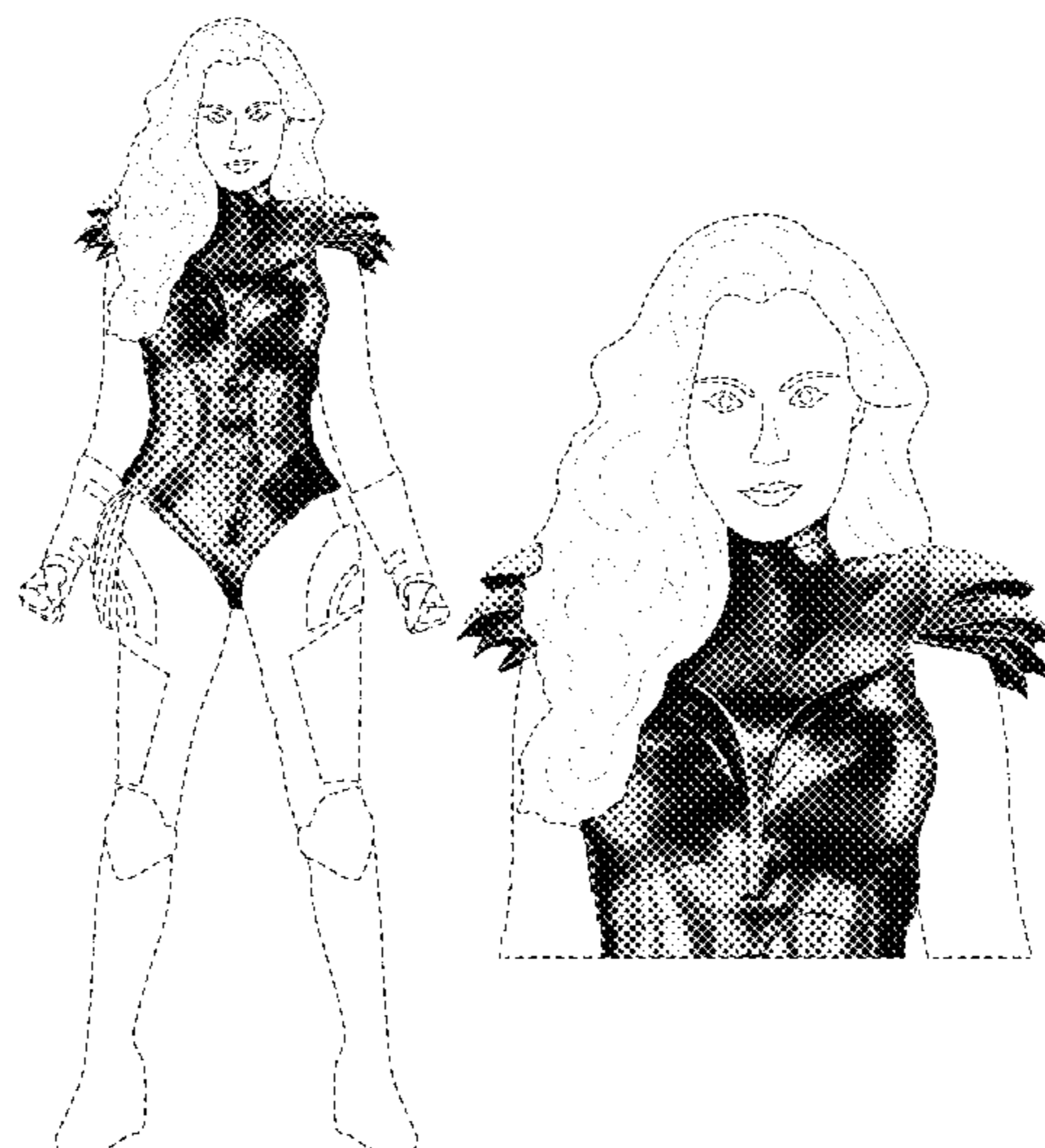
FIG. 2 is an enlarged view thereof;

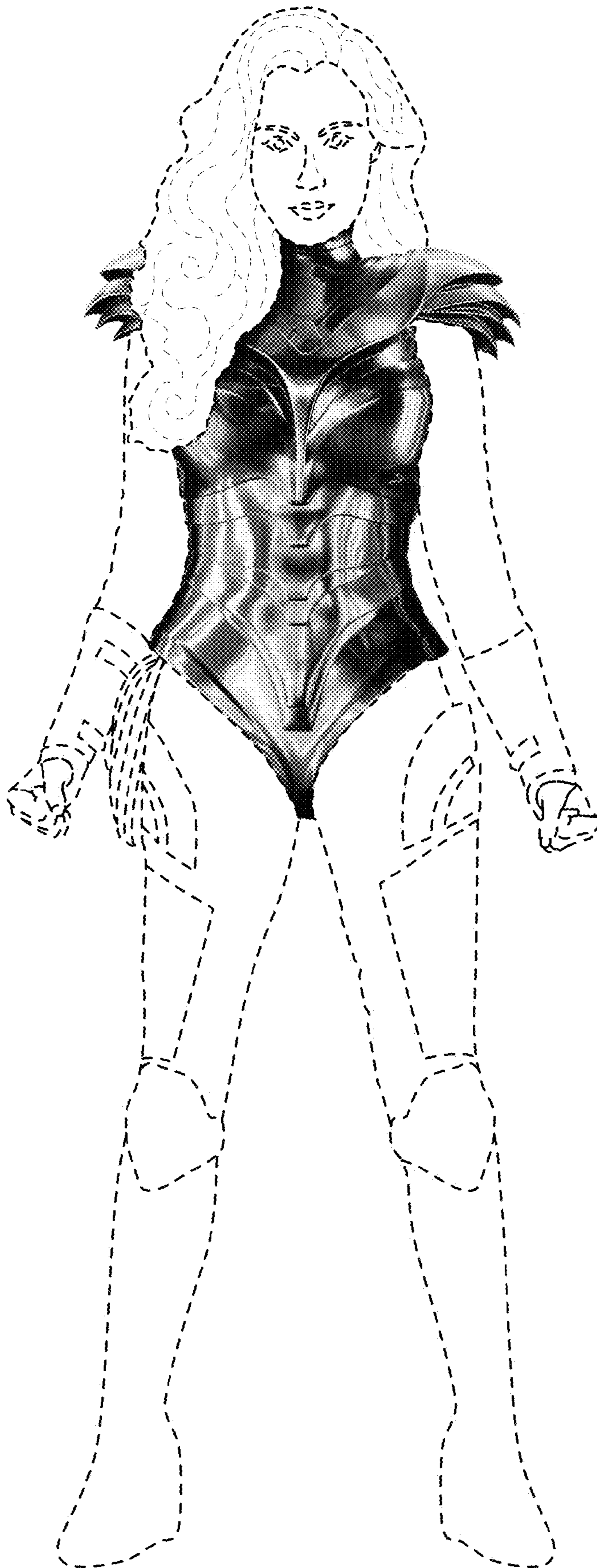

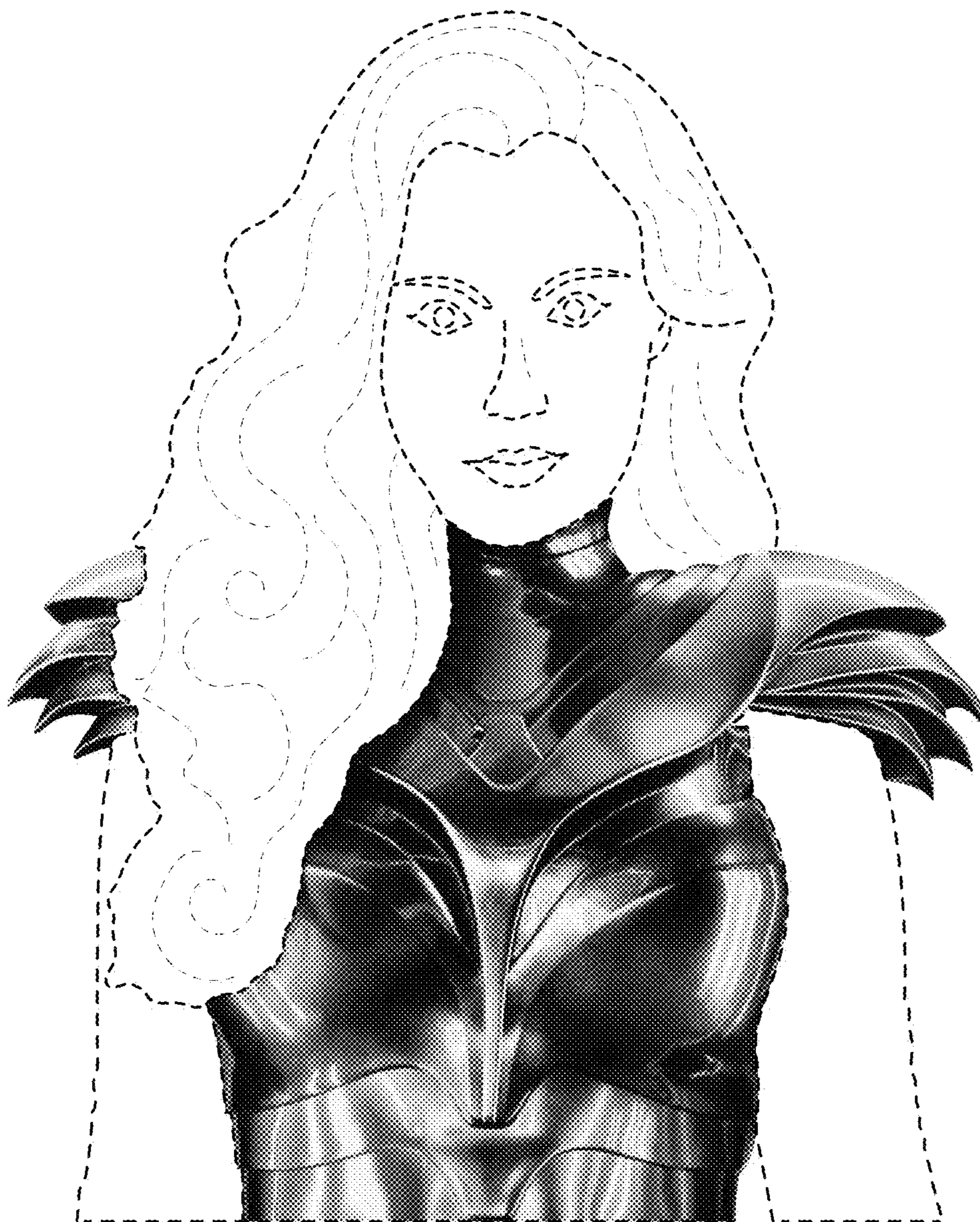

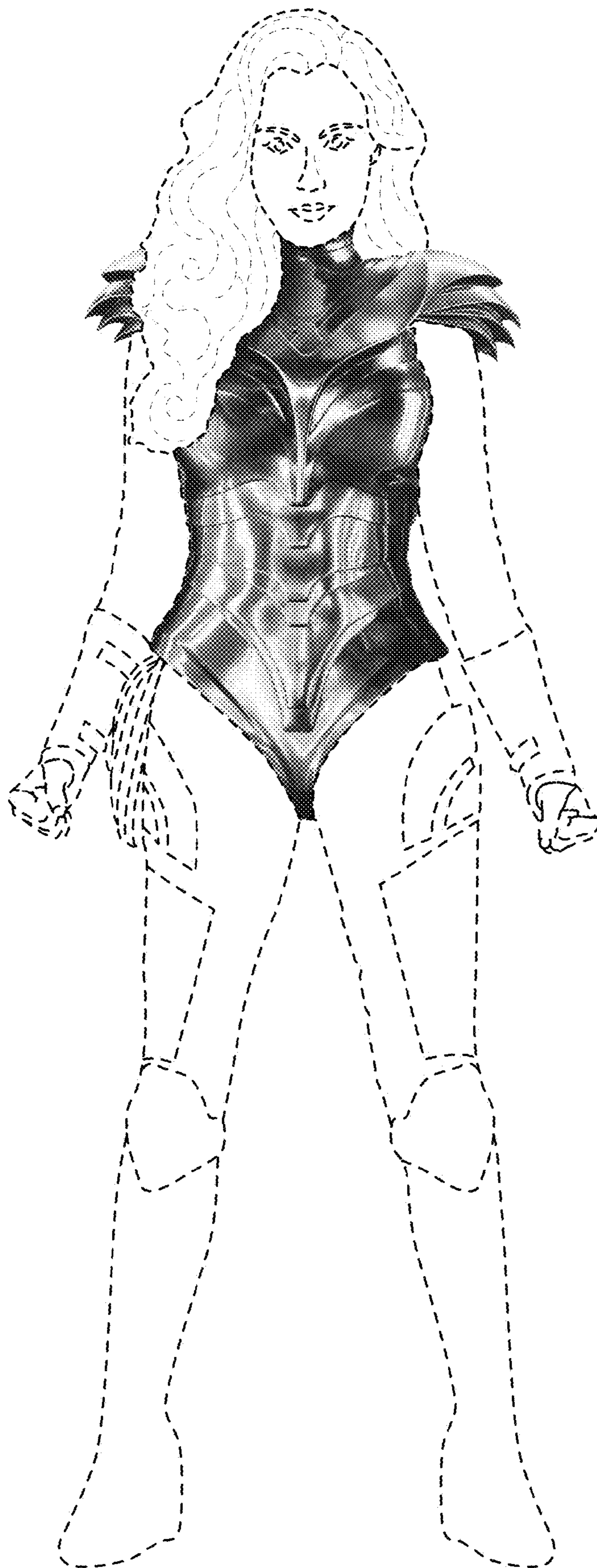

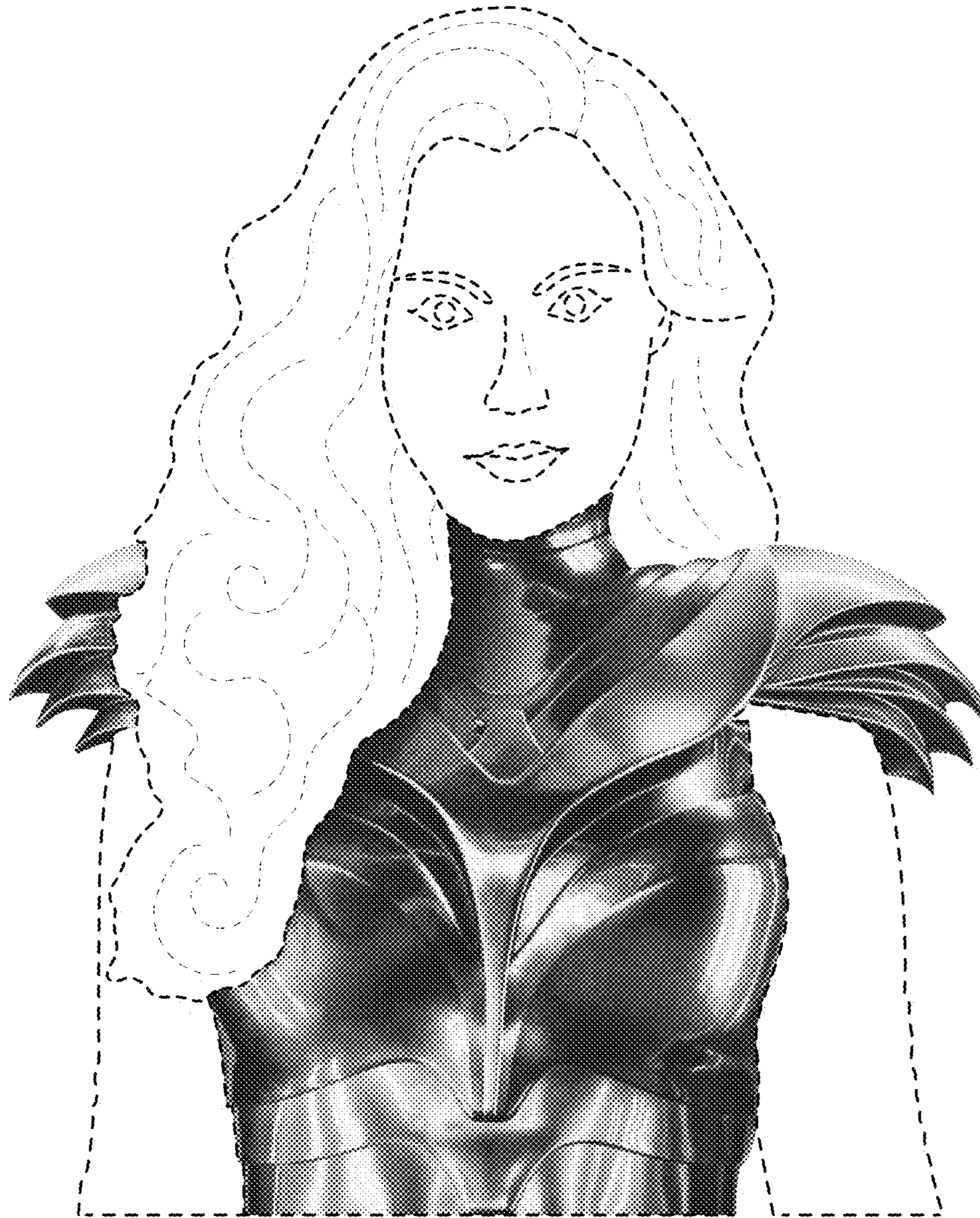
