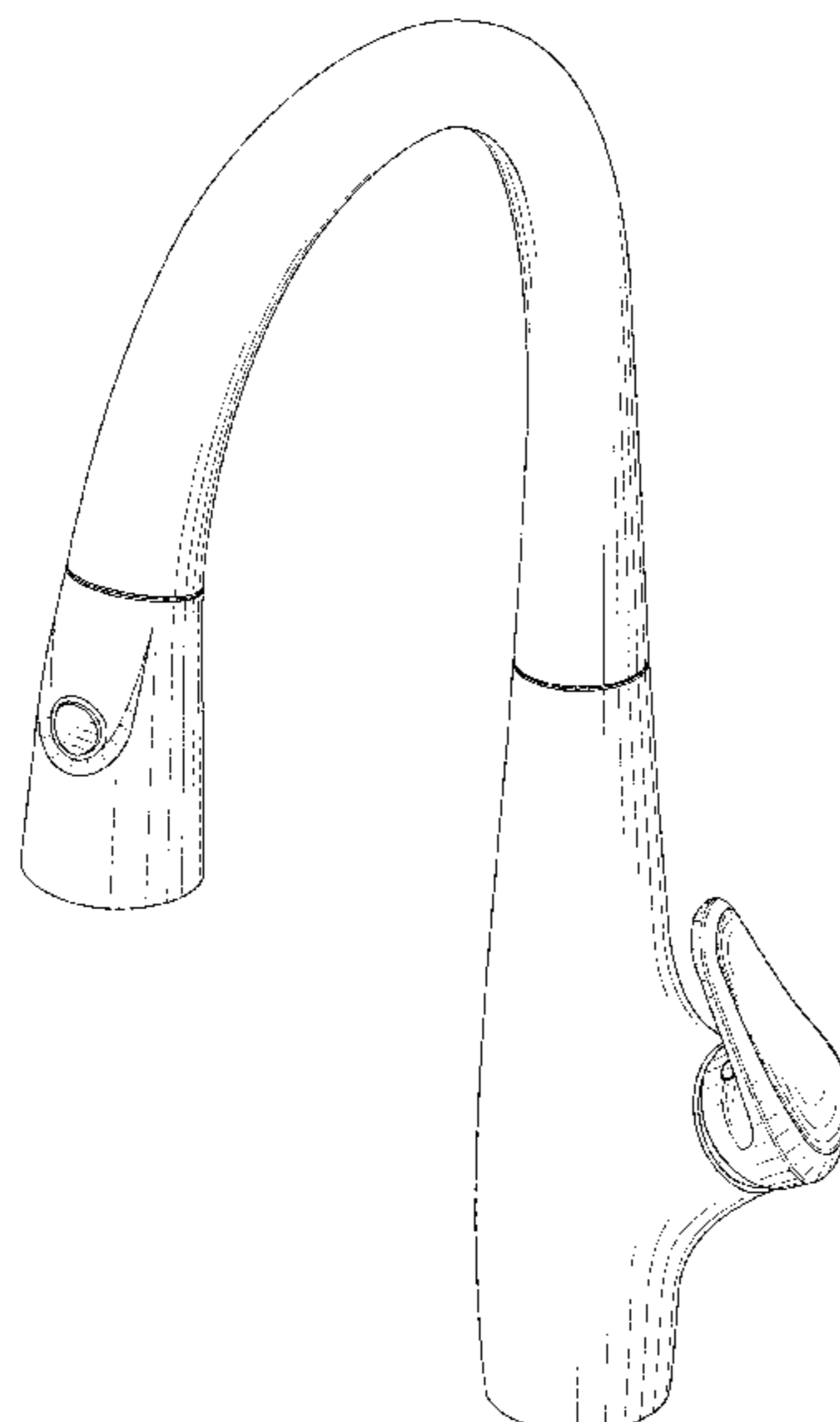
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, right side perspective view of a faucet showing my new design;
FIG. 2 is a front view thereof;

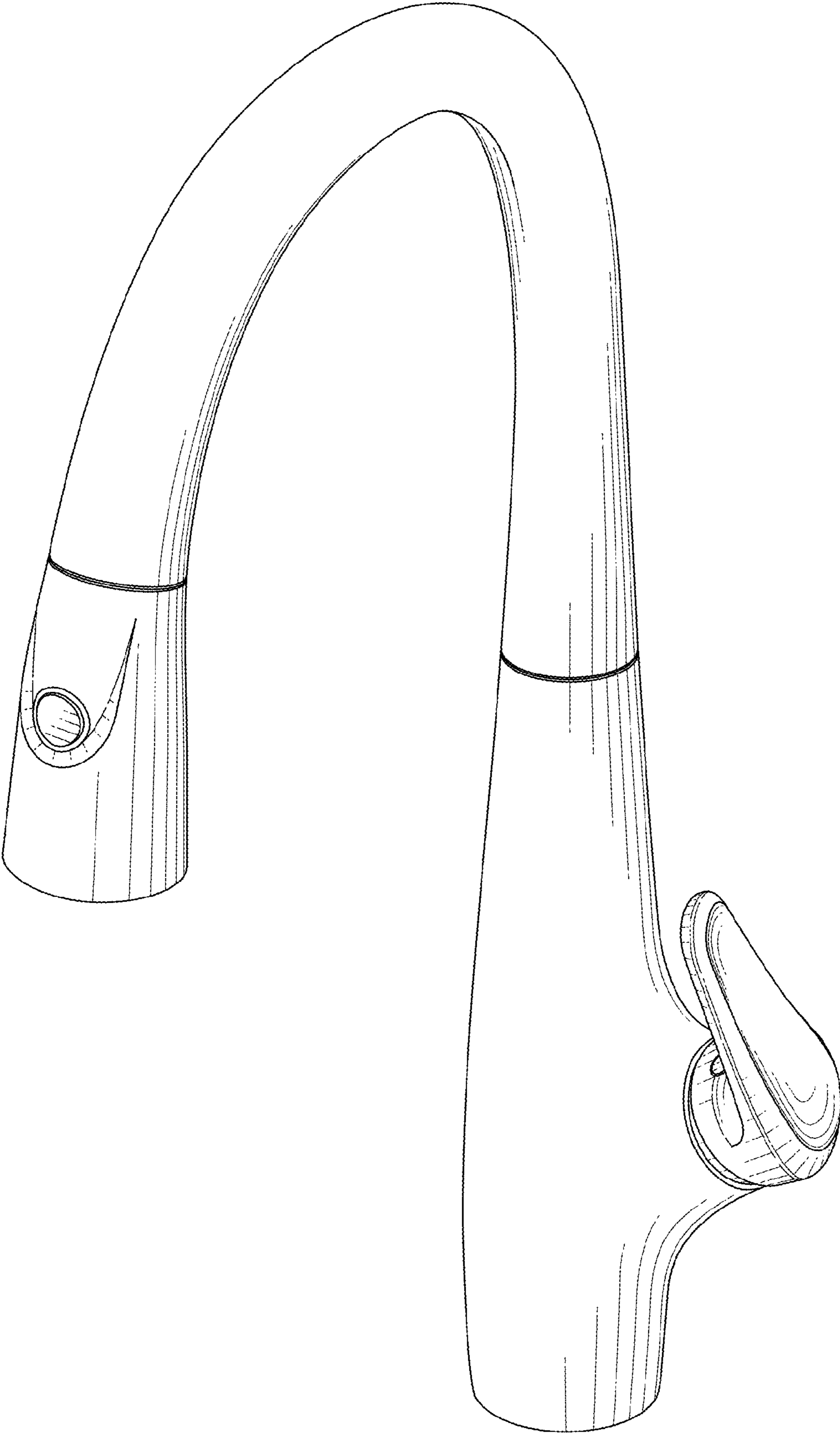

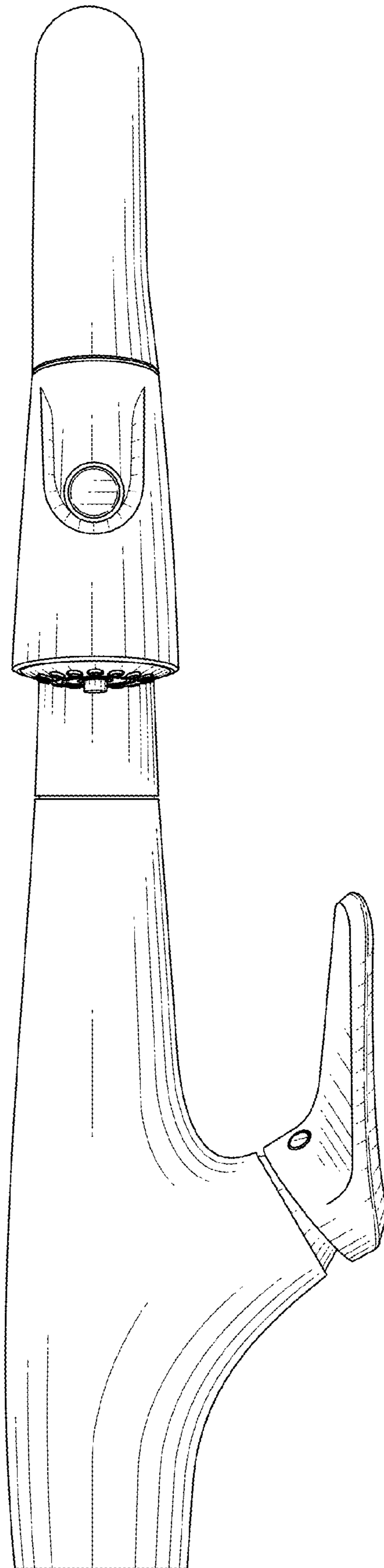

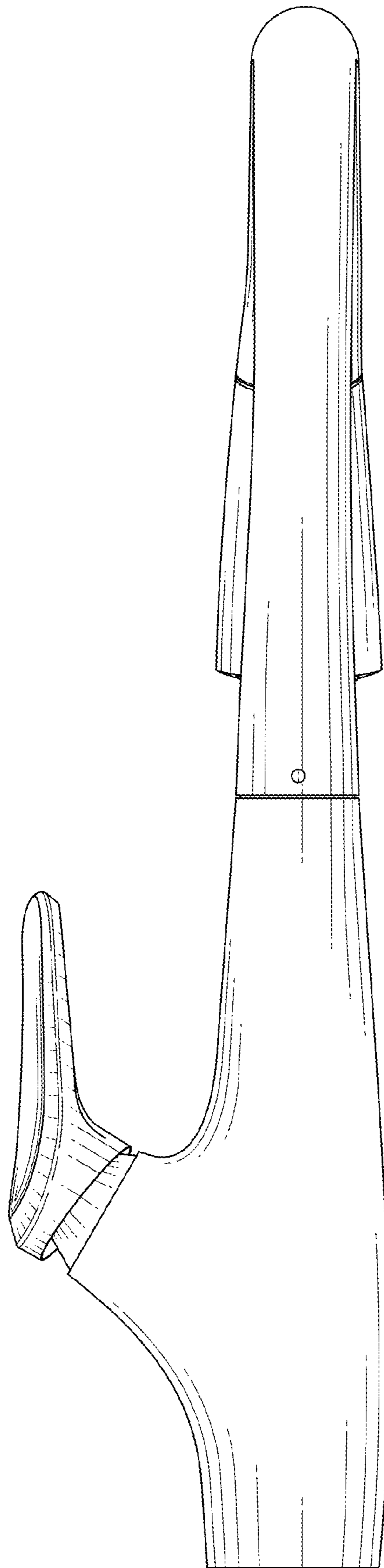

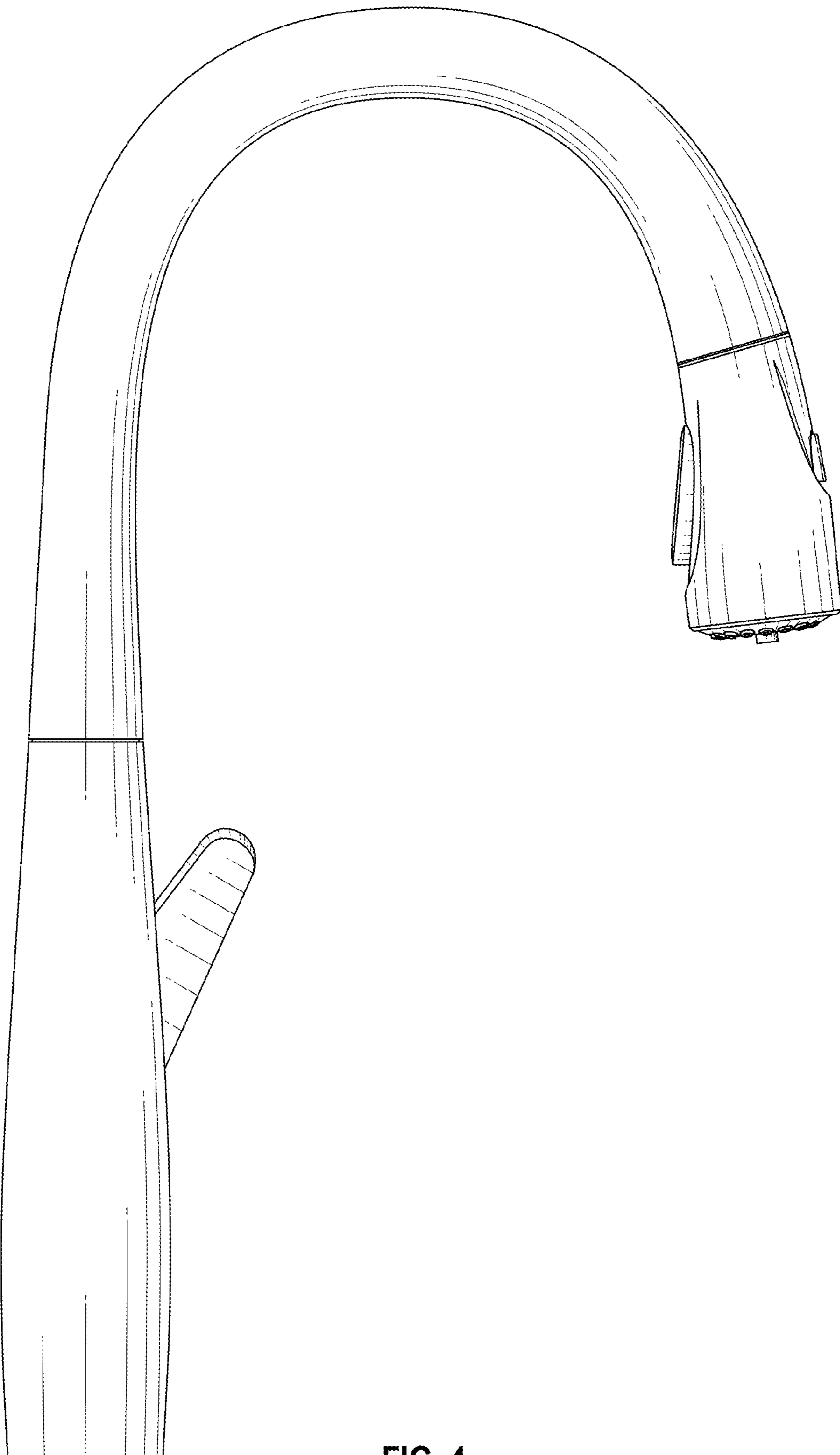

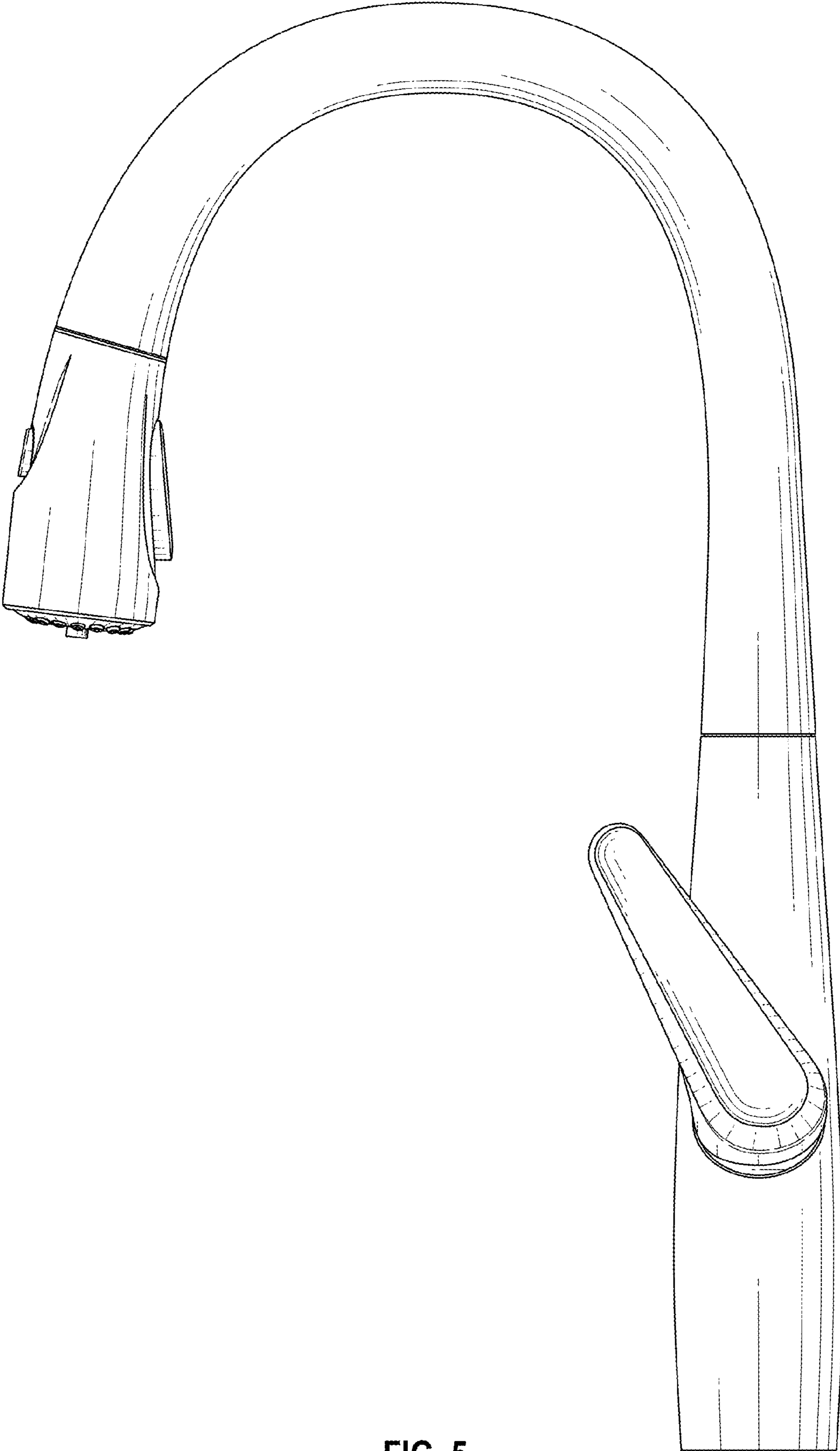

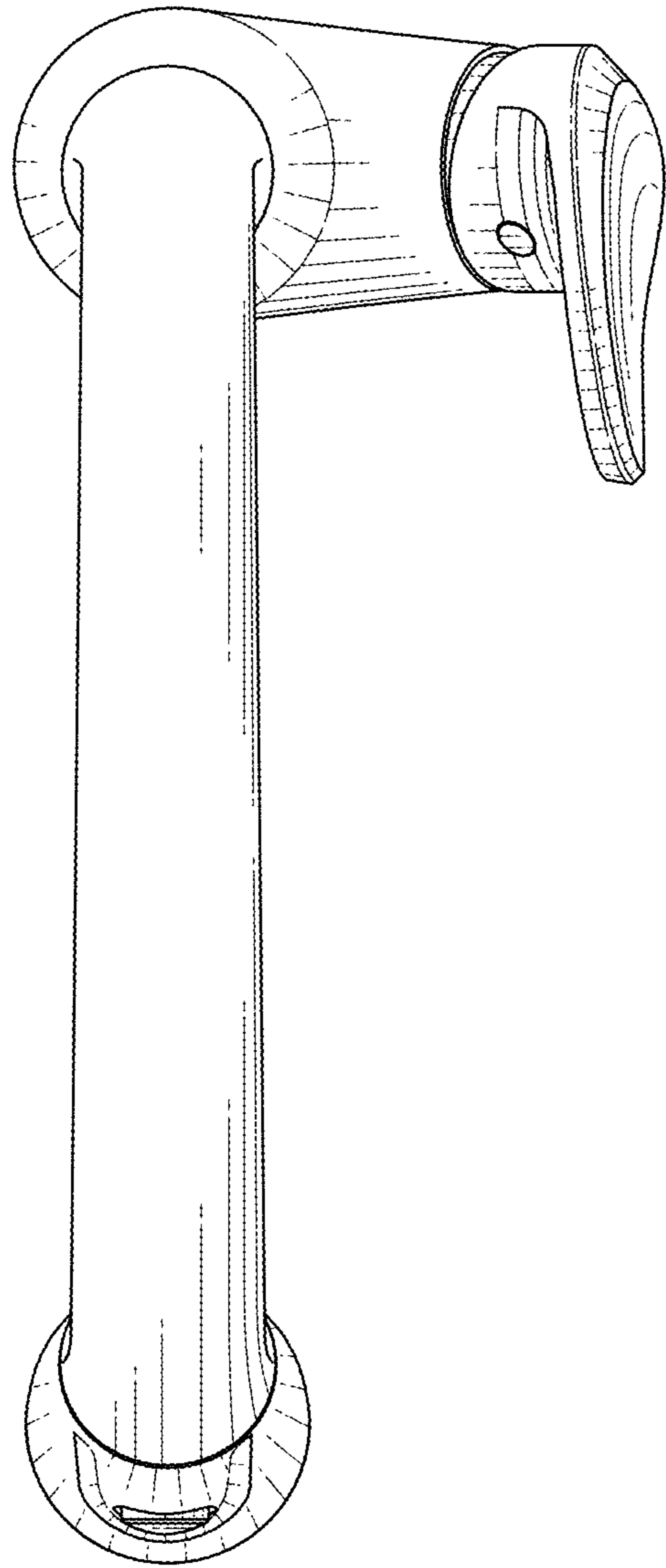

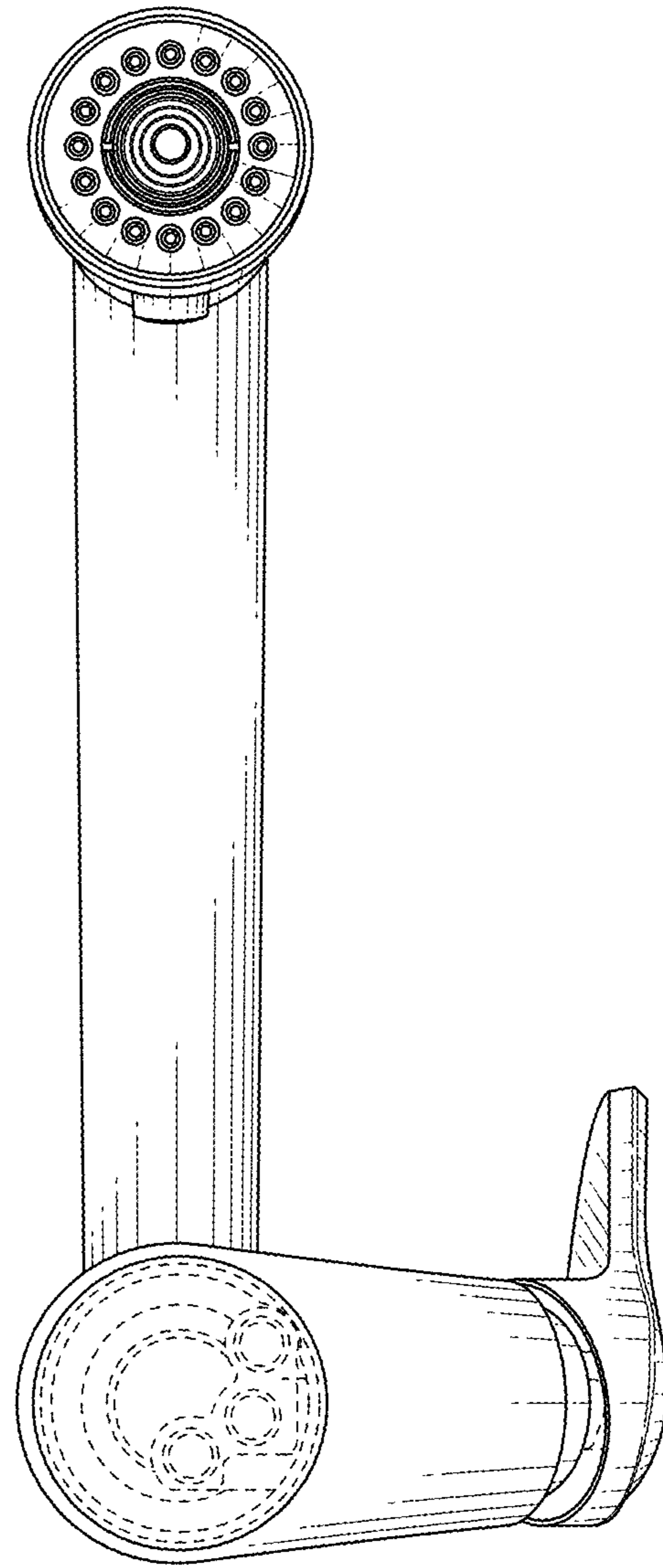
