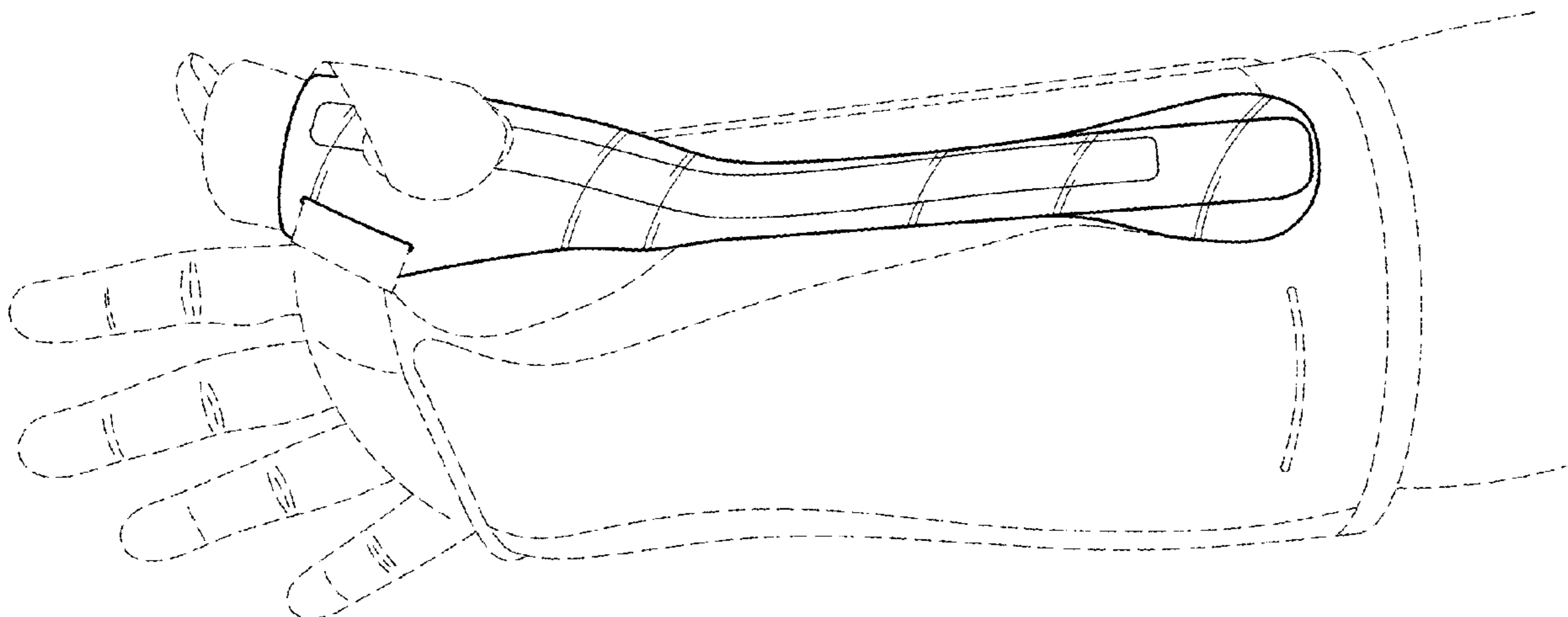
(57) **CLAIM**

The ornamental design for a thumb spica for a wrist brace, as shown and described.

DESCRIPTION

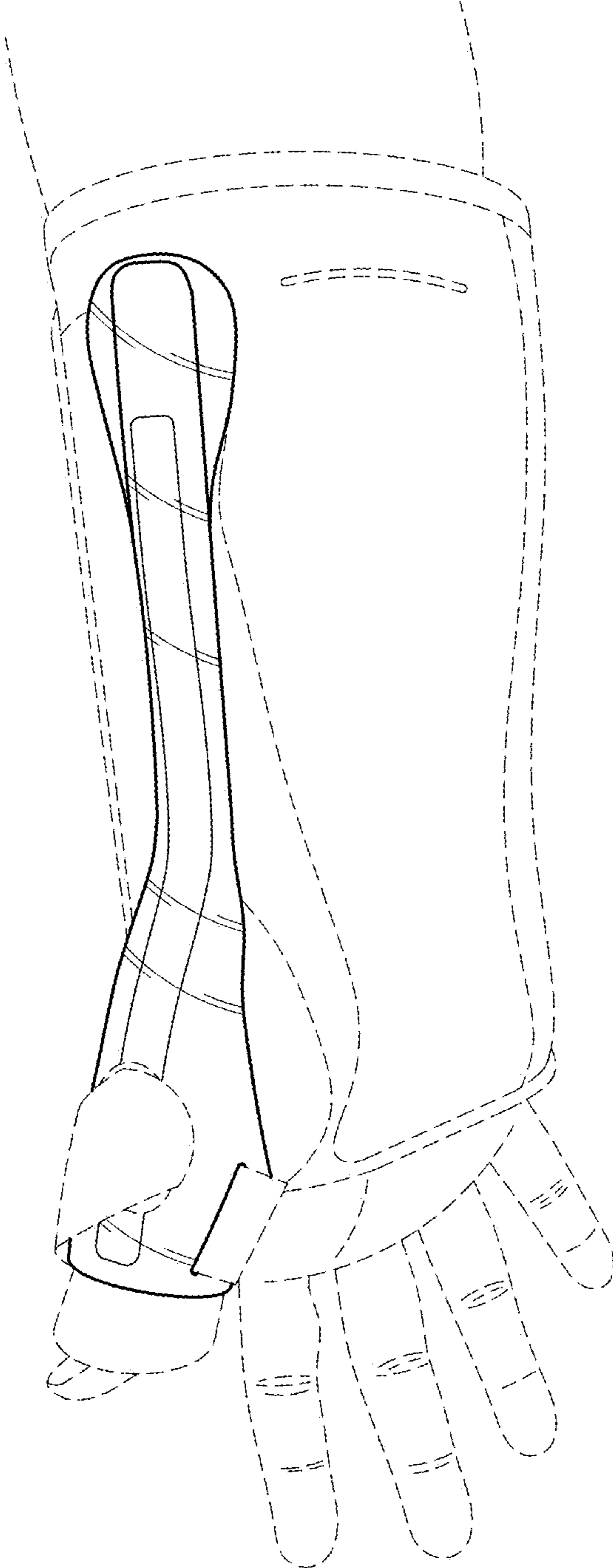

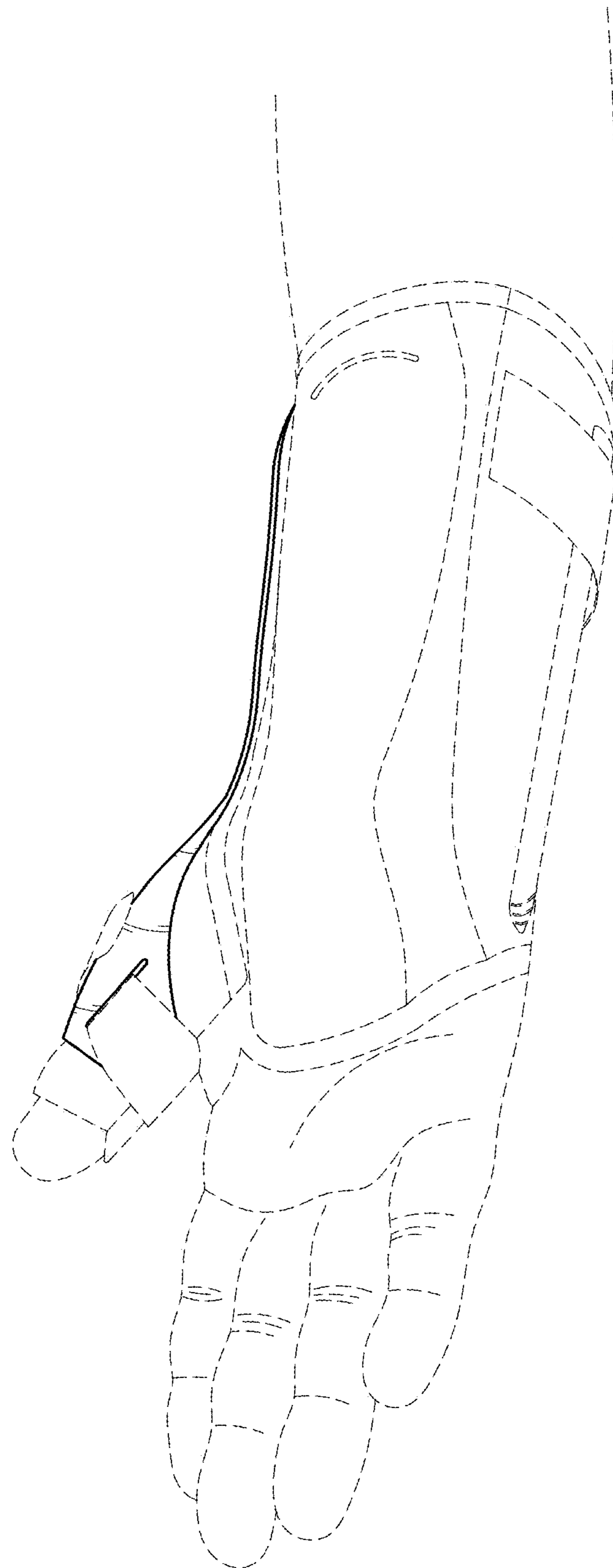

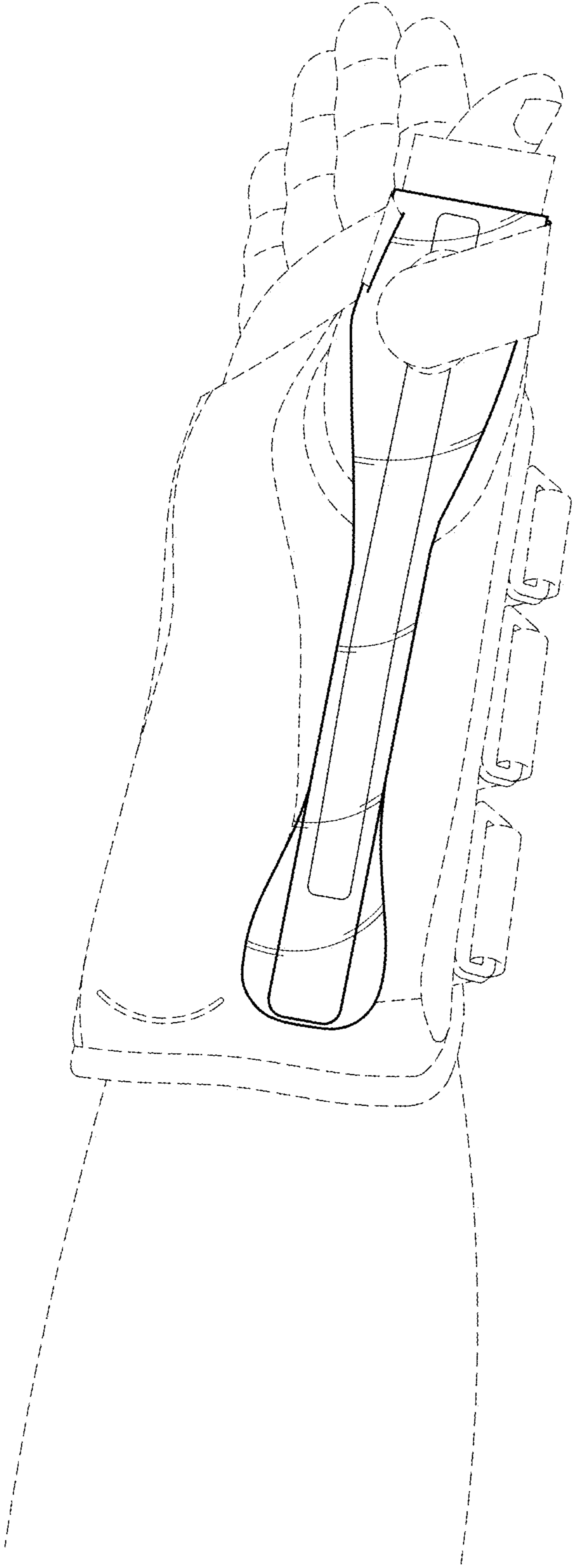

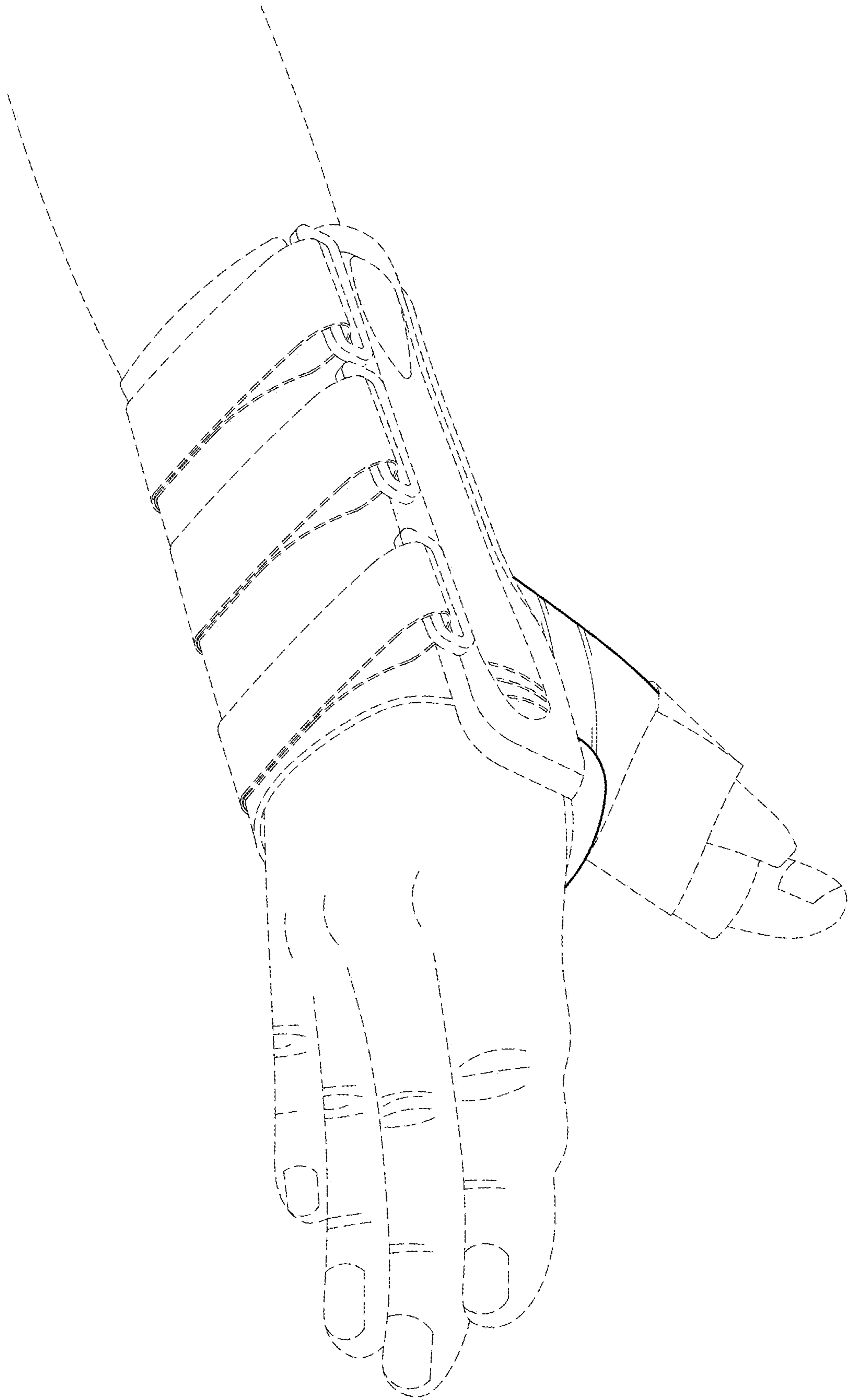

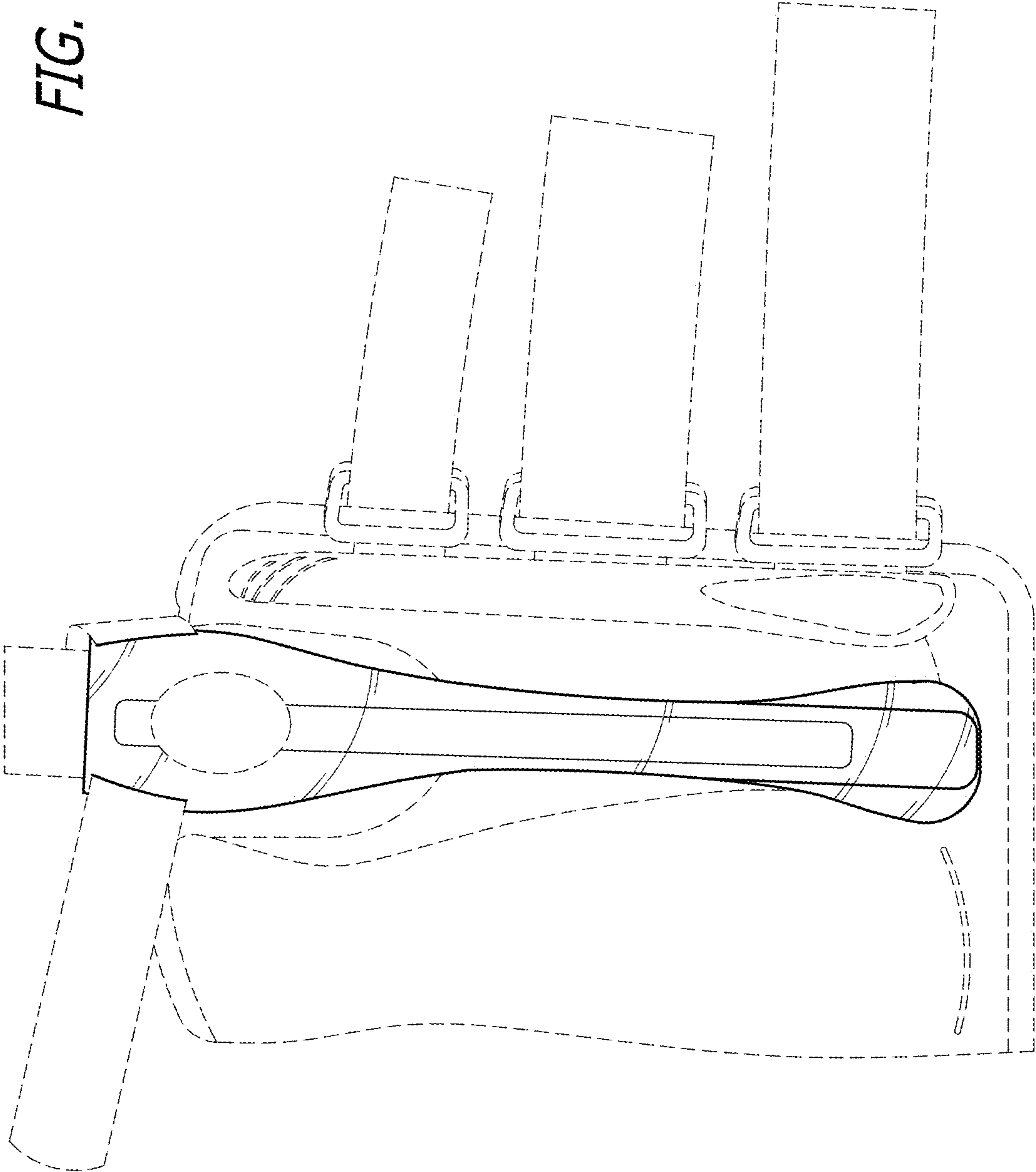

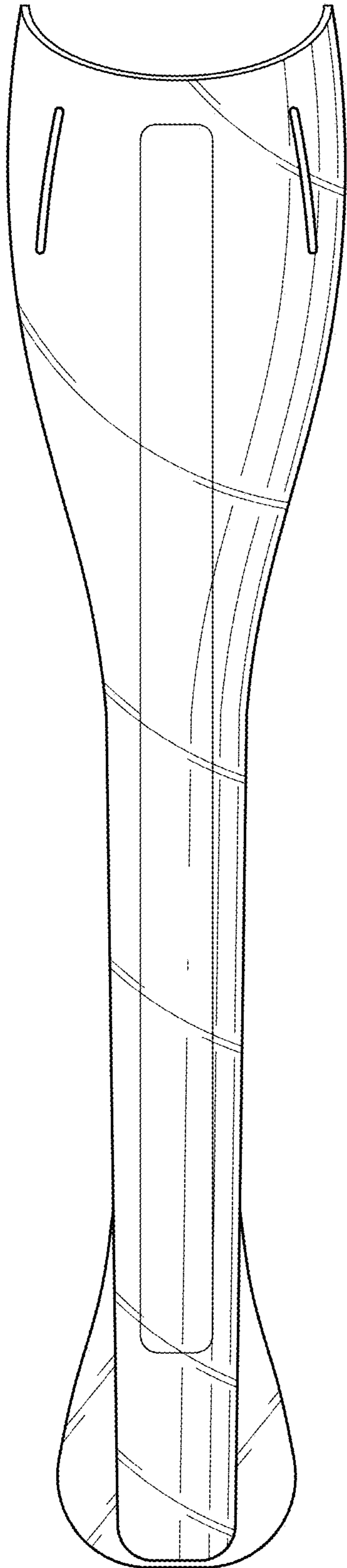

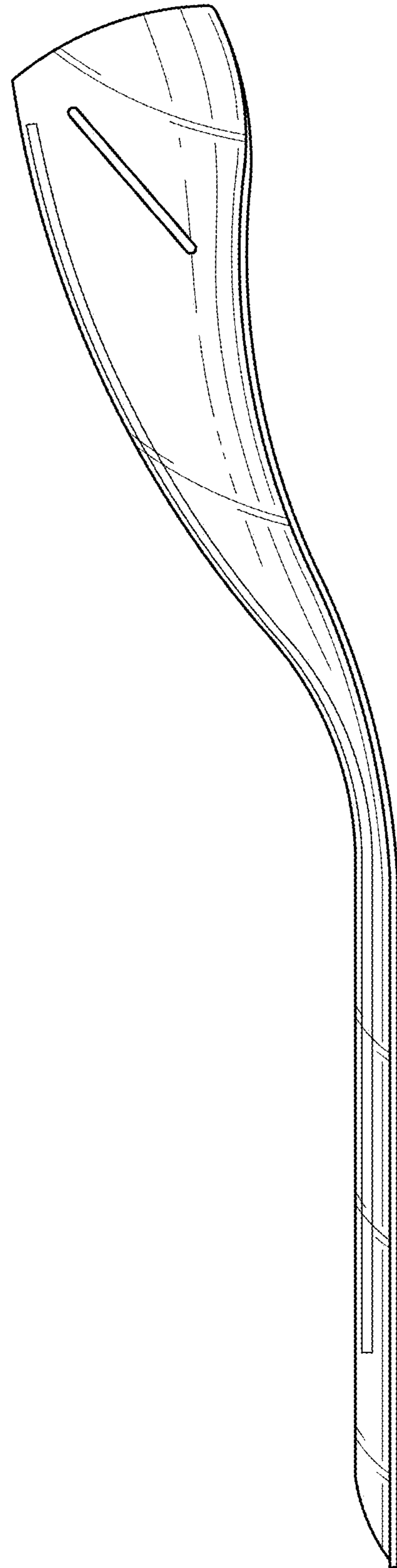

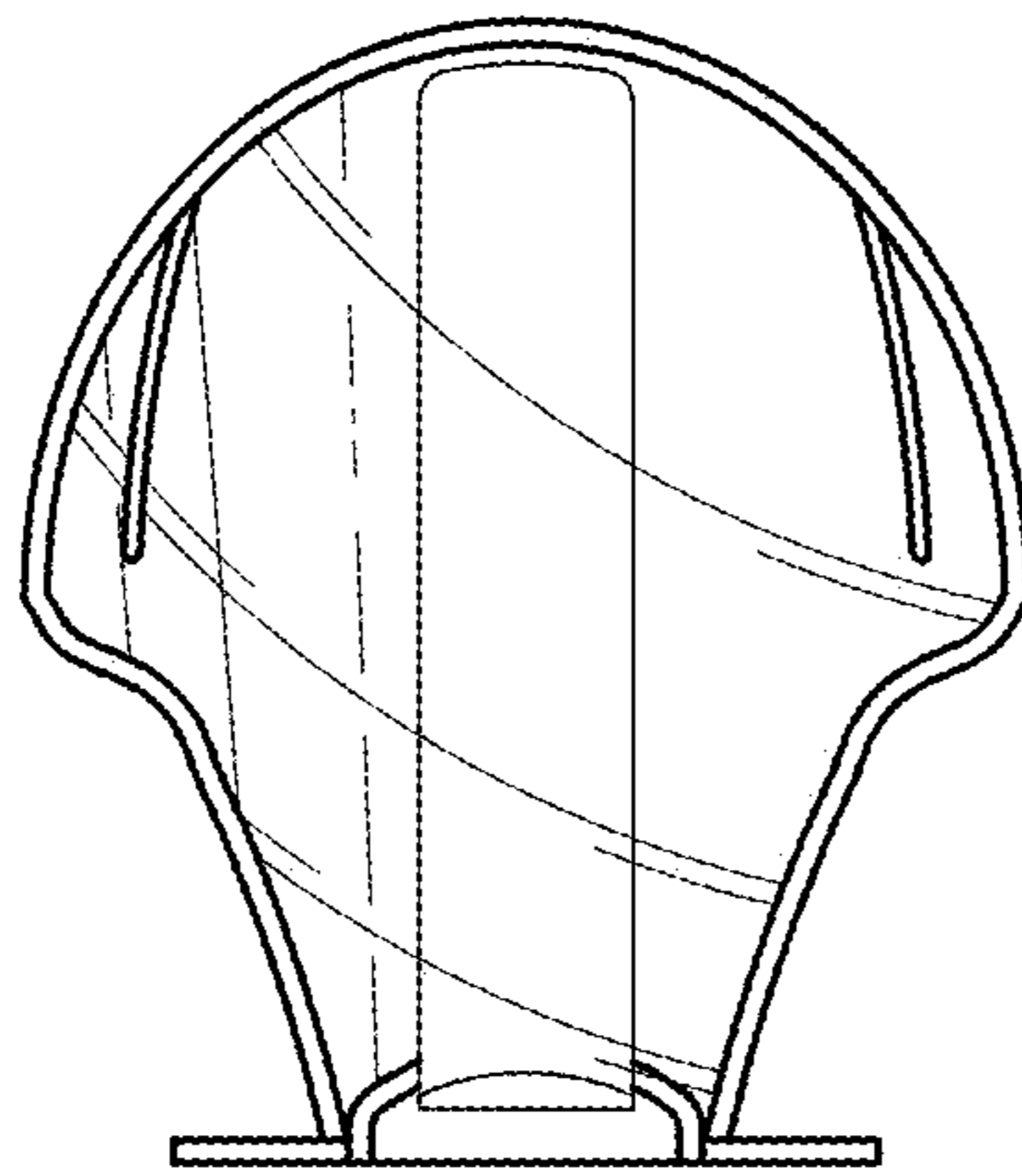
