(57) **CLAIM**

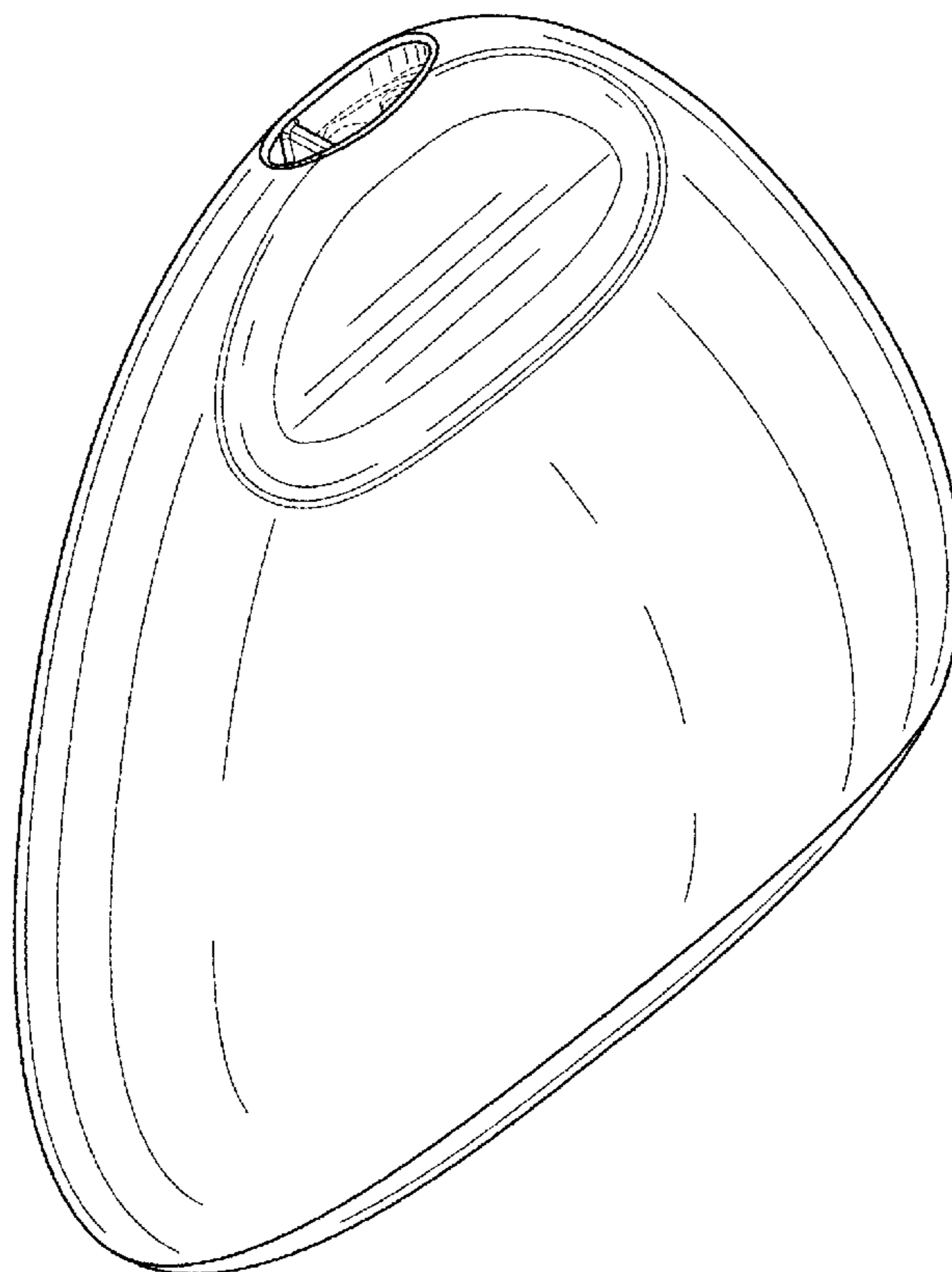
The ornamental design for an electronic cigarette, as shown and described.

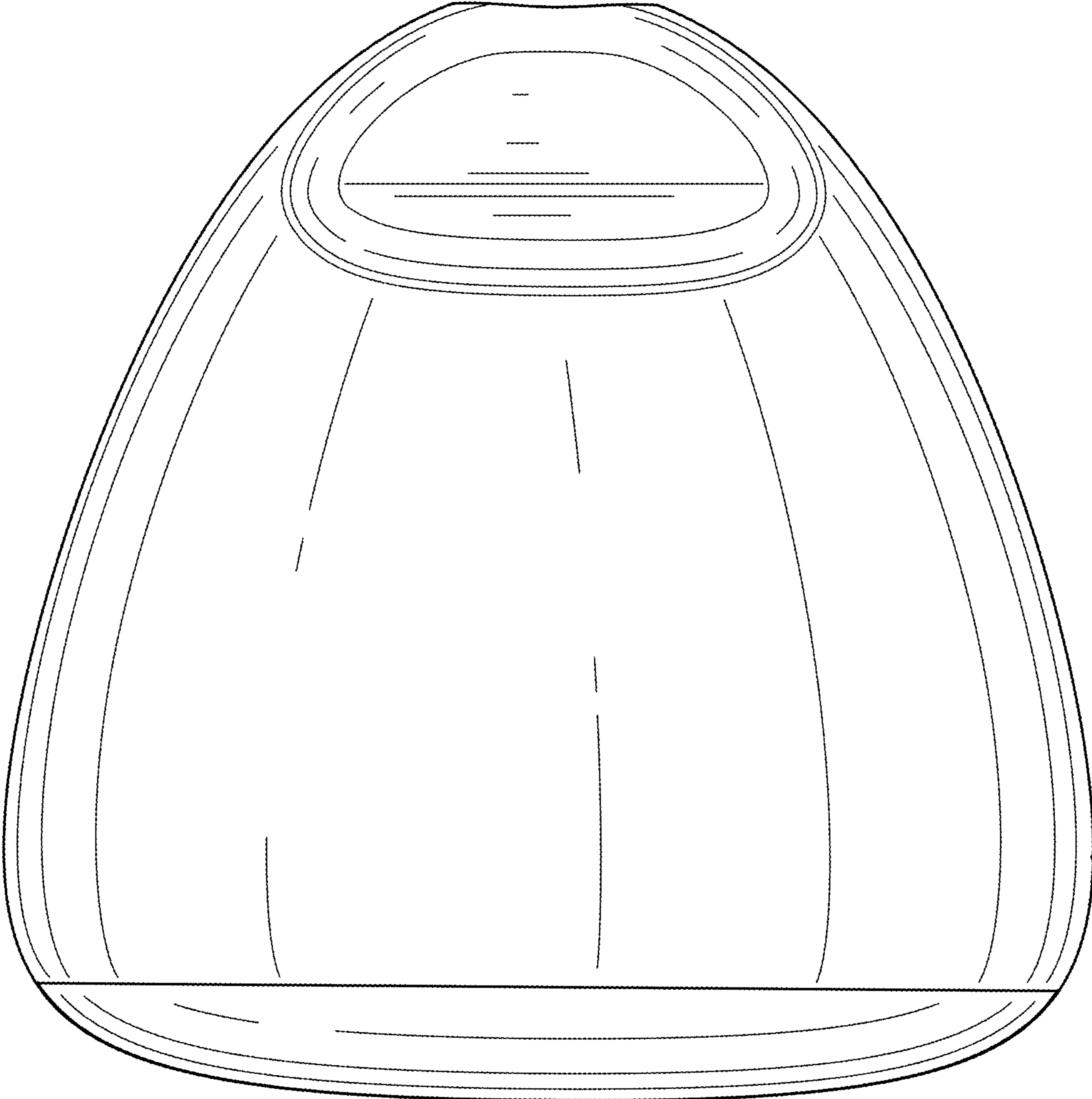

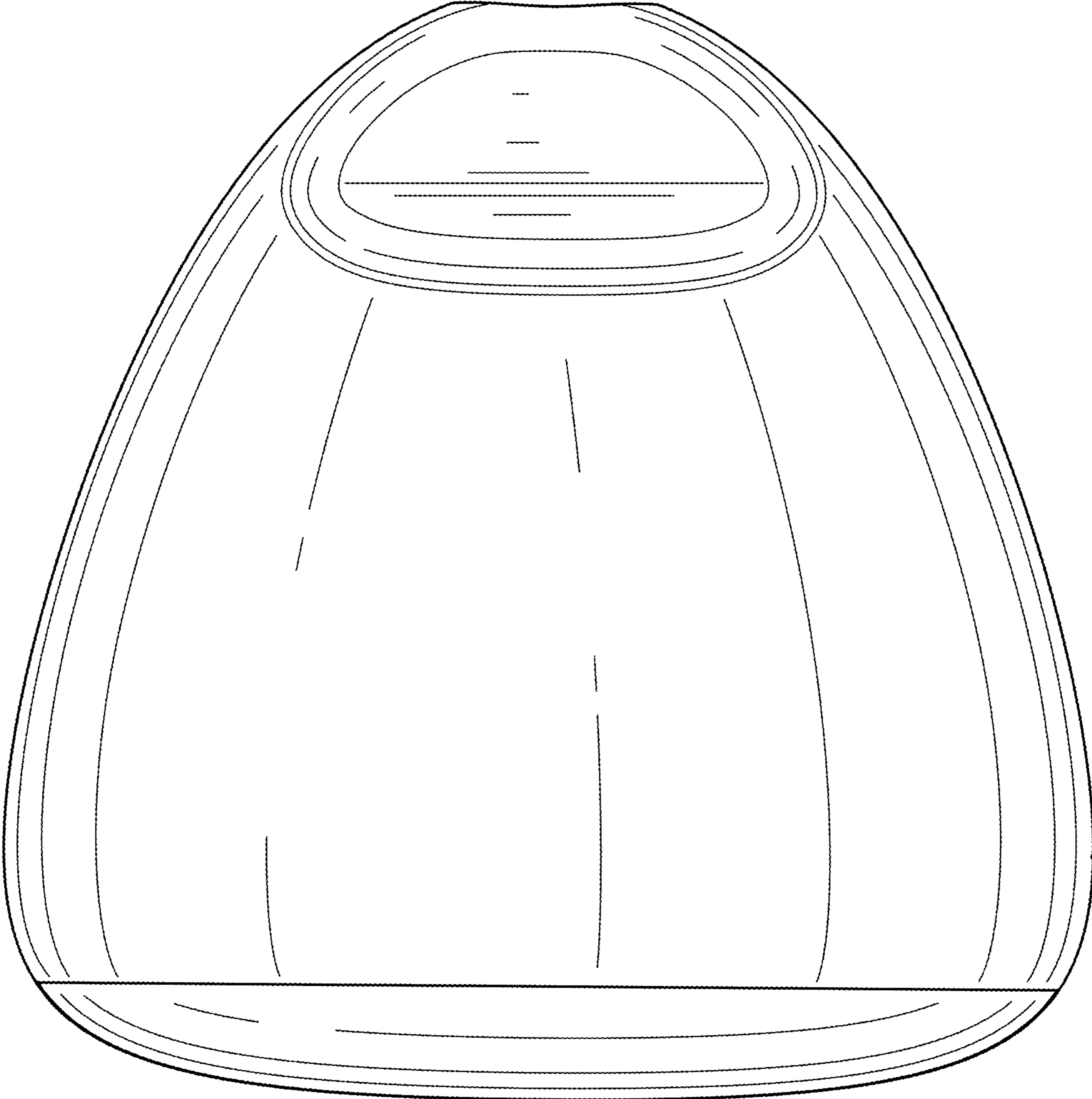

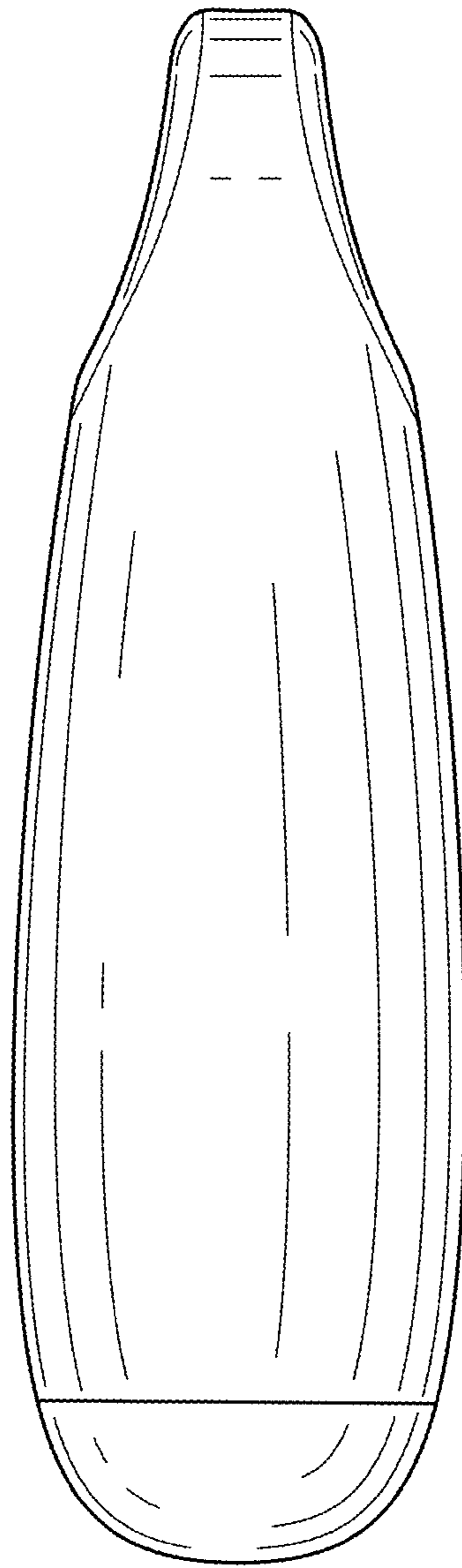

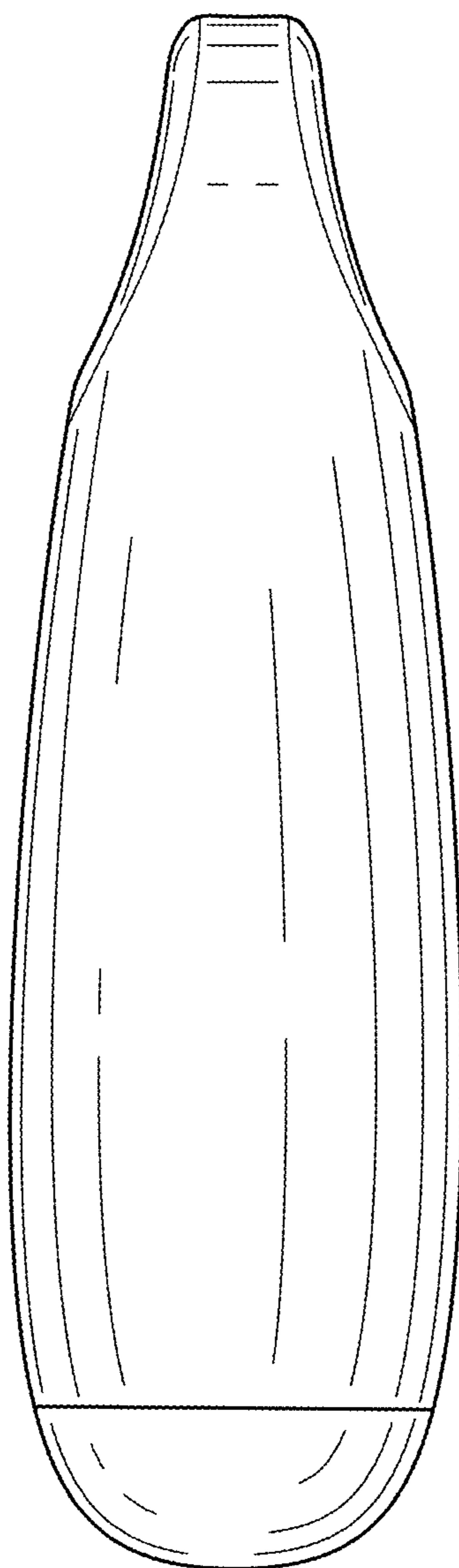

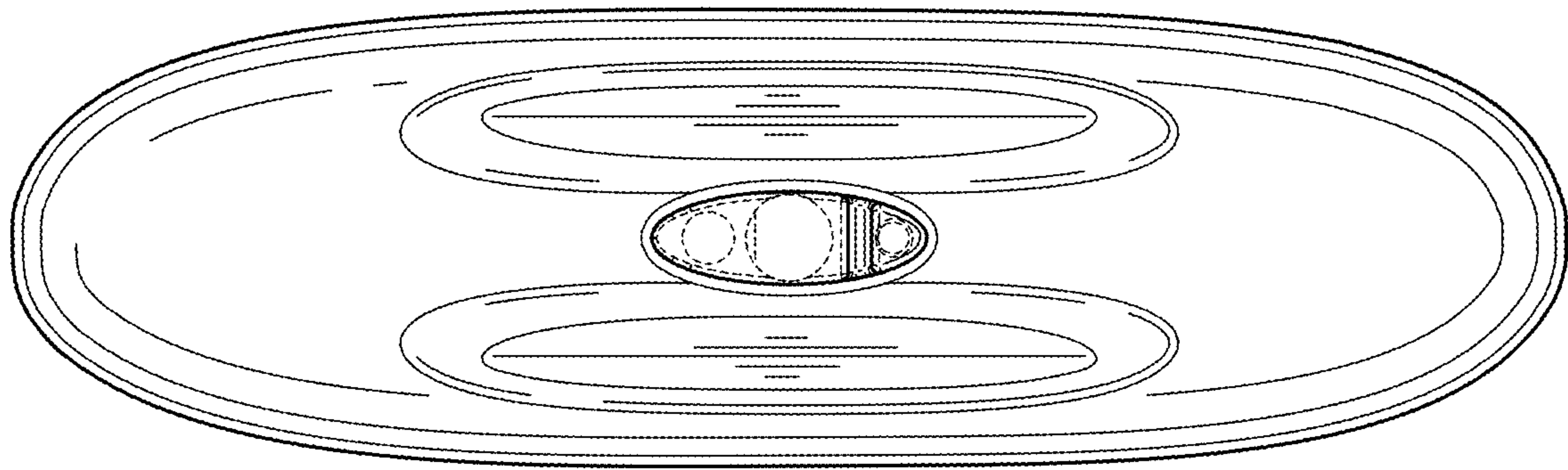

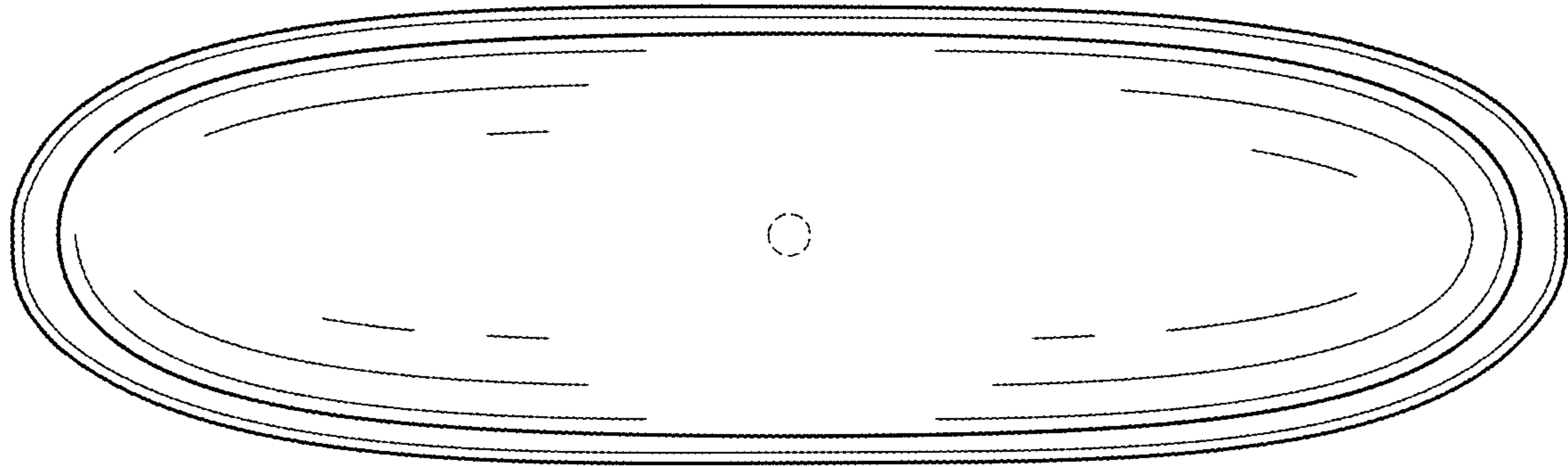

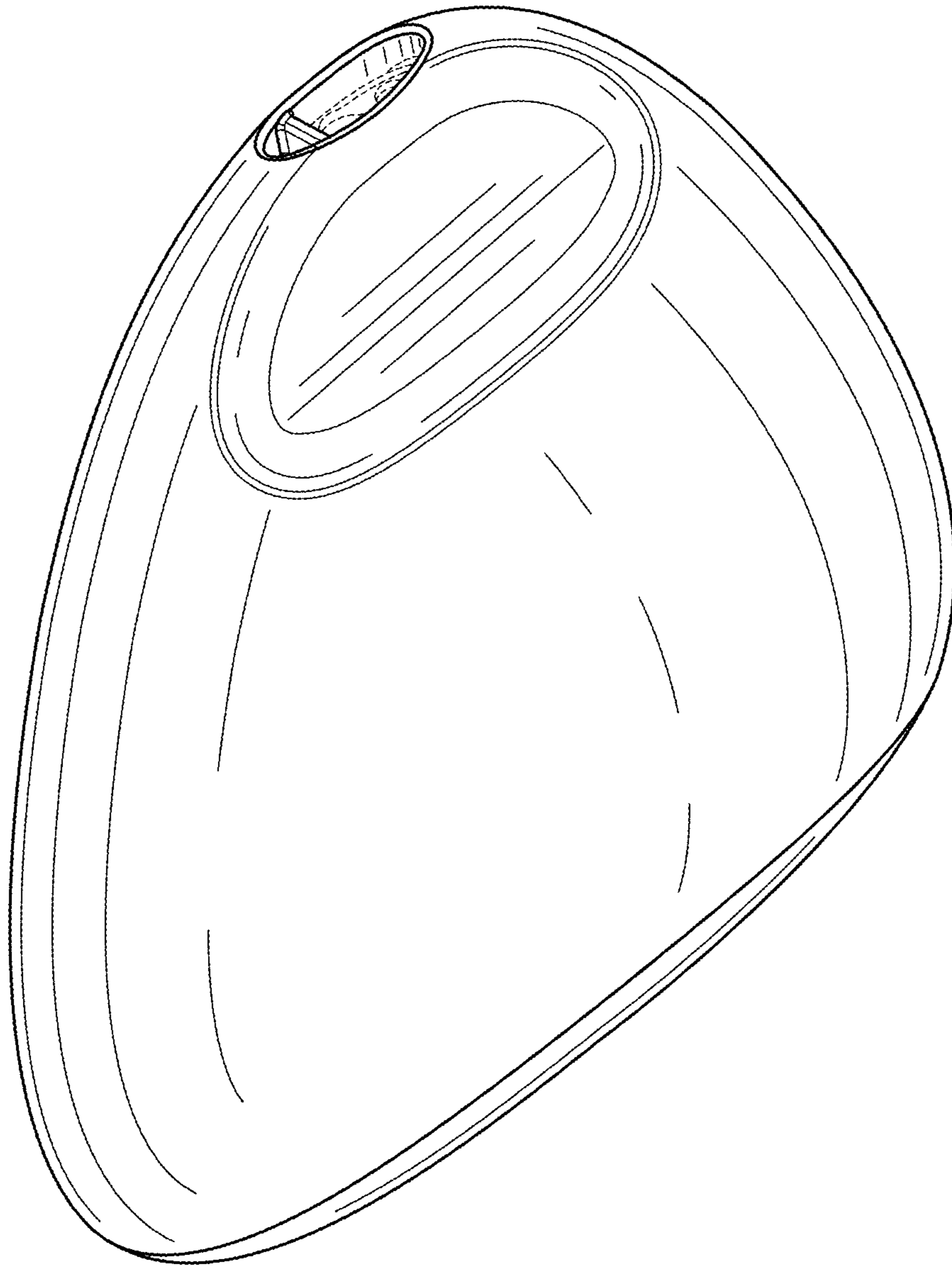
