The ornamental design for an exercise garment for infant, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an exercise garment for infant showing our new design thereof;

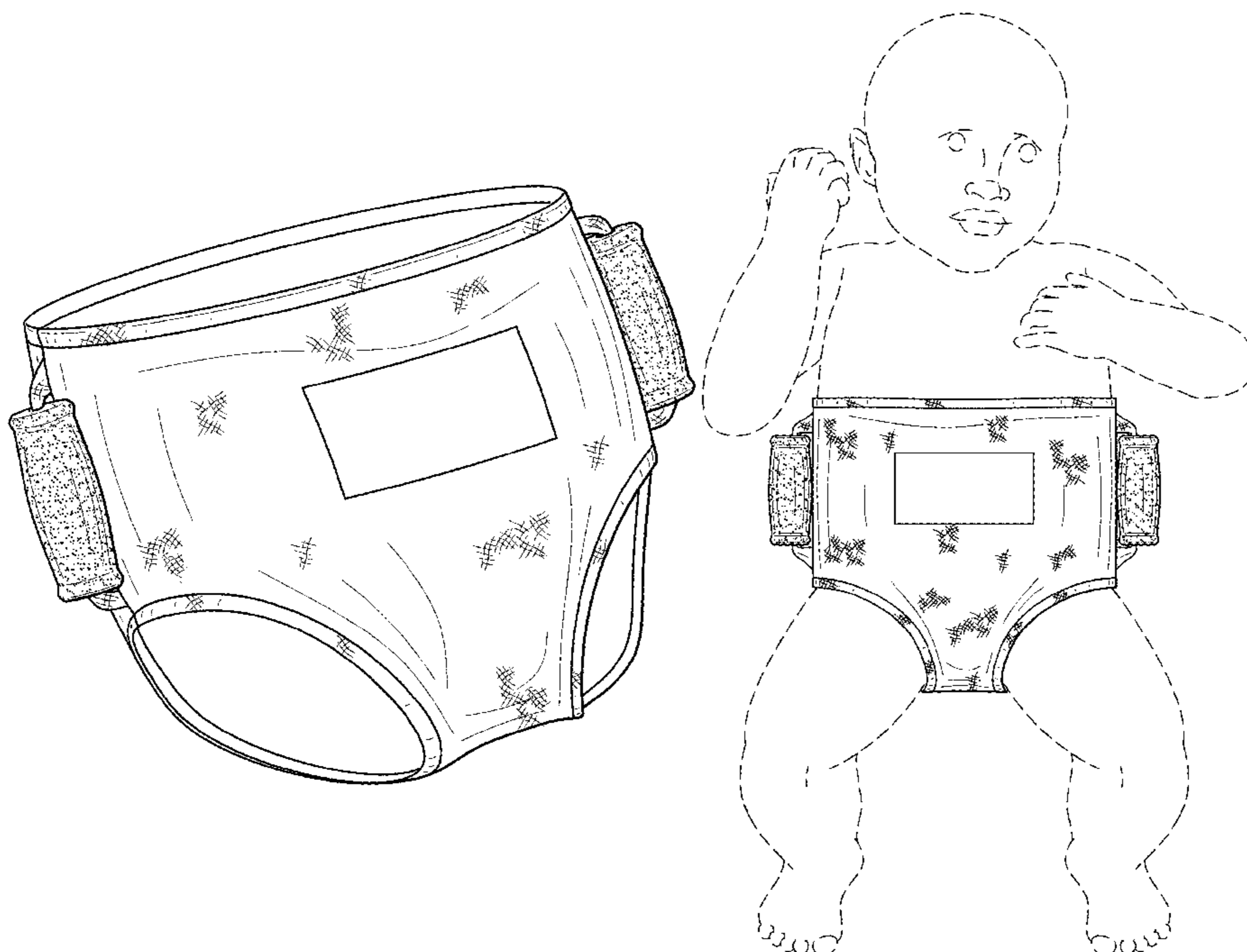

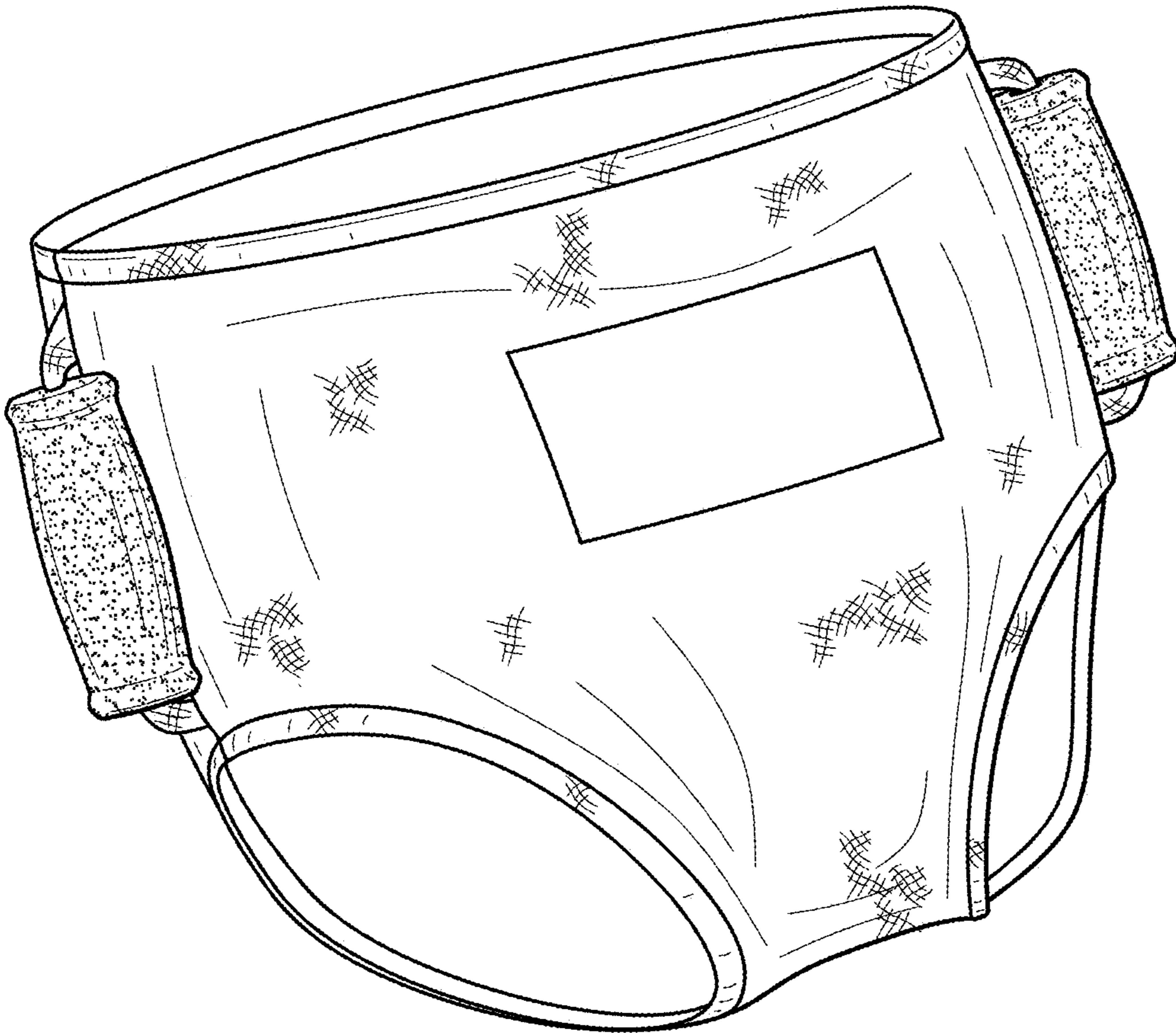

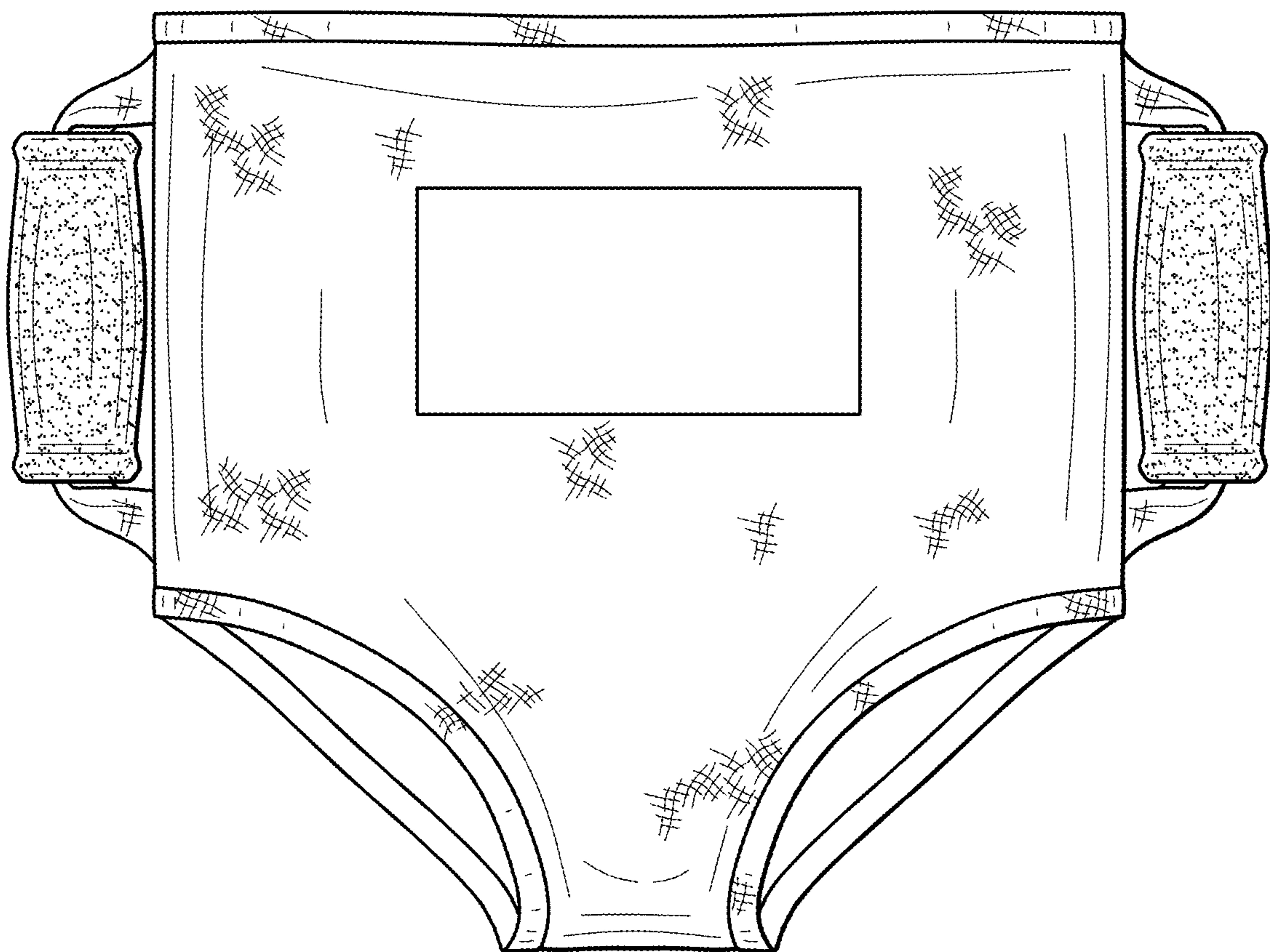

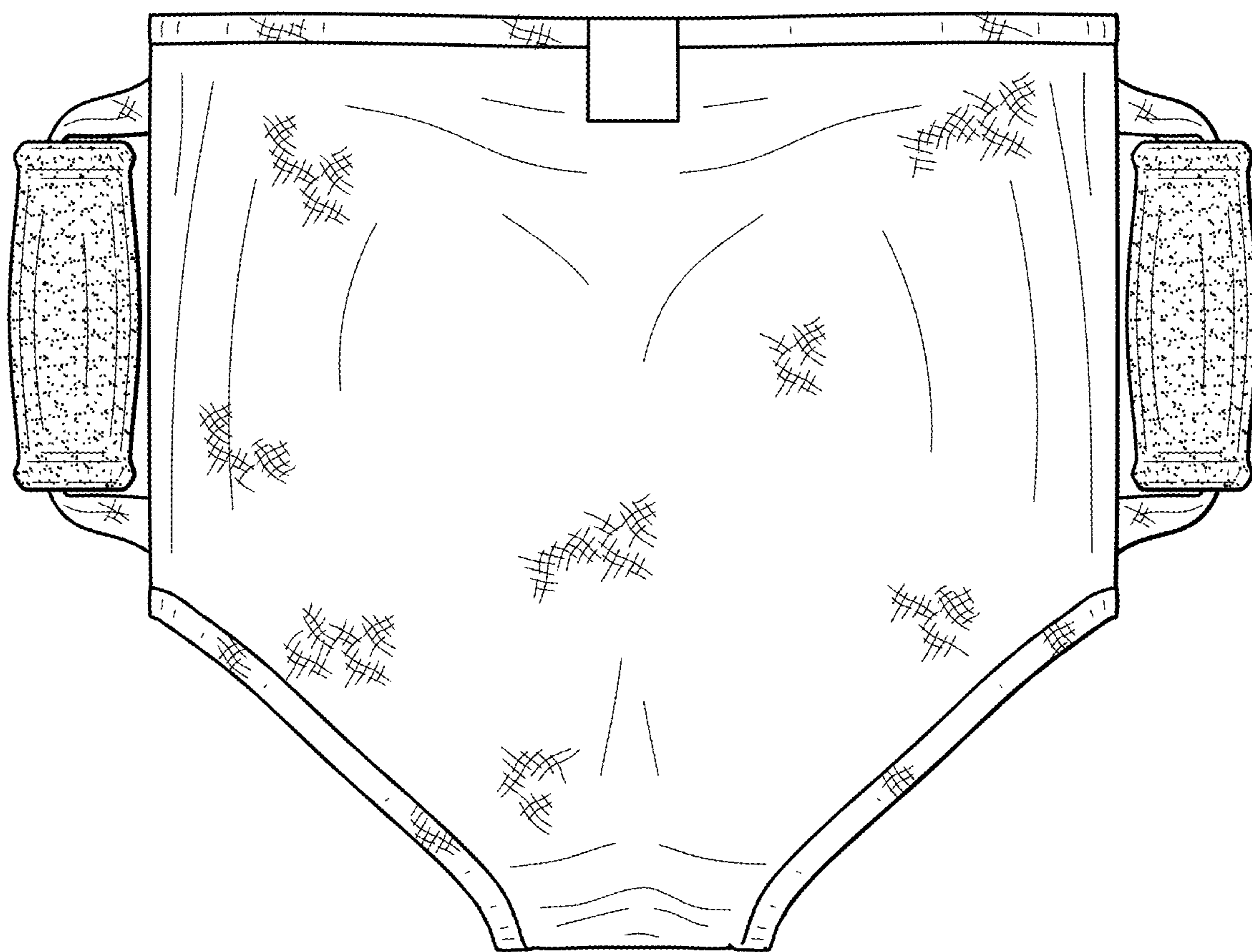

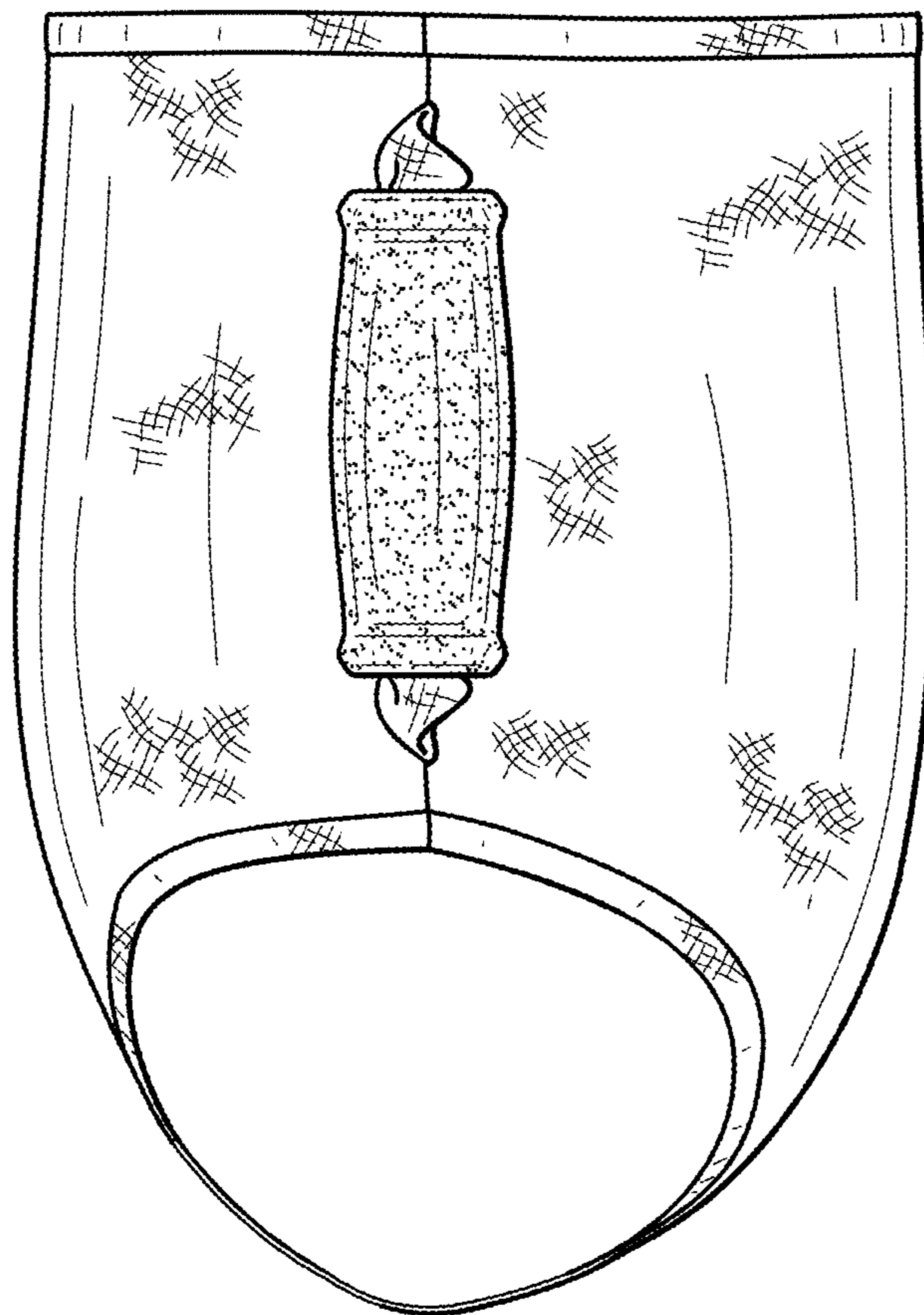

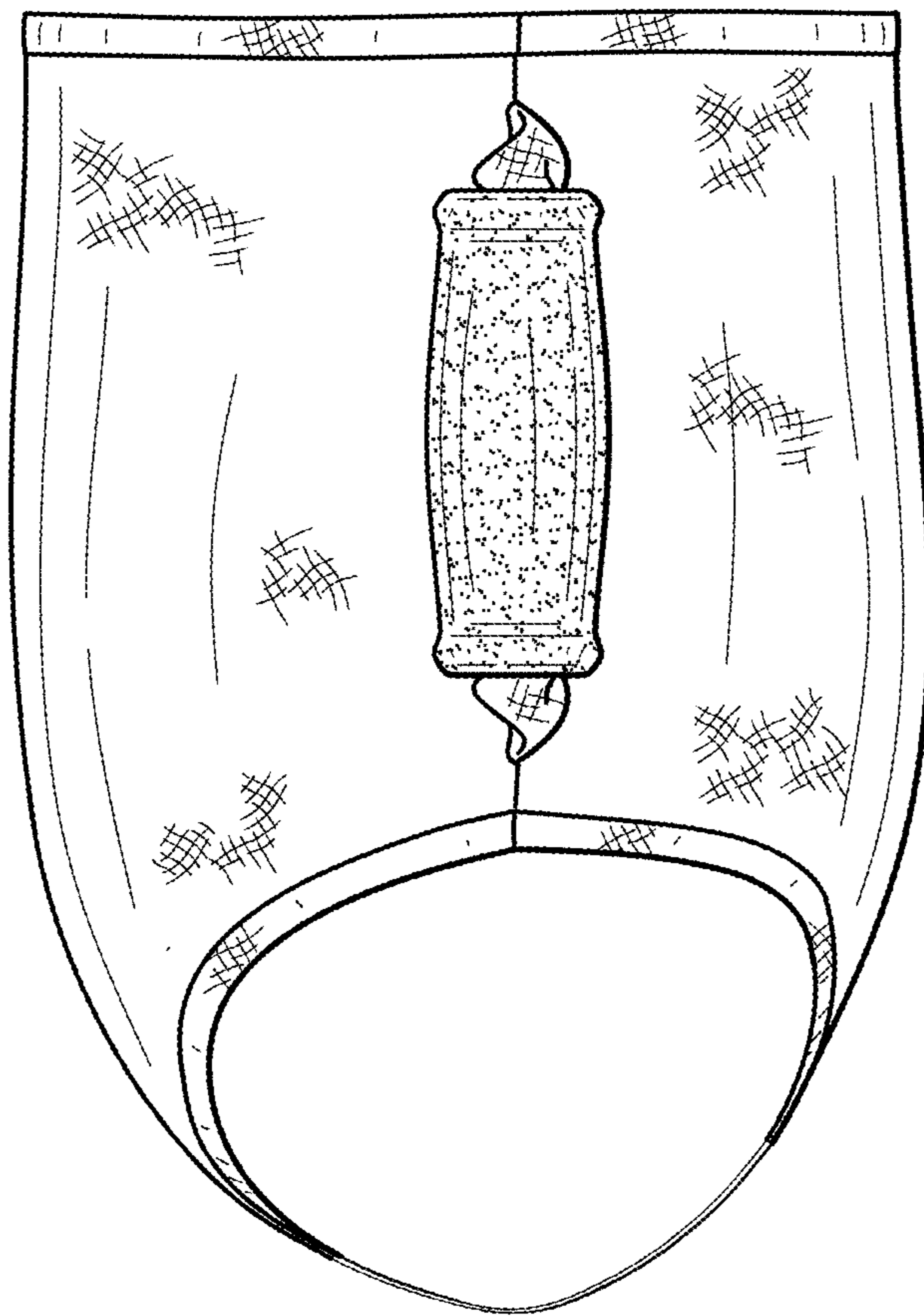

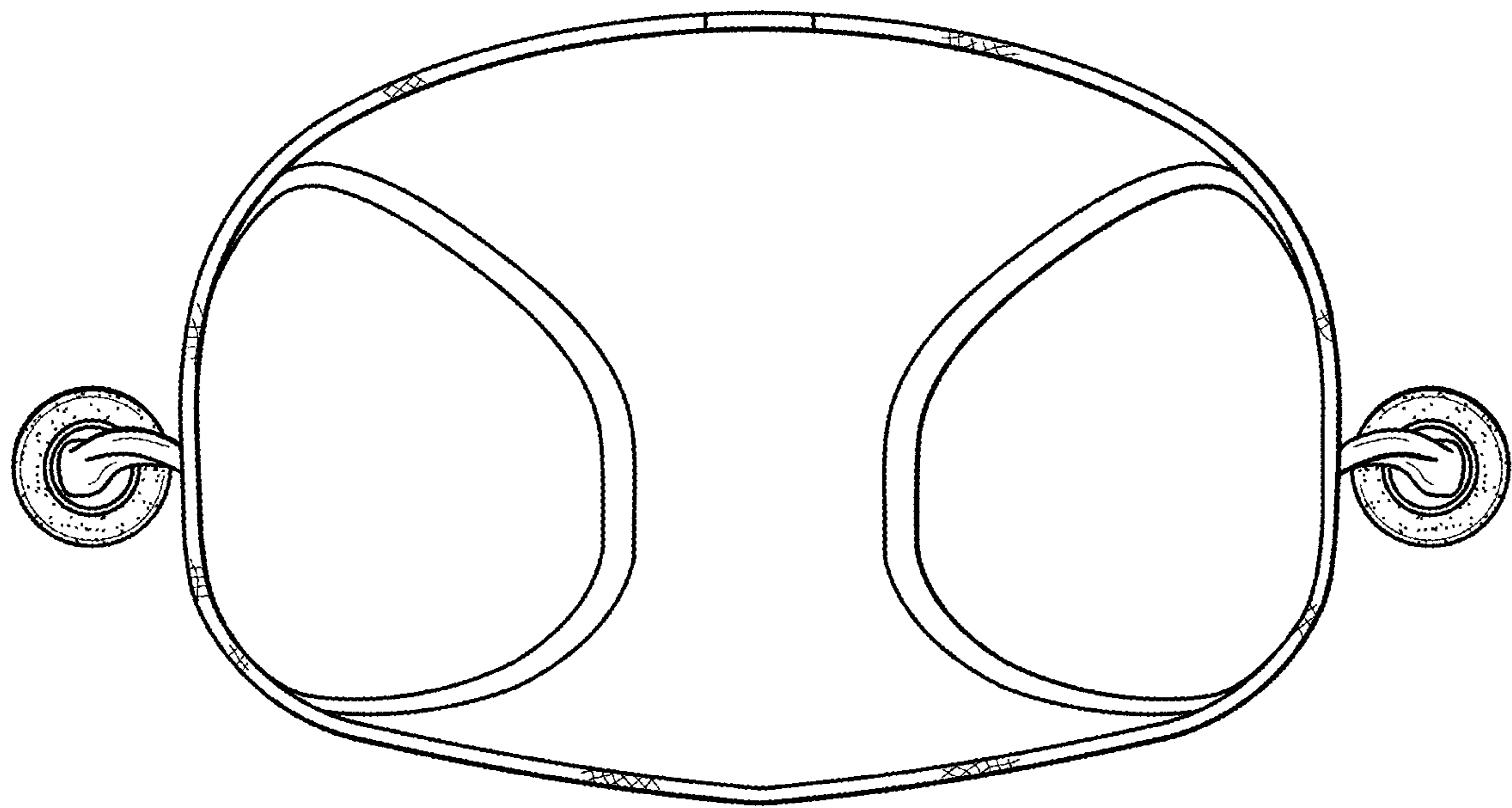

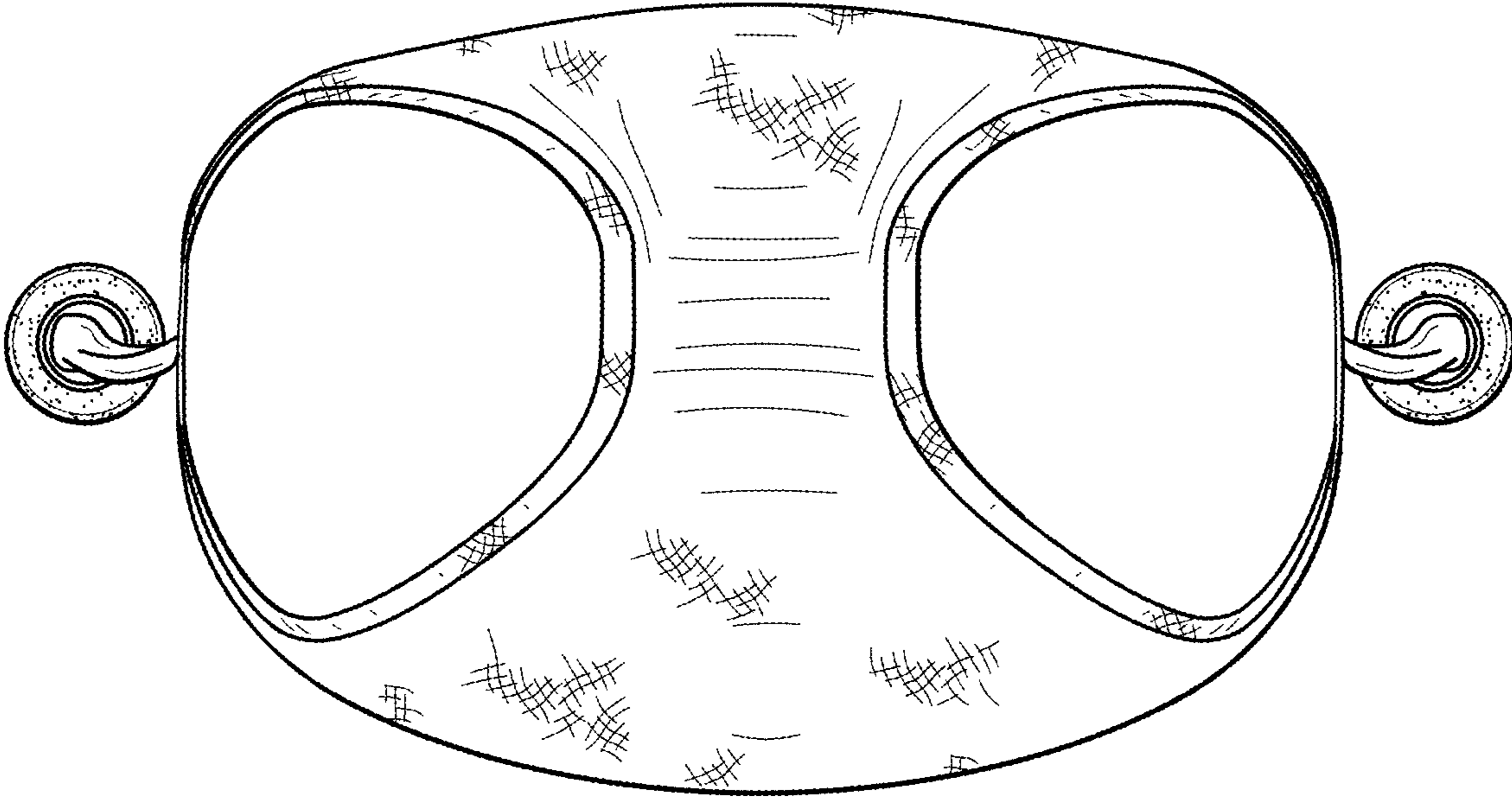
