DESCRIPTION

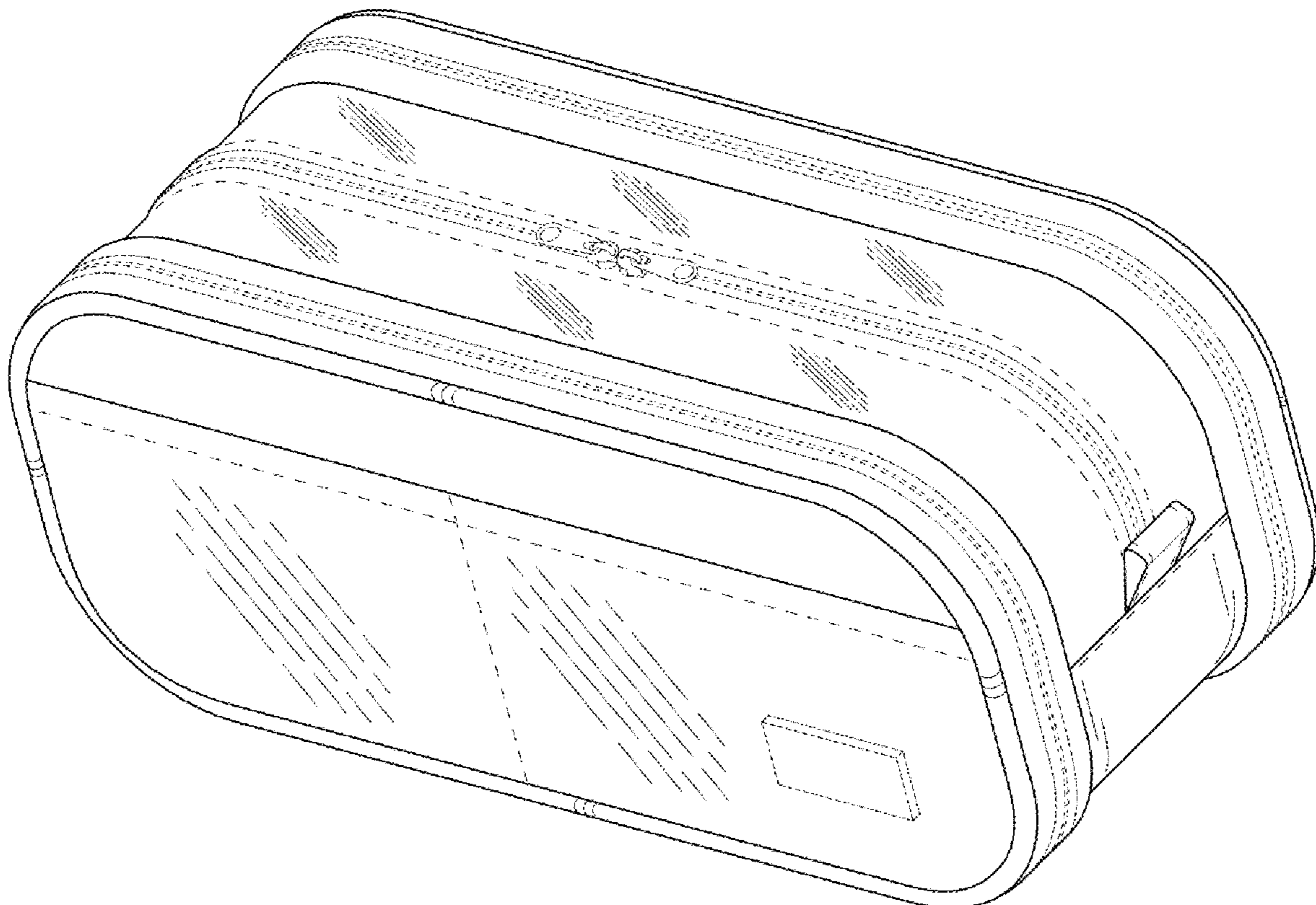
FIG. 1 is a front perspective view of a pencil case, showing my design.

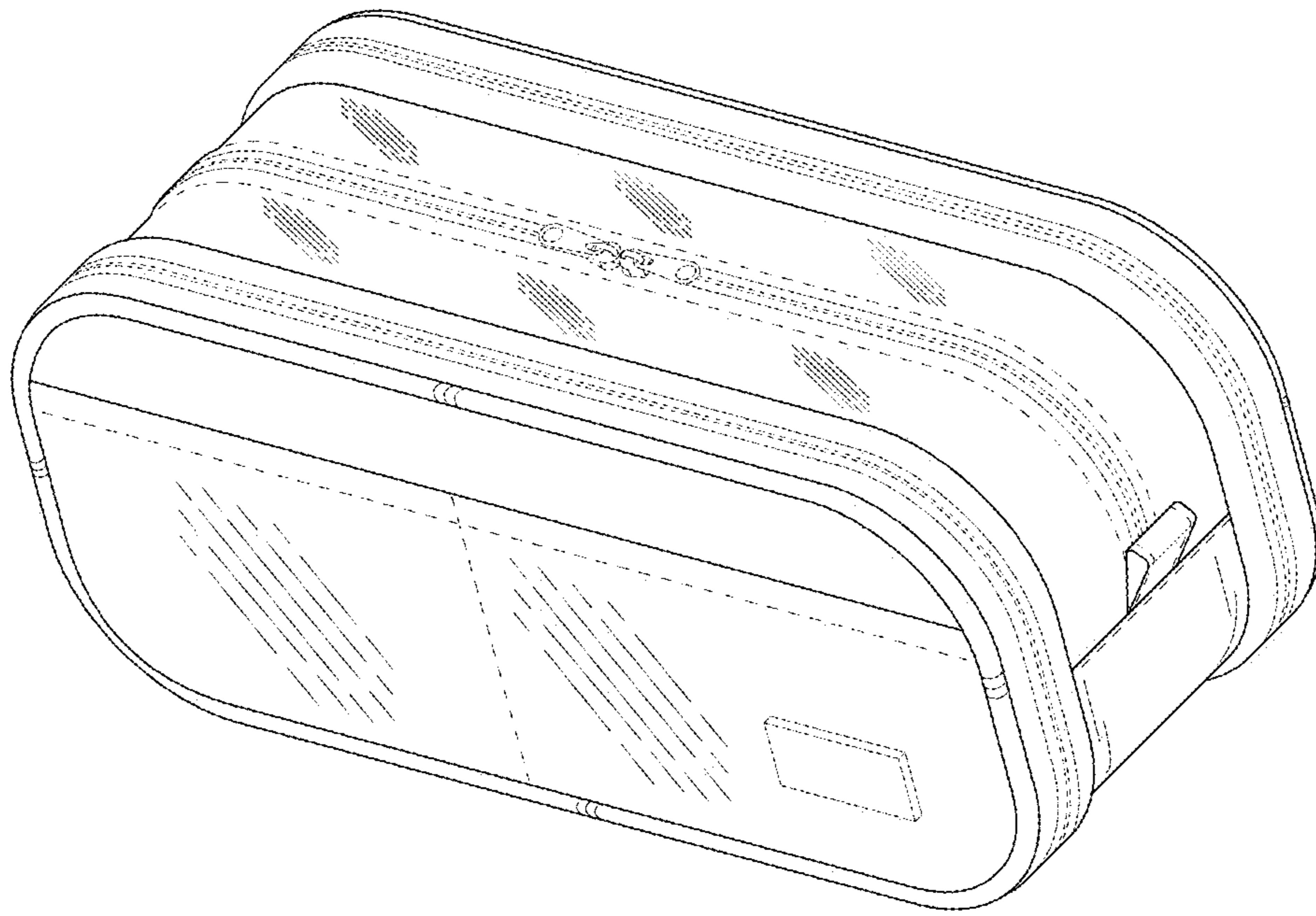

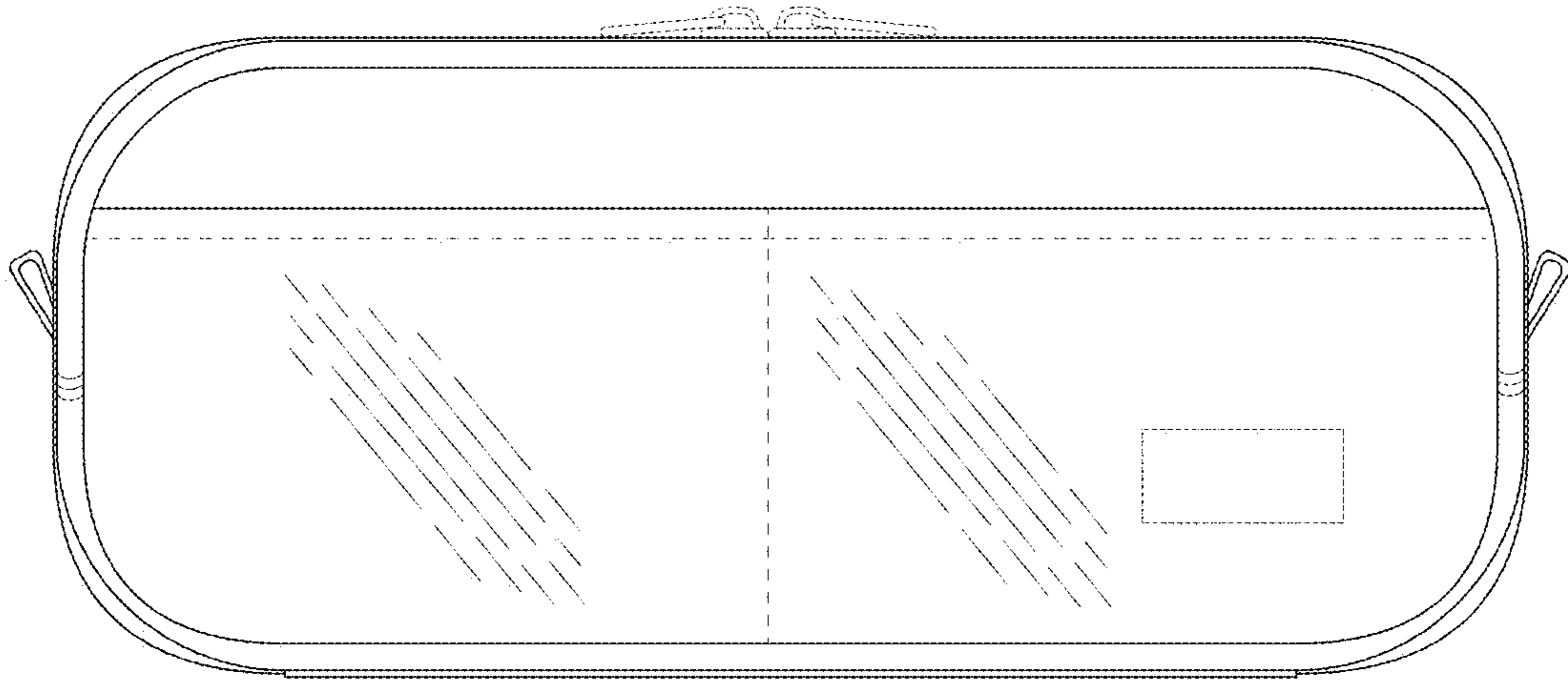

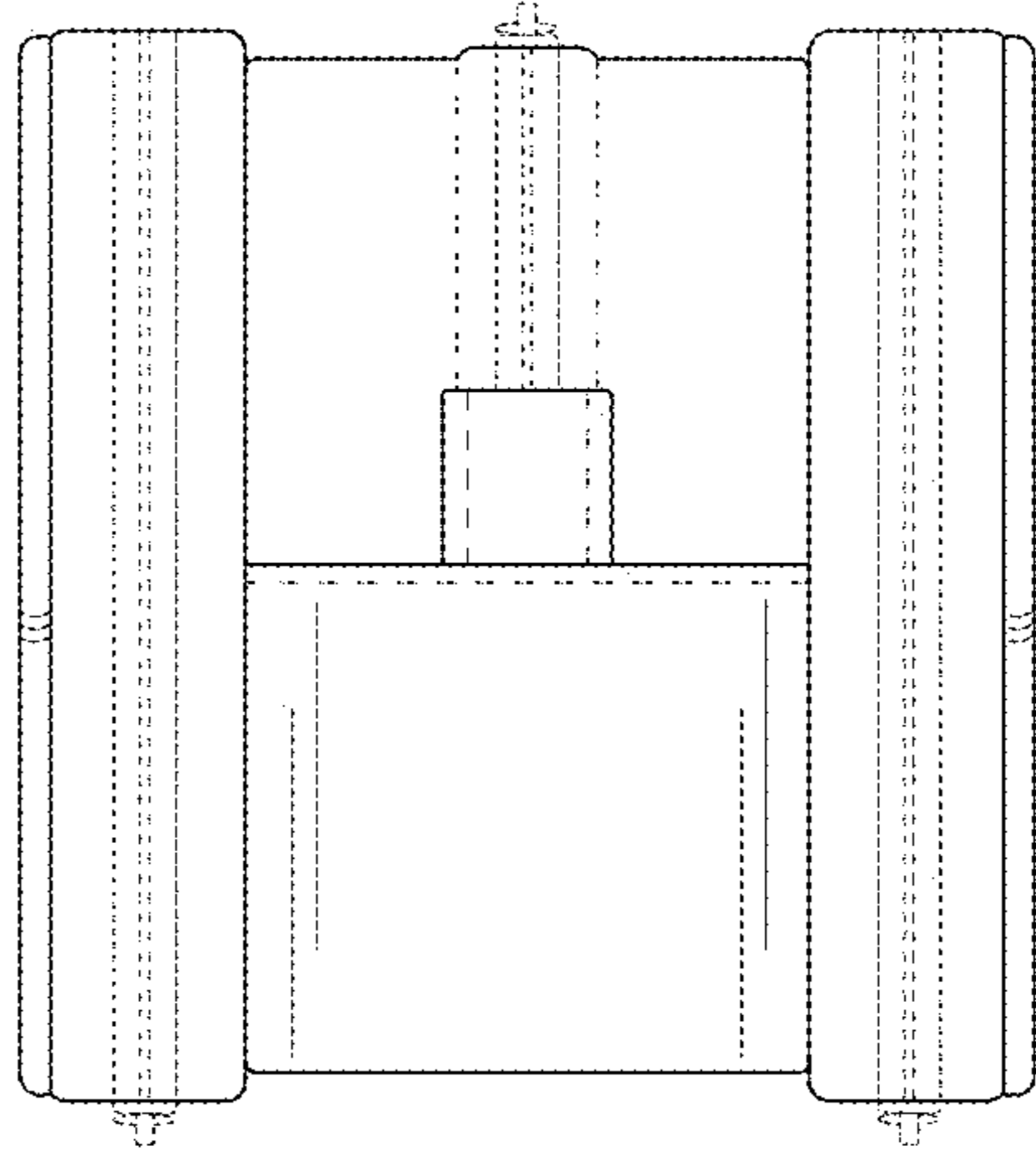

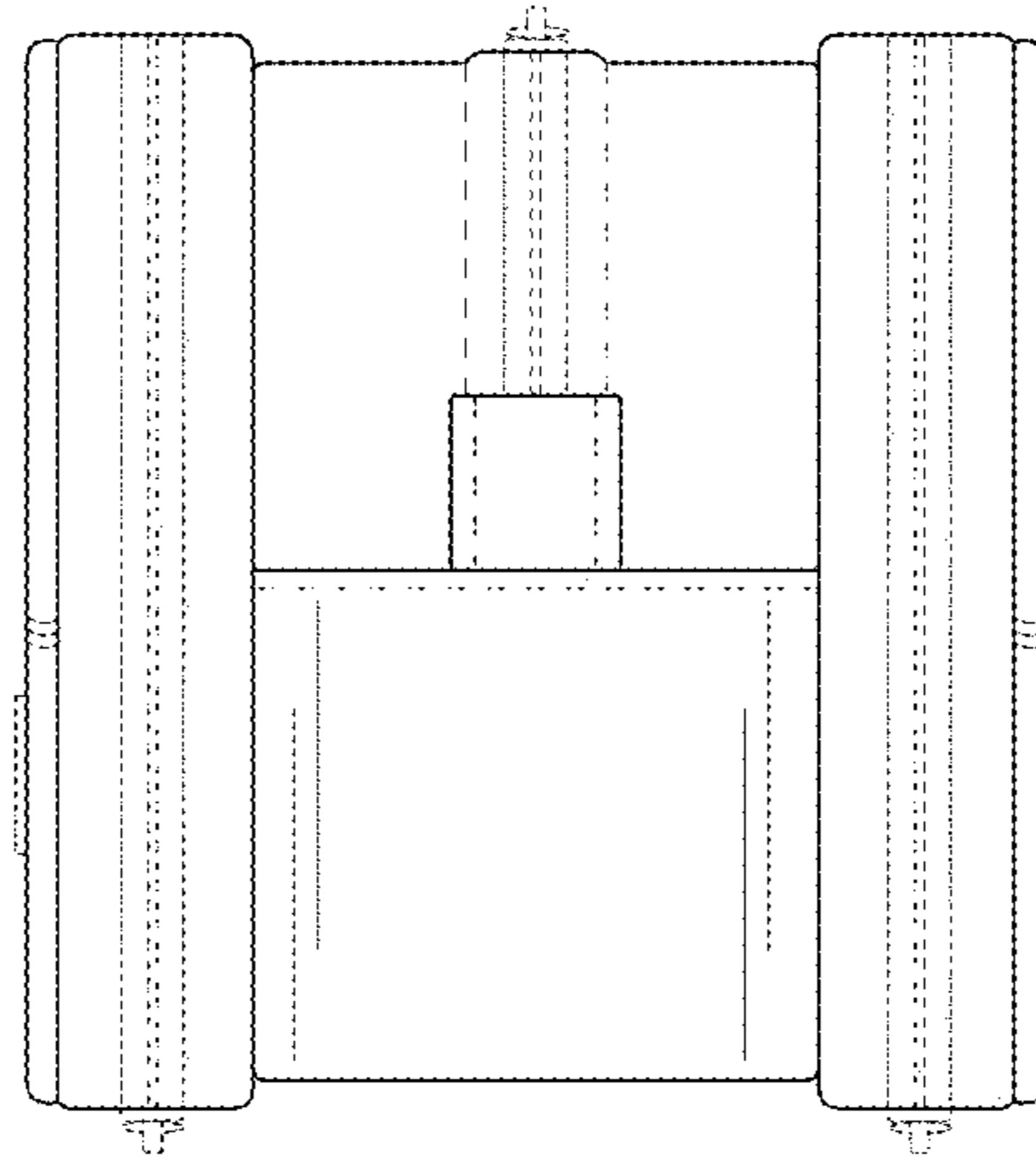

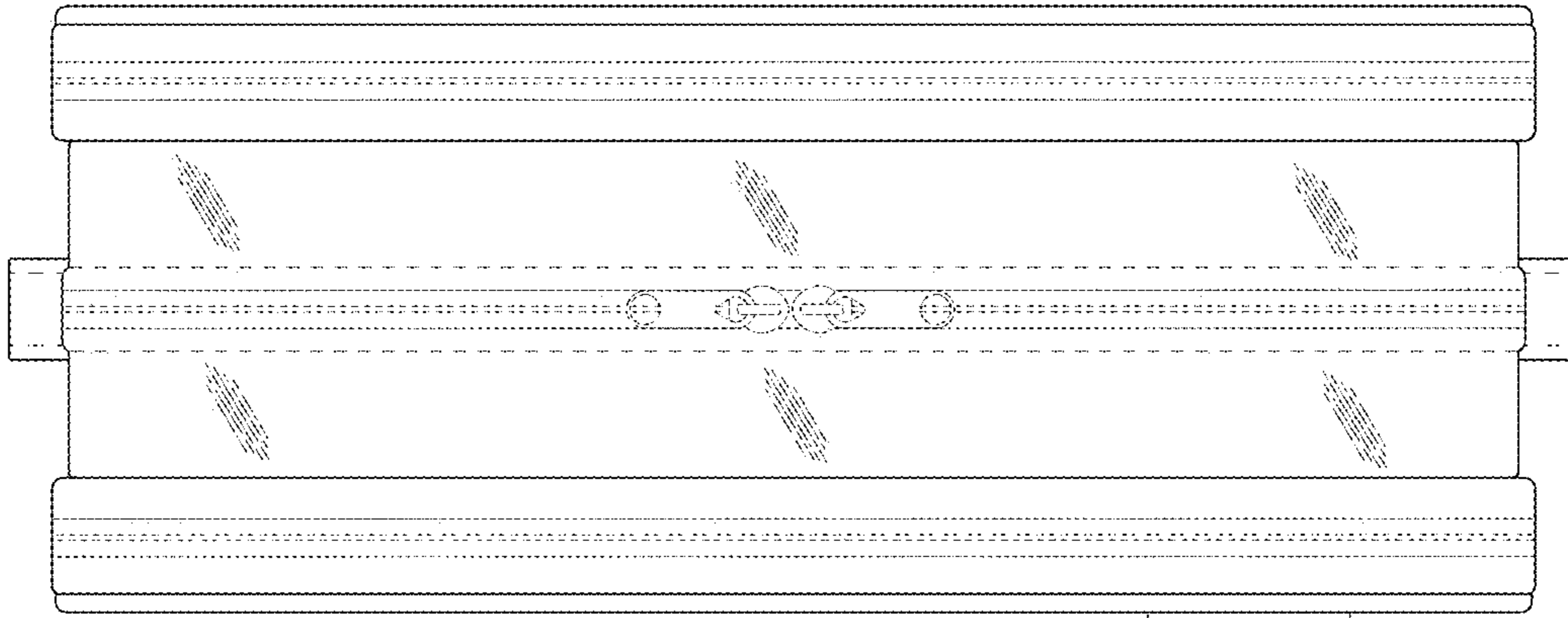

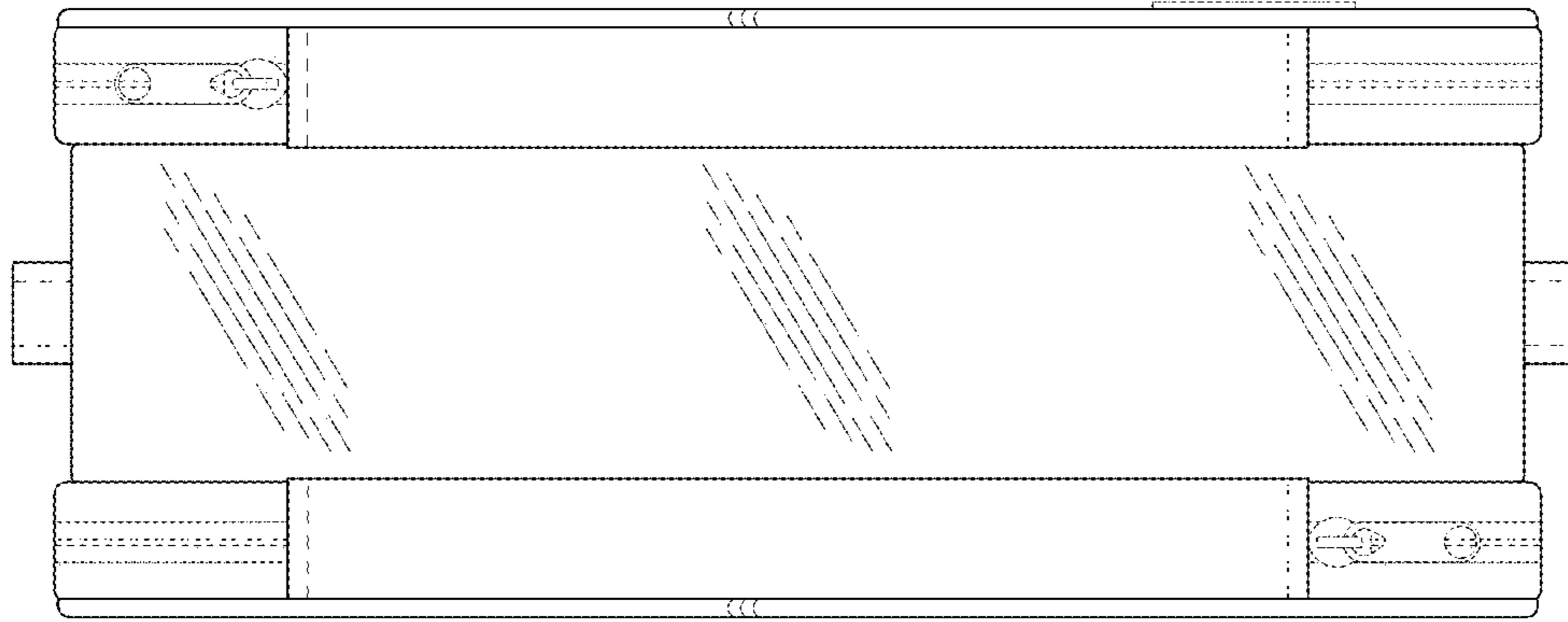

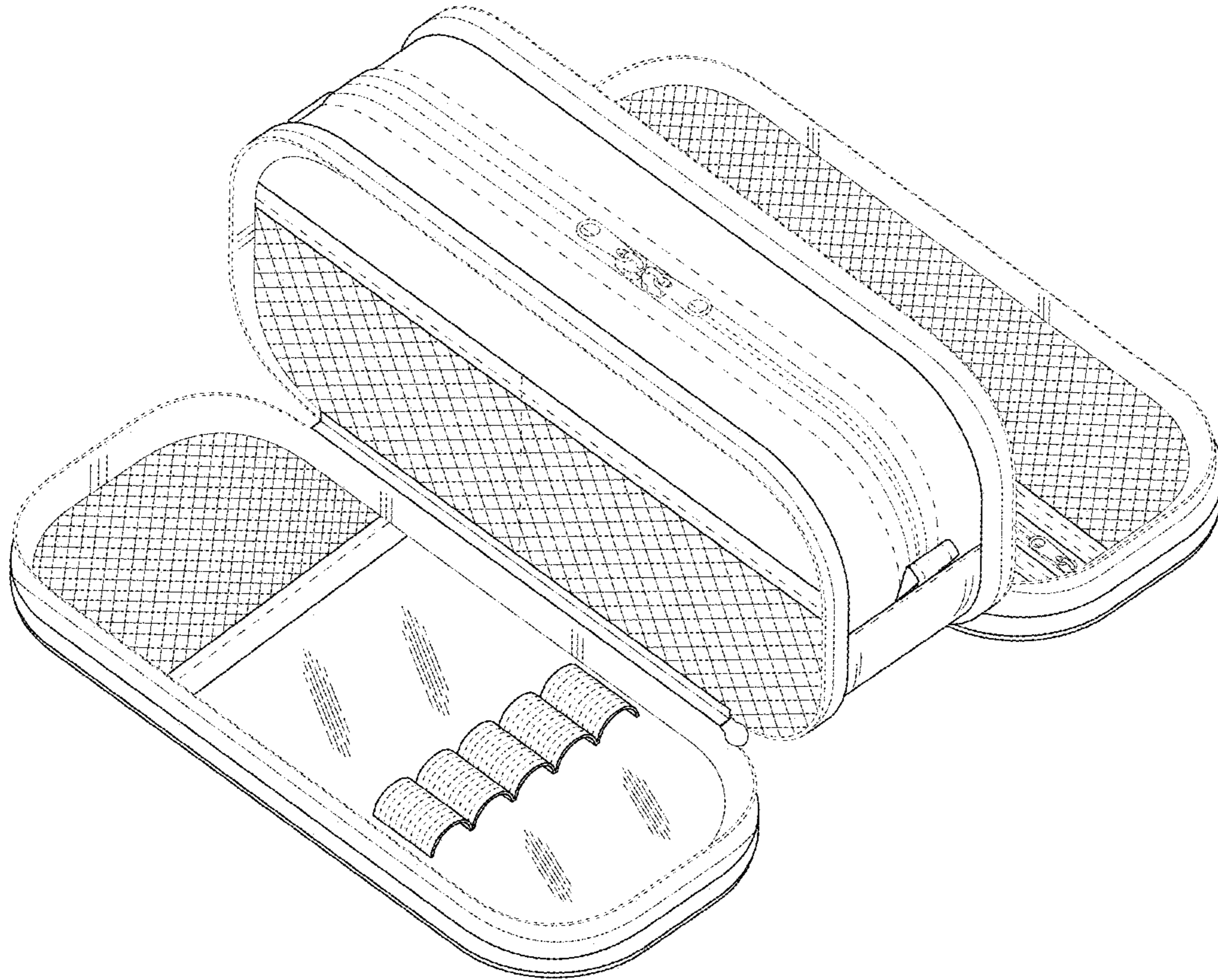

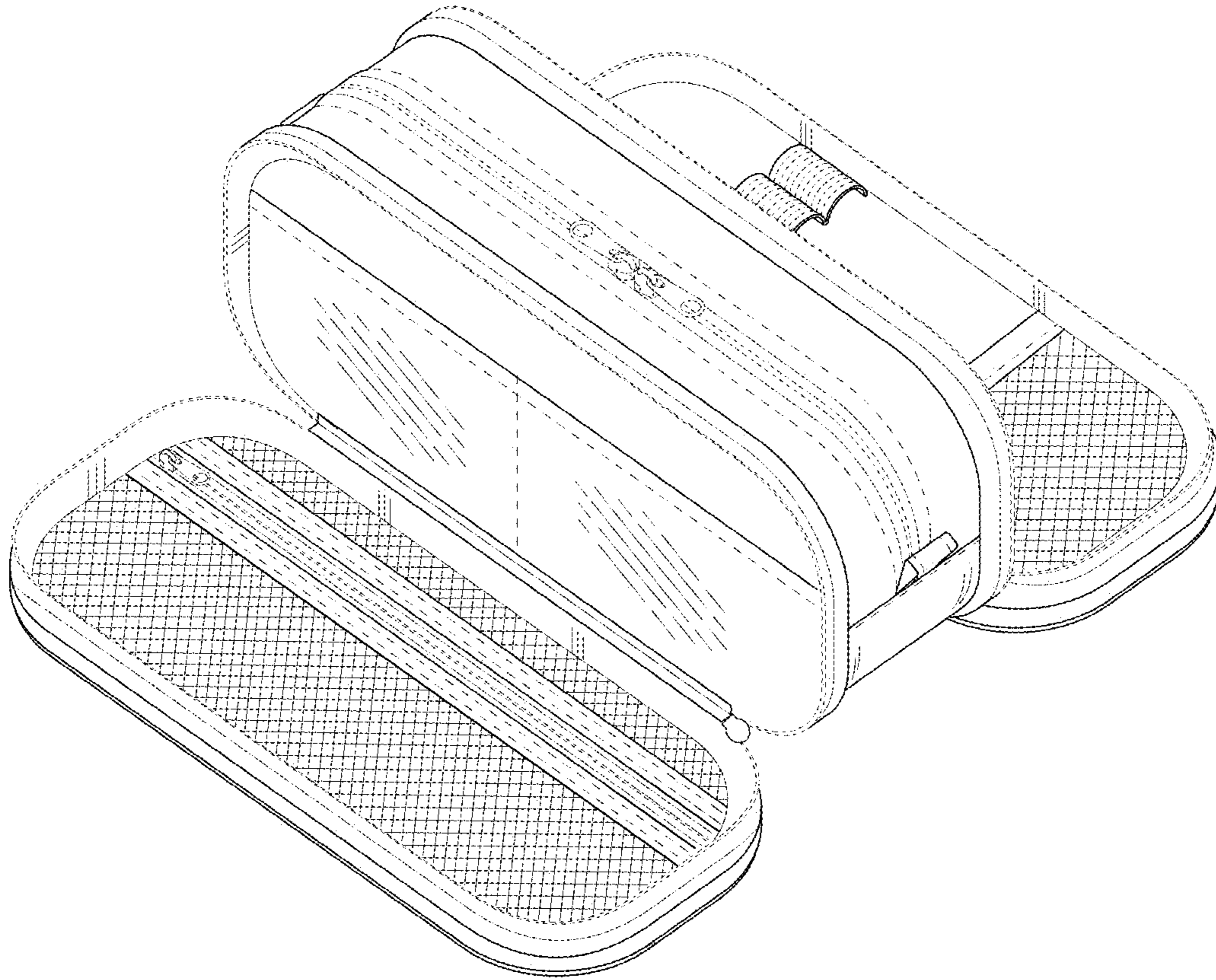
