(57) **CLAIM**

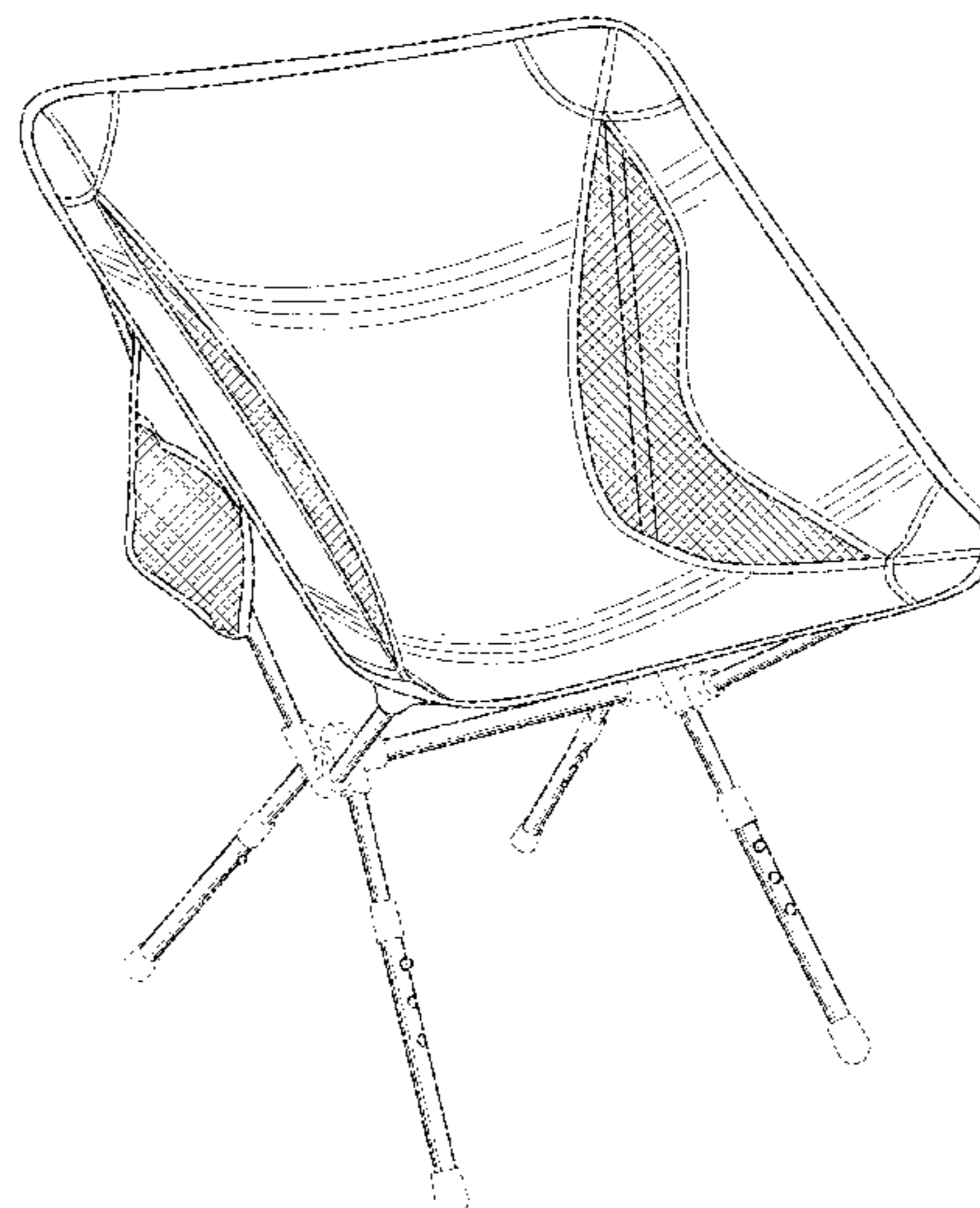
The ornamental design for a height adjustable portable camping chair, as shown and described.

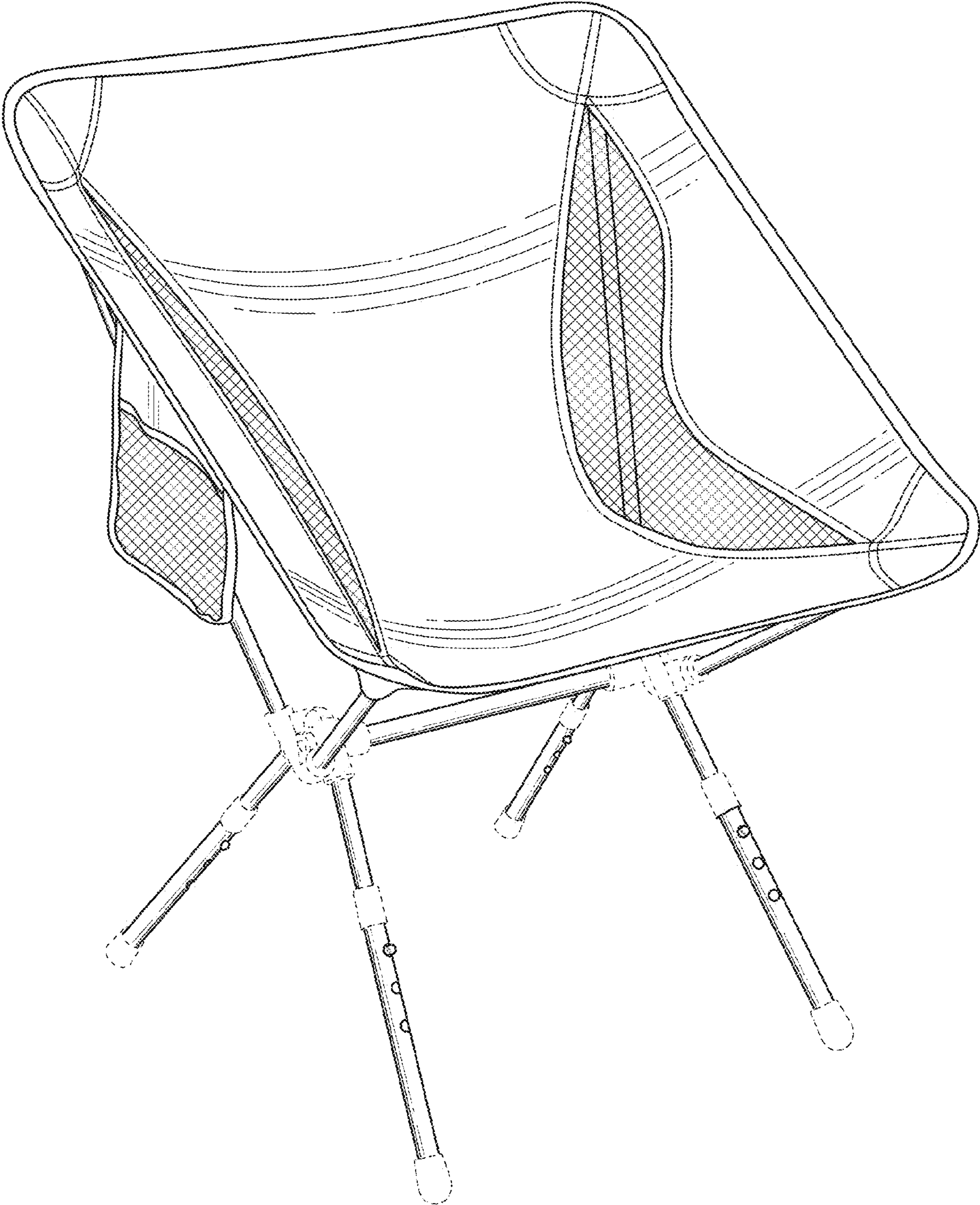

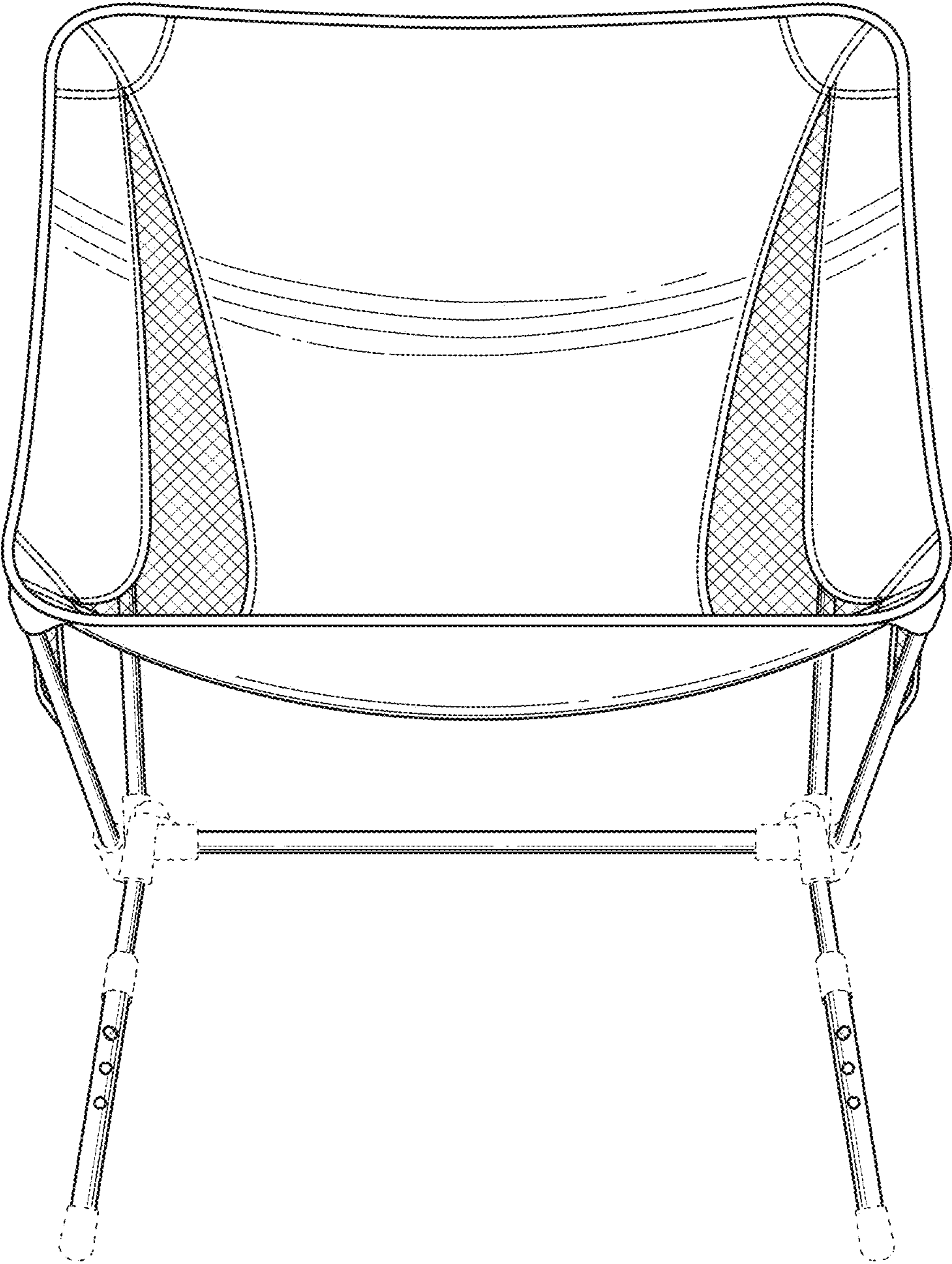

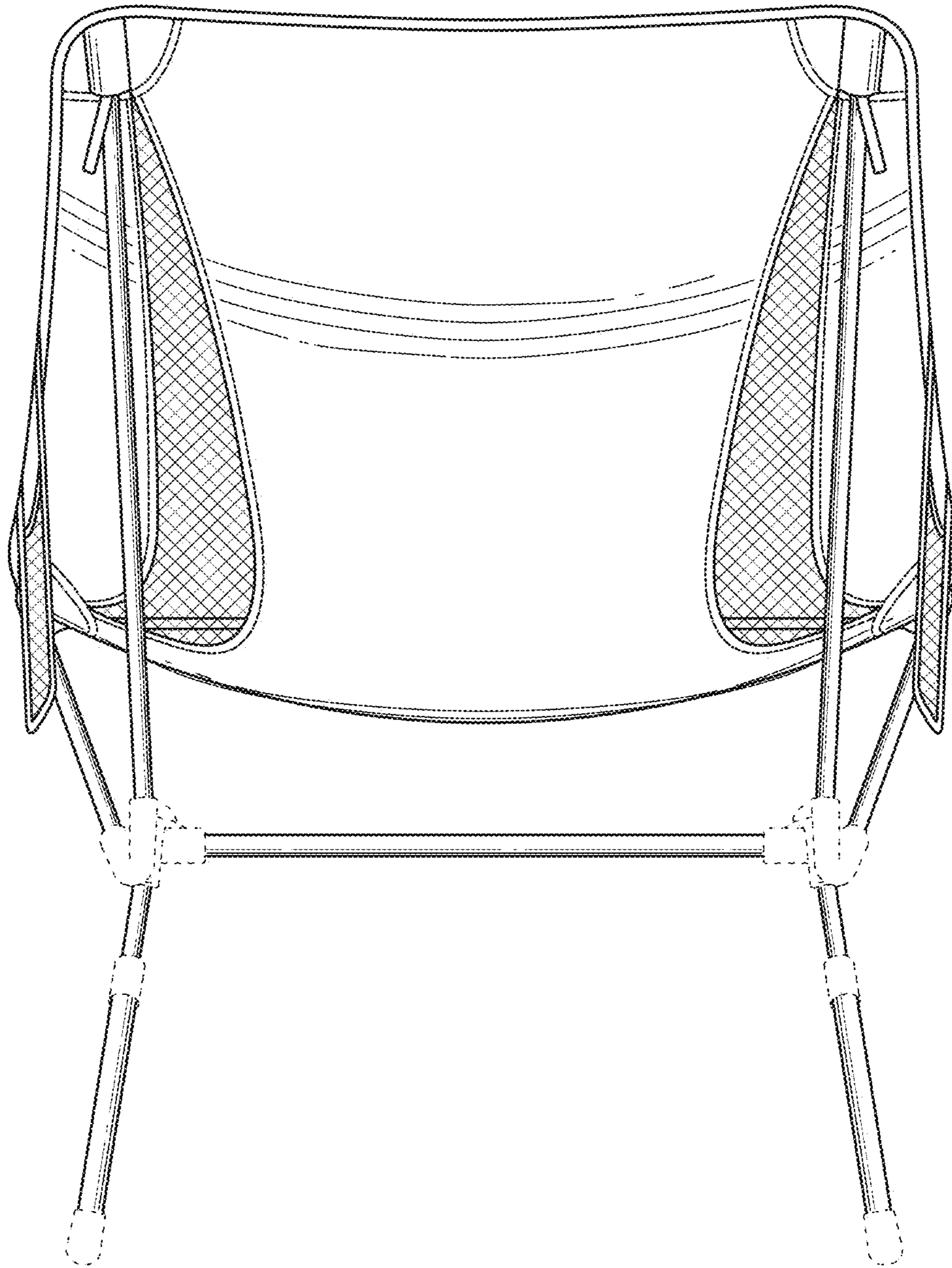

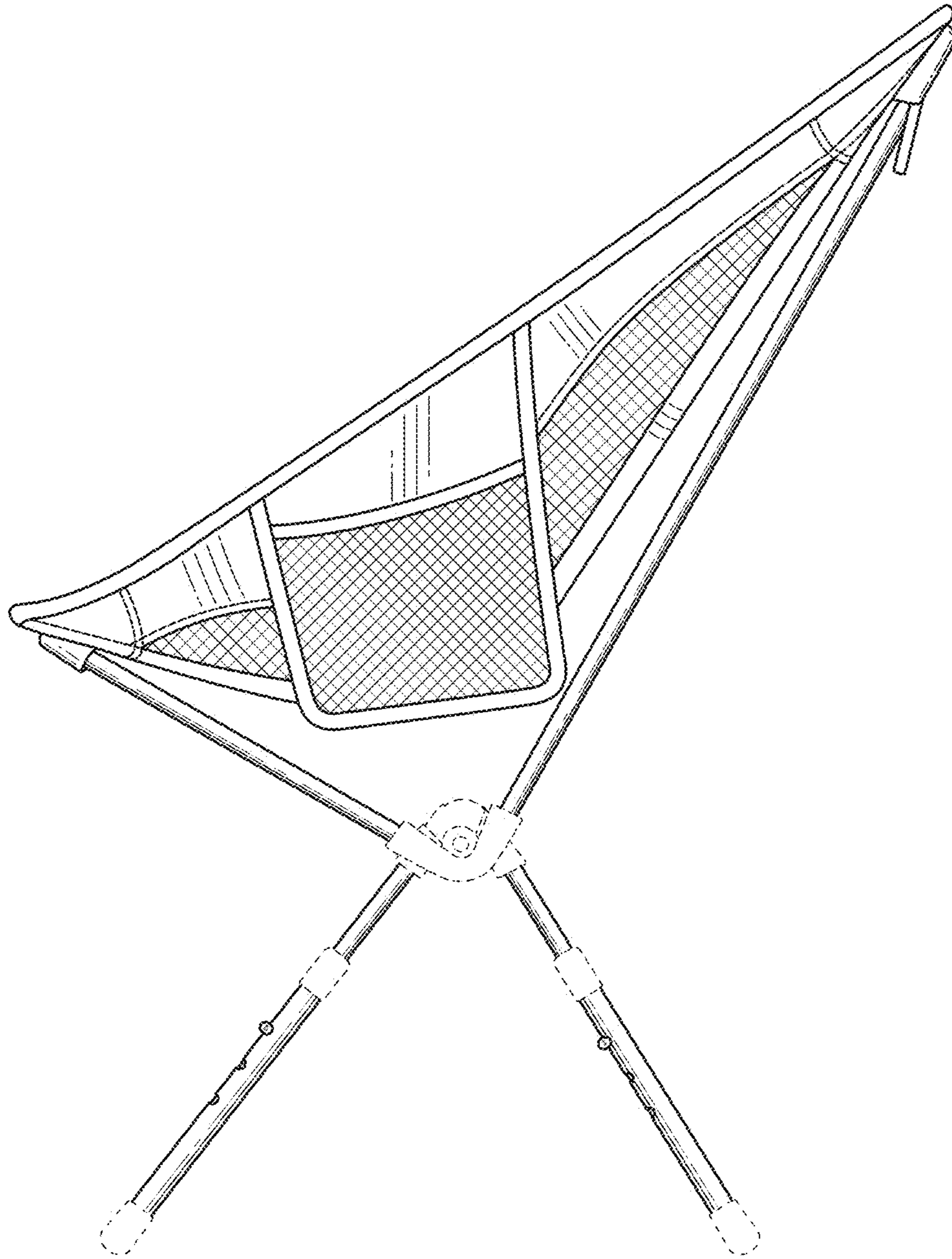

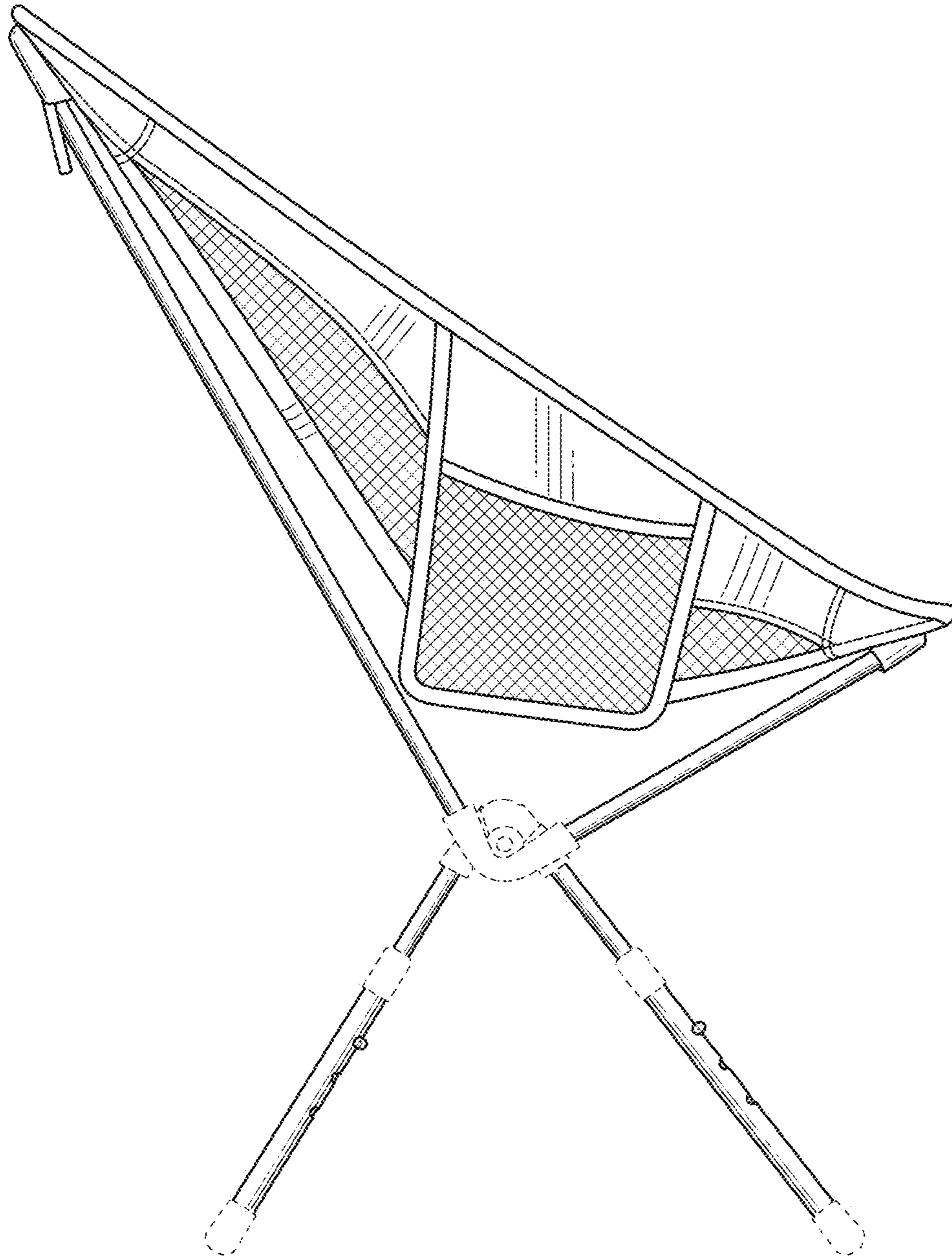

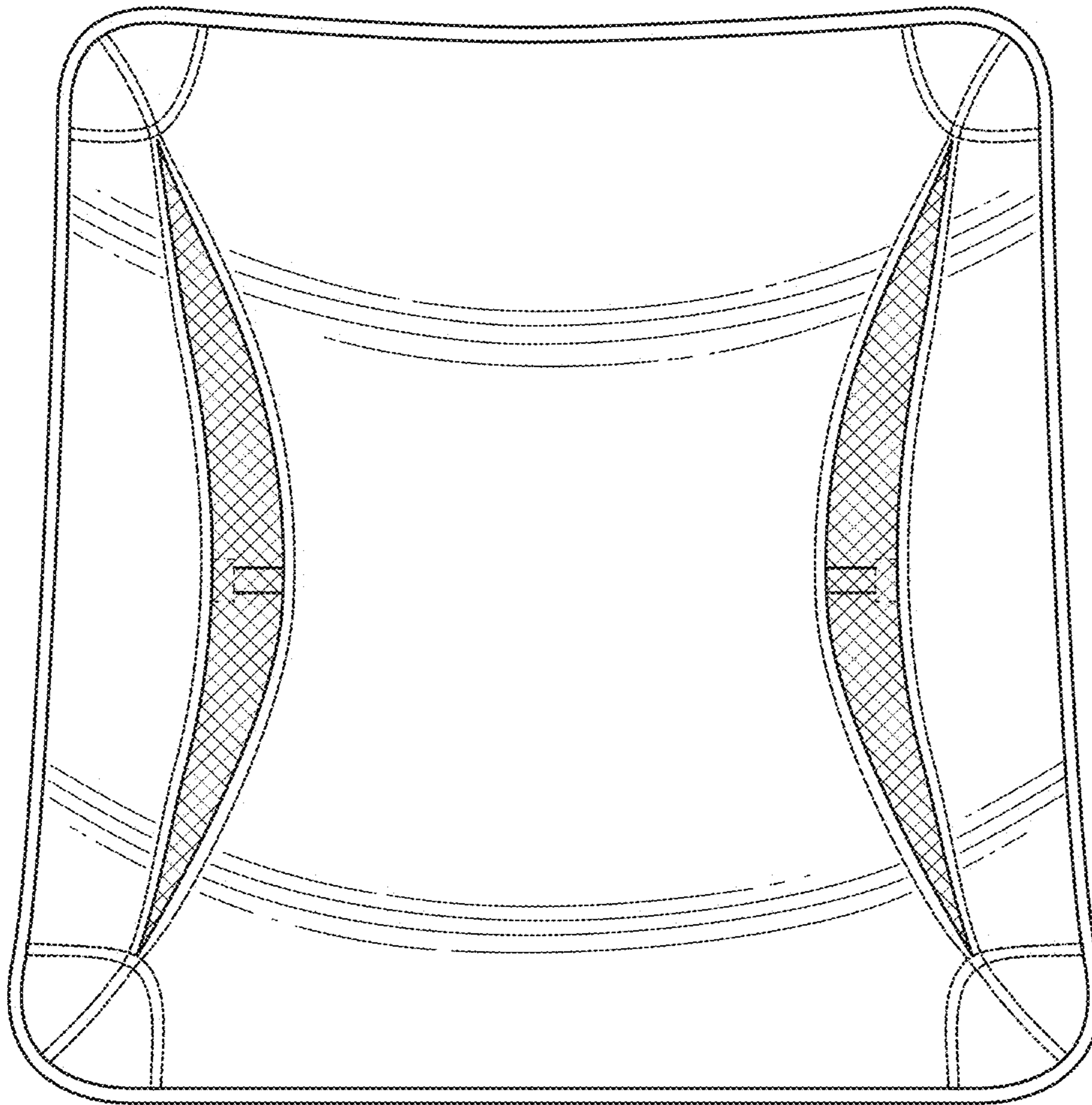

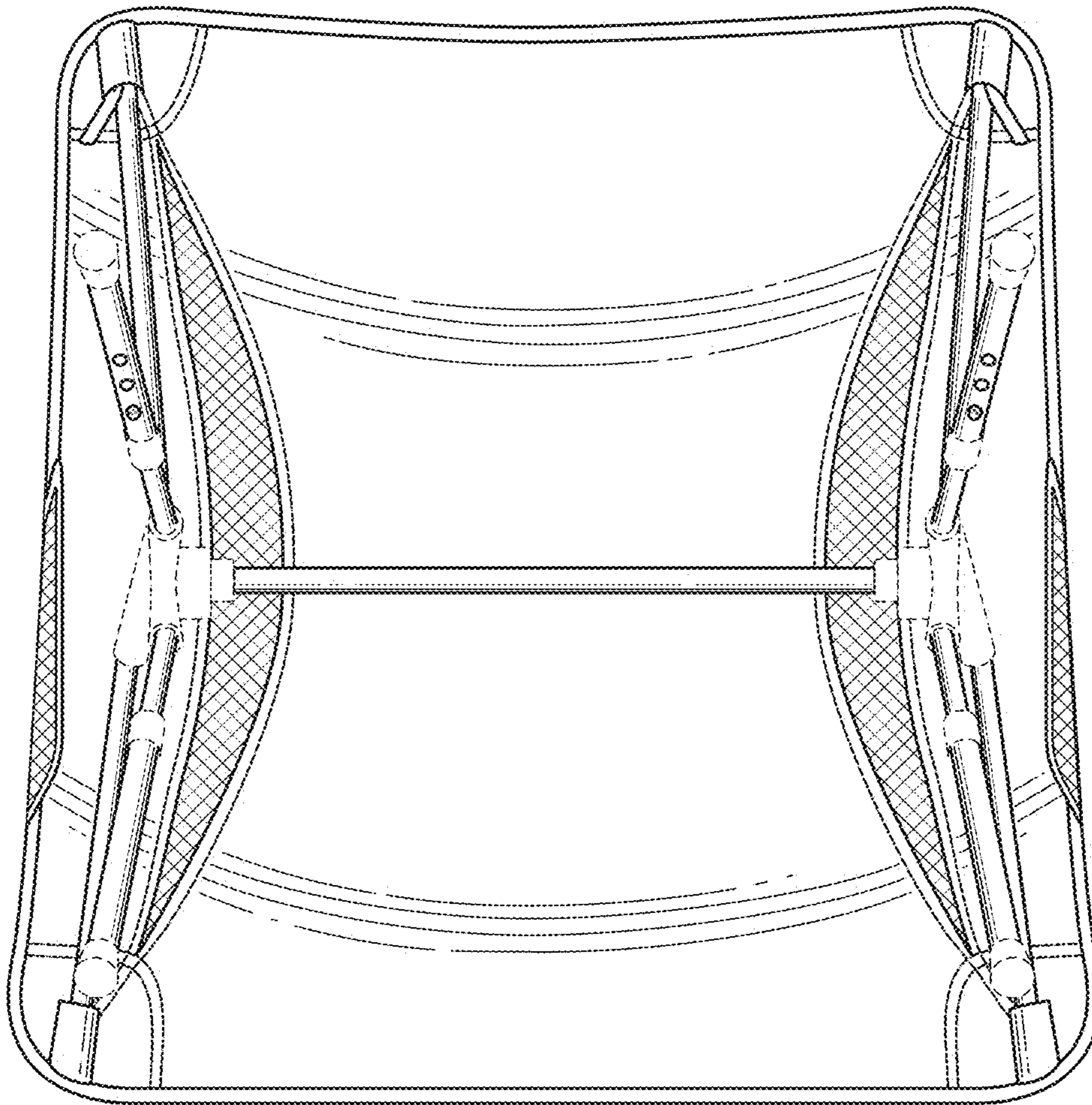

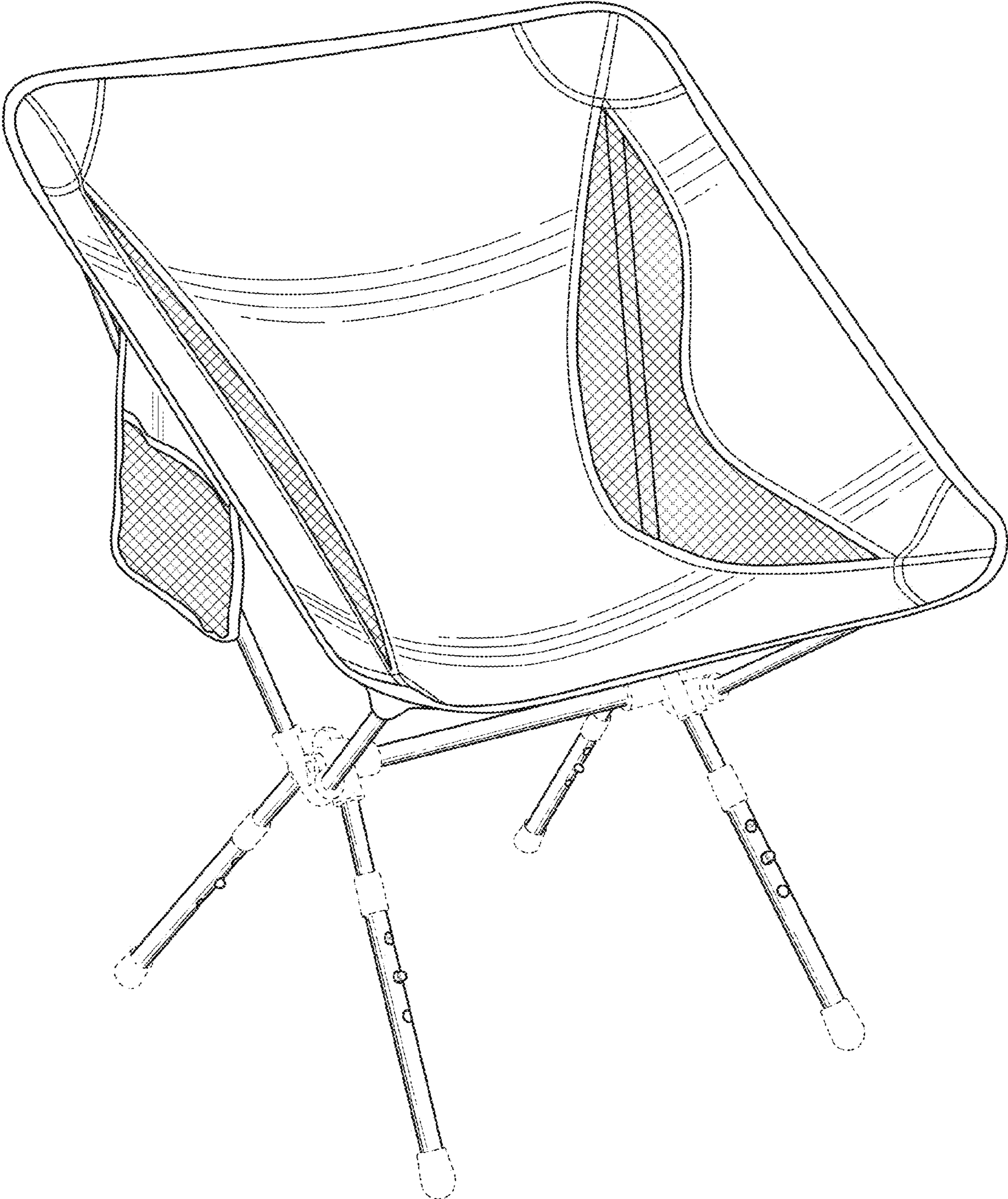
