(57) **CLAIM**

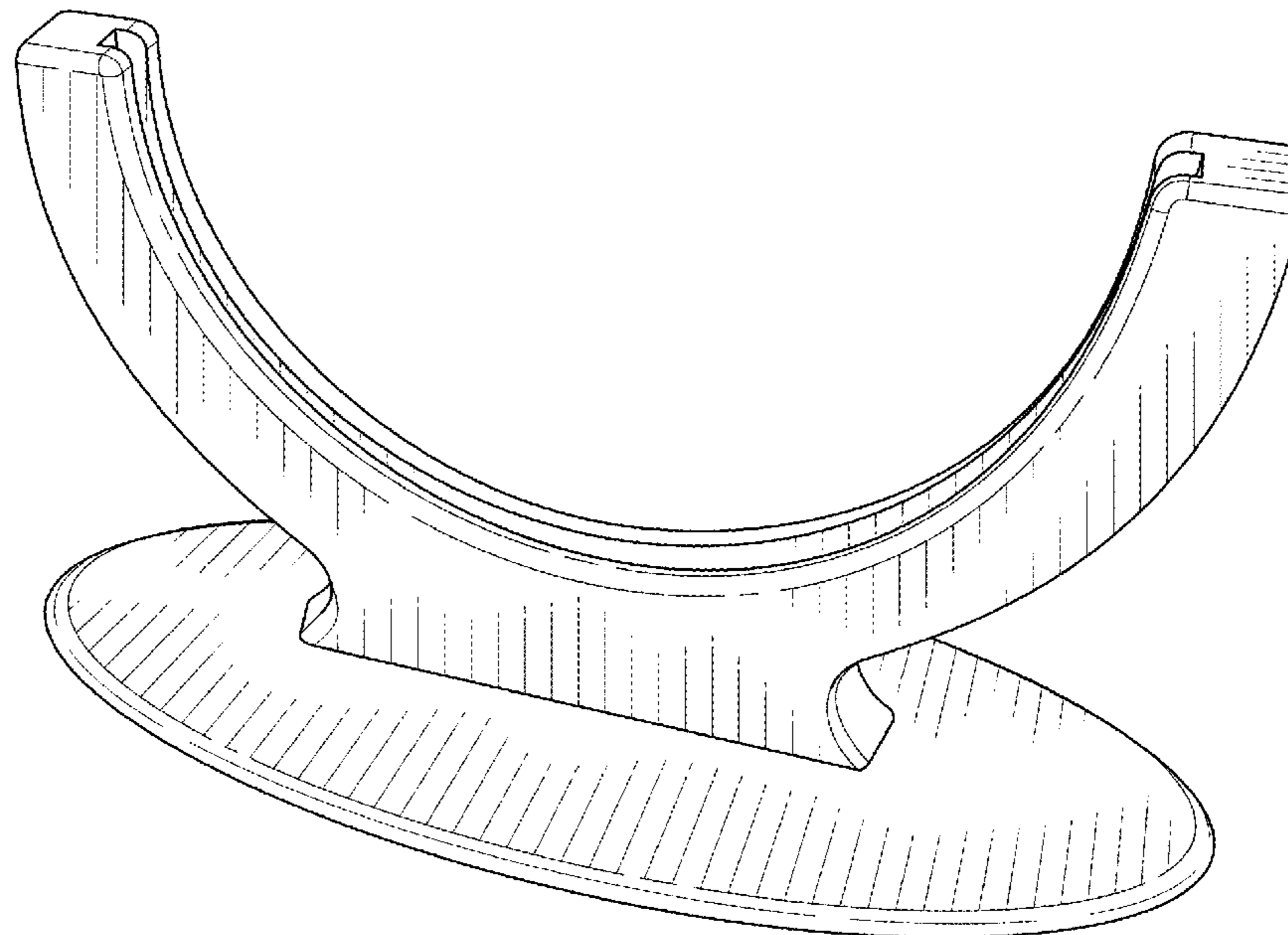
The ornamental design for a memorabilia ball simulacrum stand, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a memorabilia ball simulacrum stand;  
FIG. 2 is a front view of the memorabilia ball simulacrum stand;  
FIG. 3 is a rear view of the memorabilia ball simulacrum stand;  
FIG. 4 is a side view of the memorabilia ball simulacrum stand;  
FIG. 5 is a top view of the memorabilia ball simulacrum stand;  
FIG. 6 is a bottom view of the memorabilia ball simulacrum stand; and,  
FIG. 7 is a perspective view of the memorabilia ball simulacrum stand with a memorabilia ball simulacrum installed in the stand.

The broken lines in FIG. 7 representing a memorabilia ball simulacrum, show the design as being used, and form no part of the claimed design.

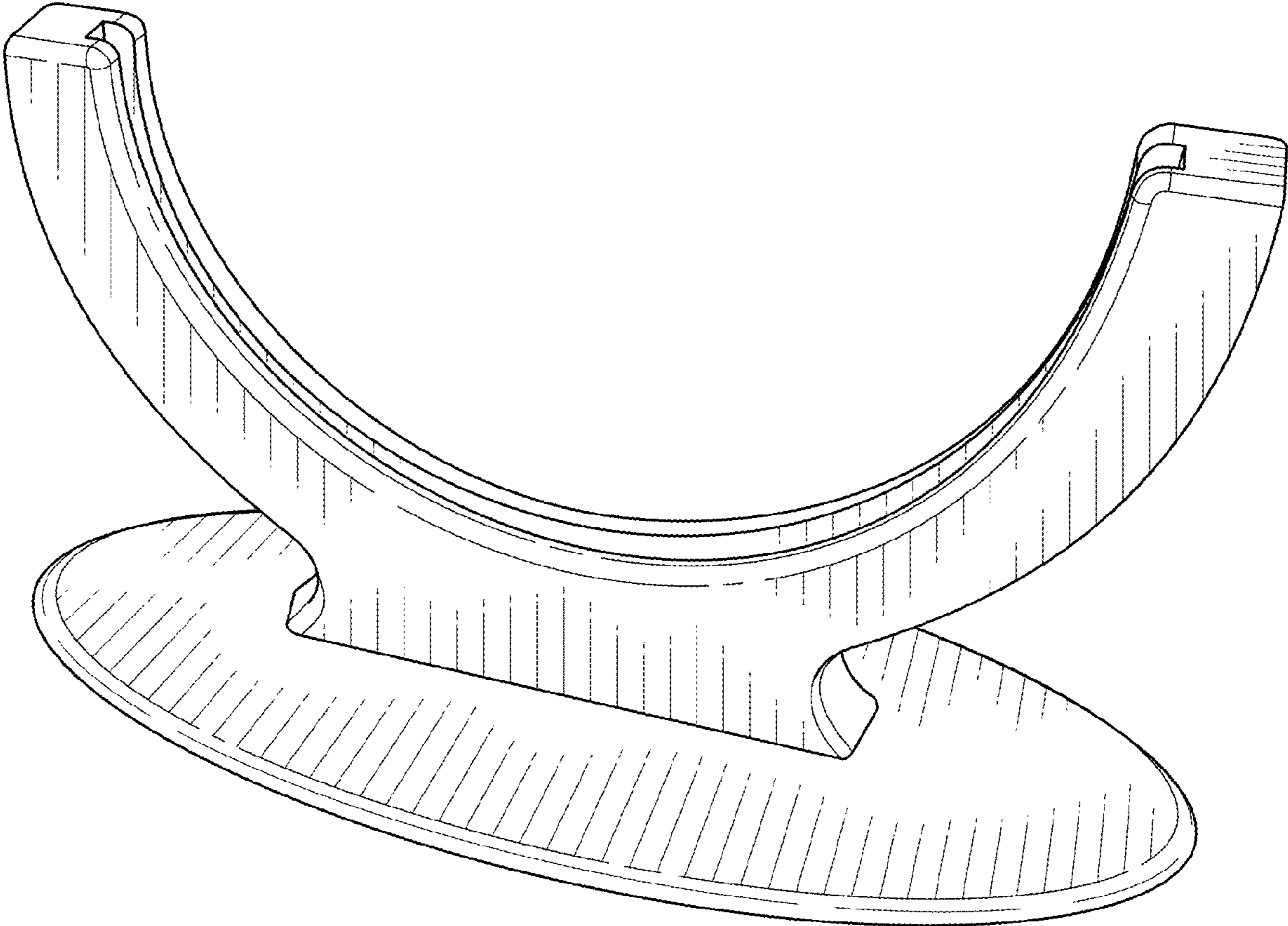

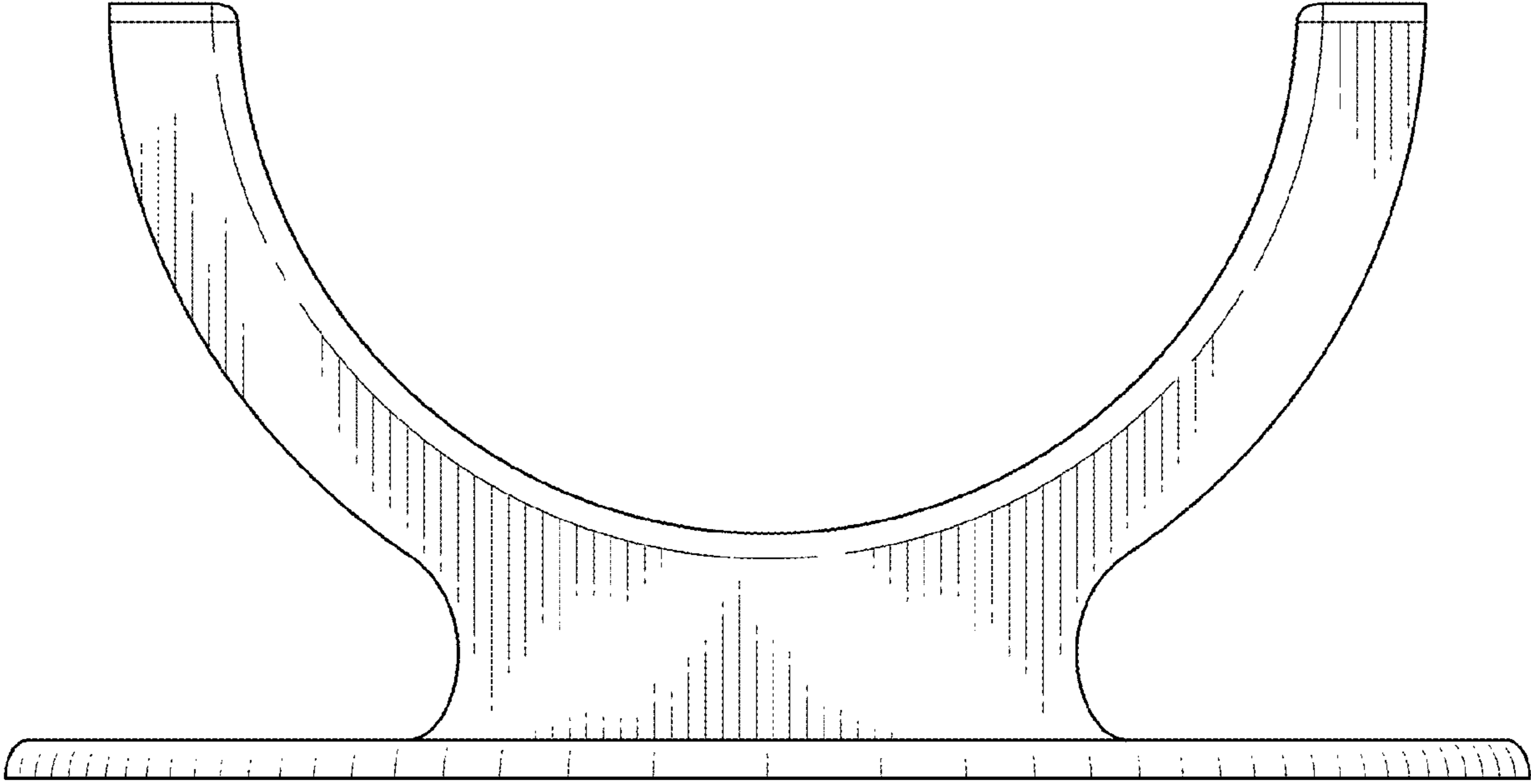

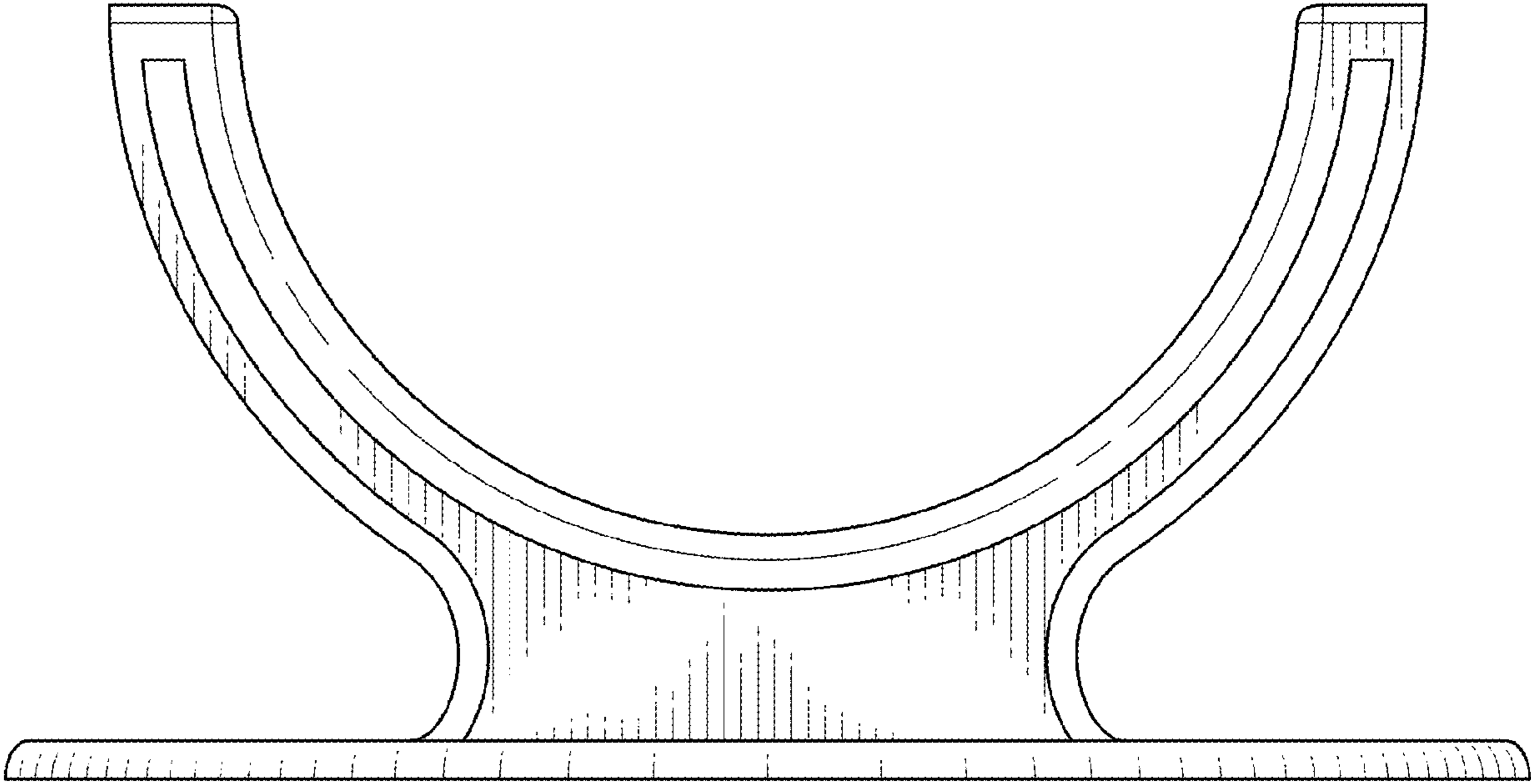

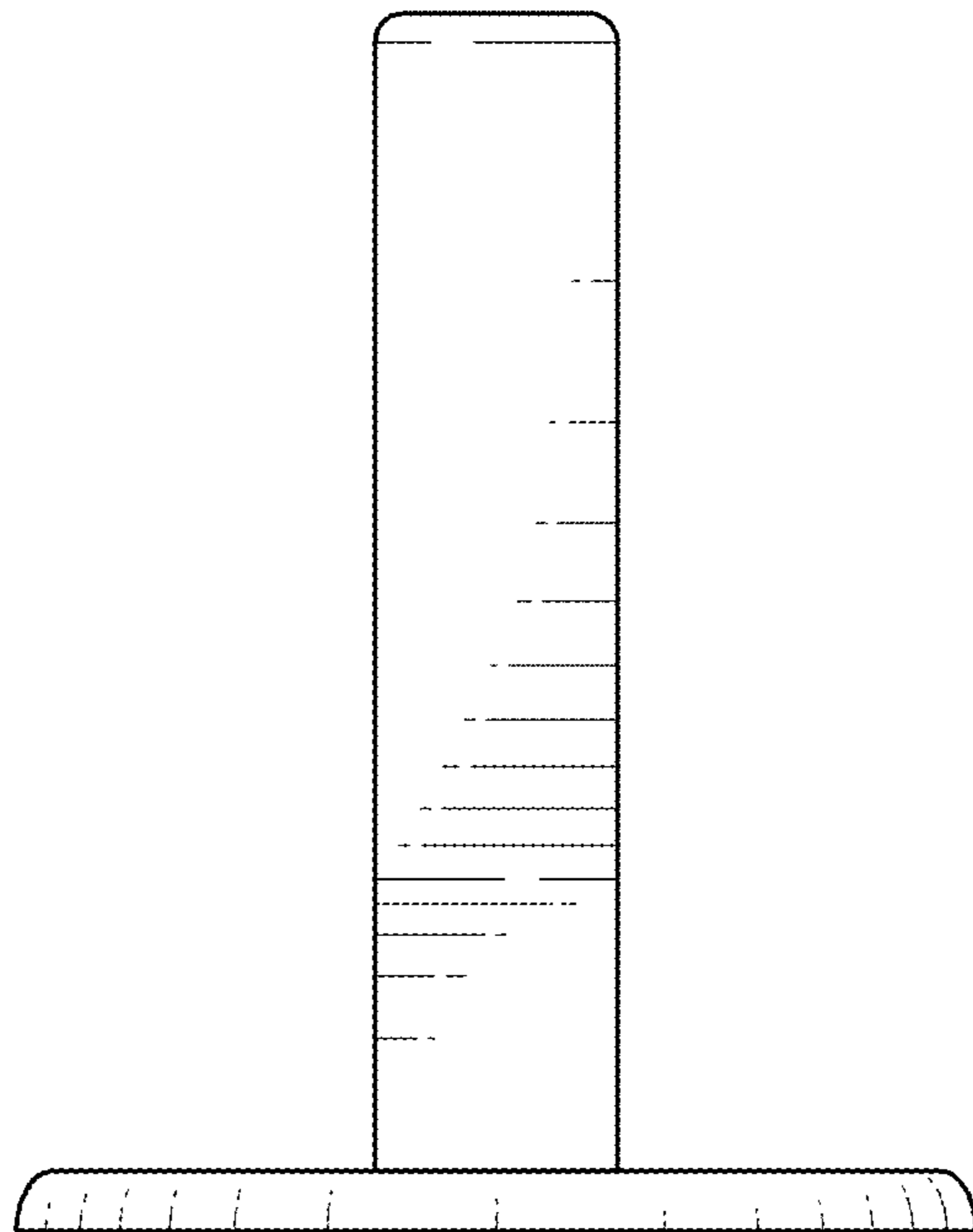

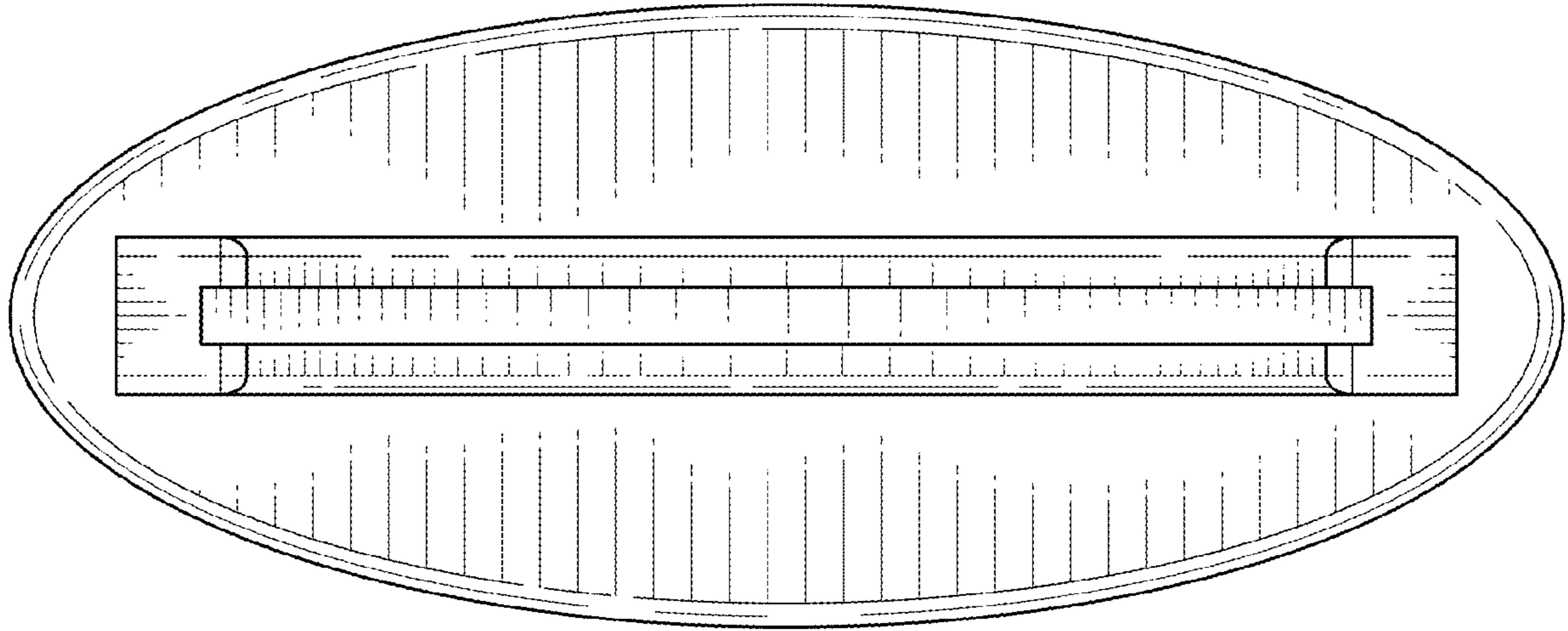

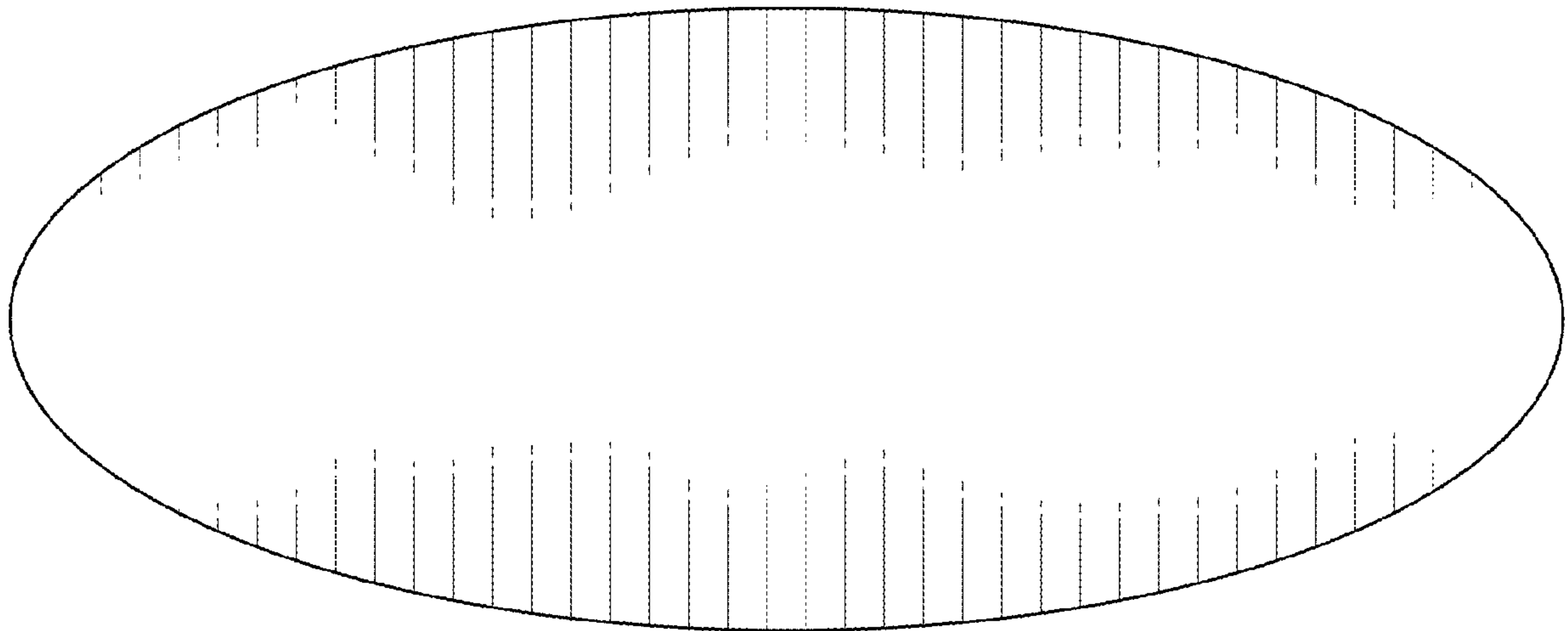

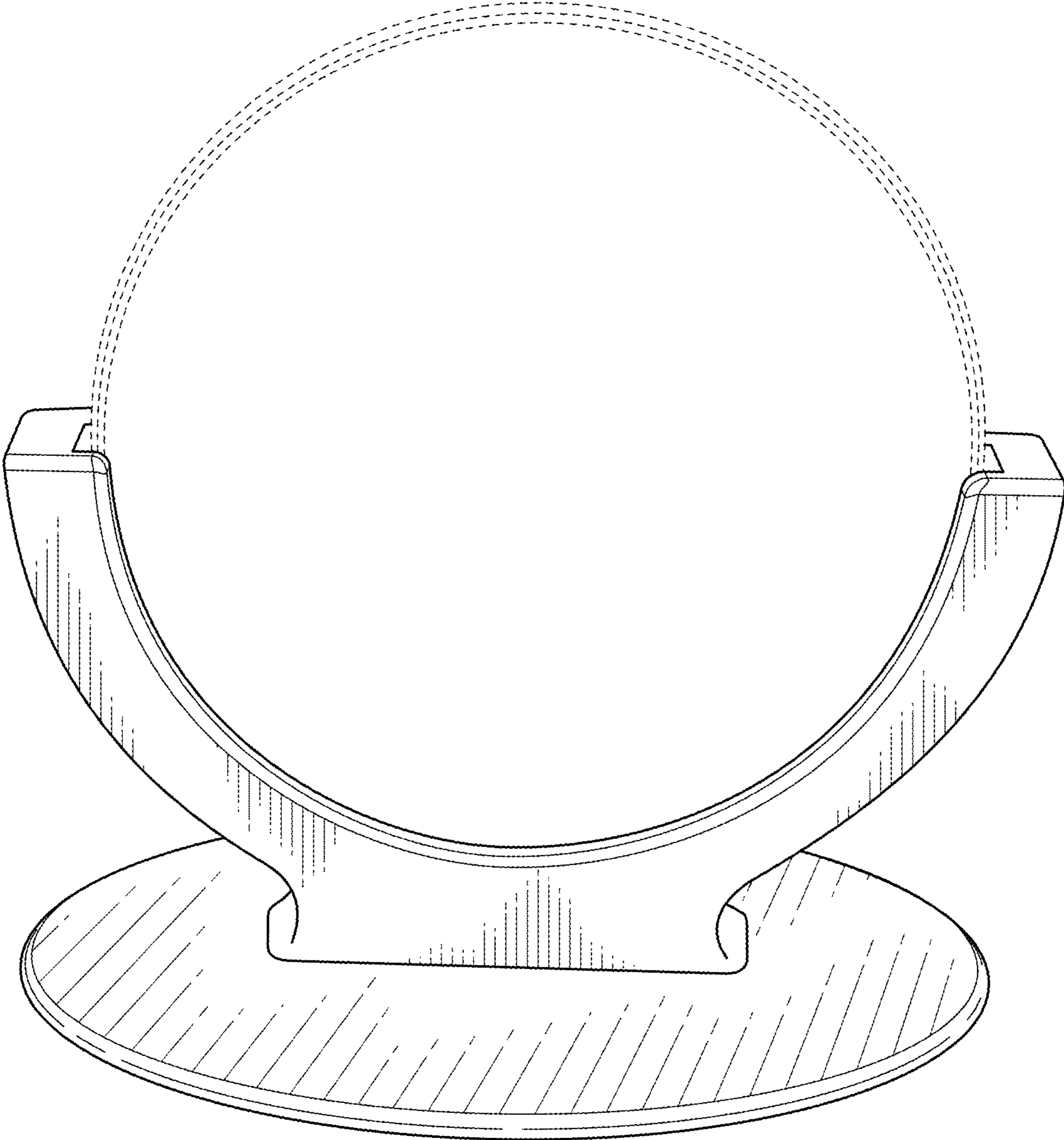
