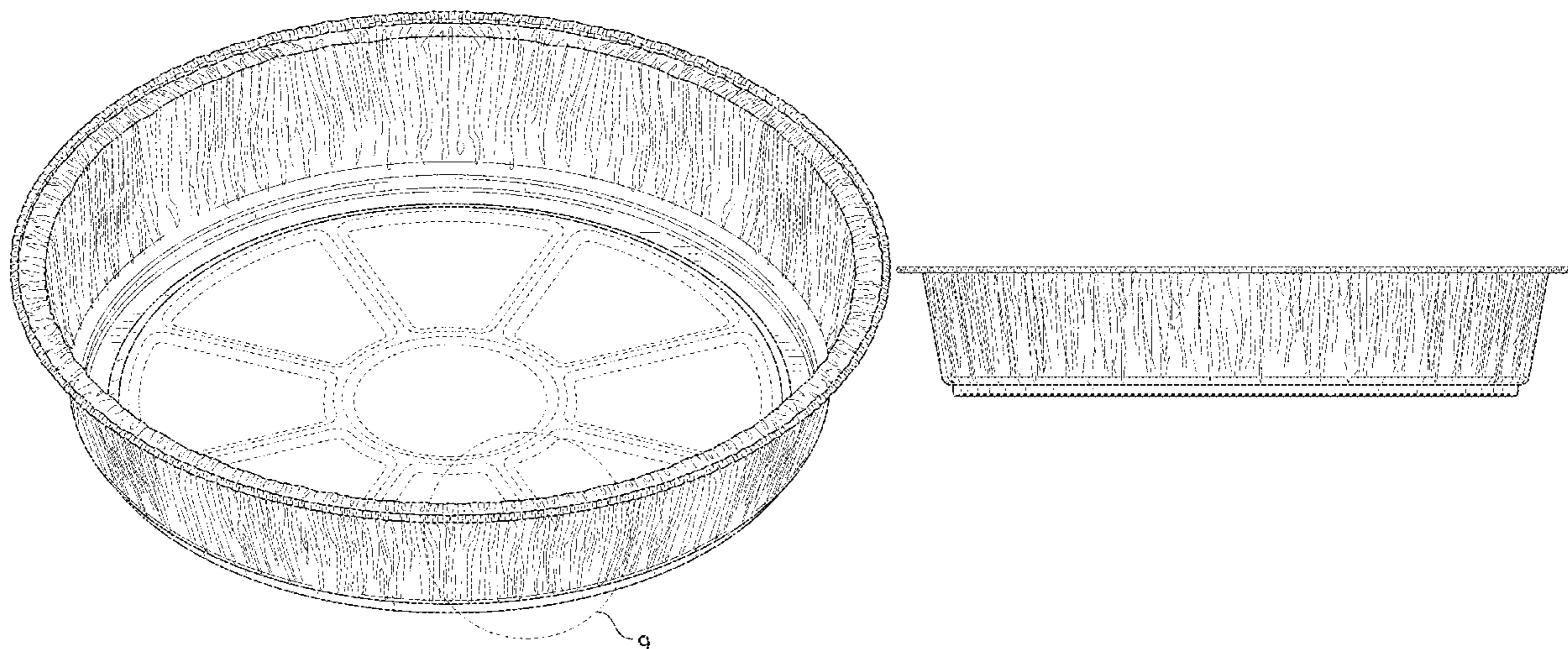
The ornamental design for a pan, as shown and described.

DESCRIPTION

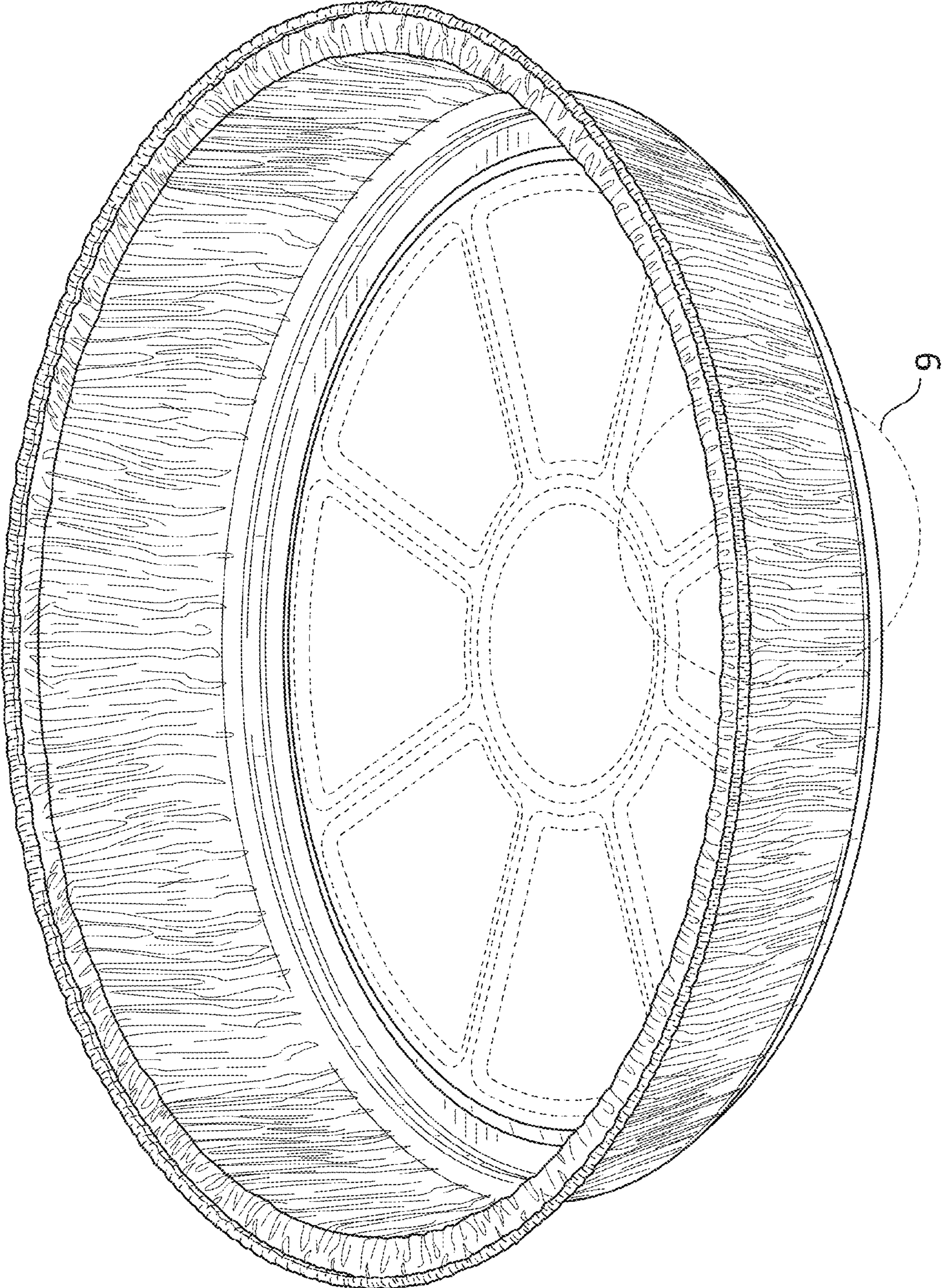

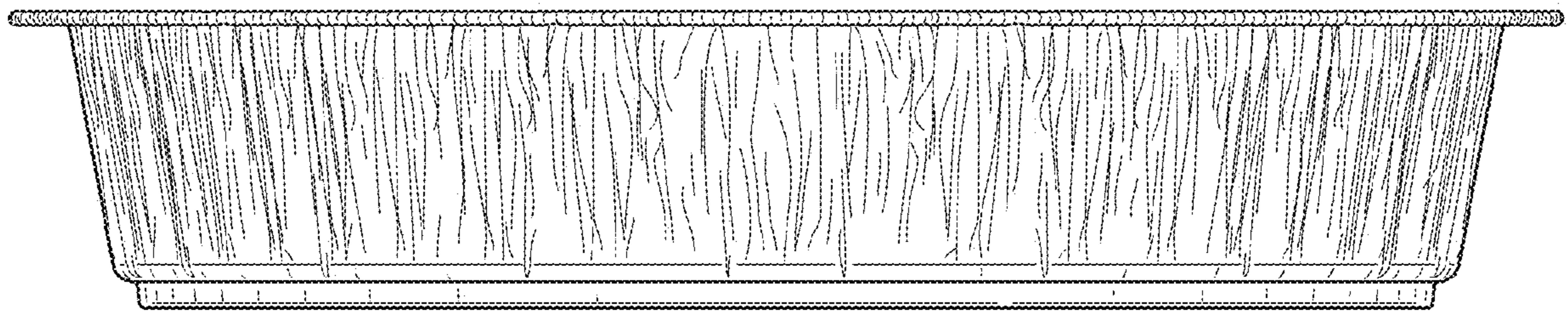

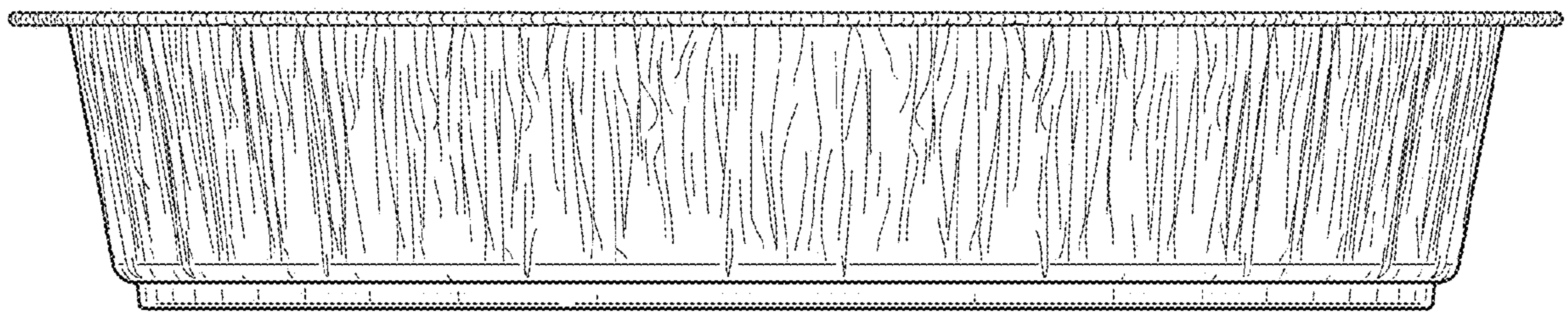

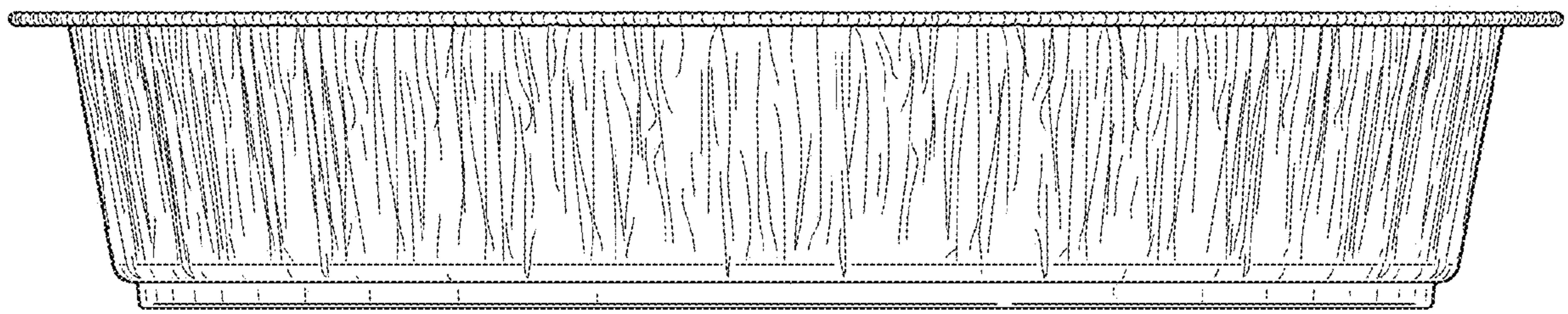

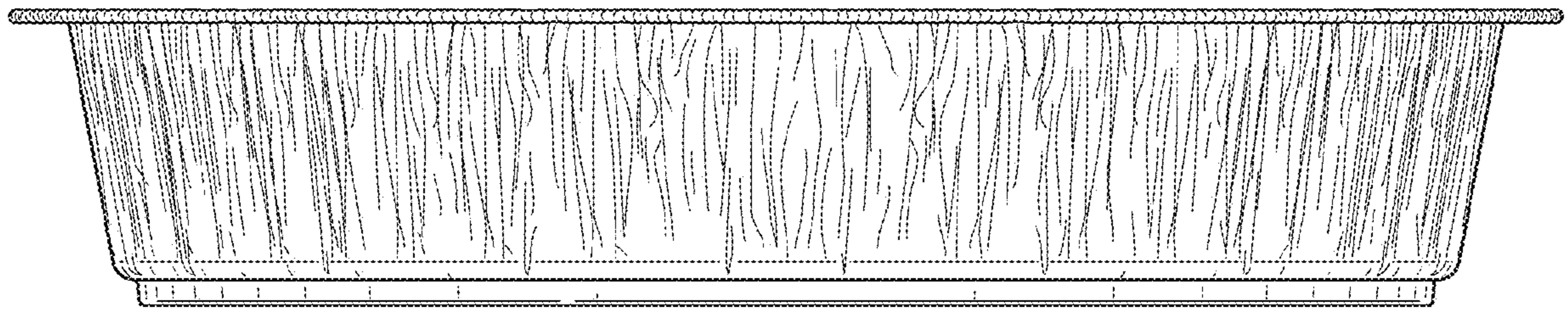

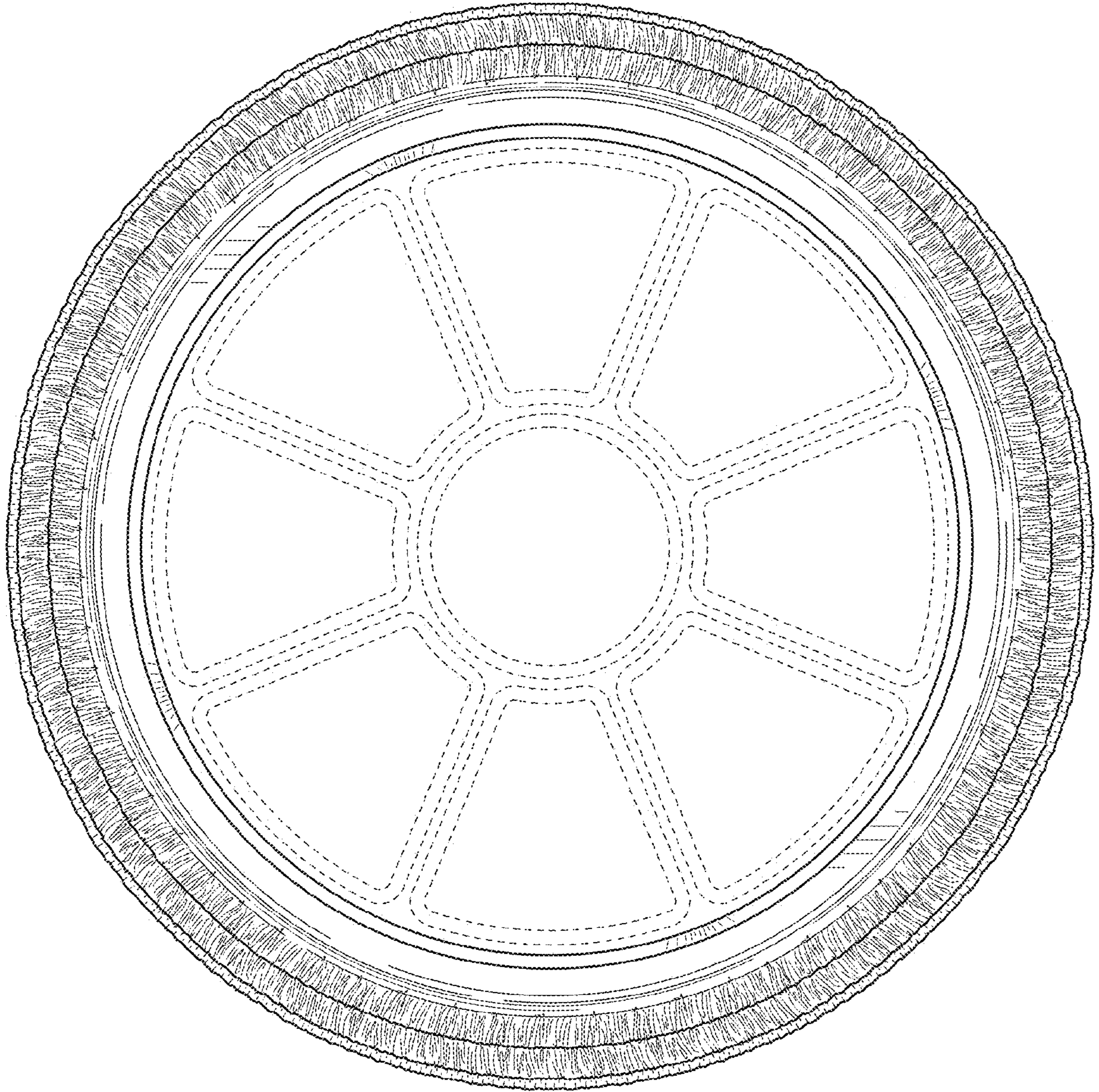

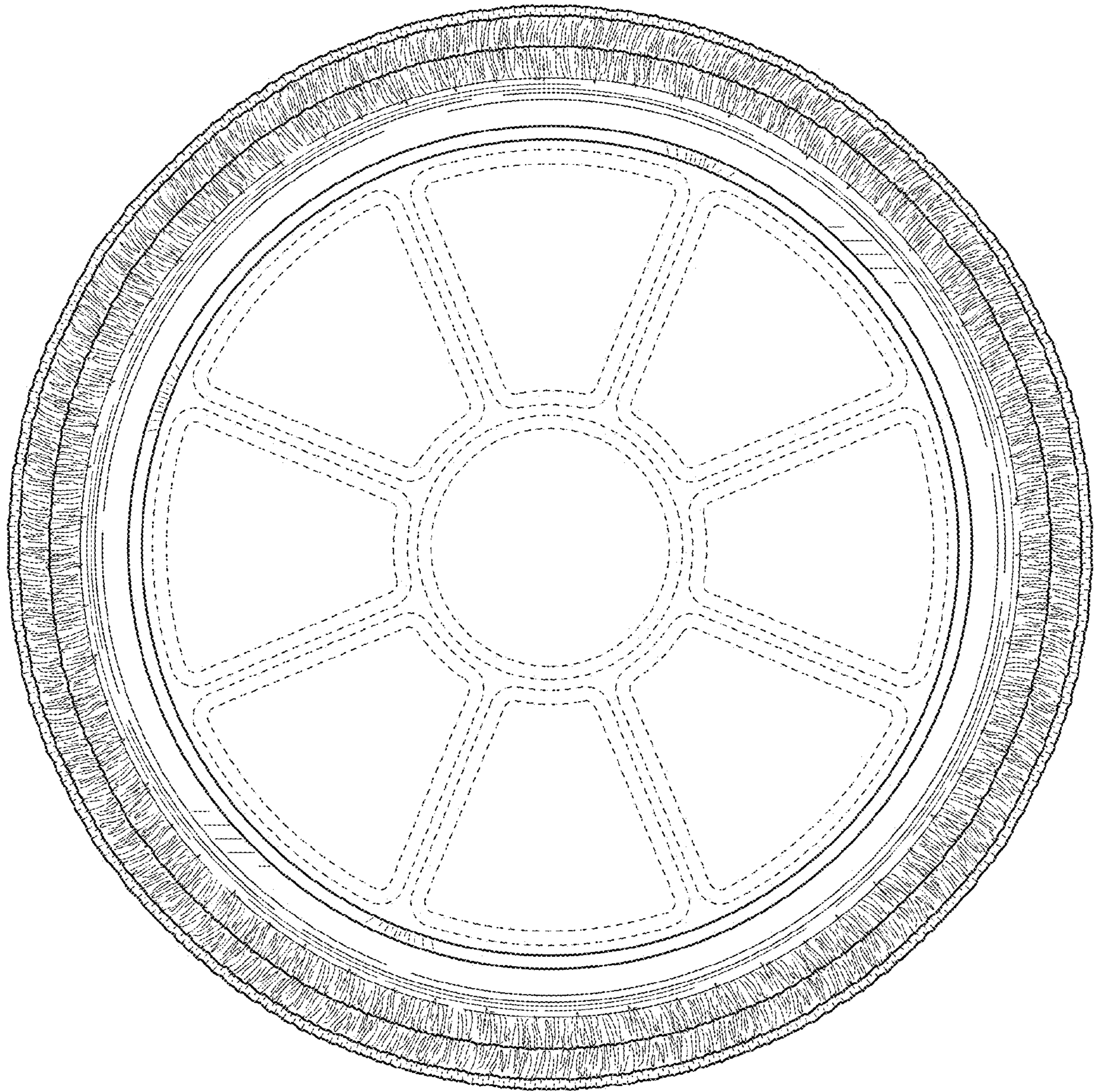

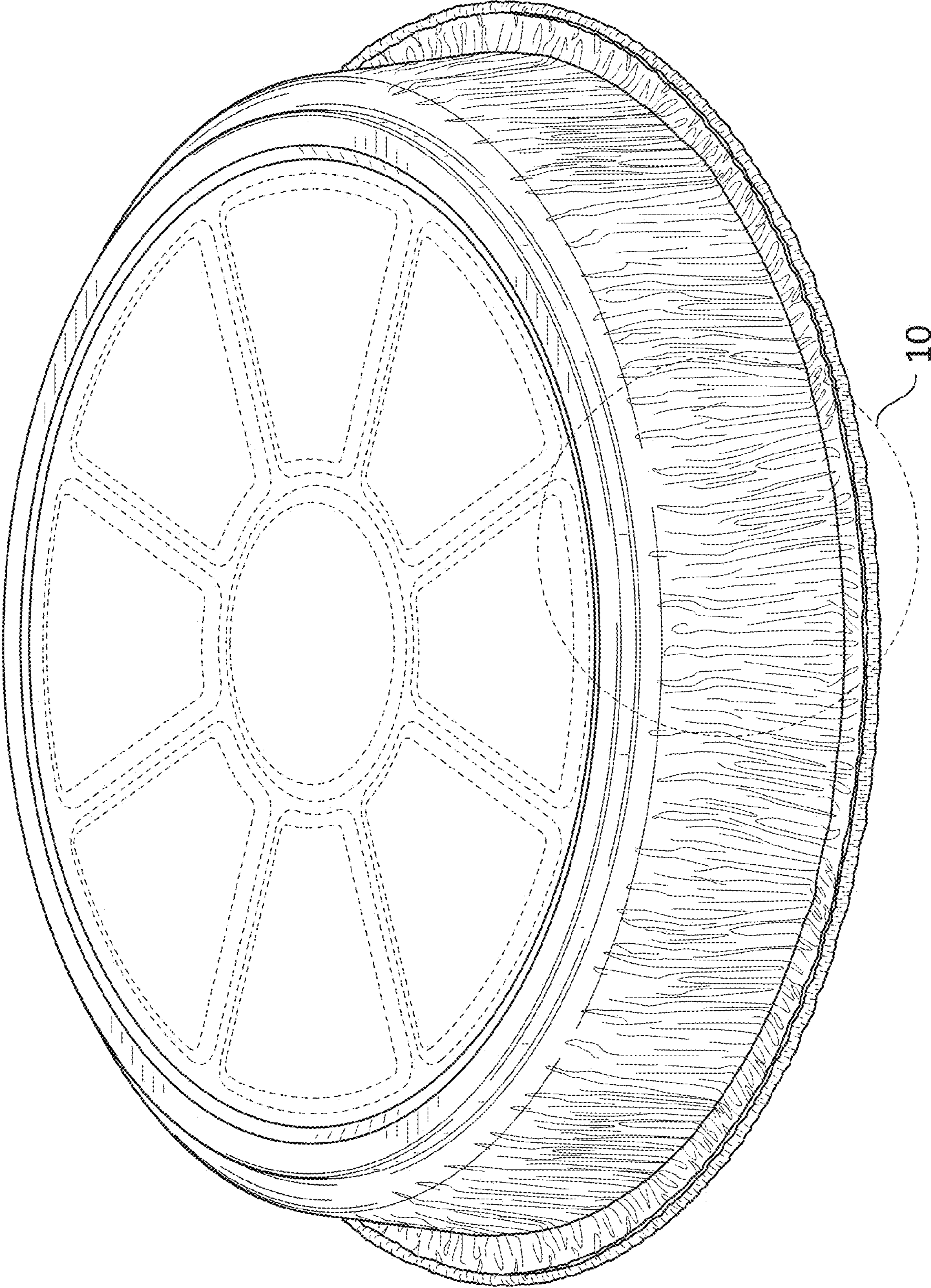

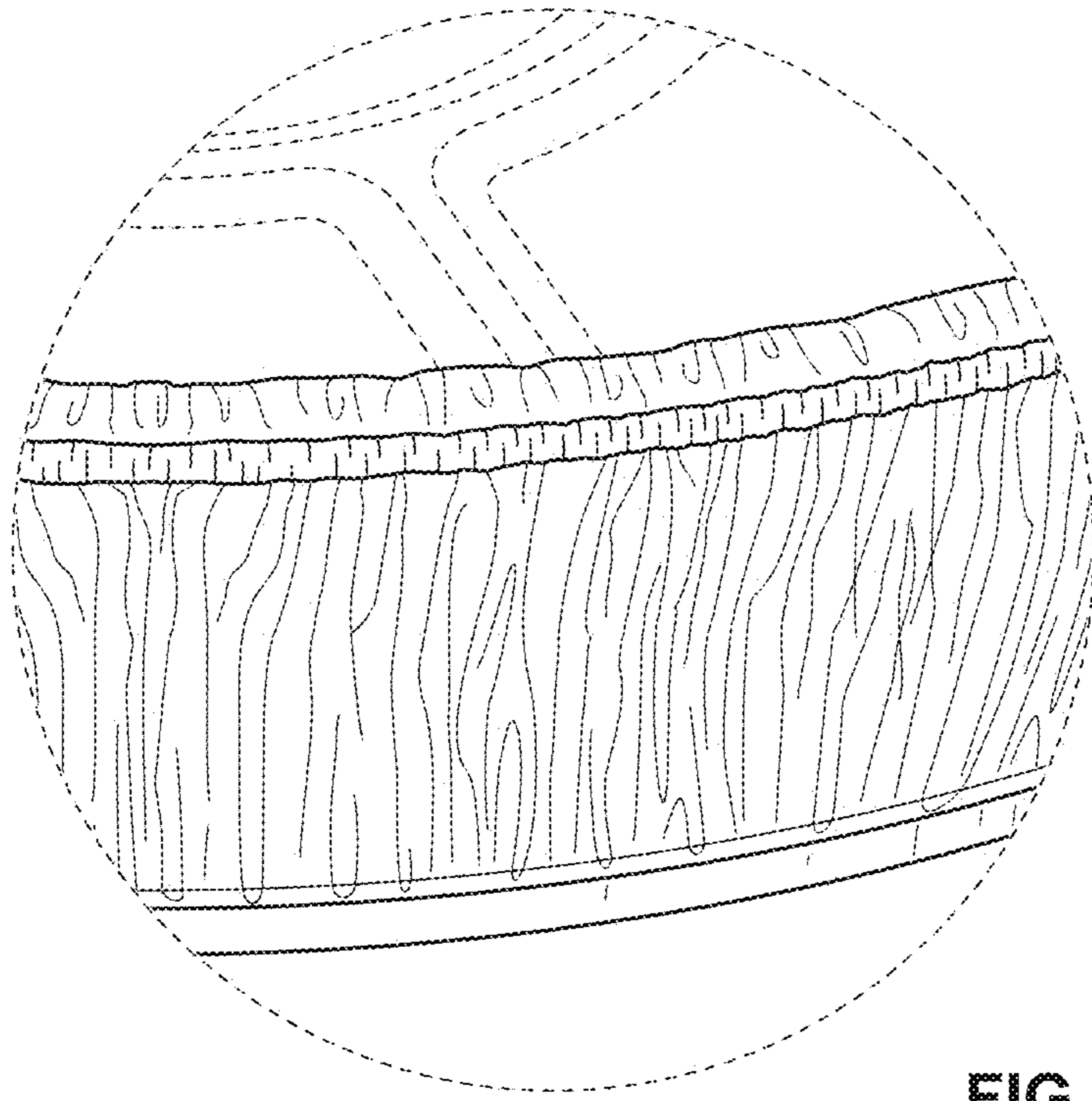

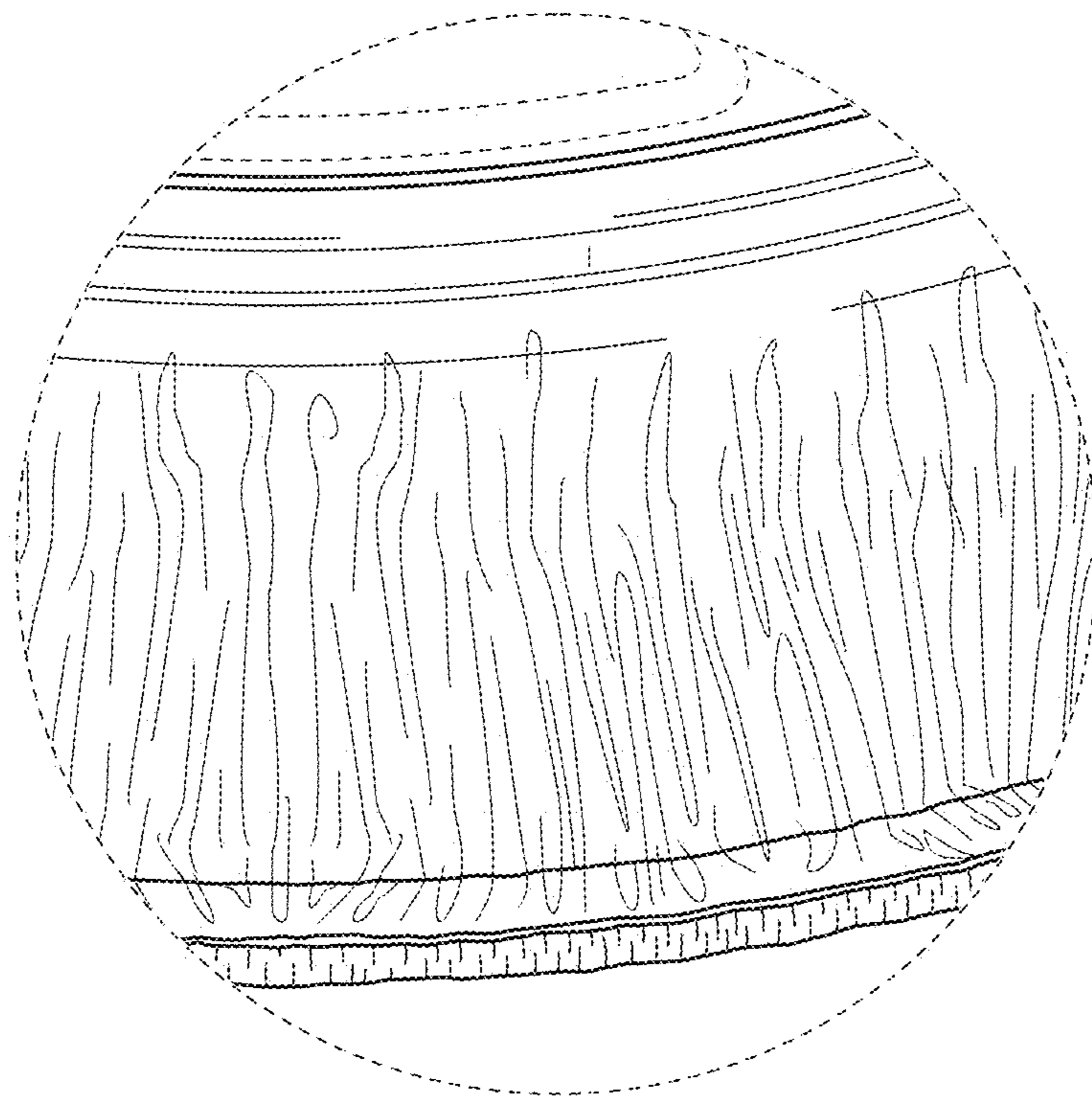
