The ornamental design for a utensil holder, as shown and described.

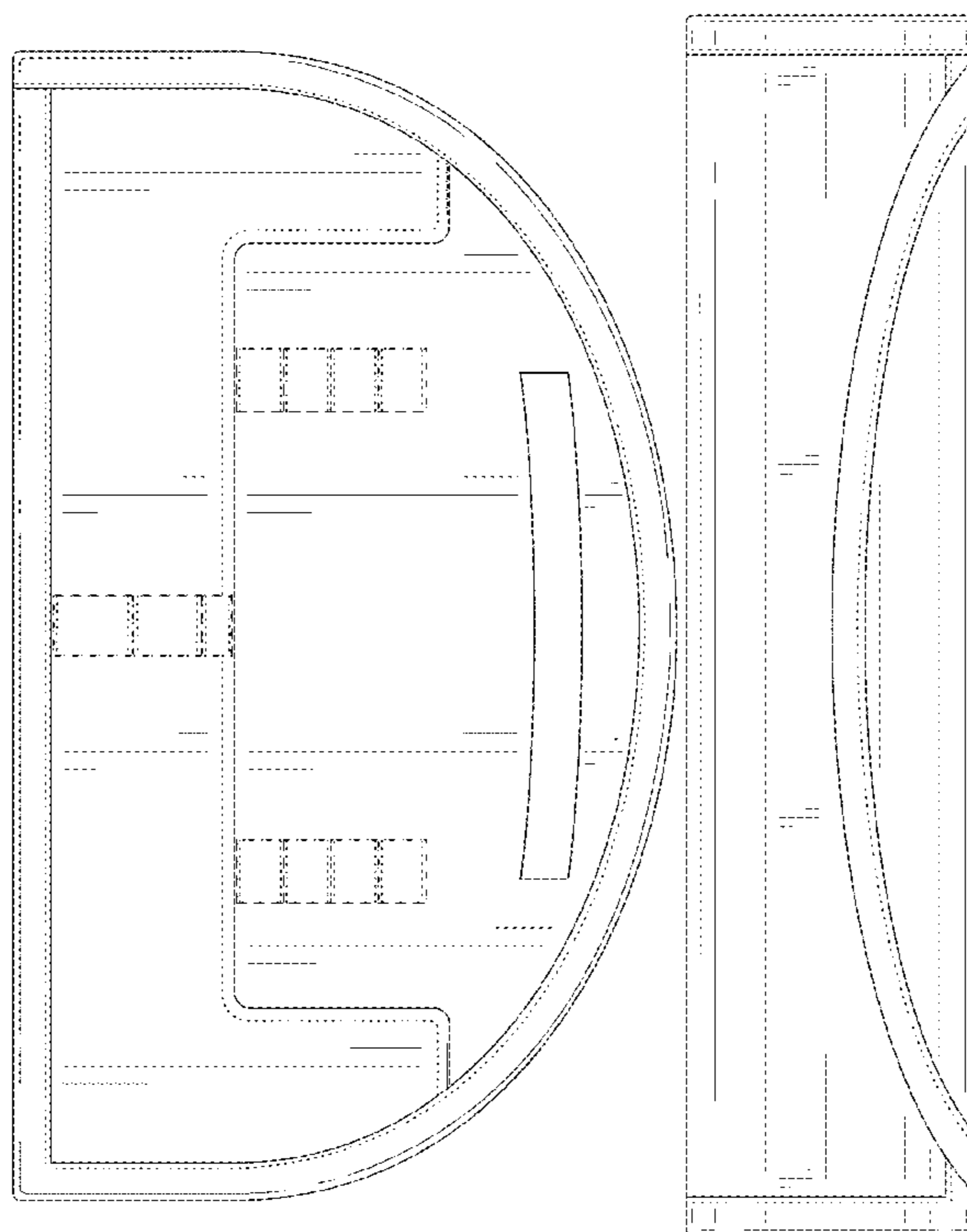
DESCRIPTION

FIG. 1. is a top view of a utensil holder, showing my new design, shown in open condition;
FIG. 2 is a bottom view thereof, shown in open condition;
FIG. 3 is a top view thereof;
FIG. 4 is a bottom view thereof;
FIG. 5 is a side view thereof;
FIG. 6 is an opposite side view thereof;
FIG. 7 is a front view thereof; and,
FIG. 8 is a rear view thereof.

The dotted lines on the utensil holder of FIGS. 1-4, 7, and 8 are included to show unclaimed stitching on the article.

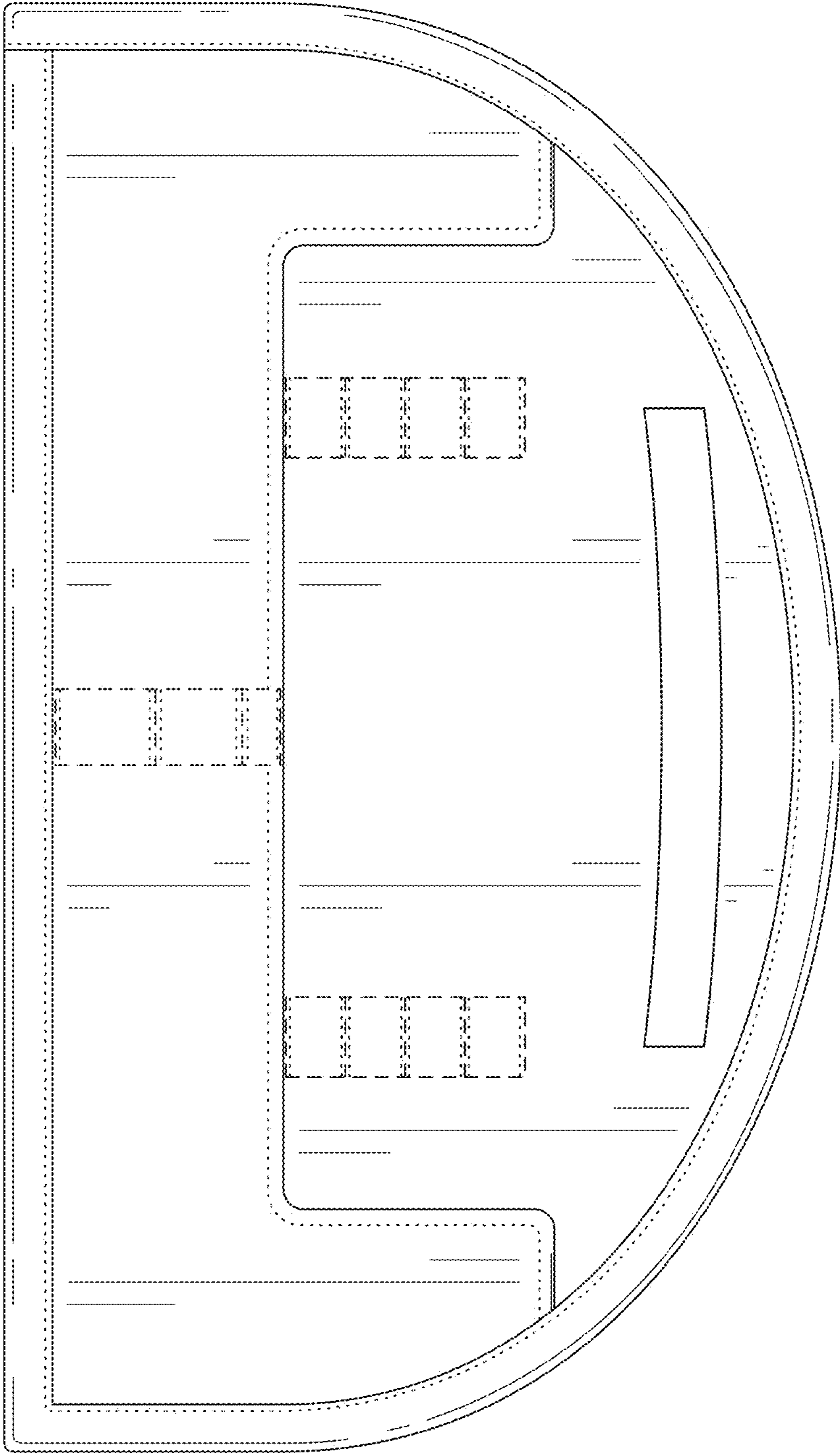

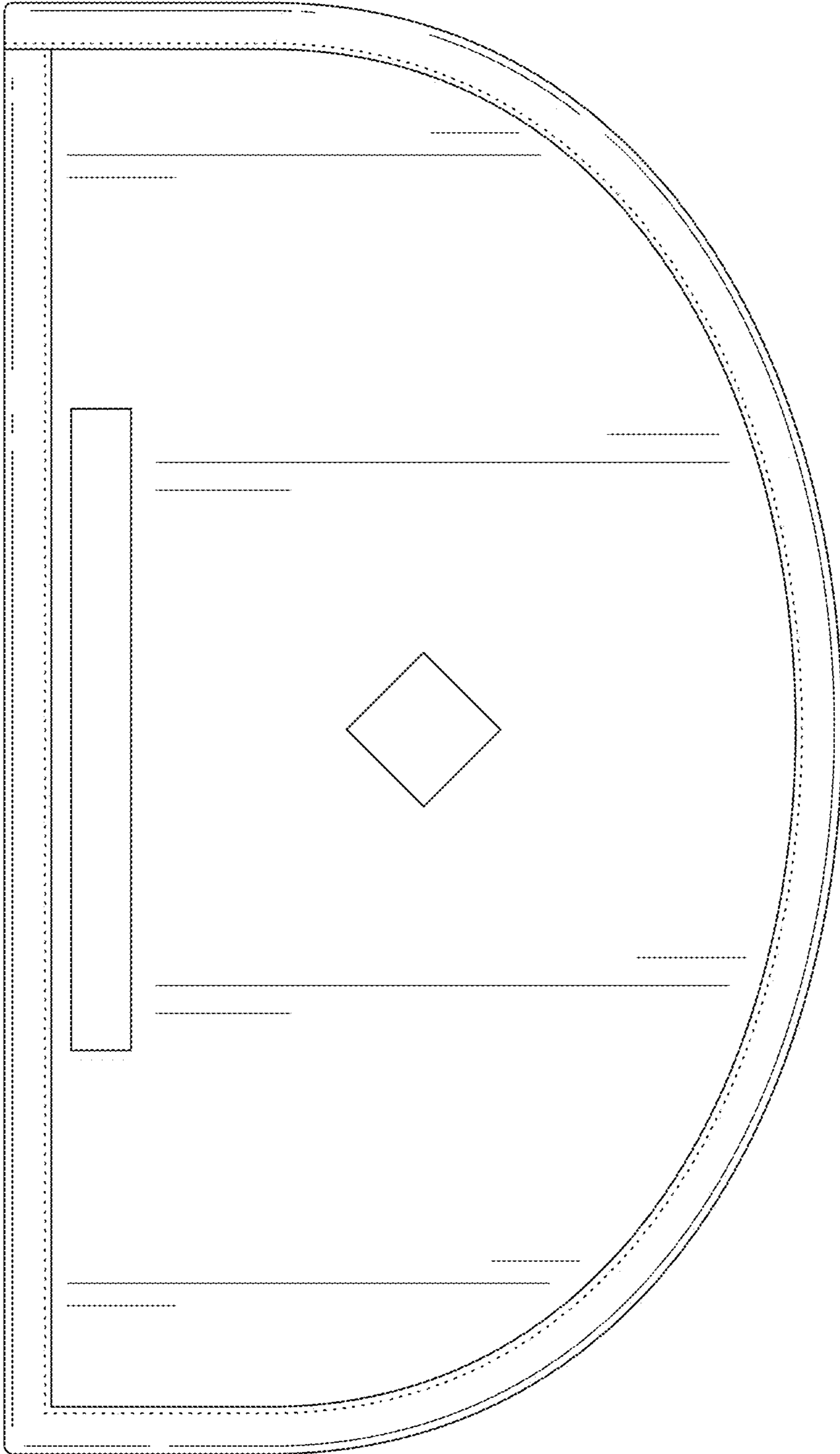

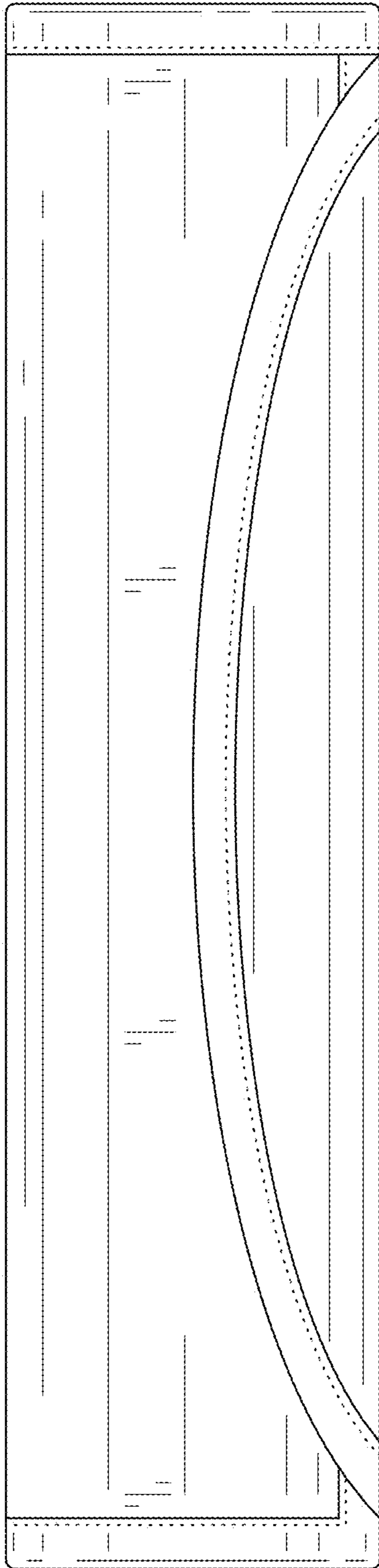

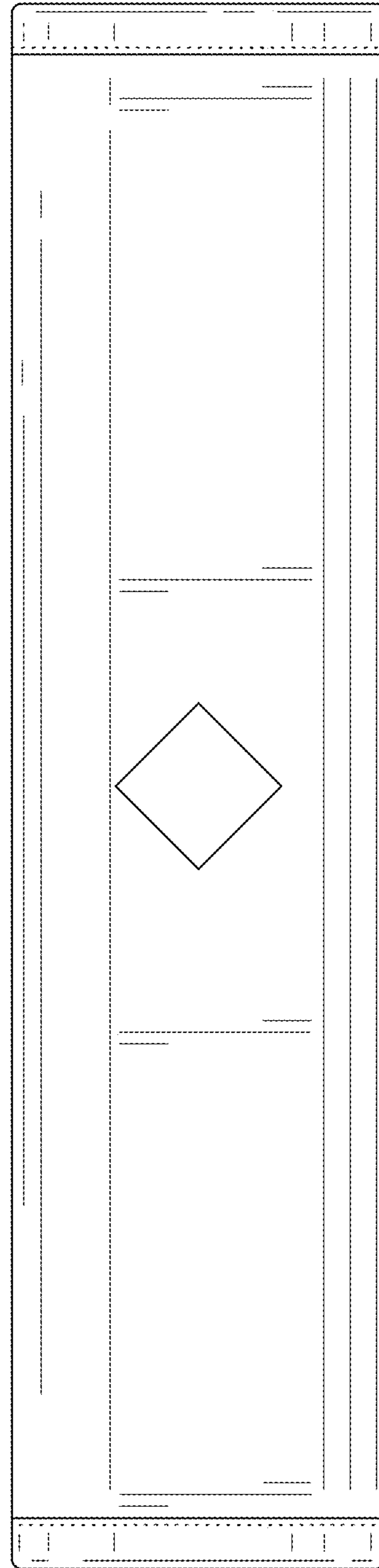

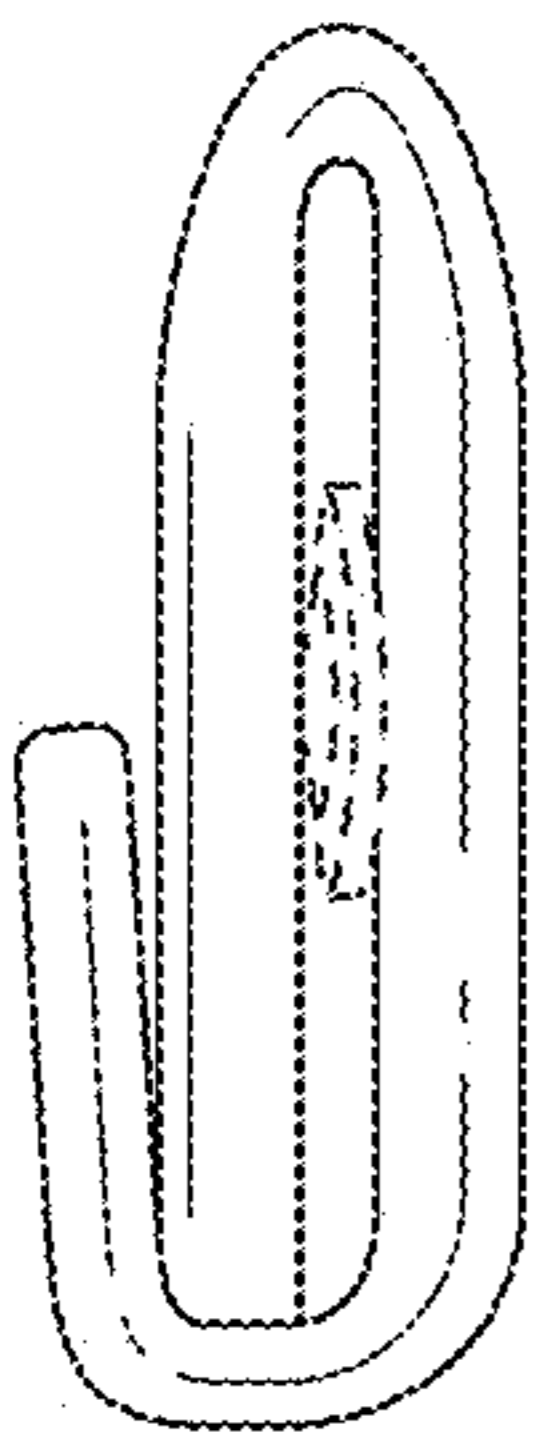

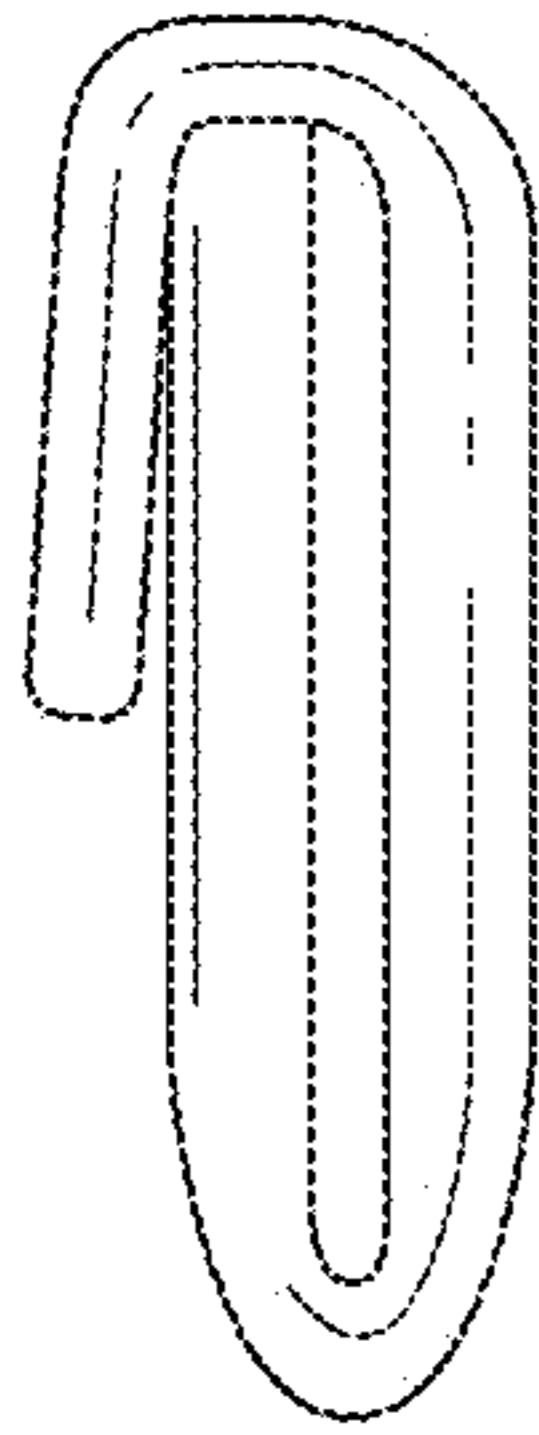

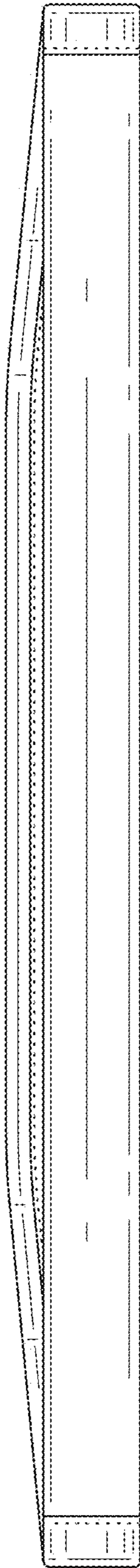

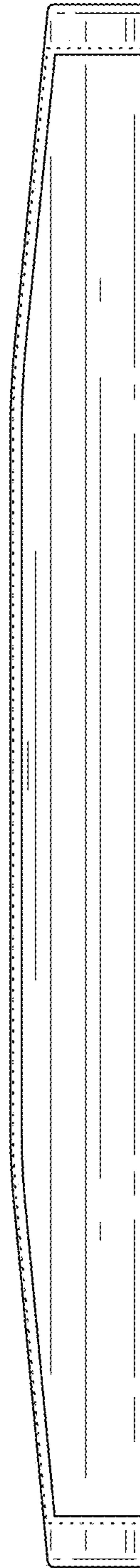
