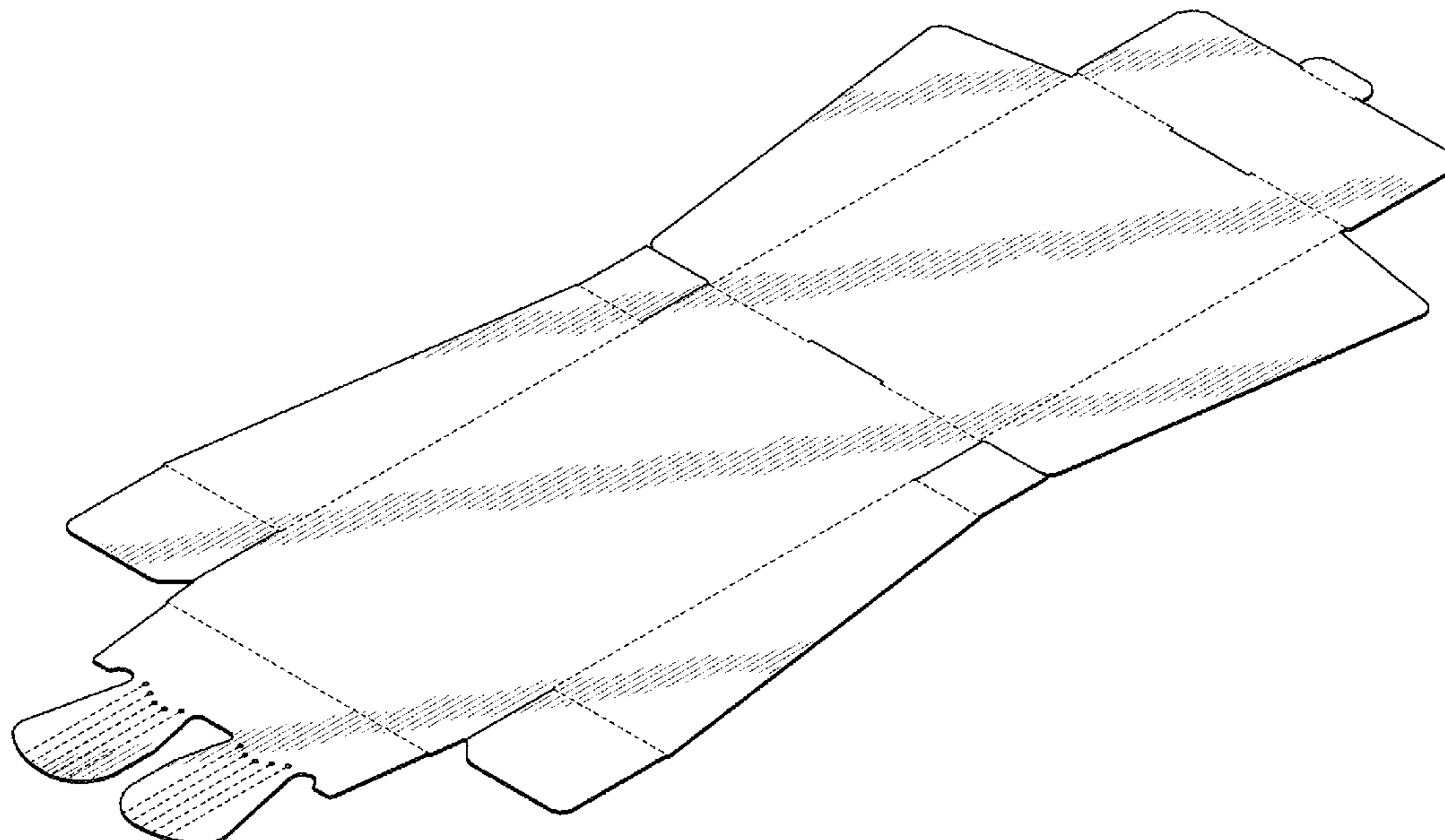
The ornamental design for a carton blank, shown and described.

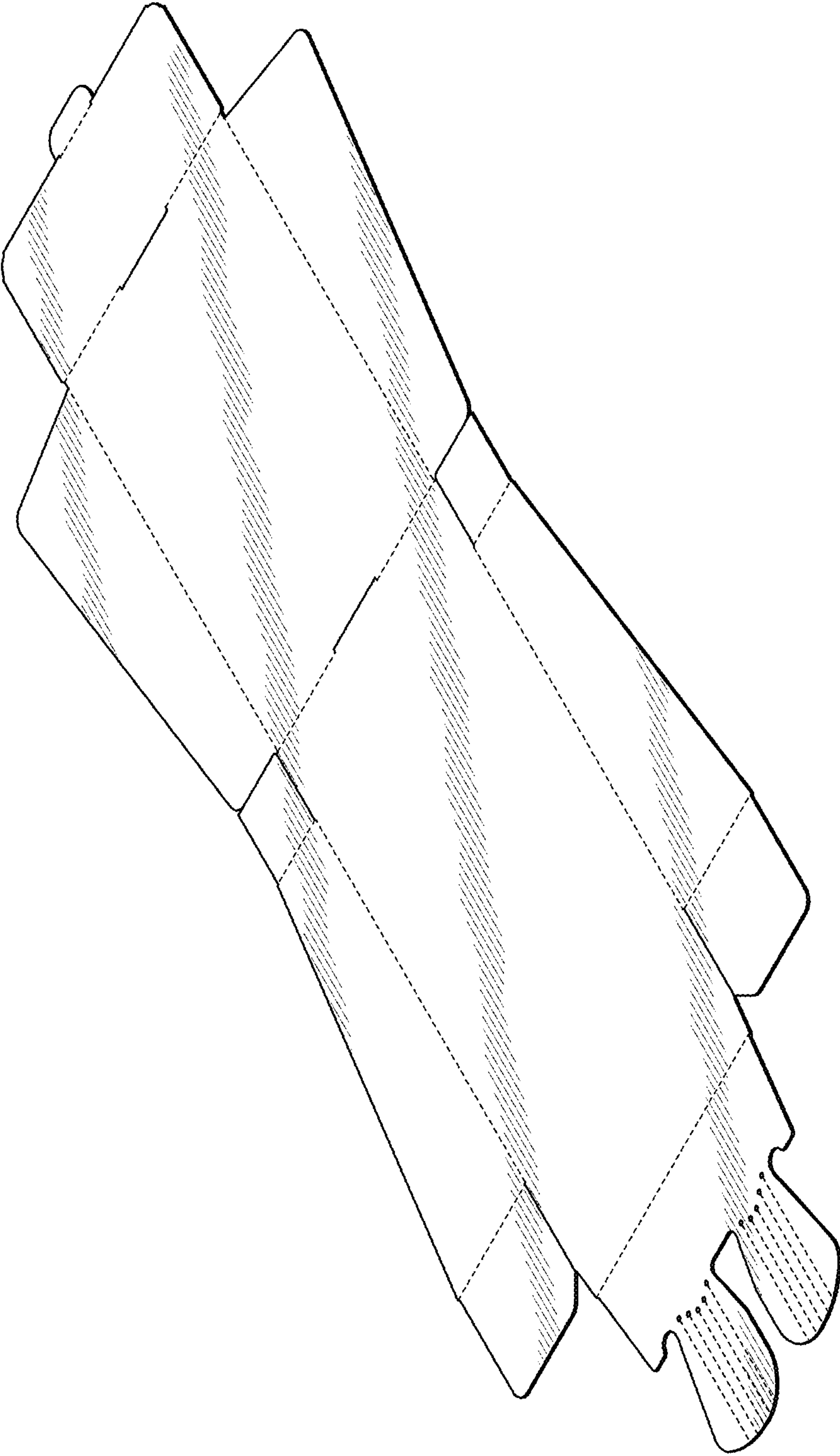

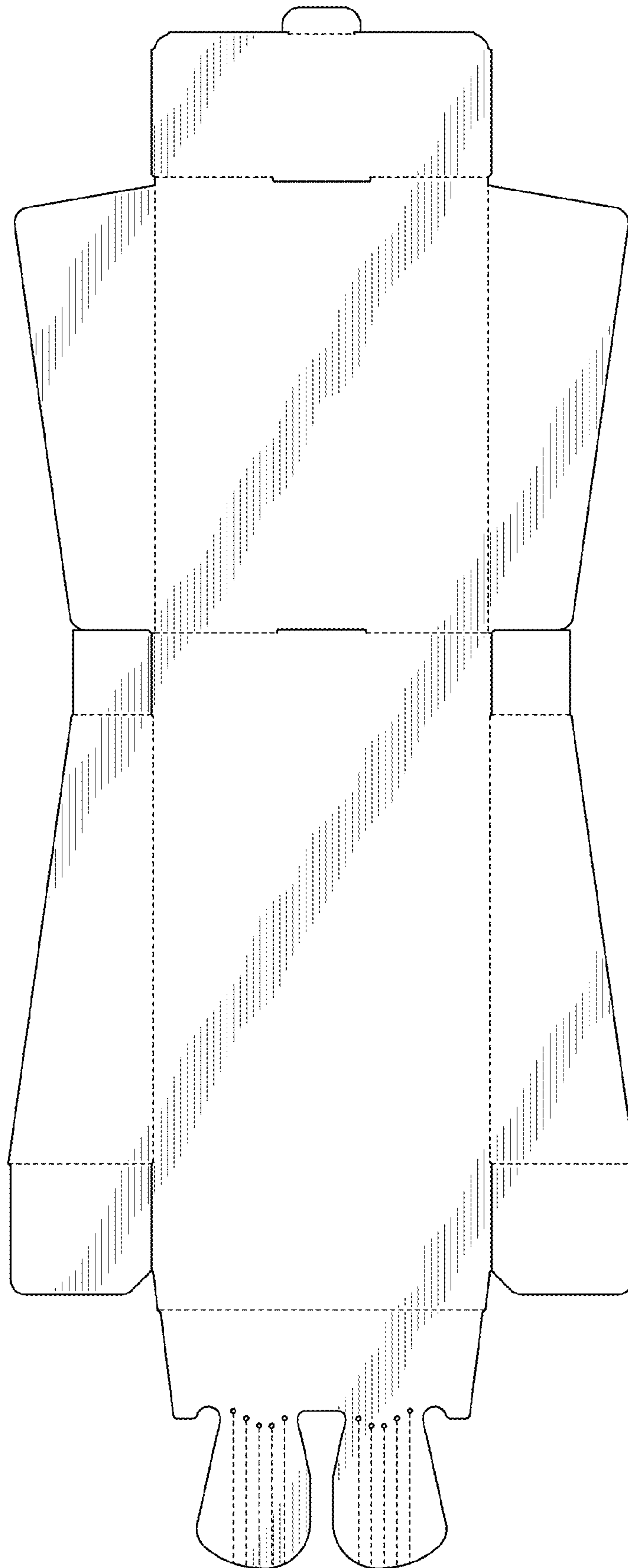

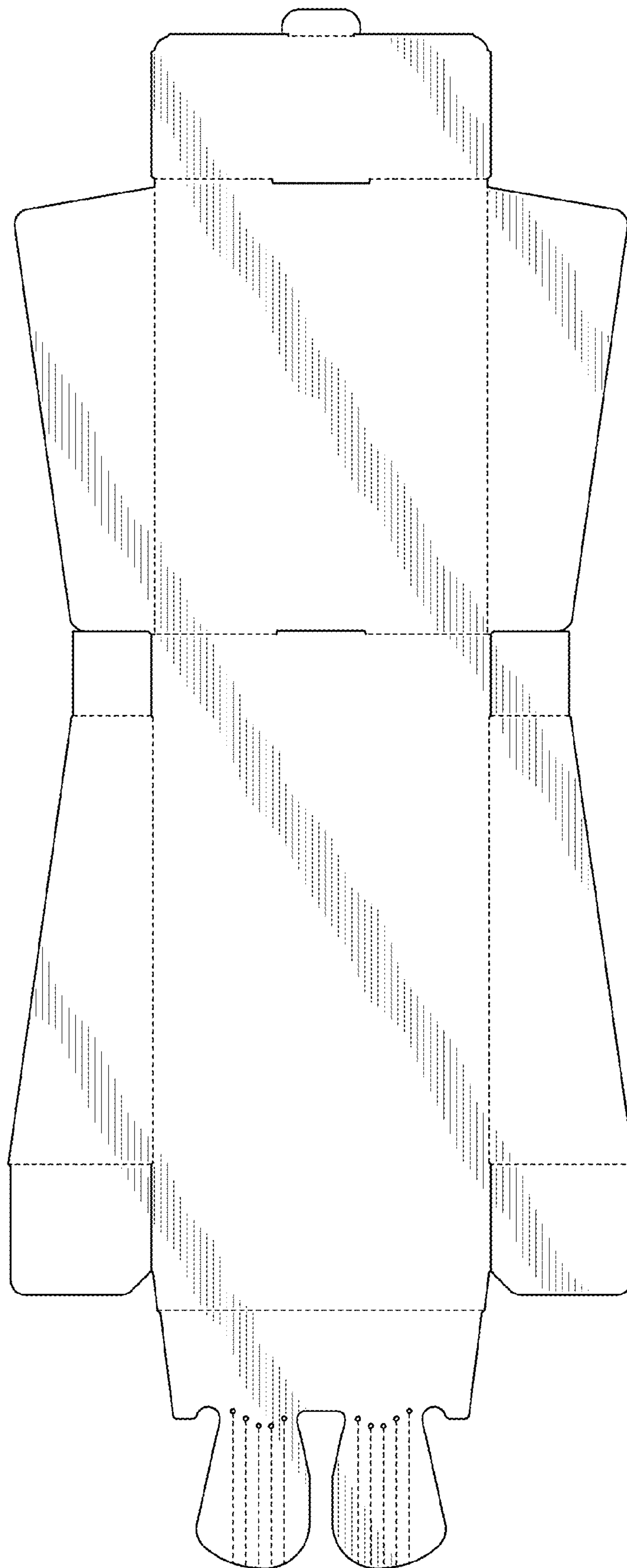

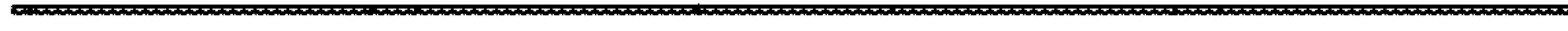
