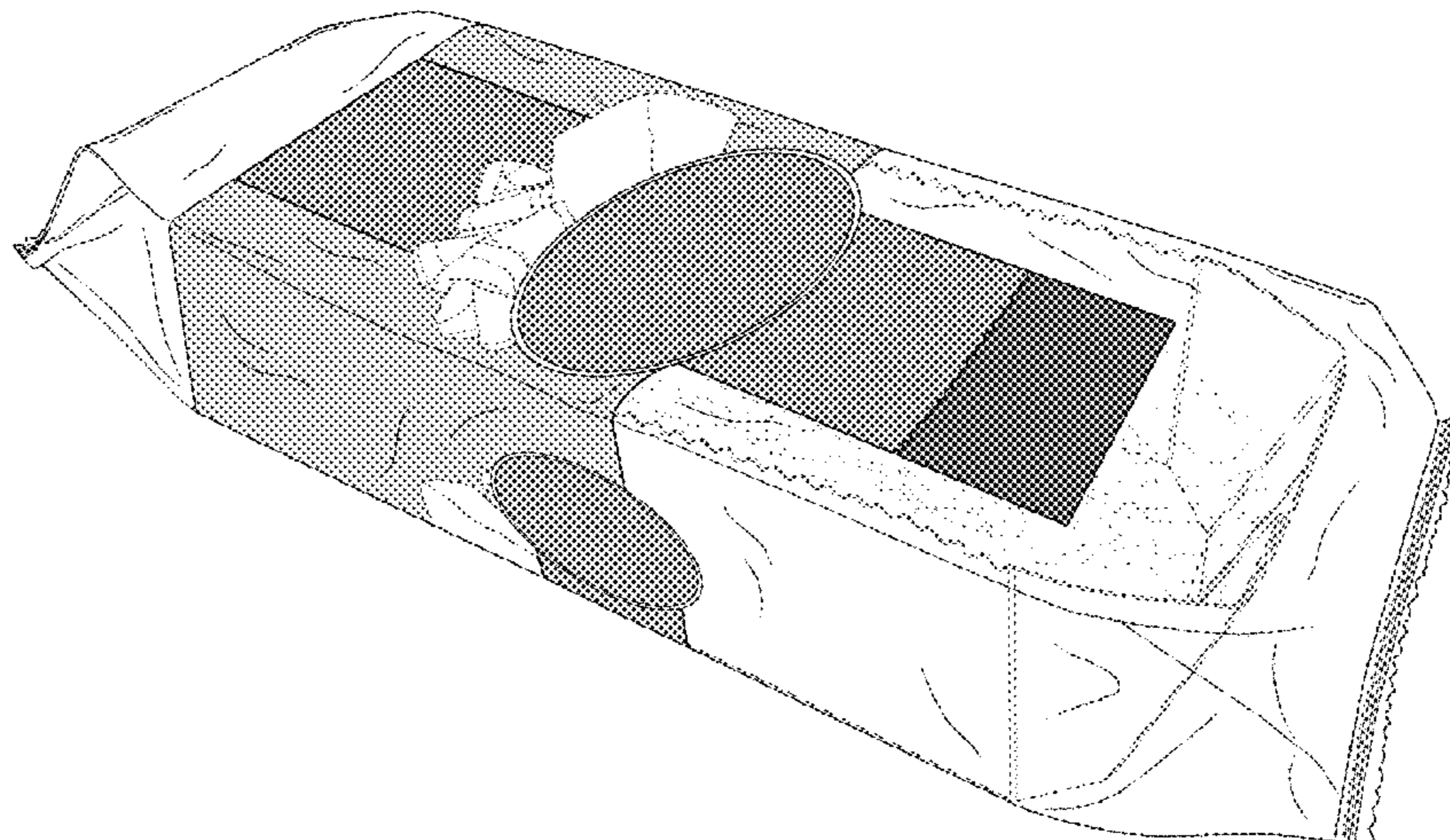
The ornamental design for a packaging for foodstuffs, as shown and described.

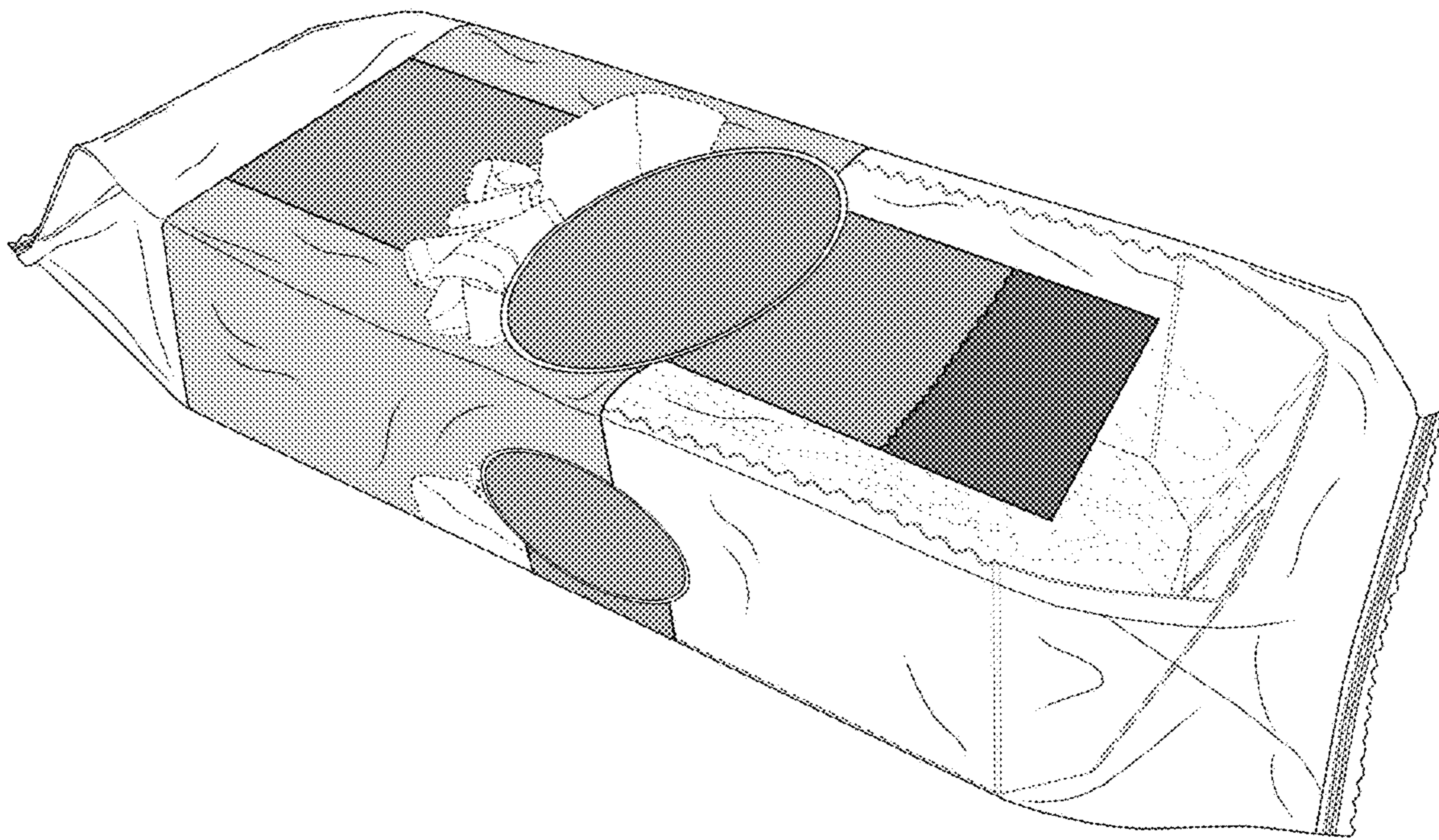

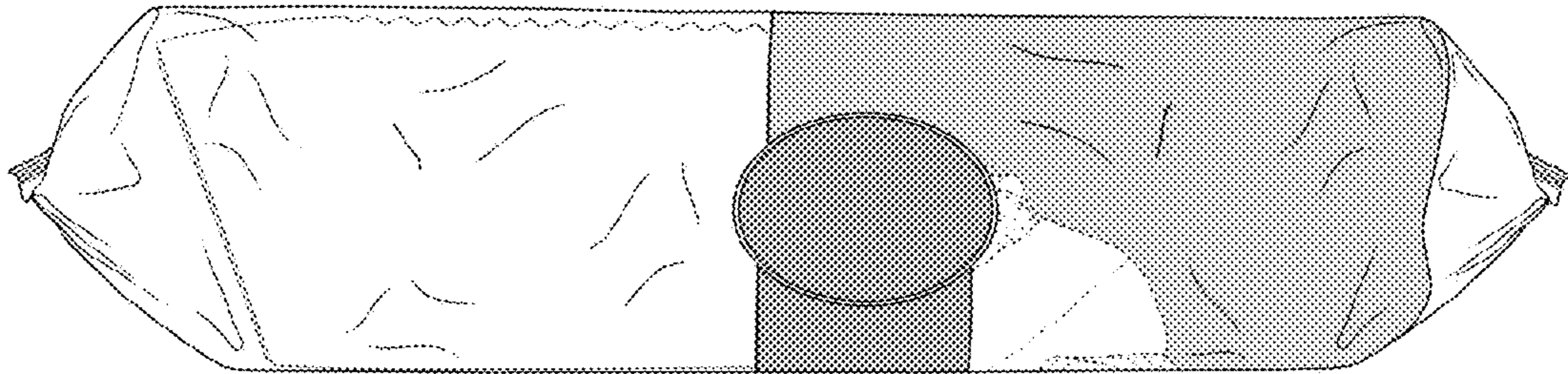

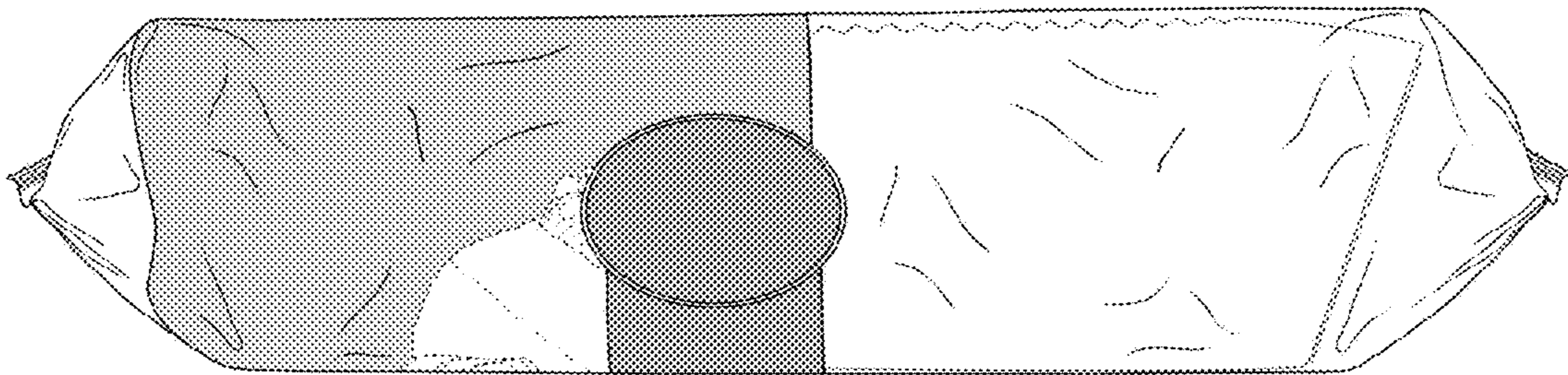

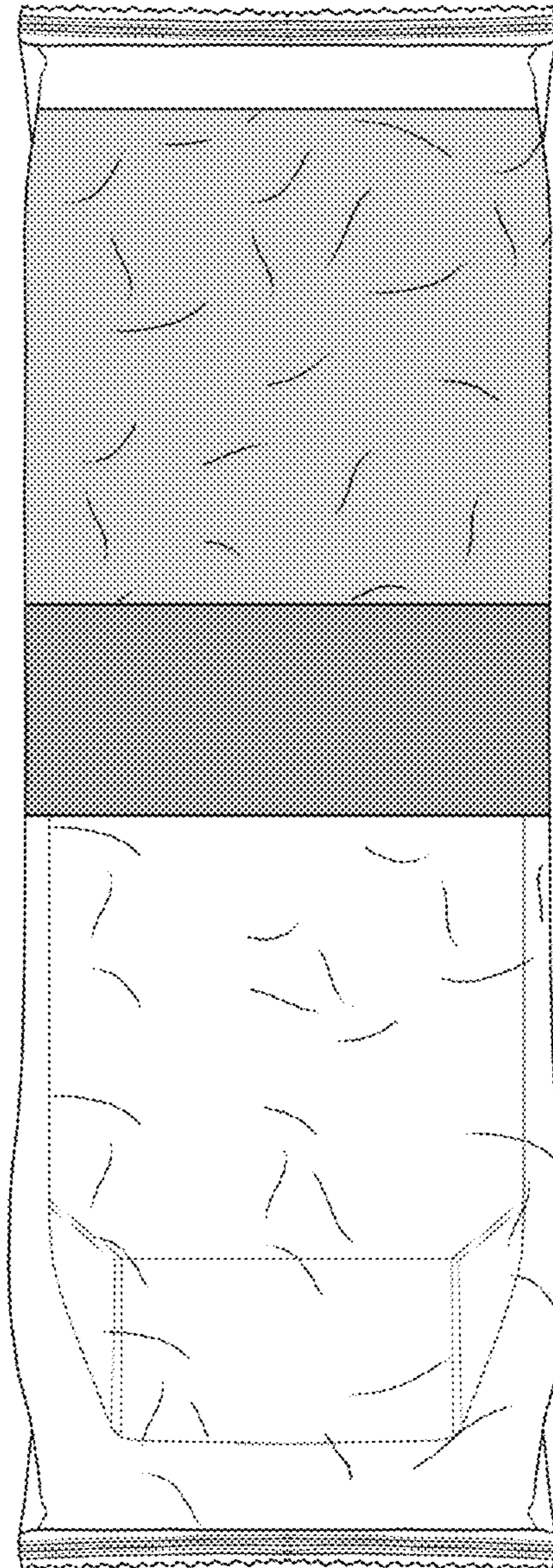

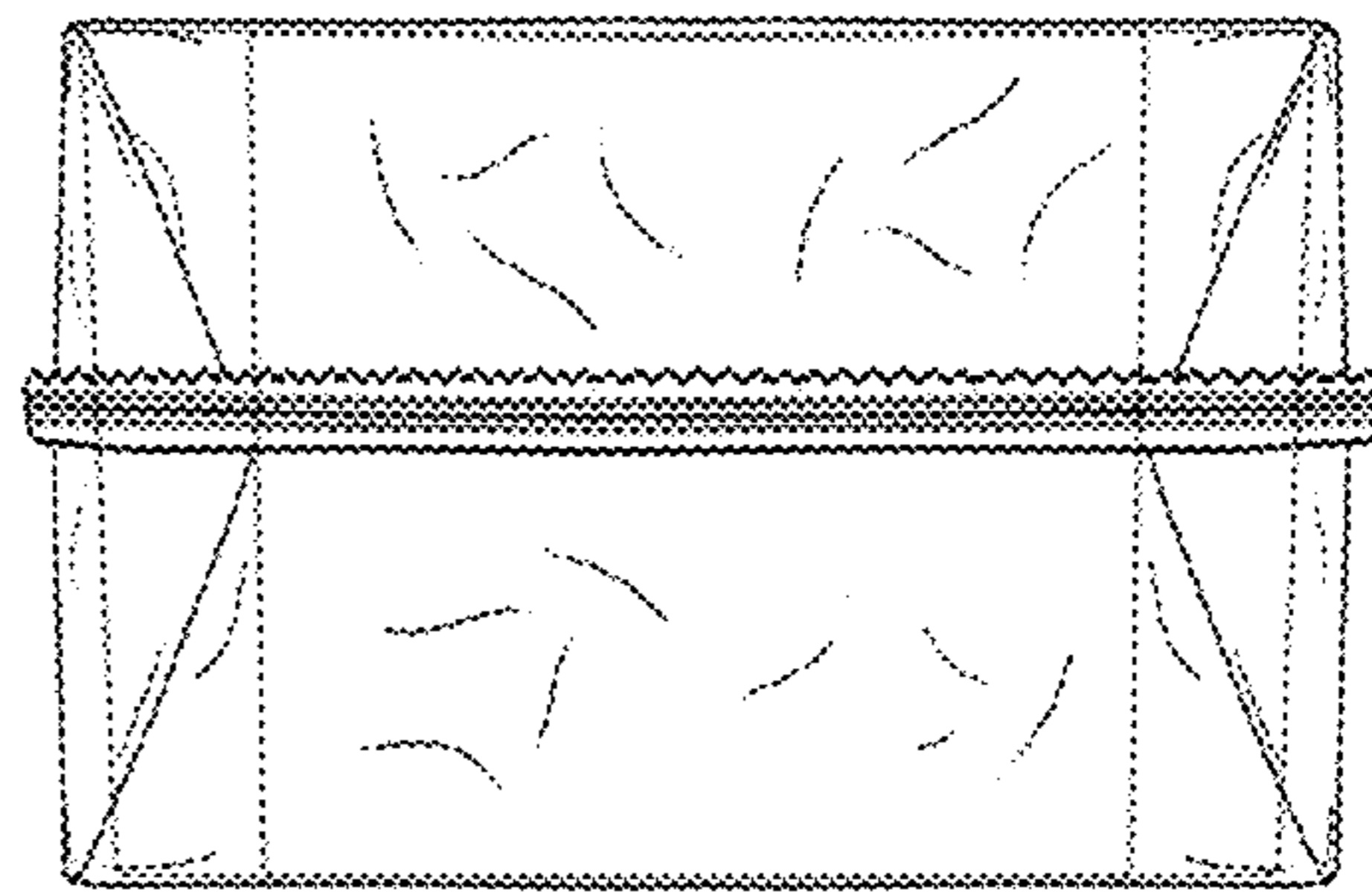
