FIG. 7 is a bottom plan view thereof.

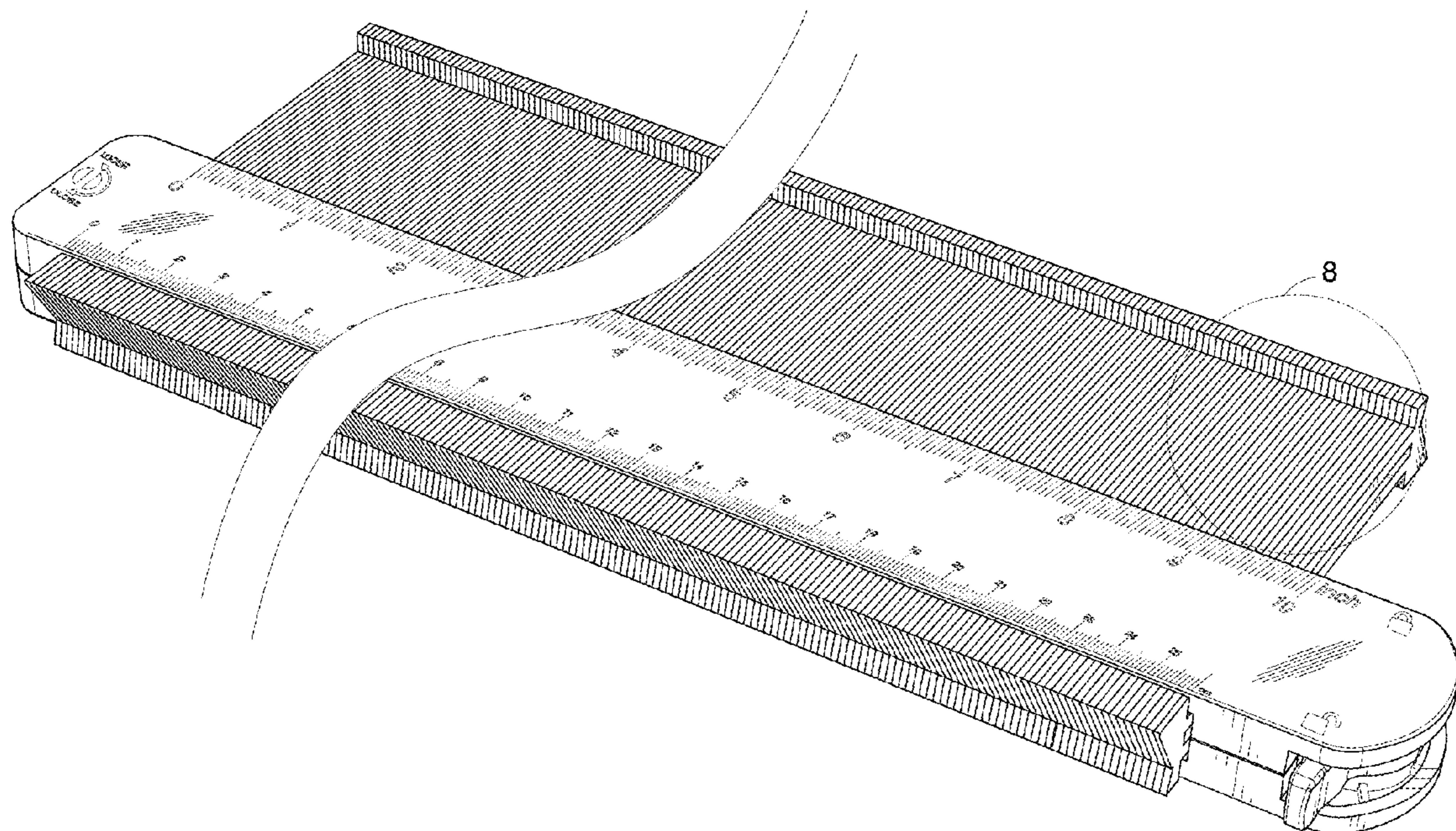
FIG. 8 is an enlarged view of an area labeled 8 in FIG. 1; and,

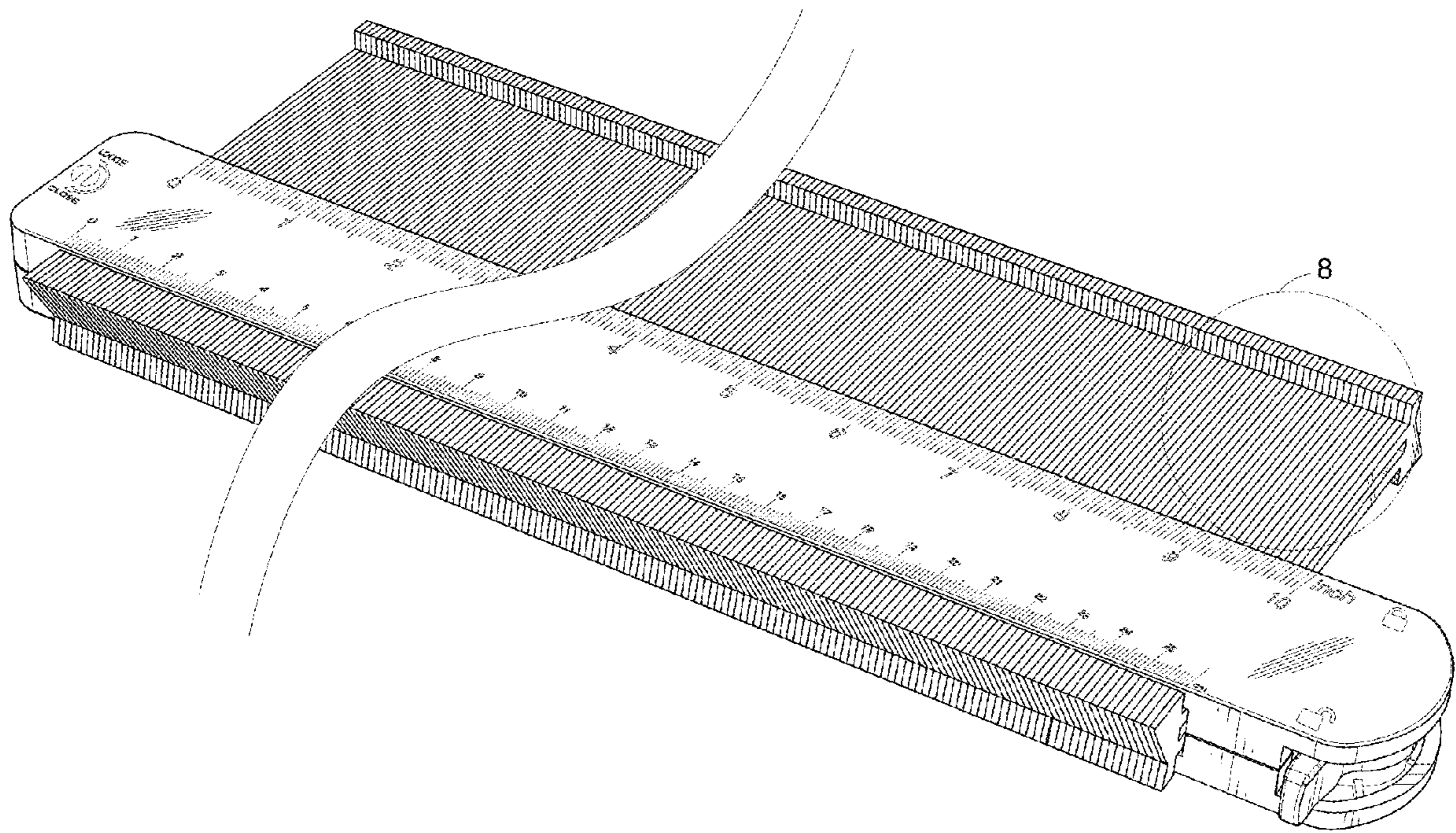

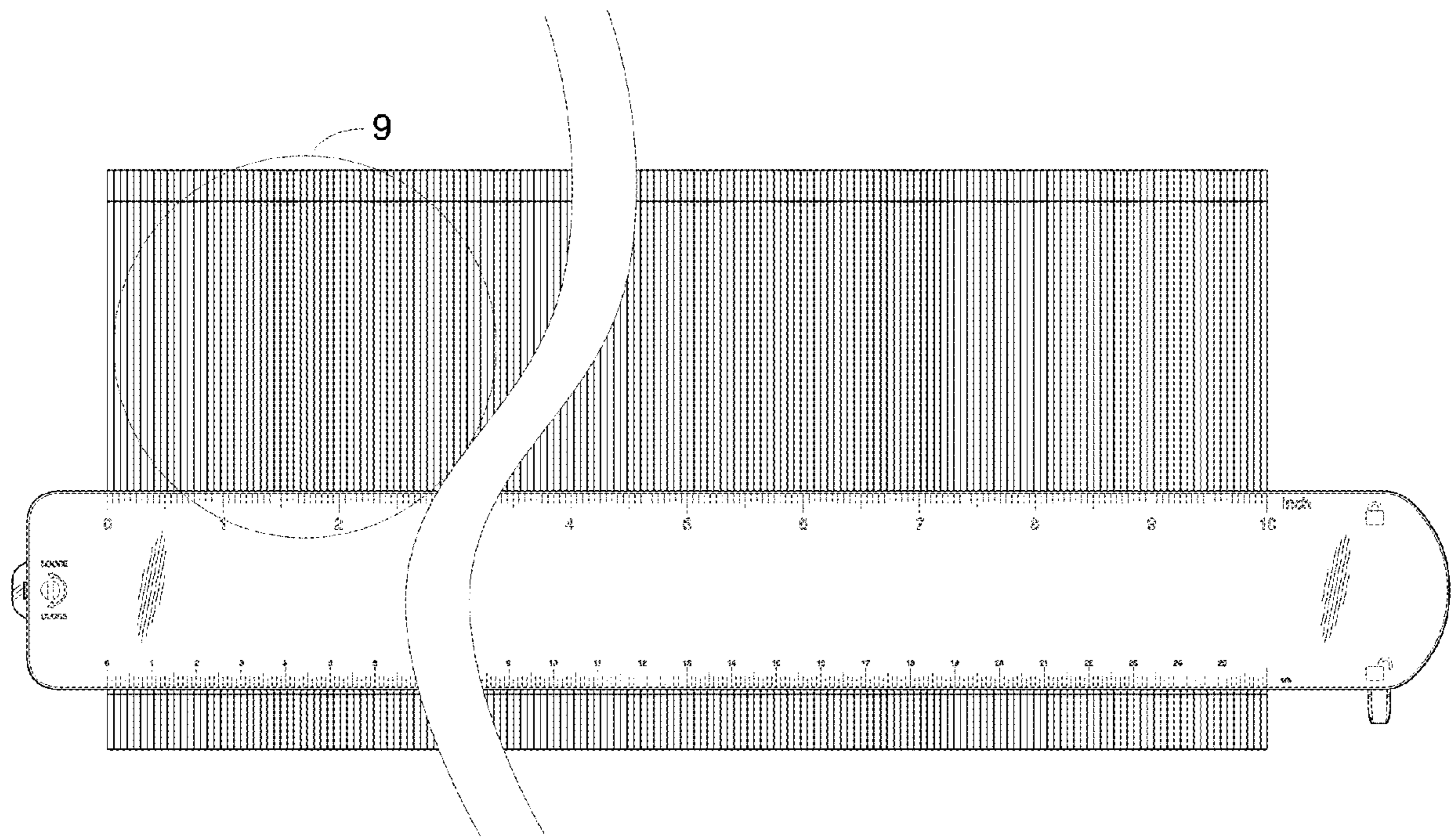

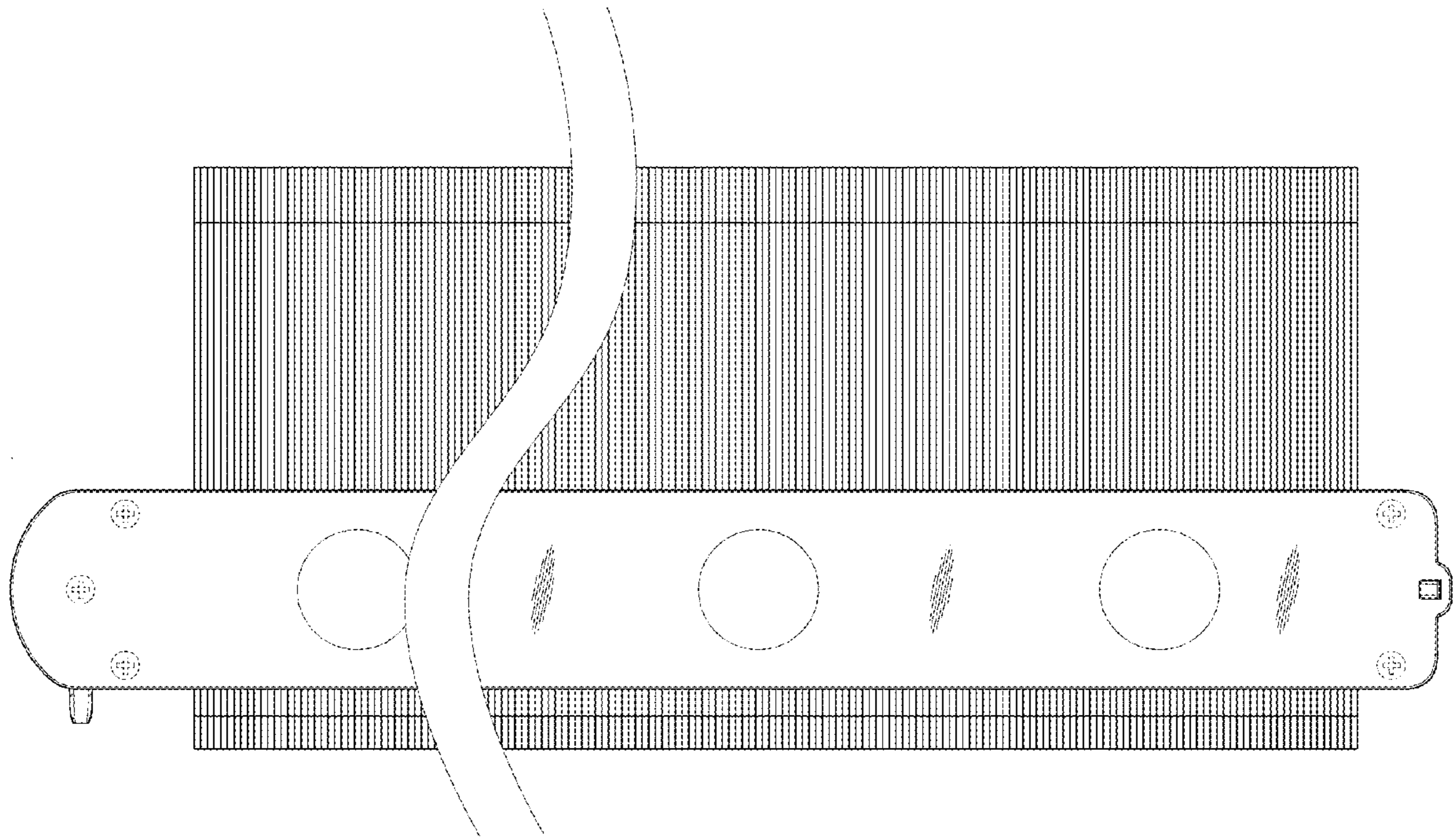

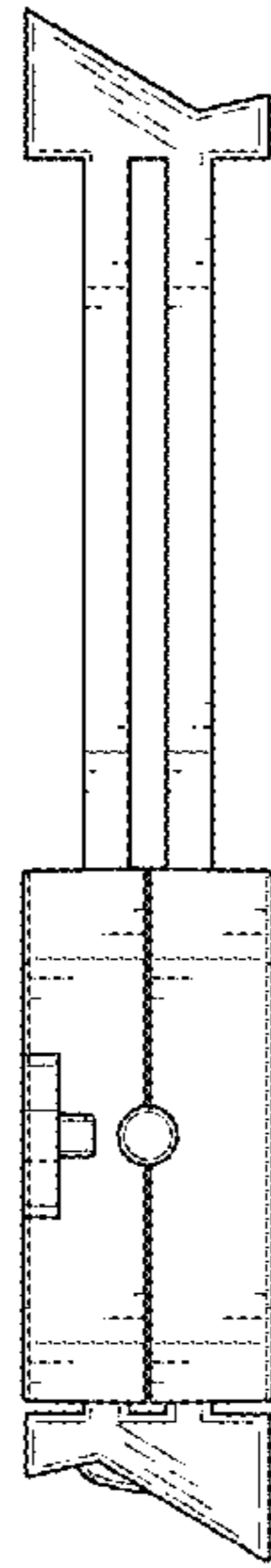

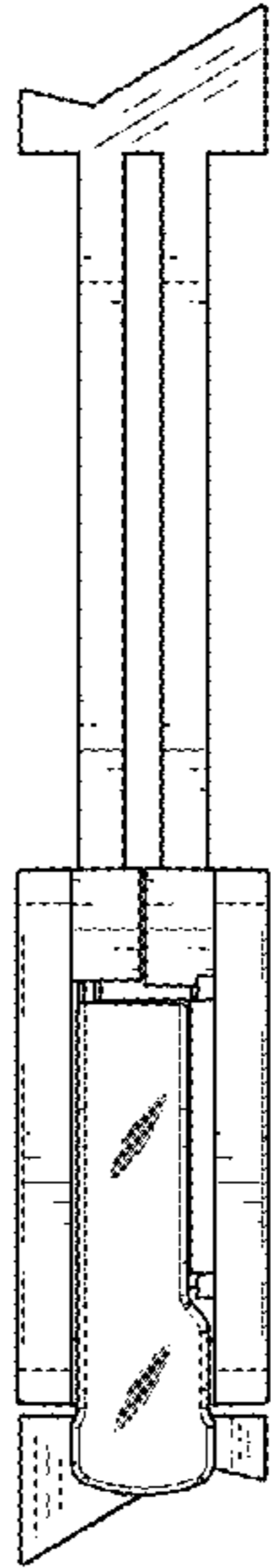

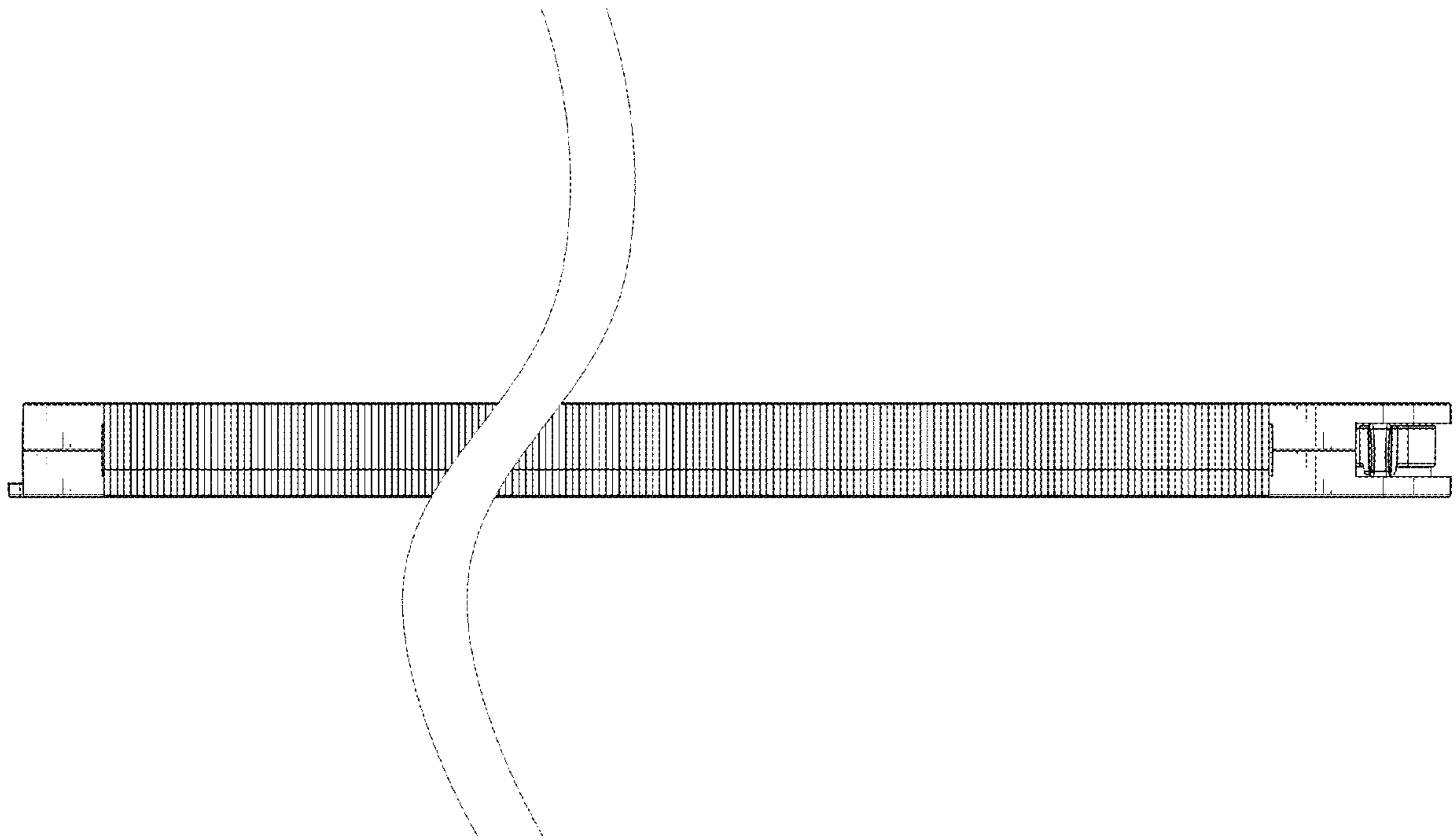

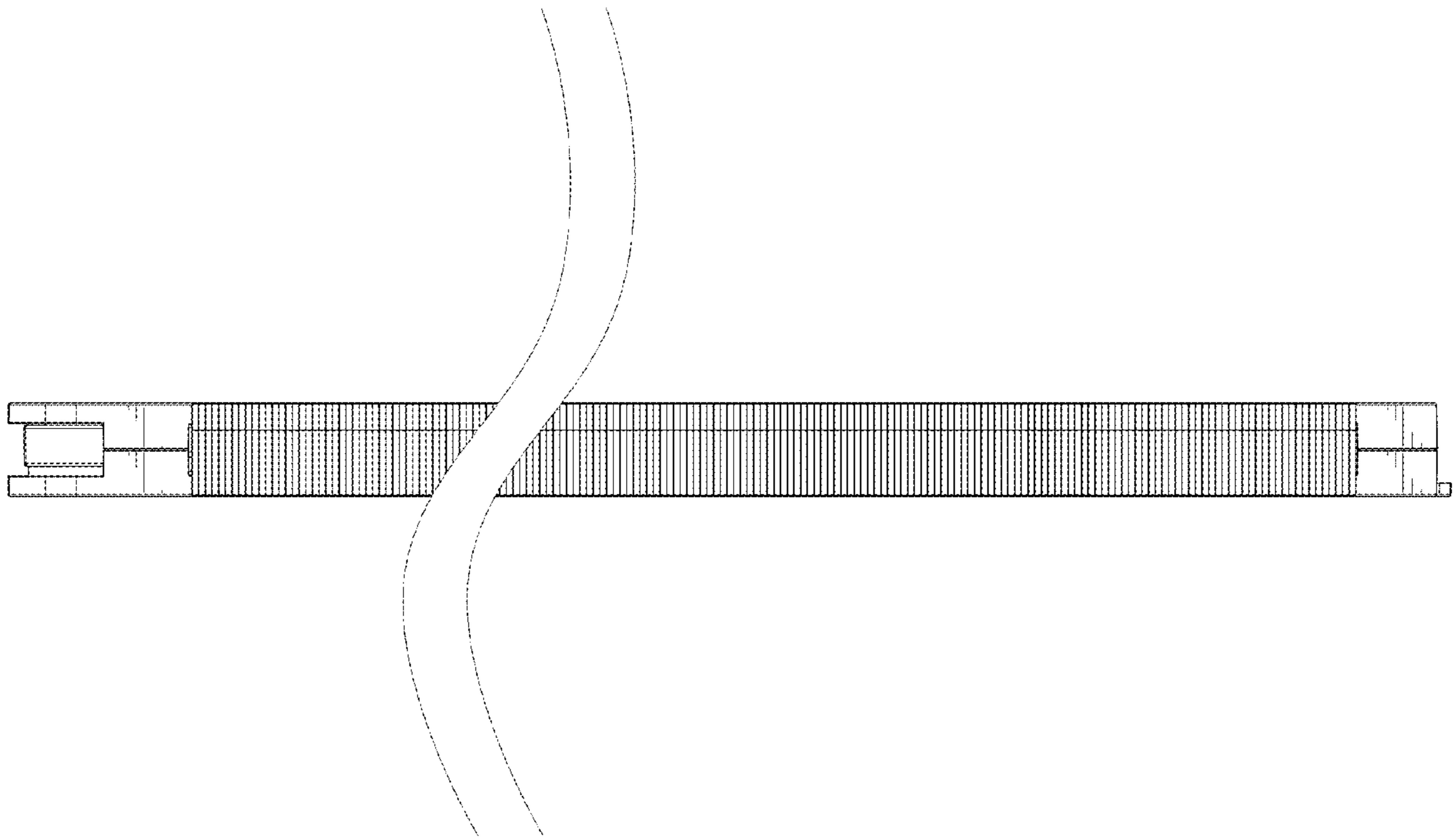

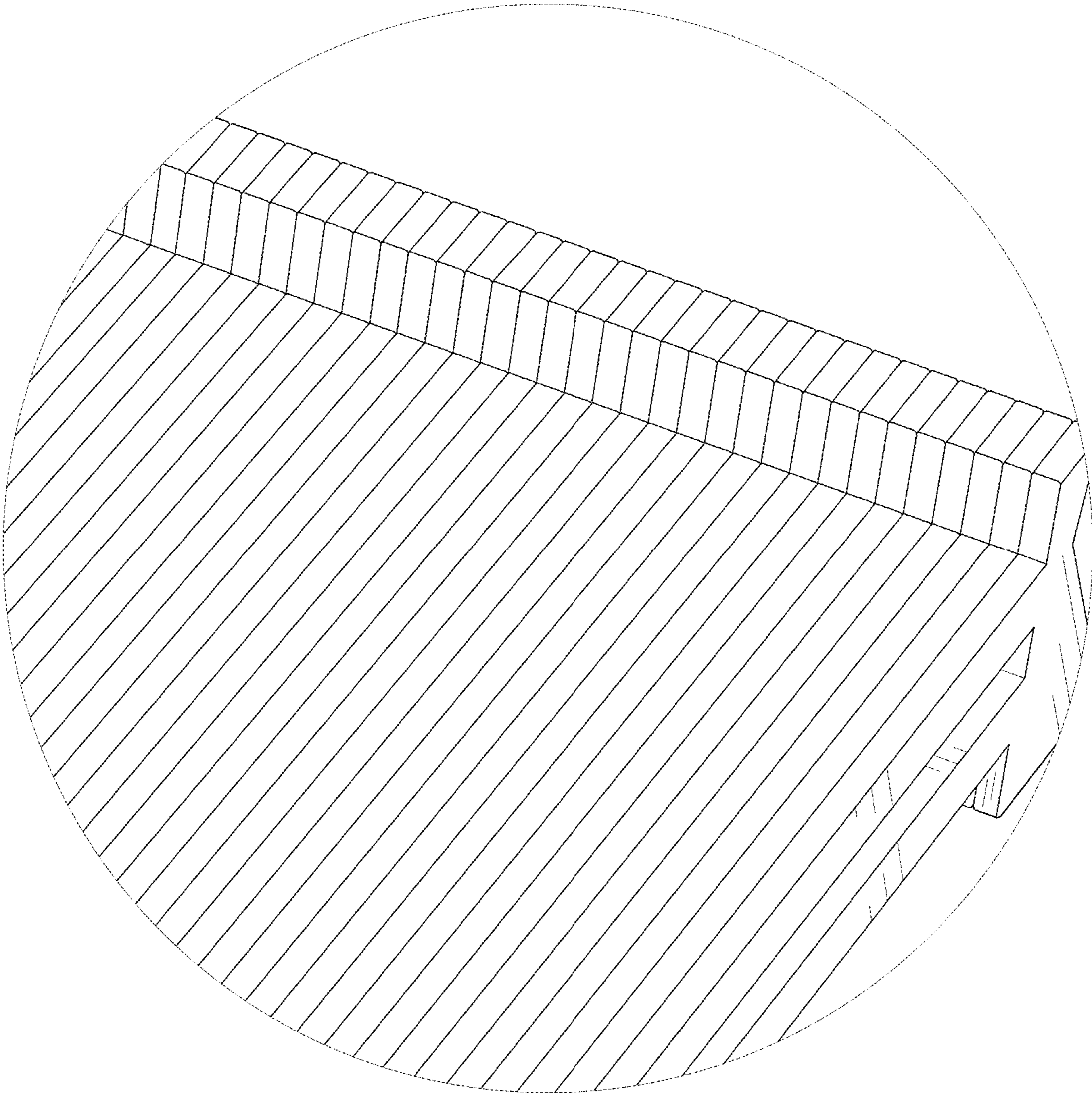

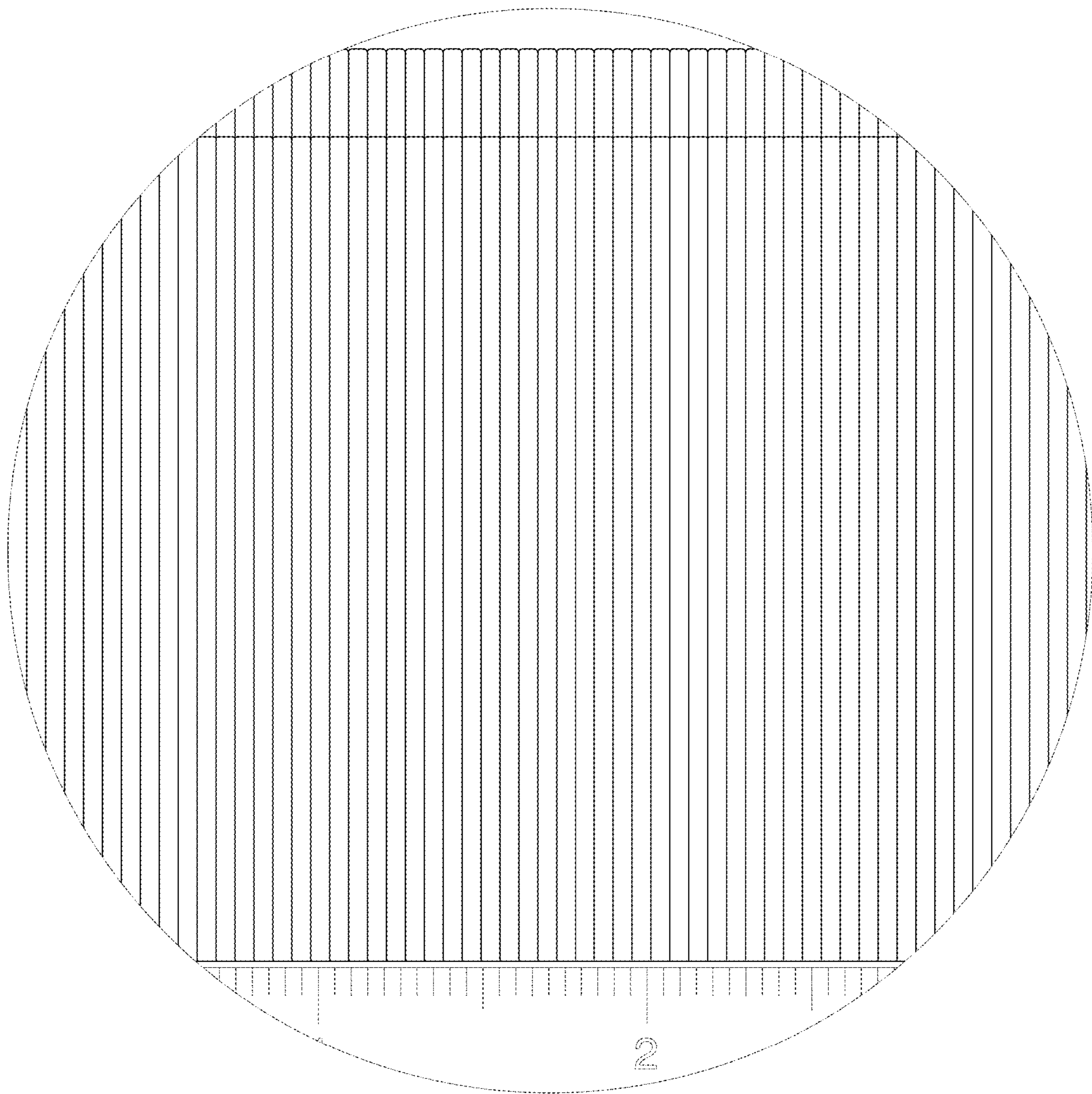
