The ornamental design for a necklace, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of a first embodiment of a necklace showing my new design;

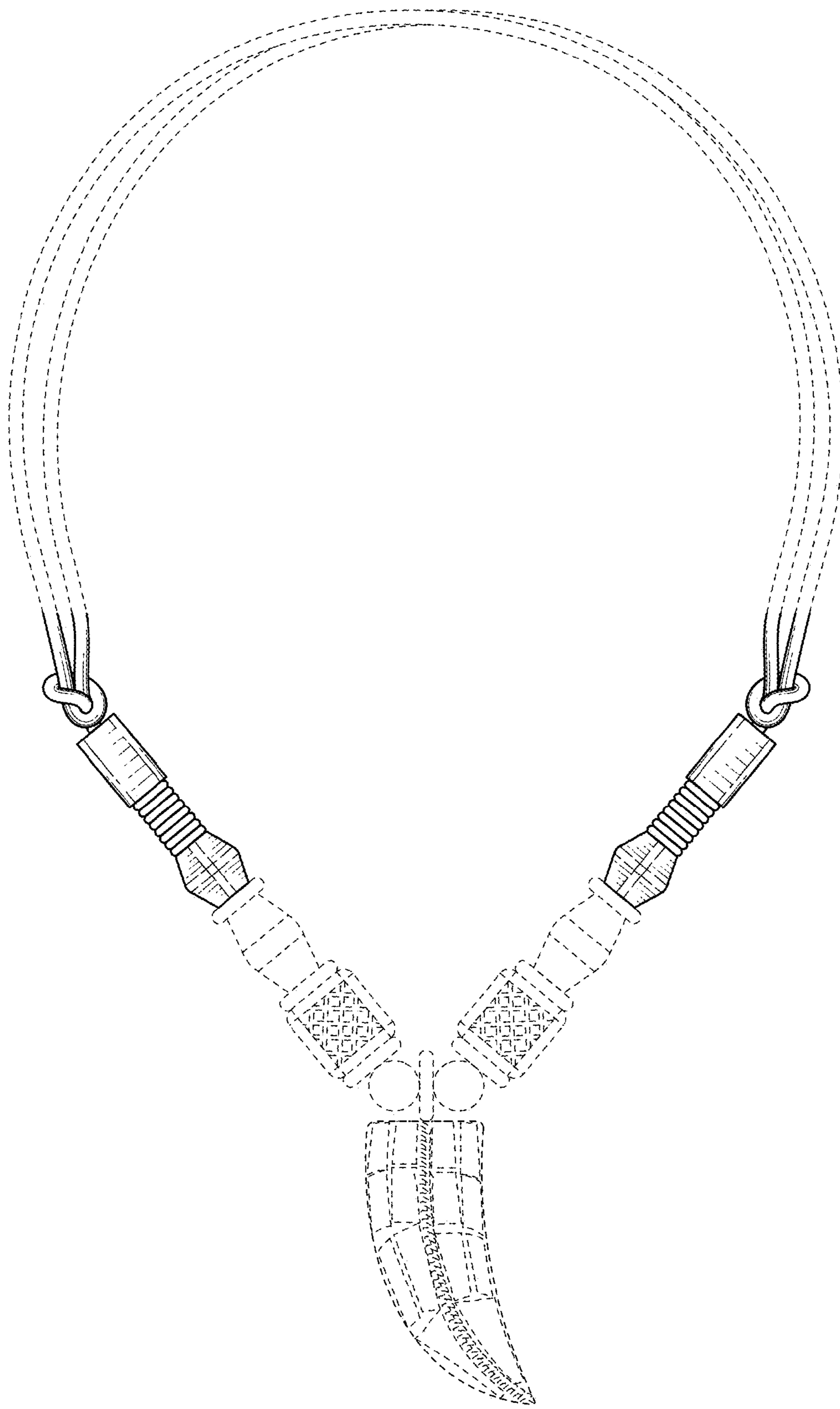

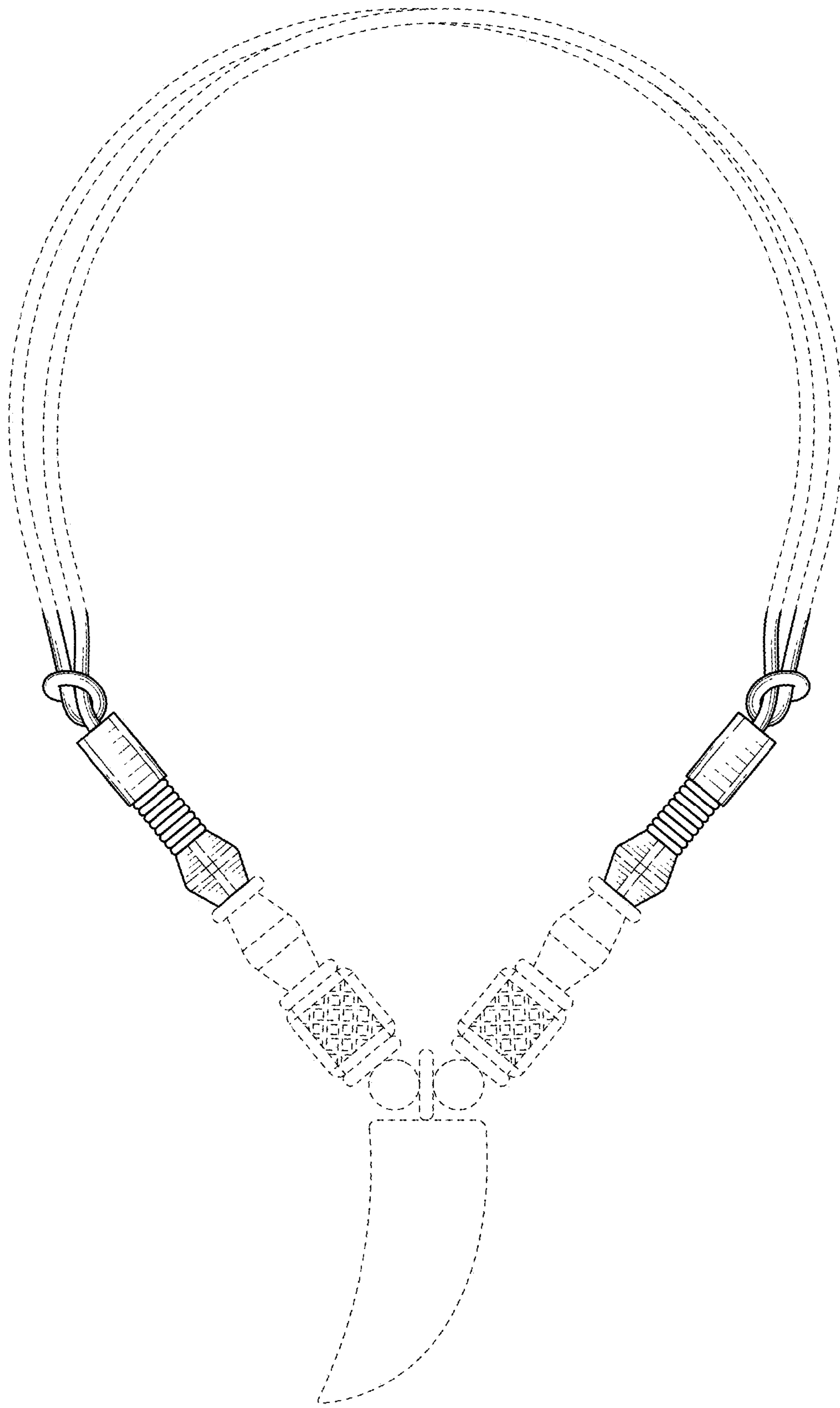

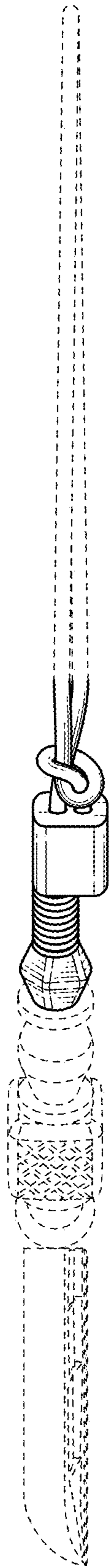

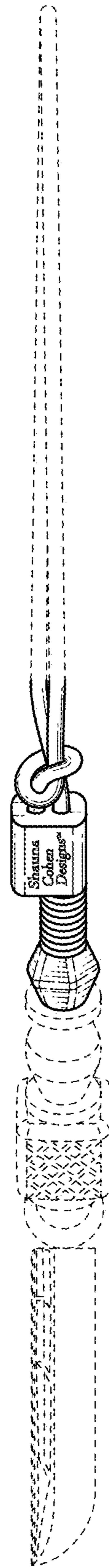

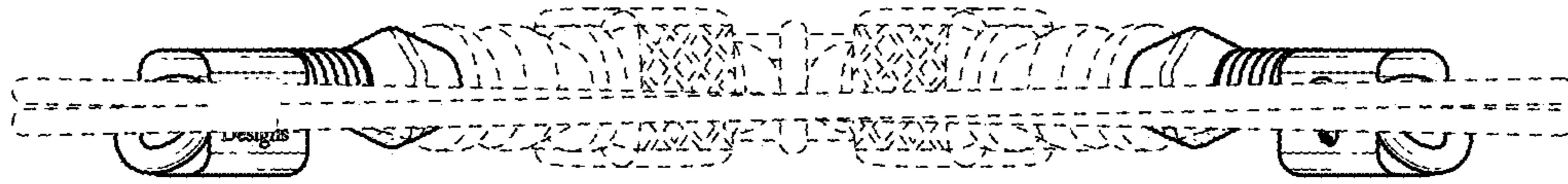

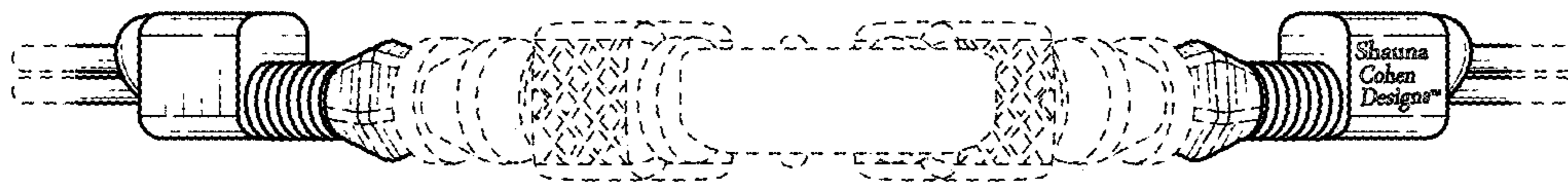
