(57) **CLAIM**

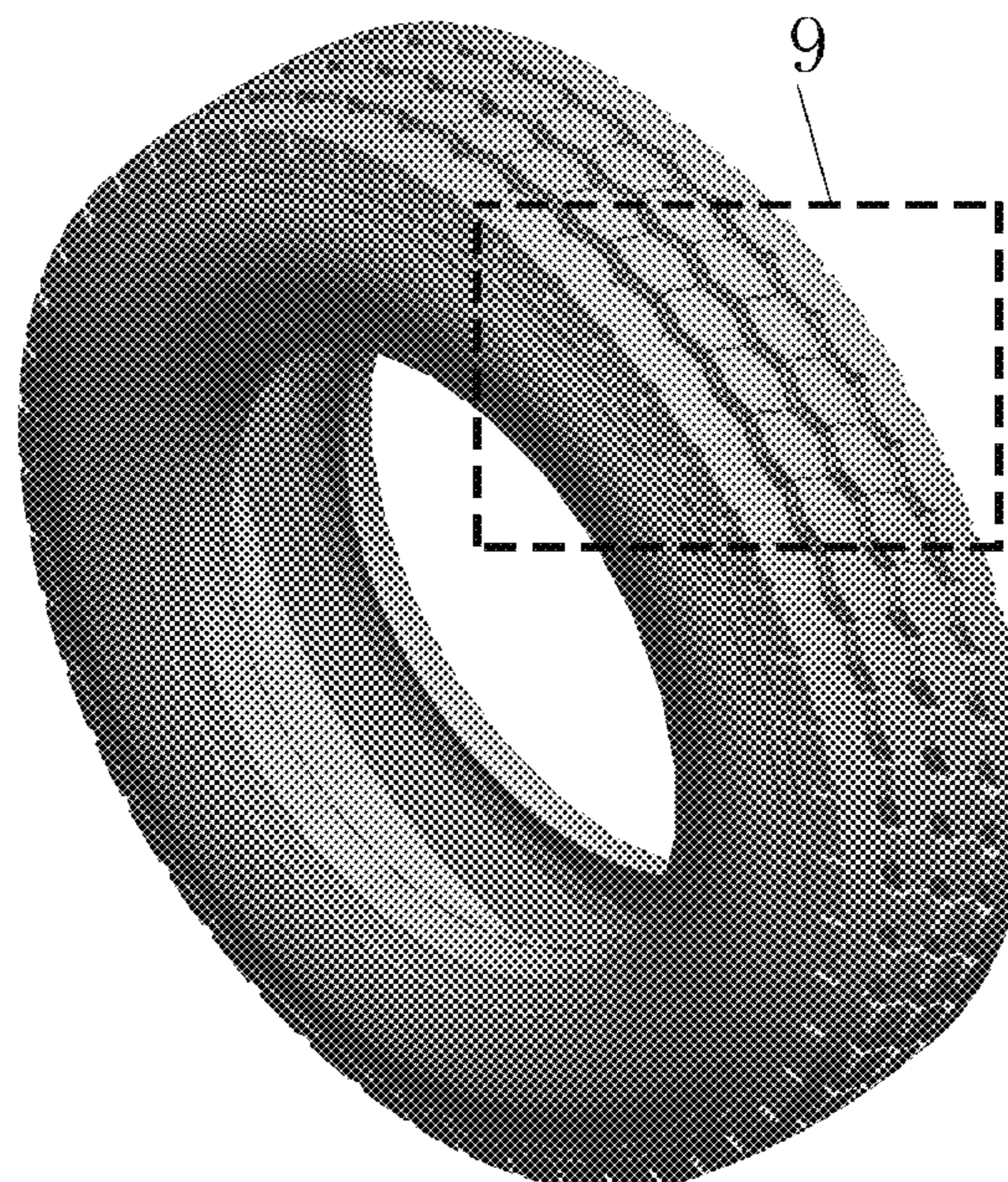
The ornamental design for a vehicle tire, as shown and described.

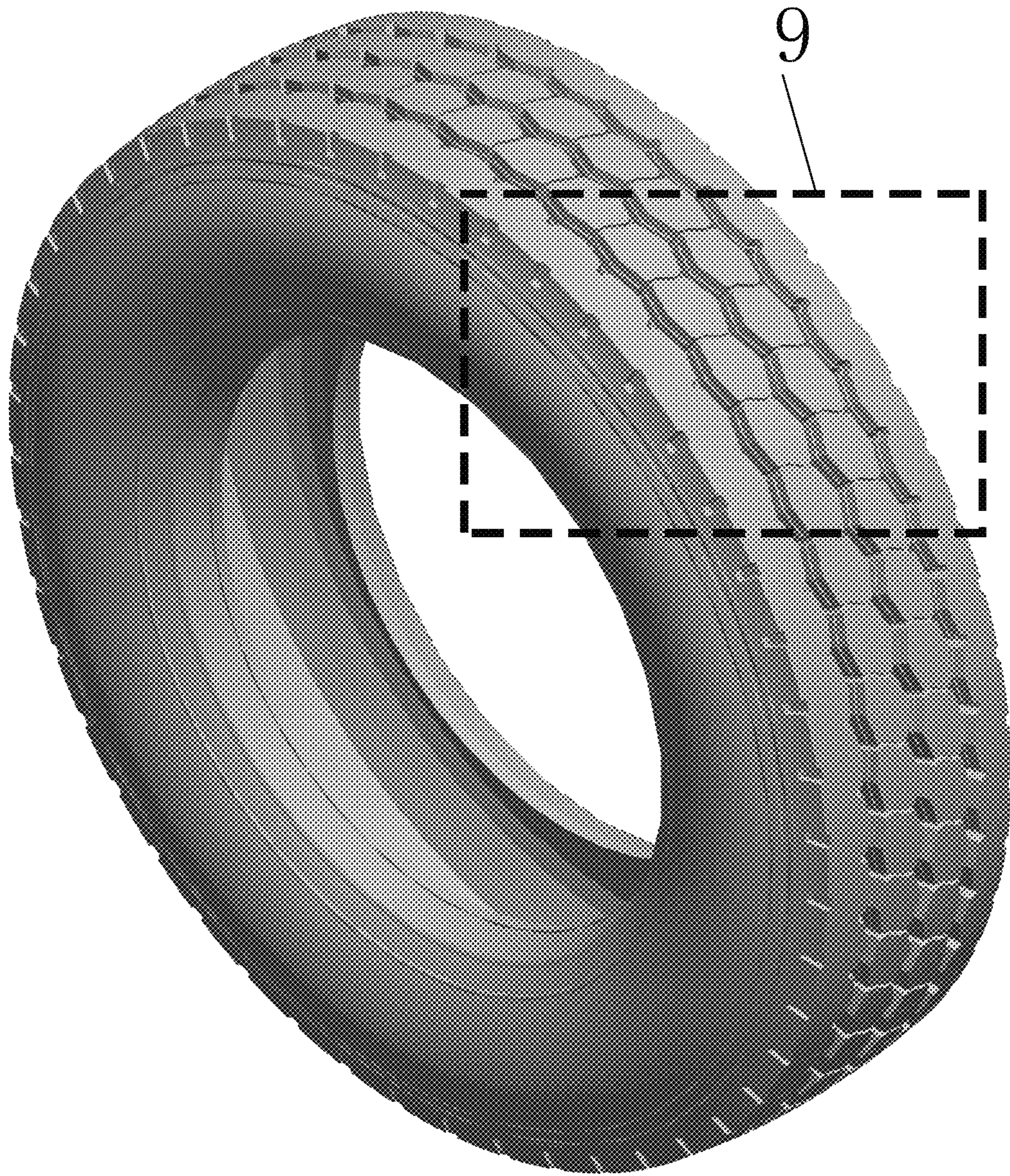

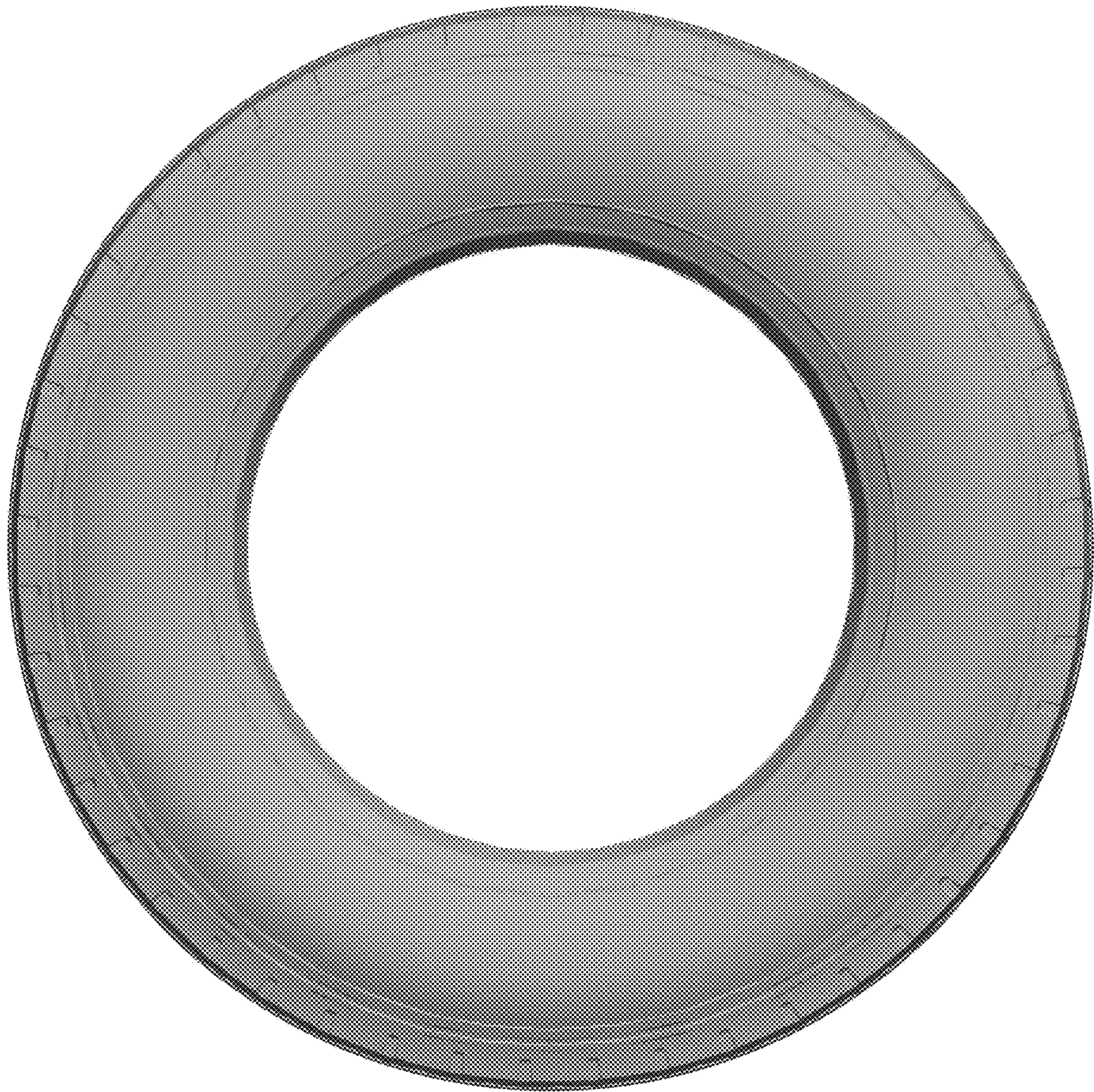

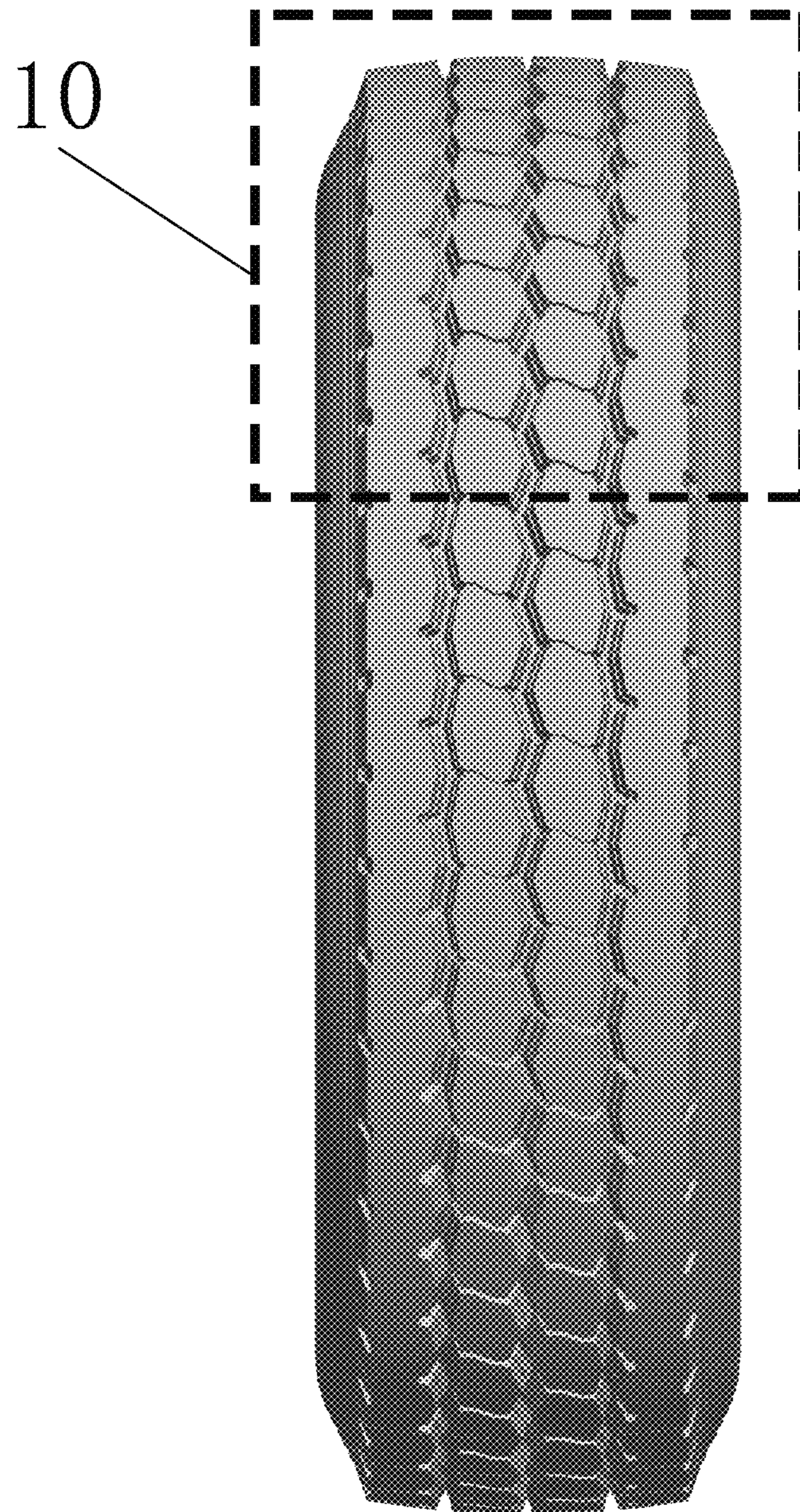

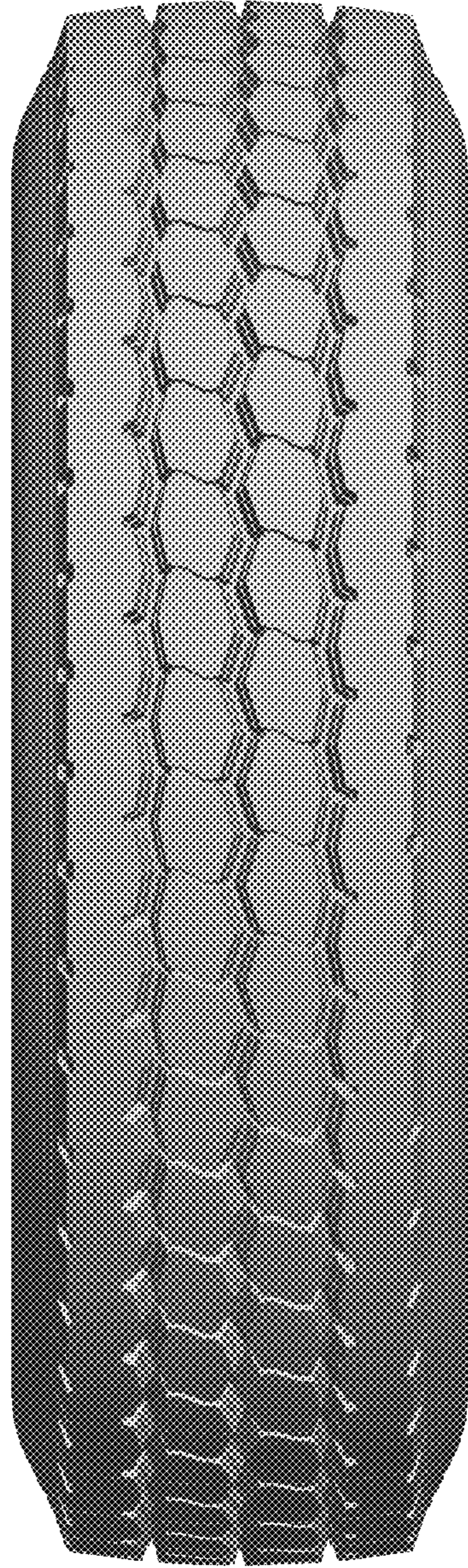

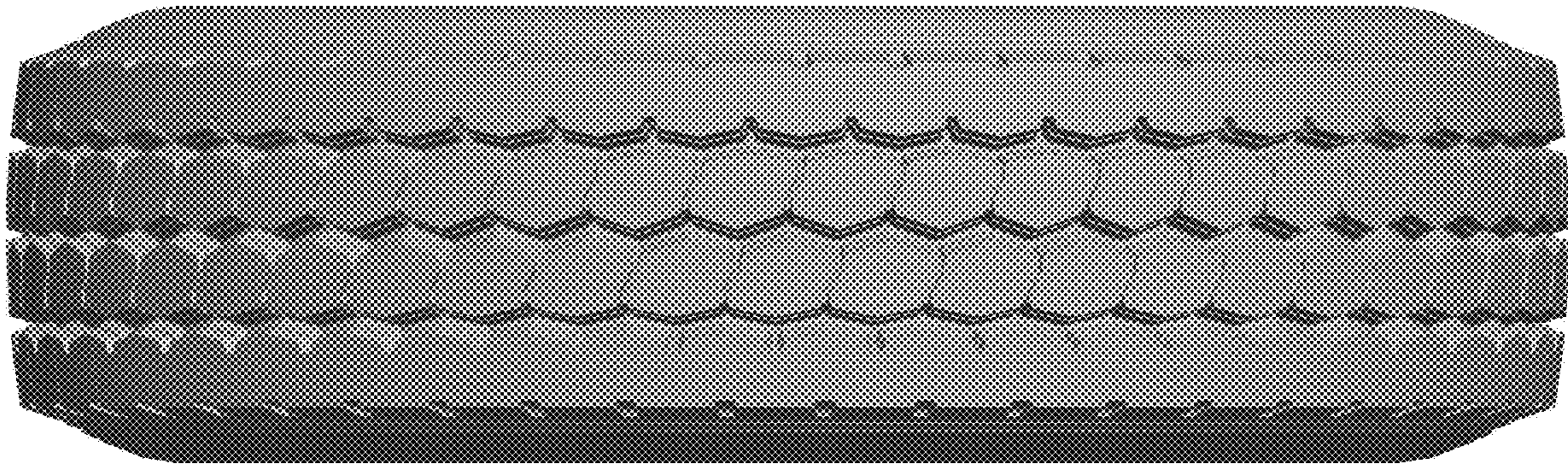

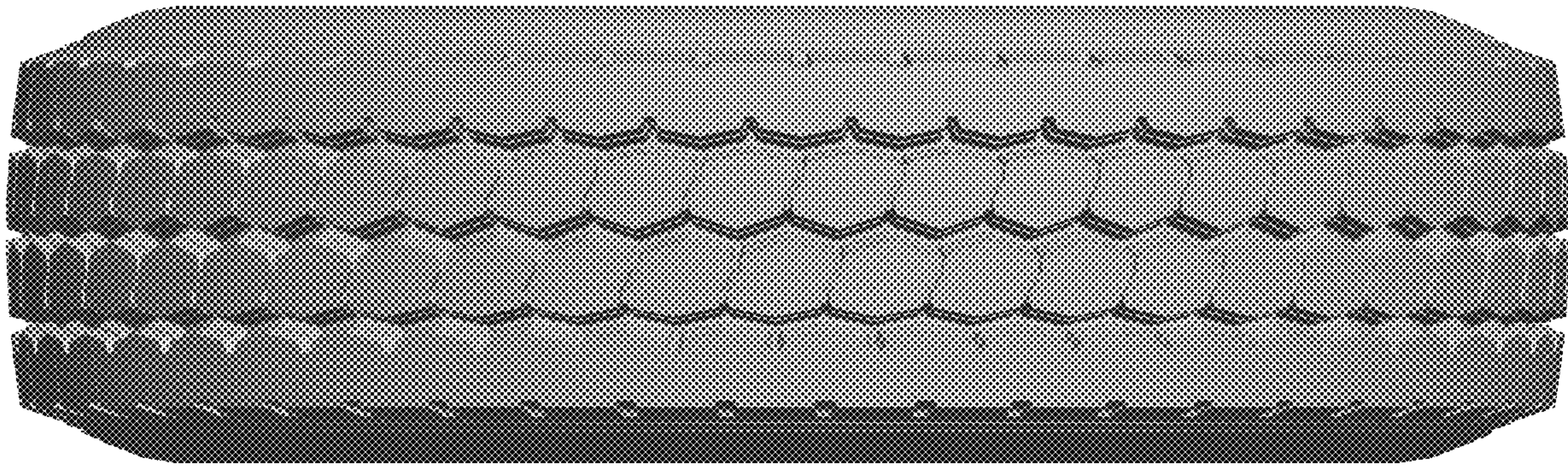

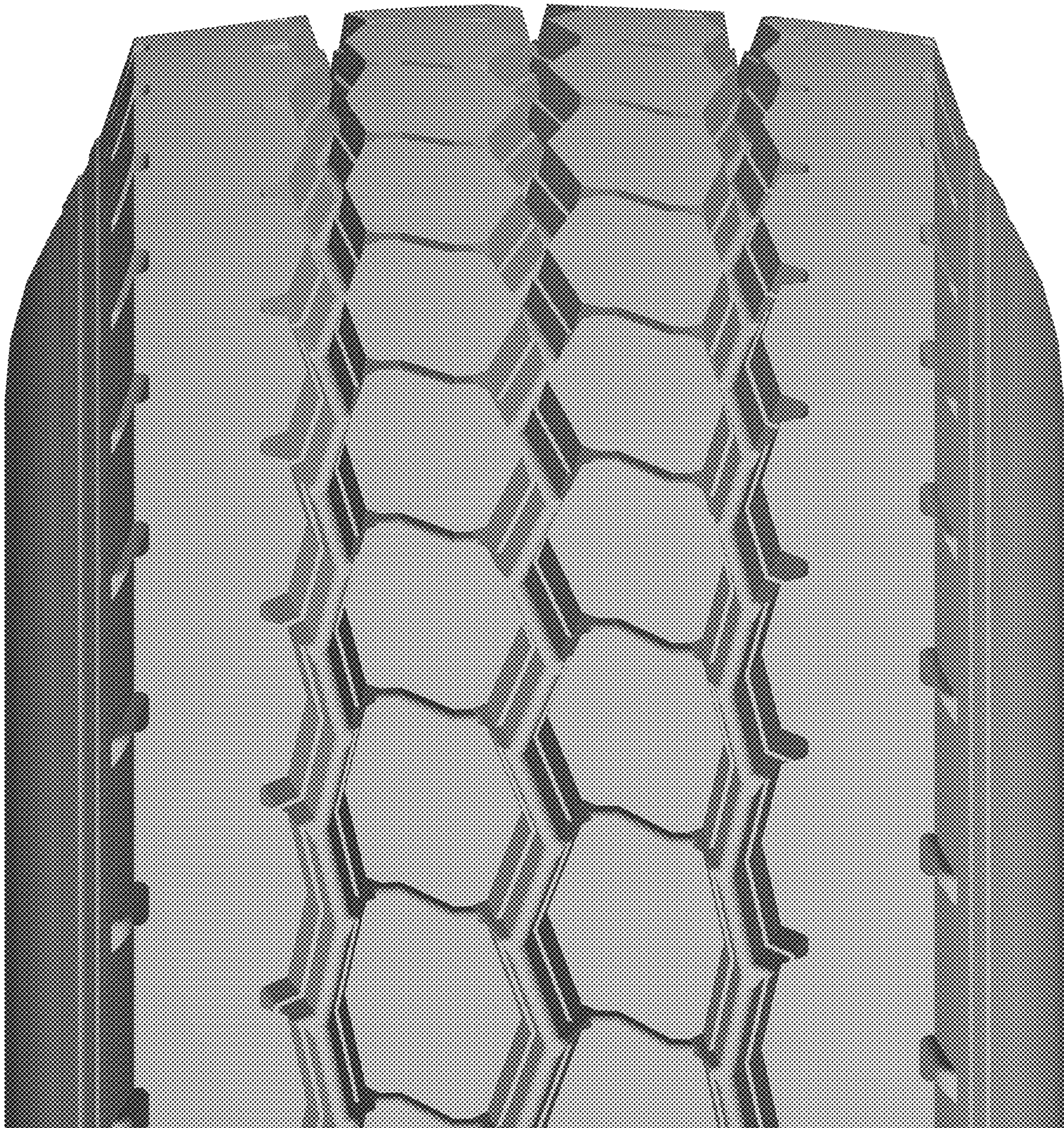
