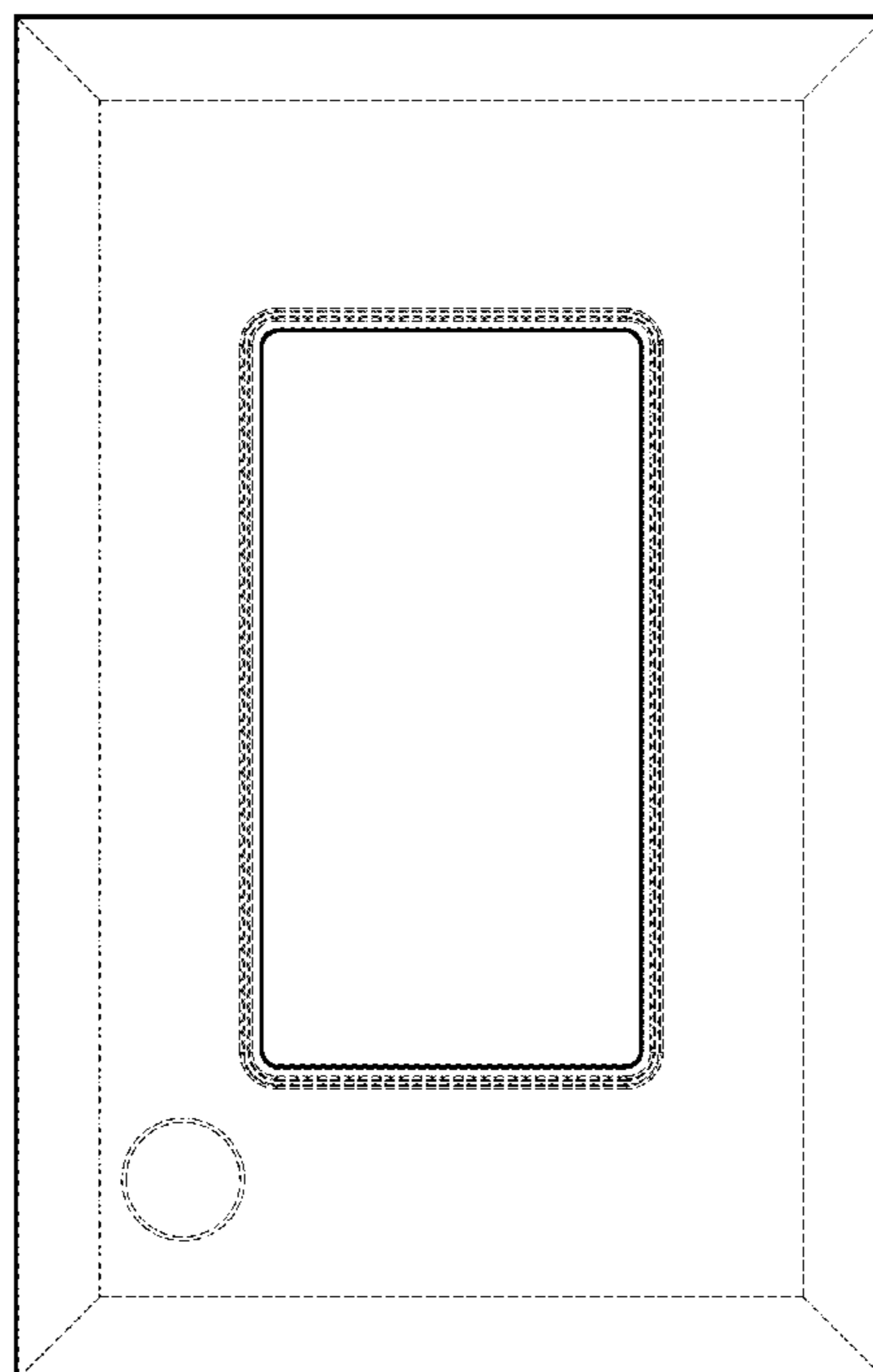
(57) **CLAIM**

I claim the ornamental design for a stick on LED light switch, as shown and described.

DESCRIPTION

FIG. 1 is a front view for a stick on LED light switch;

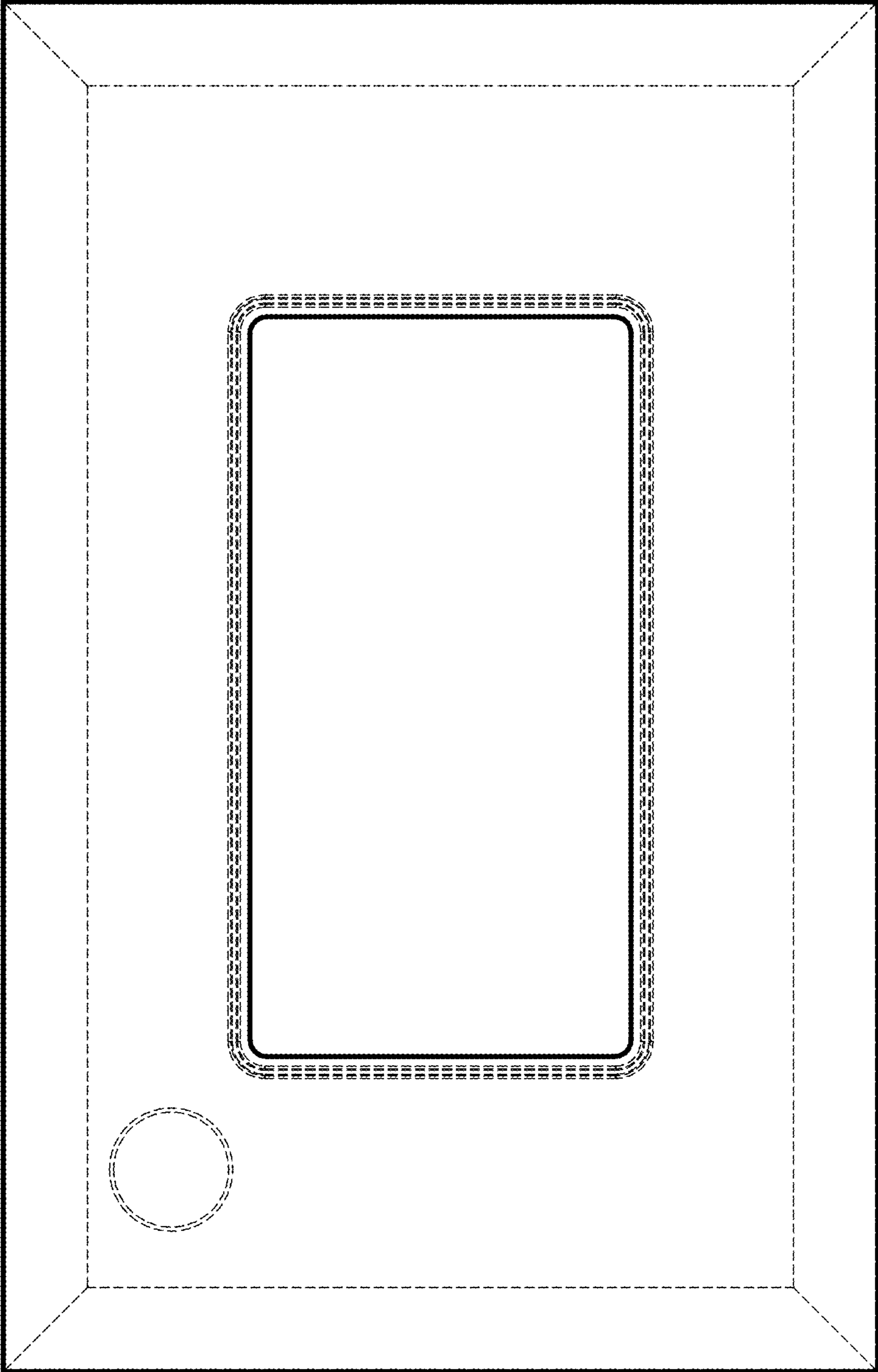

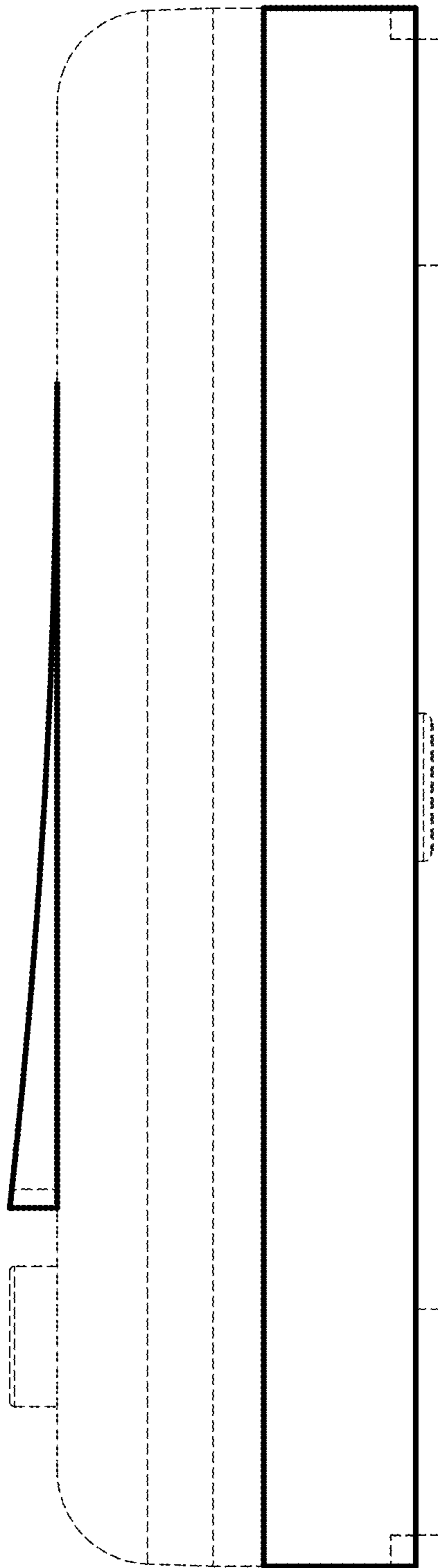

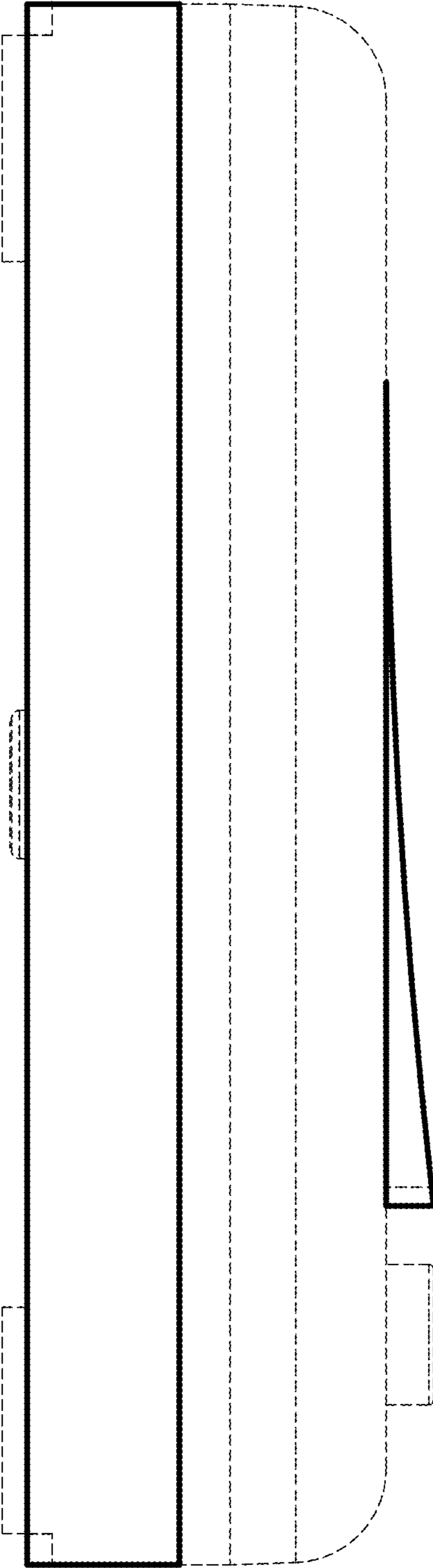

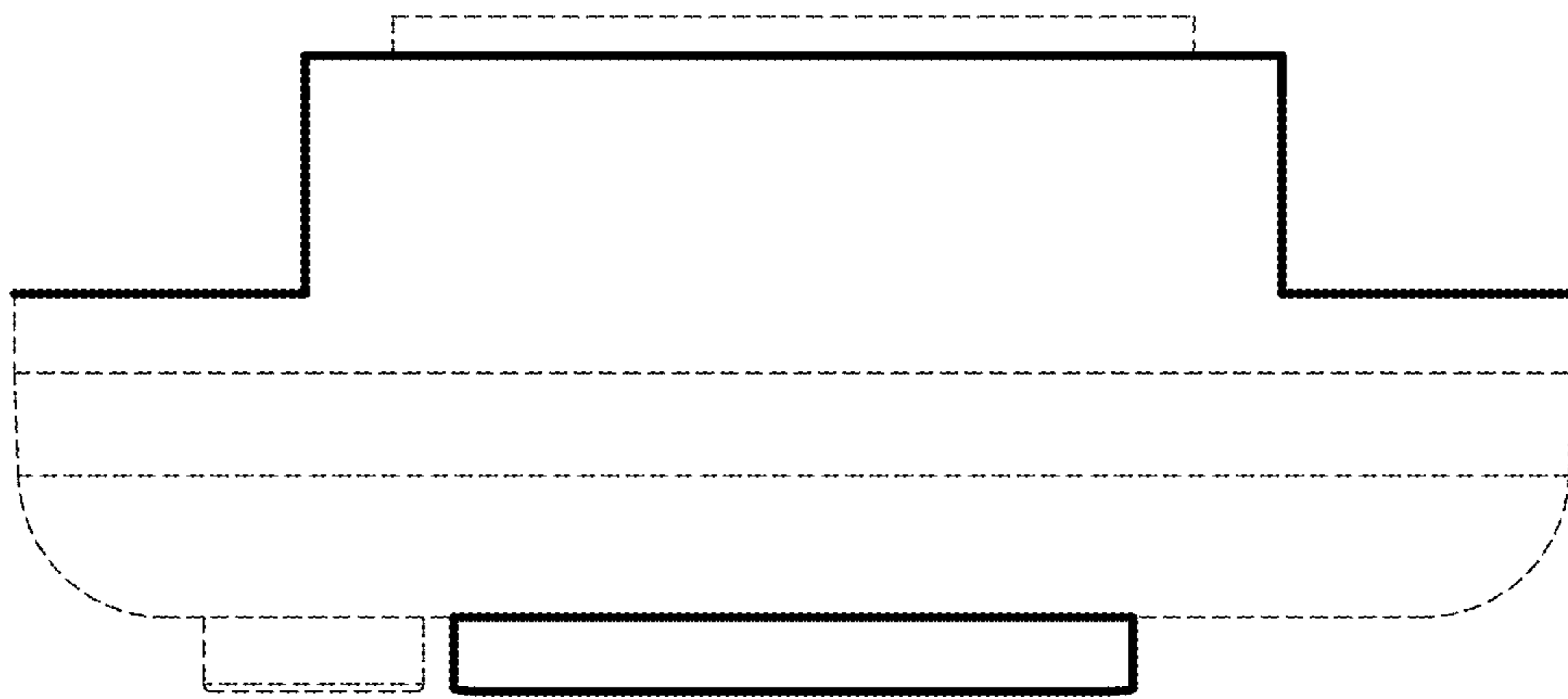

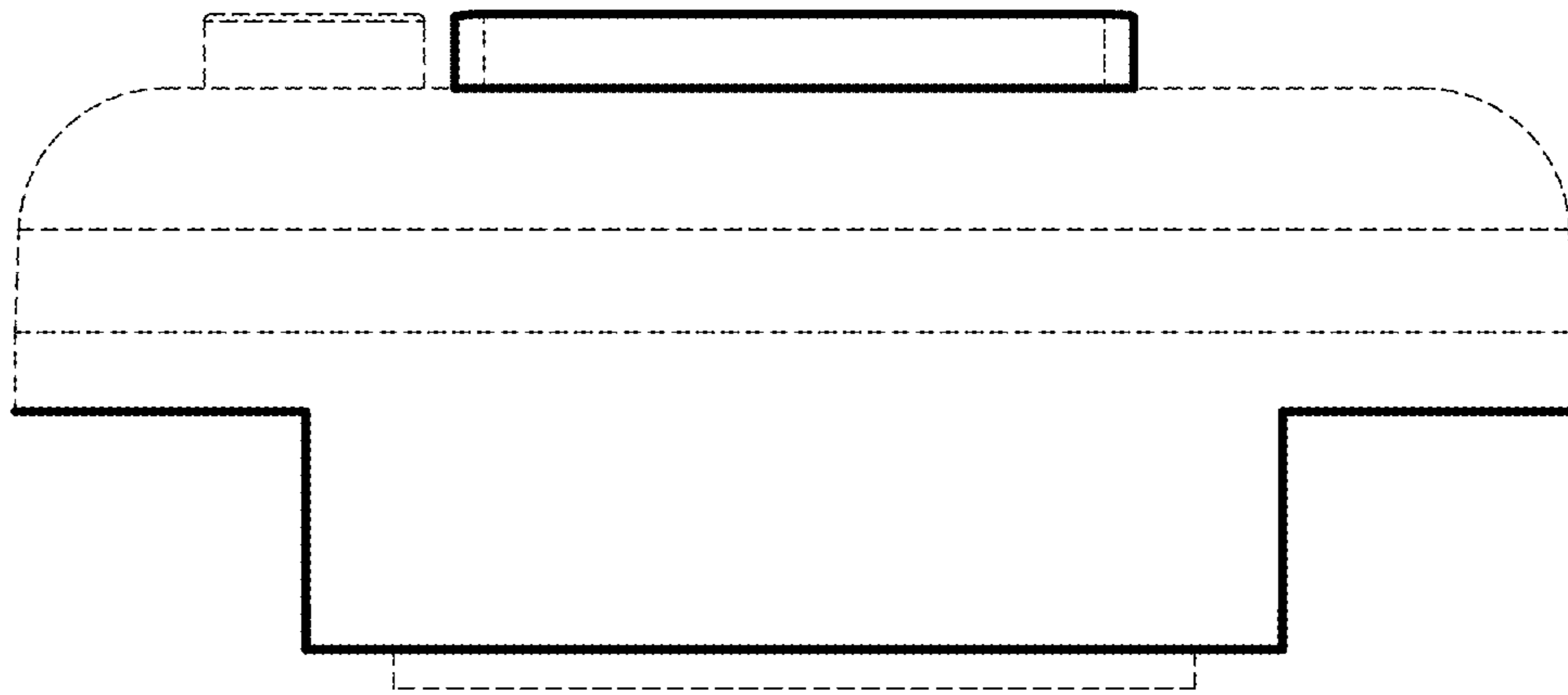

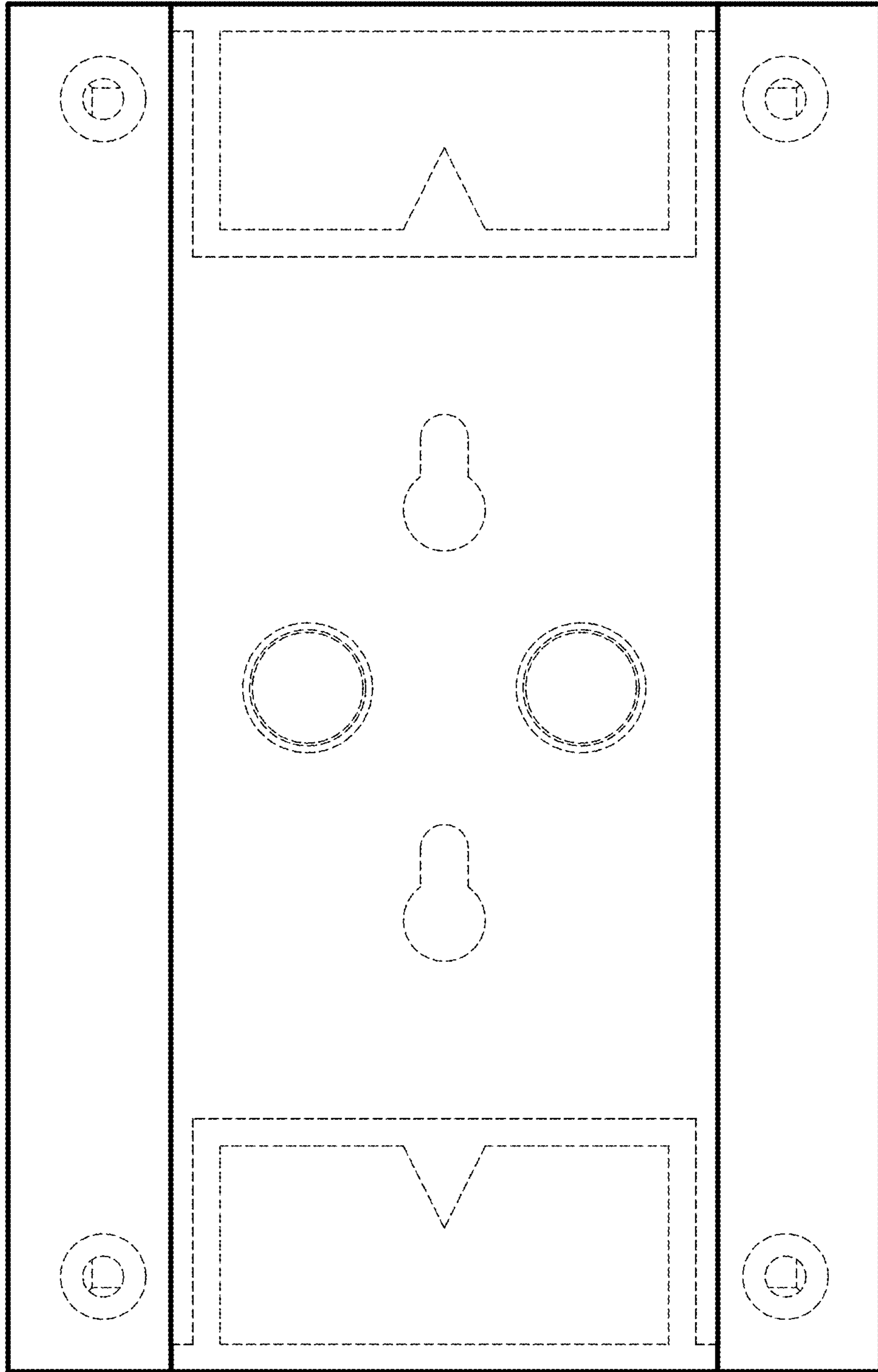

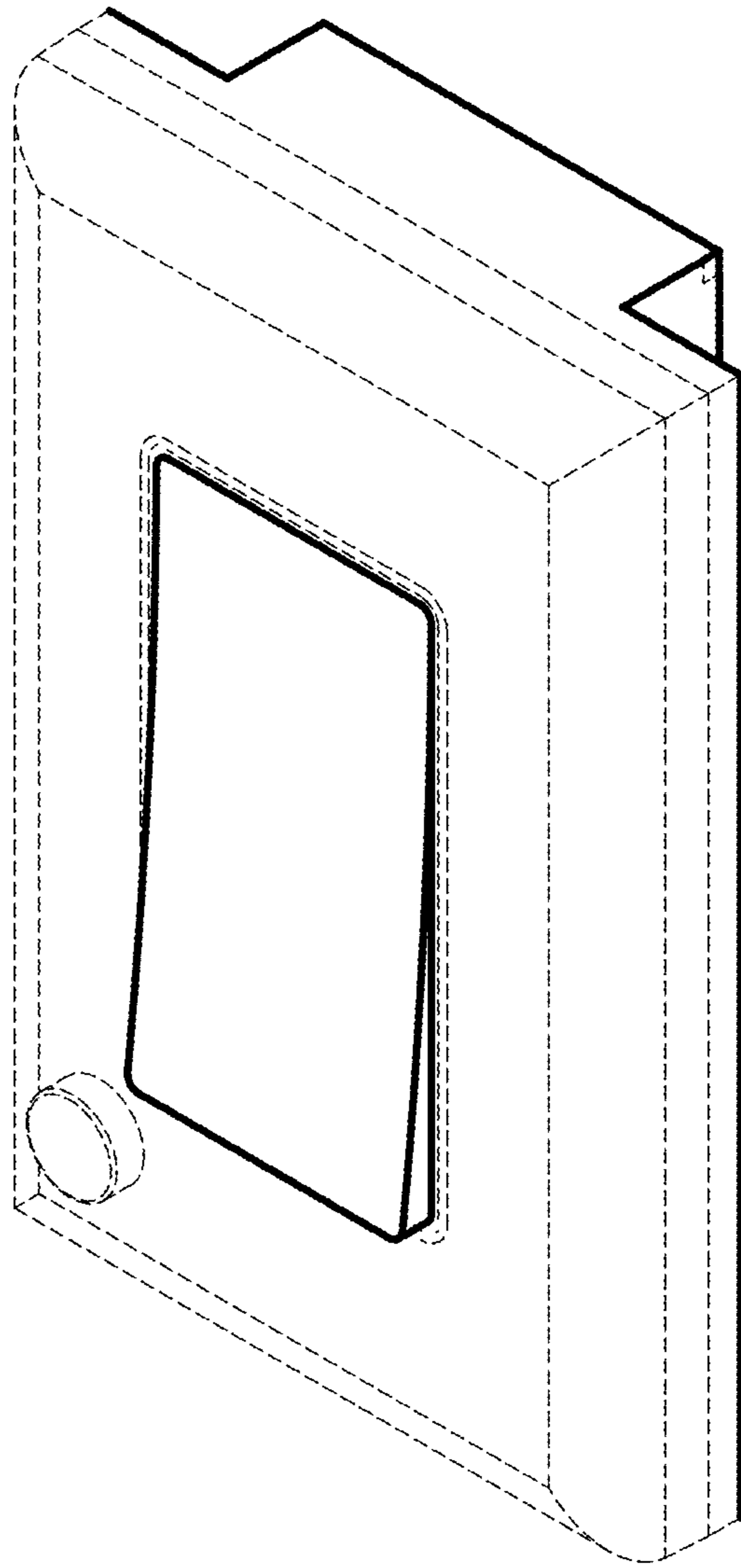

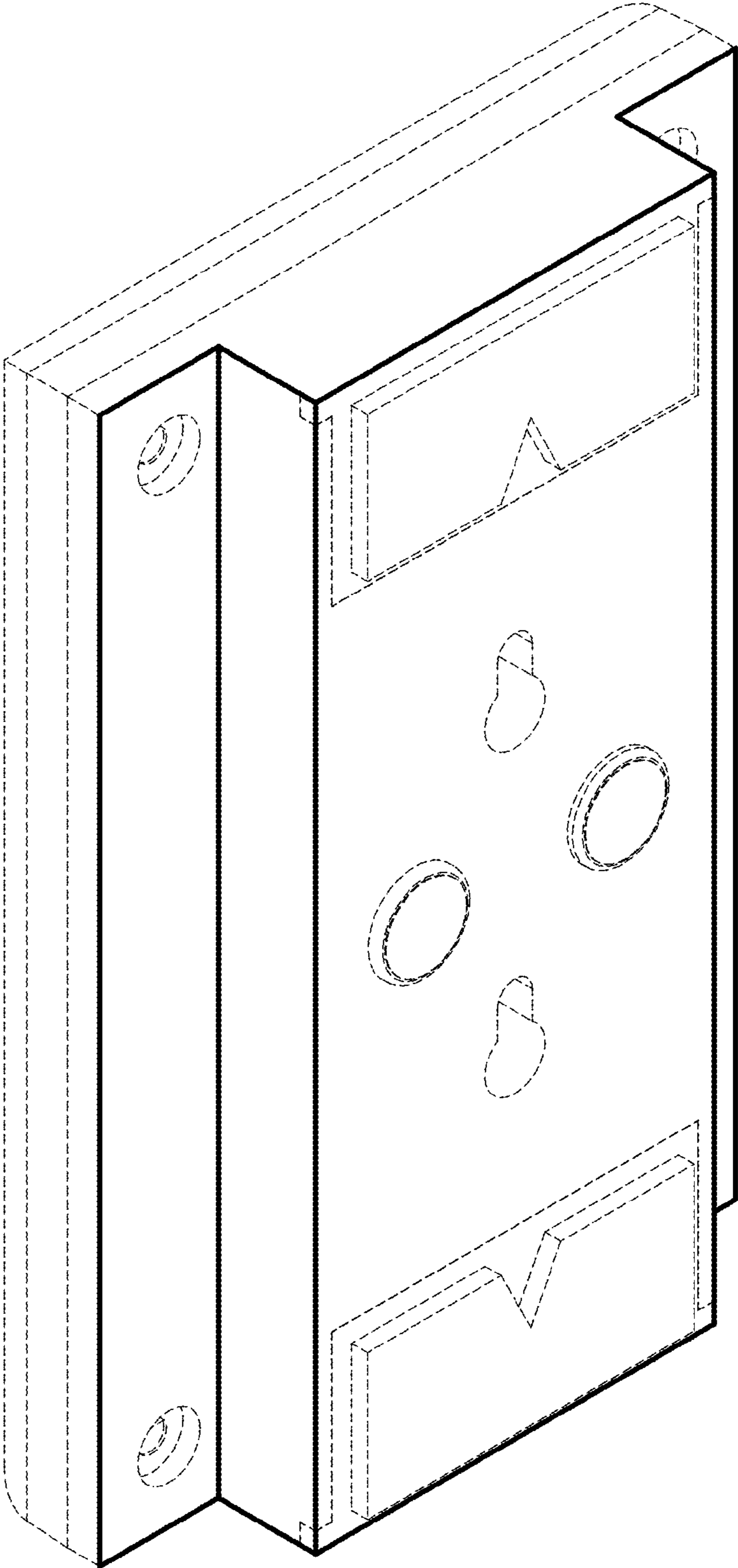
