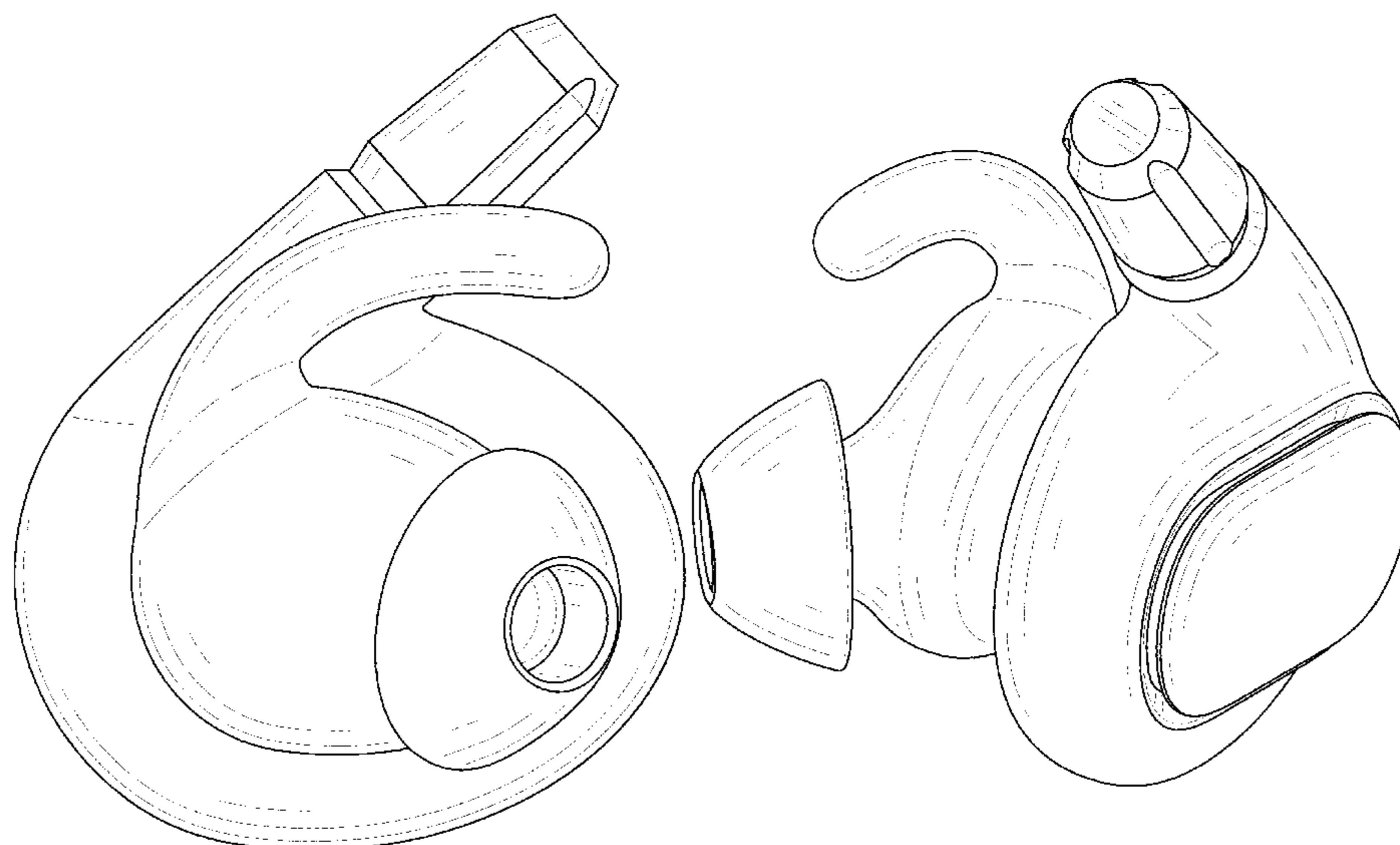
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front elevational view of an earphone showing our new design;  
FIG. 2 is a rear elevational view thereof;

FIG. 4 is a right side view thereof;  
FIG. 5 is a top plan view thereof;

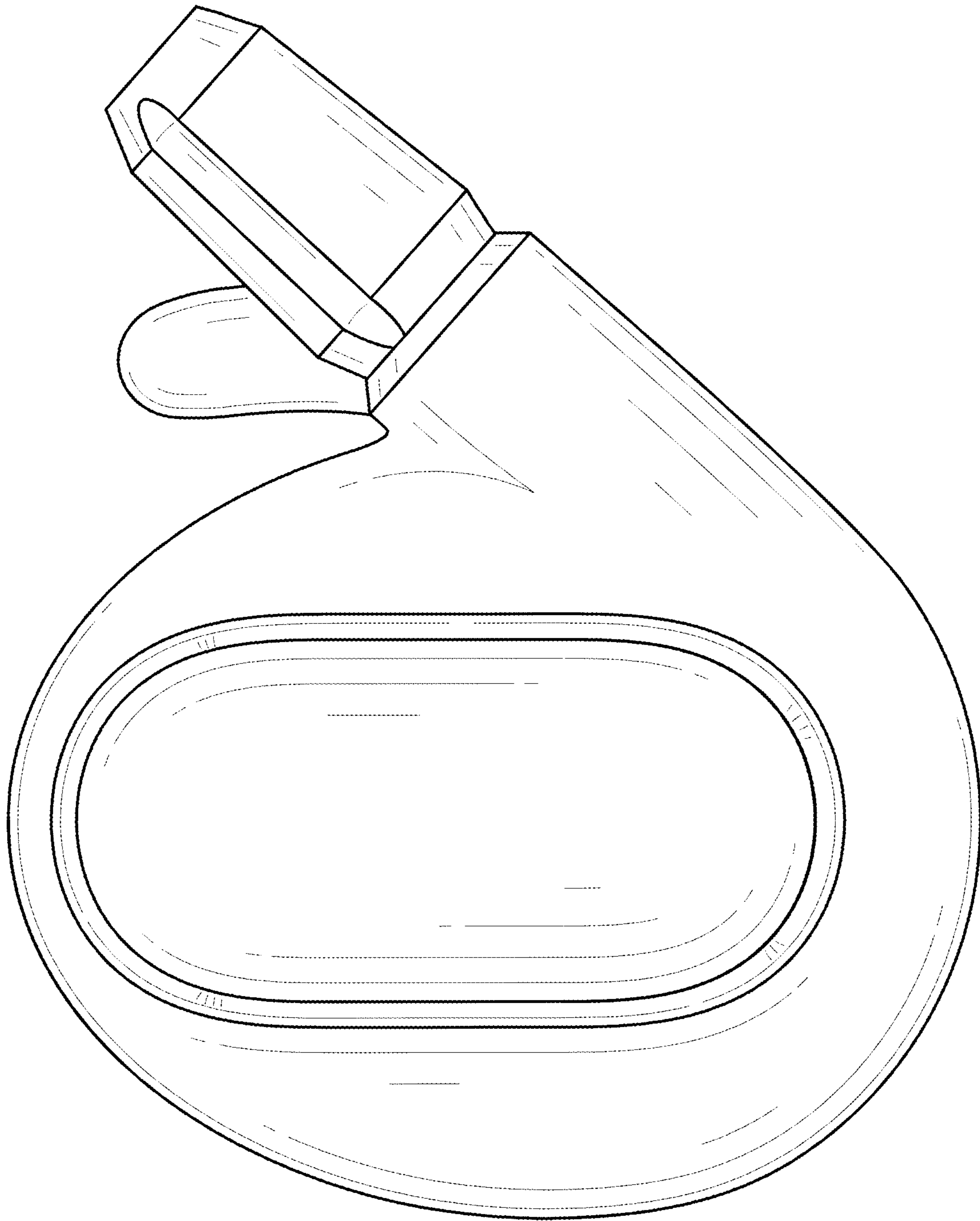

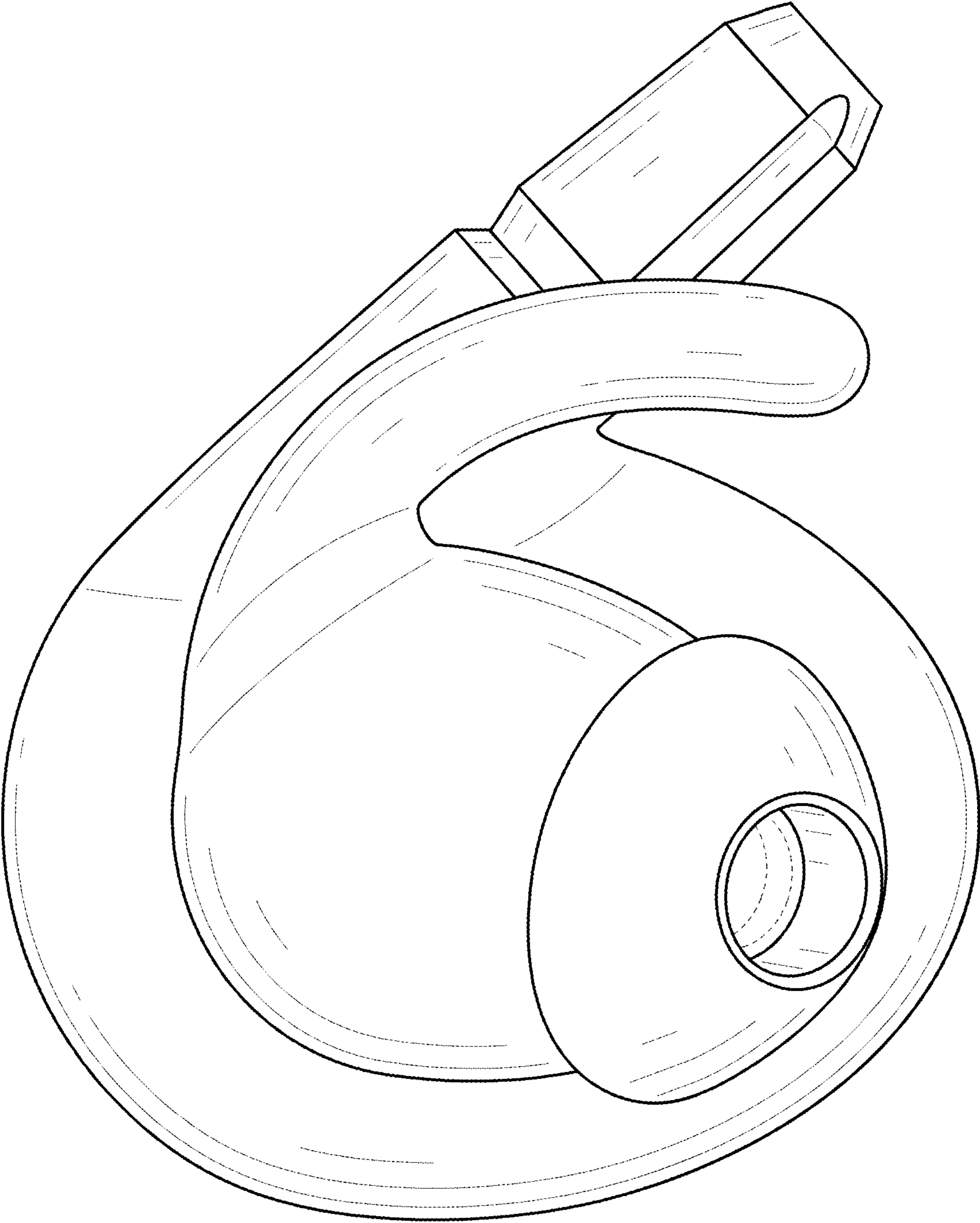

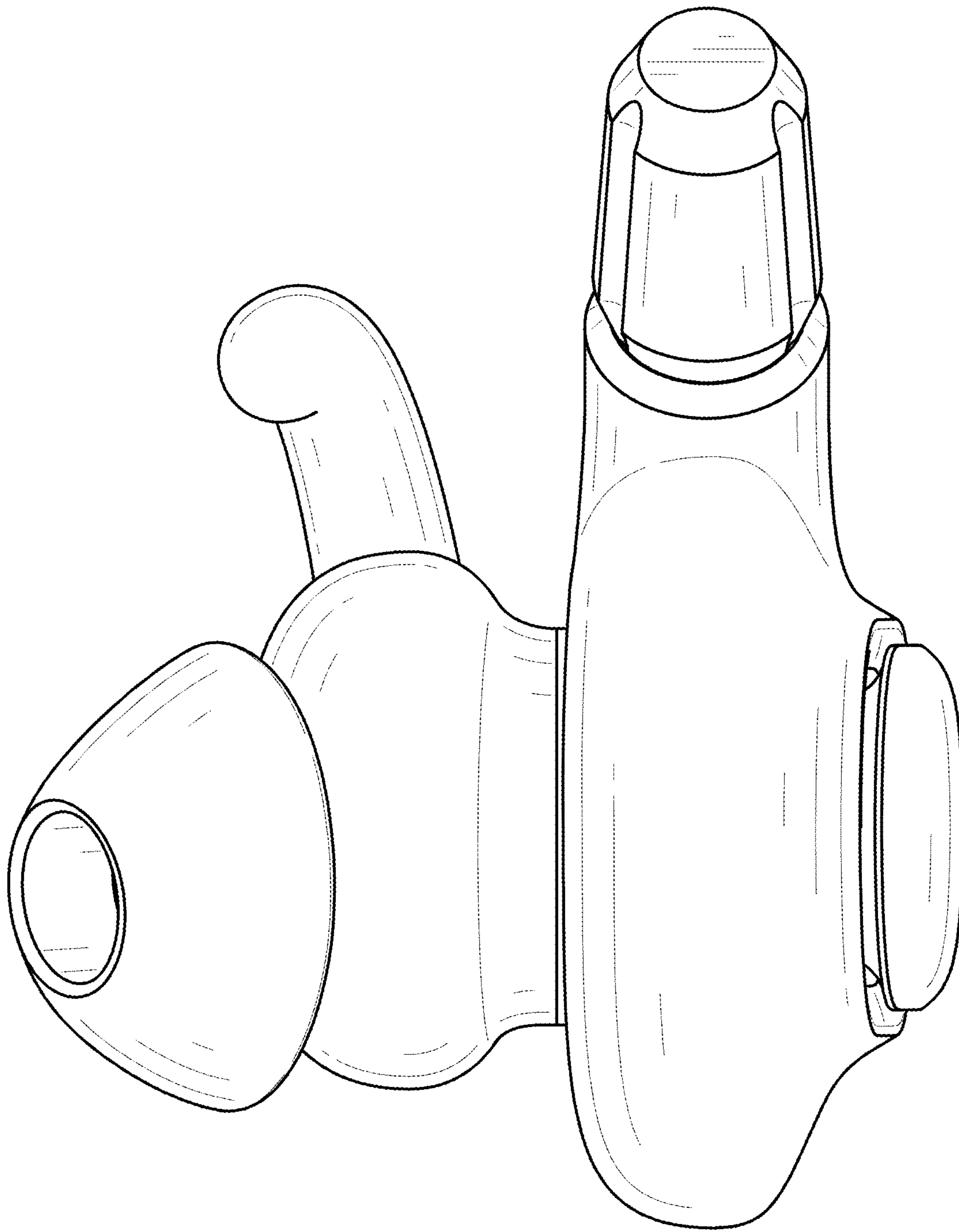

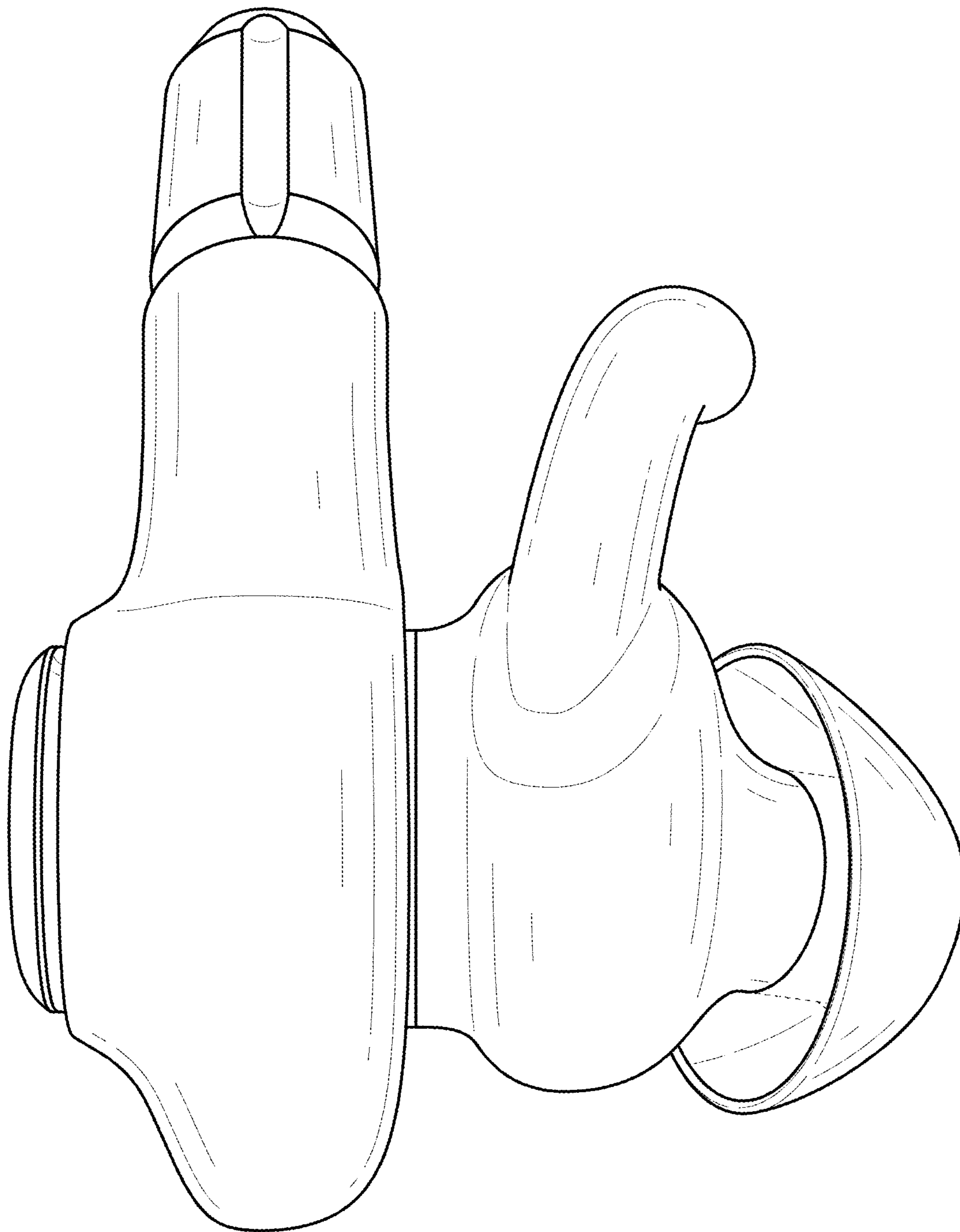

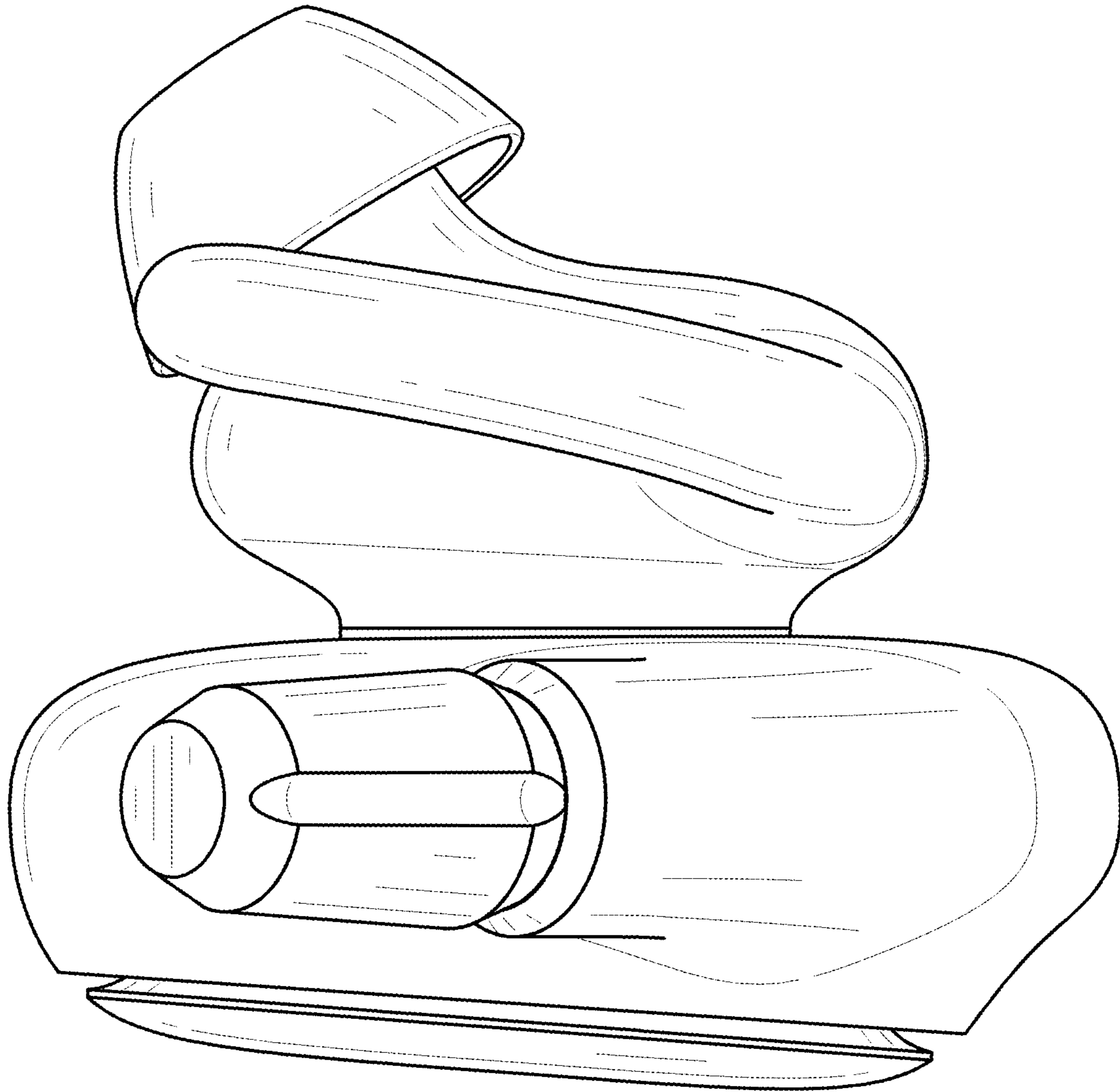

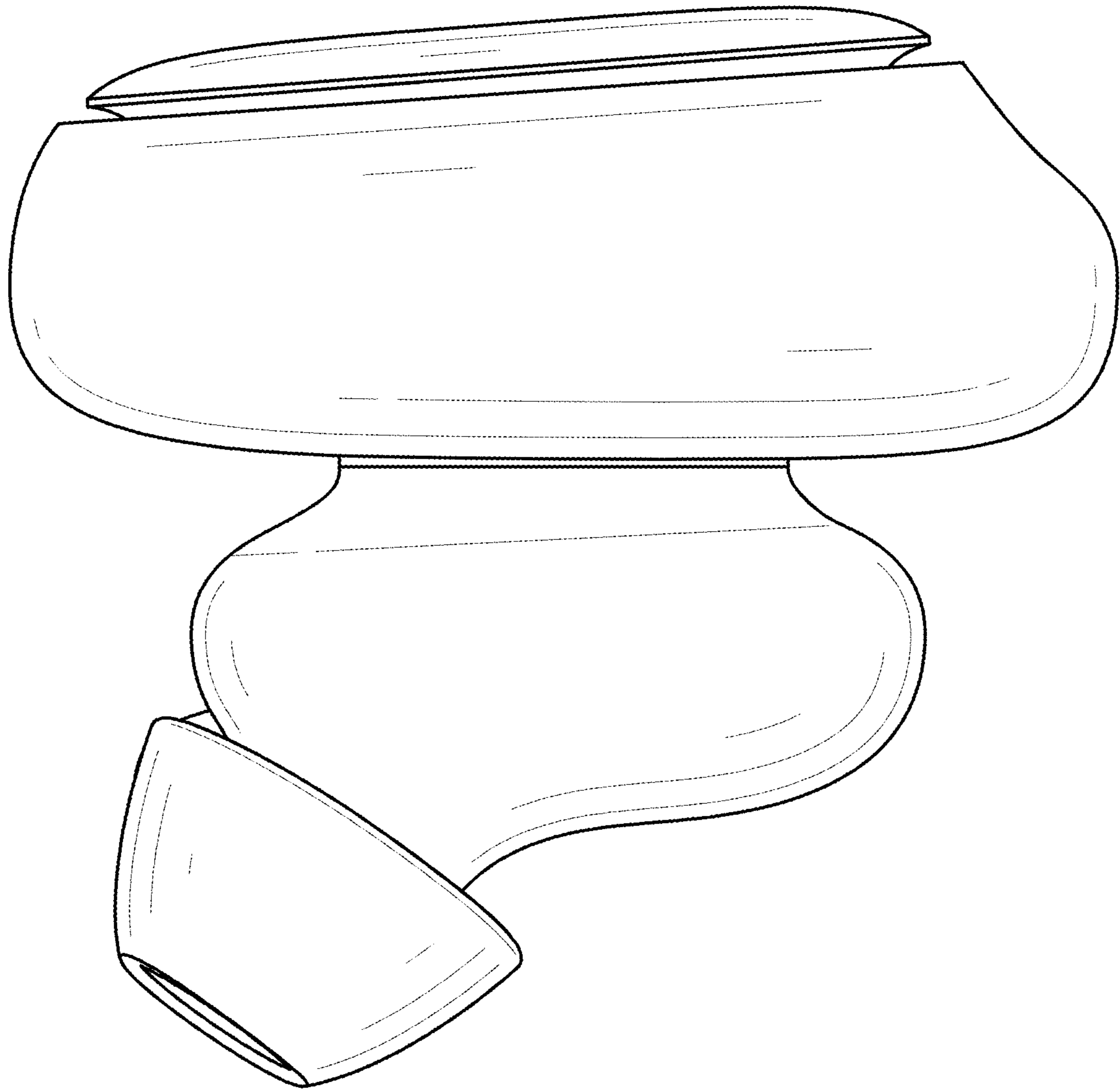

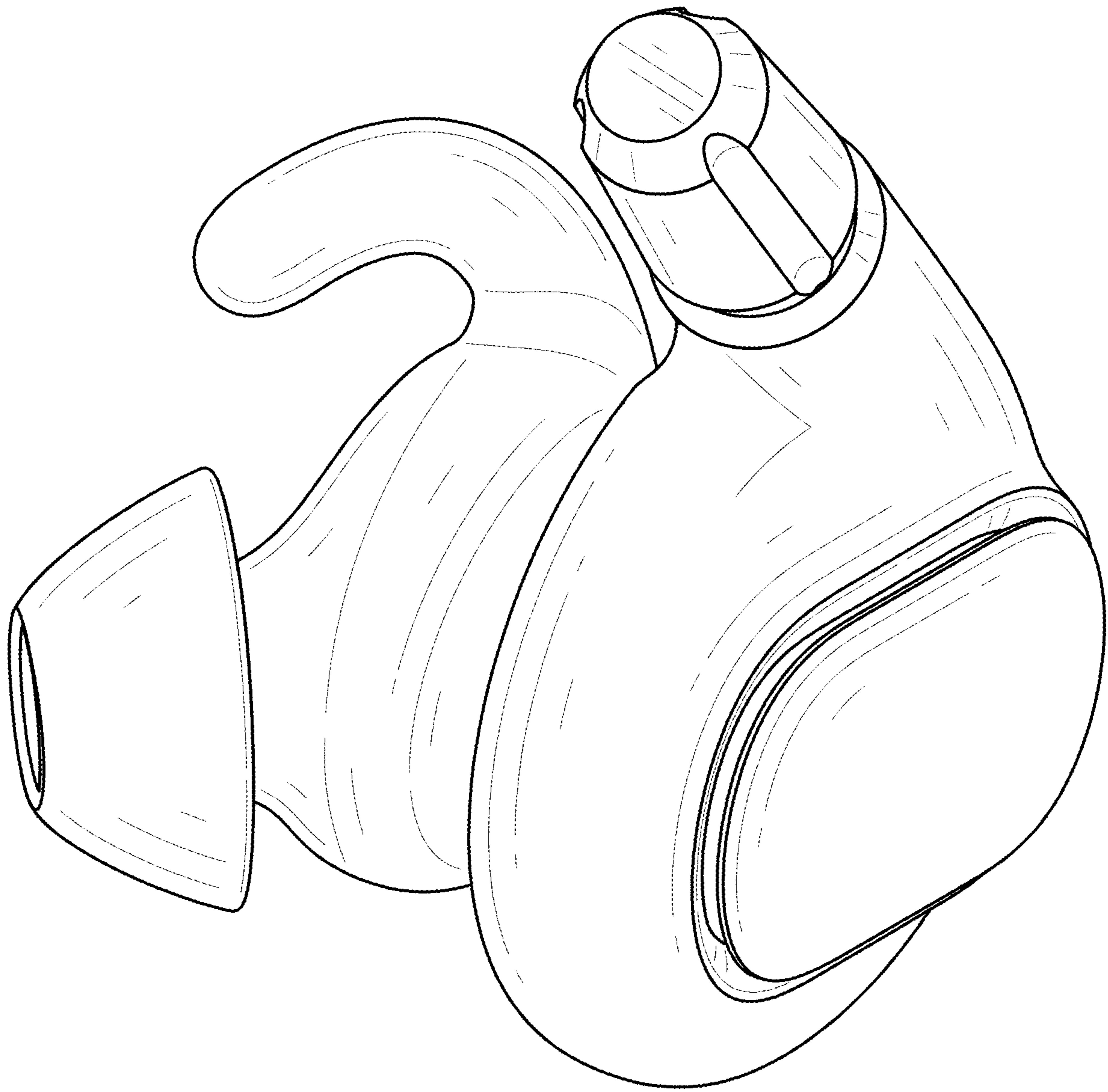
