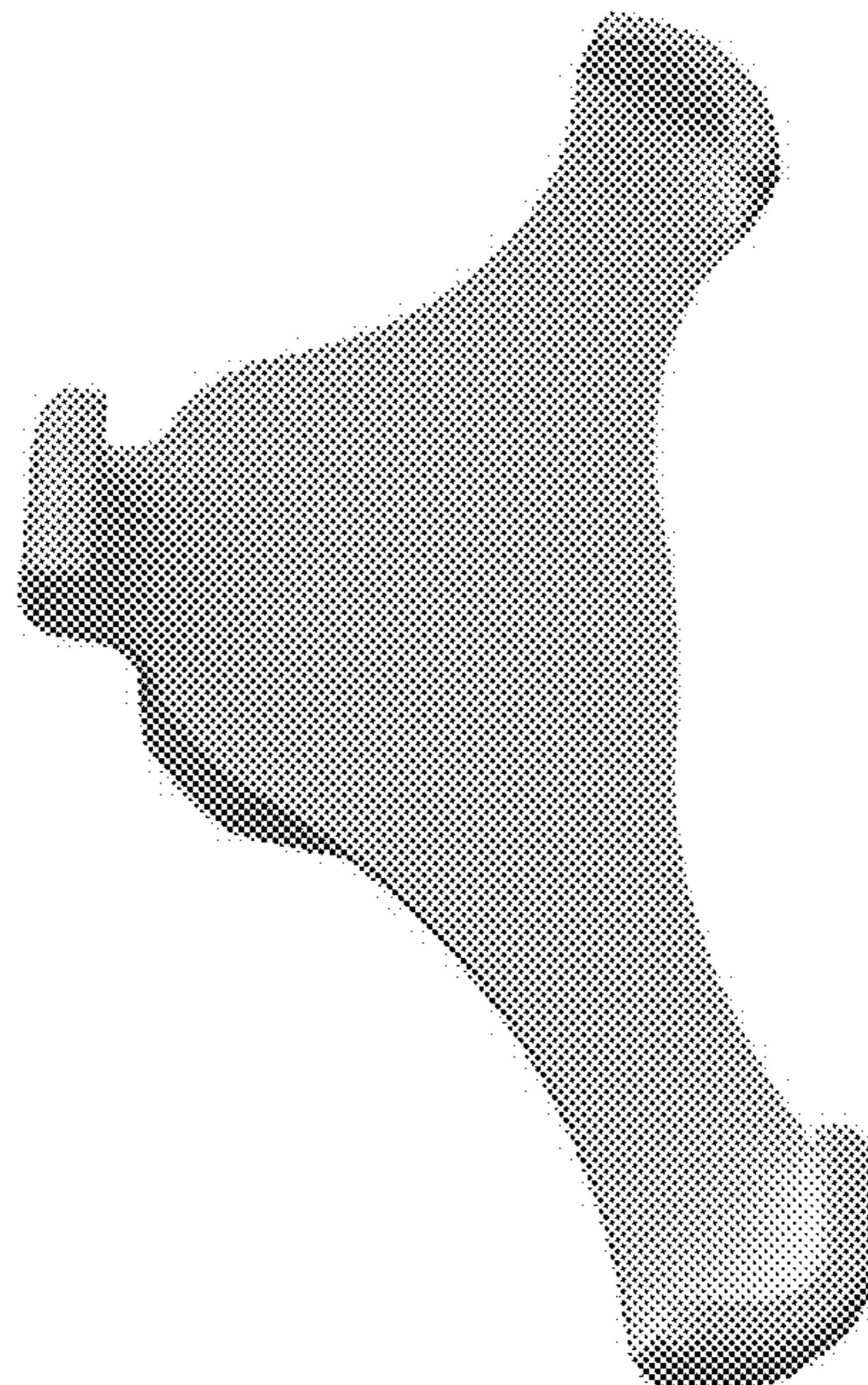

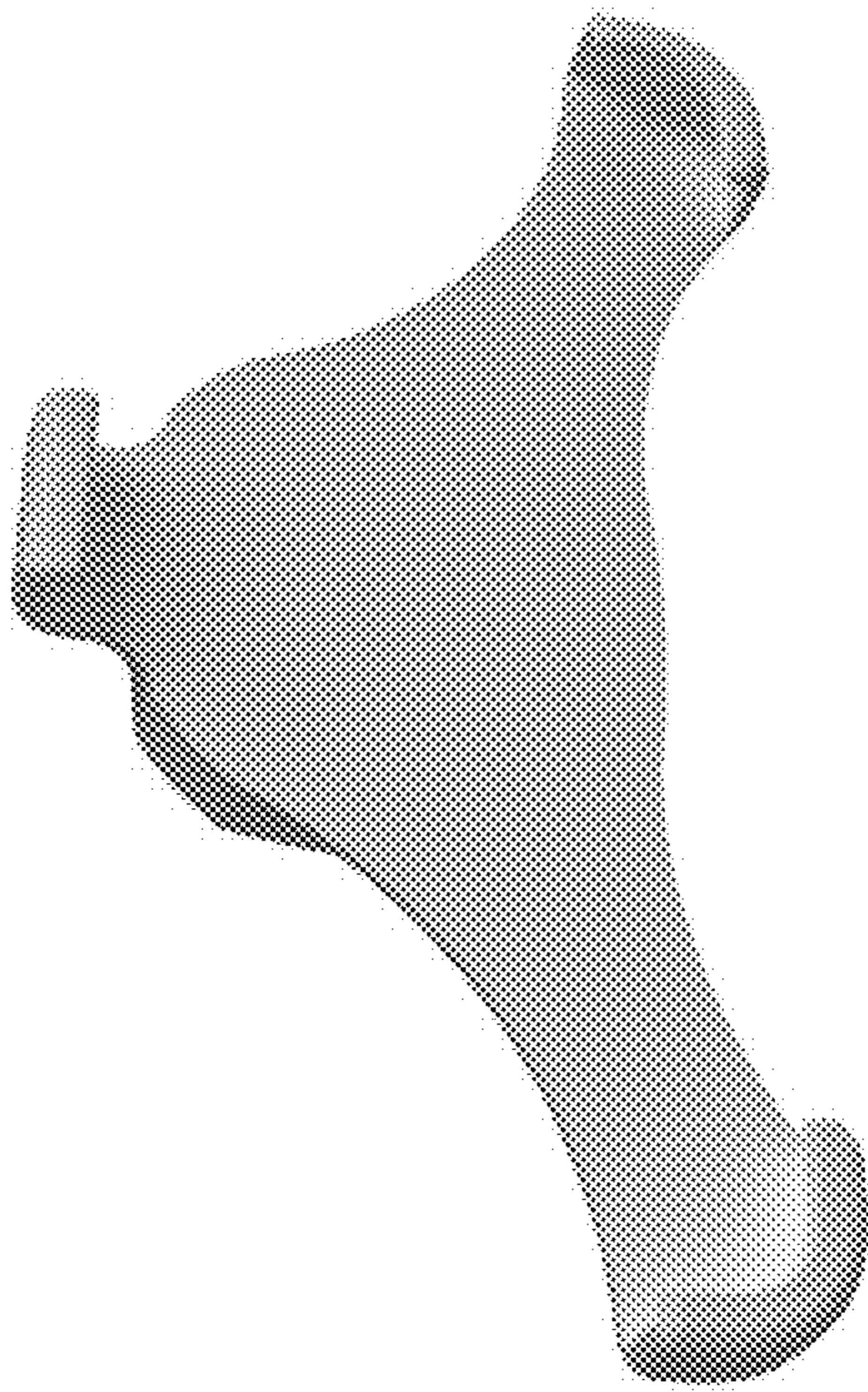
The ornamental design for a security bracket for an article of merchandise, as shown and described.

**DESCRIPTION**

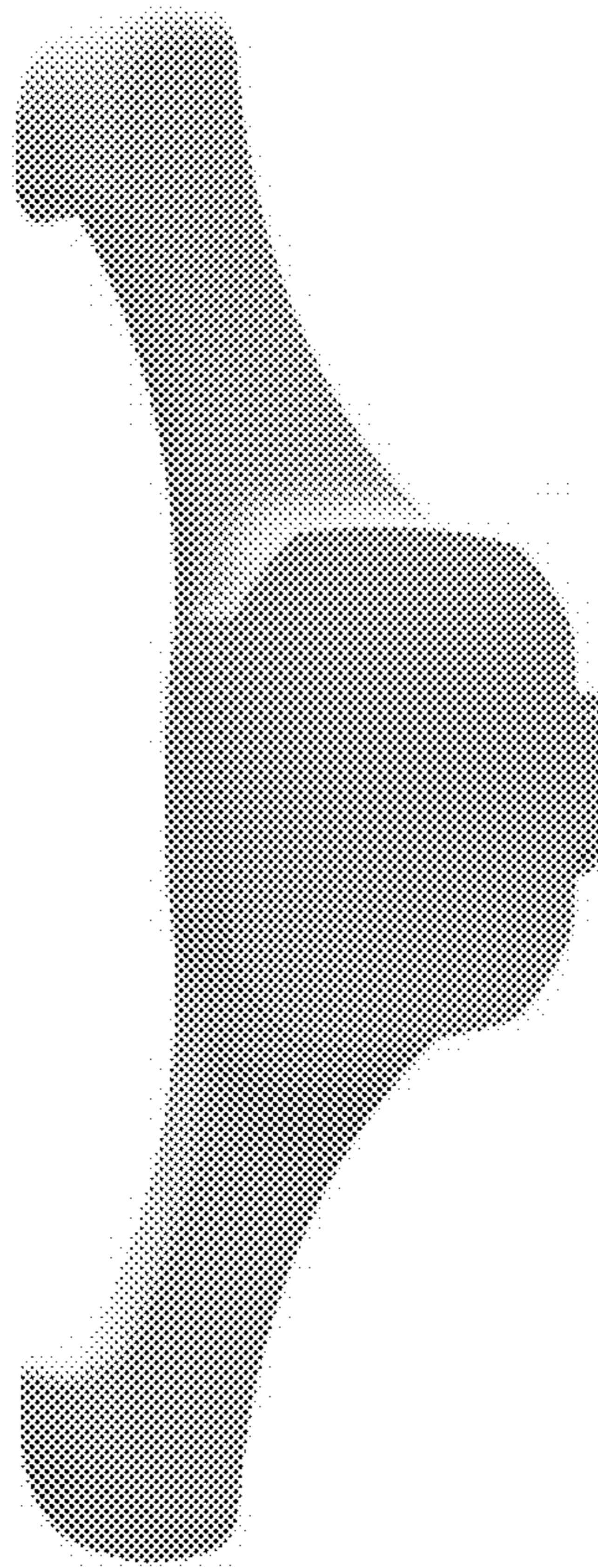

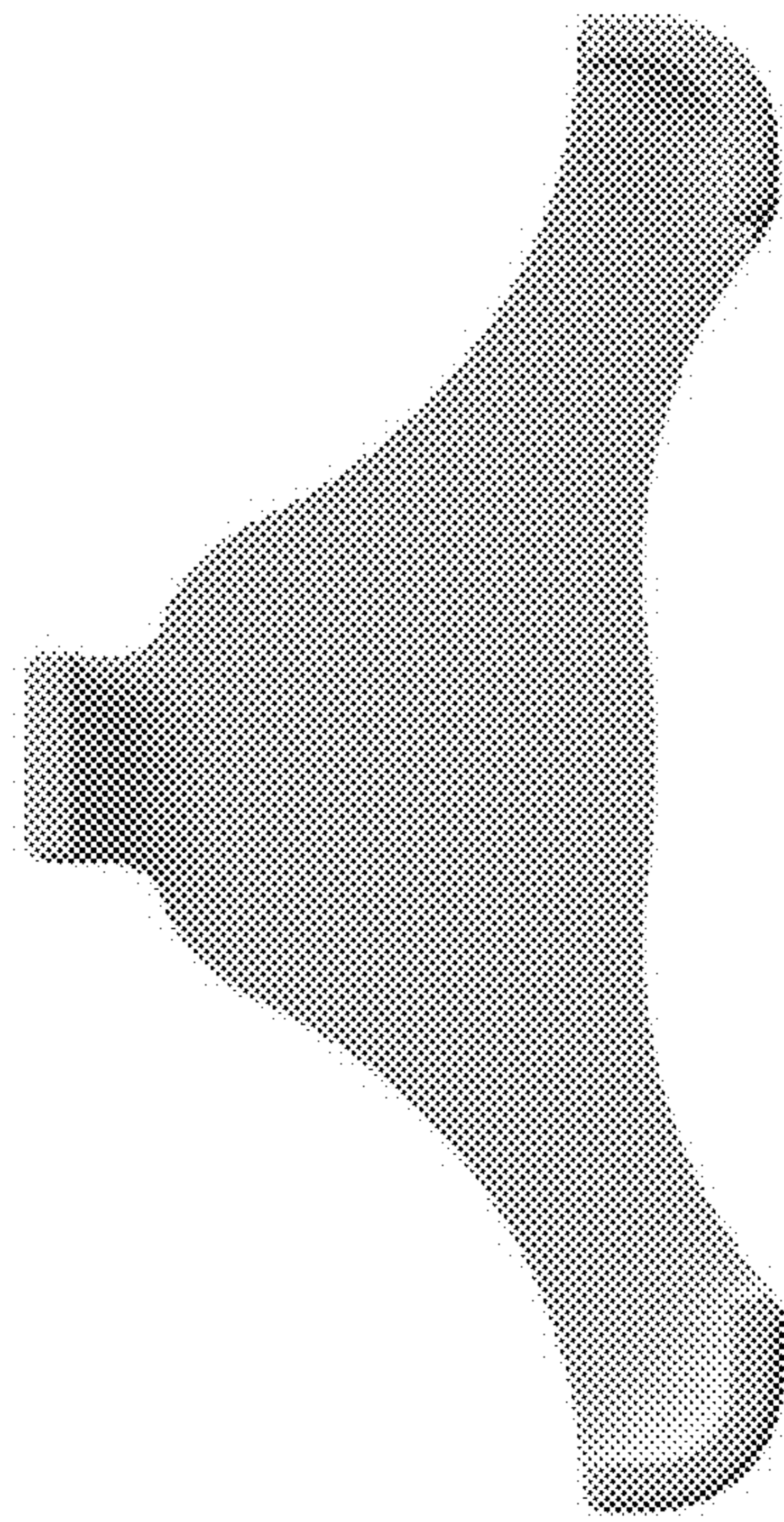




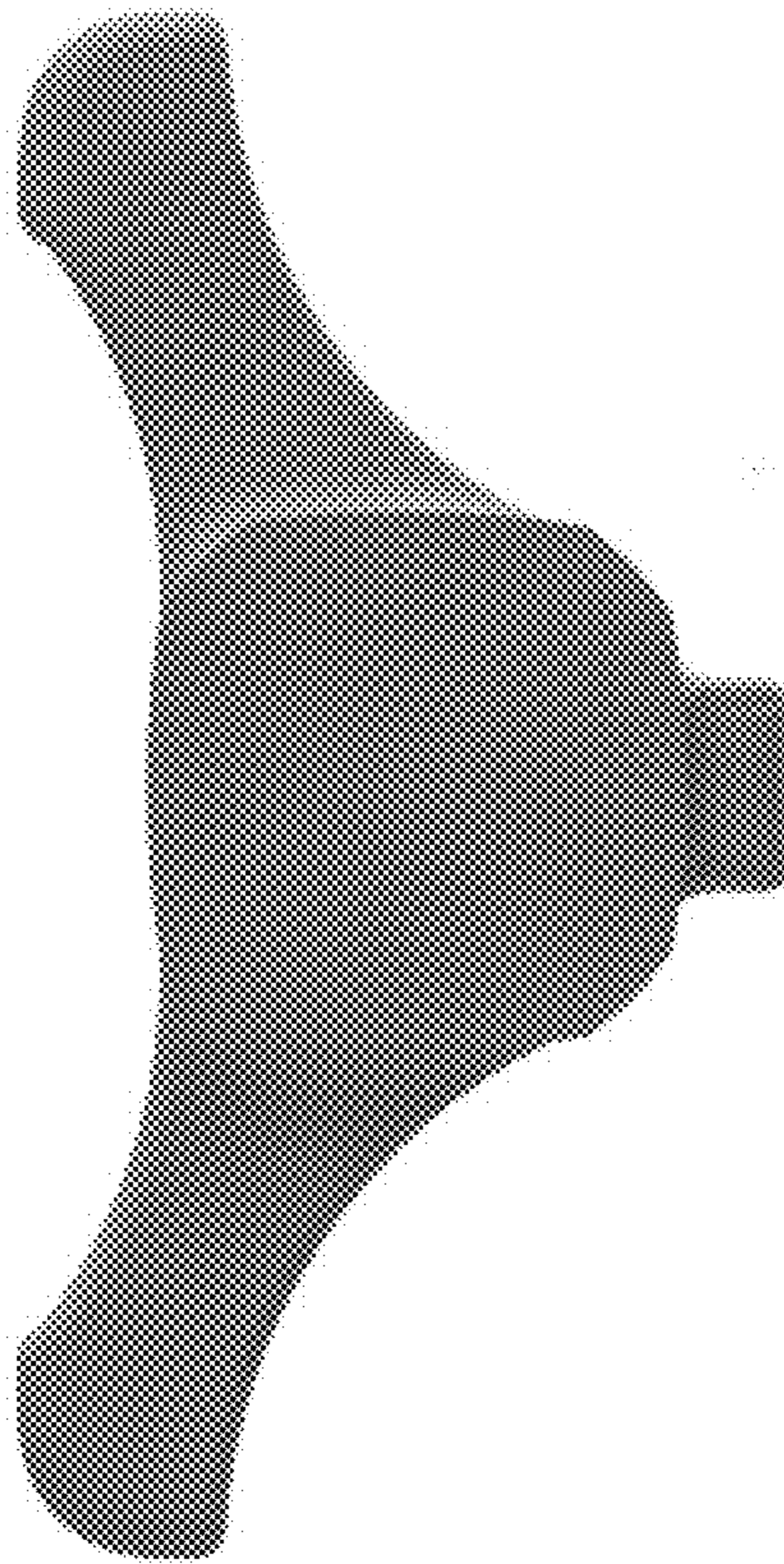

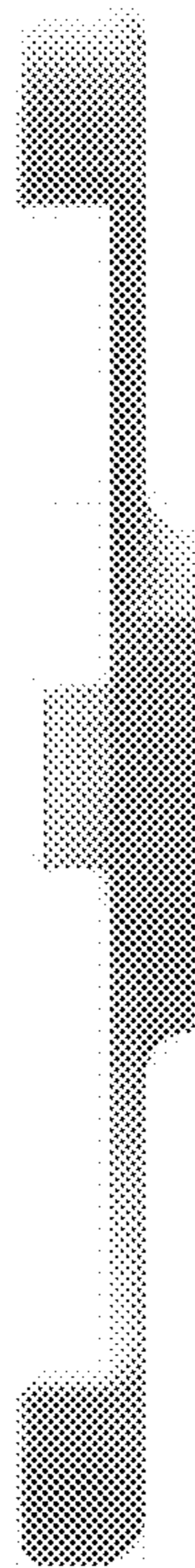

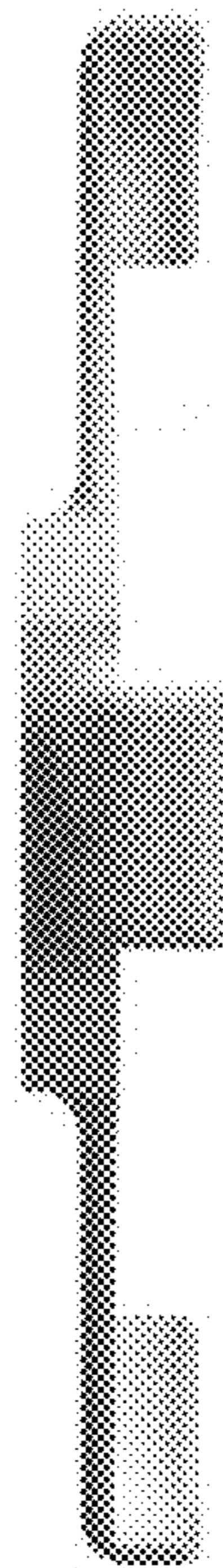
