(57) **CLAIM**

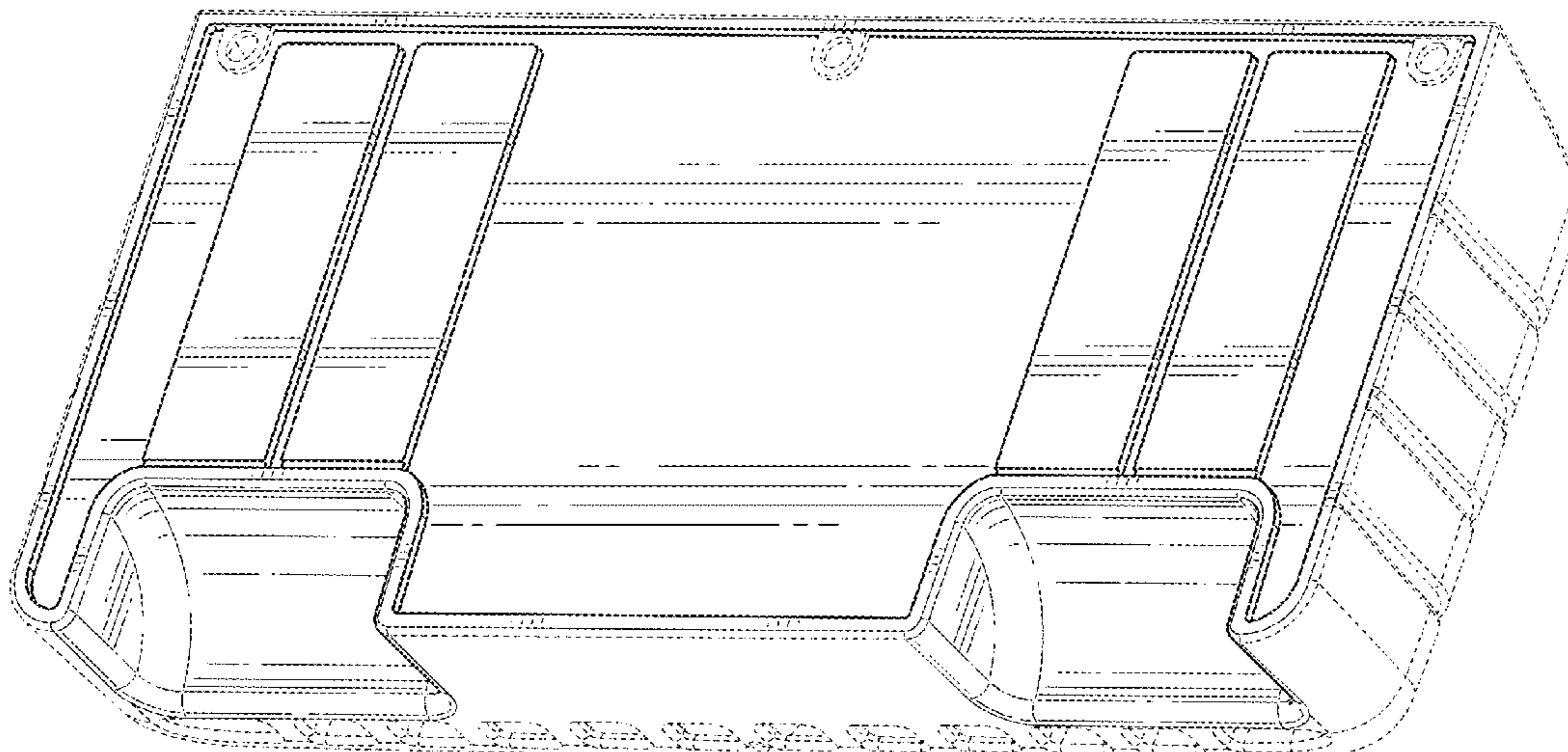
The ornamental design for a mount for electronic devices, as shown and described.

DESCRIPTION

FIG. 1 is a front, first side, and top perspective view of a mount for electronic devices embodying the new design; FIG. 2 is a back, second side, and bottom perspective view thereof; FIG. 3 is a top, back, and first side perspective view thereof; FIG. 4 is a front view thereof; FIG. 5 is a back view thereof; FIG. 6 is a second side view thereof; FIG. 7 is a first side view thereof; FIG. 8 is a bottom view thereof; and, FIG. 9 is a top view thereof.

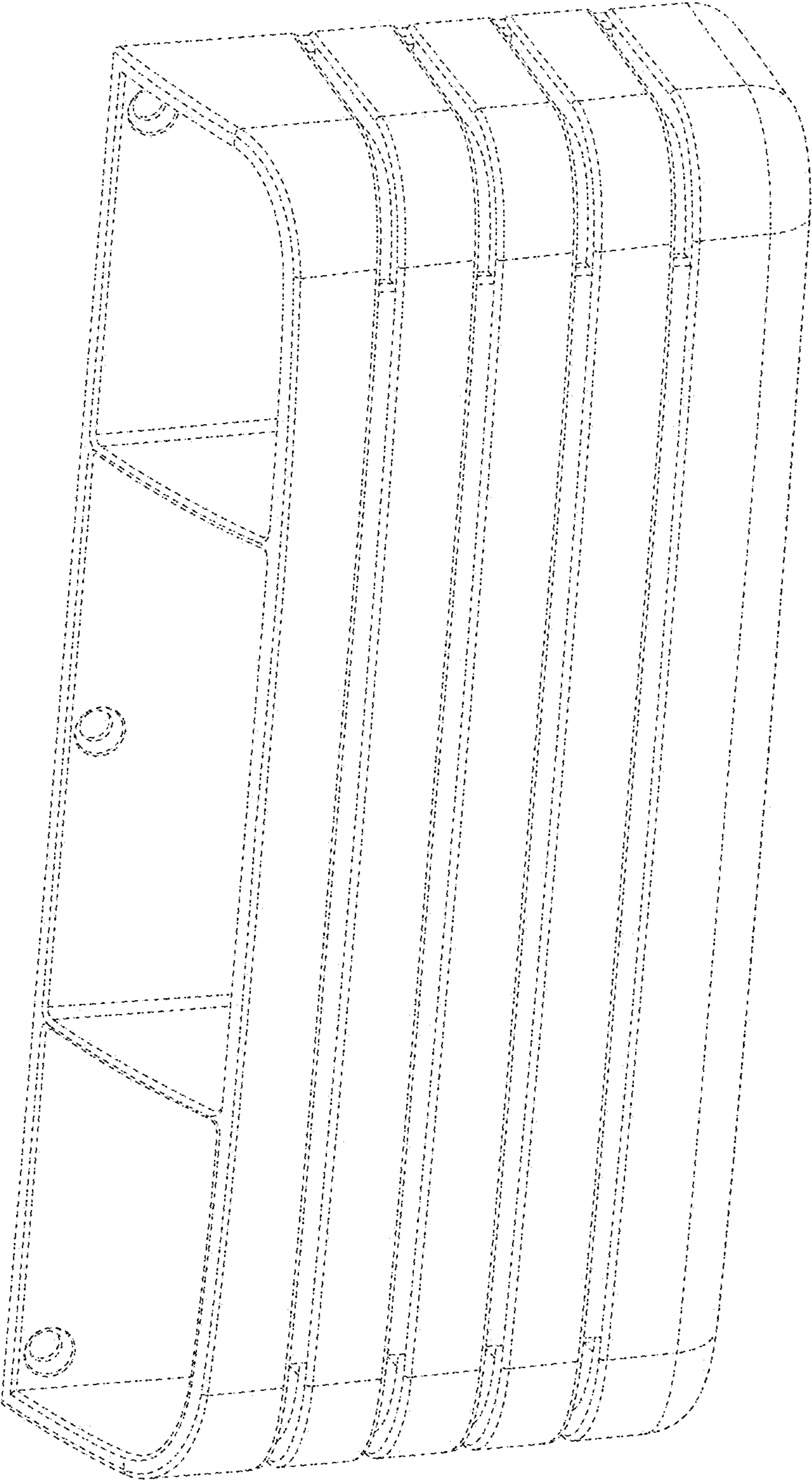

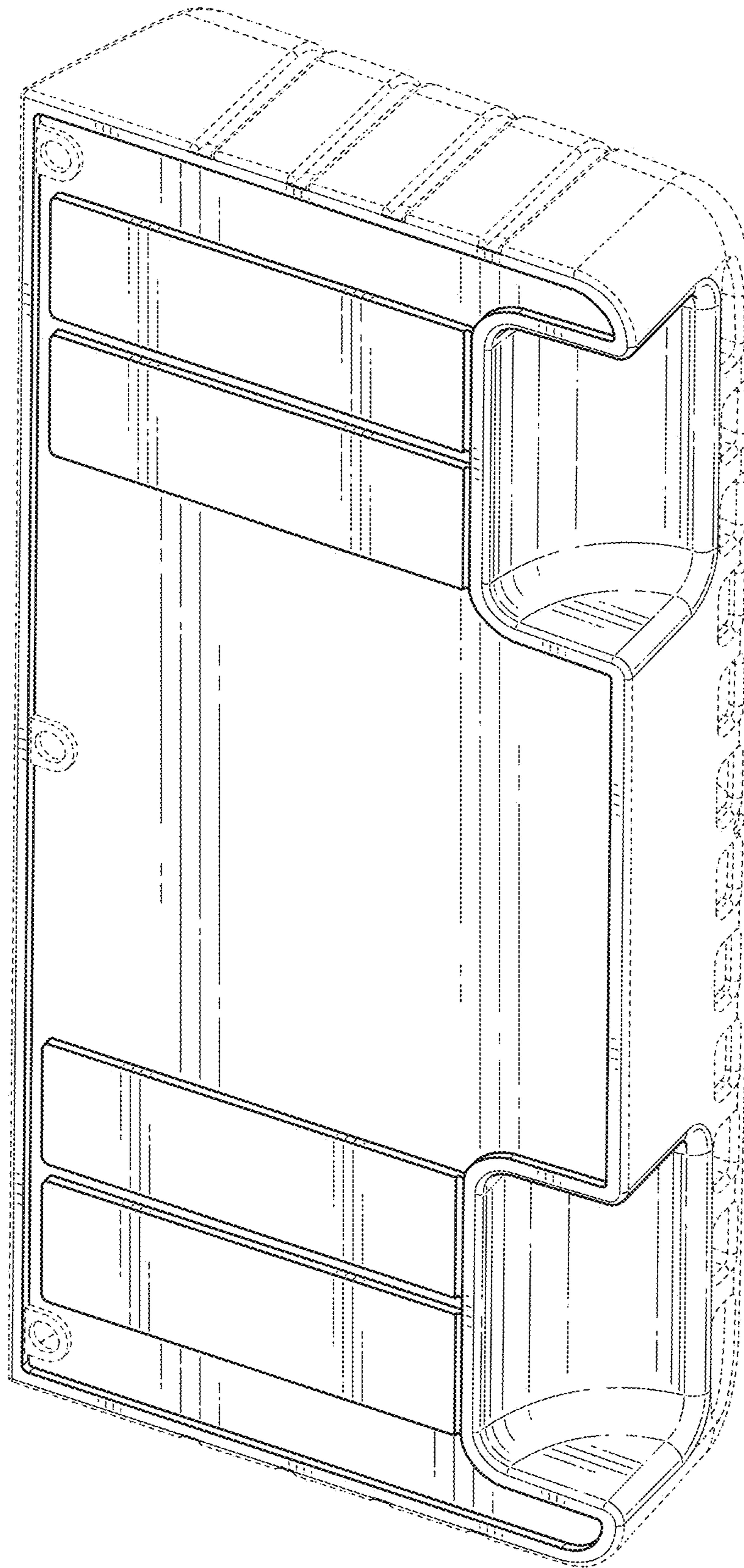

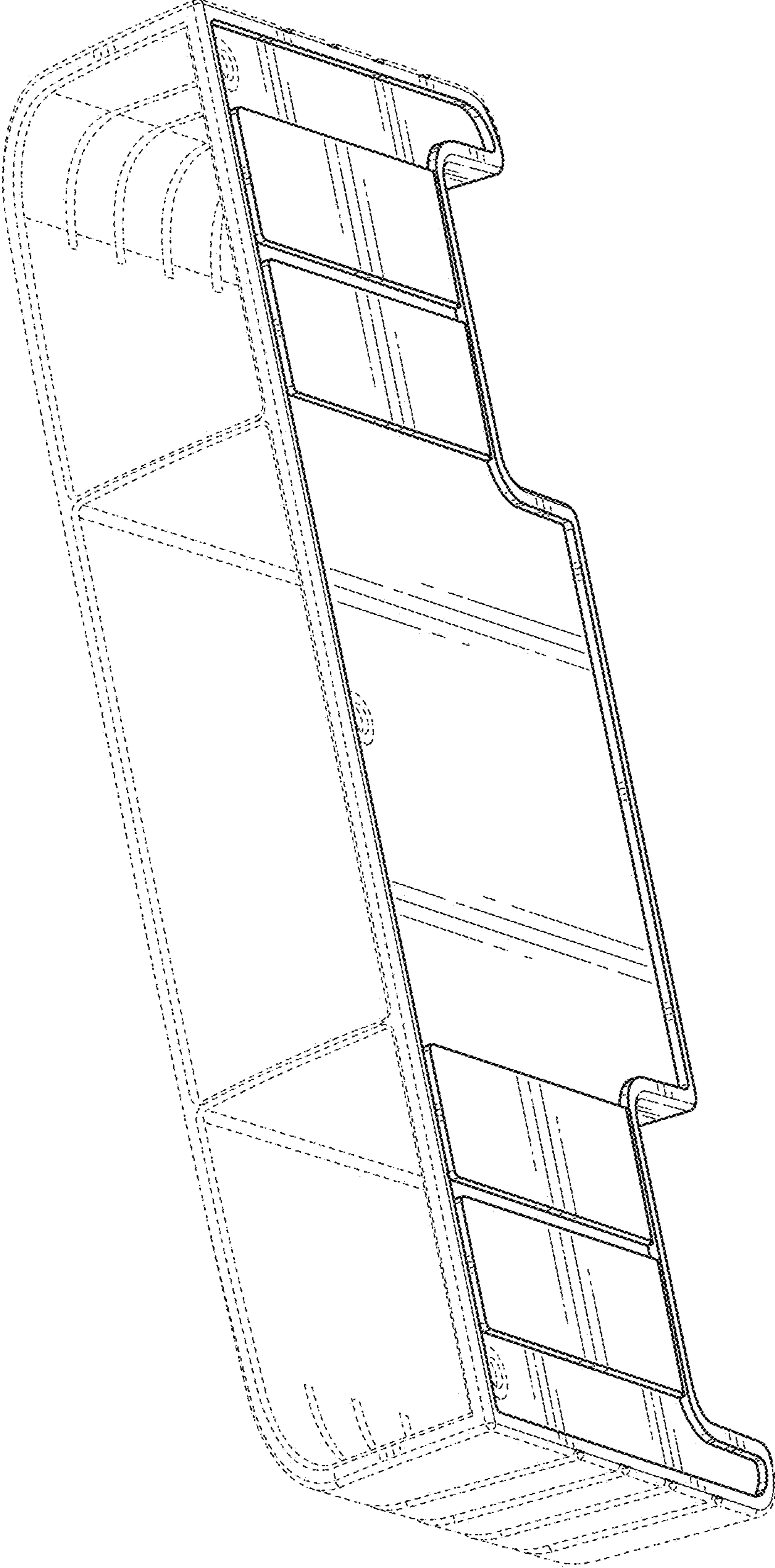

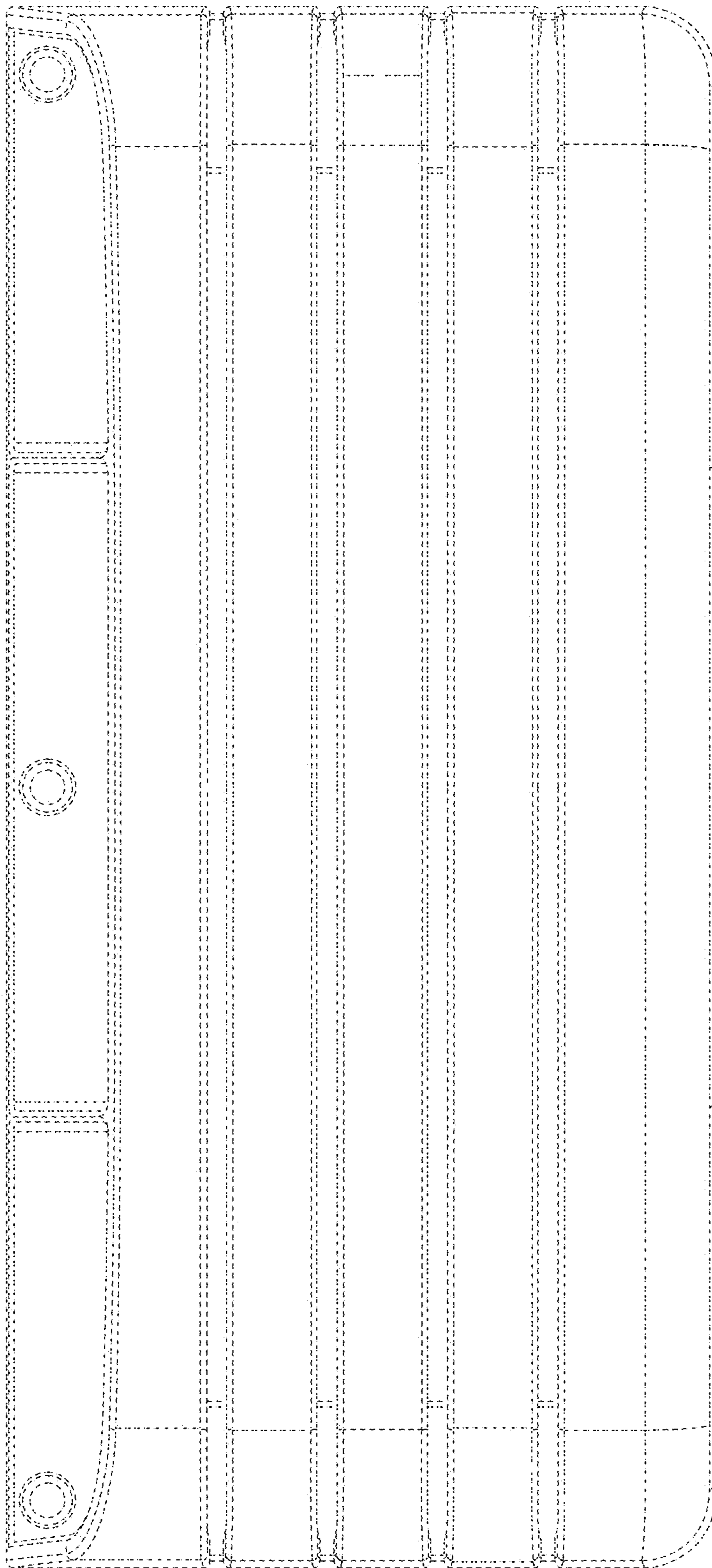

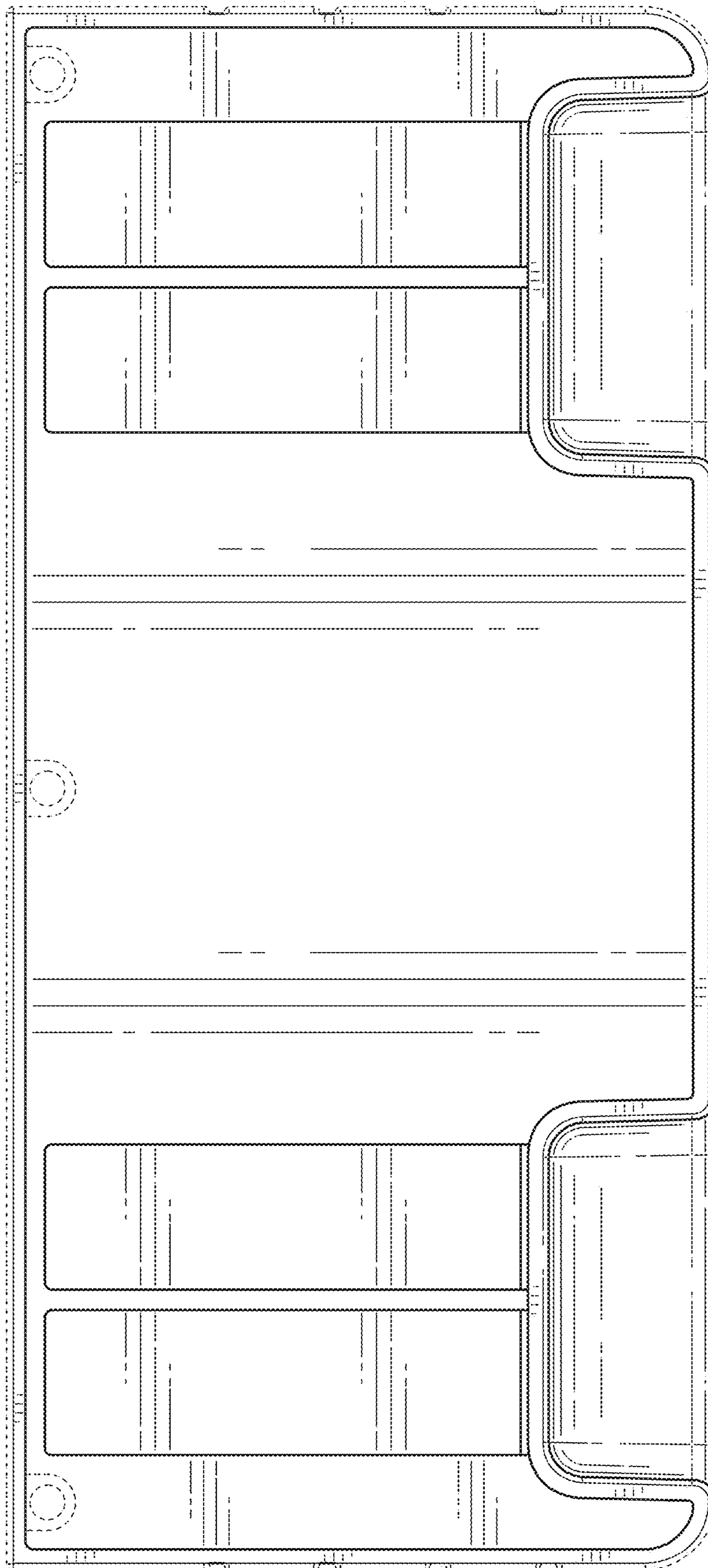

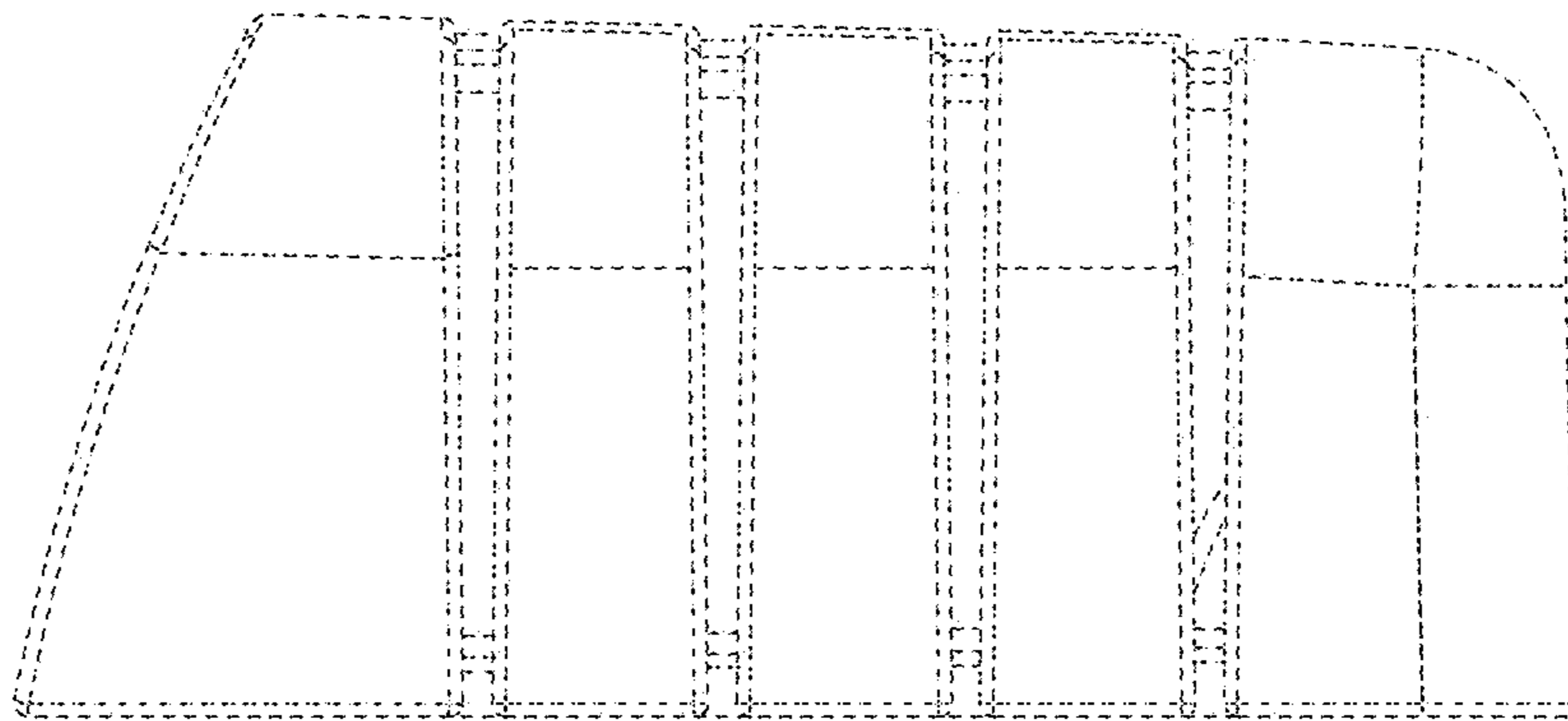

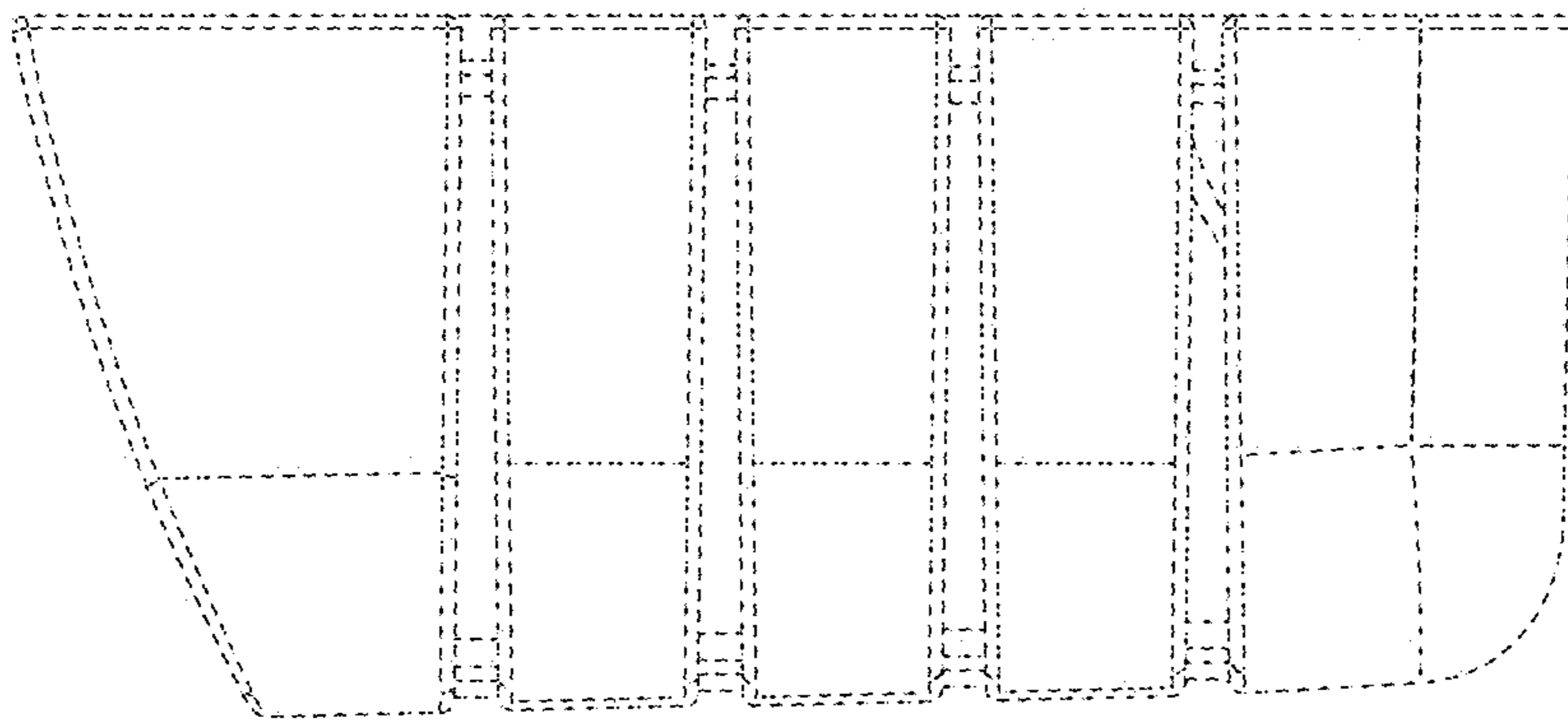

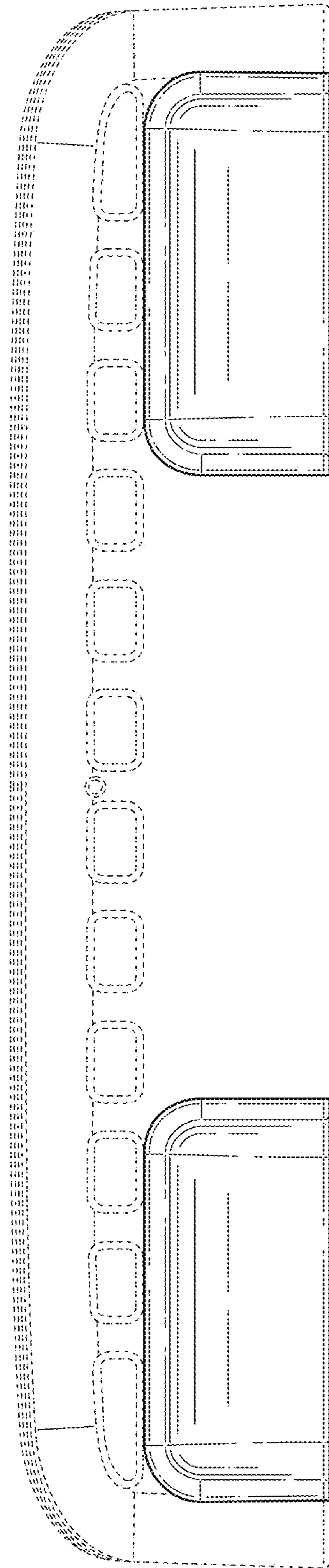

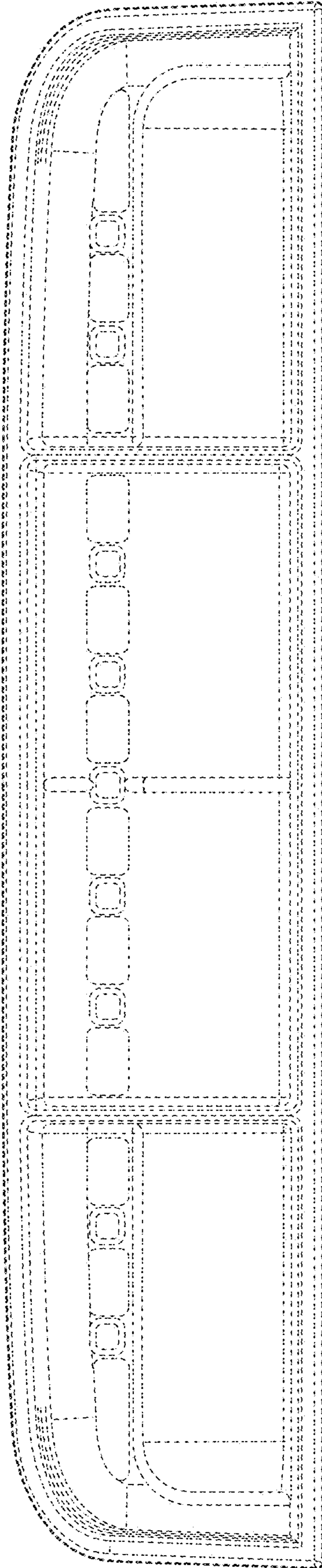
