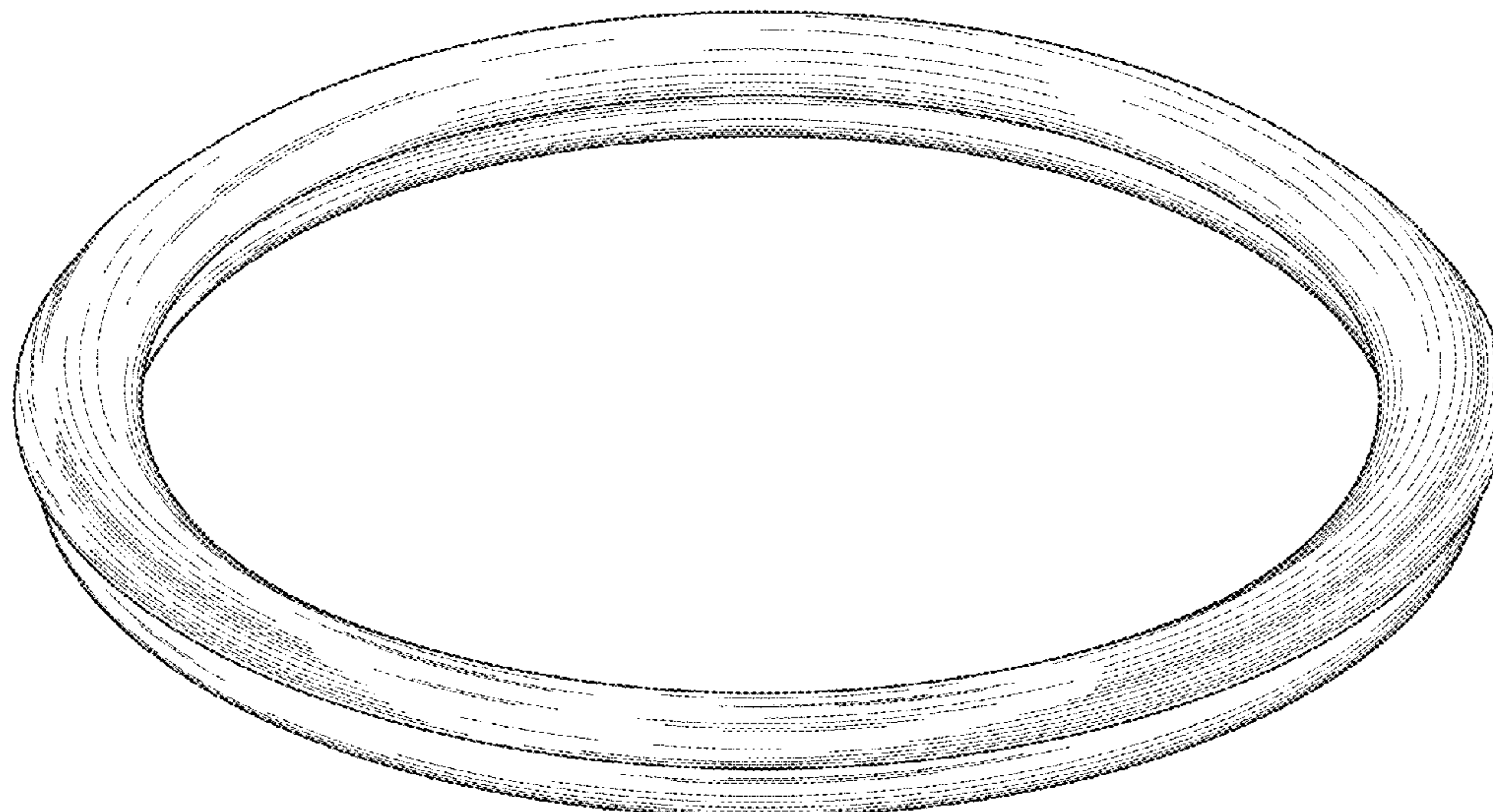
(57) **CLAIM**

The ornamental design for a seal for vacuum gate valve, as shown and described.

DESCRIPTION

1.1 is a perspective view of a seal for vacuum gate valve, showing my new design;
1.2 is a front elevation view thereof;
1.3 is a rear elevation view thereof;
1.4 is a left side elevation view thereof;
1.5 is a right side elevation view thereof;
1.6 is a top view thereof;
1.7 is a bottom view thereof;
1.8 is a cross-sectional view thereof taken along lines **1.8-1.8** shown in Reproduction **1.6**; and
1.9 is an enlarged cross-sectional view of a portion thereof taken from area **1.9** shown in Reproduction **1.8**.

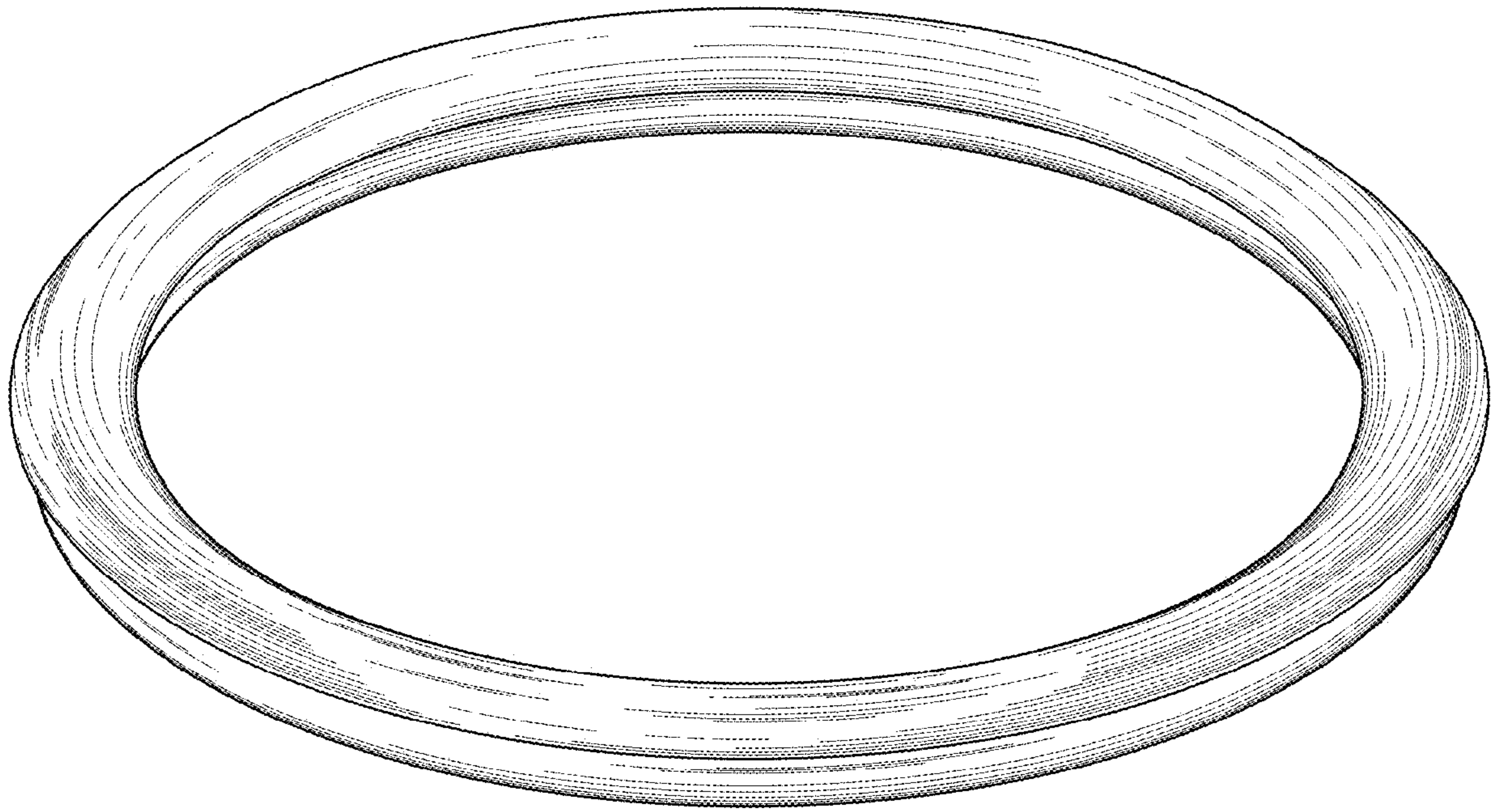

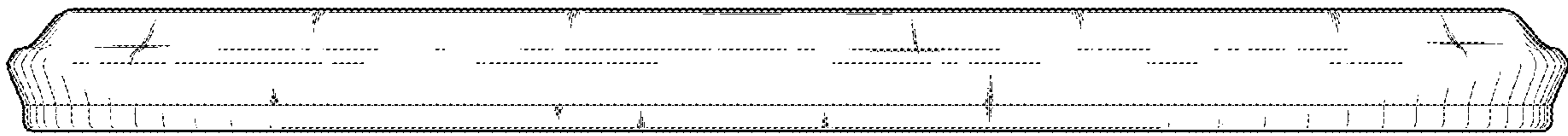

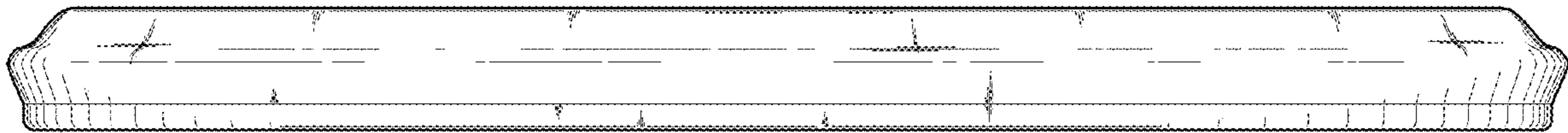

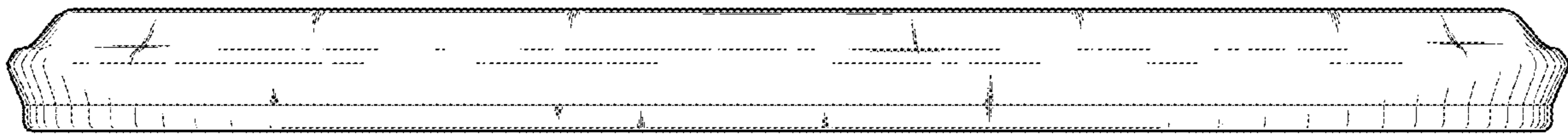

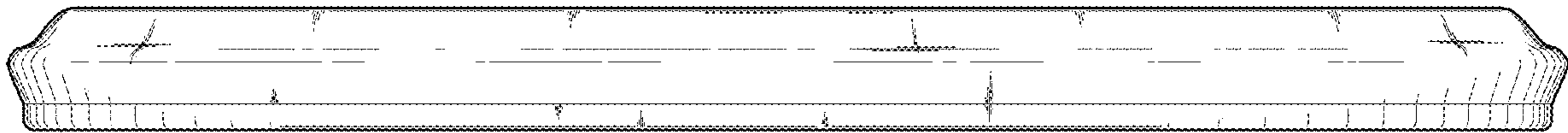

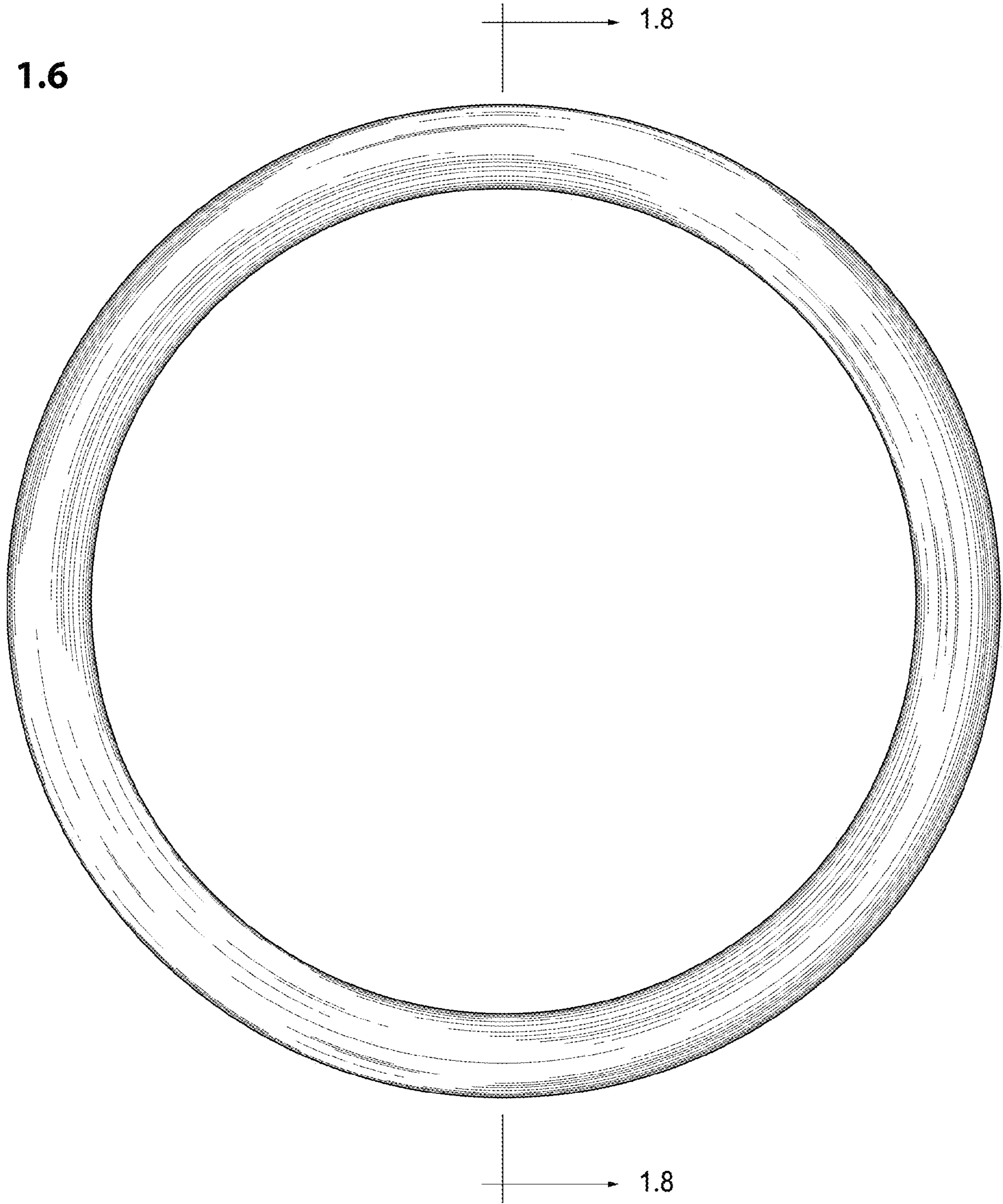
