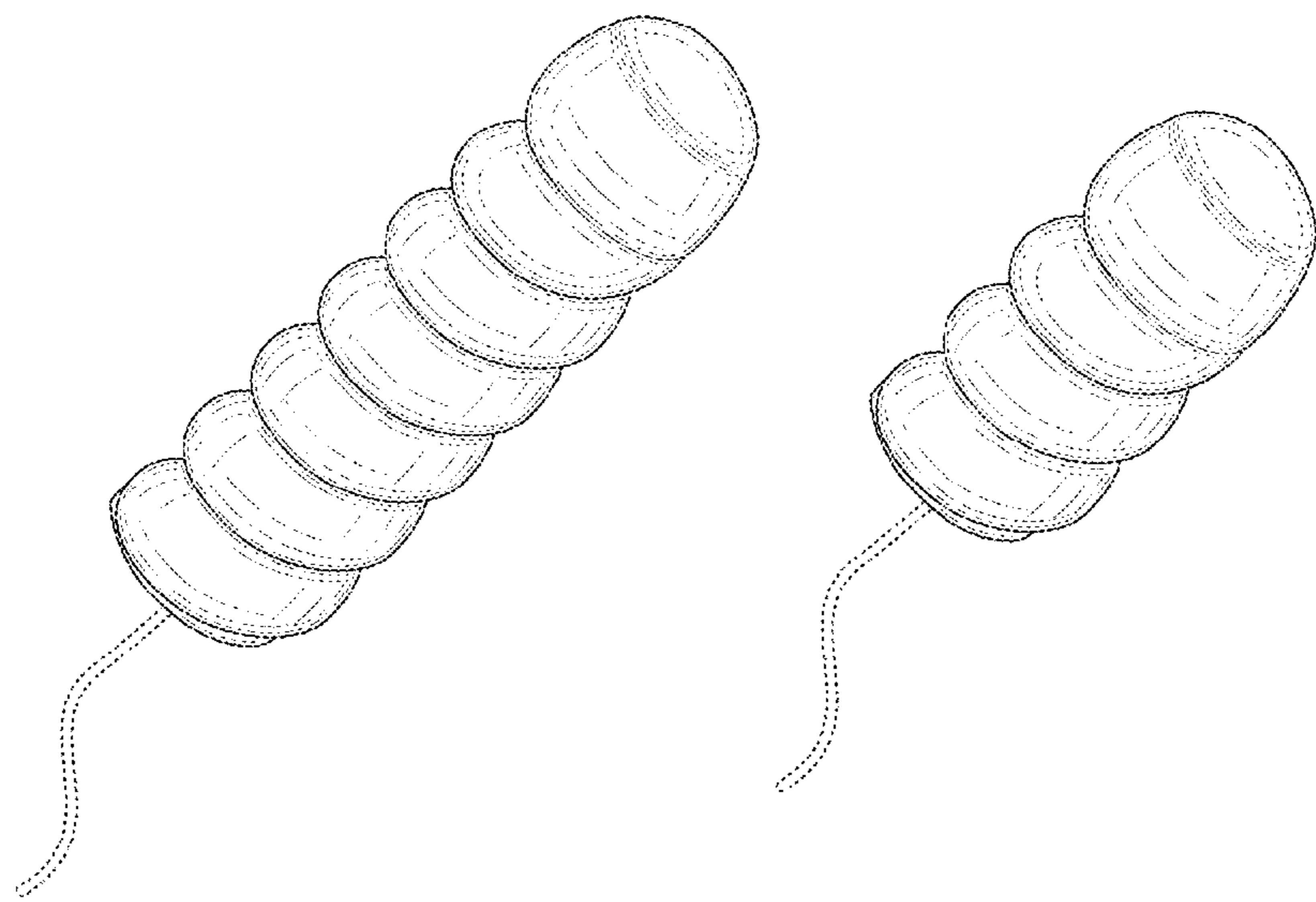
(57) **CLAIM**

The ornamental design for a feminine hygiene product, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of one embodiment of a feminine hygiene product showing our new design. FIG. 2 is a front planar view thereof. FIG. 3 is a rear planar view thereof. FIG. 4 is a right planar view thereof. FIG. 5 is a left planar view thereof. FIG. 6 is a top planar view thereof. FIG. 7 is a bottom planar view thereof. FIG. 8 is a perspective view of a second embodiment of a feminine hygiene product showing our new design. FIG. 9 is a perspective view of a third embodiment of a feminine hygiene product showing our new design. FIG. 10 is a perspective view of a fourth embodiment of a feminine hygiene product showing our new design; and, FIG. 11 is a perspective view of a fifth embodiment of a feminine hygiene product showing our new design. Embodiments 2, 3, 4, and 5 are understood to be identical to Embodiment 1 except in the number of spirals. Any unseen views in Embodiments 2 through 5 are understood to be identical to the corresponding views in FIGS. 1 through 7, other than the number of spirals. Any broken lines are for environmental purposes only and form no part of the claimed design.

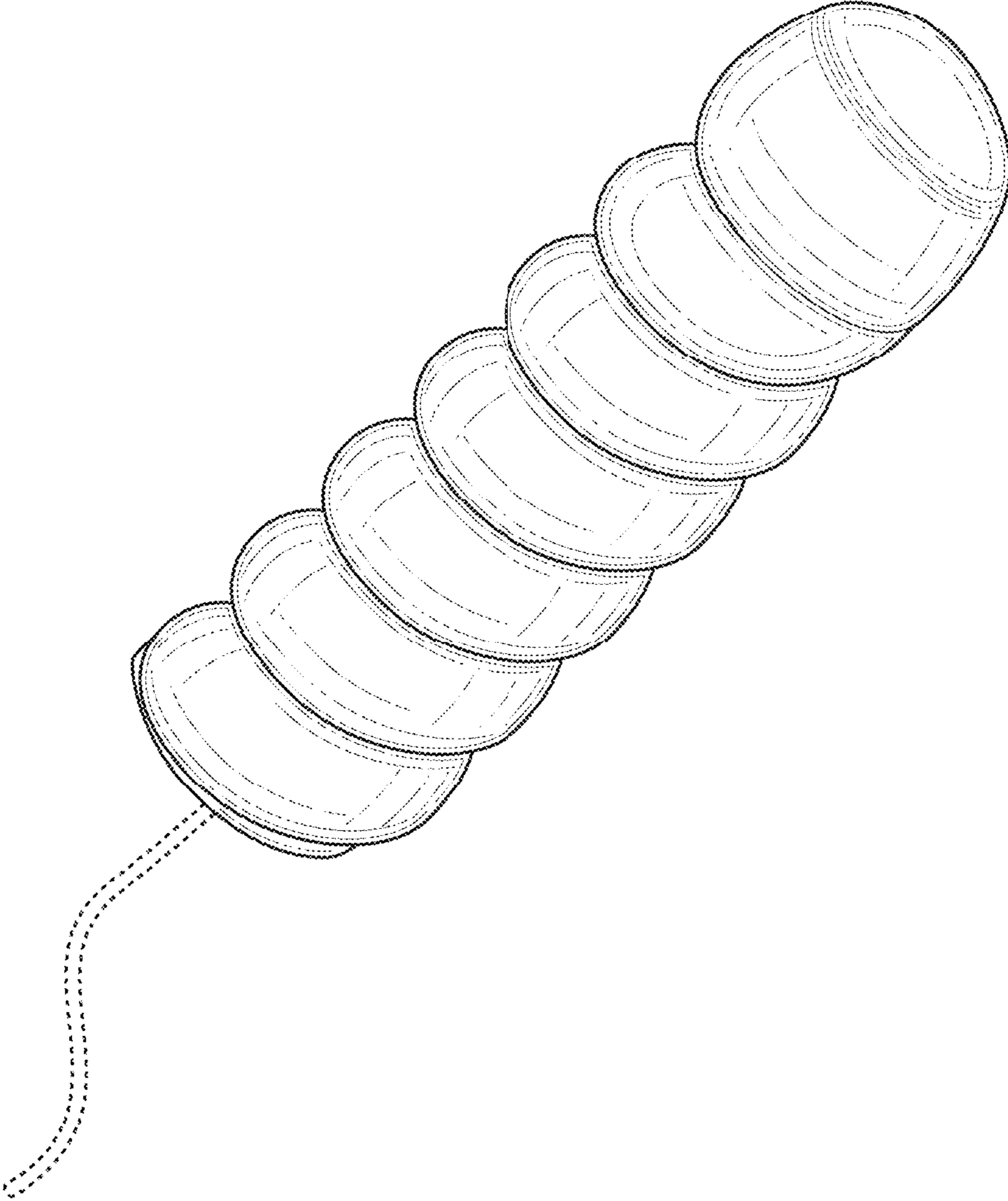

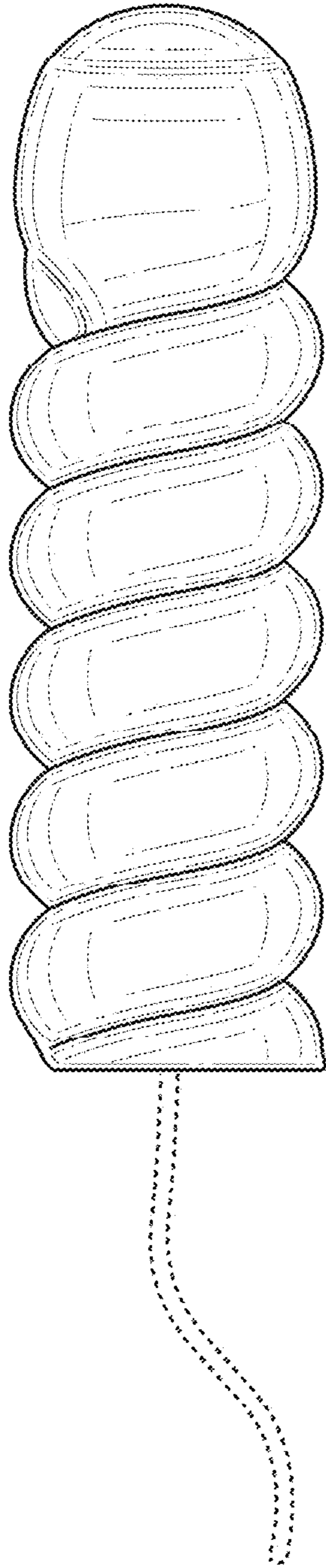

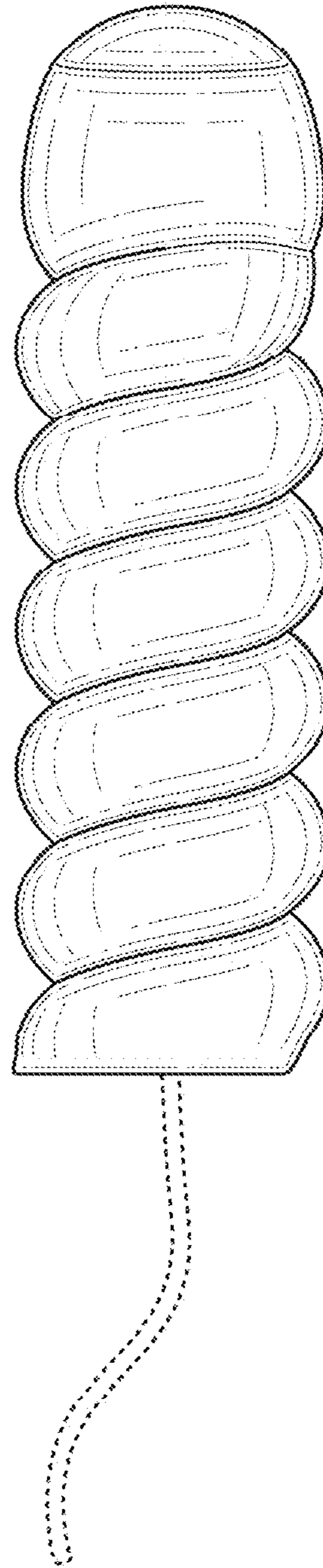

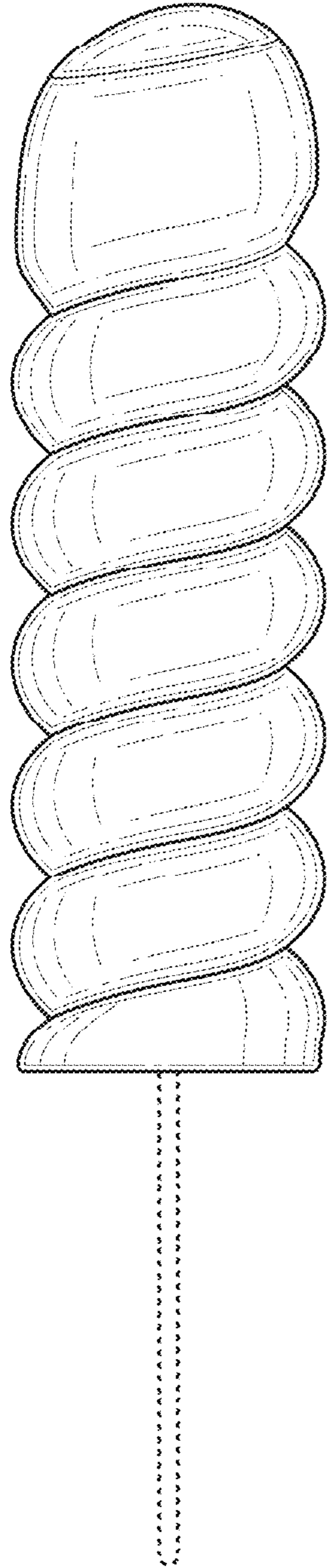

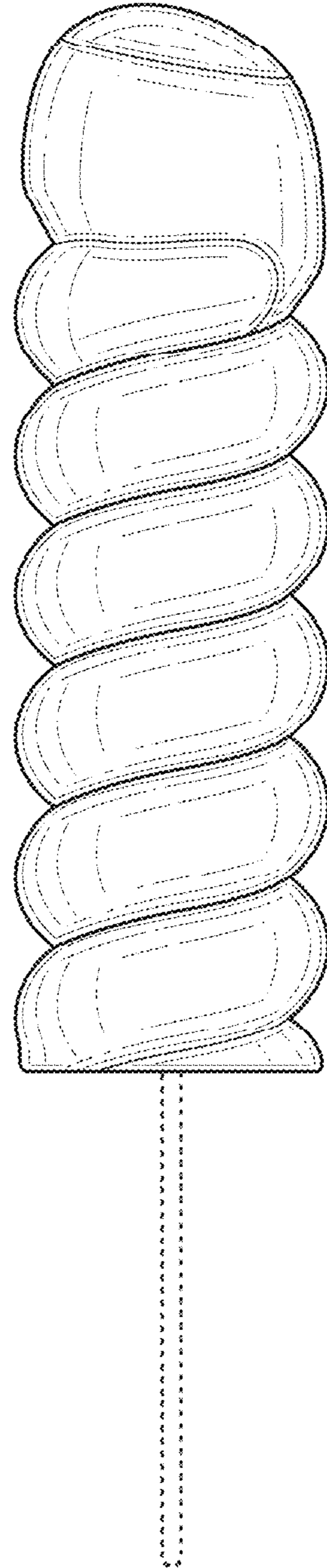

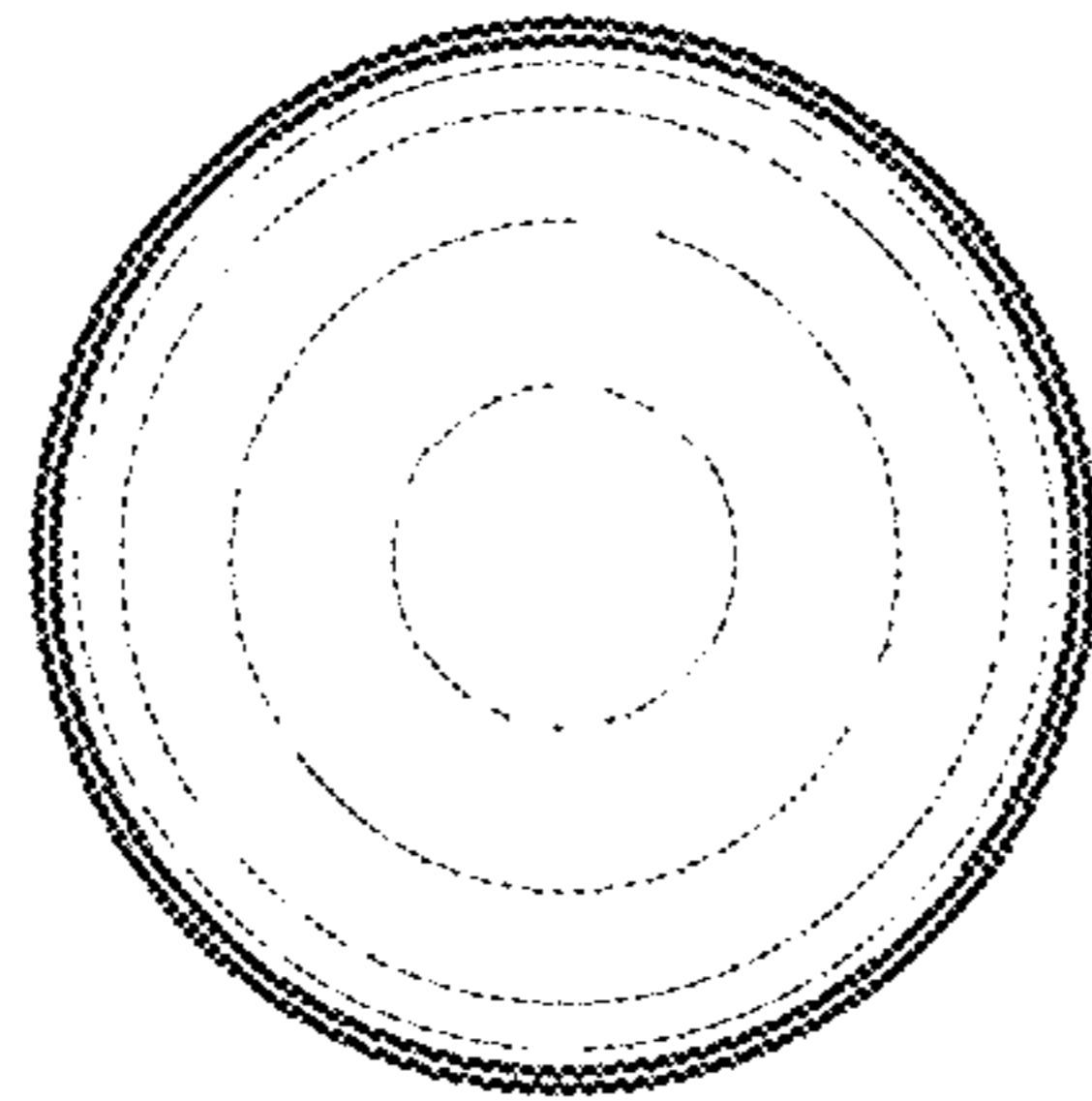

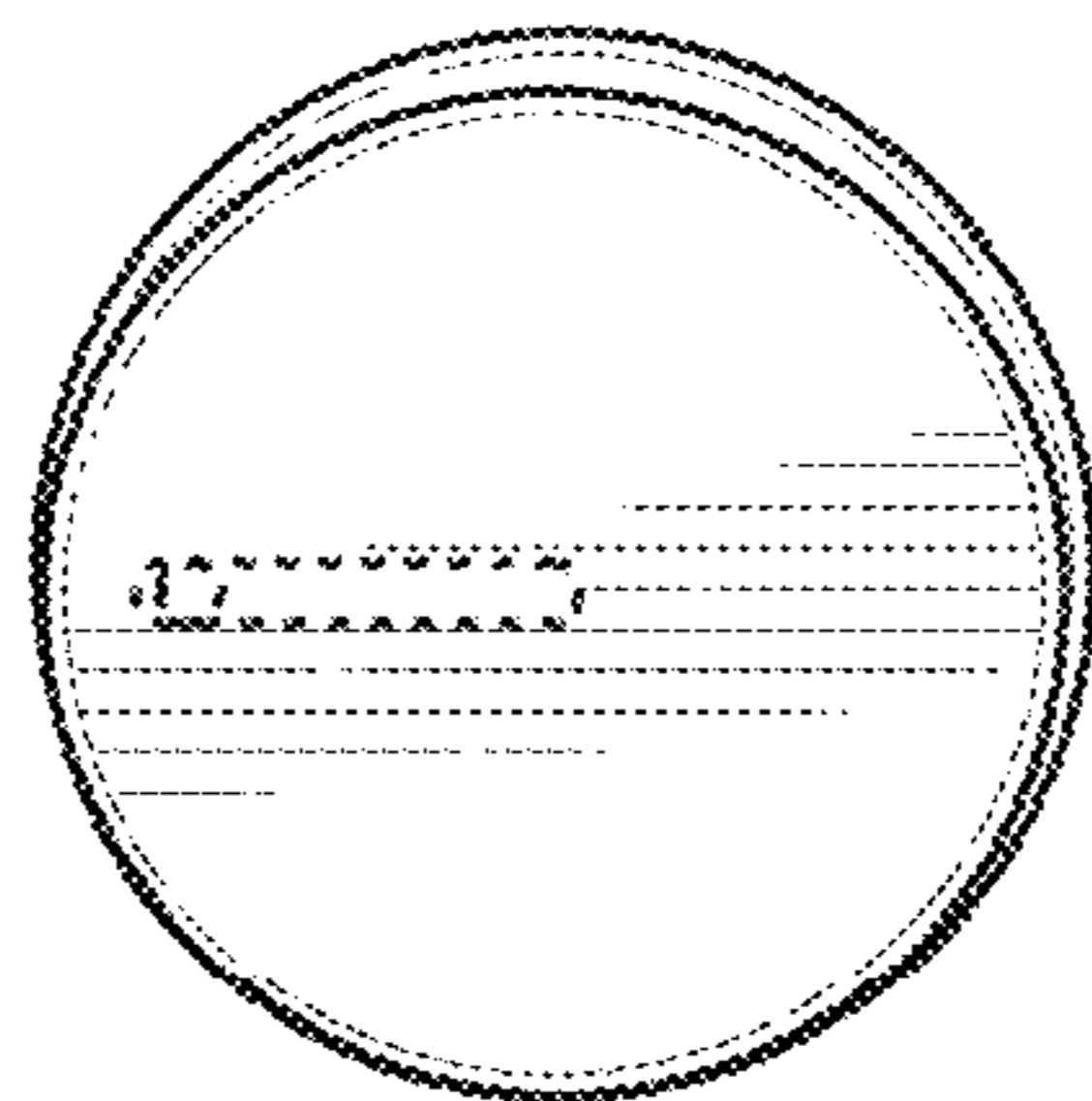

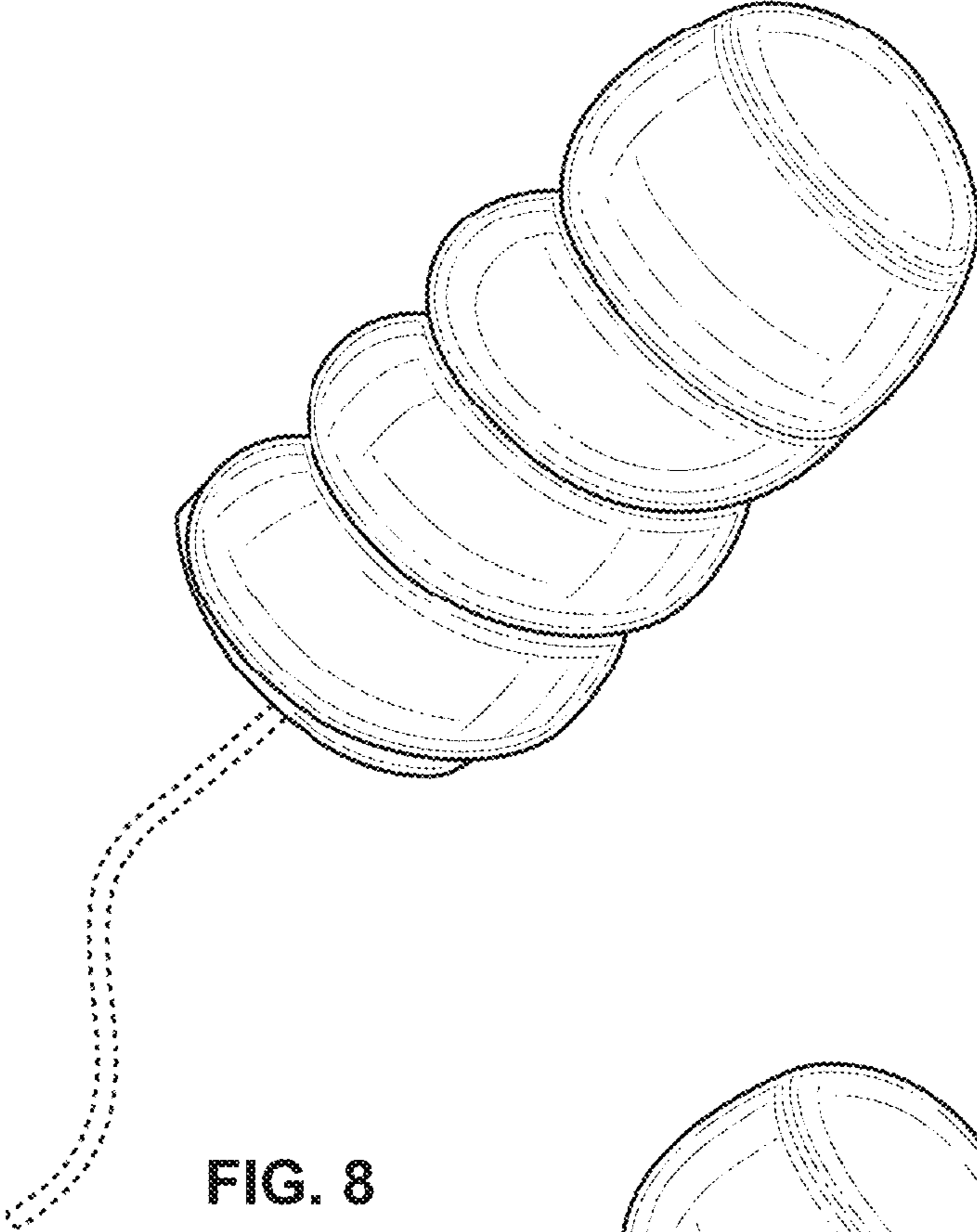

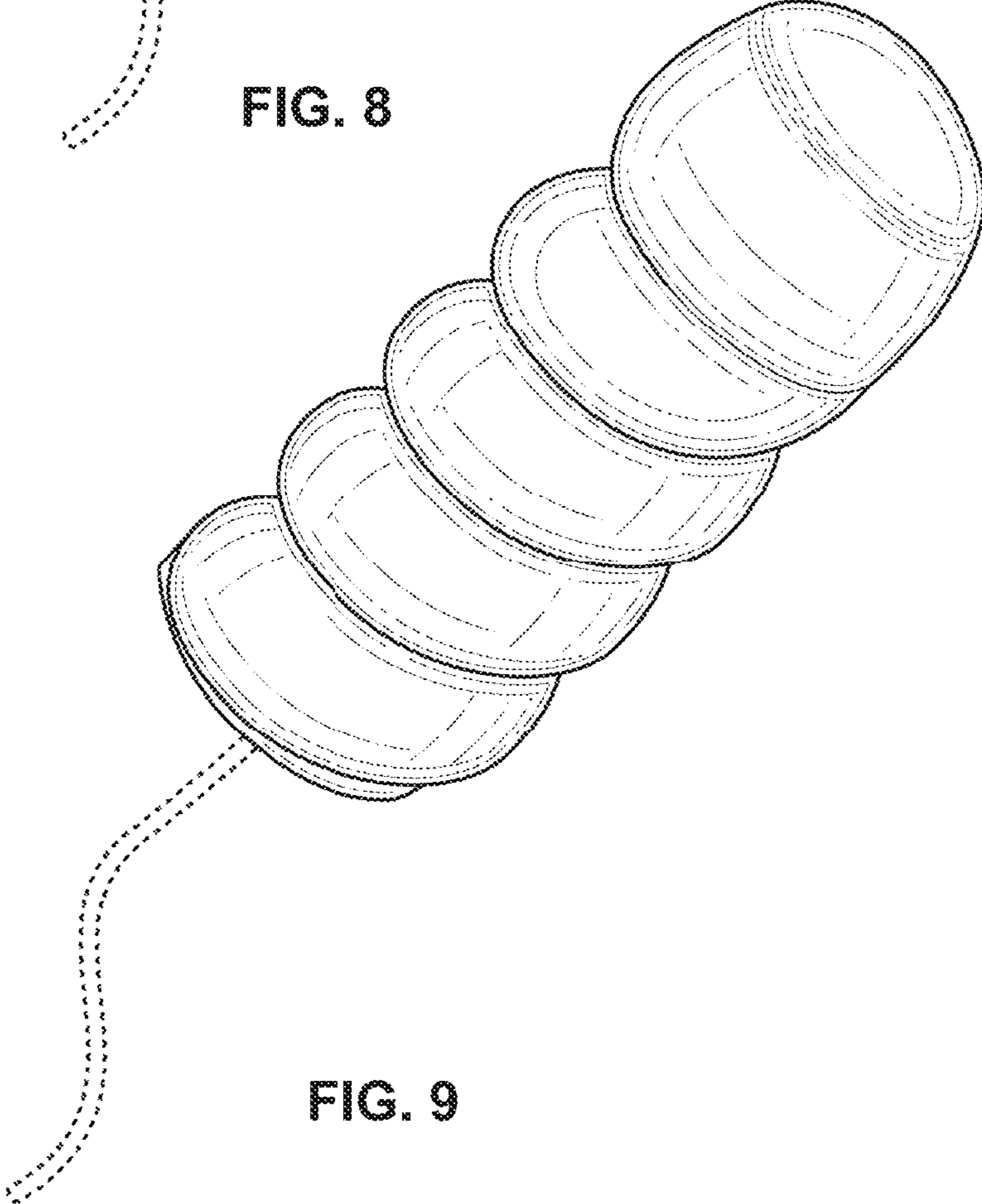

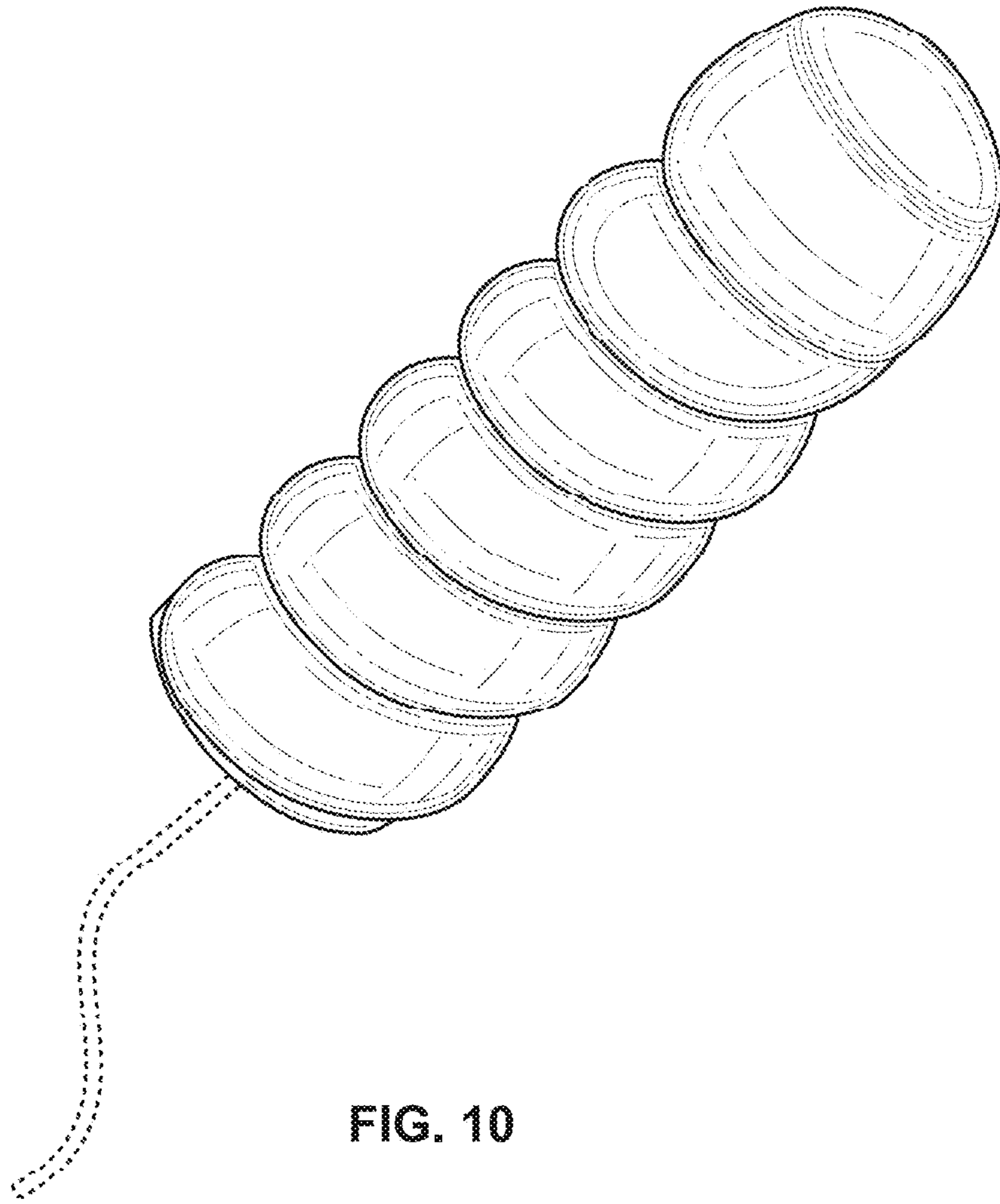

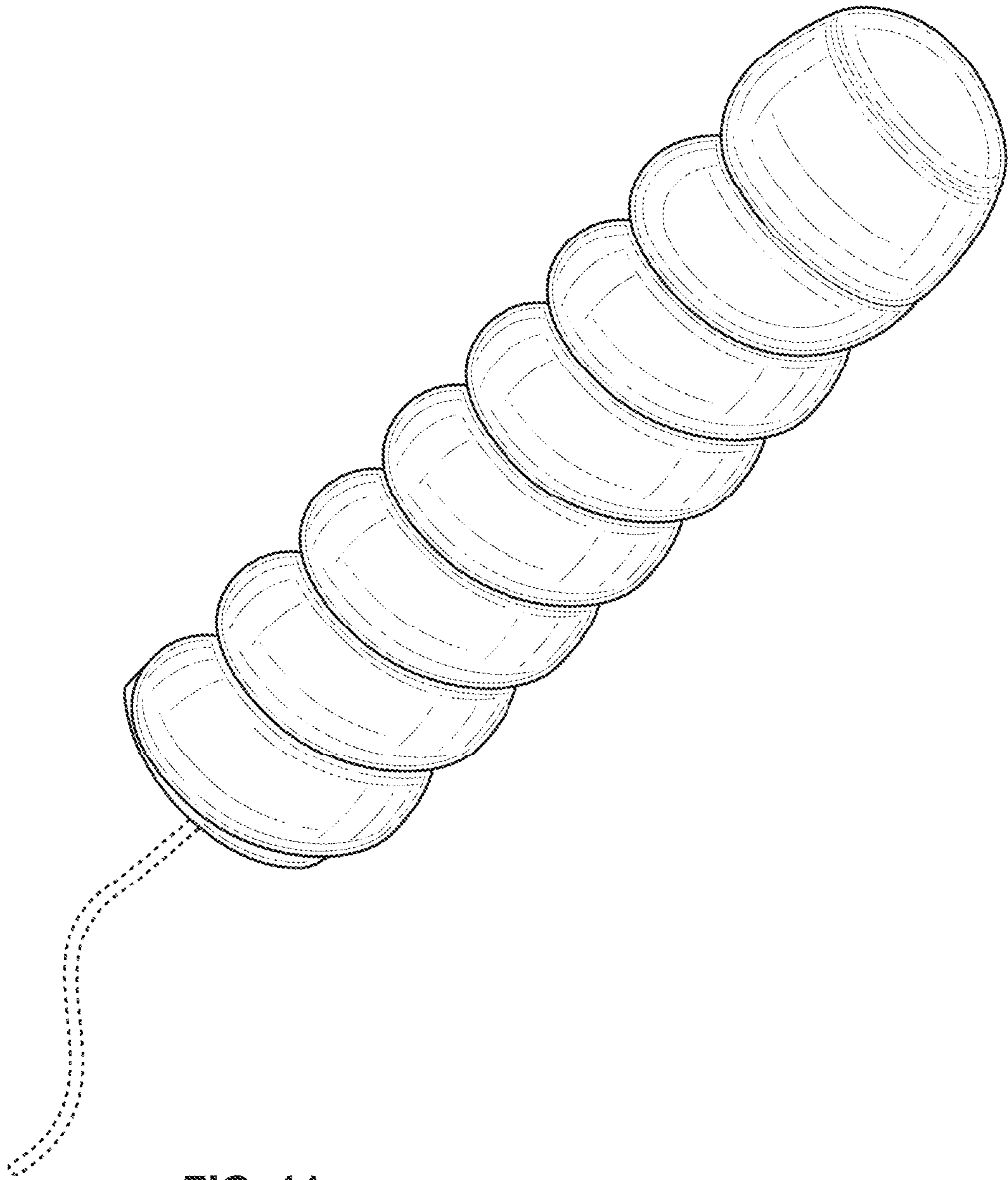
