DESCRIPTION

FIG. 4 is a bottom view of the roof shingle of FIG. 1.

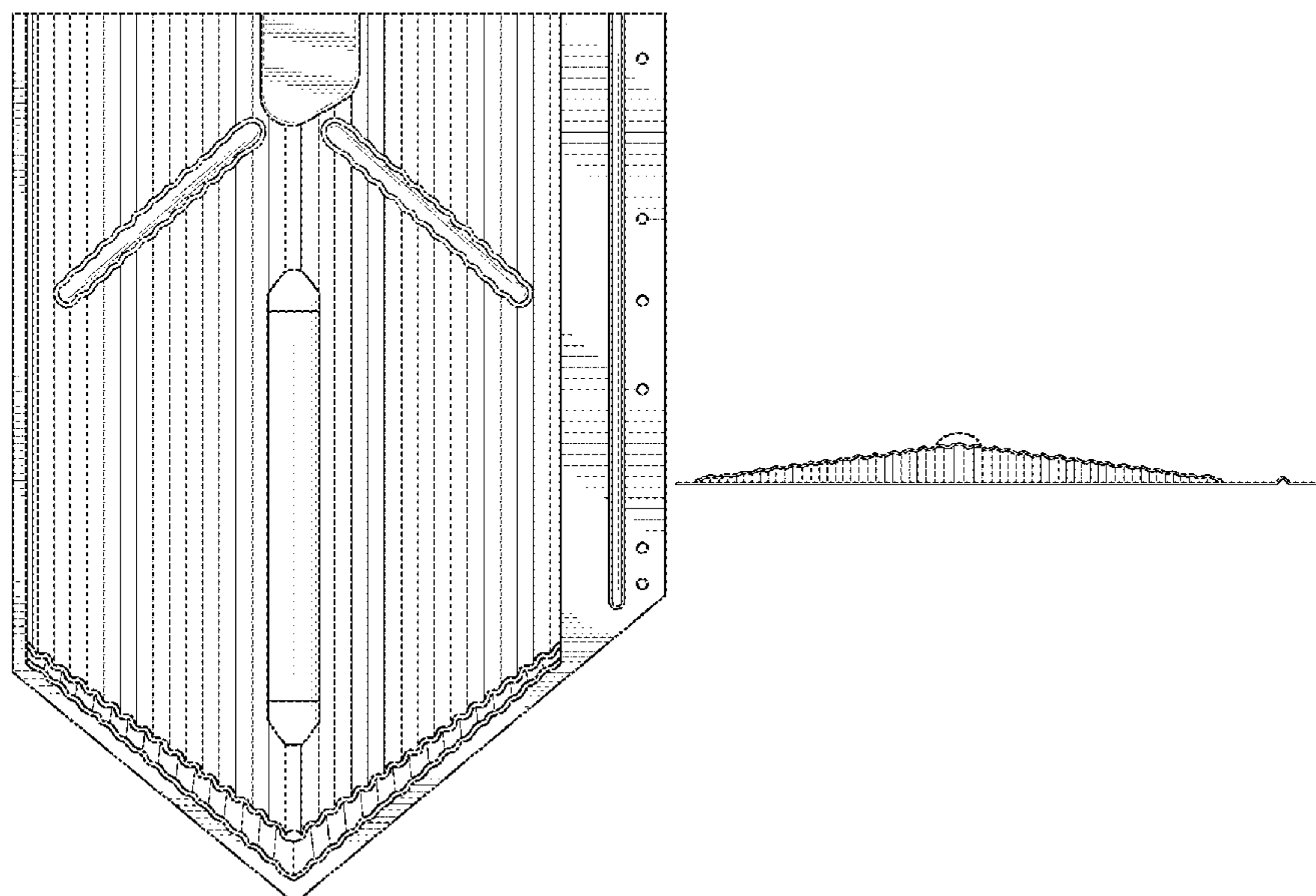
FIG. 5 is a top view of the roof shingle of FIG. 1 showing my new design with an s-bend.

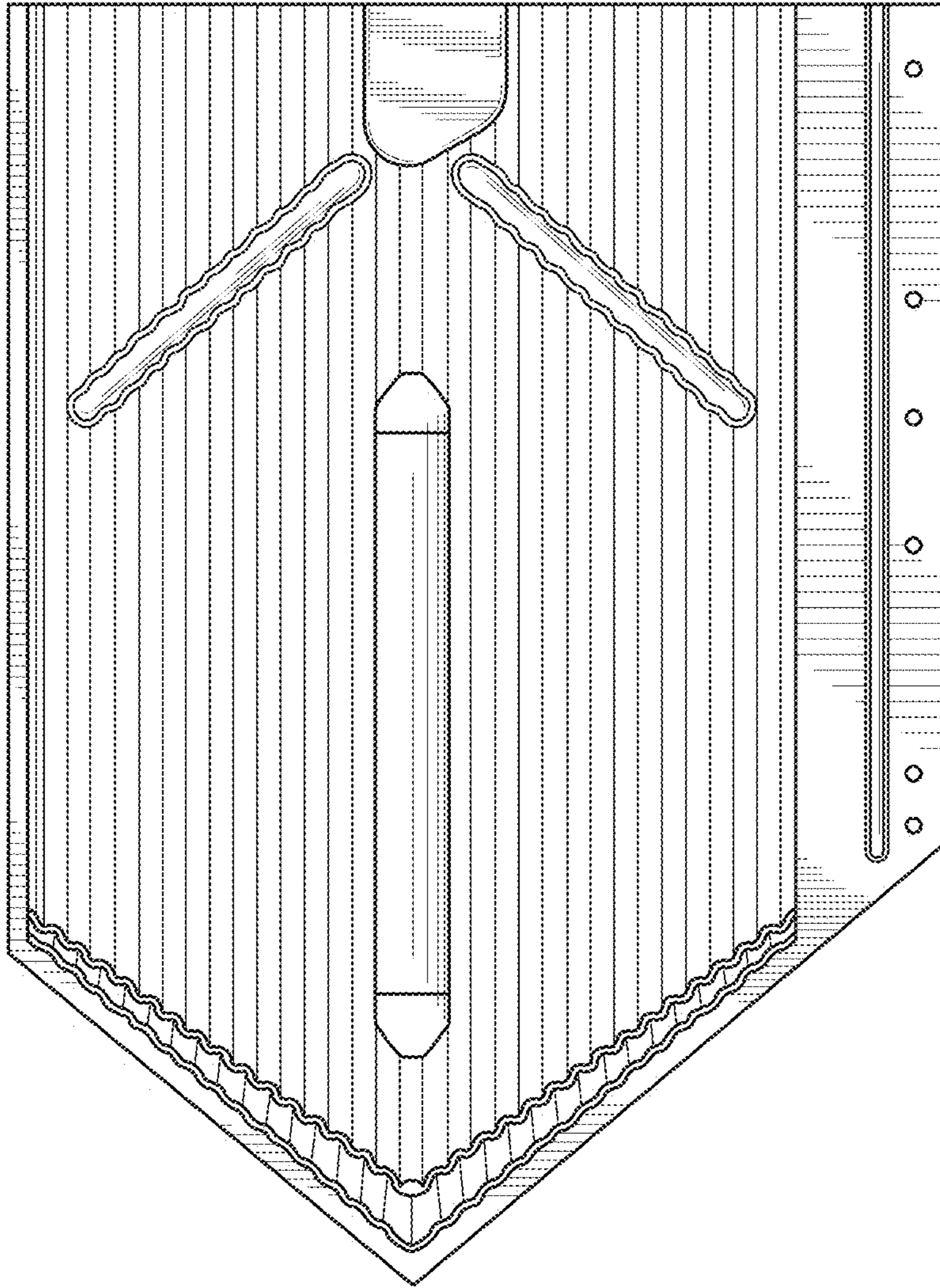

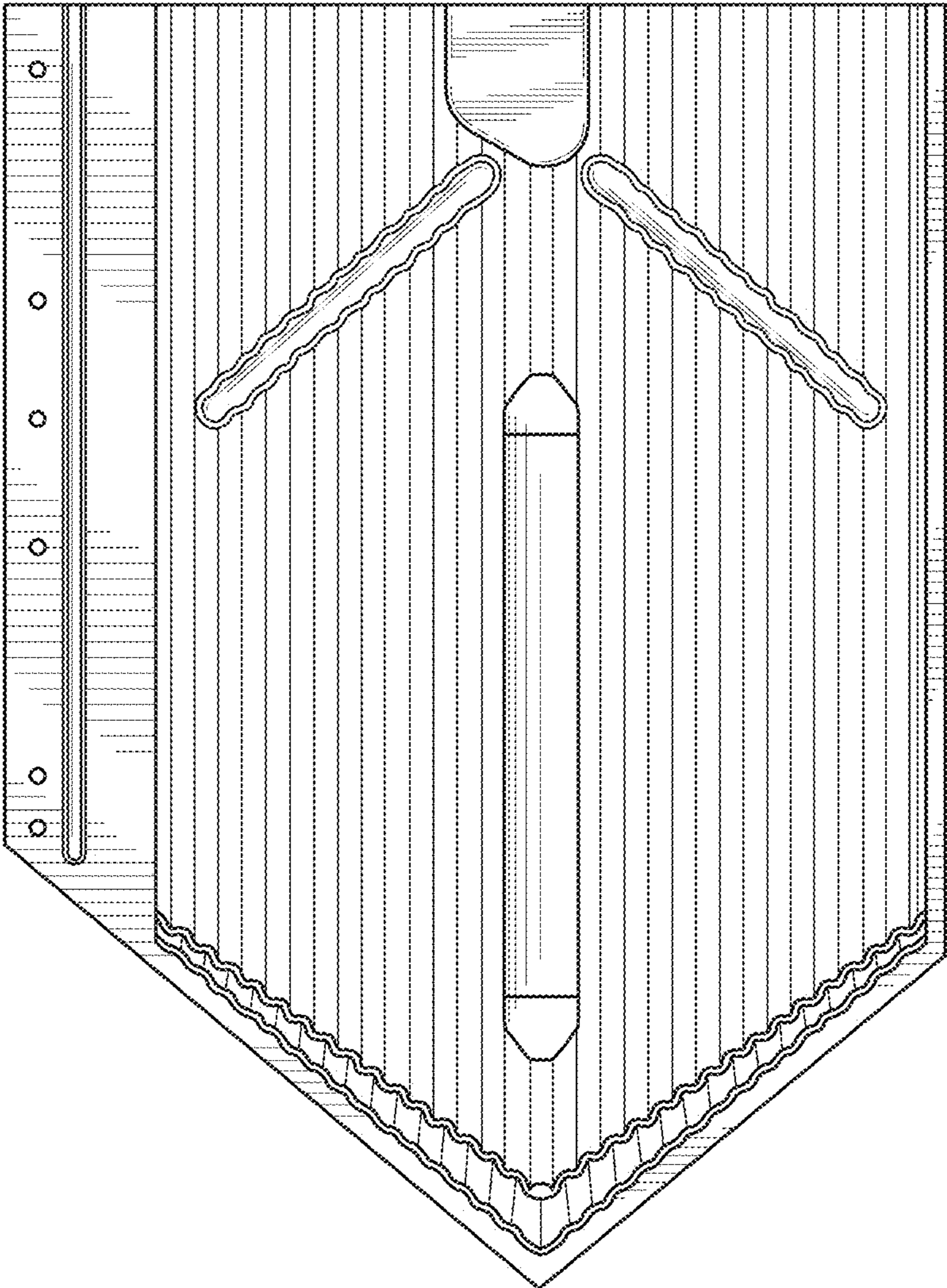

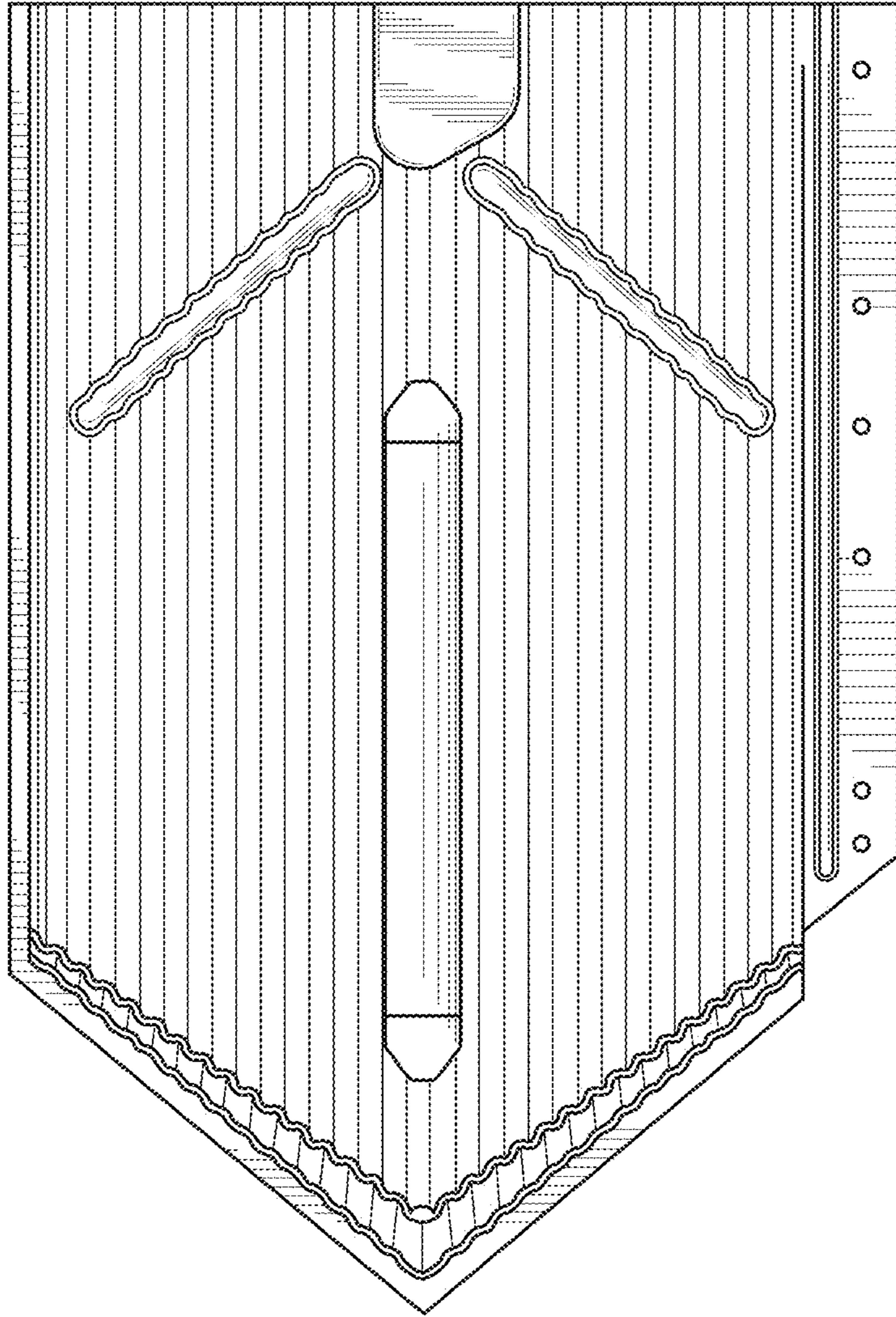

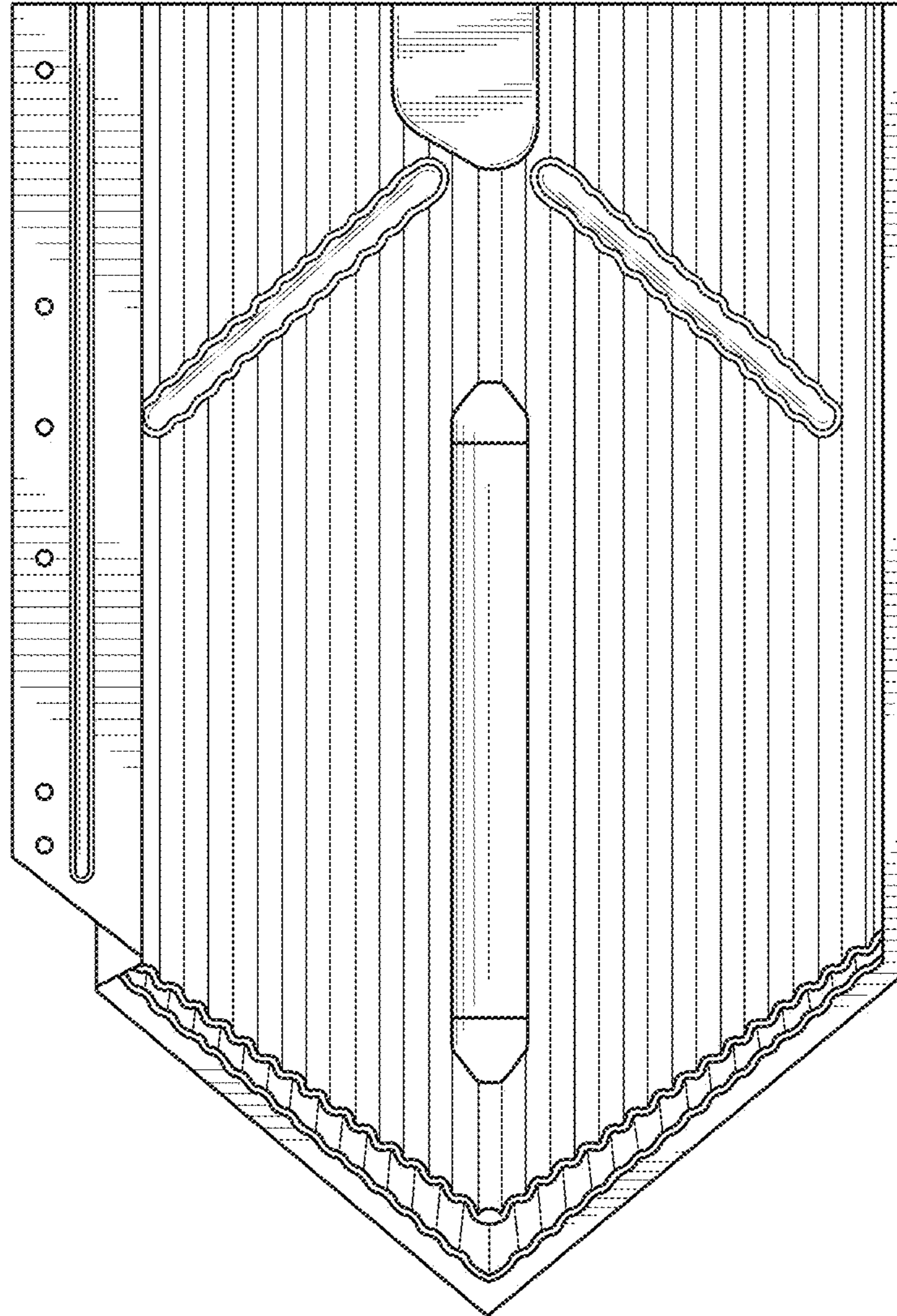
