DESCRIPTION

FIG. 1 is a perspective view of a motorcycle lamp, showing my new design;

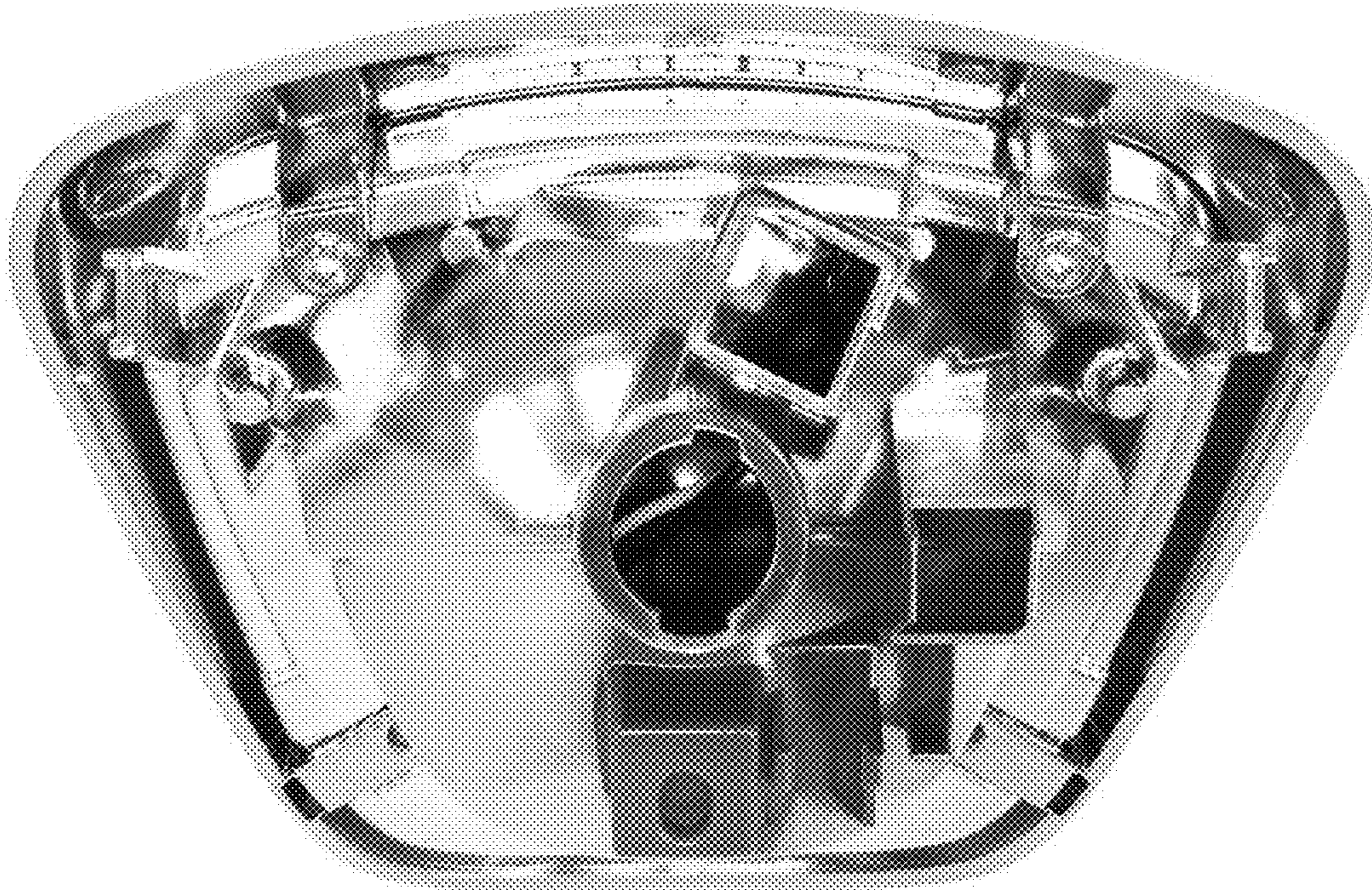

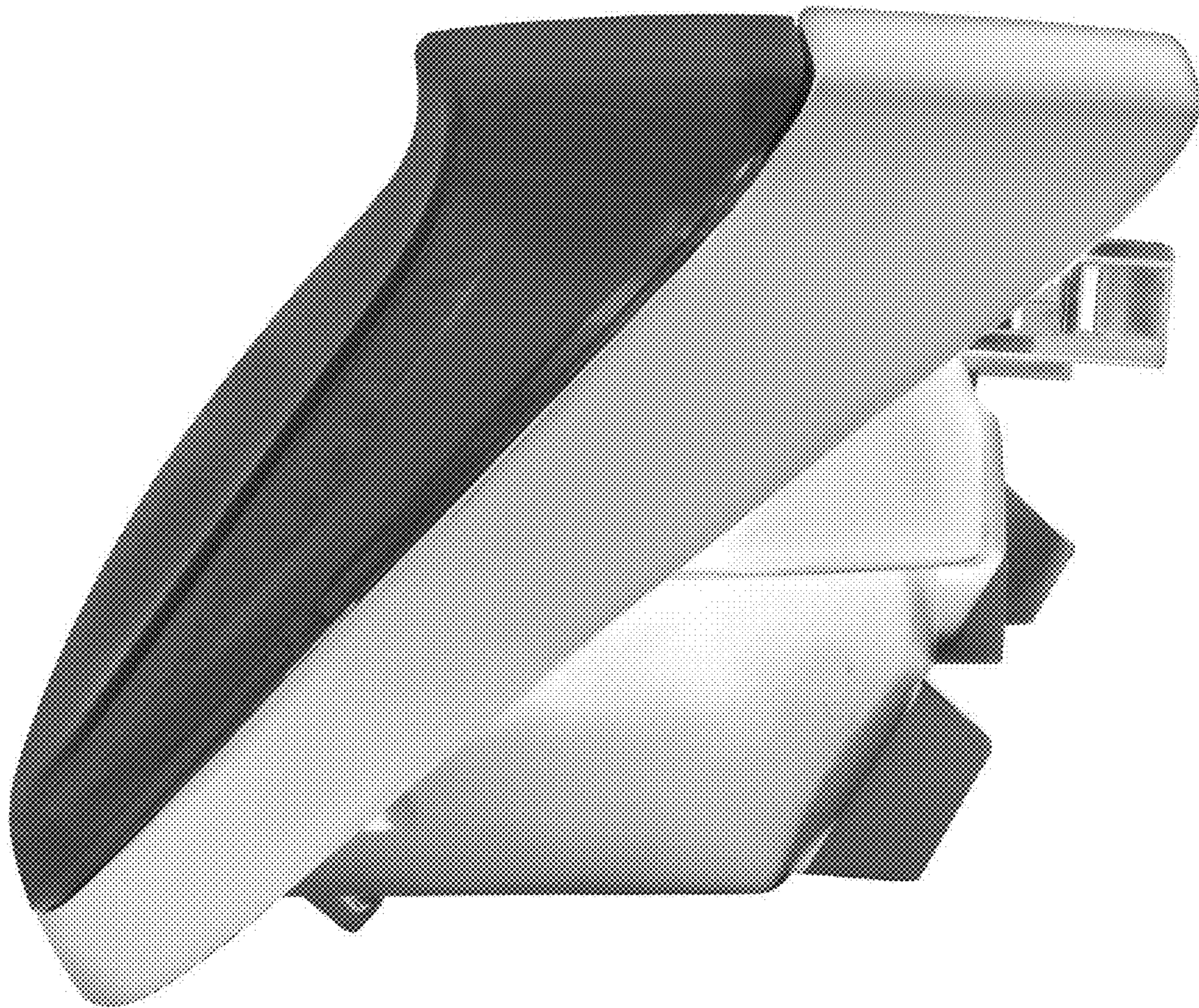

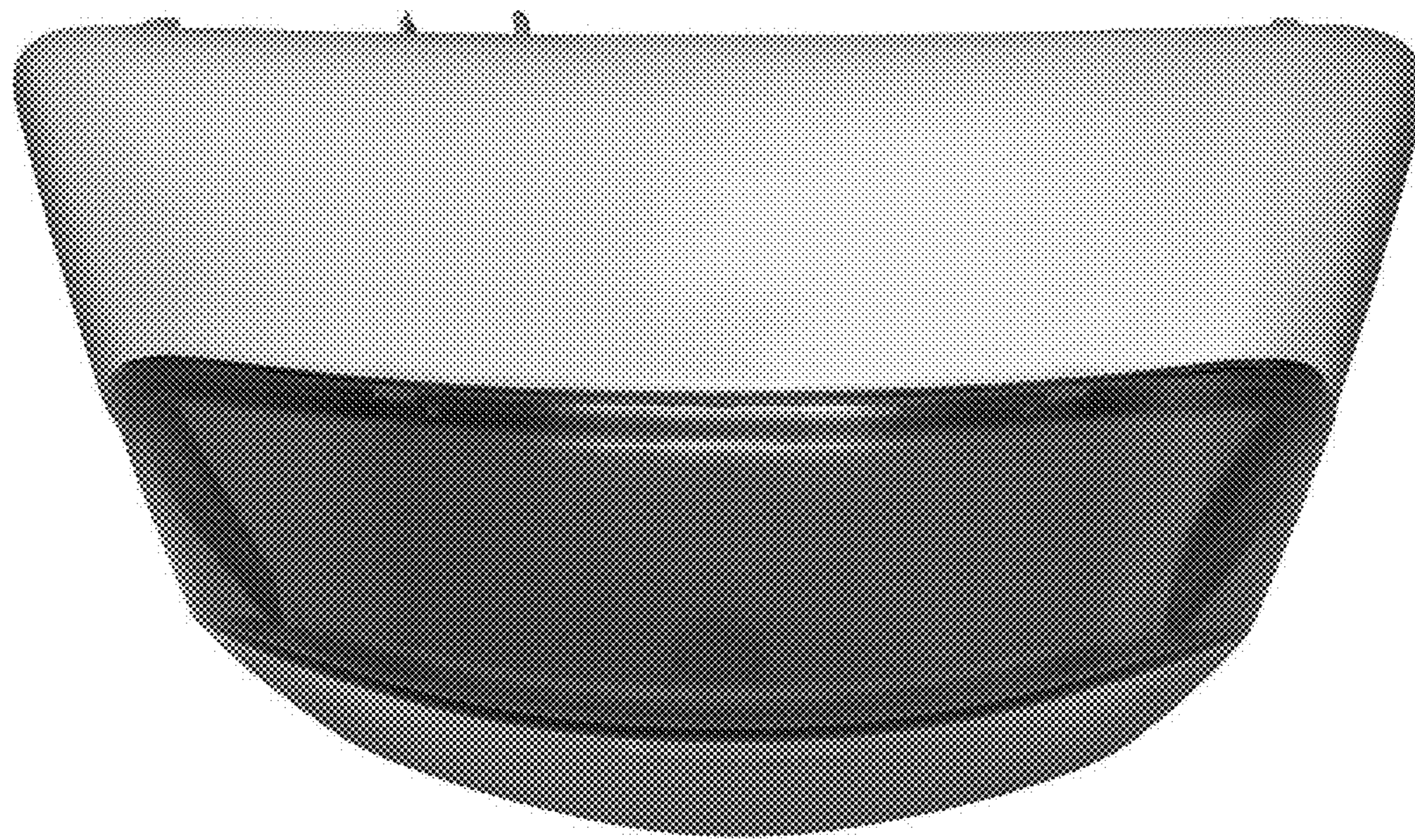

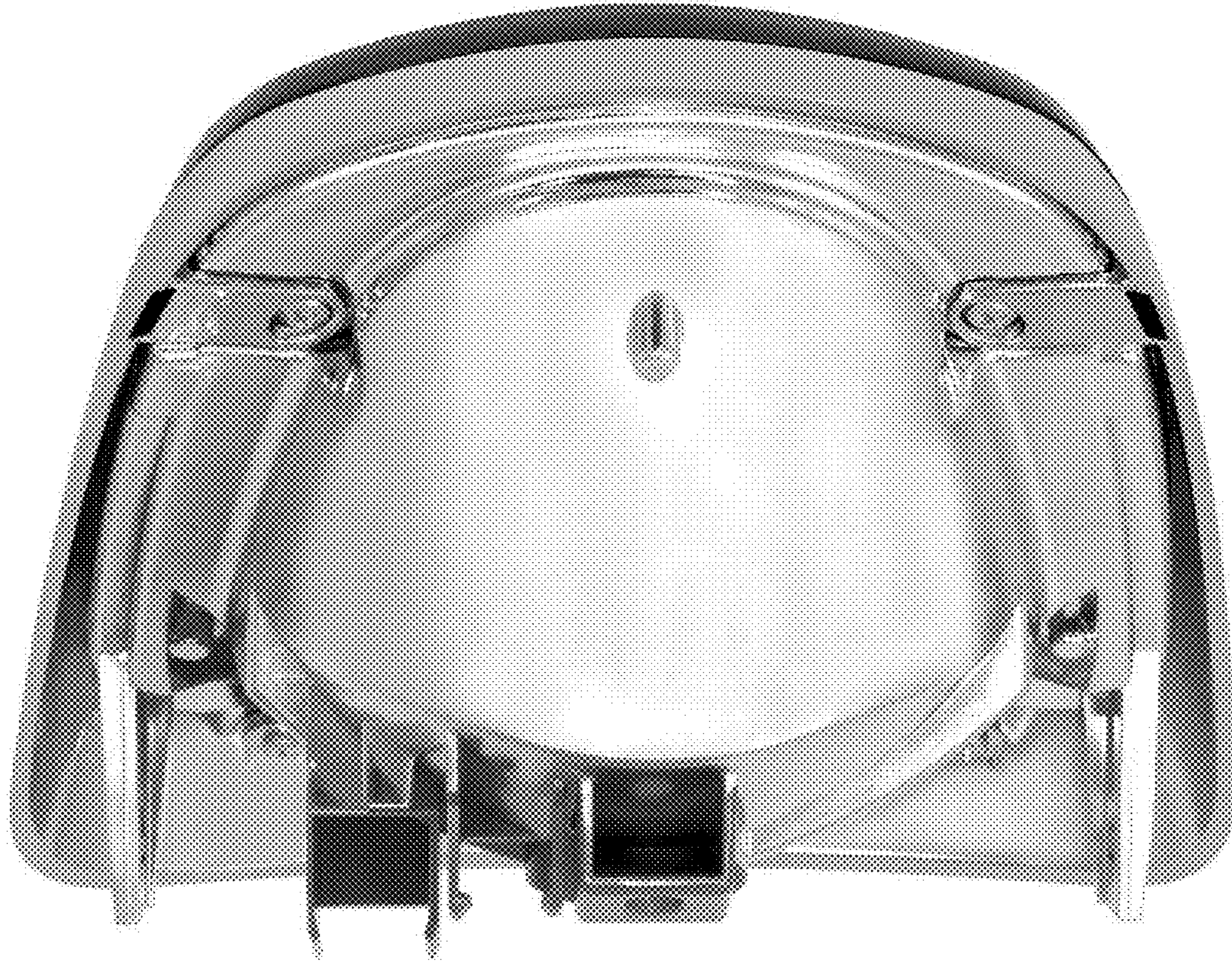
