DESCRIPTION

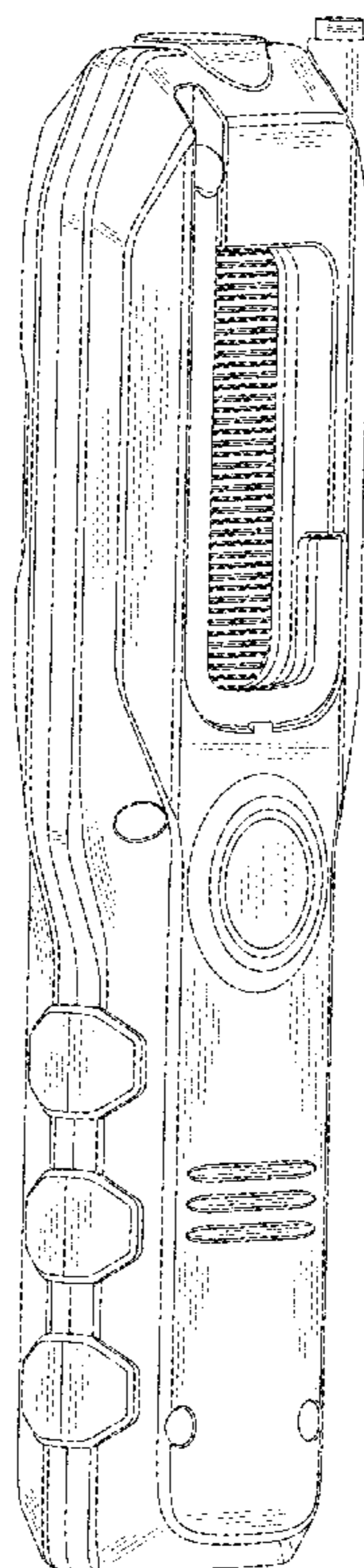
FIG. 1 is a front, left and top perspective view of a work light showing my new design;

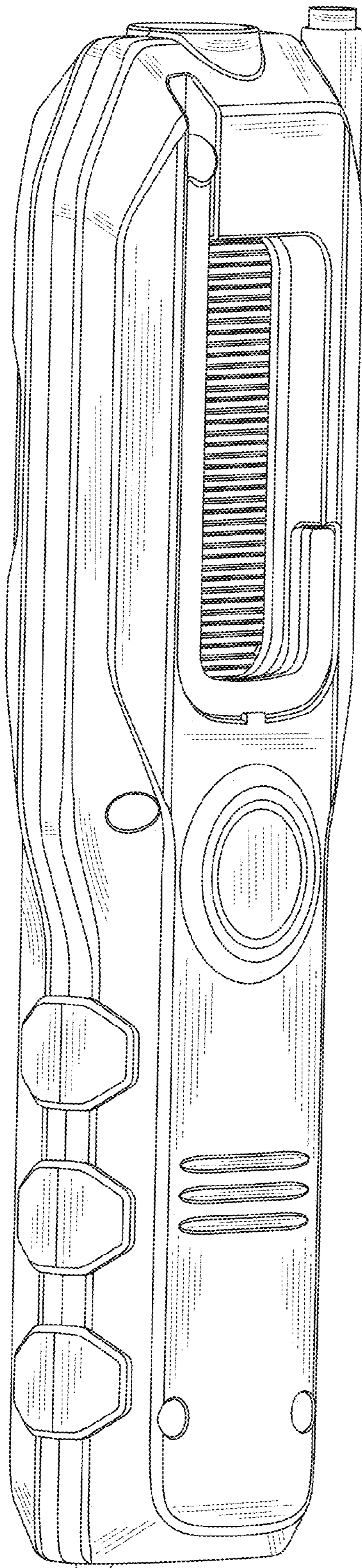

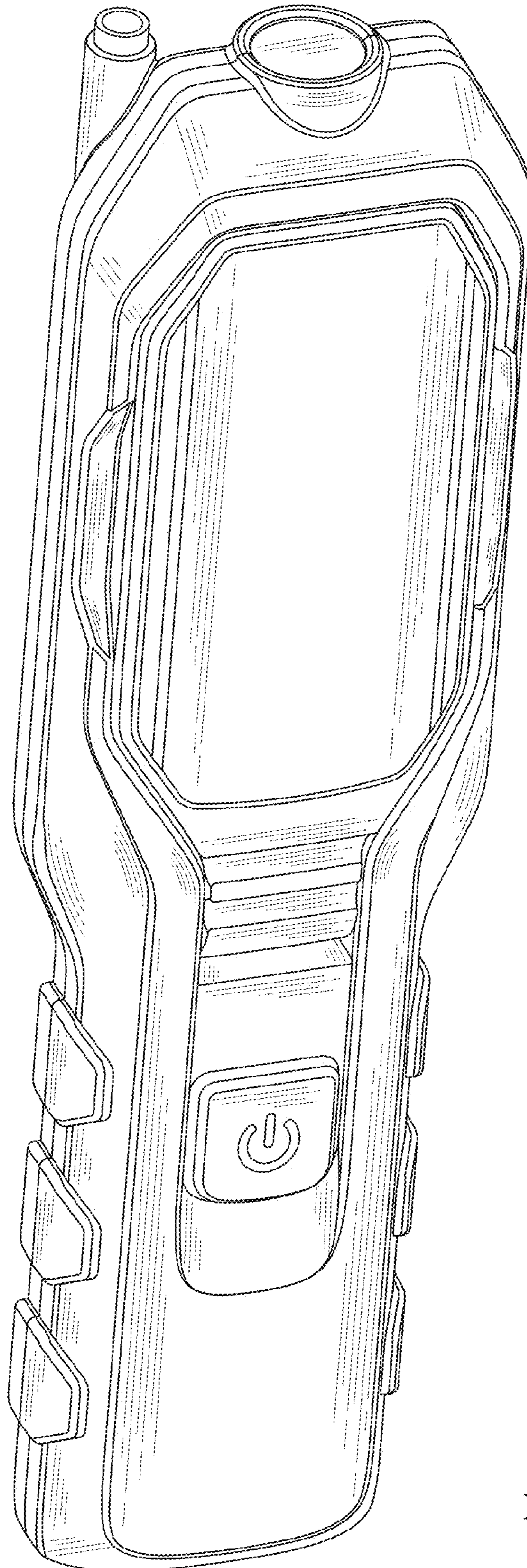

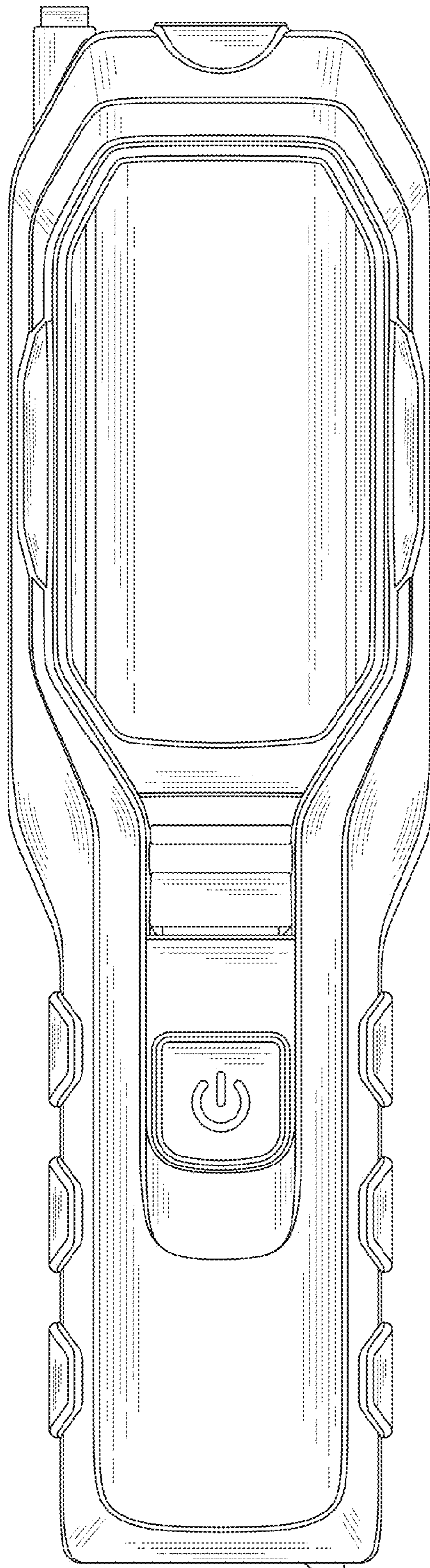

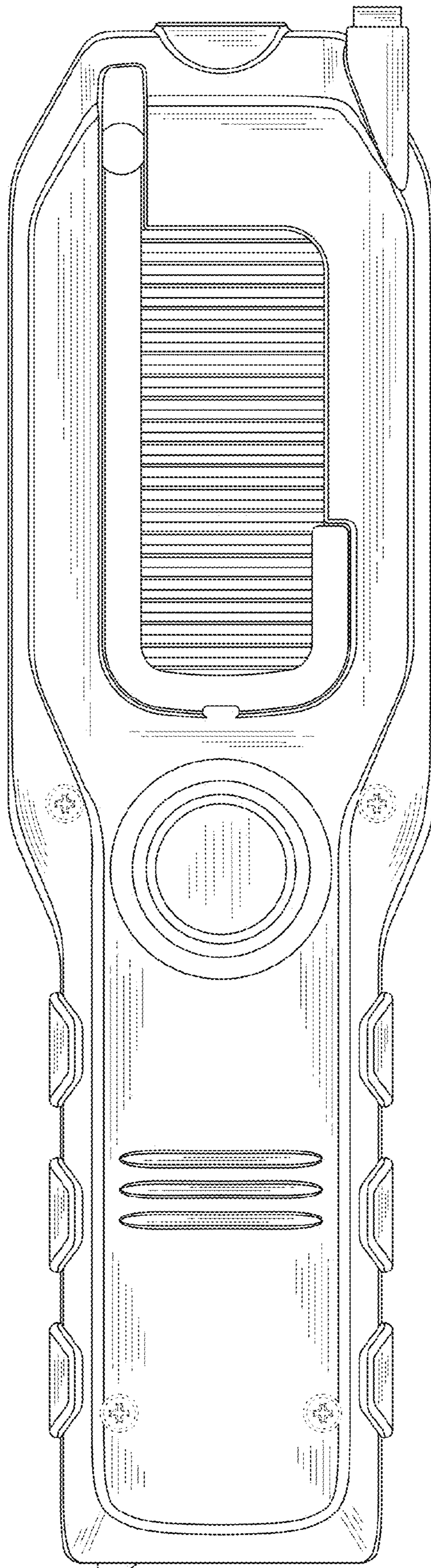

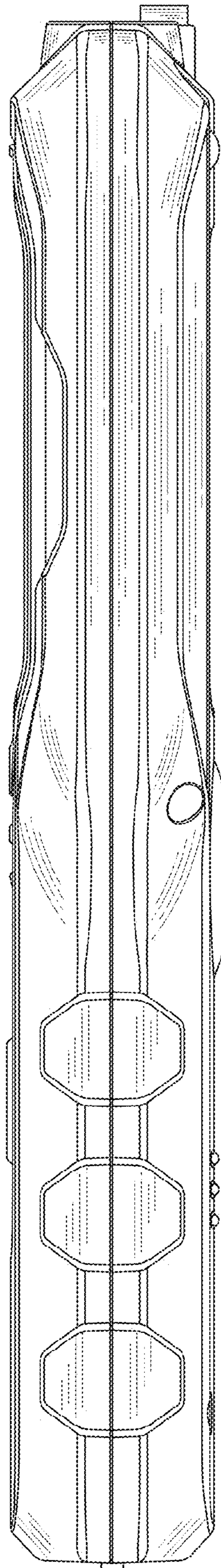

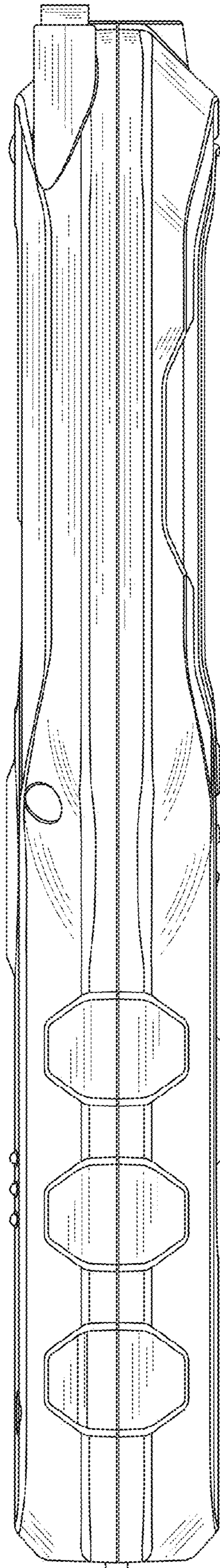

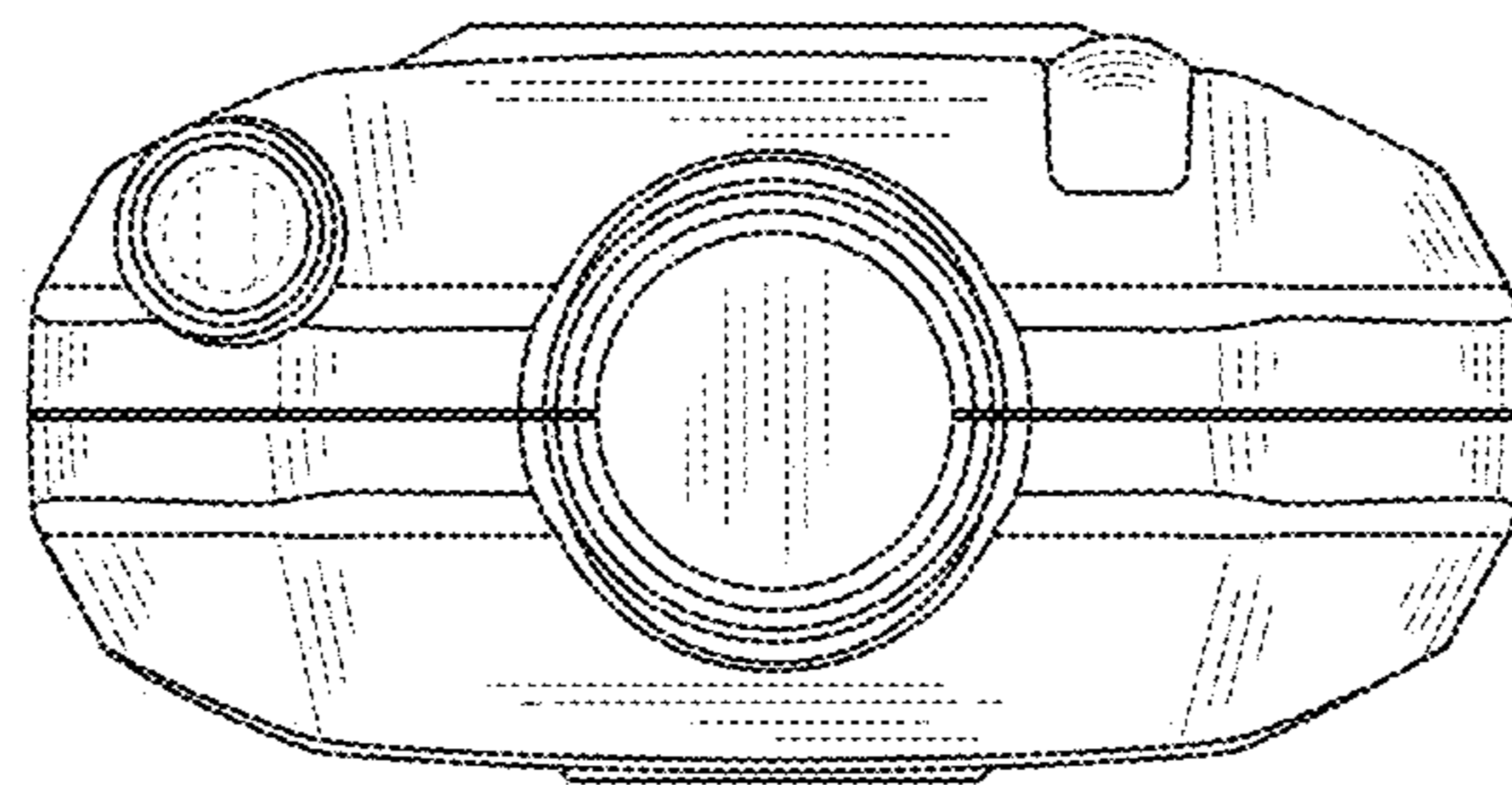

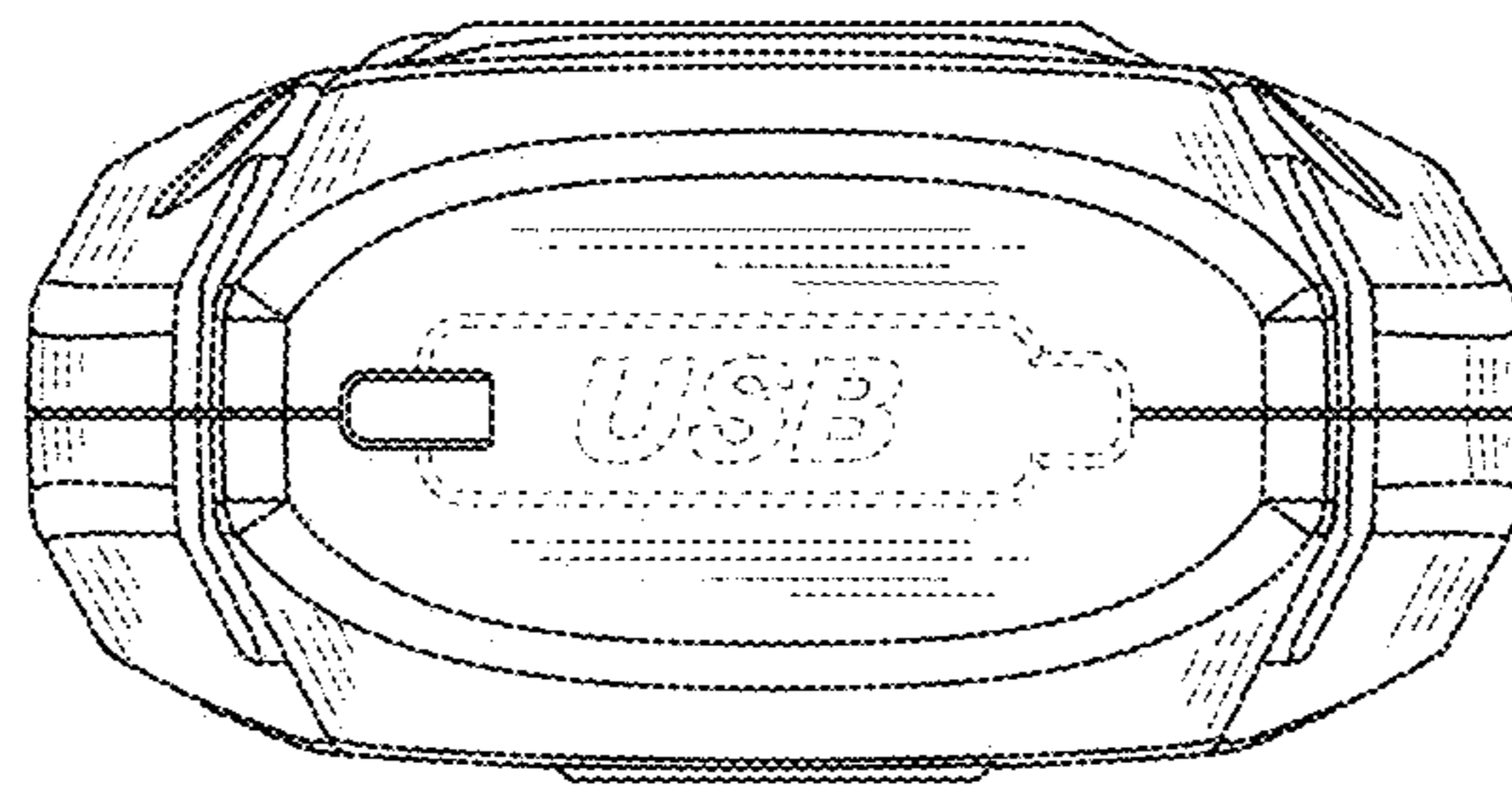
