FIG. 4 is a left side elevational view of the drawstring scrunchie of FIG. 1;

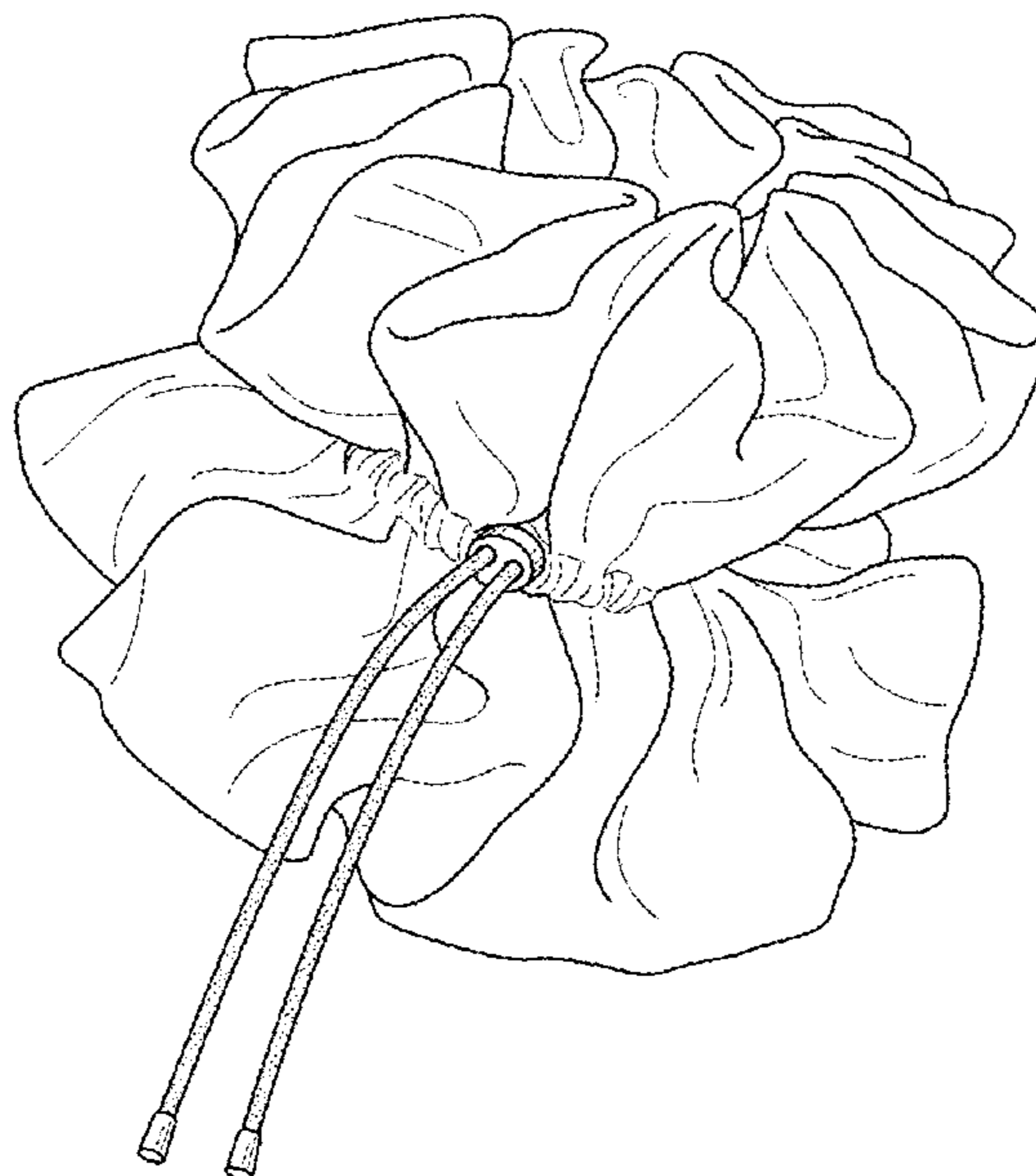
FIG. 5 is a right side elevational view of the drawstring scrunchie of FIG. 1;

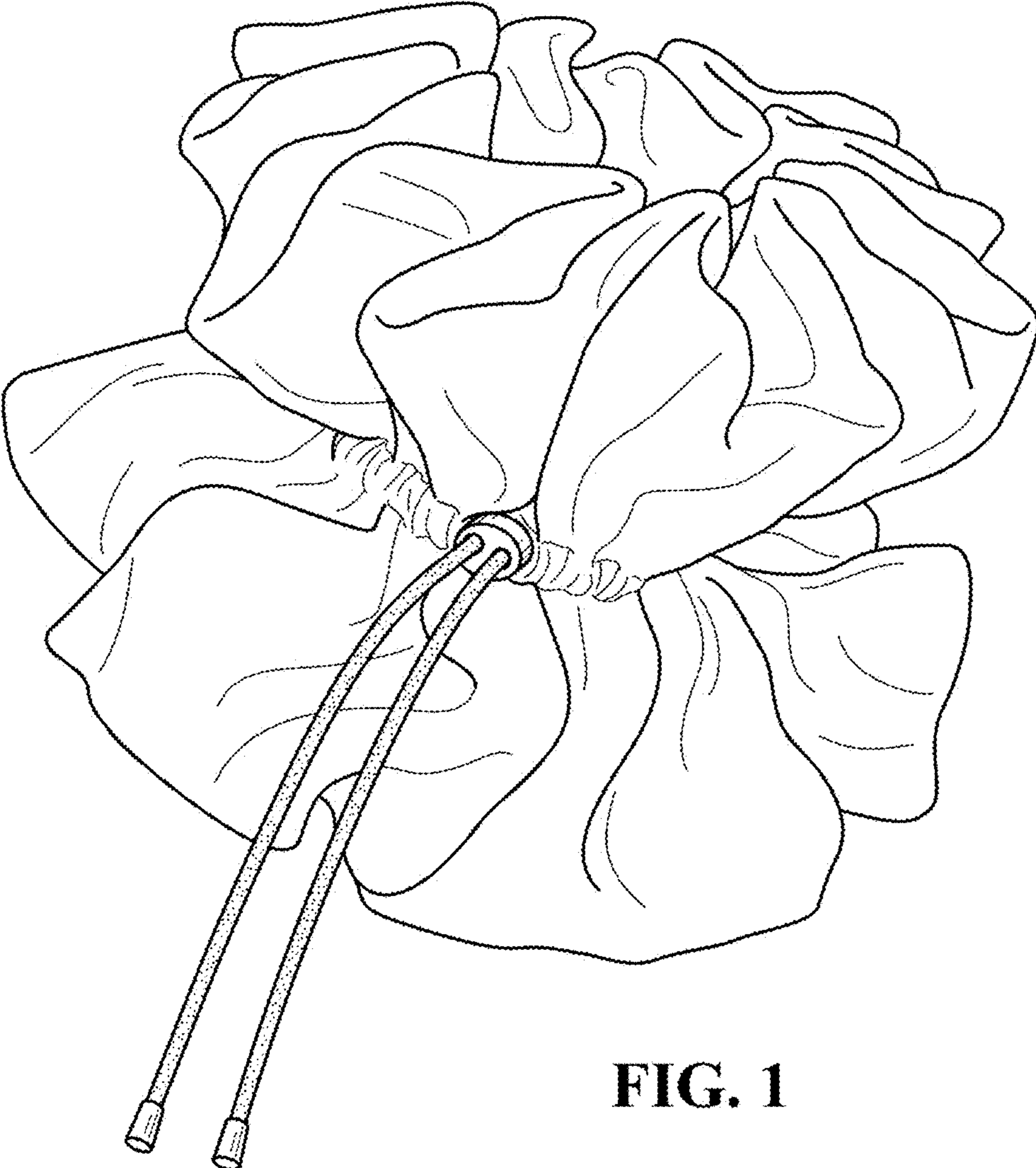

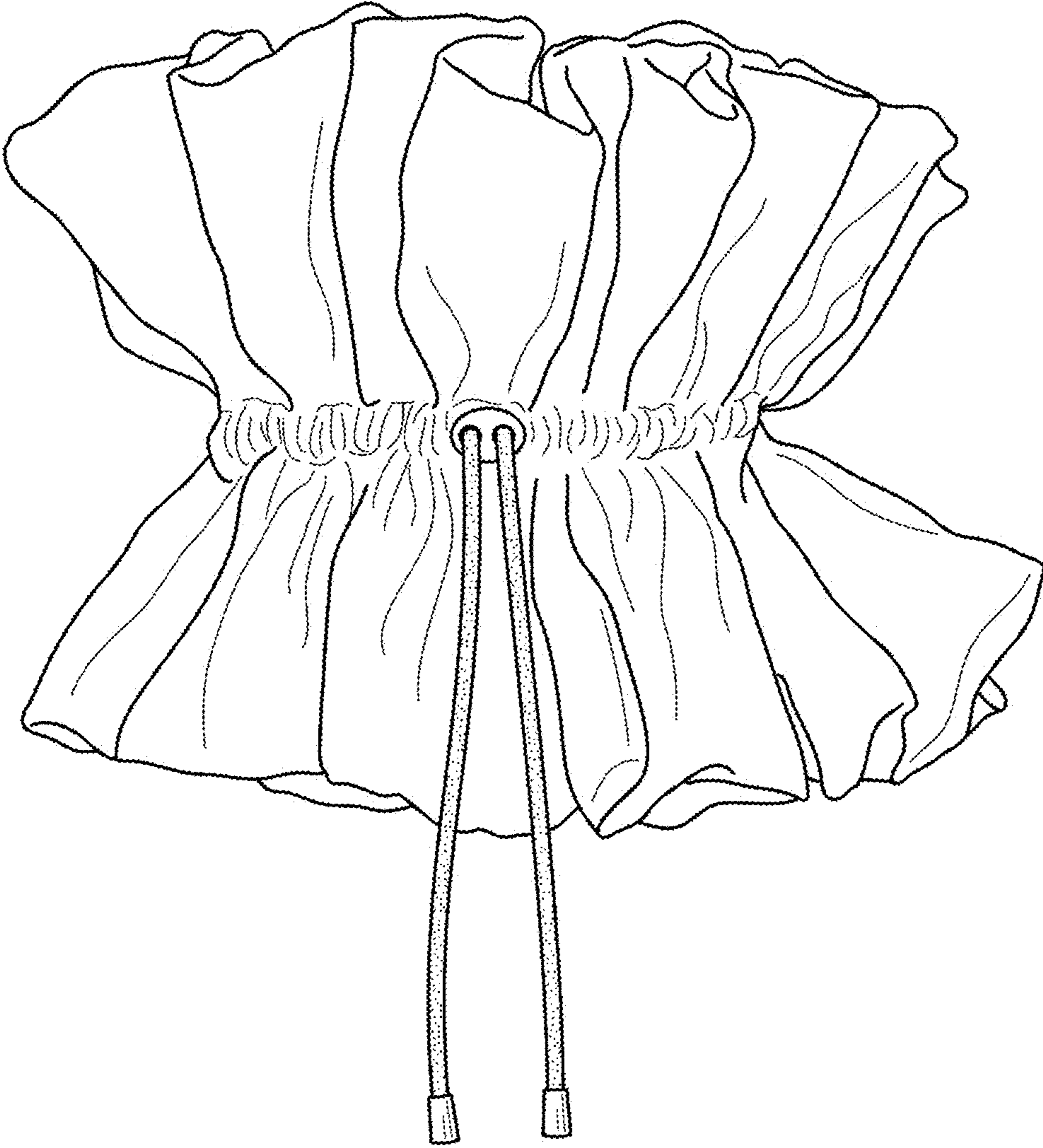

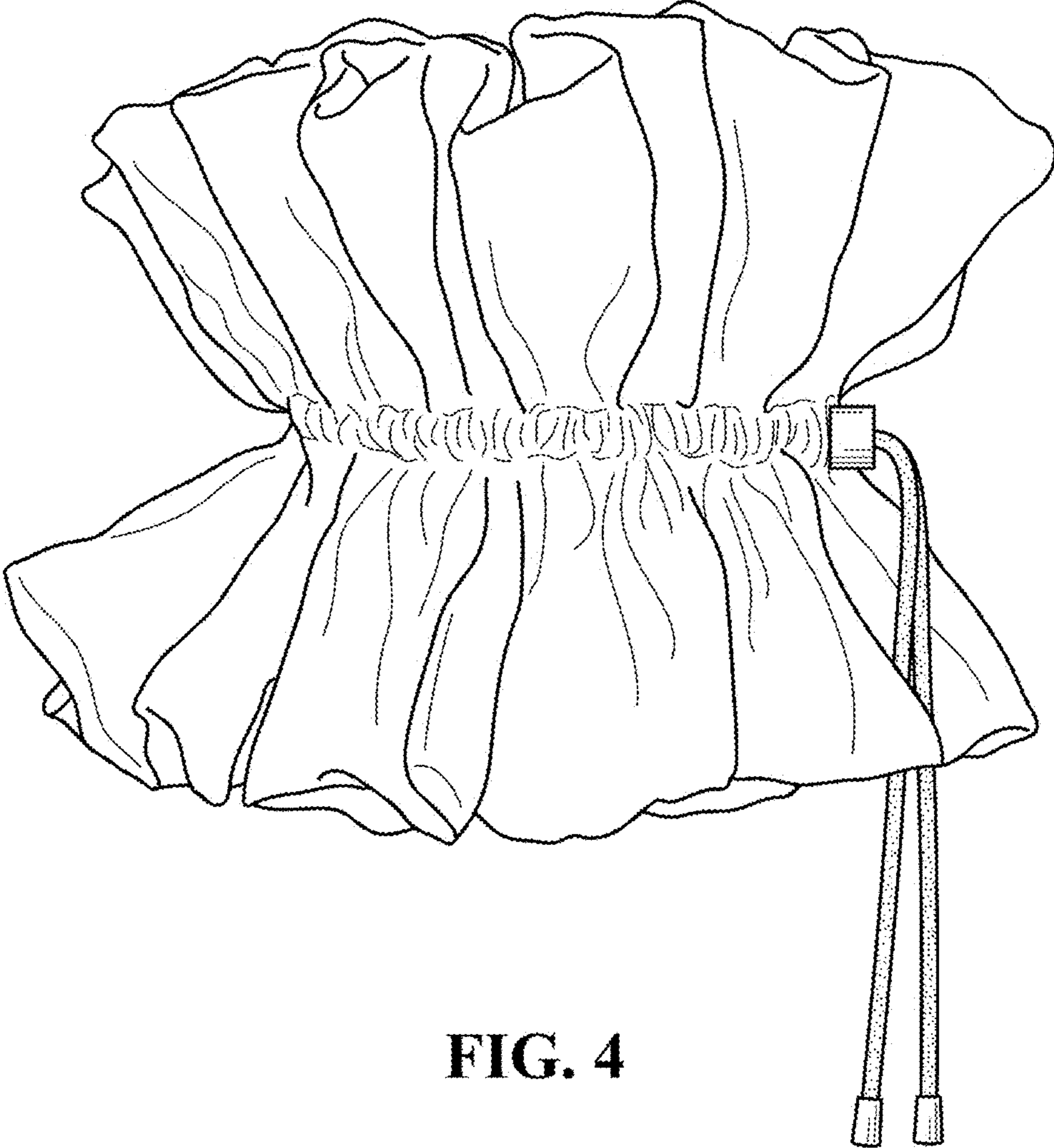

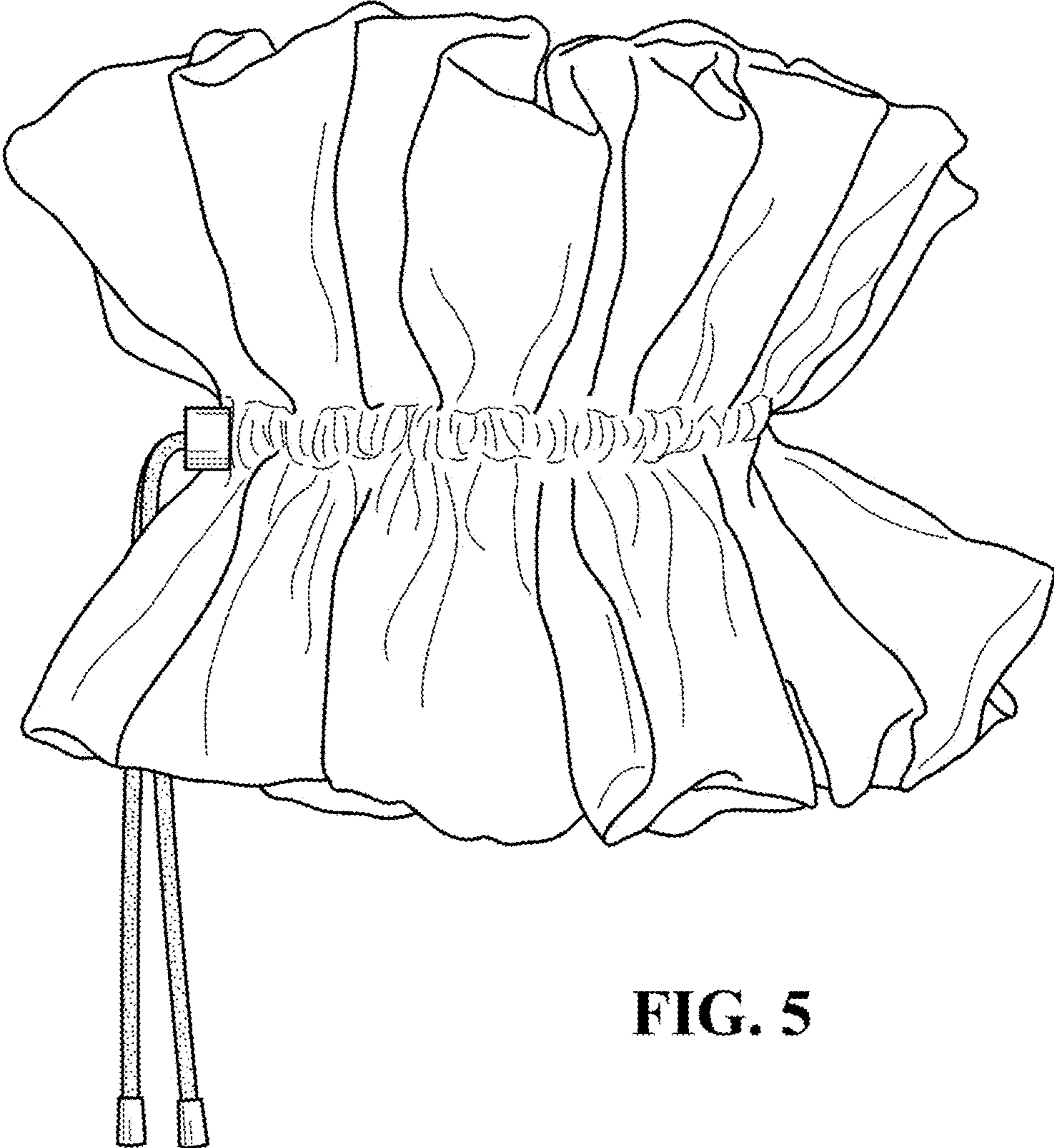




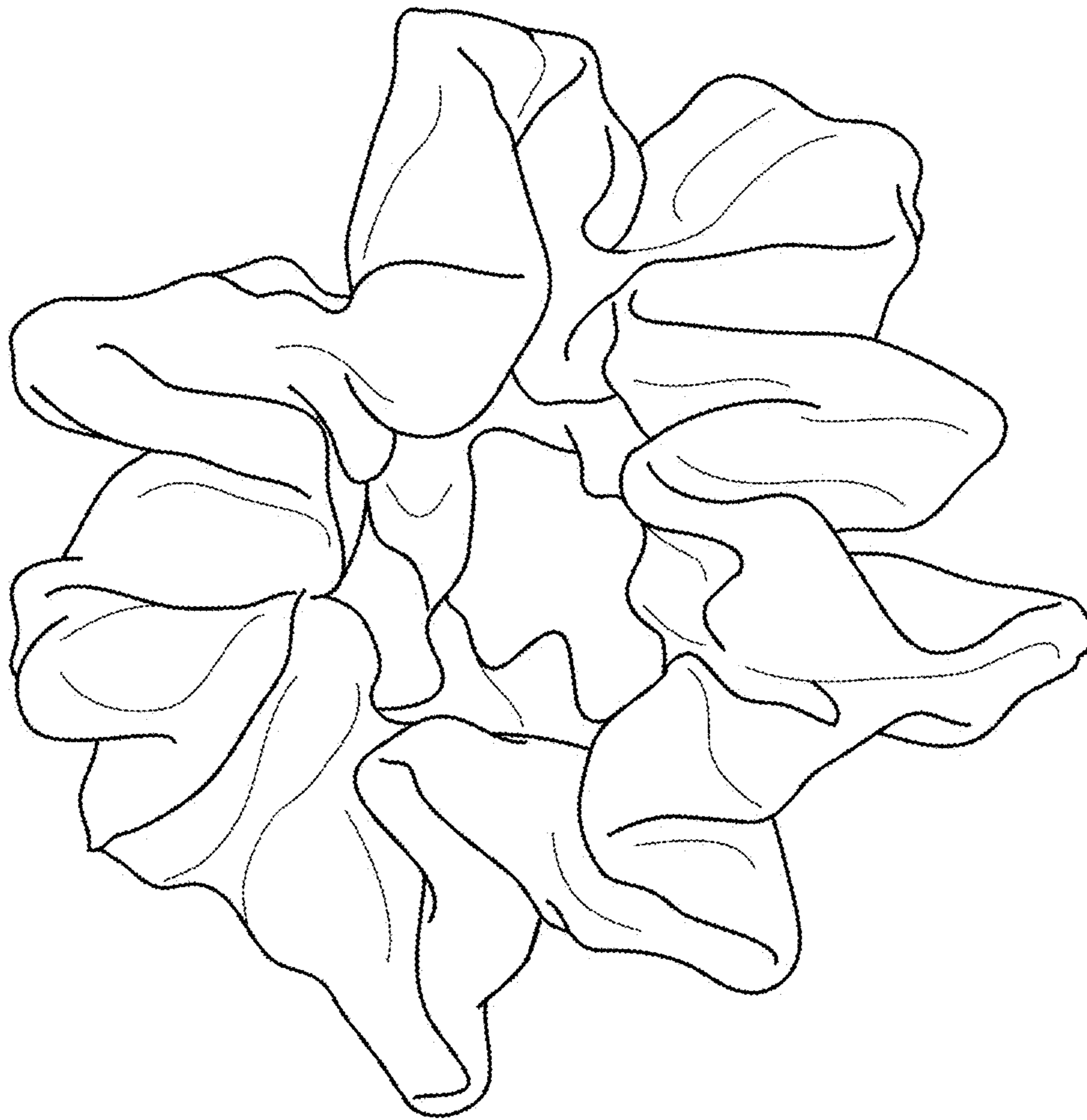

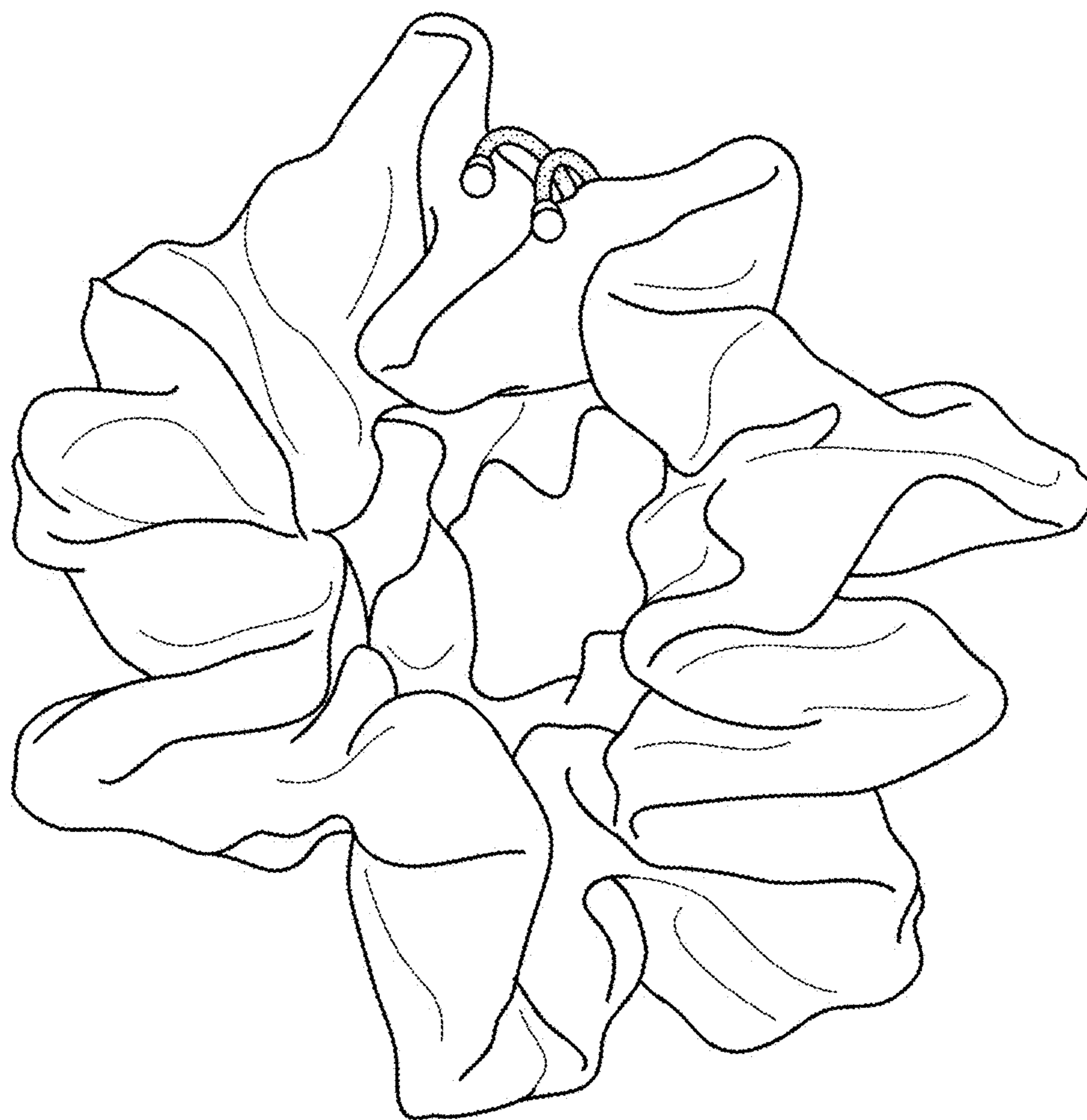
