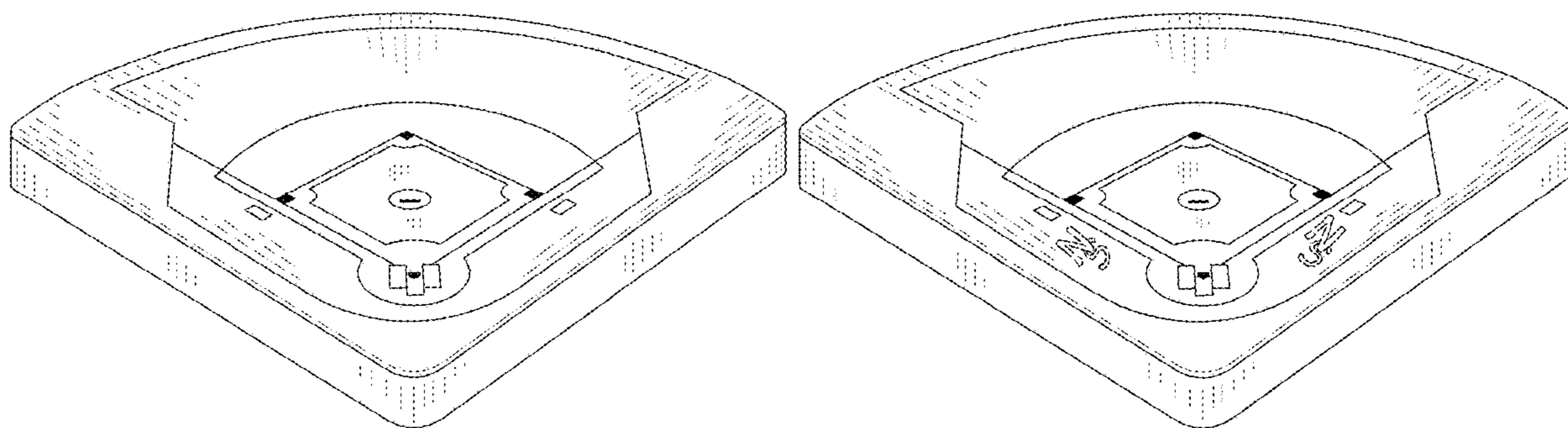
(57) **CLAIM**

The ornamental design for a baseball diamond pet bed, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a baseball diamond pet bed showing my new design.
 FIG. 2 is a top view of the baseball diamond pet bed.
 FIG. 3 is a front elevation view of the baseball diamond pet bed.
 FIG. 4 is a right side elevation view of the baseball diamond pet bed.
 FIG. 5 is a left side elevation view of the baseball diamond pet bed.
 FIG. 6 is a rear elevation view of the baseball diamond pet bed.
 FIG. 7 is a bottom view of the baseball diamond pet bed; and,
 FIG. 8 is another perspective view of the baseball diamond pet bed.

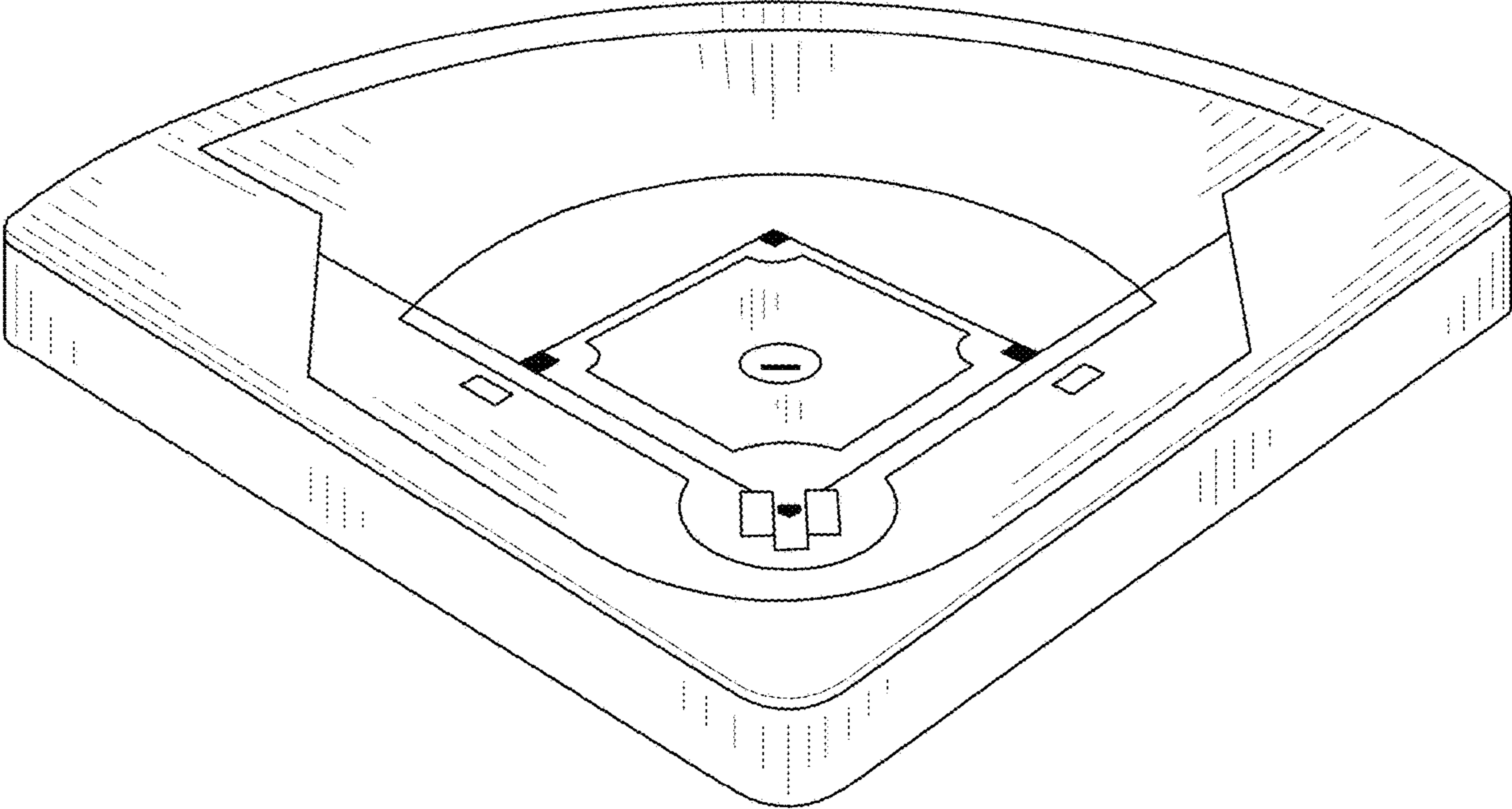

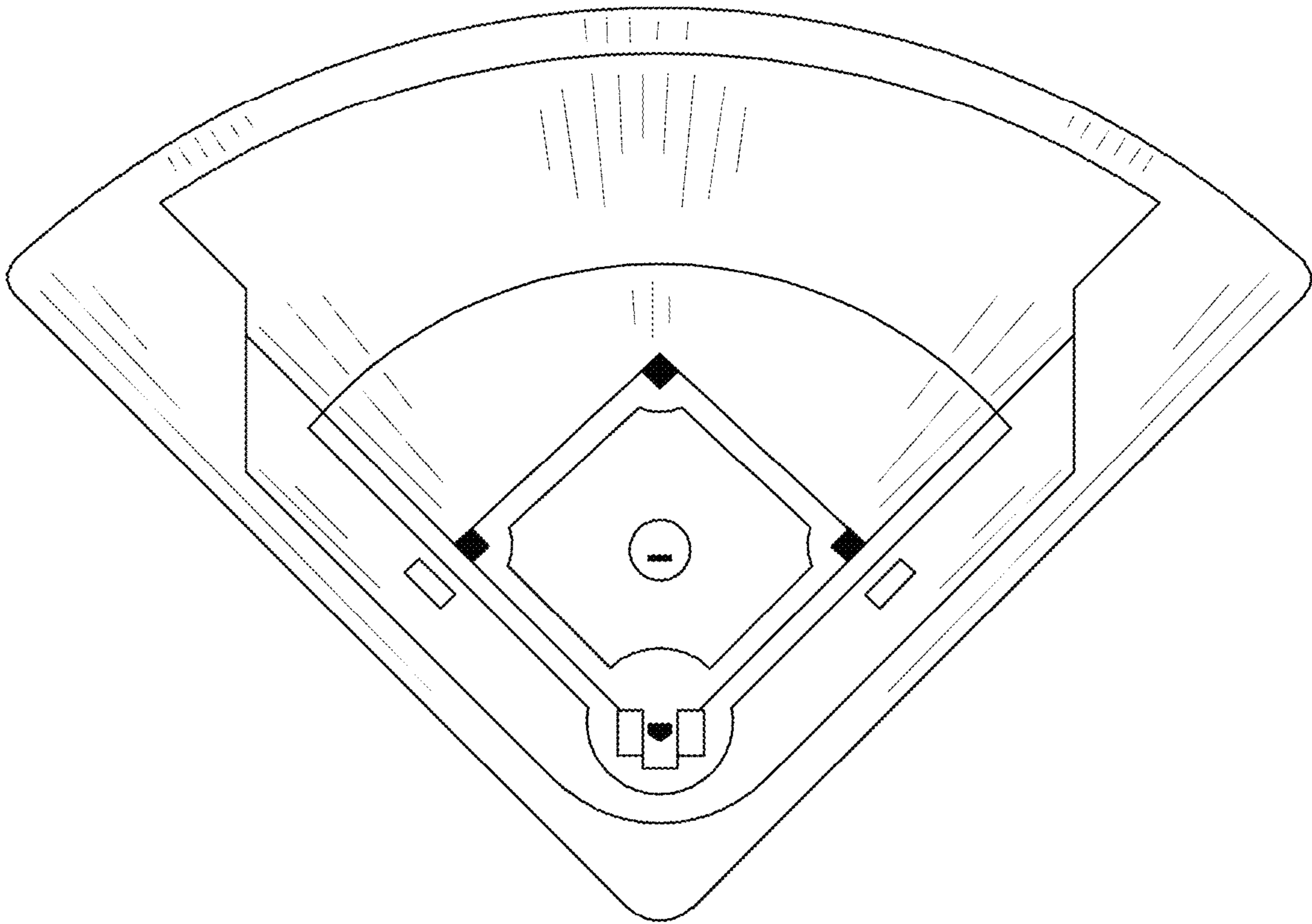

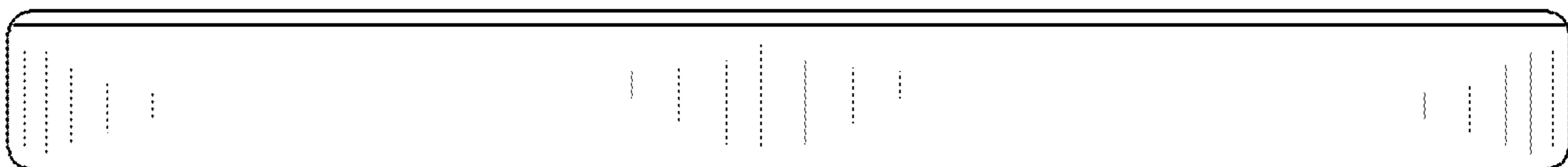

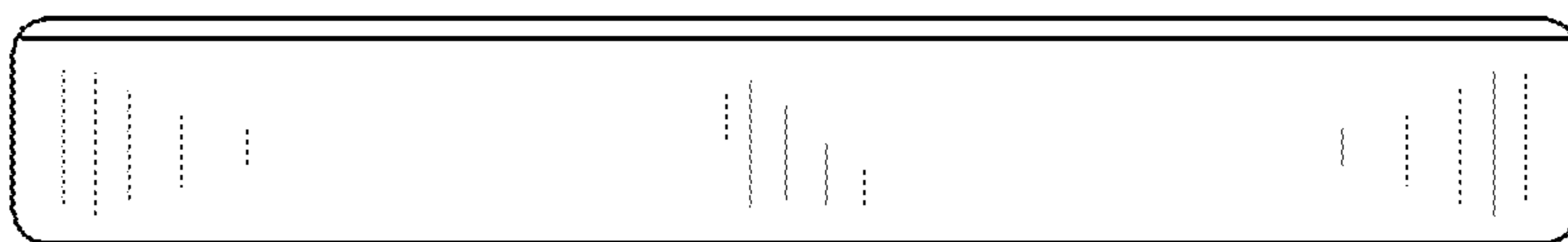

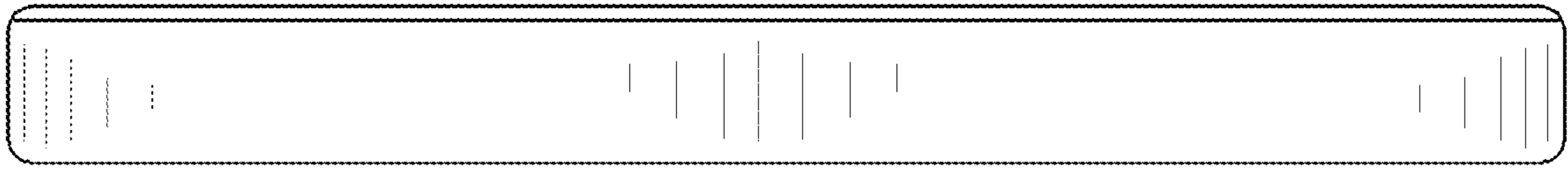

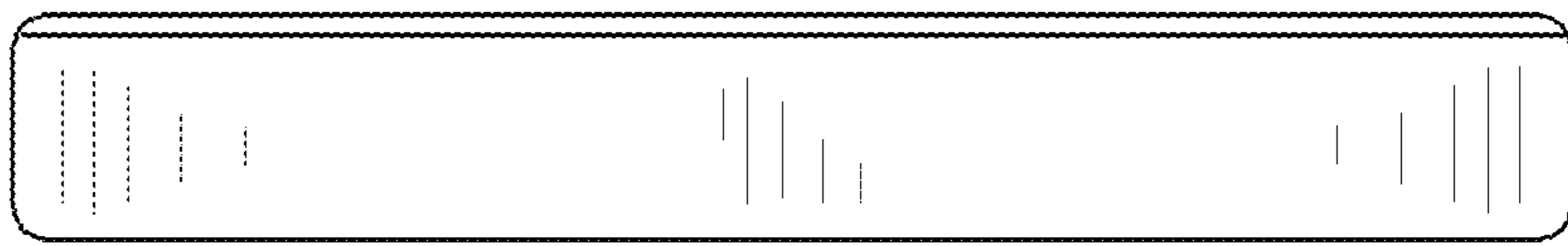

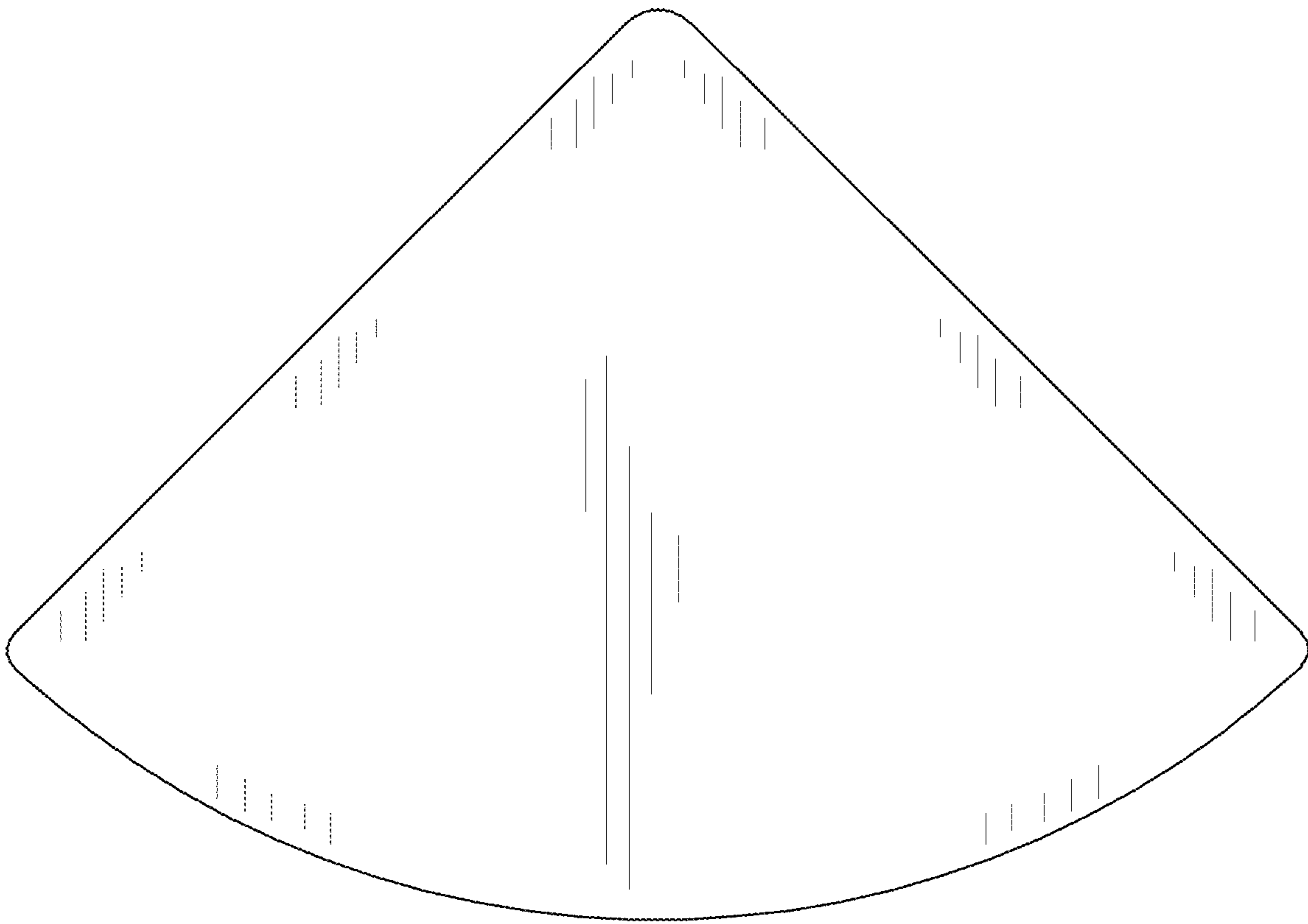

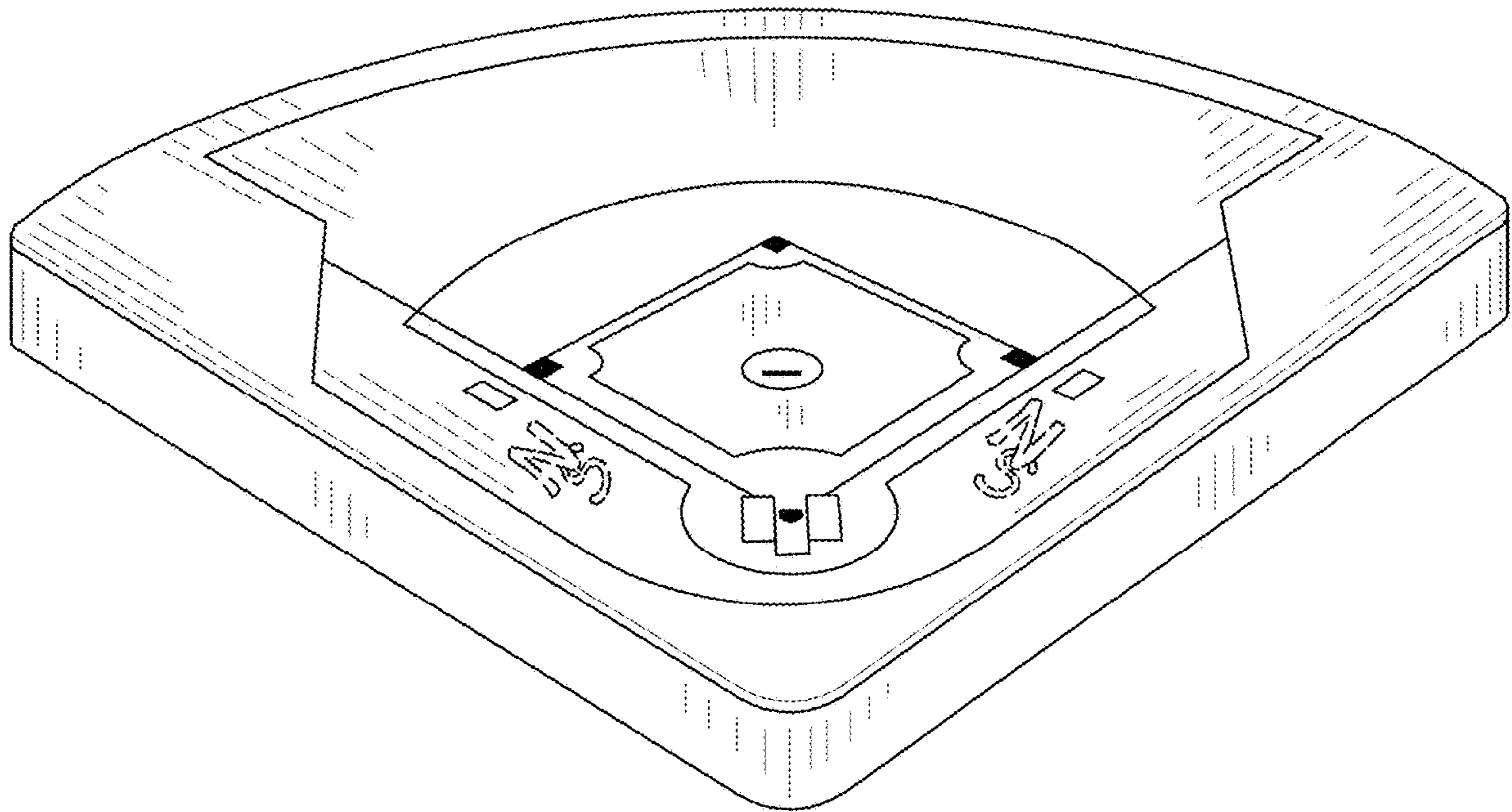
