DESCRIPTION

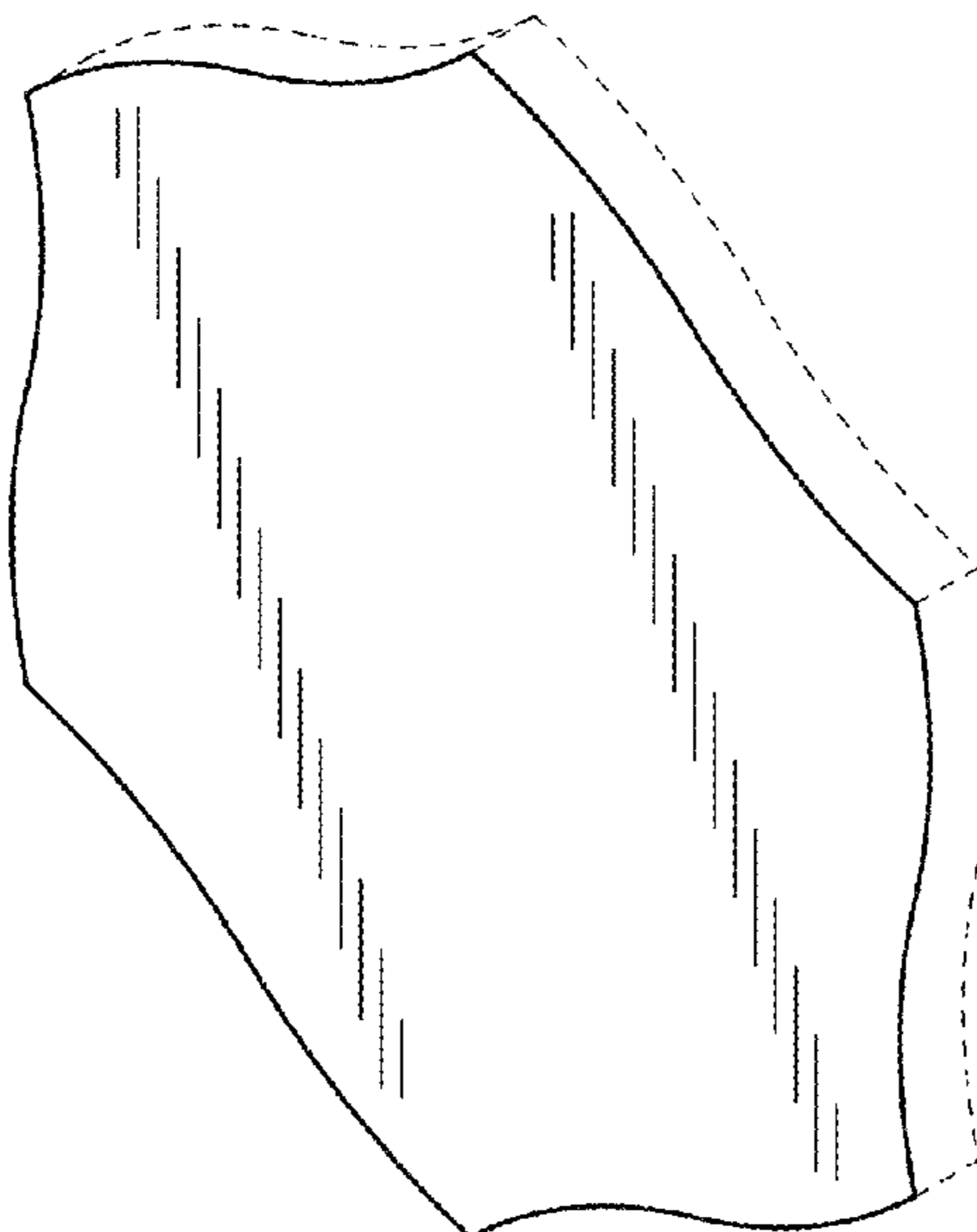
FIG. 1 is a perspective view of a first embodiment of a cleaning tool showing the new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a top view thereof, the bottom view being a mirror image thereof; FIG. 5 is a right side view thereof, the left side view being a mirror image thereof; FIG. 6 is a perspective view of a second embodiment of a cleaning tool showing the new design; FIG. 7 is a front view thereof; FIG. 8 is a rear view thereof; FIG. 9 is a top view thereof, the bottom view being a mirror image thereof; and, FIG. 10 is a right side view thereof, the left side view being a mirror image thereof. 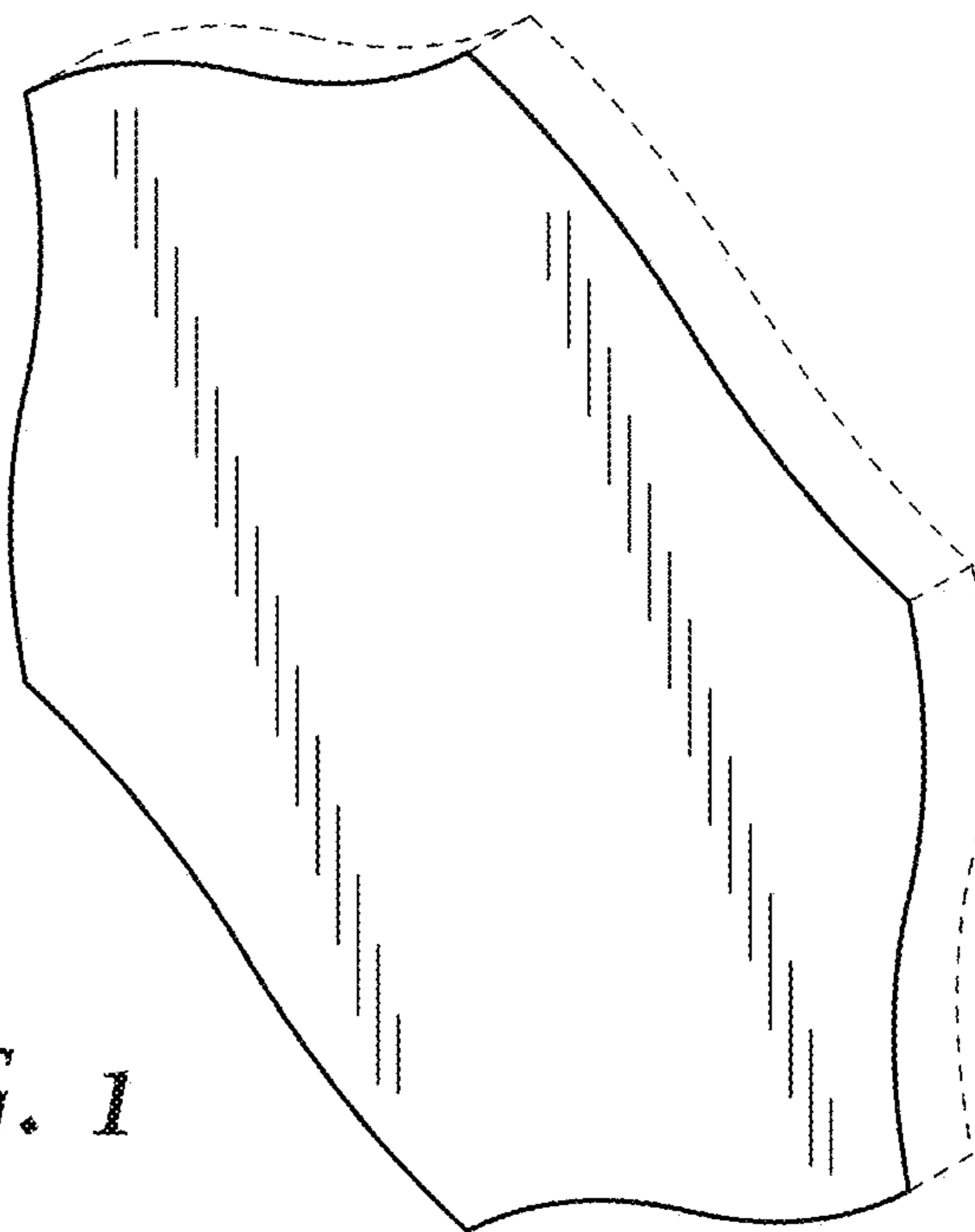

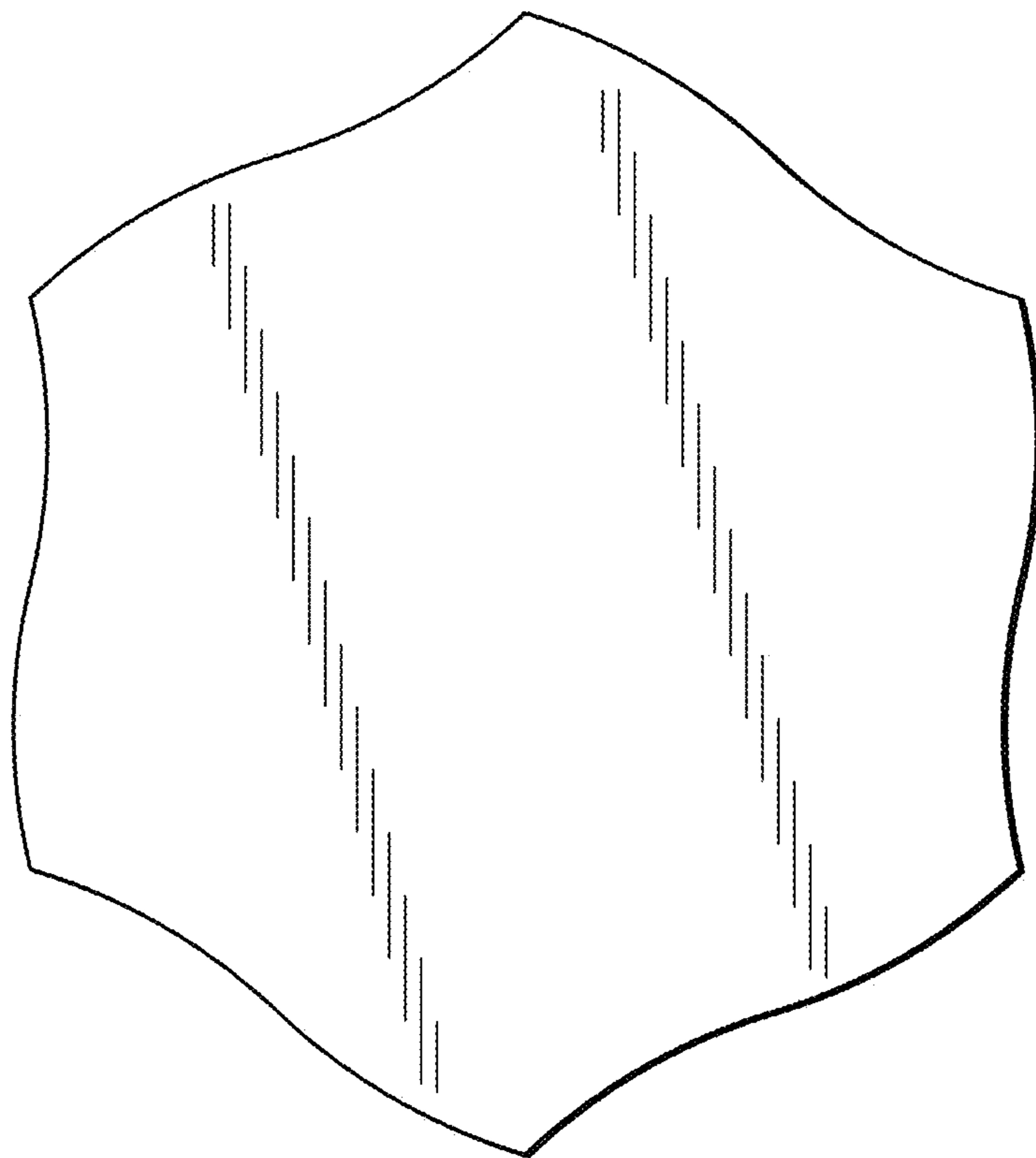

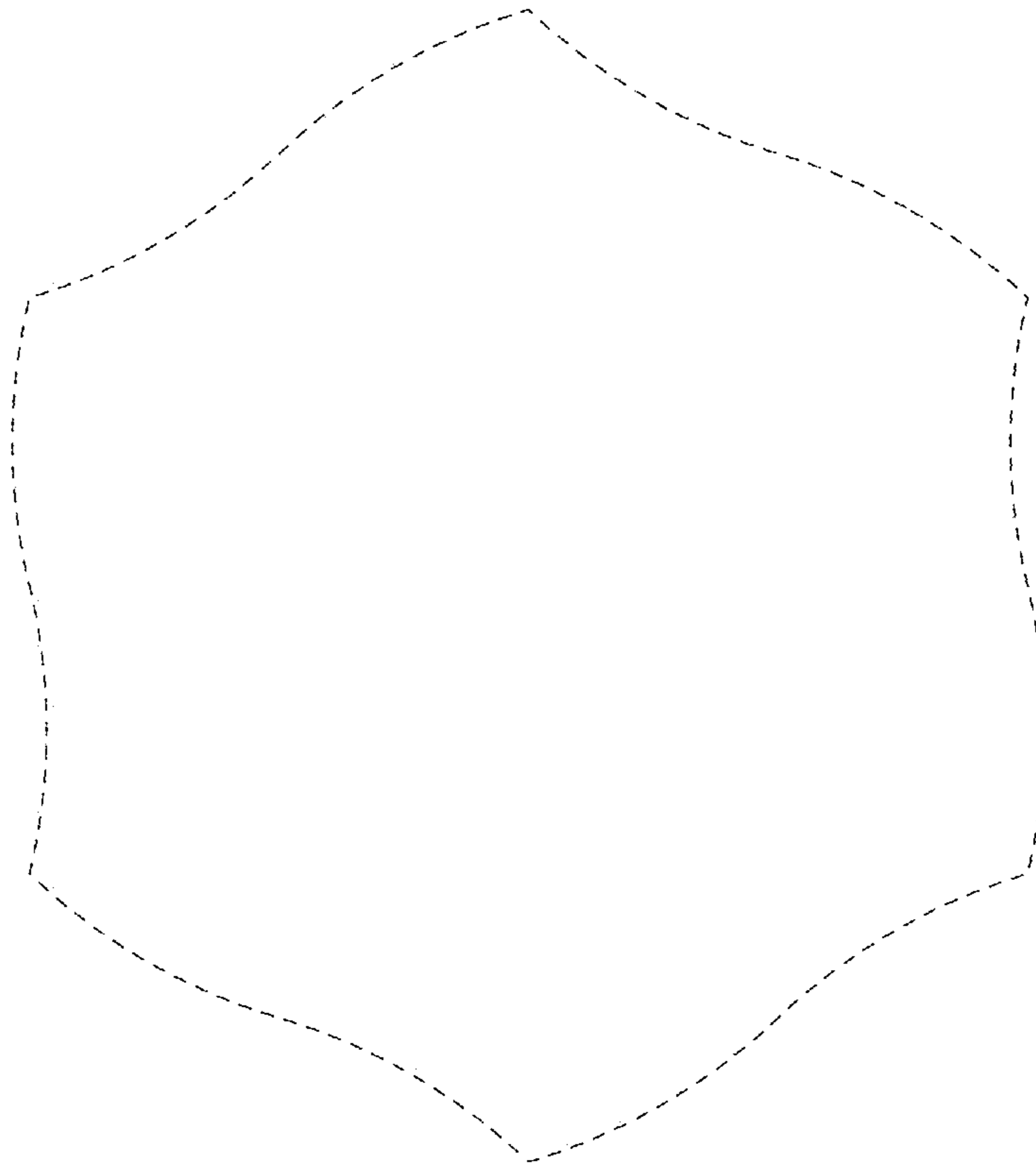

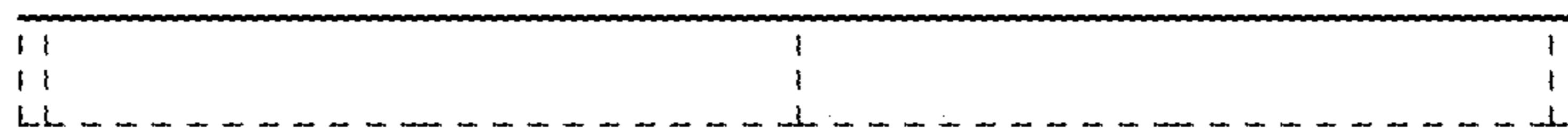

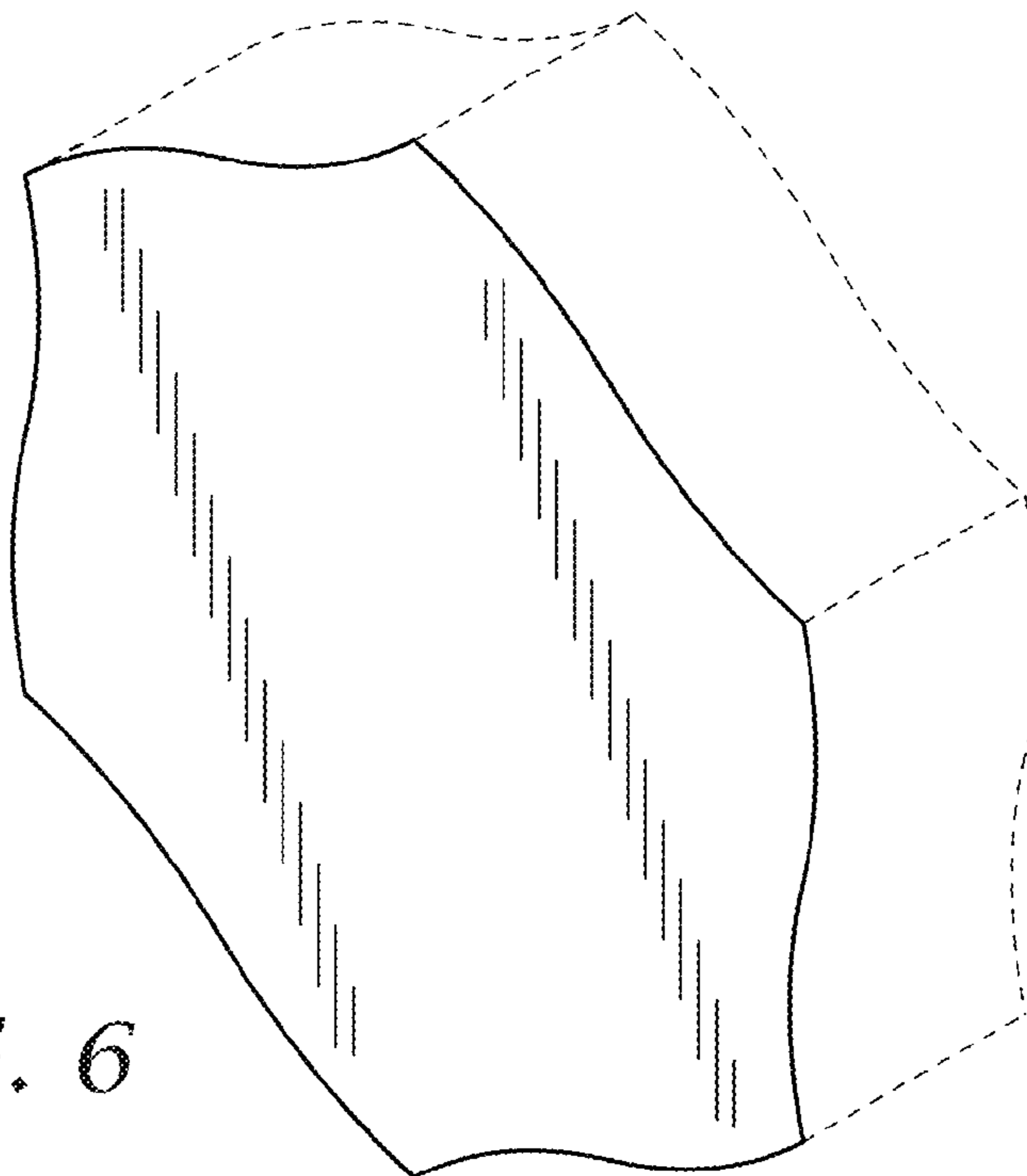

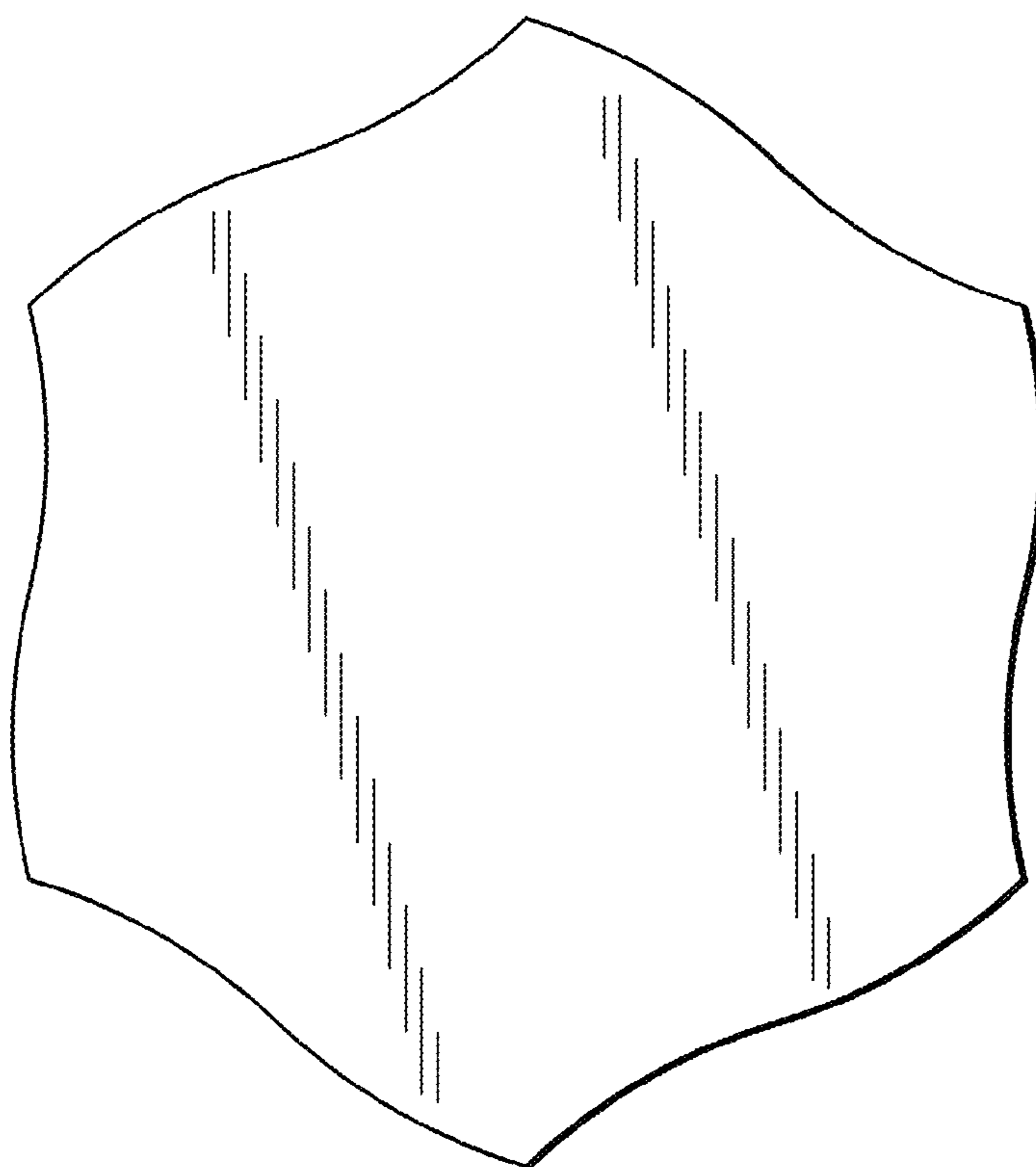

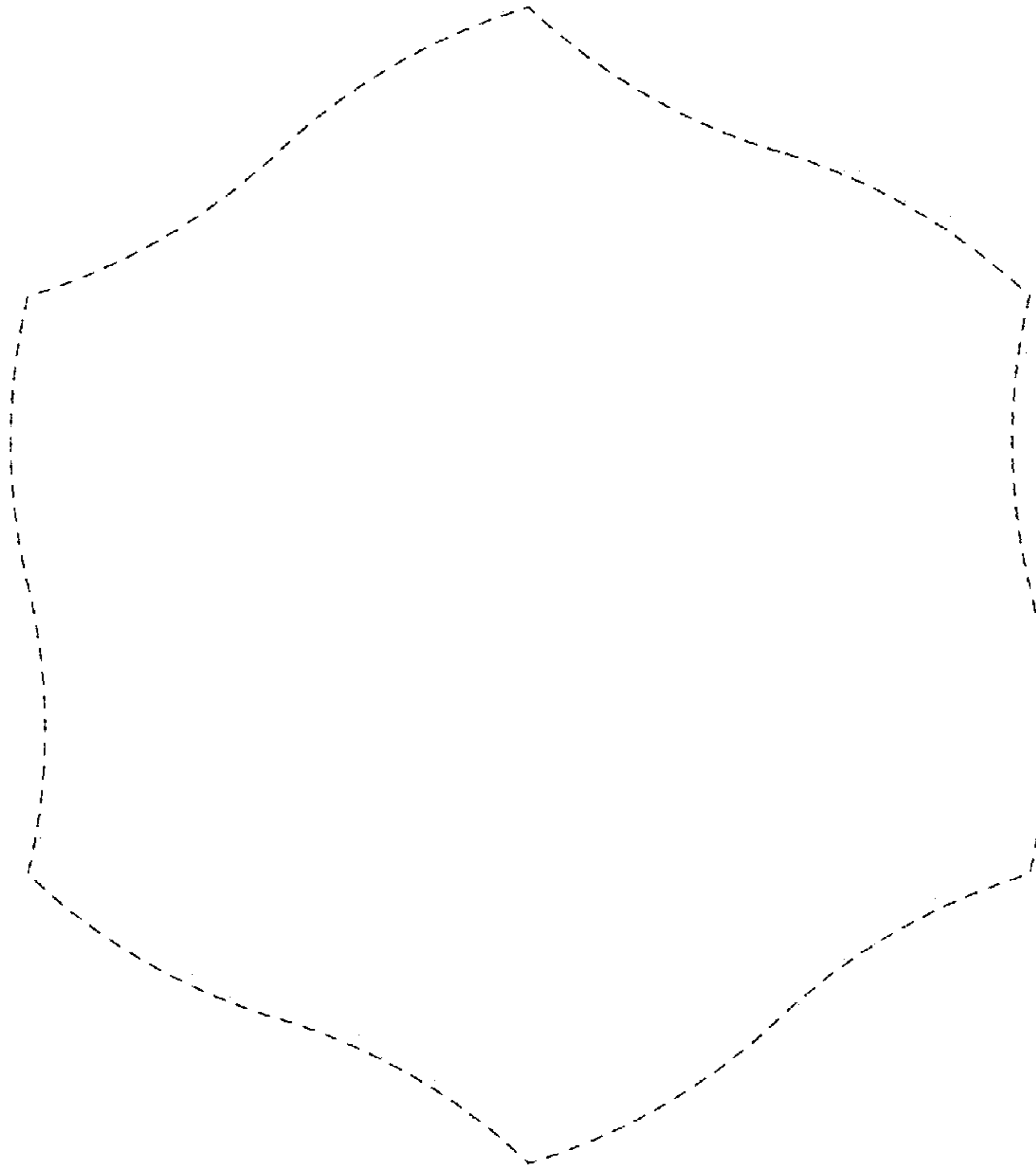

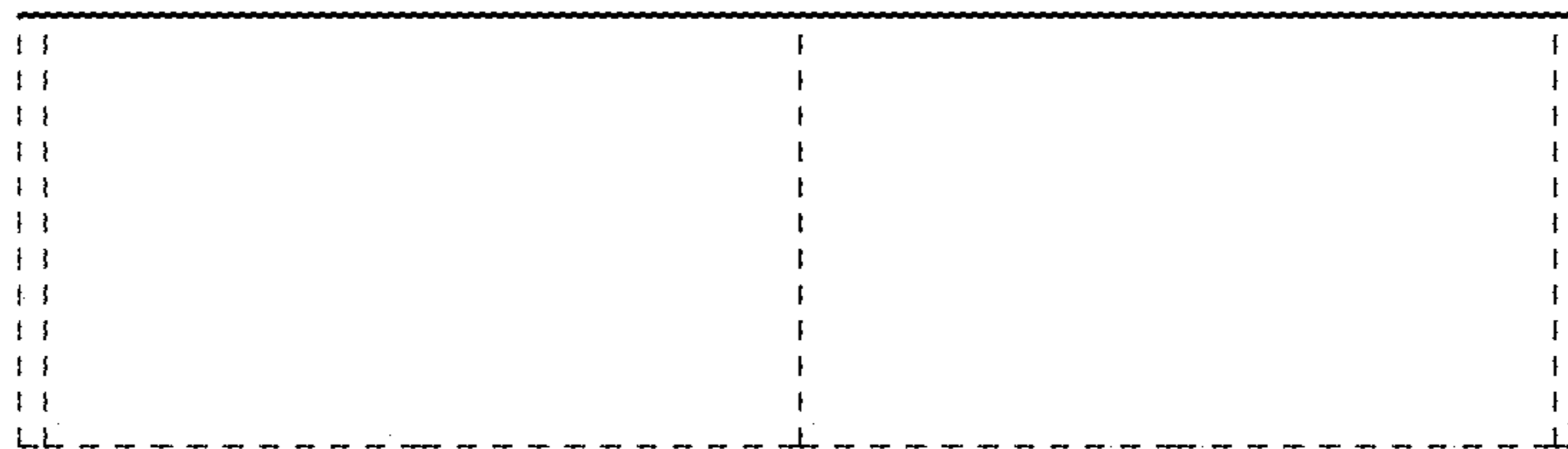

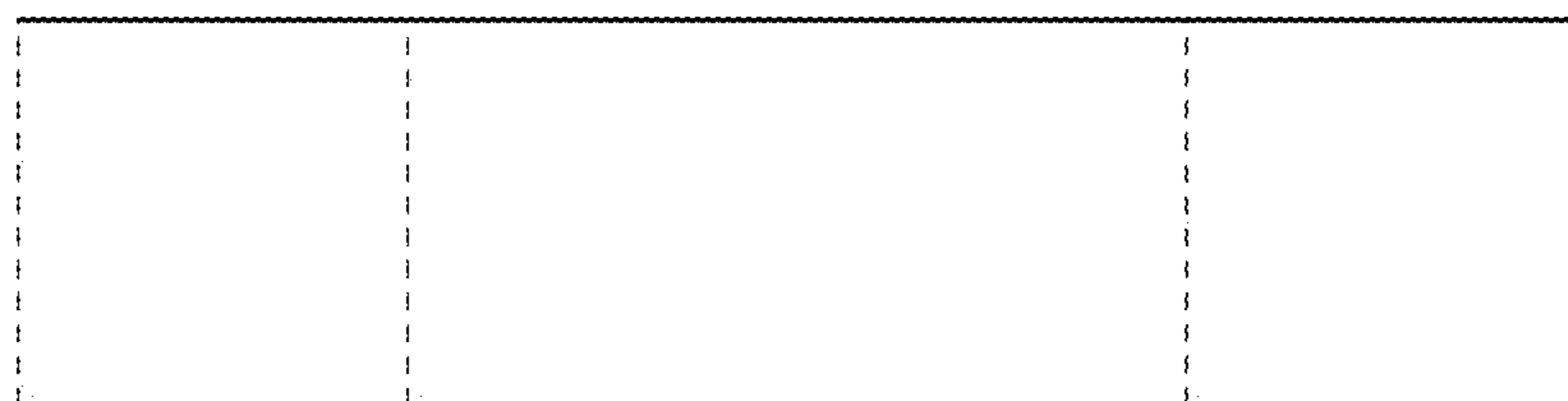
