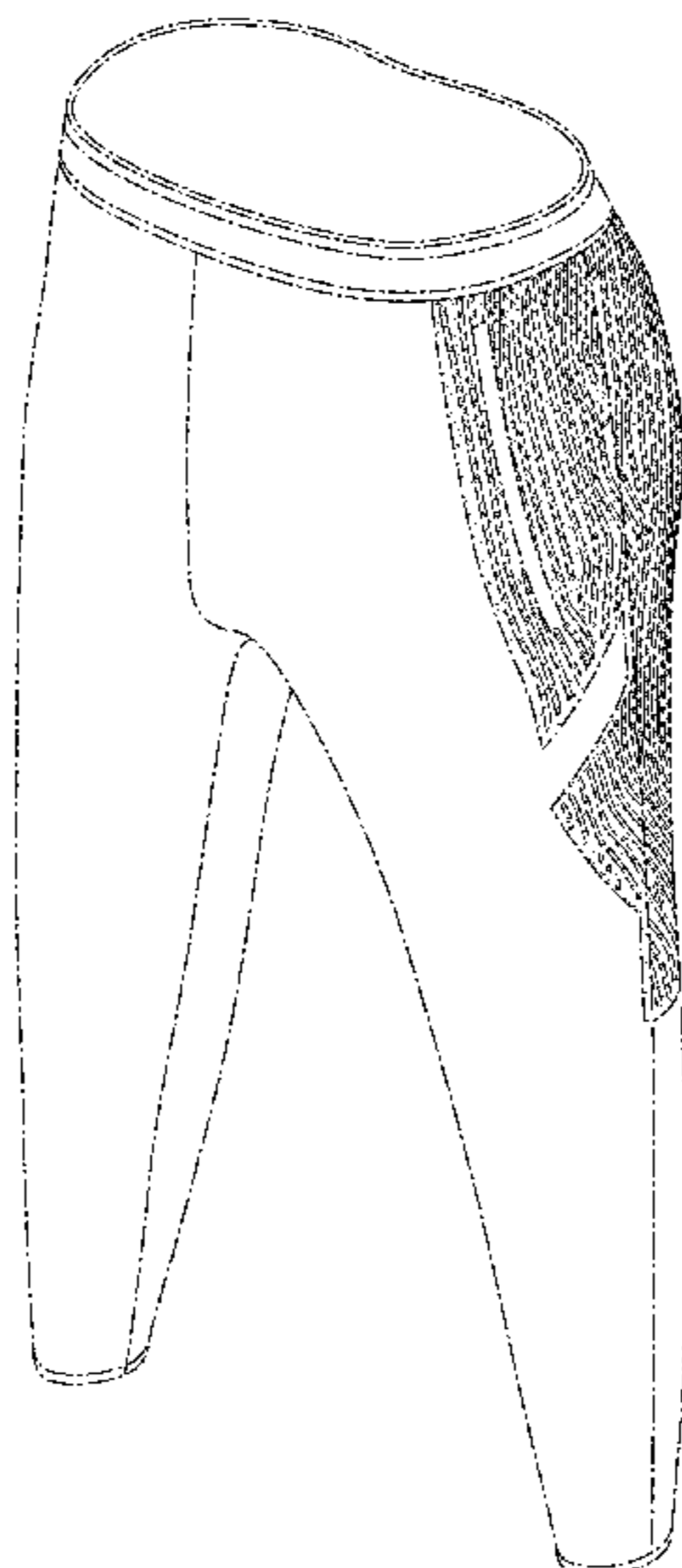
(57) **CLAIM**

The ornamental design for pants, as shown and described.

**DESCRIPTION**

FIG. 1 is a front left perspective view of pants showing my new design;  
 FIG. 2 is a front right perspective view thereof;  
 FIG. 3 is a rear left perspective view thereof;  
 FIG. 4 is a rear right perspective view thereof;  
 FIG. 5 is a front view thereof;  
 FIG. 6 is a rear view thereof;  
 FIG. 7 is a left side view thereof;  
 FIG. 8 is a right side view thereof;  
 FIG. 9 is an enlarged view of the design shown in FIG. 7 with environment removed for clarity; and,  
 FIG. 10 is an enlarged view of the design shown in FIG. 8 with environment removed for clarity.  
 The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The broken line within the shaded areas forms no part of the claimed design. The broken lines depicting the remainder of the pants show features that form no part of the claimed design.

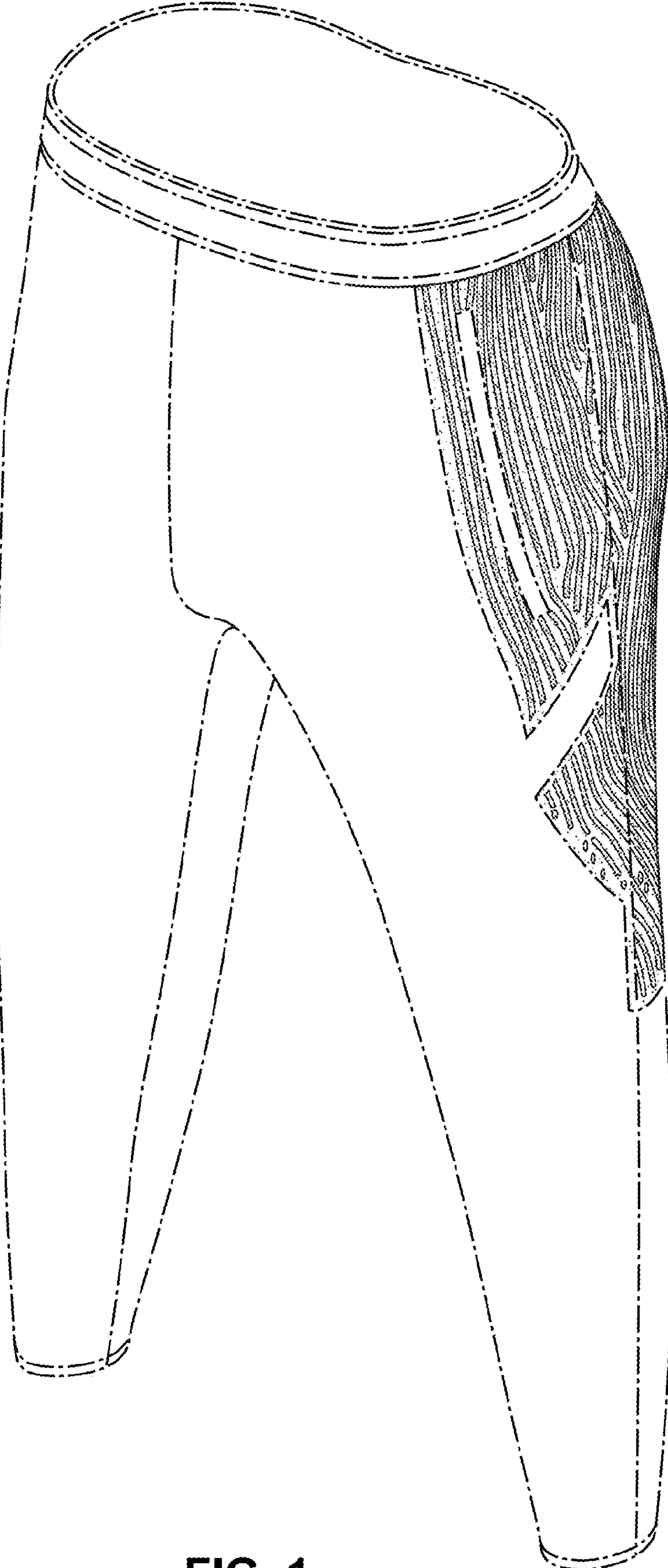

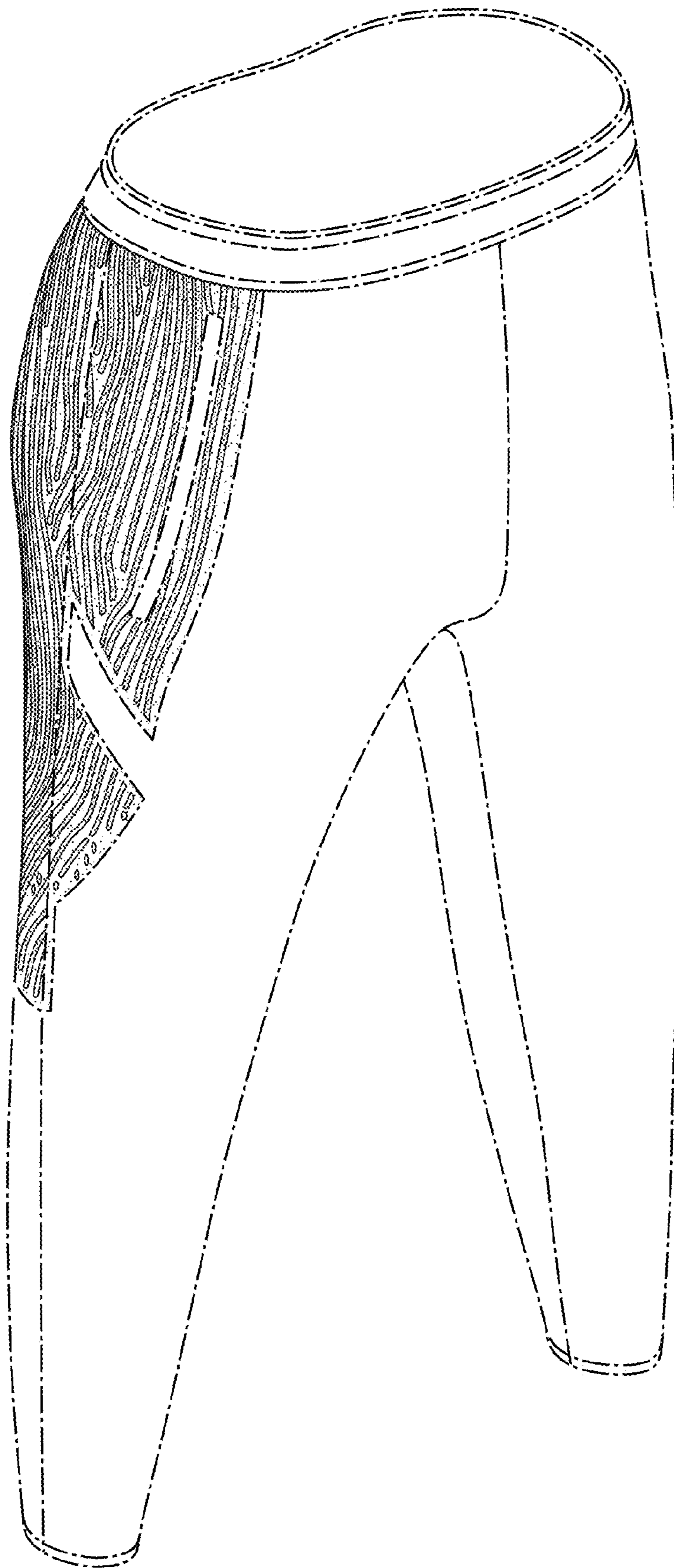

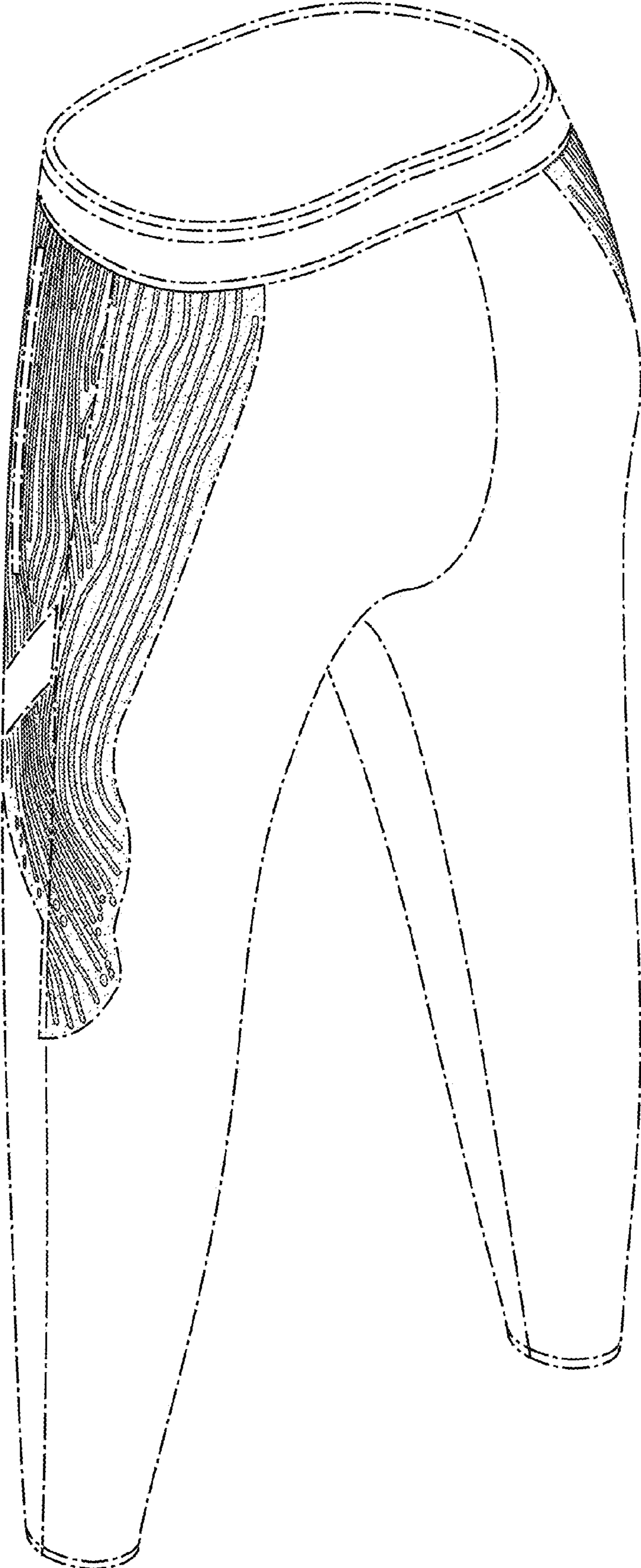

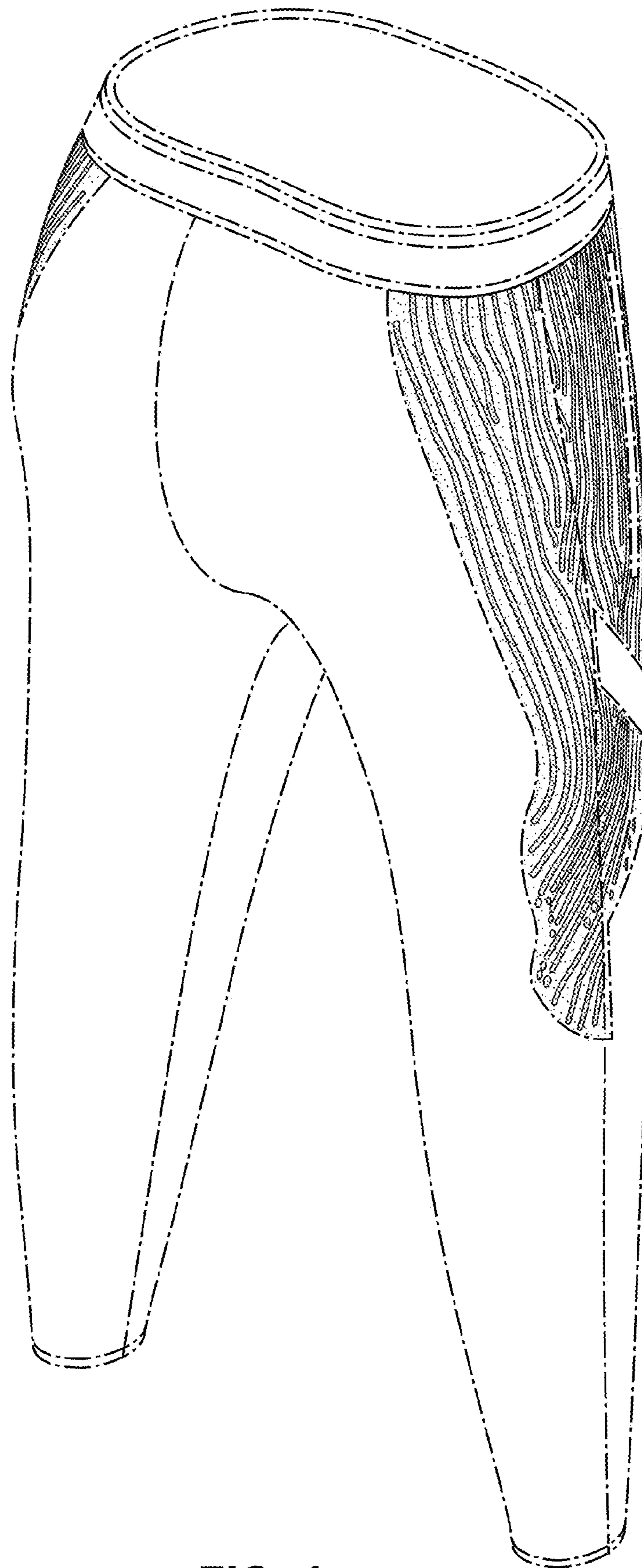

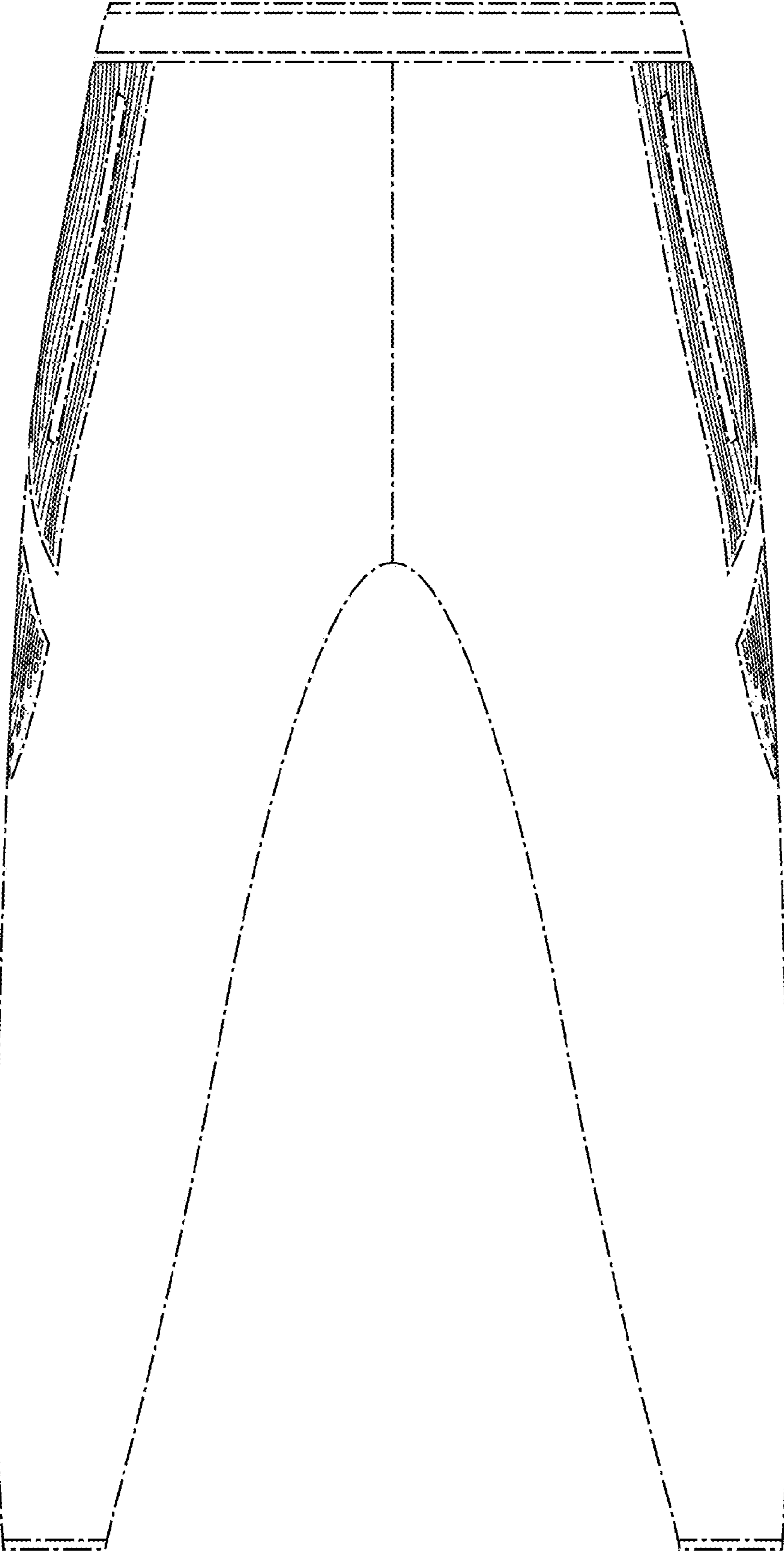

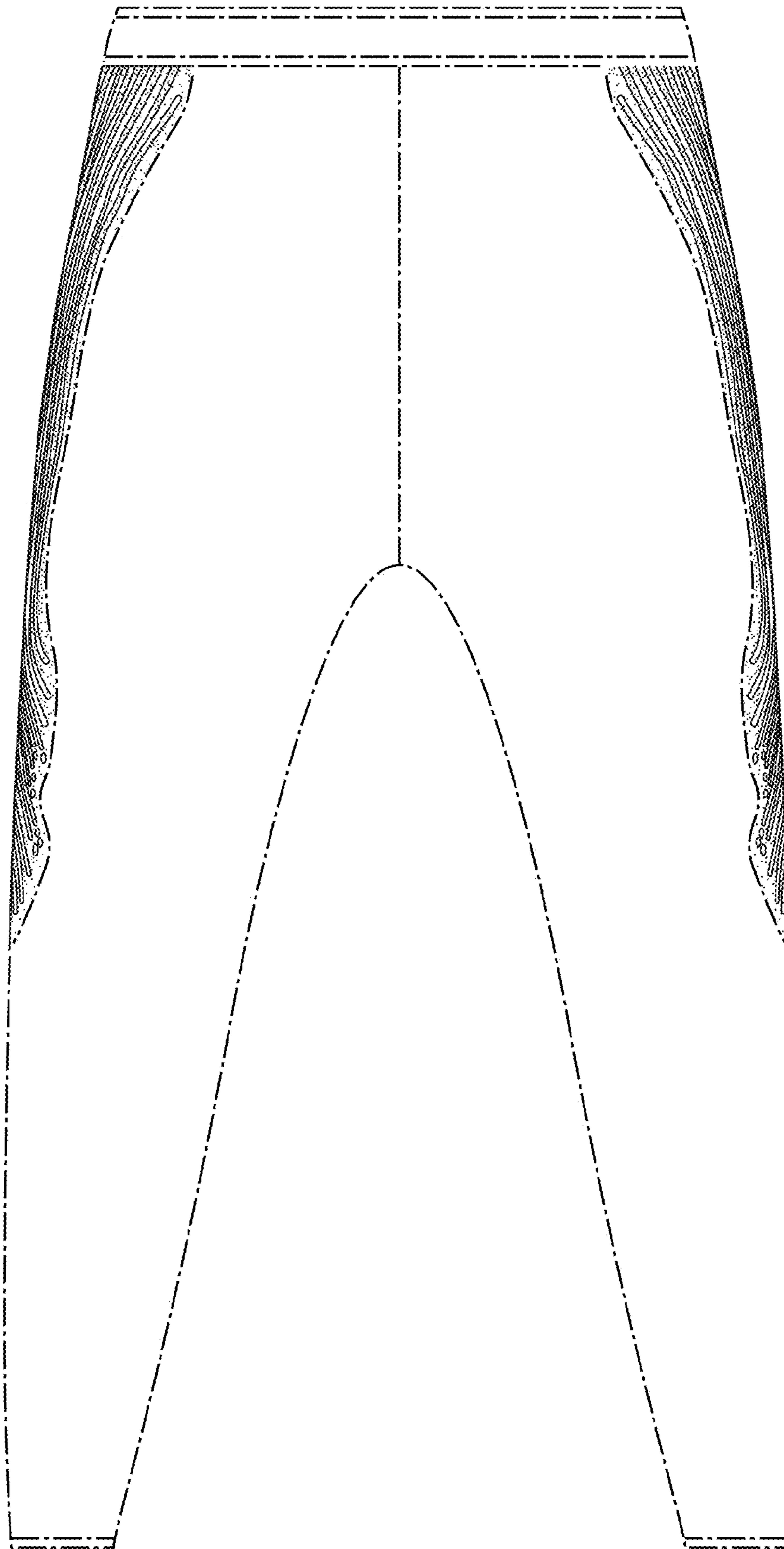

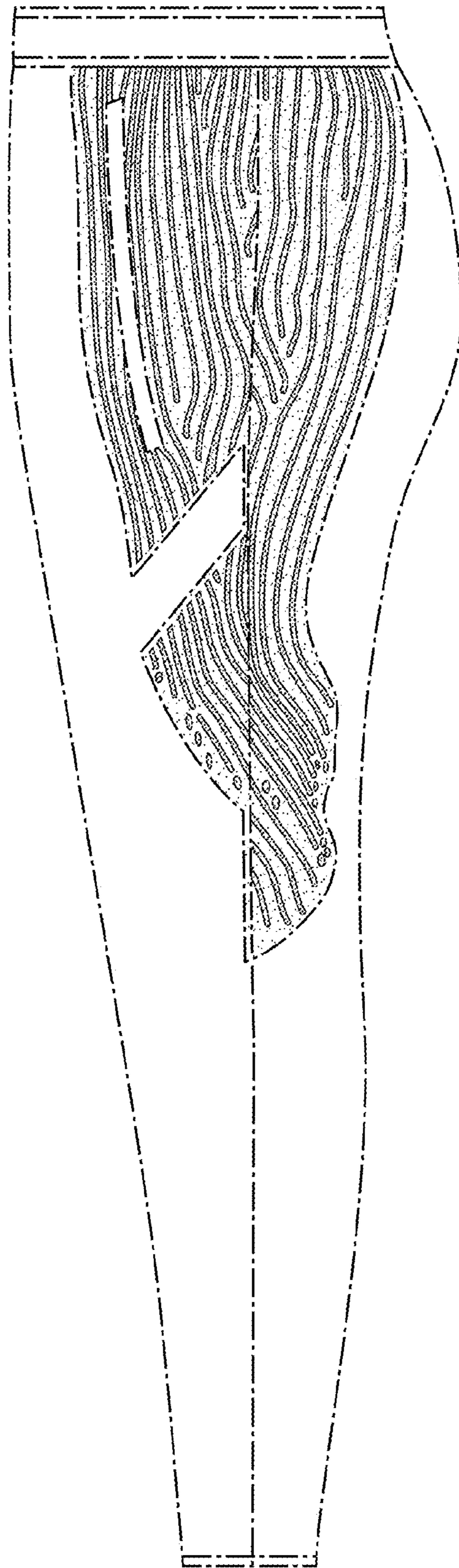

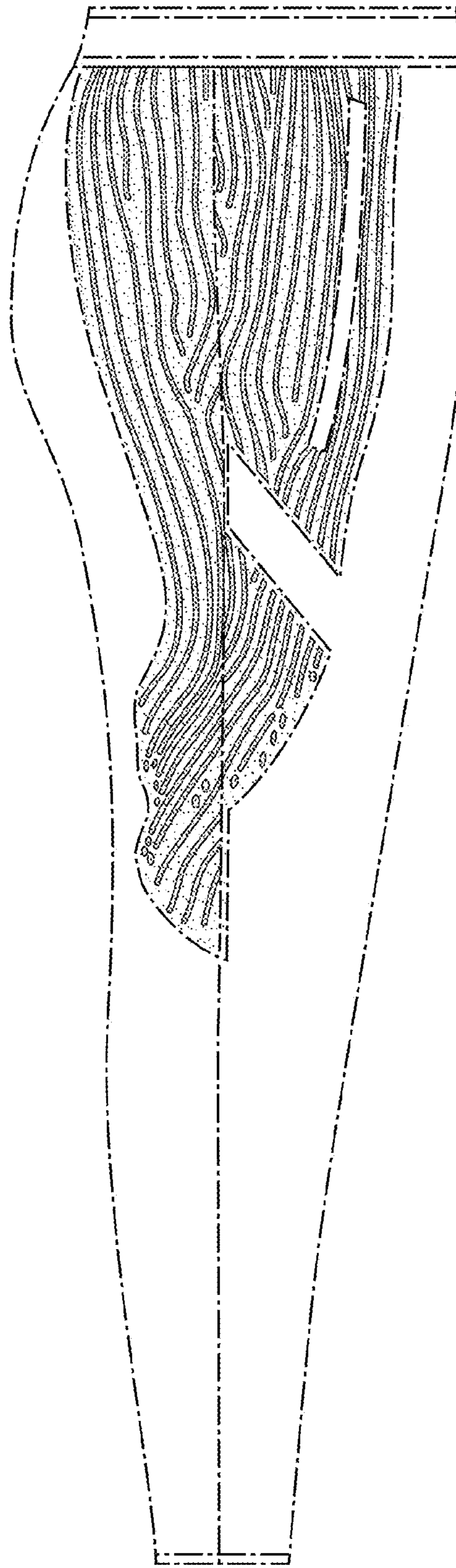

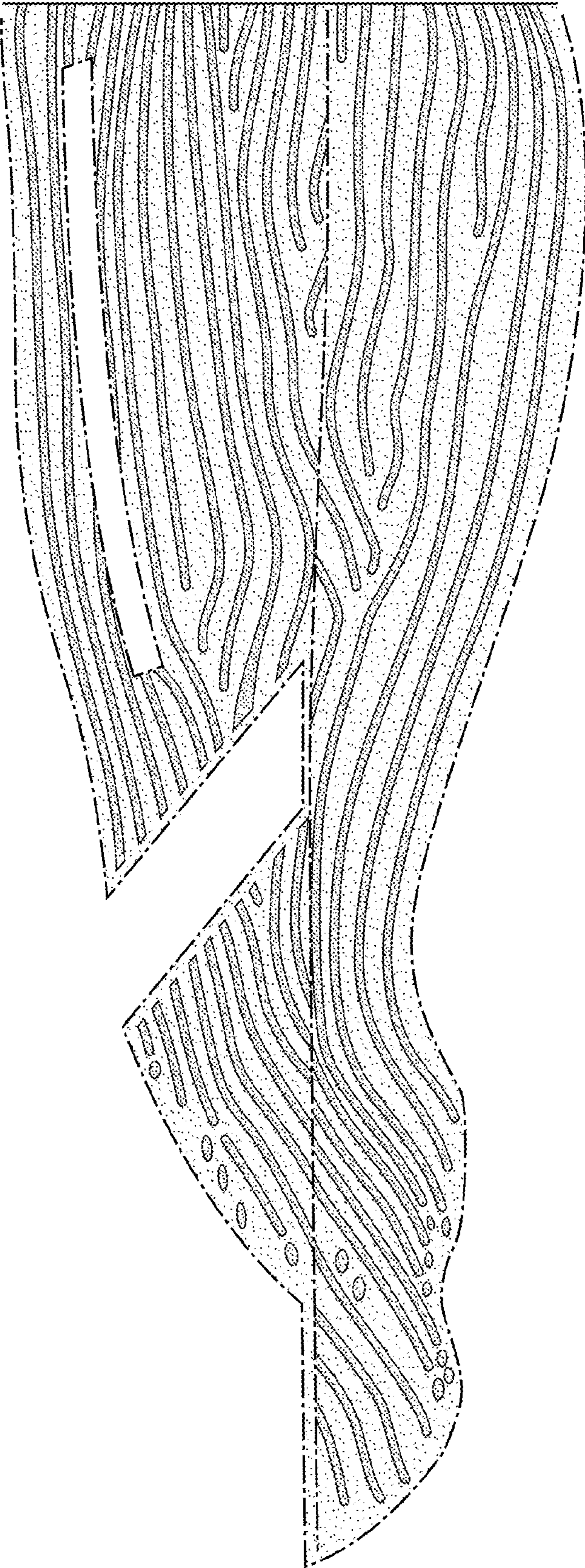

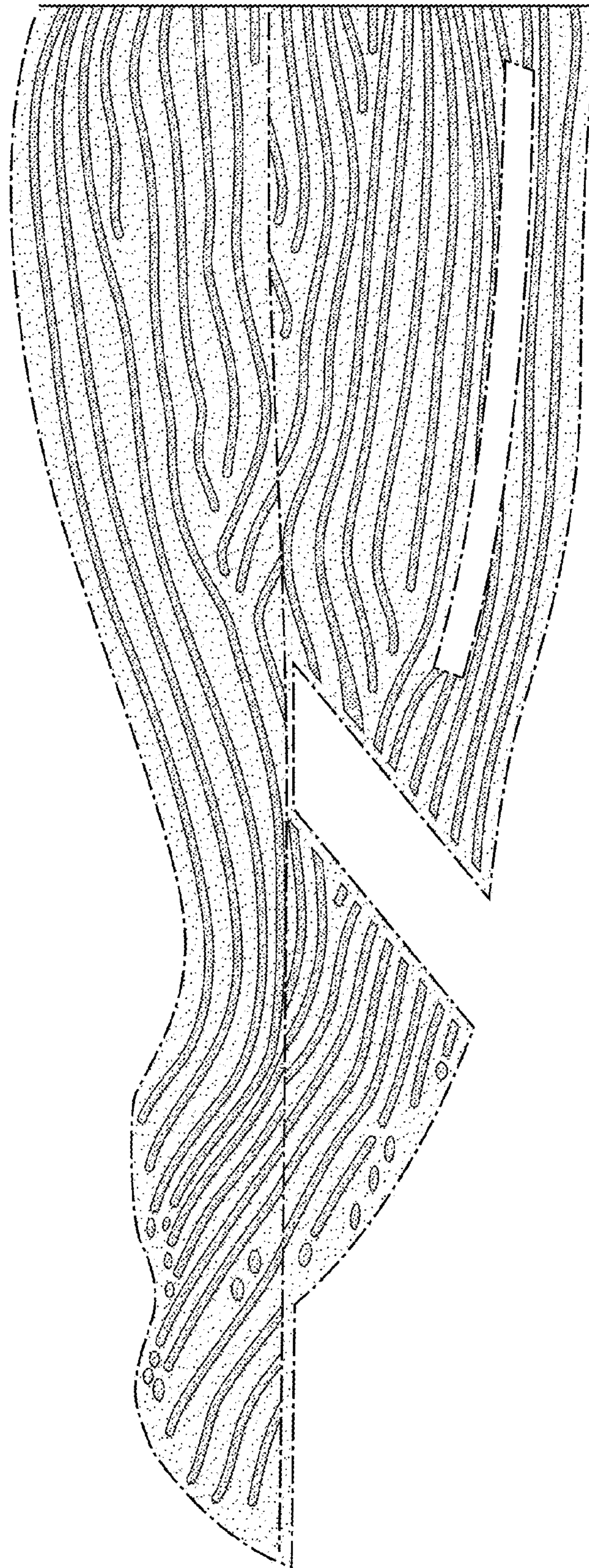
