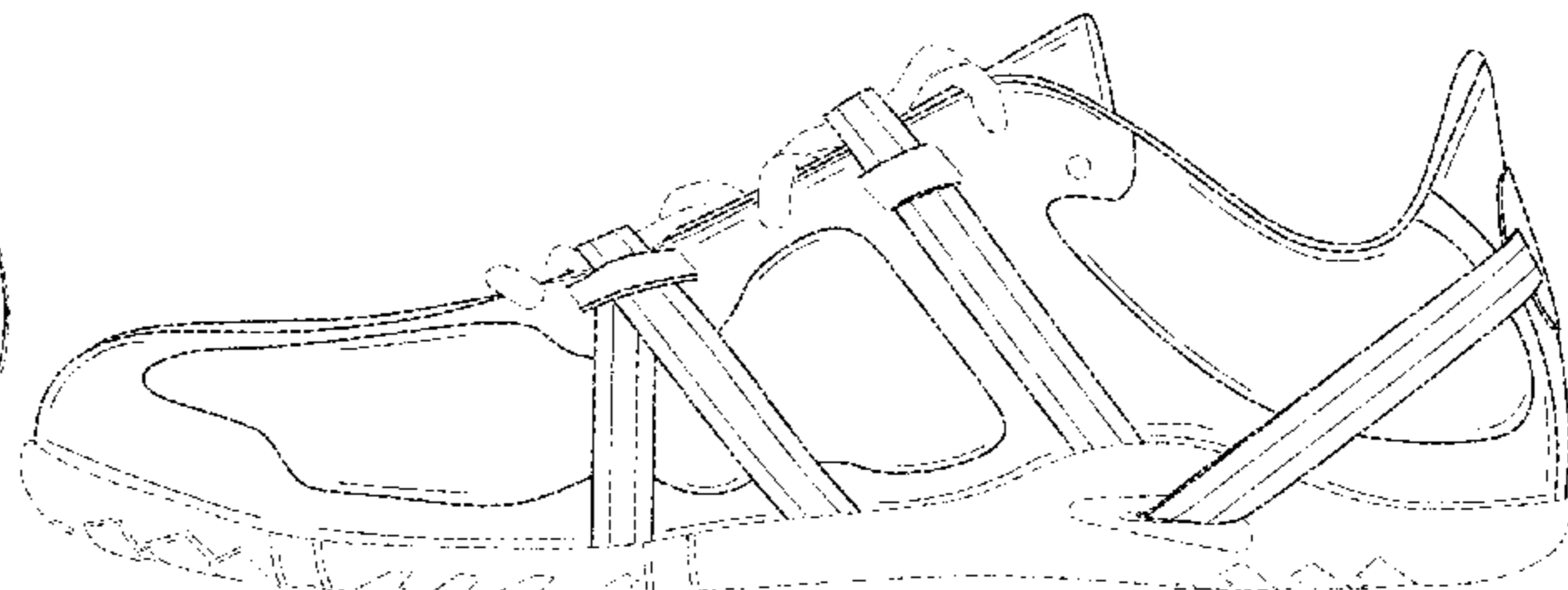
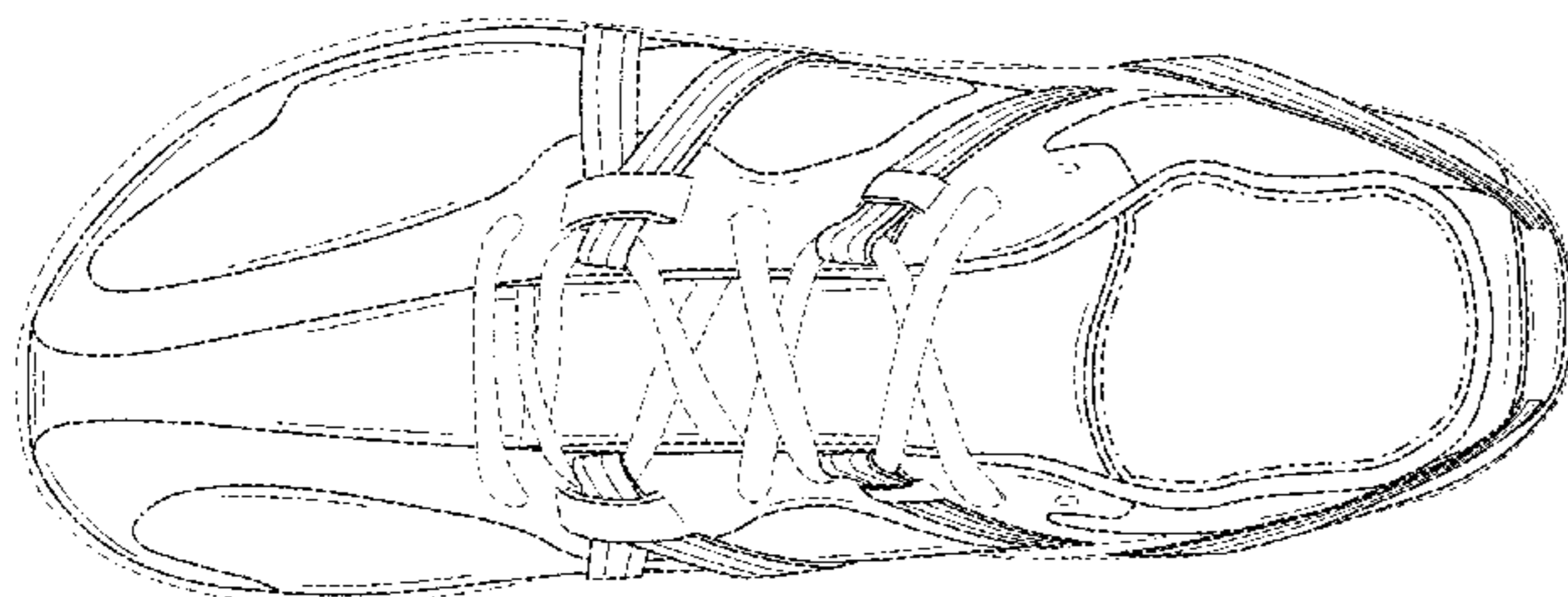
(57) **CLAIM**

We claim the ornamental design for footwear, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of footwear.
FIG. 2 is a bottom plan view of the footwear of FIG. 1.
FIG. 3 is an inner side elevation view of the footwear of FIG. 1.
FIG. 4 is an outer side elevation view of the footwear of FIG. 1.
FIG. 5 is a front elevation view of the footwear of FIG. 1; and,
FIG. 6 is a rear elevation view of the footwear of FIG. 1.
The broken lines in the figures are for the purpose of illustrating environmental structure and form no part of the claimed design. The dash-dot broken lines in the figures illustrate an unclaimed boundary and form no part of the claimed design.

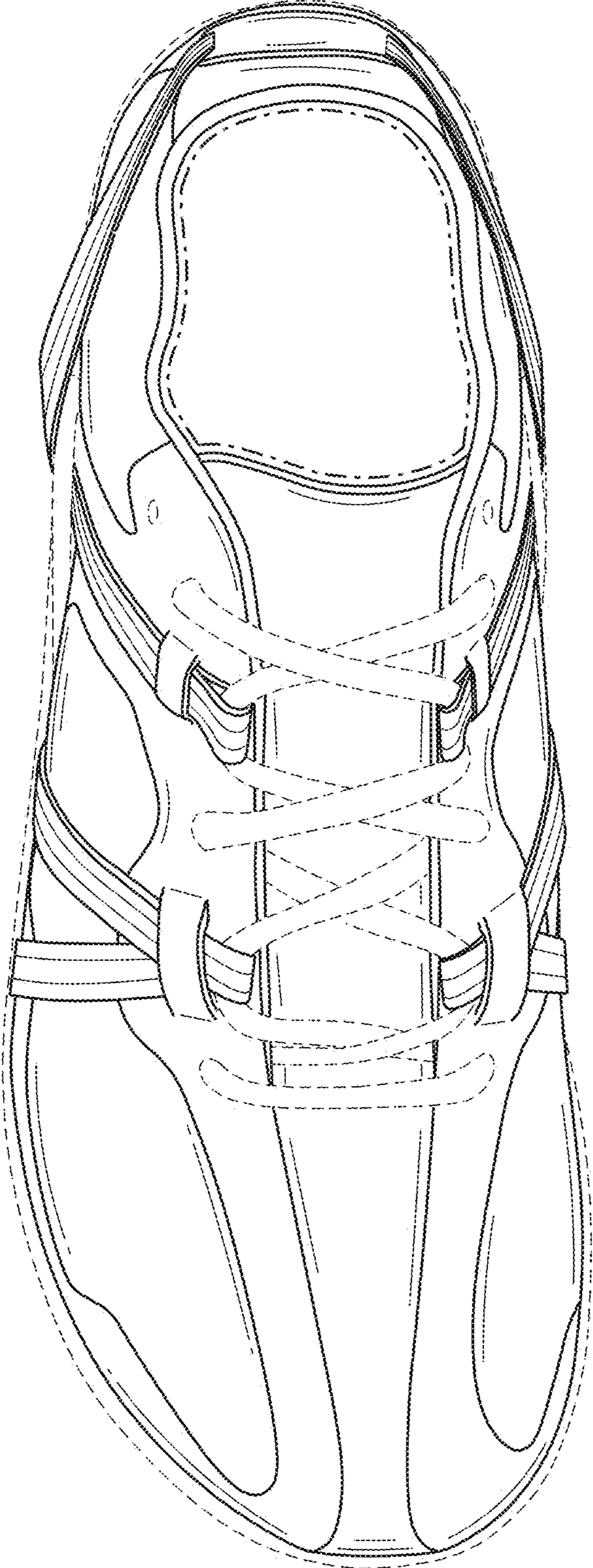

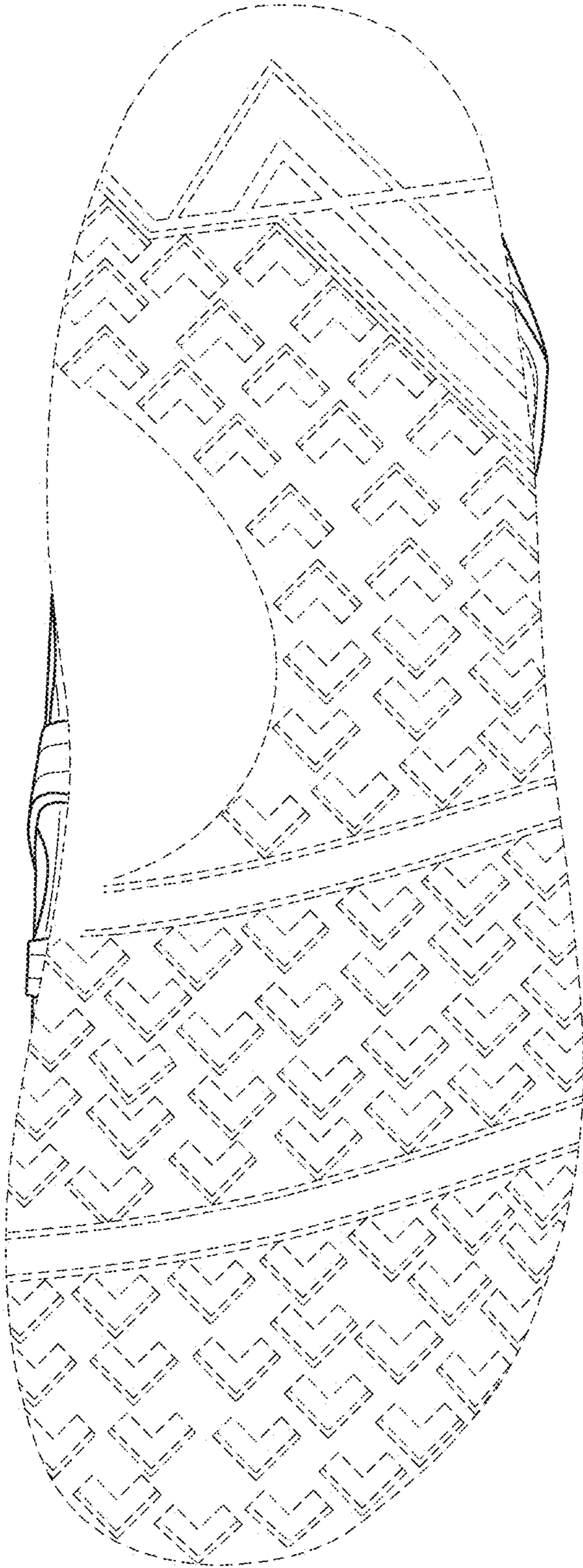

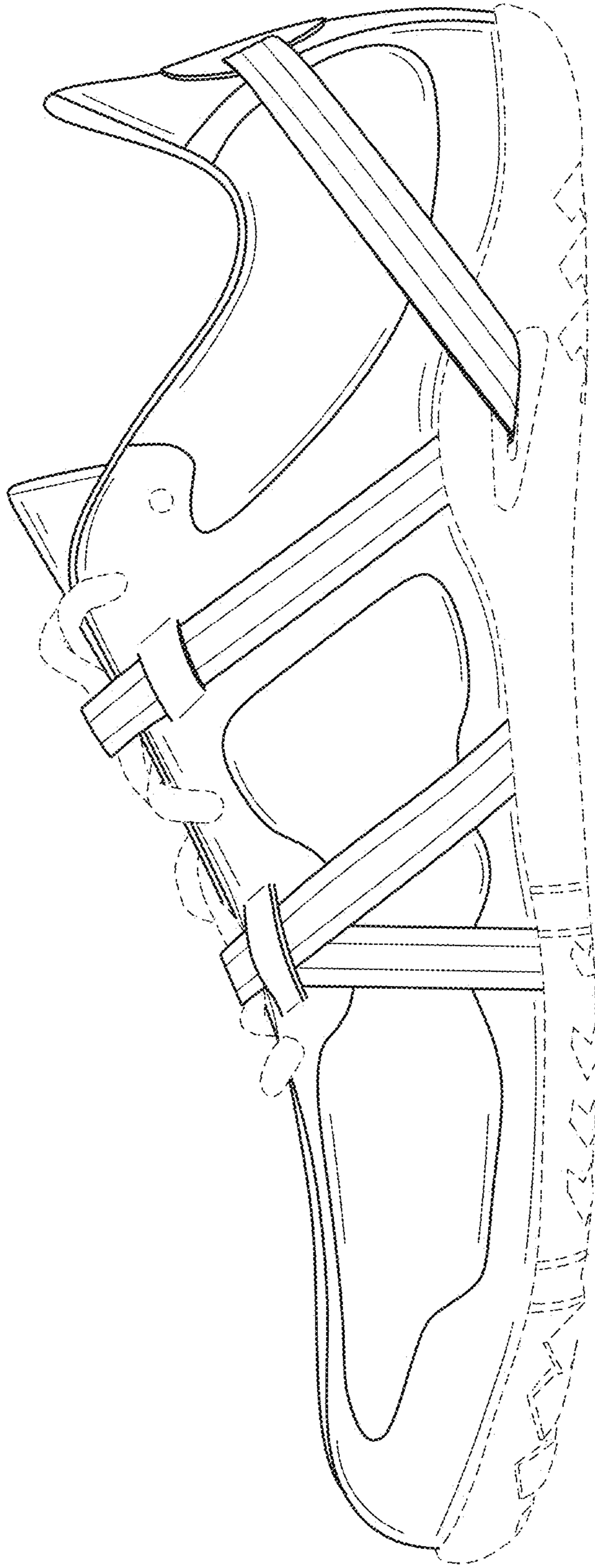

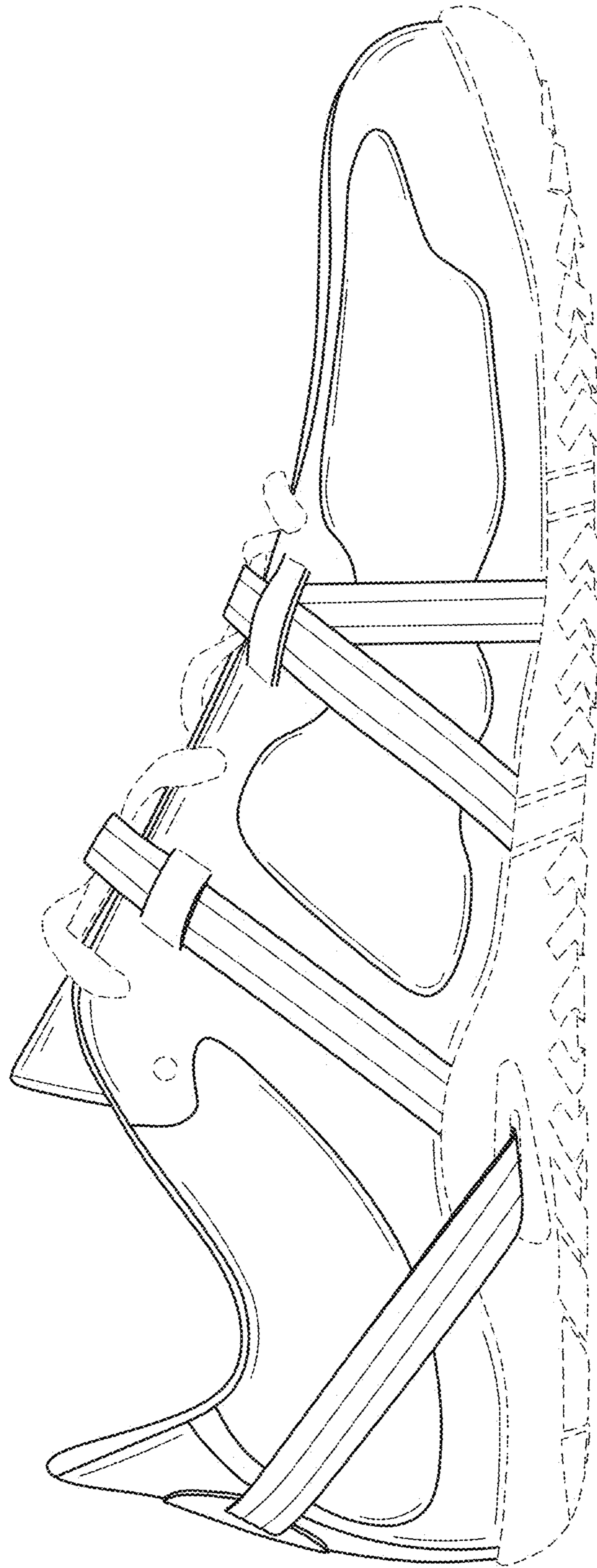

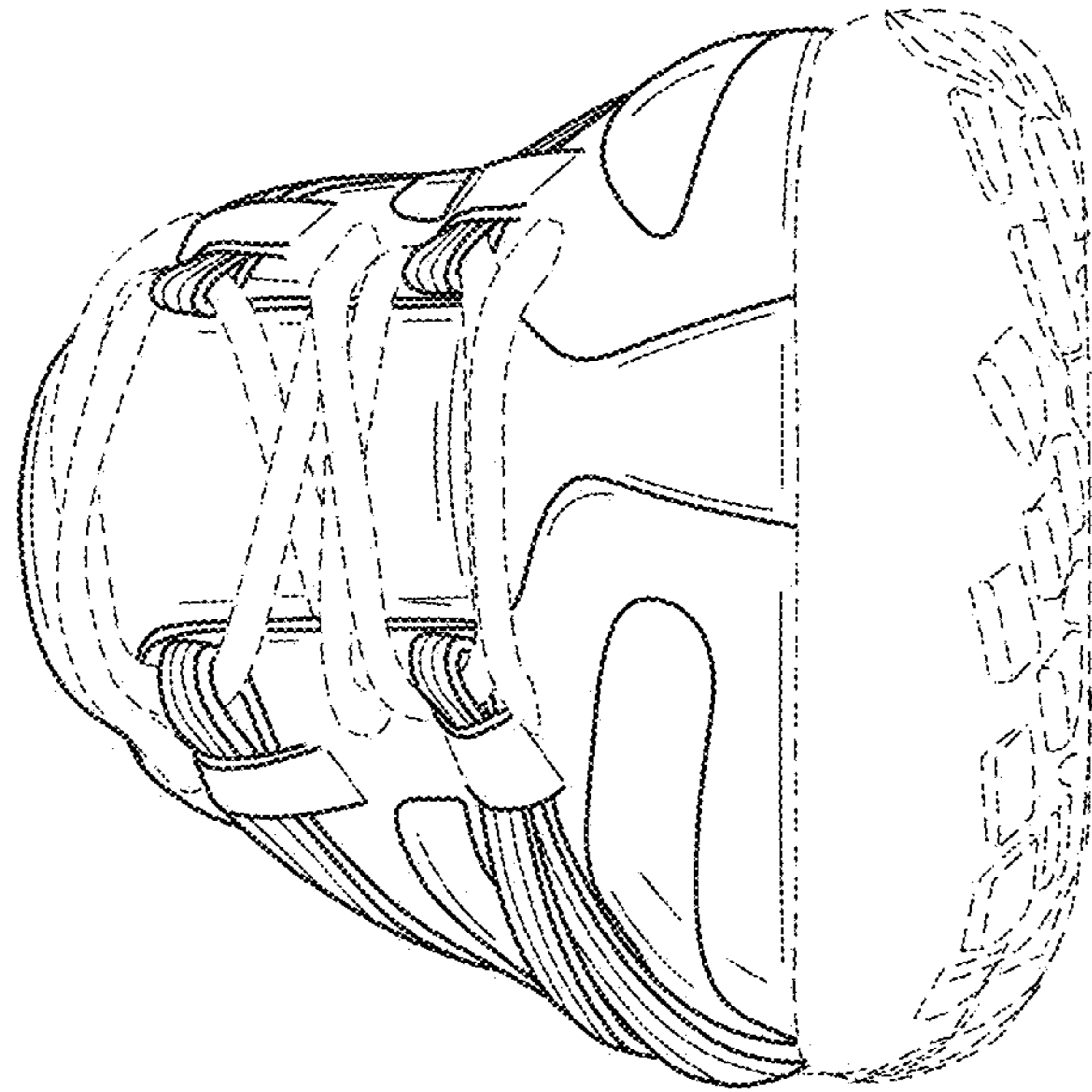

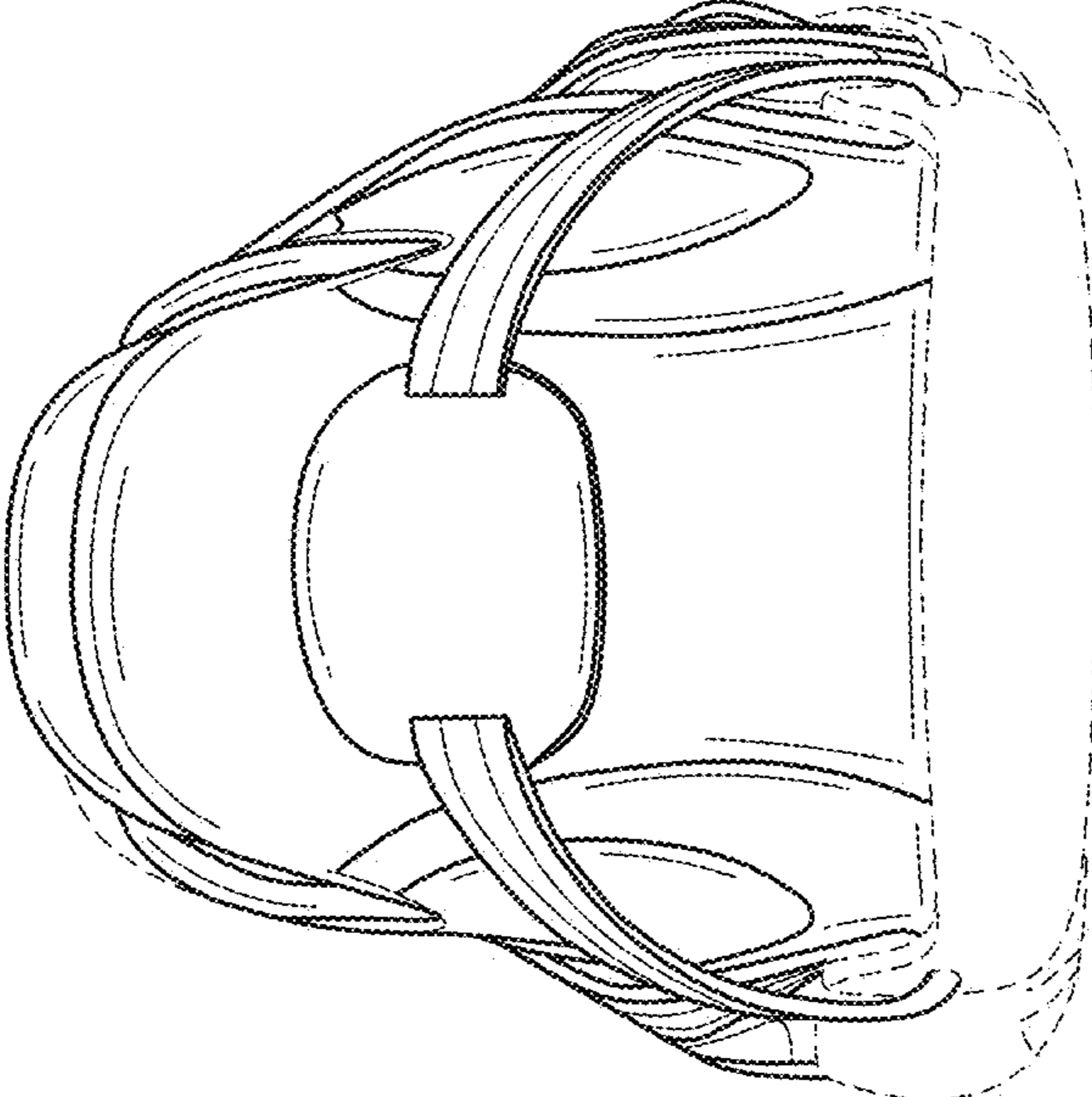
