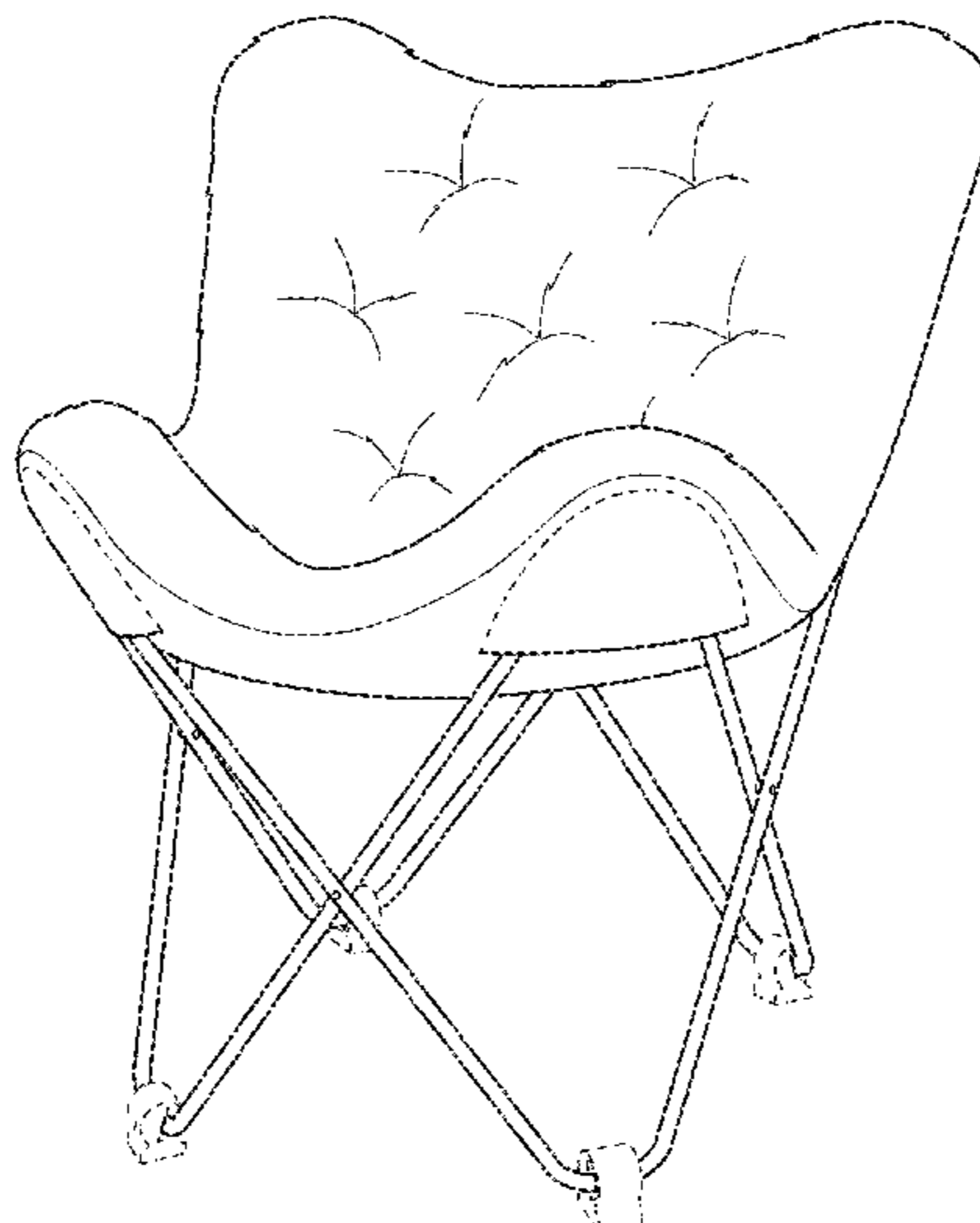
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front and left side perspective view of a butterfly chair in accordance with my new design;

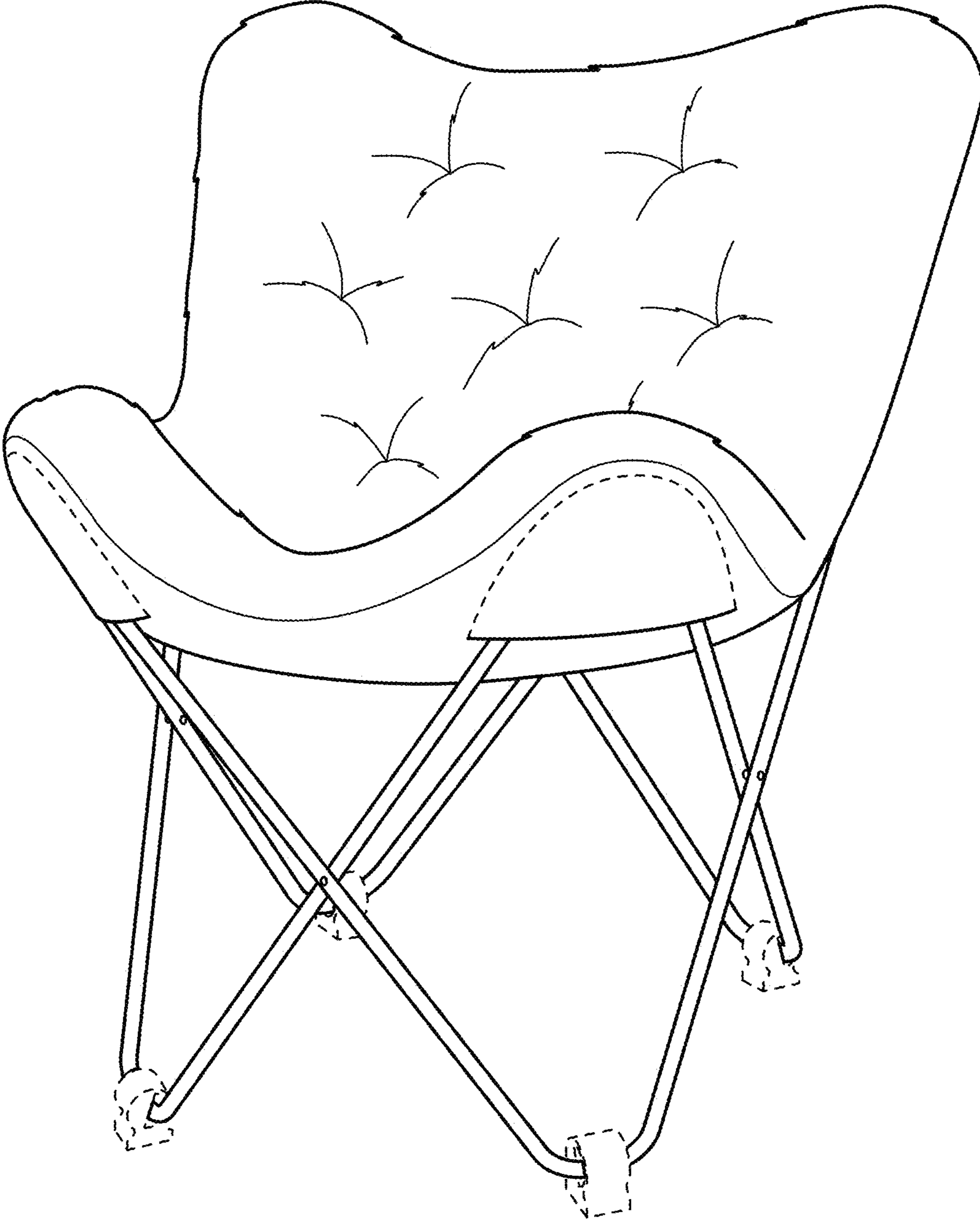

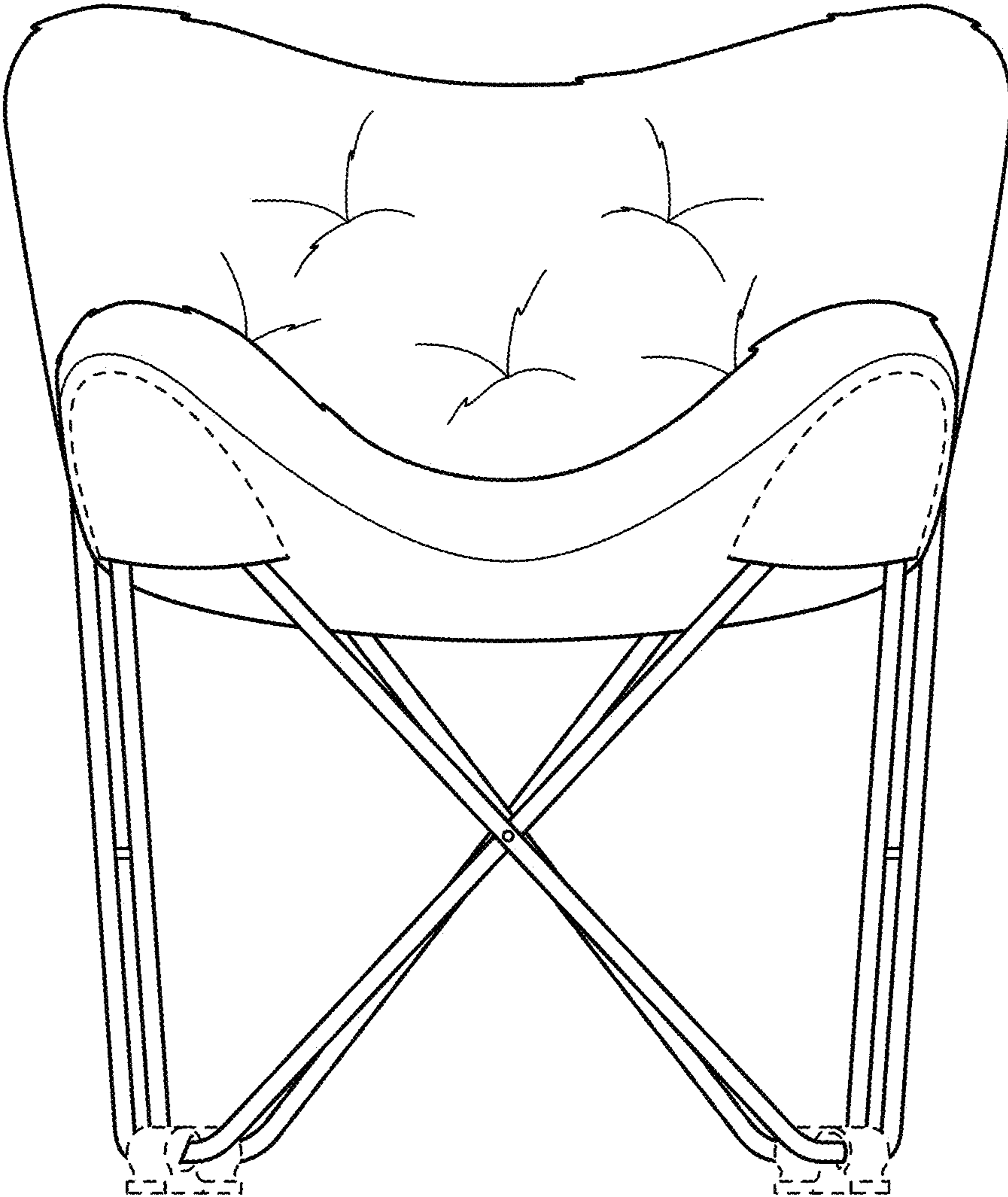

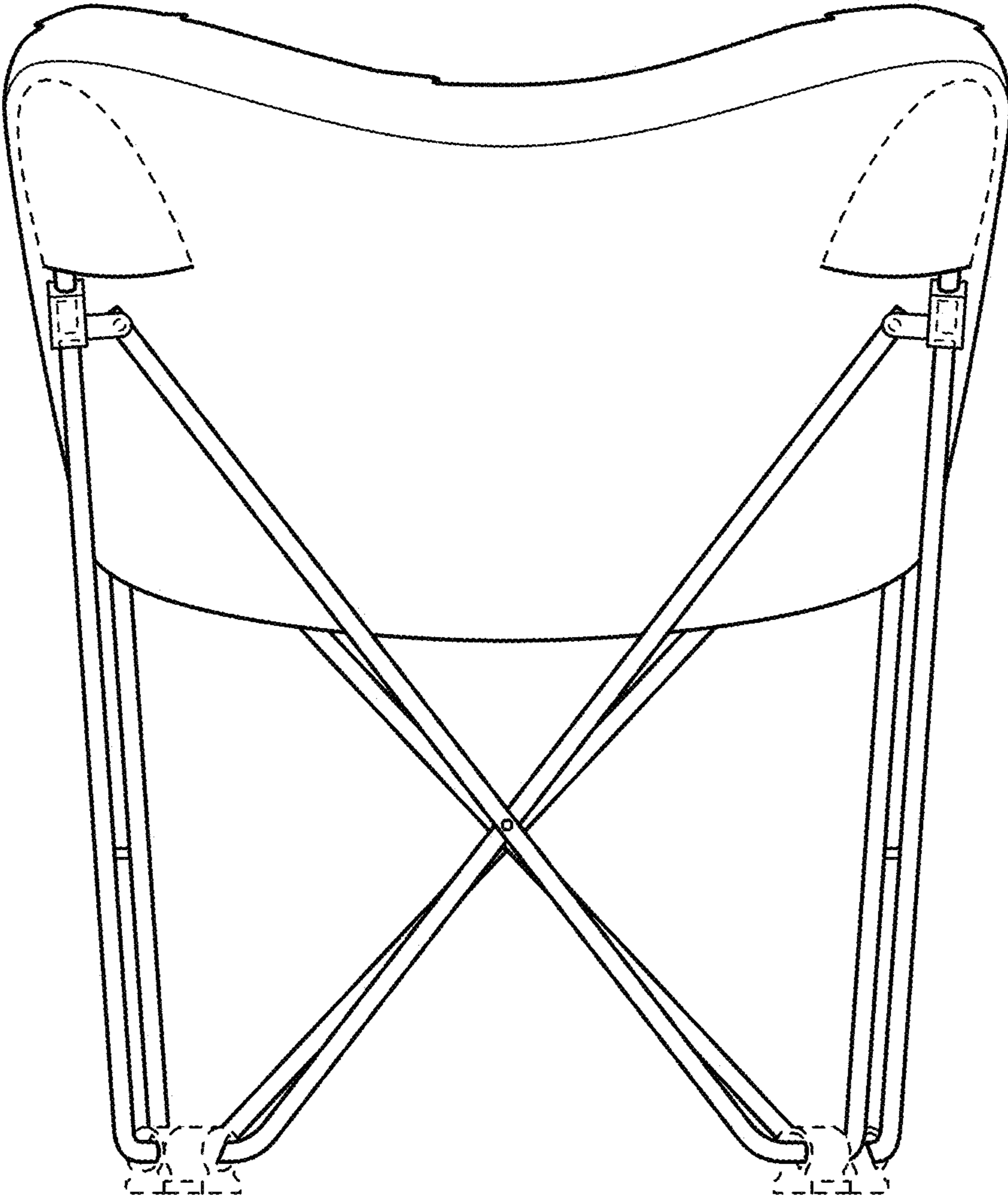

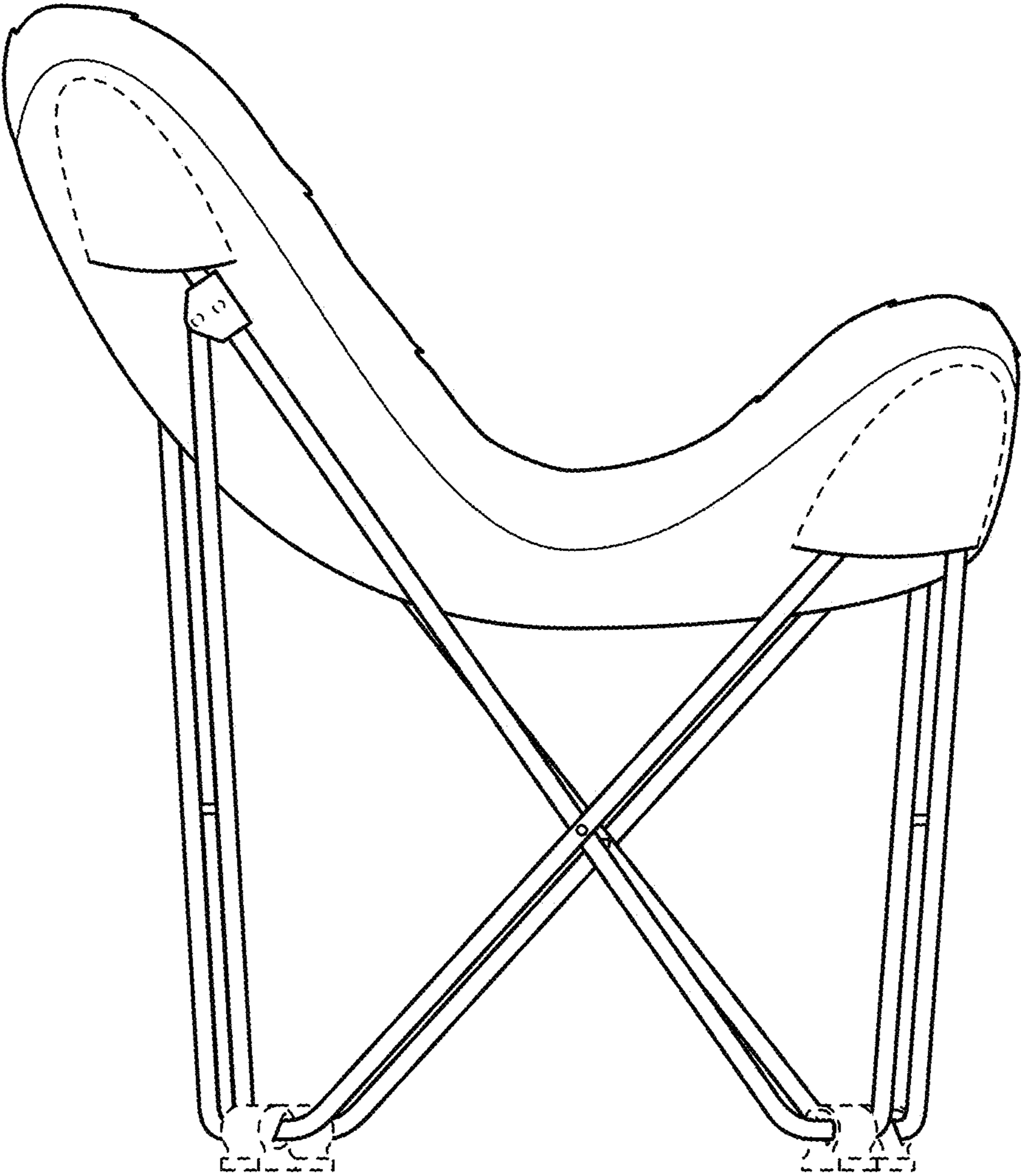

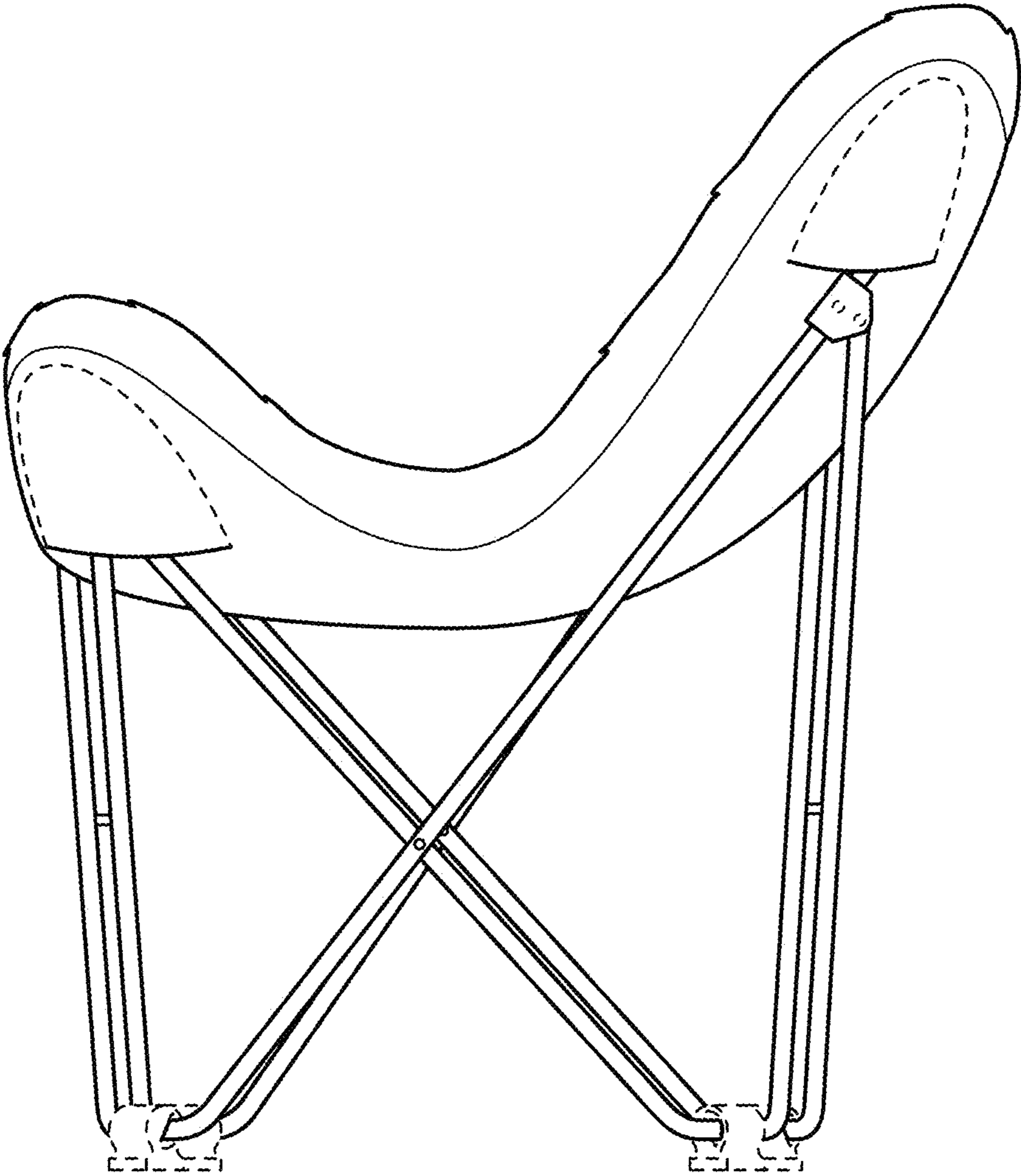
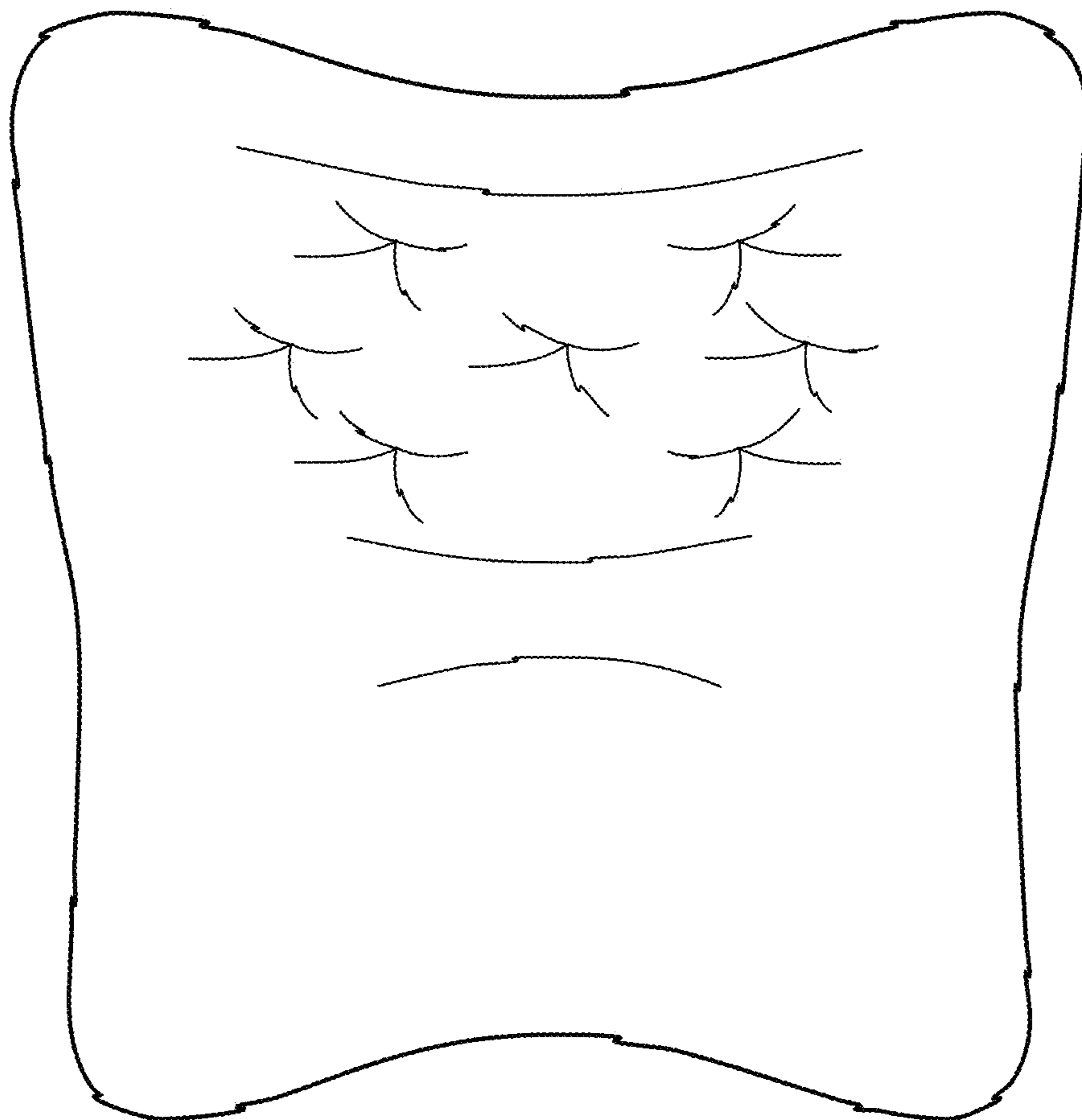
