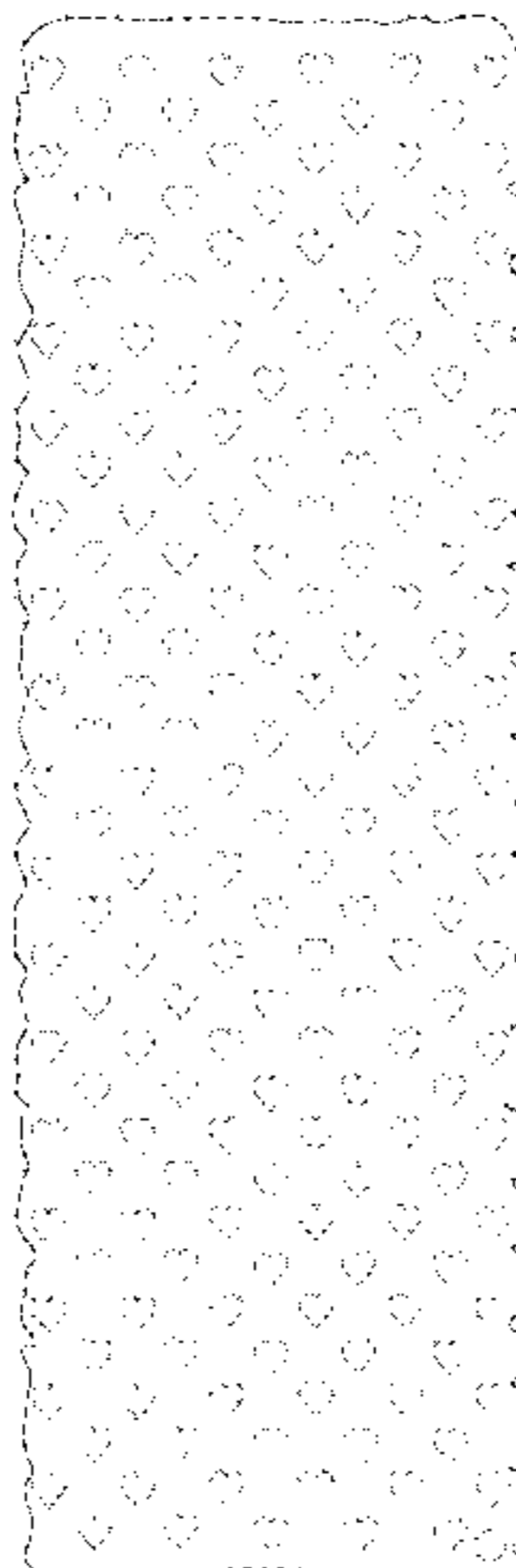
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front view of a sleeping pad, showing our new design;

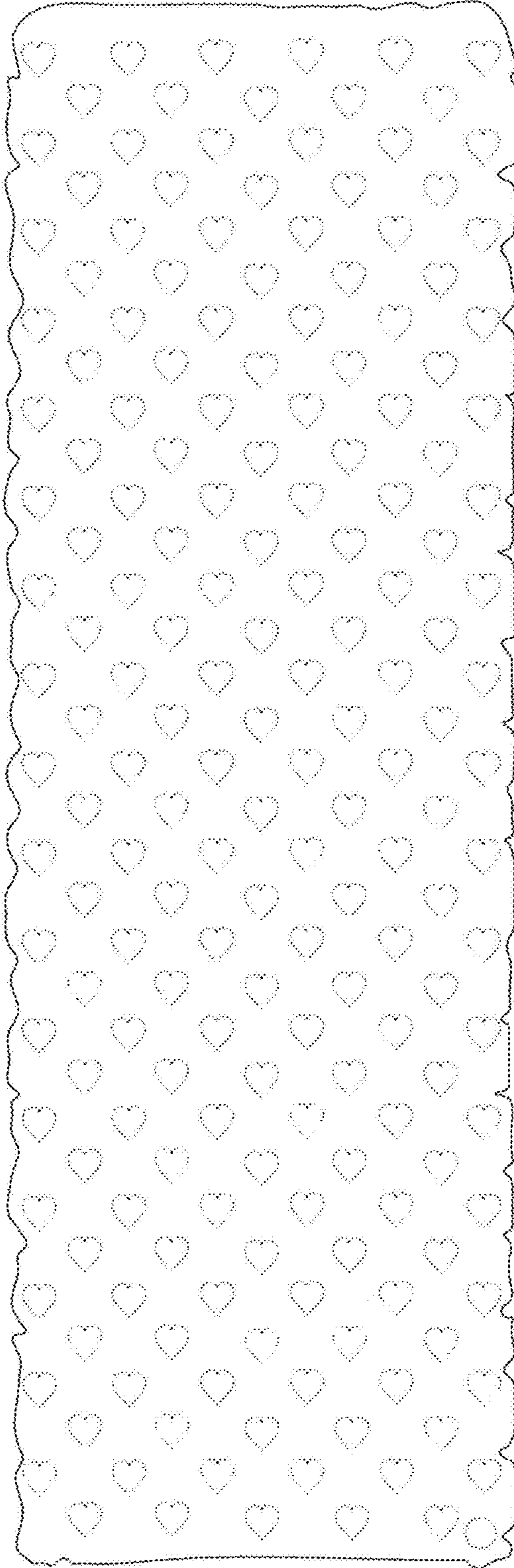

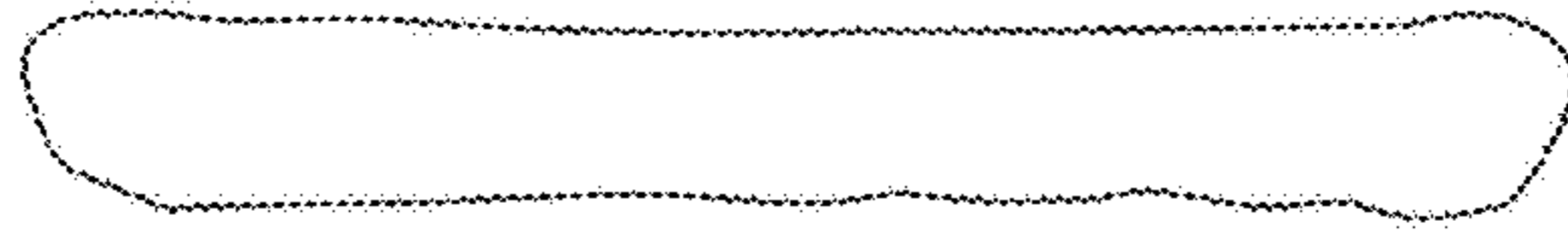

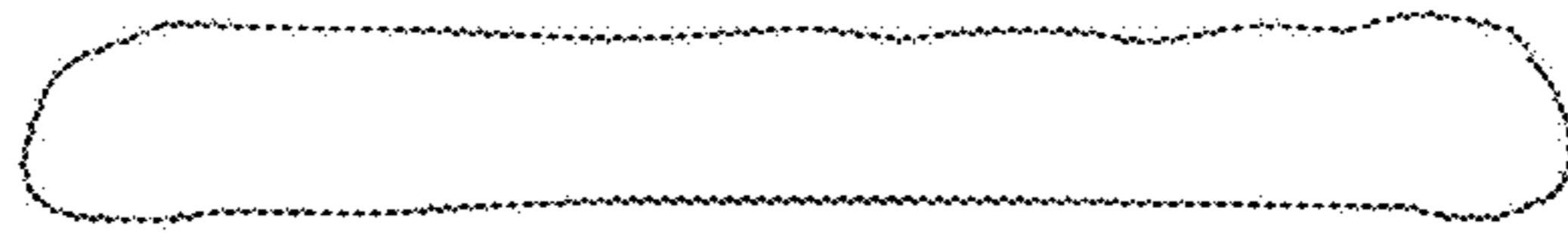

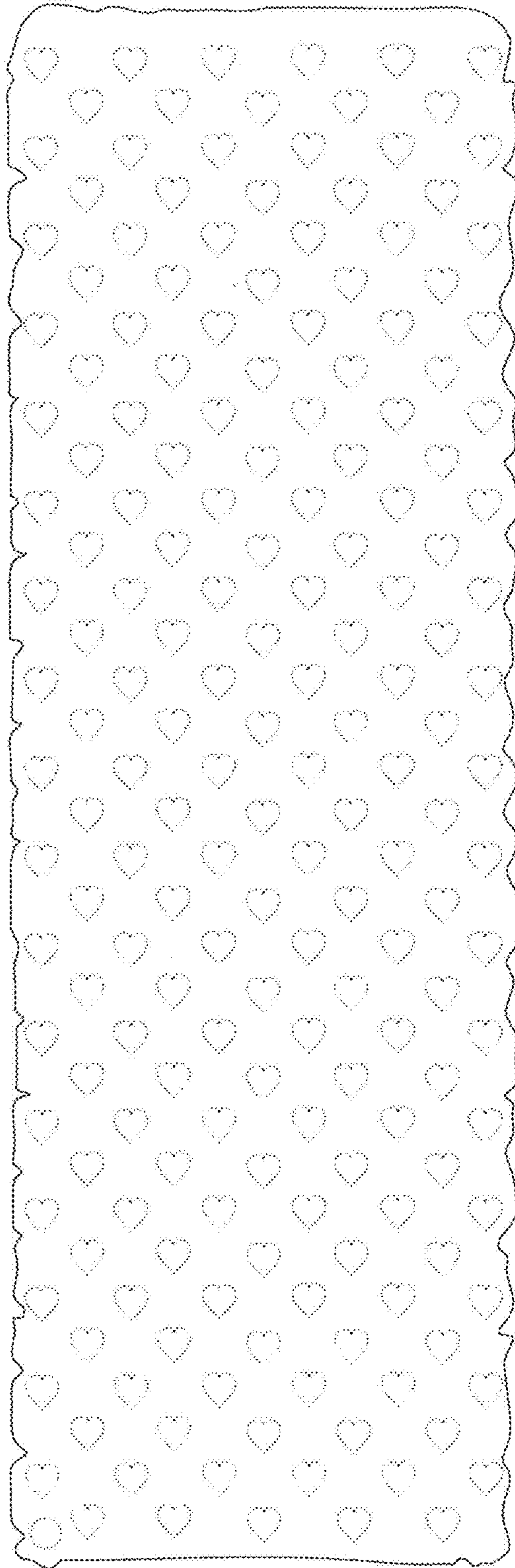

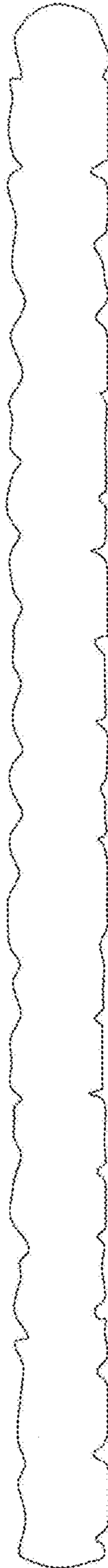

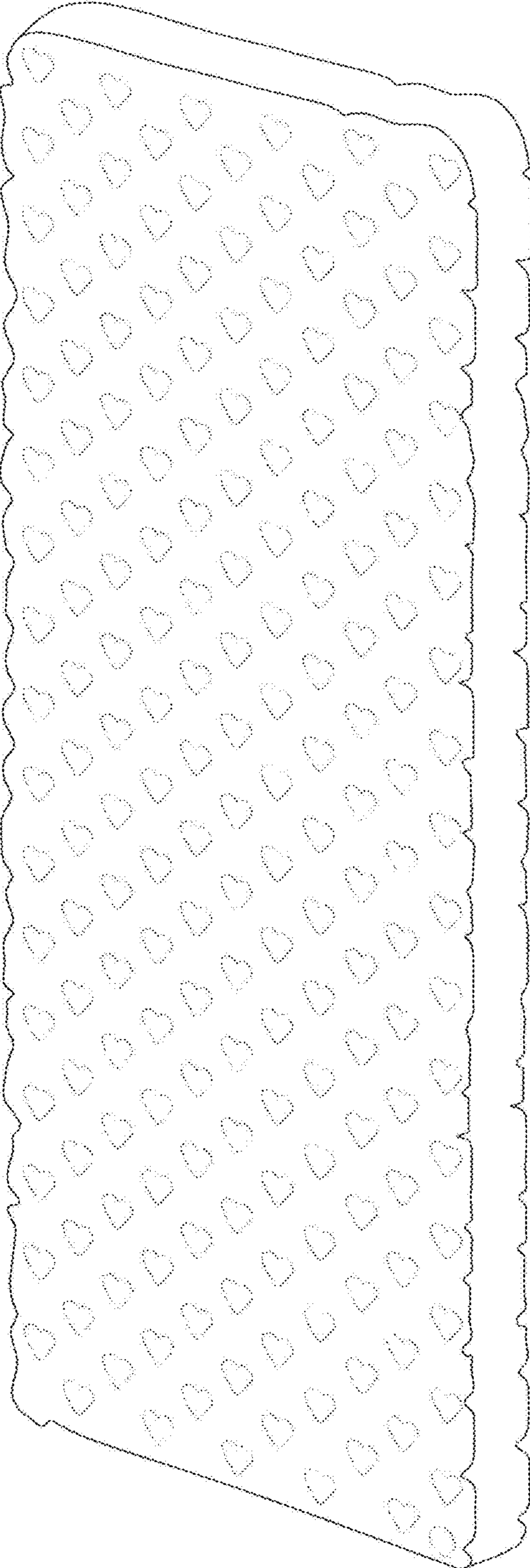
