The ornamental design for a mattress, as shown and described.

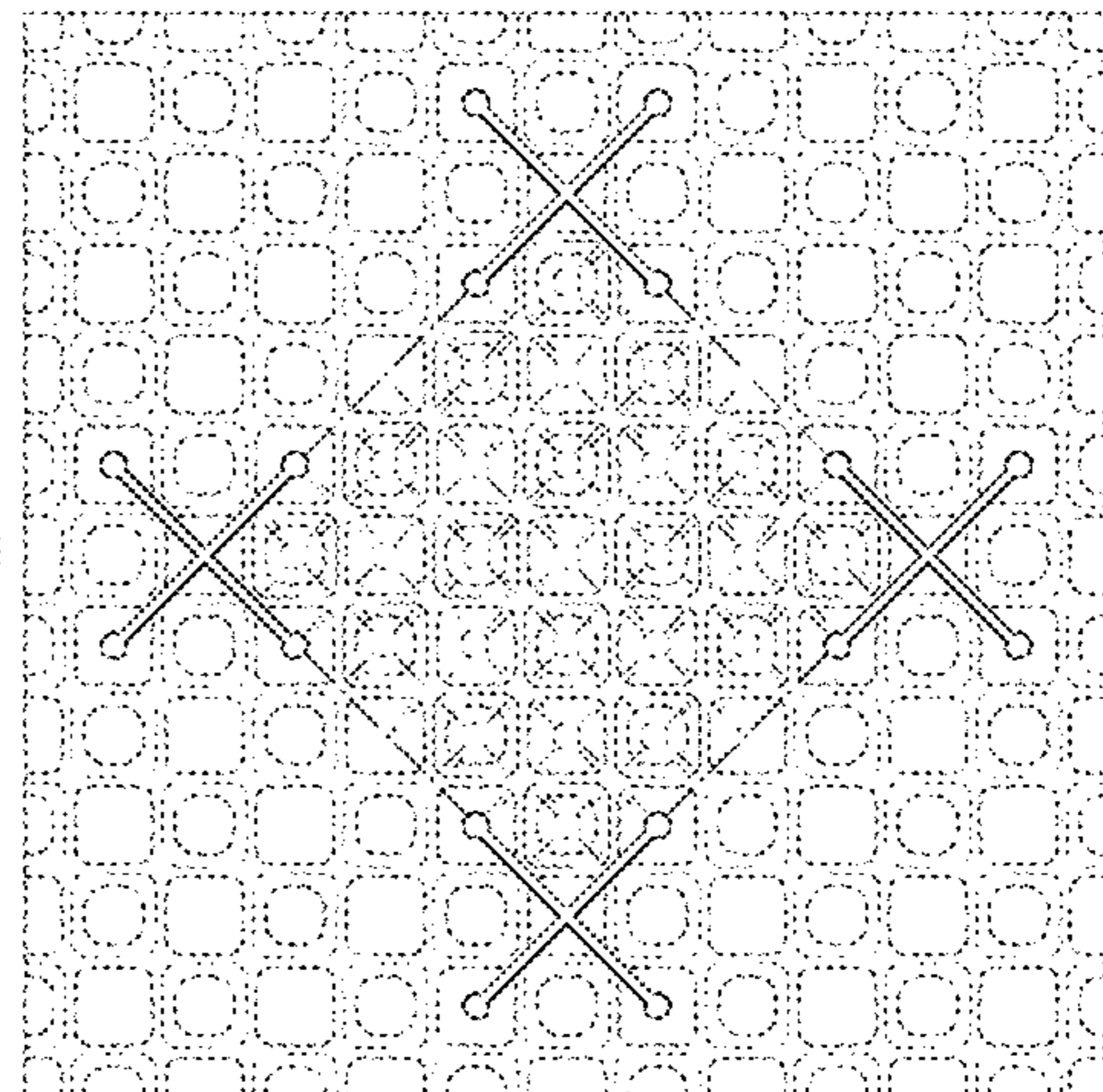
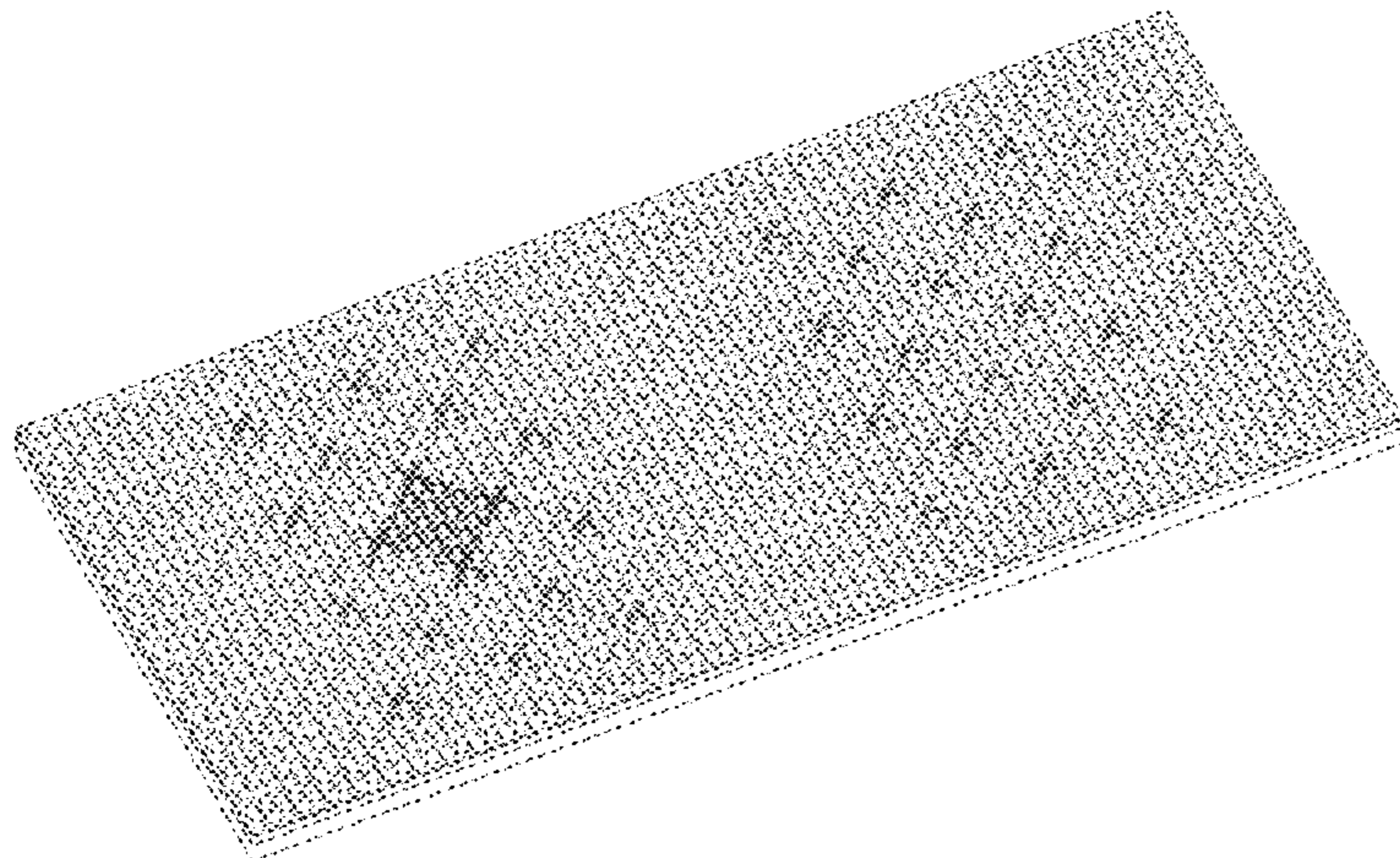
DESCRIPTION

Reproduction 1.12 is an enlarged cross-sectional view taken alarm the center of reproduction 1.9. Reproduction 1.13 is an enlarged cross-sectional view a little bit above the center of reproduction 1.9 at the claimed four circular holes.

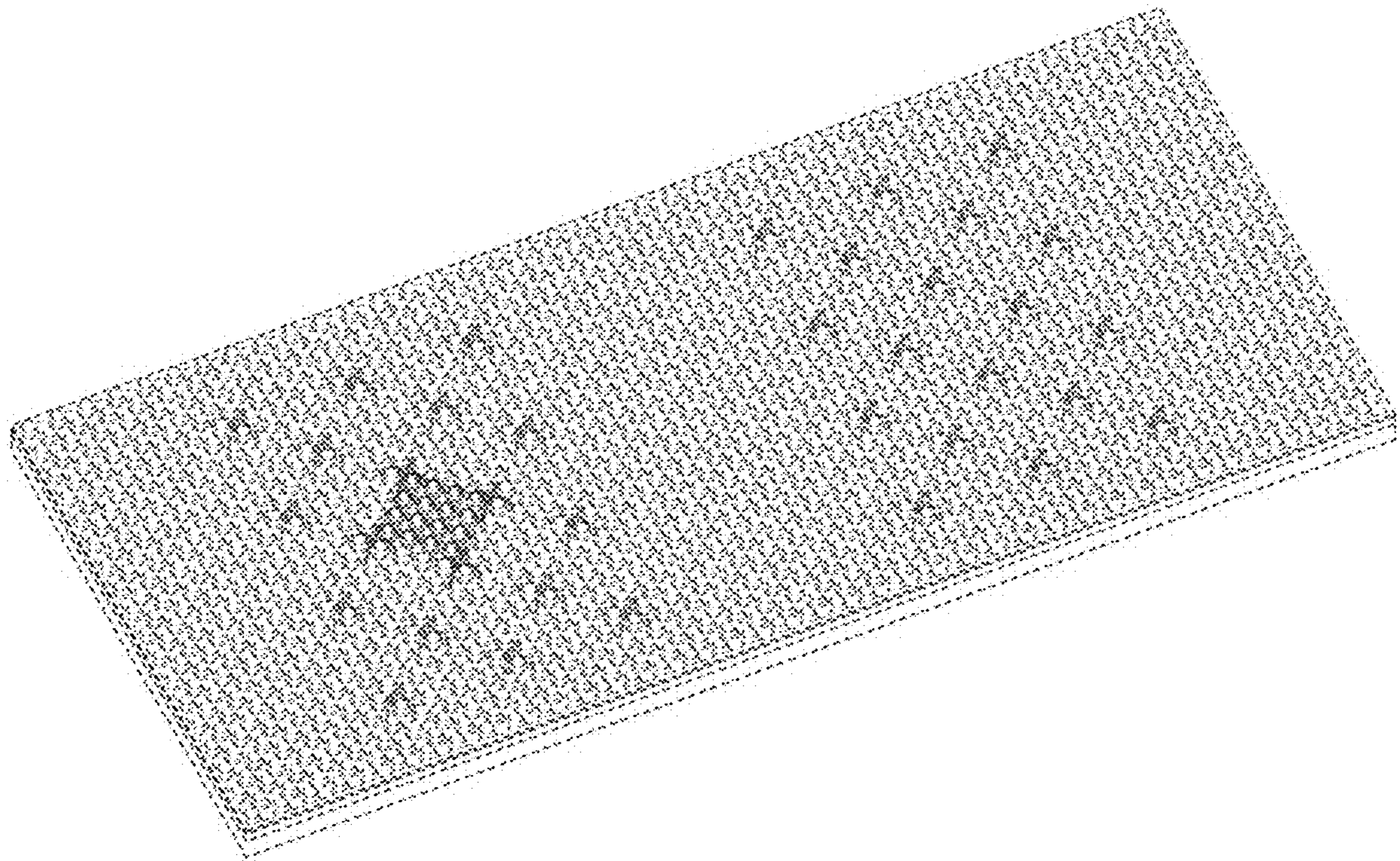

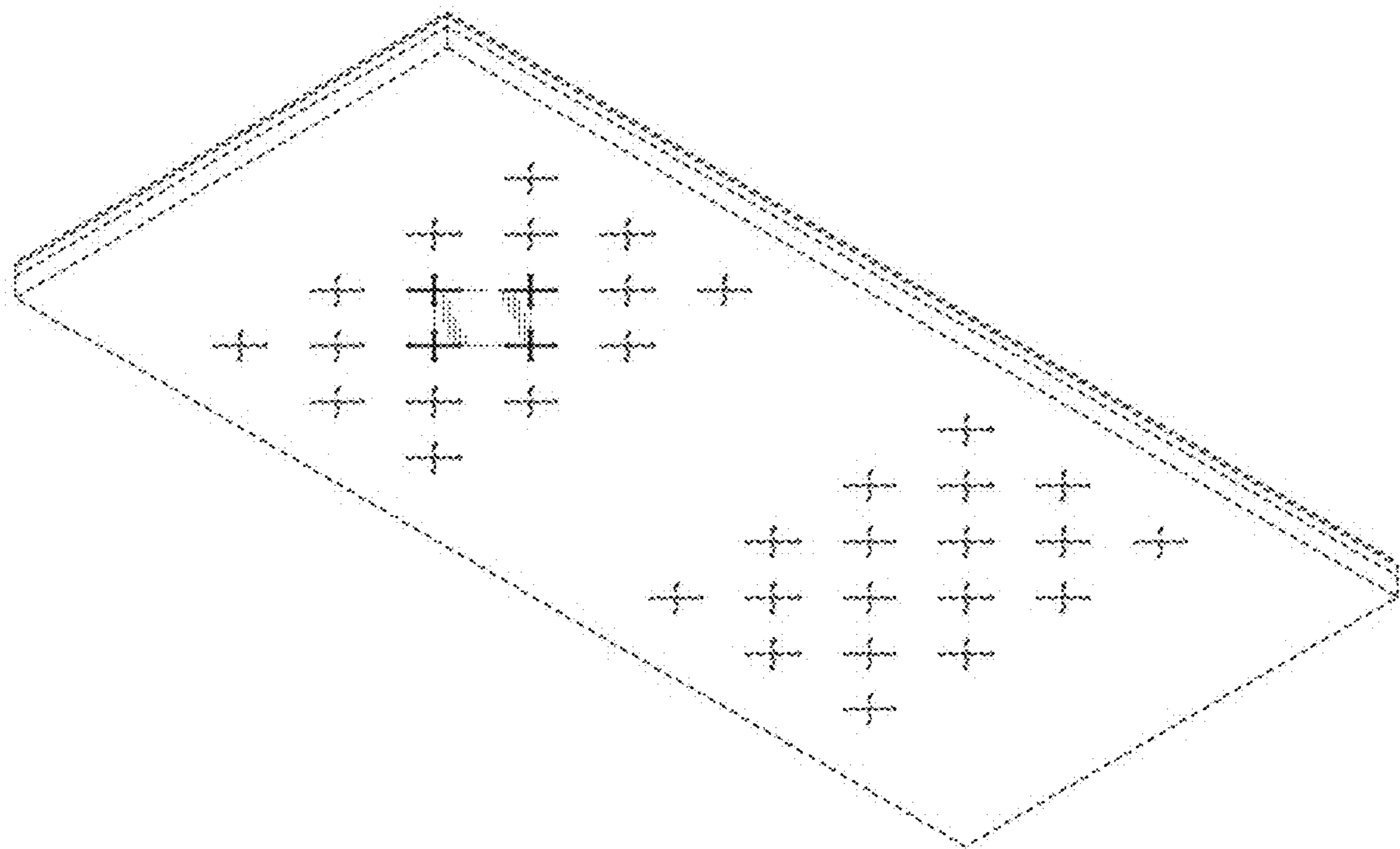

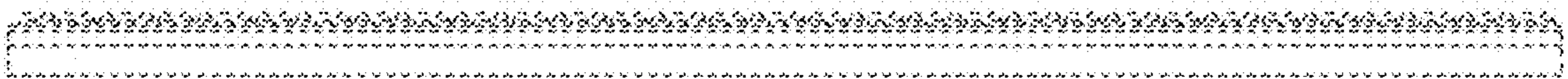

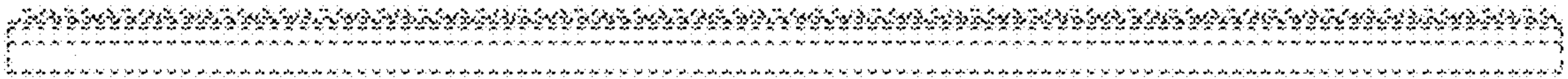

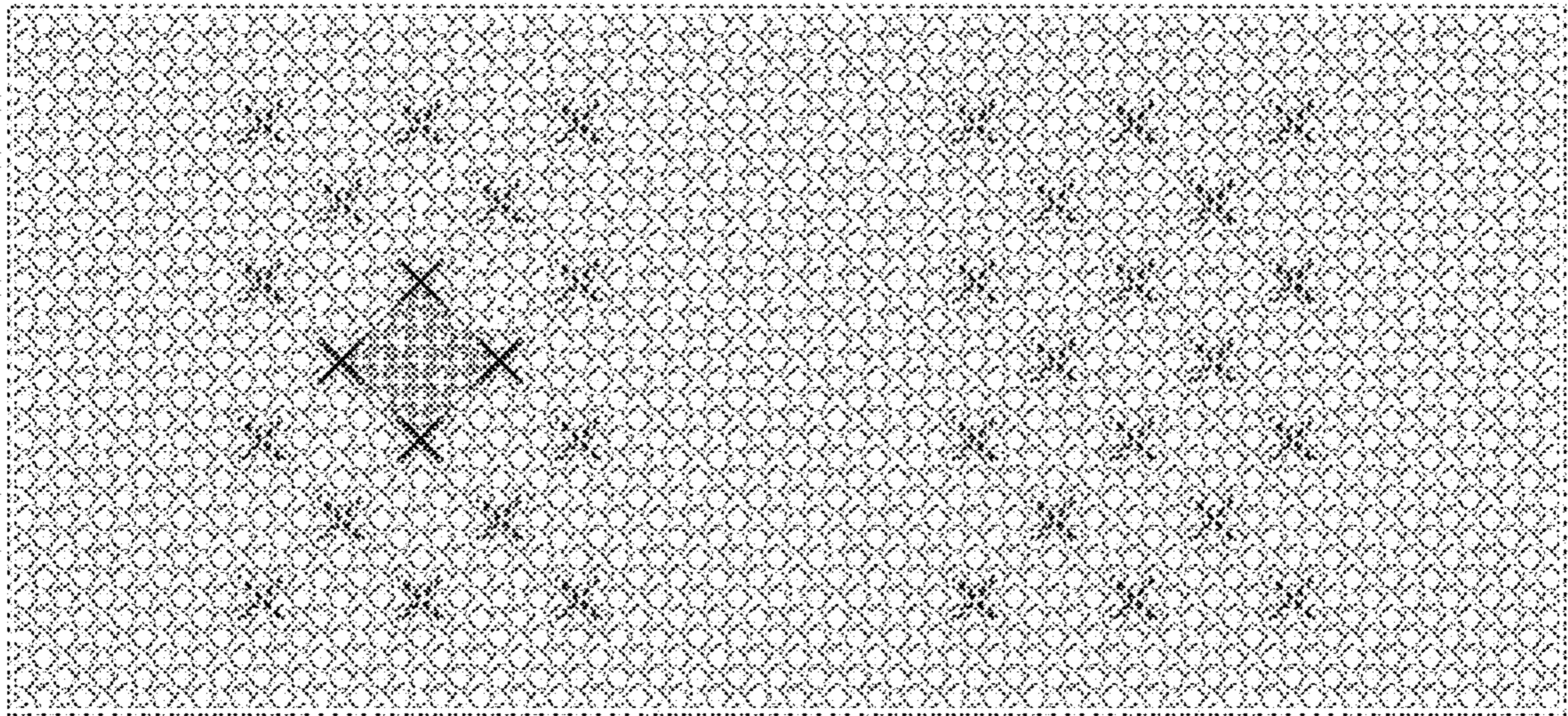

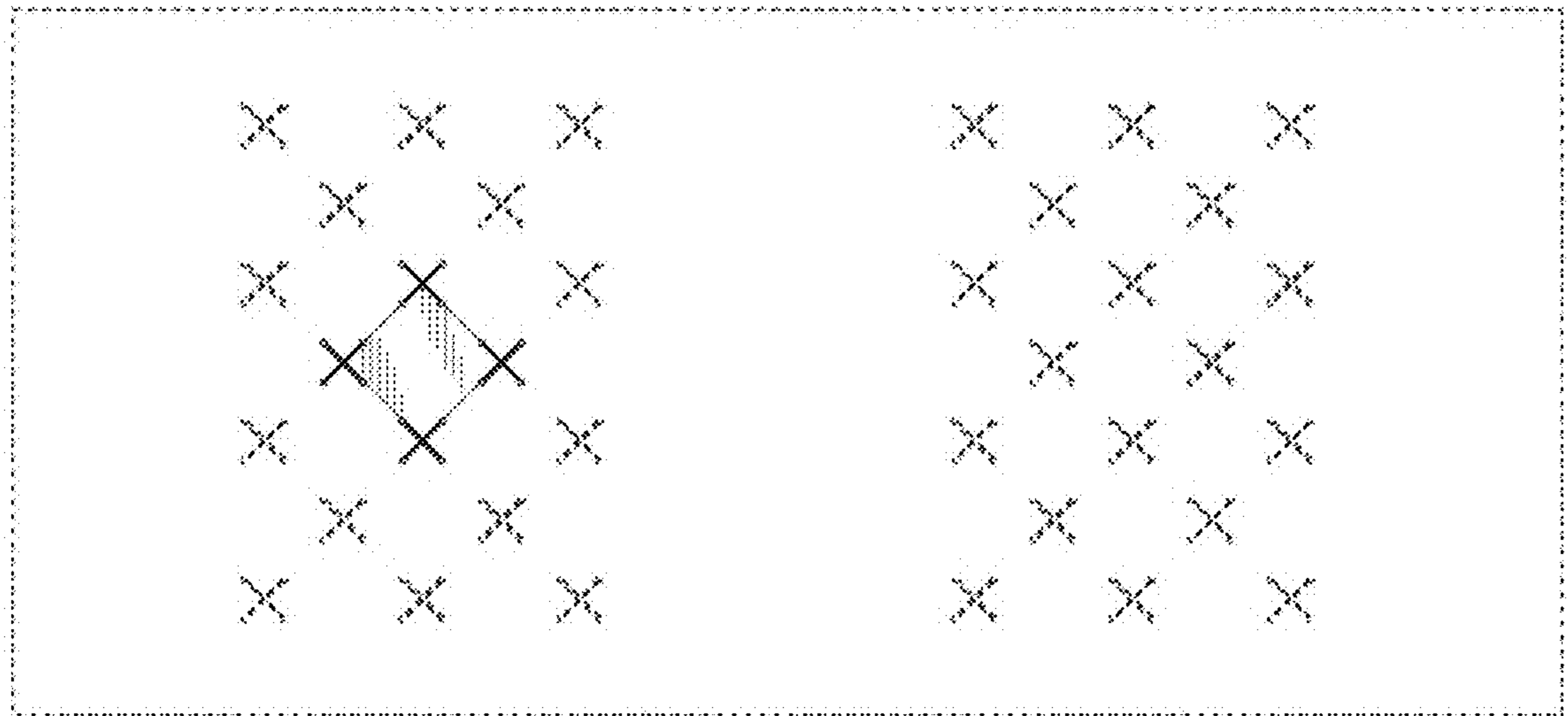

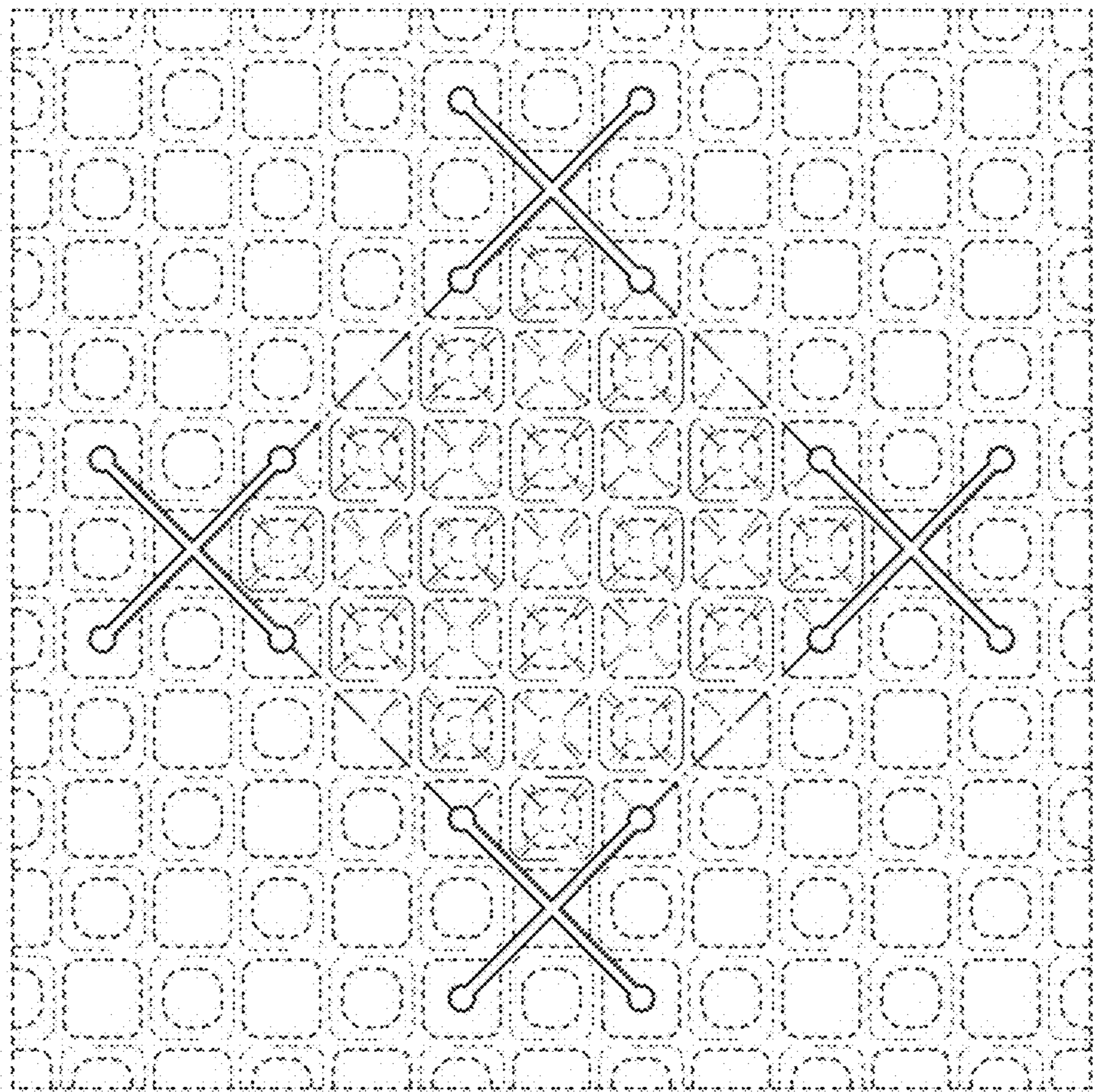

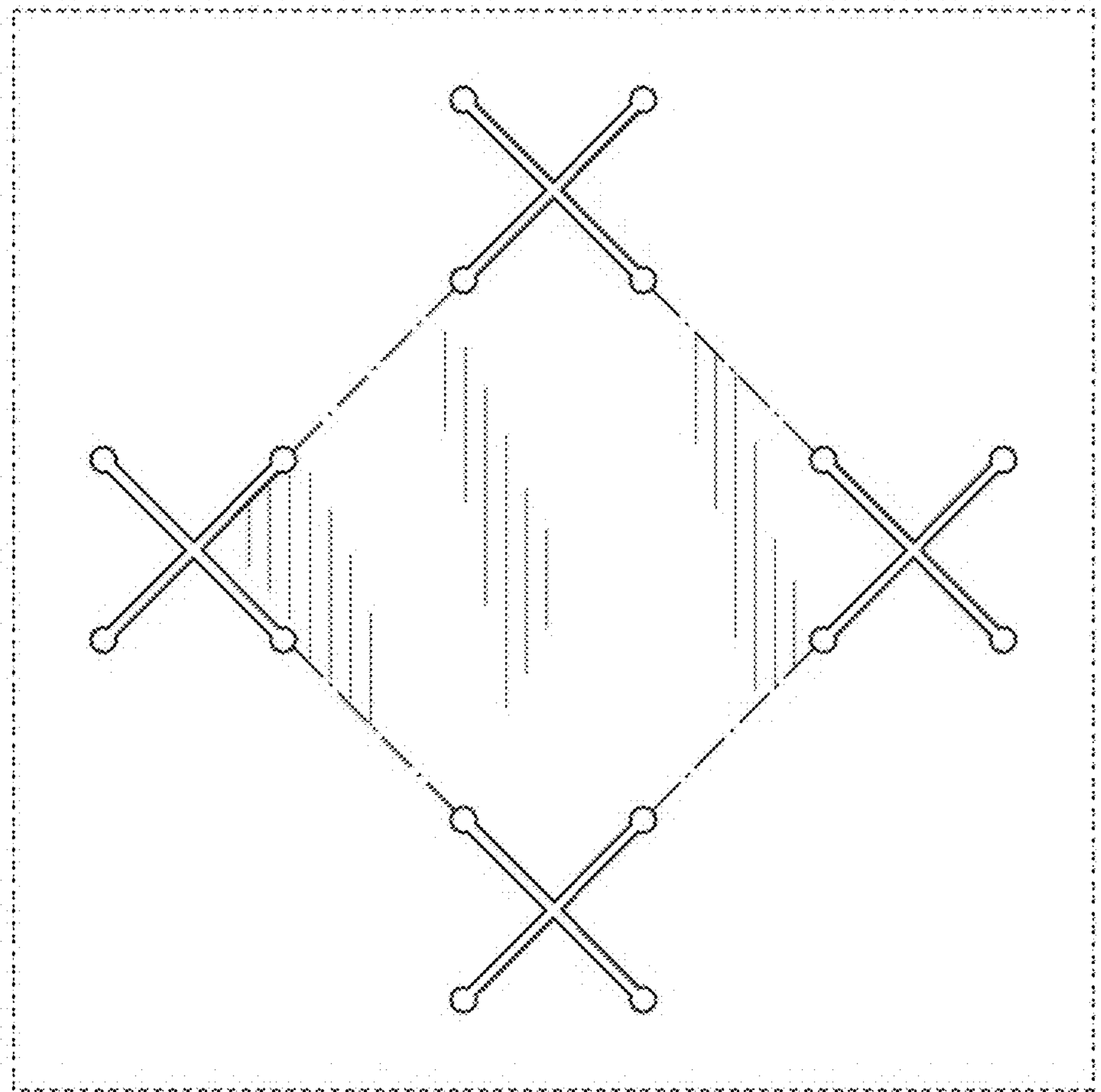

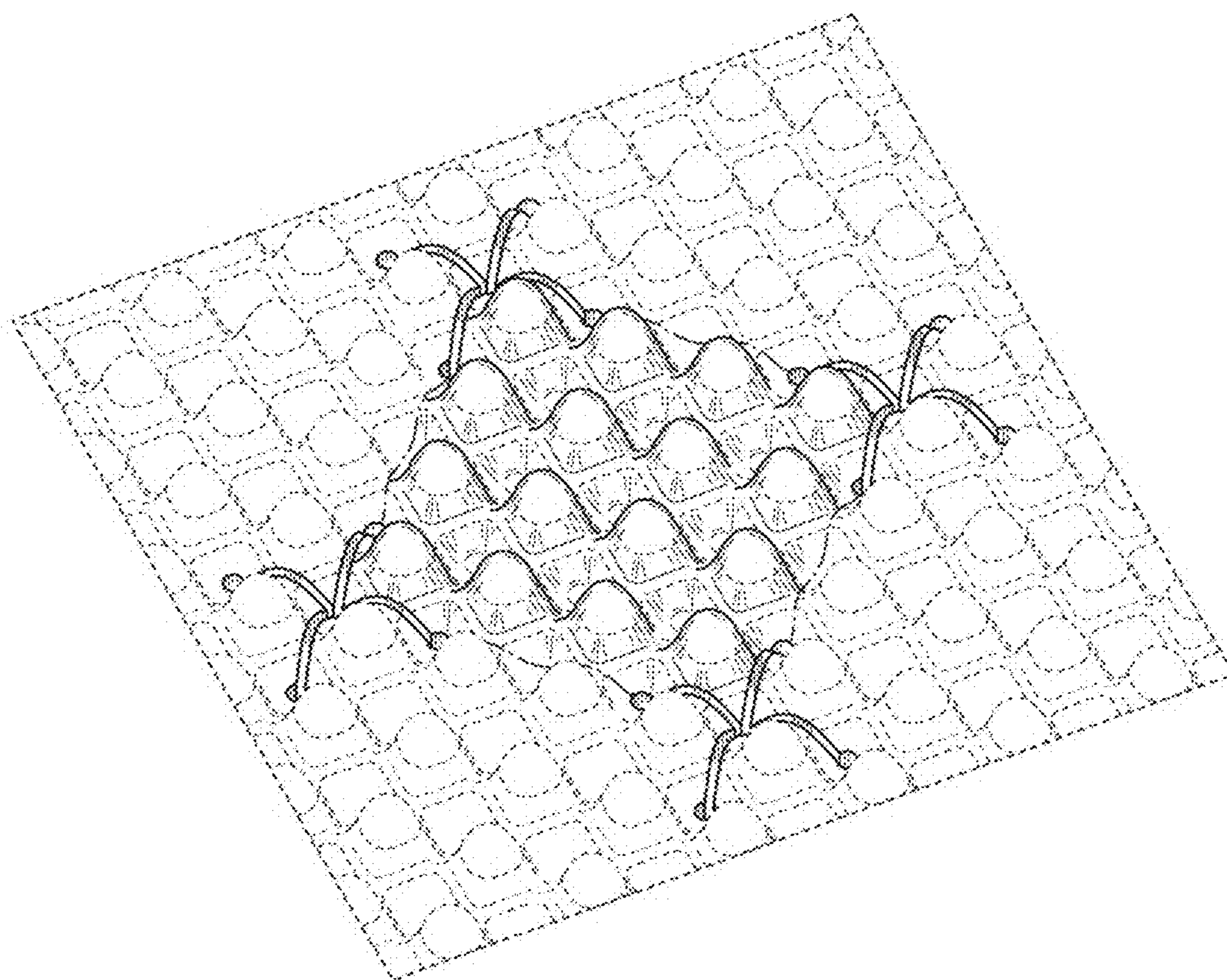

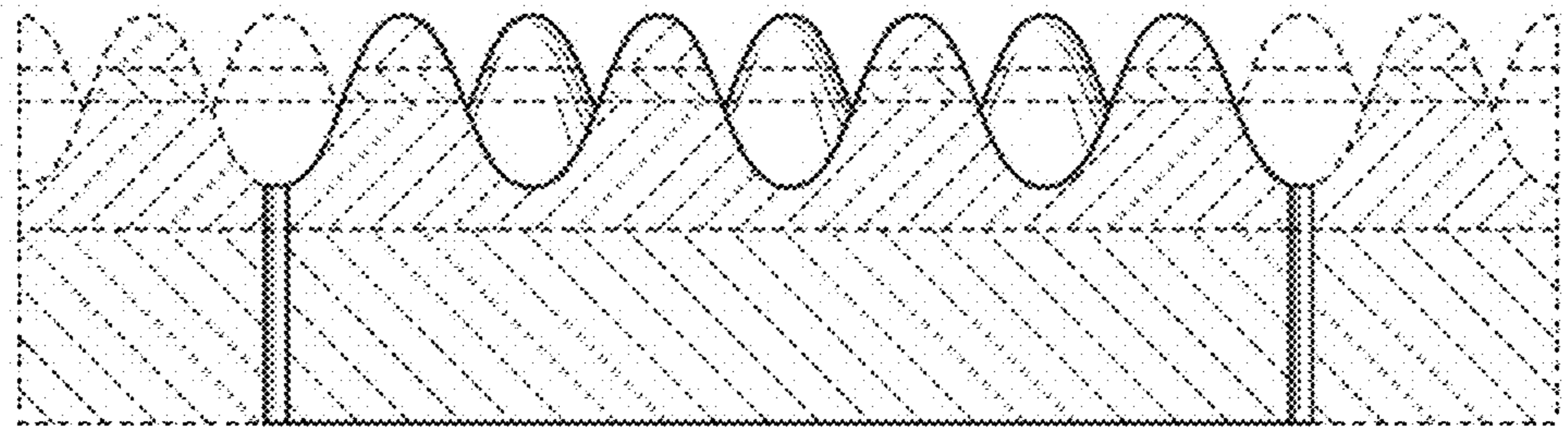
