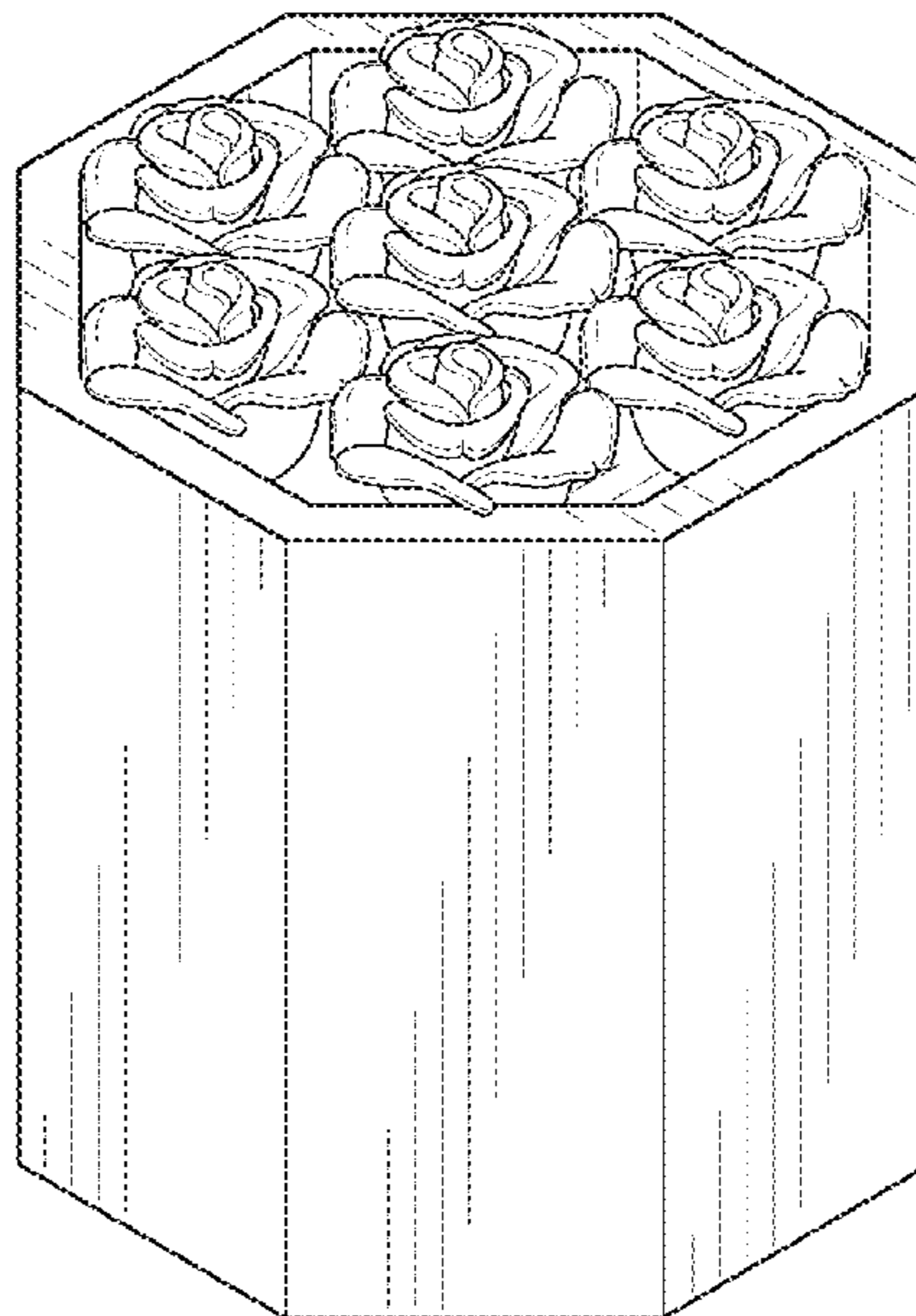
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top view of a flowerpot showing my new design. FIG. 2 is a first perspective view thereof; FIG. 3 is a second perspective view thereof; FIG. 4 is a front view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a rear view thereof; FIG. 7 is a left side view thereof; and, FIG. 8 is a bottom view thereof. The broken lines in FIG. 8 illustrate portions of the flowerpot that form no part of the claimed design.

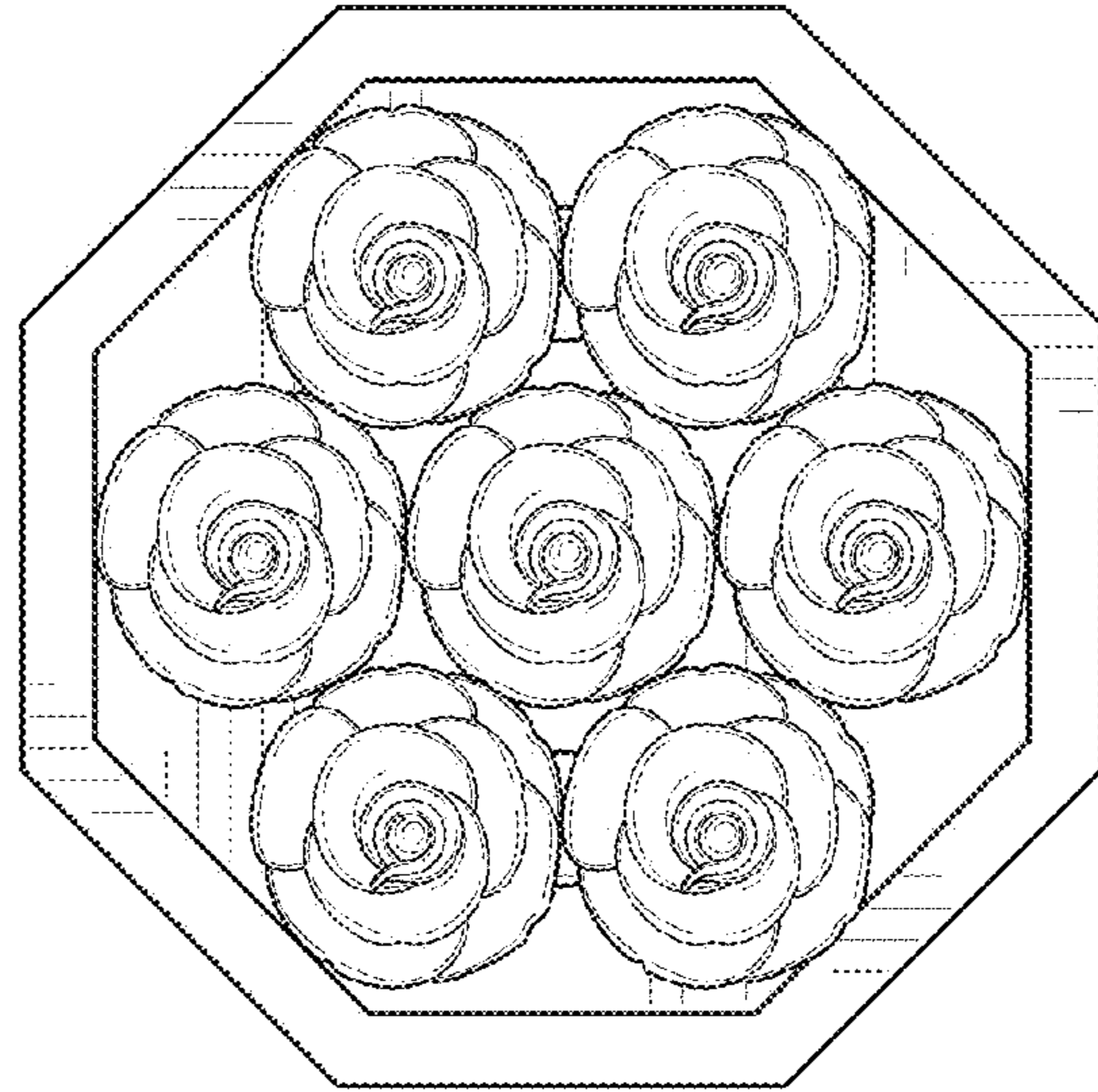

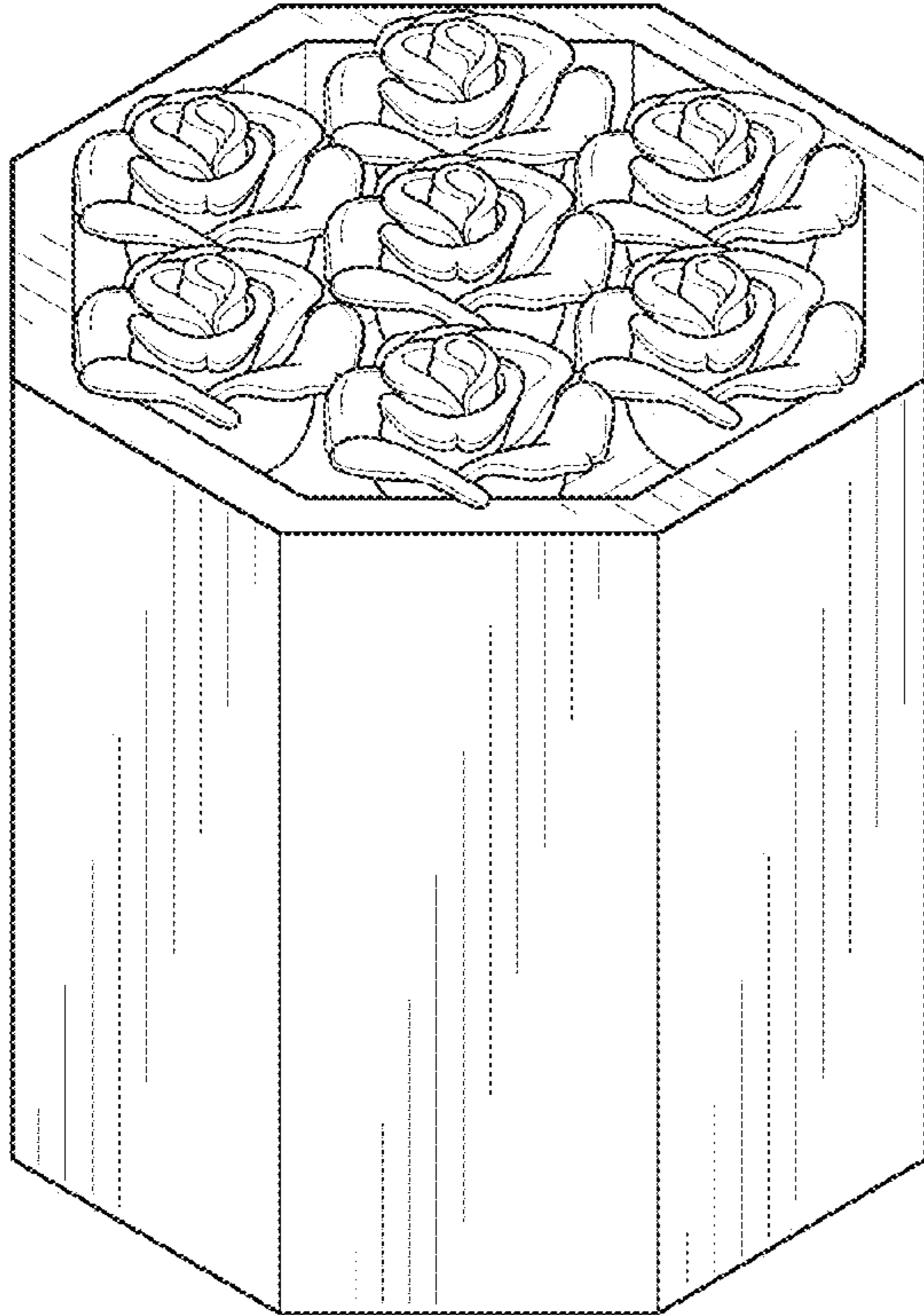

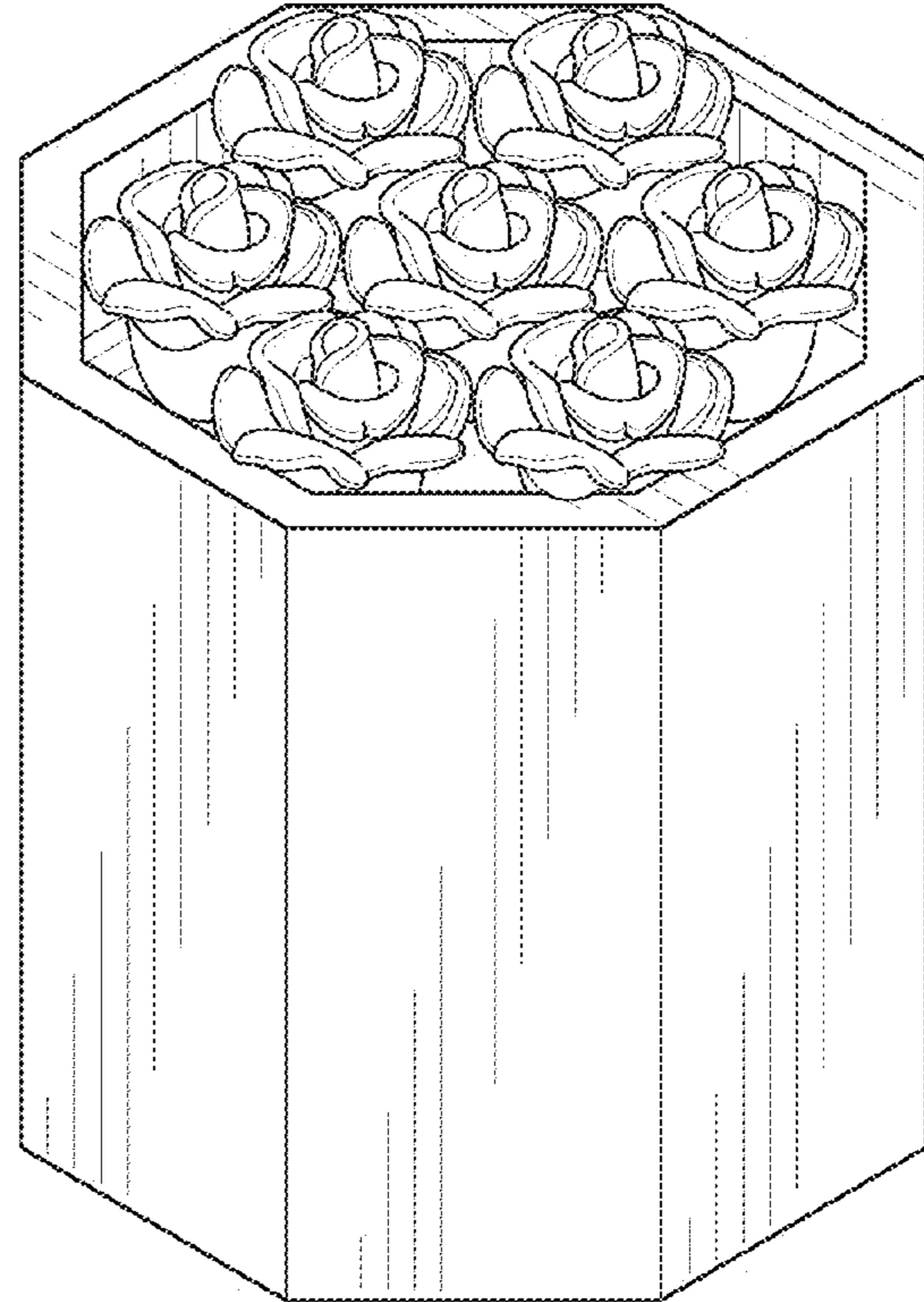

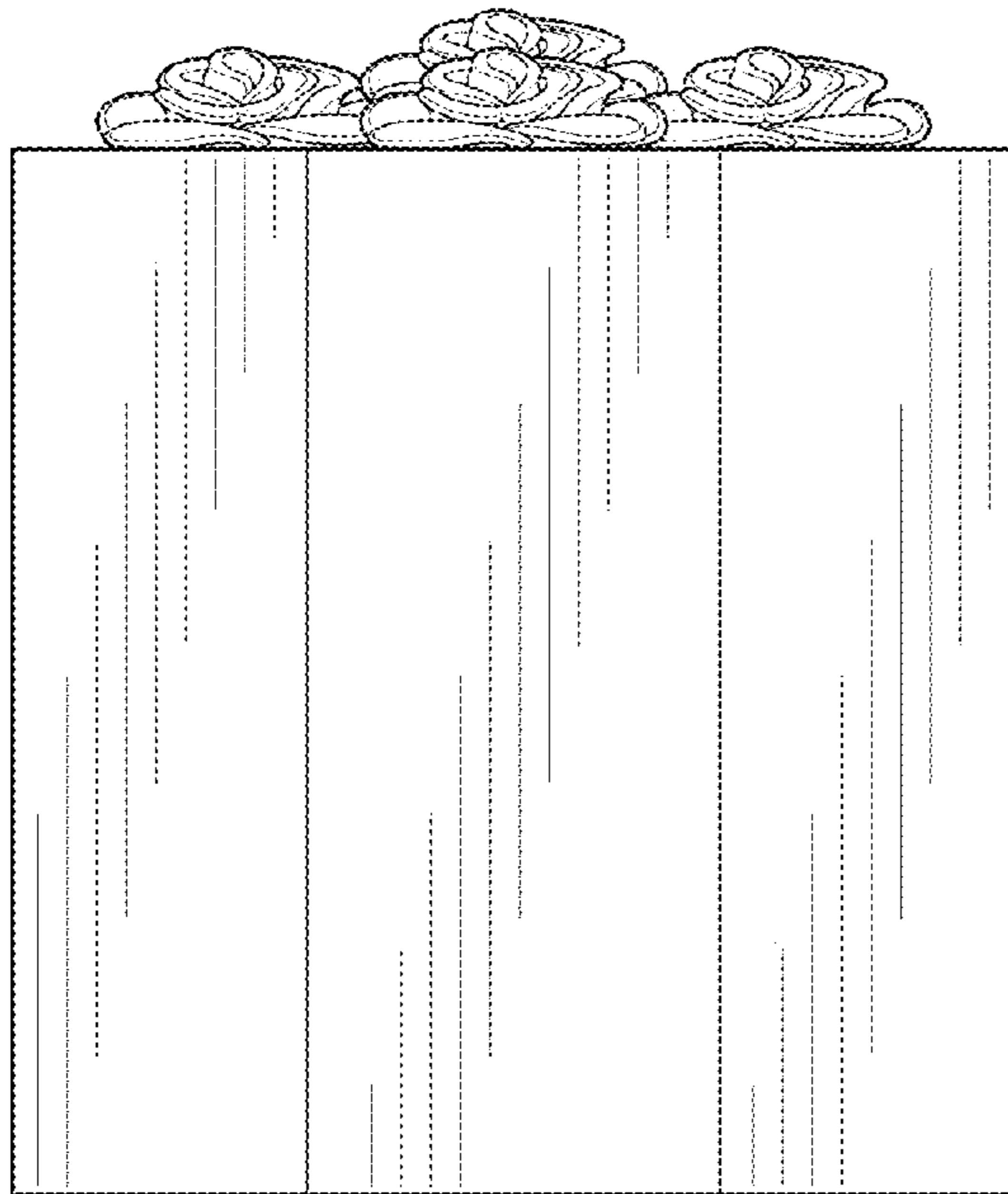

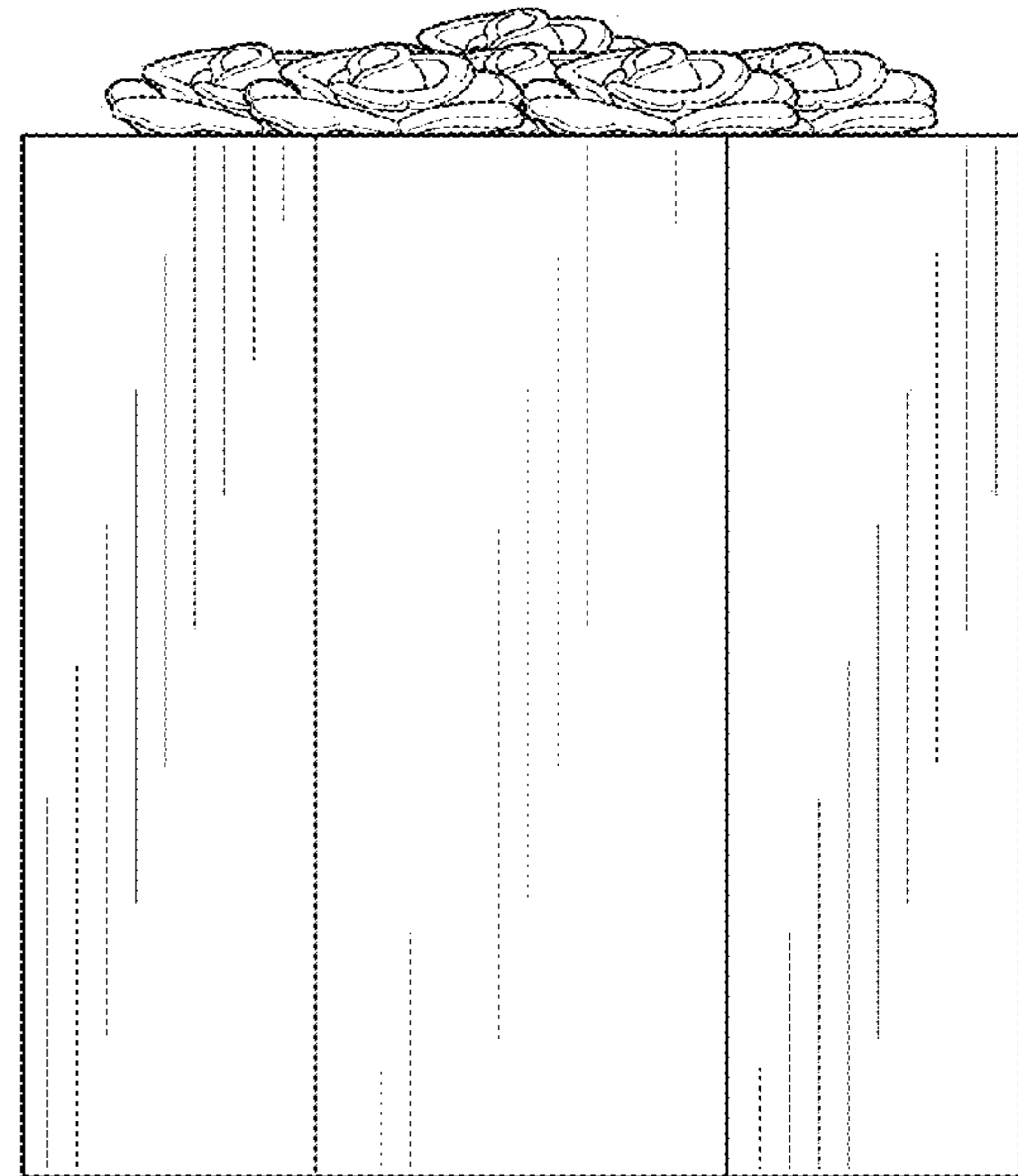

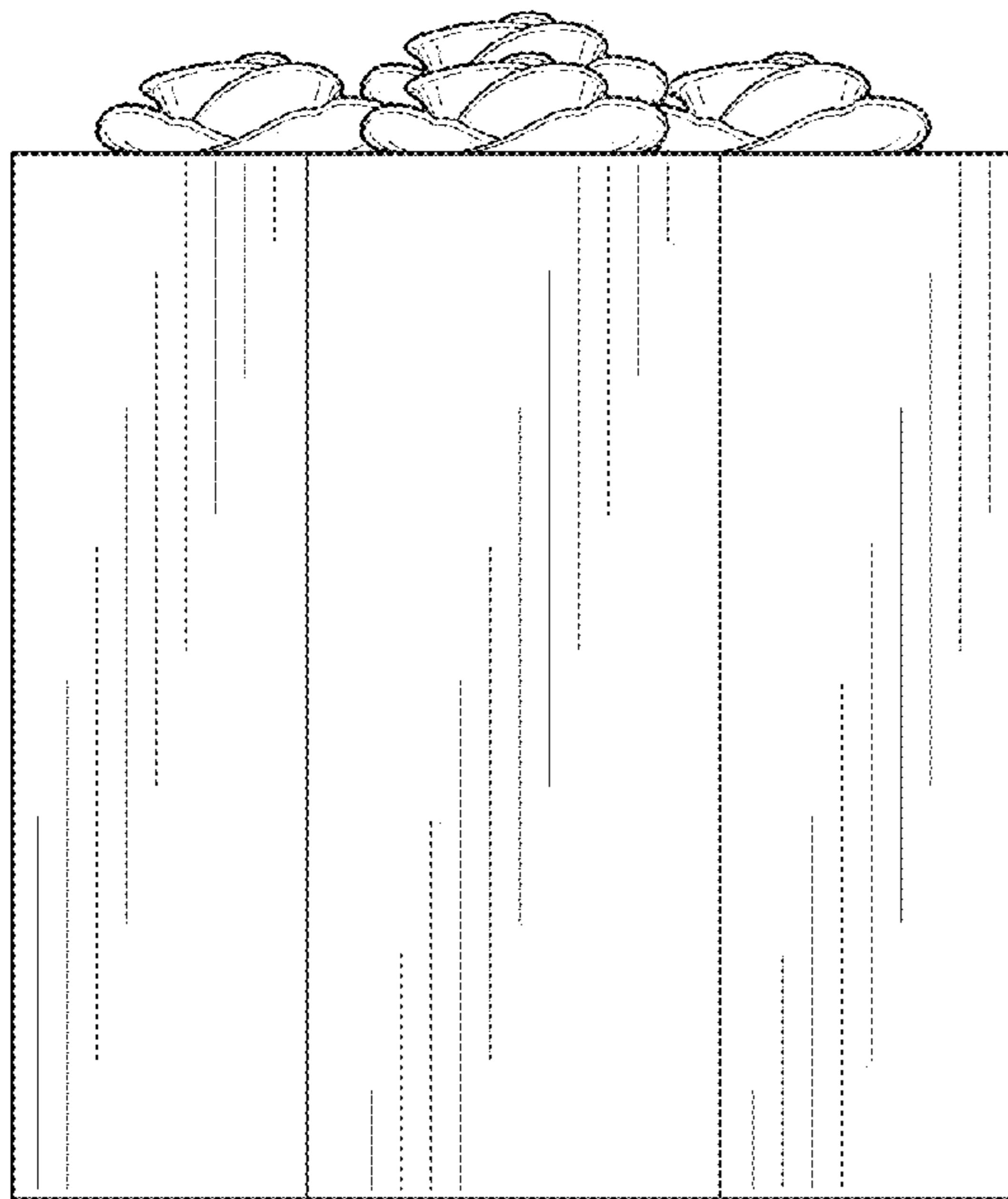

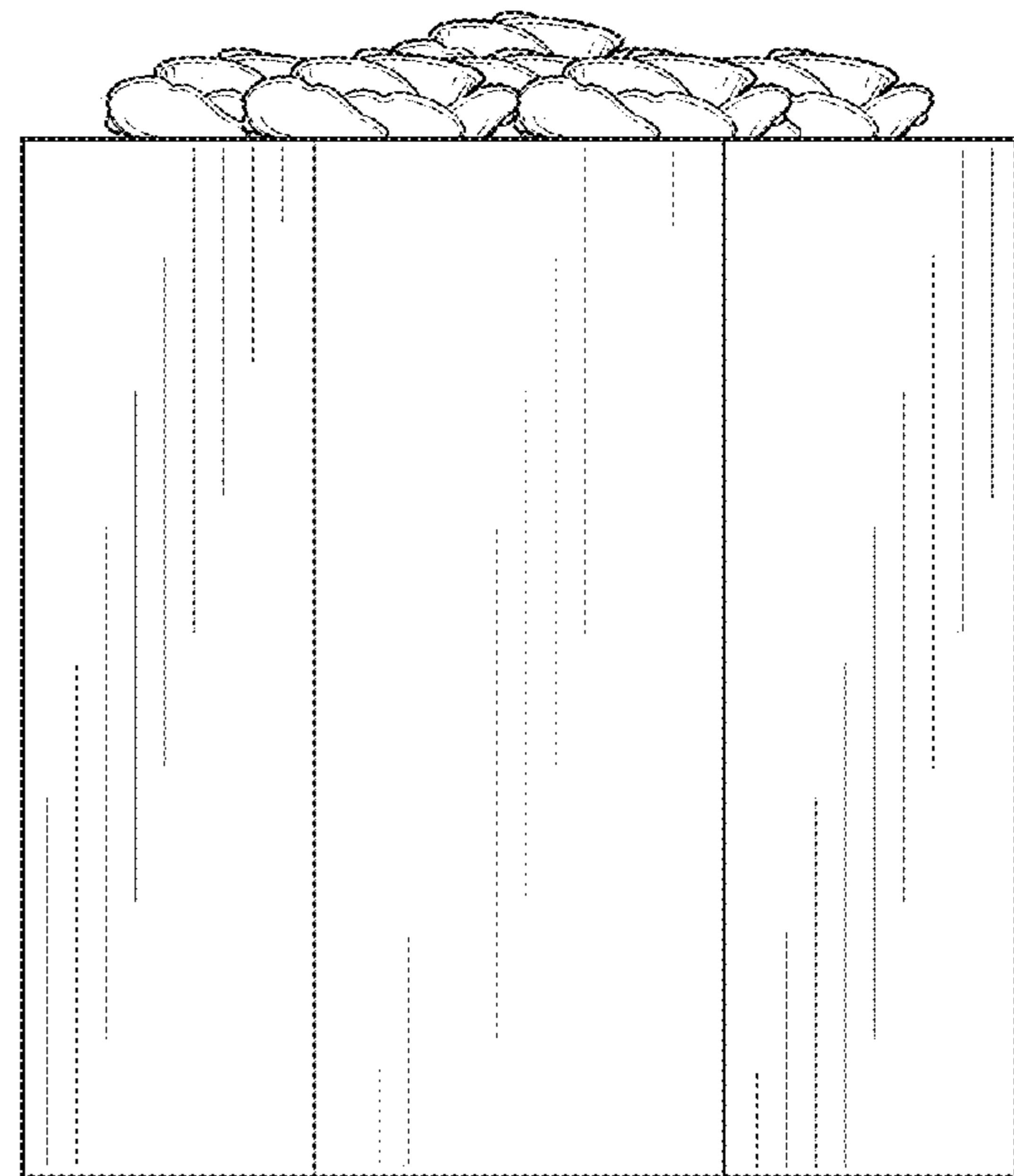

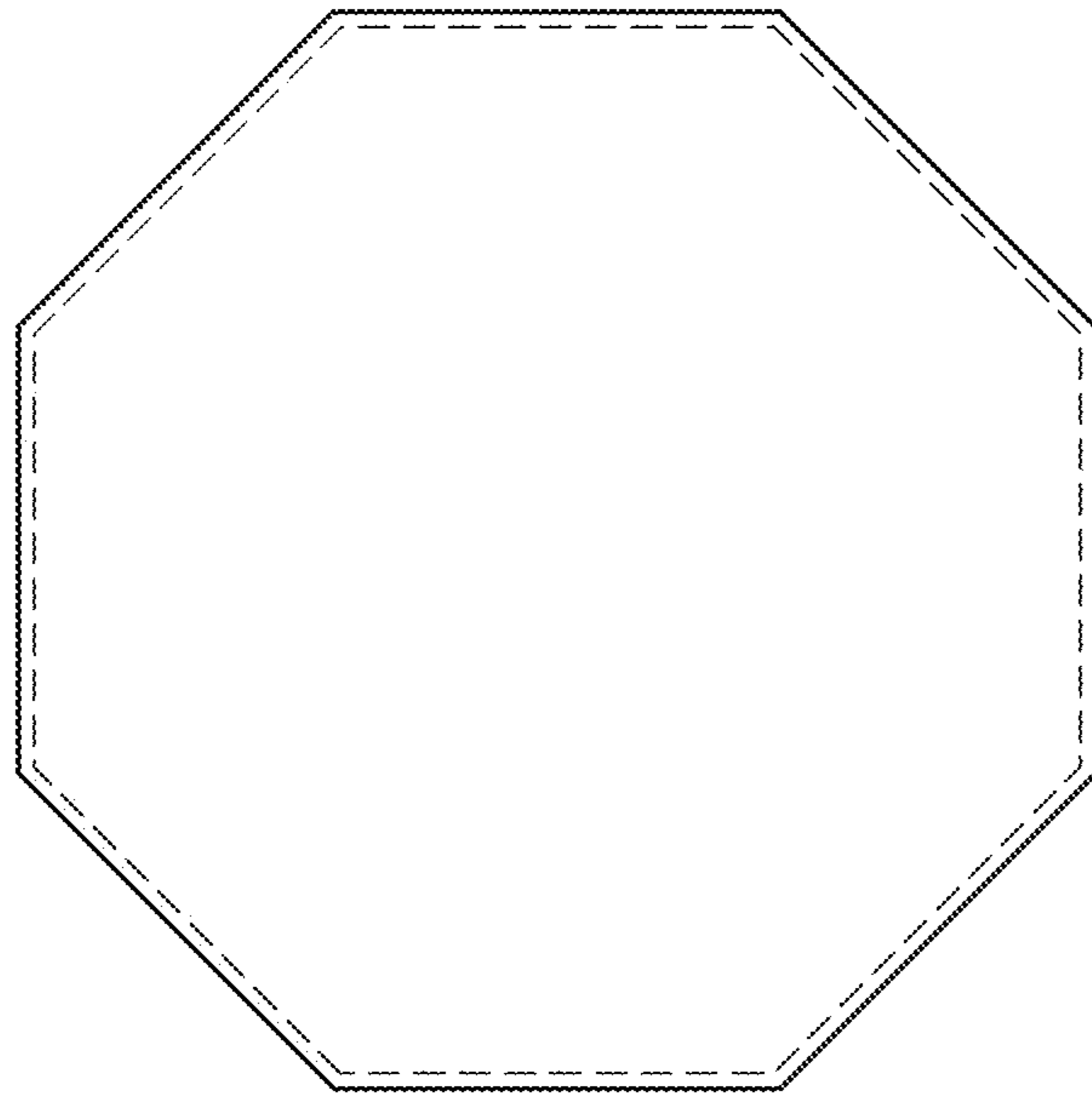
