The ornamental design for a palm shifter for a vehicle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front left elevated perspective view of a palm shifter for a vehicle according to the present invention.

FIG. 7 is a left side view thereof.

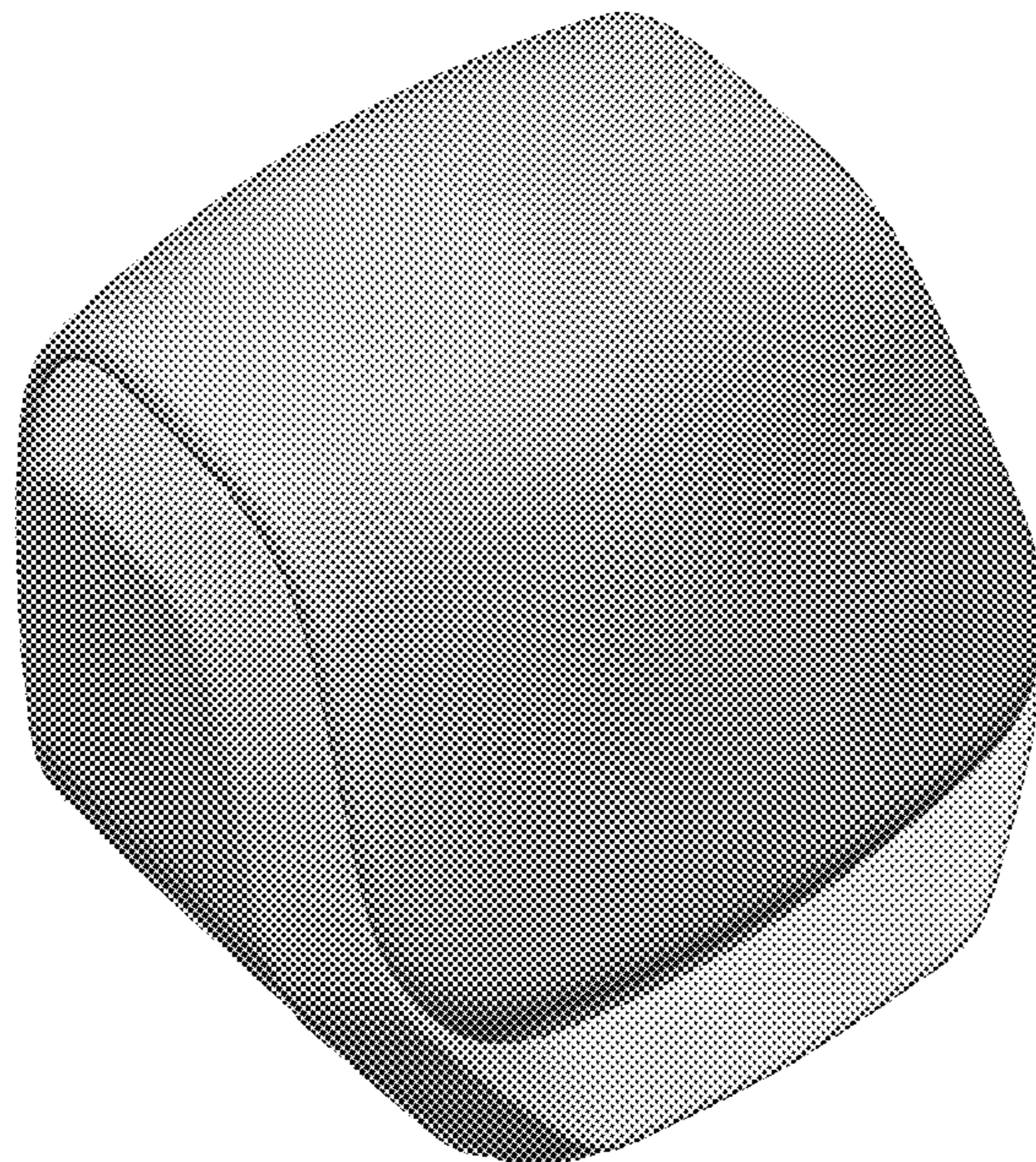
FIG. 8 is a right side view thereof.

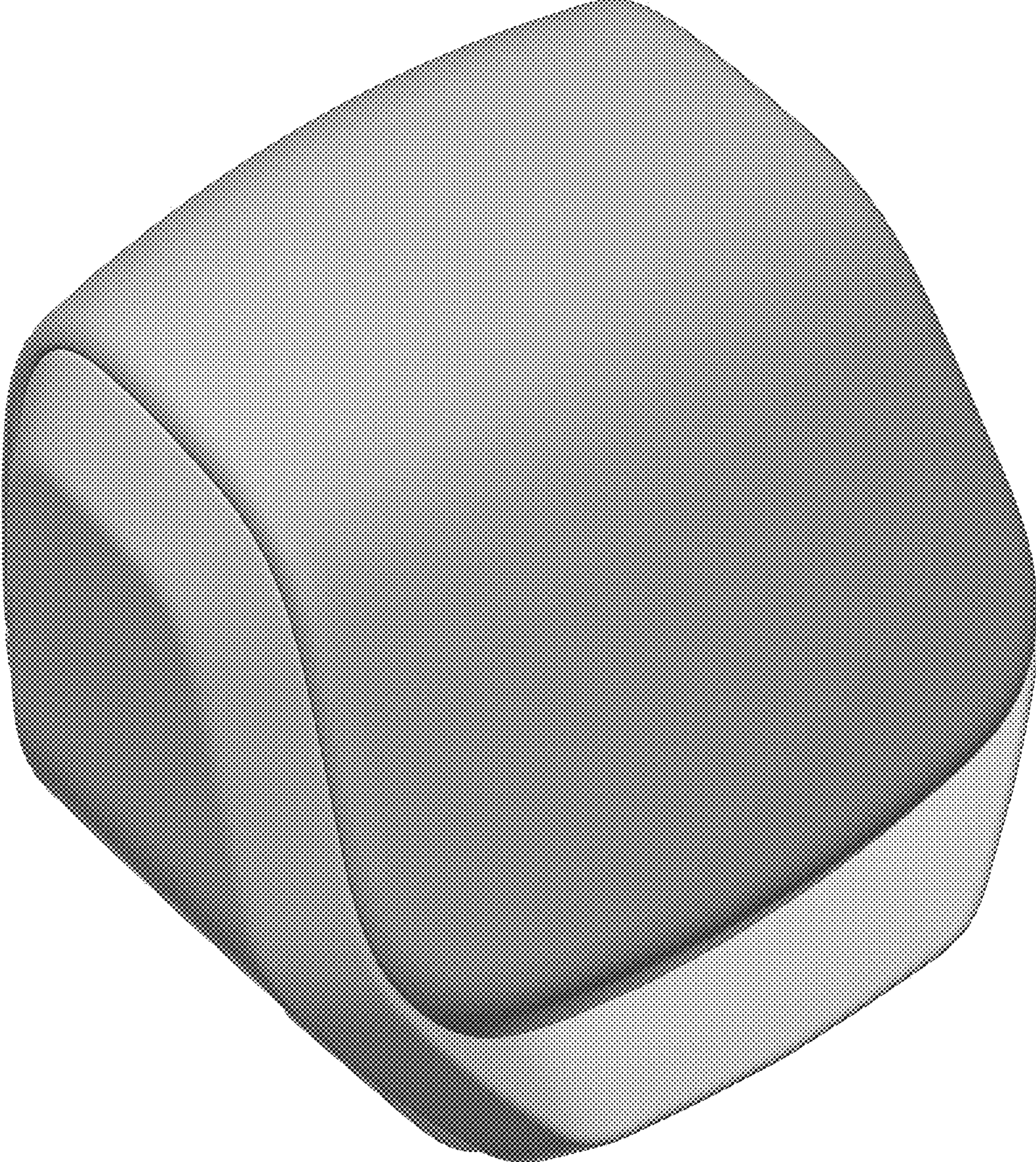

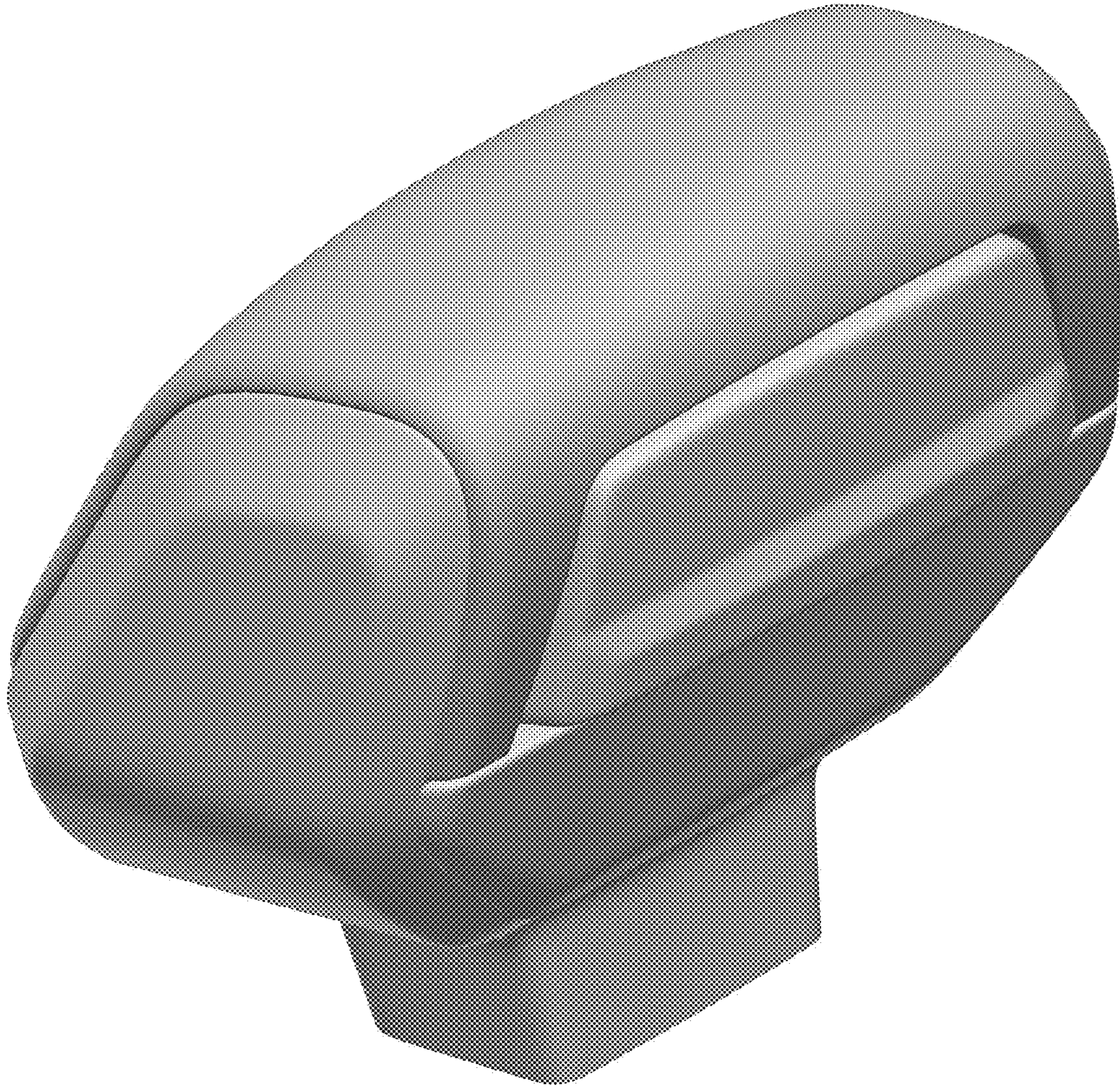

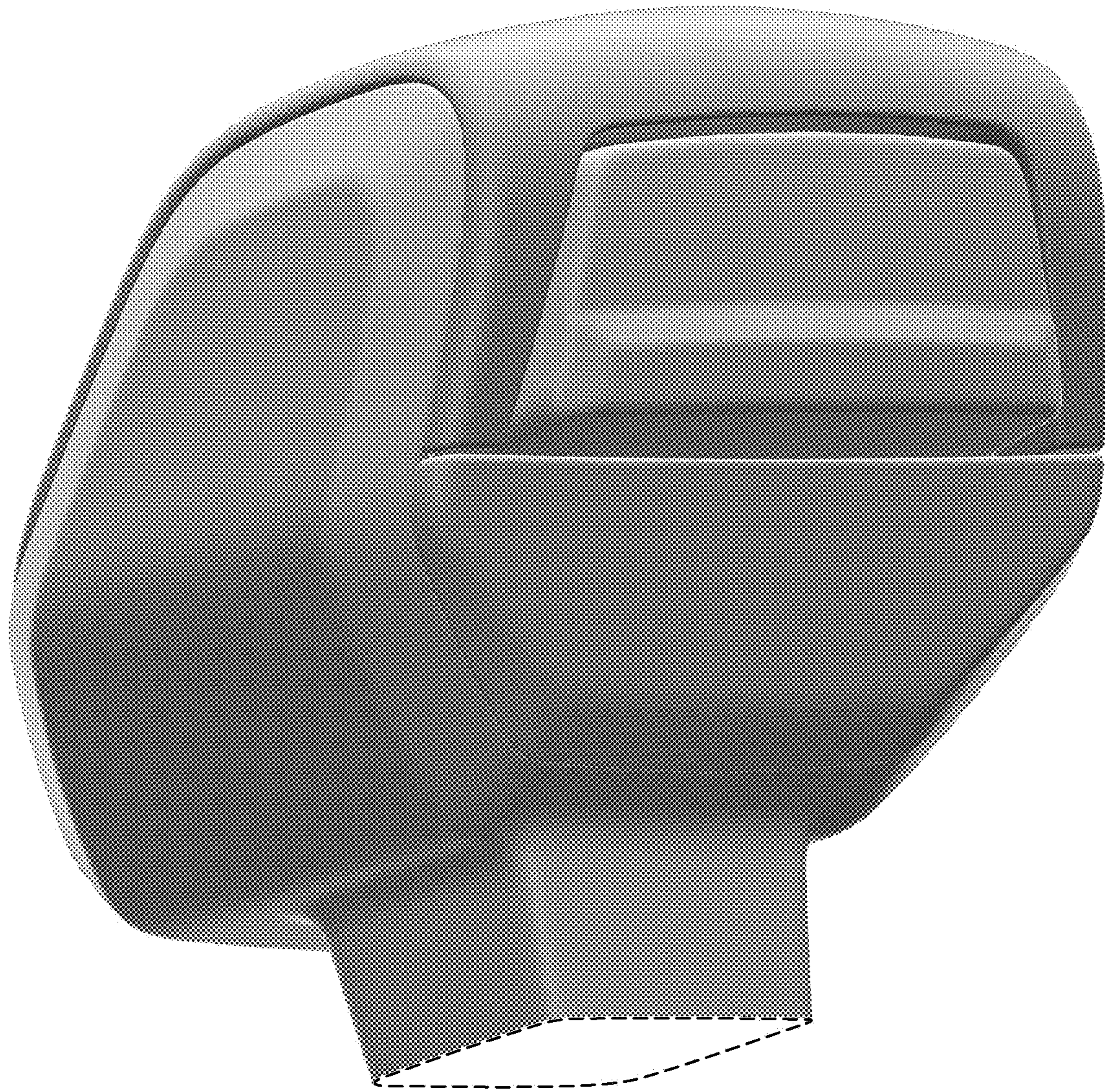

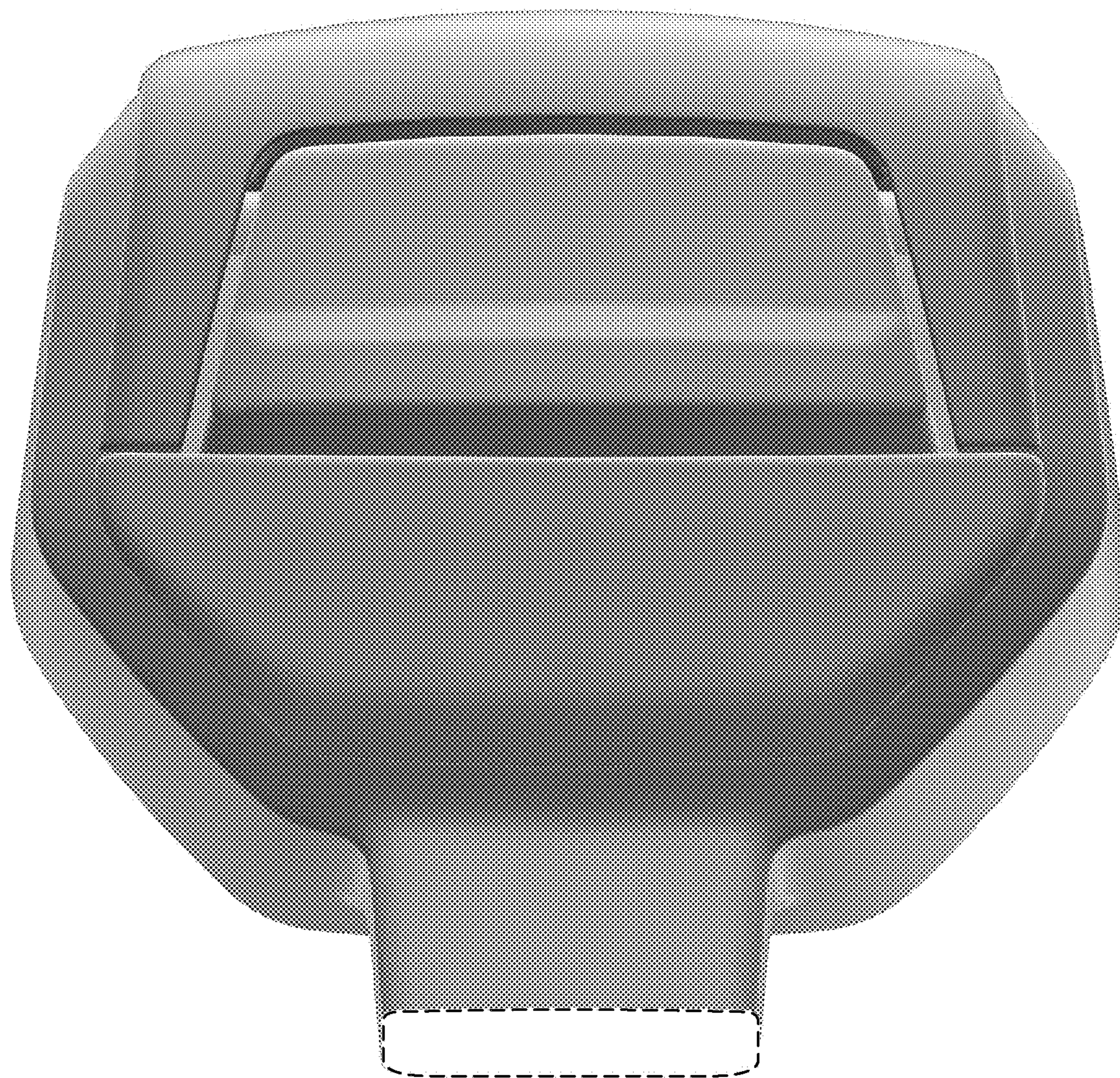

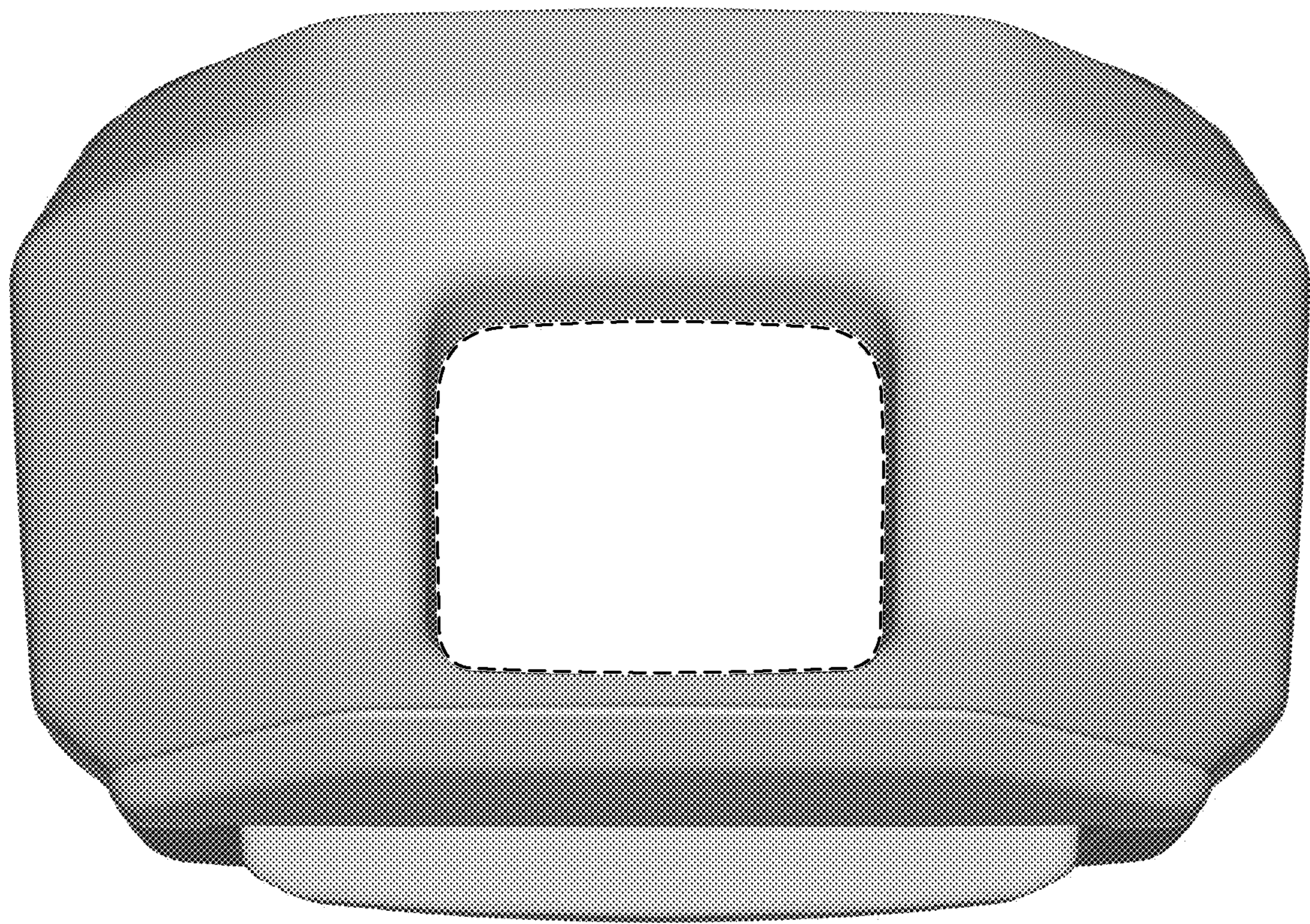
