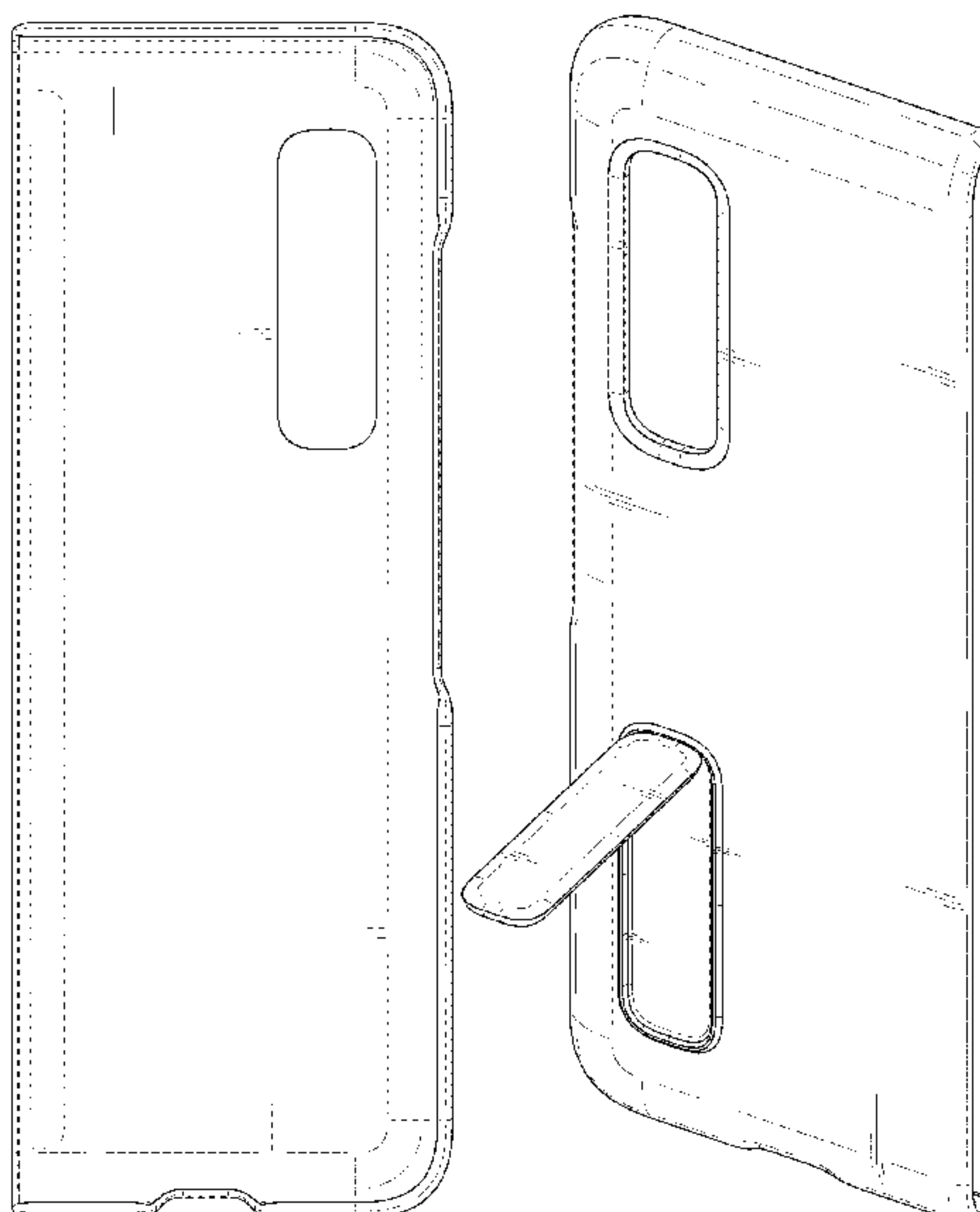
The ornamental design for a cover for mobile phone, as

DESCRIPTION

FIG. 1 is a front perspective view of a cover for mobile
phone showing our new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a left side elevation view thereof;
FIG. 5 is a right side elevation view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a rear perspective view thereof; and,
FIG. 9 is a front perspective view thereof, showing a stand
in an open position.

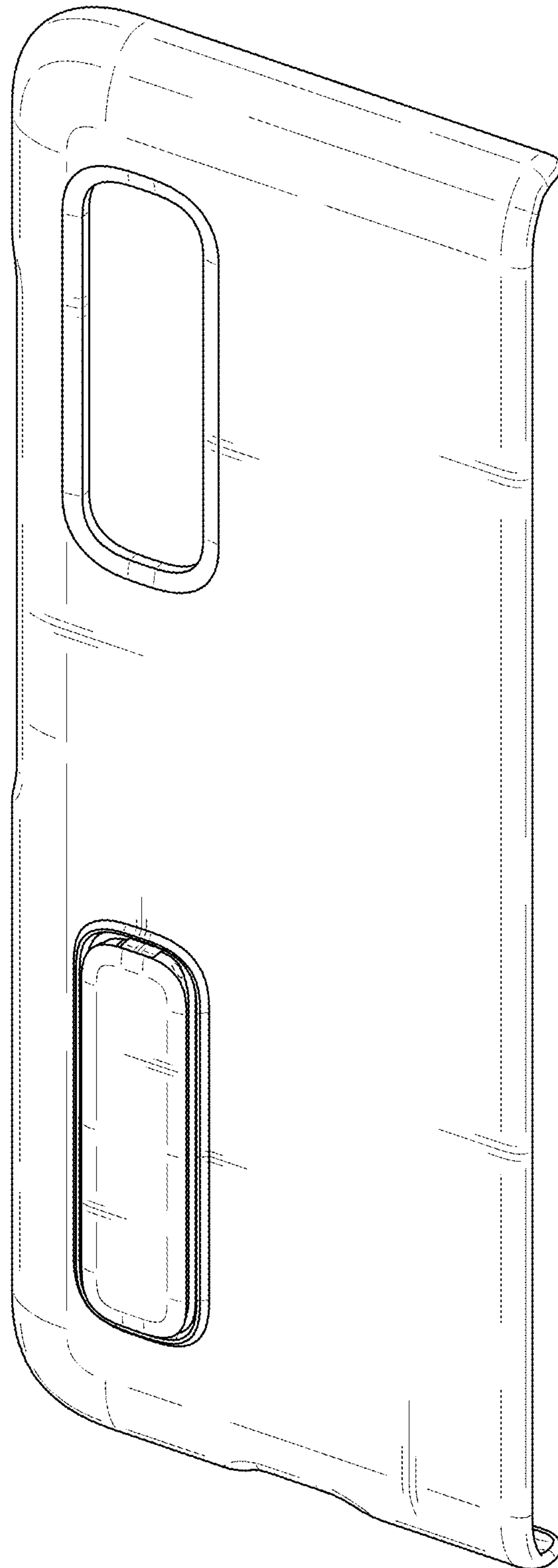

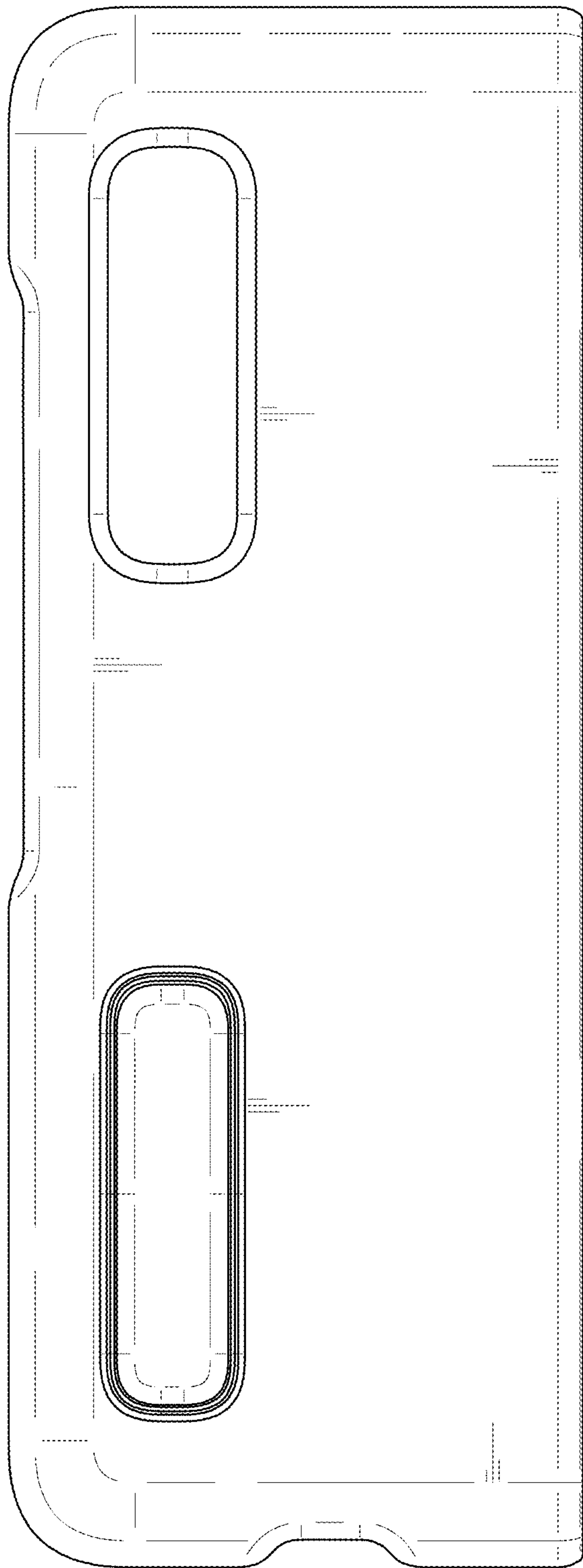

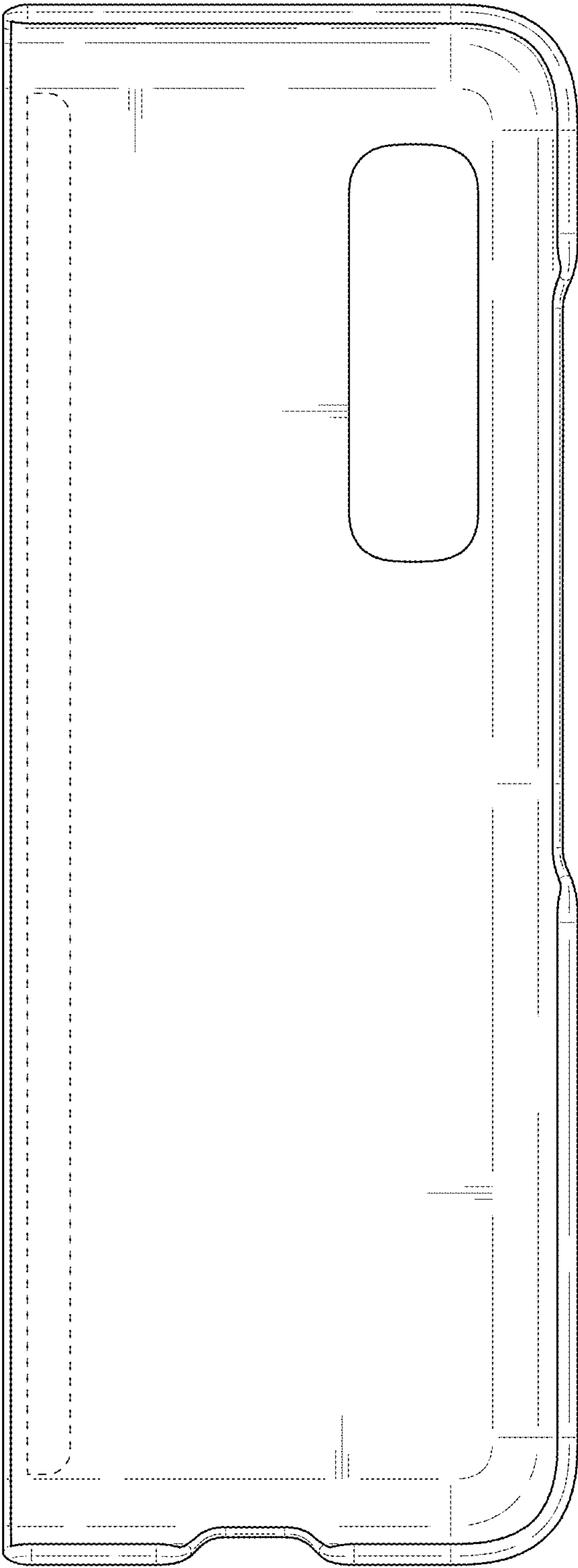

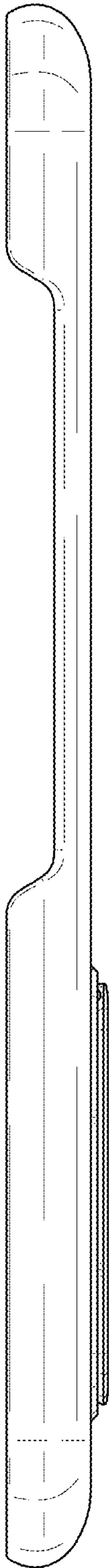

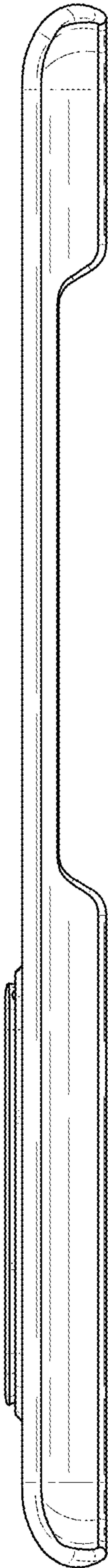

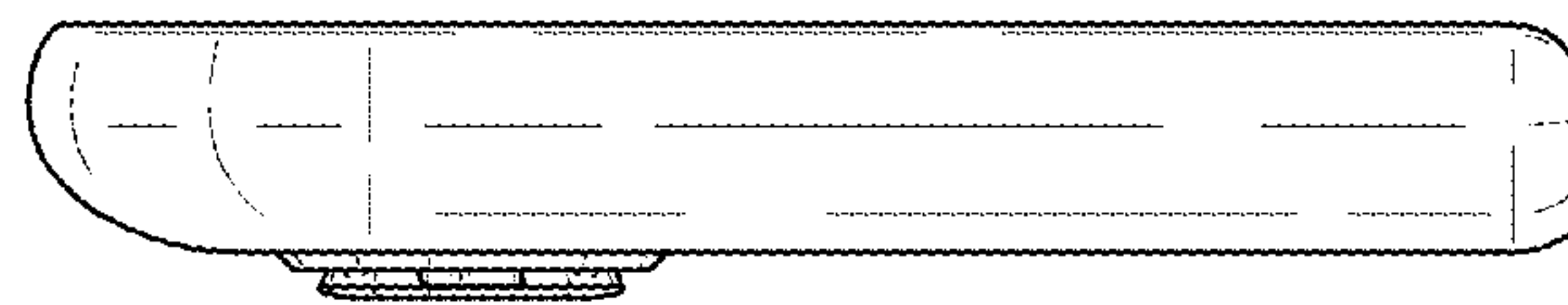

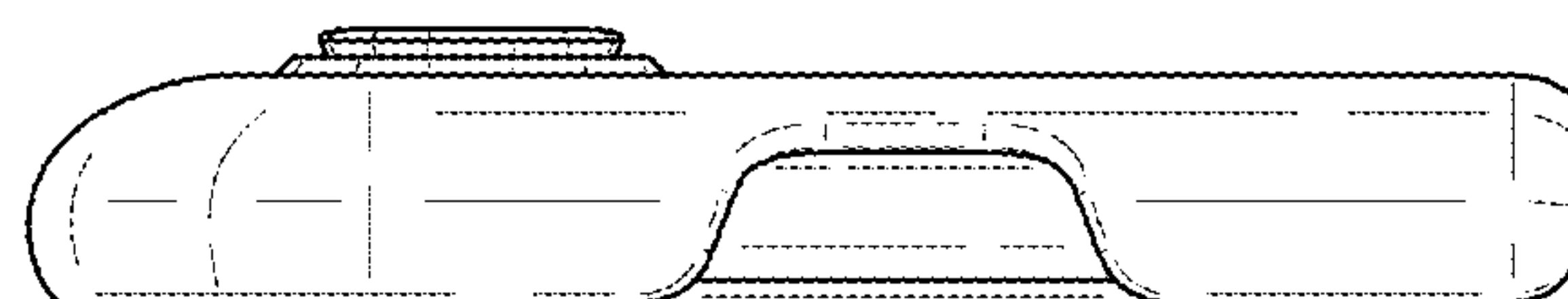

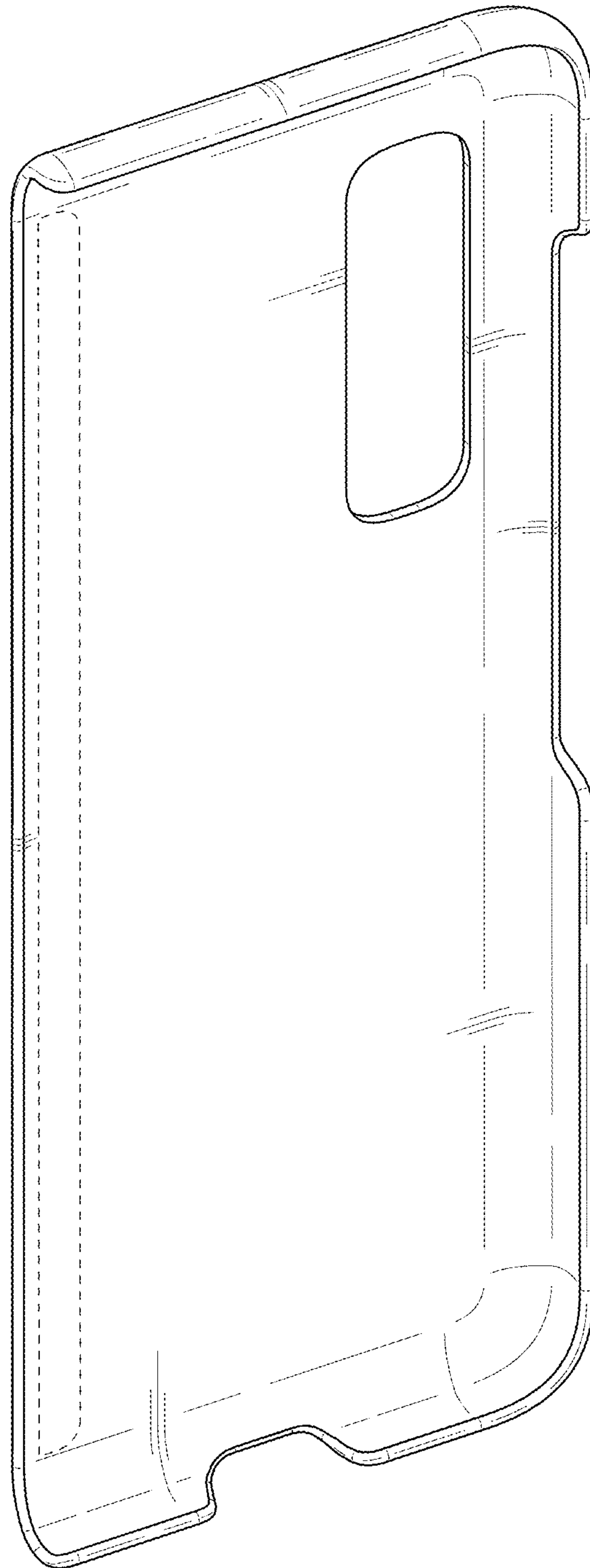
