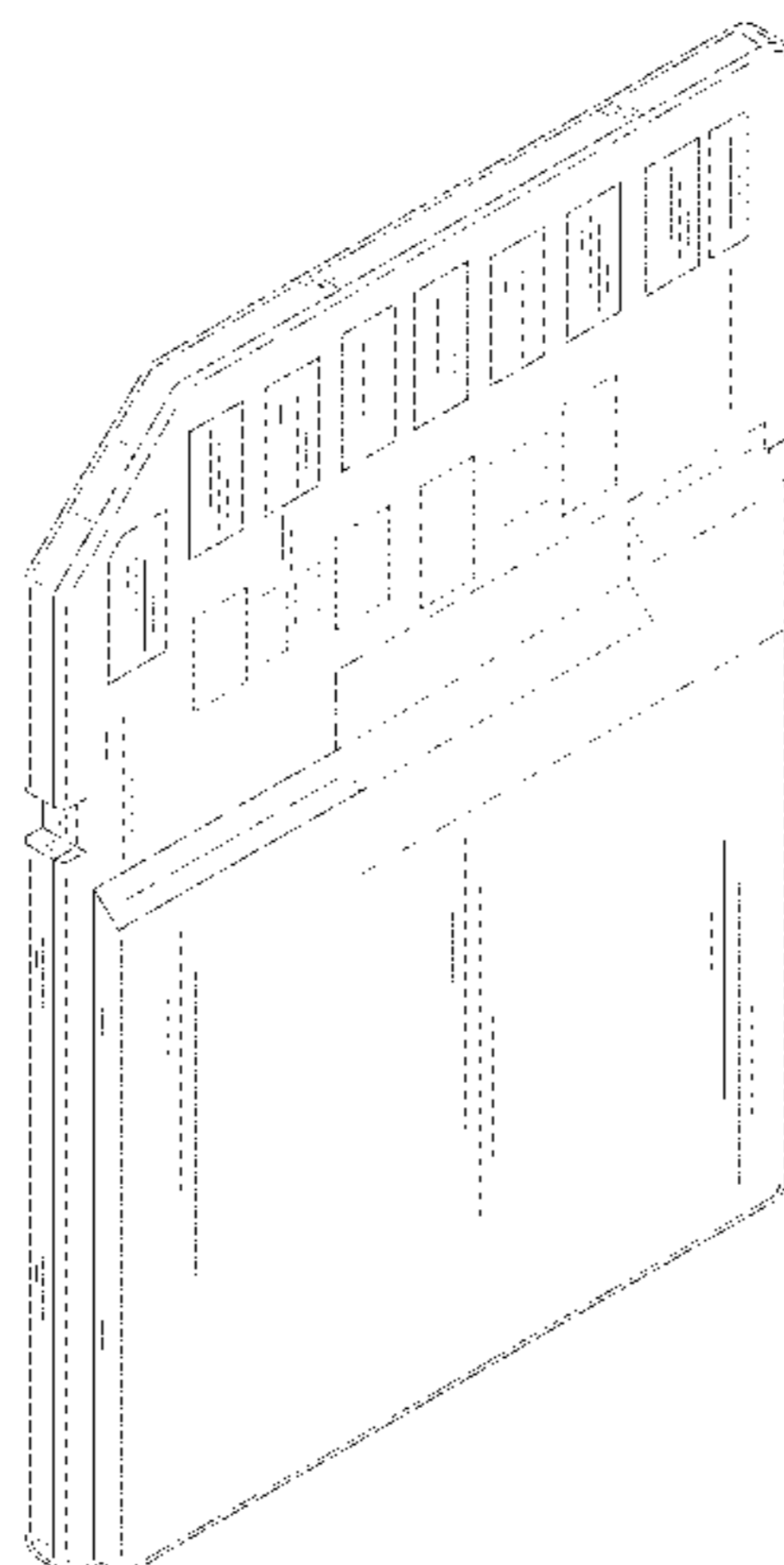

The ornamental design for a memory card, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a memory card showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a right side elevational view thereof;  
FIG. 6 is a top plan view thereof; and  
FIG. 7 is a bottom plan view thereof.  
FIG. 8 is an enlarged partial left side elevational view thereof along the lines 8-8 of FIG. 4.  
FIG. 9 is a perspective view of a second embodiment of a memory card showing my new design;  
FIG. 10 is a front elevational view thereof;  
FIG. 11 is a rear elevational view thereof;  
FIG. 12 is a left side elevational view thereof;  
FIG. 13 is a right side elevational view thereof;  
FIG. 14 is a top plan view thereof; and  
FIG. 15 is a bottom plan view thereof.  
FIG. 16 is an enlarged partial left side elevational view thereof along the lines 16-16 of FIG. 12.

The even-dash broken lines illustrating a portion of the memory card form no part of the claimed design. Dot-dash broken lines showing of a part of the memory card define the boundaries of the claimed design and are not included in the claimed design.

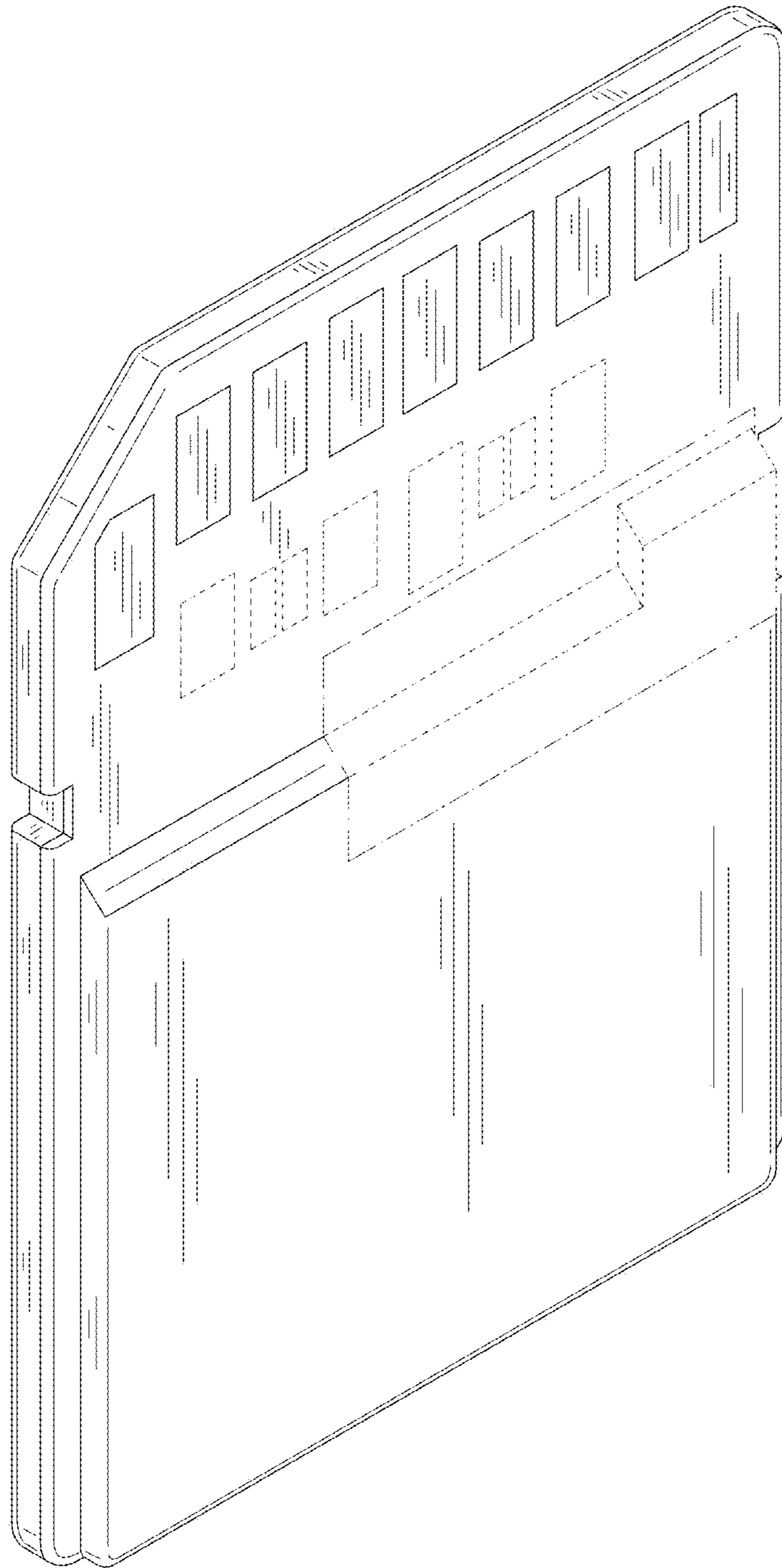

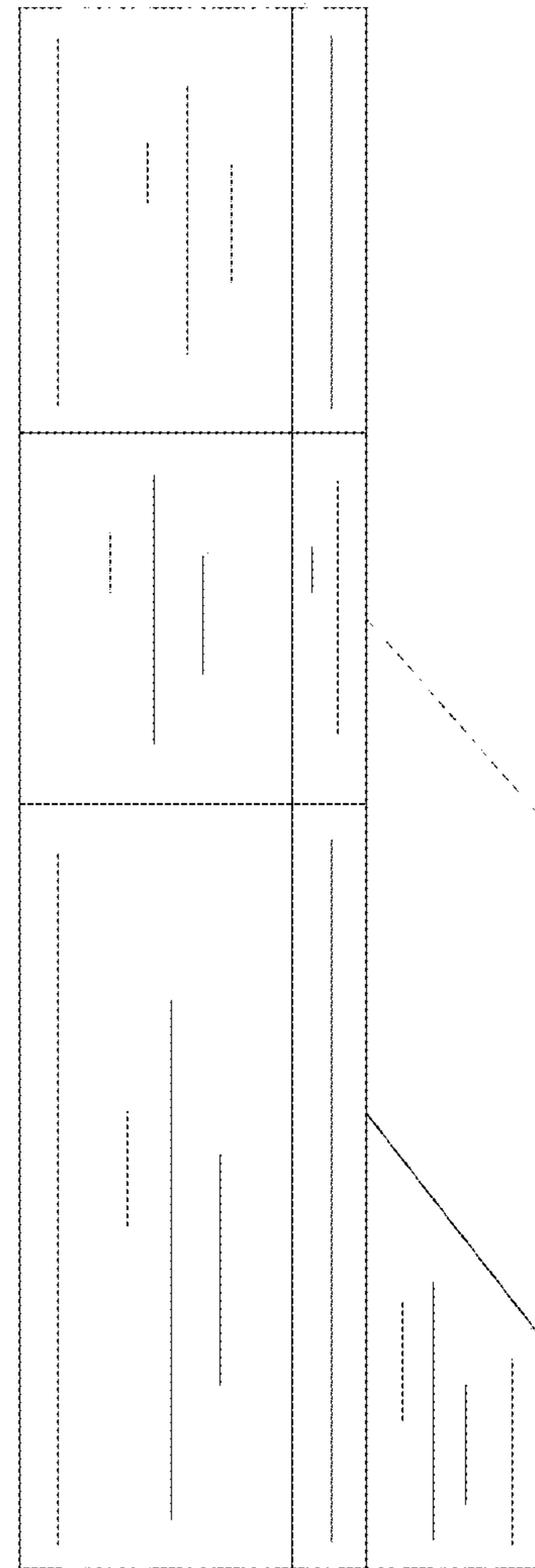

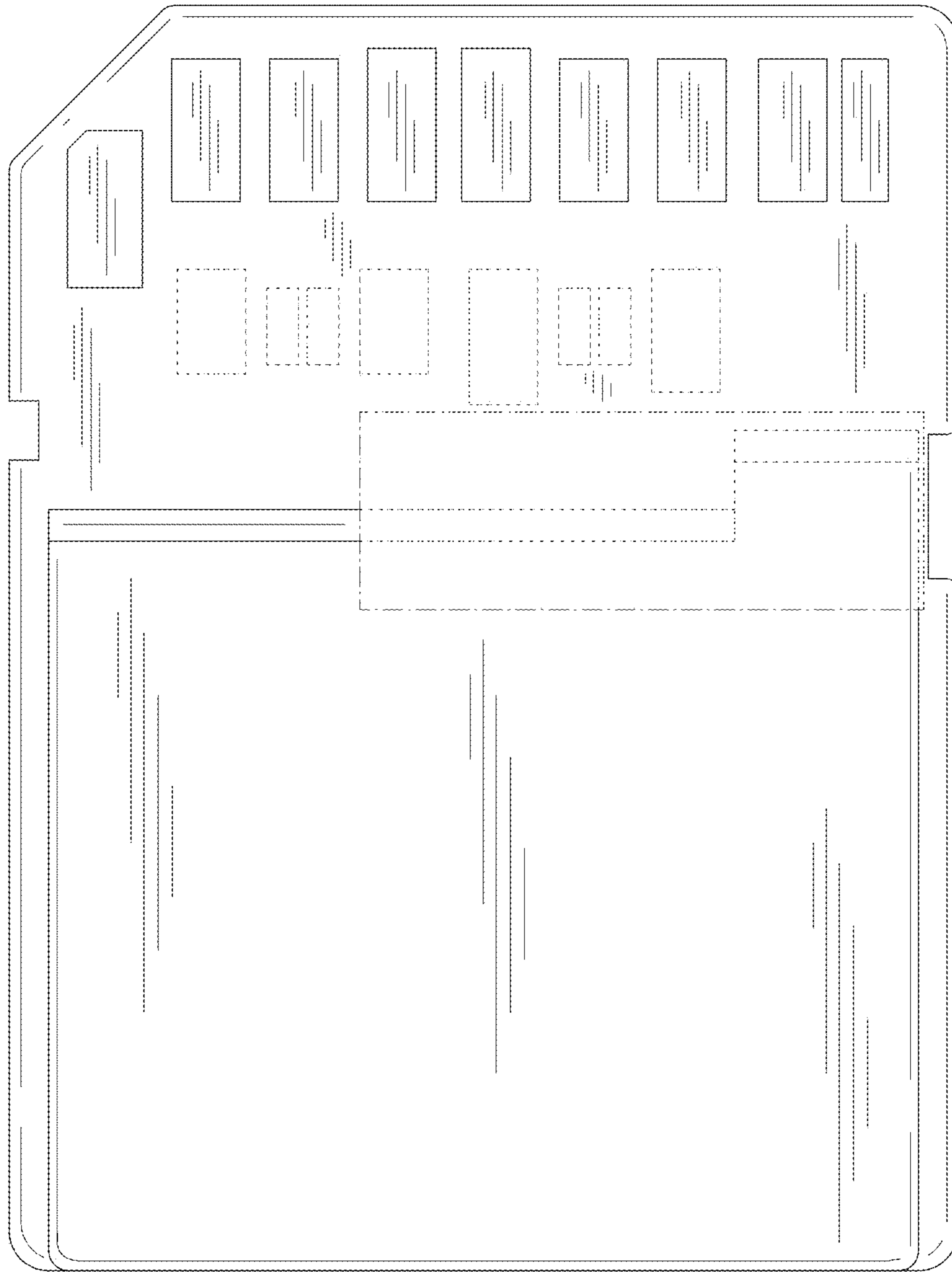

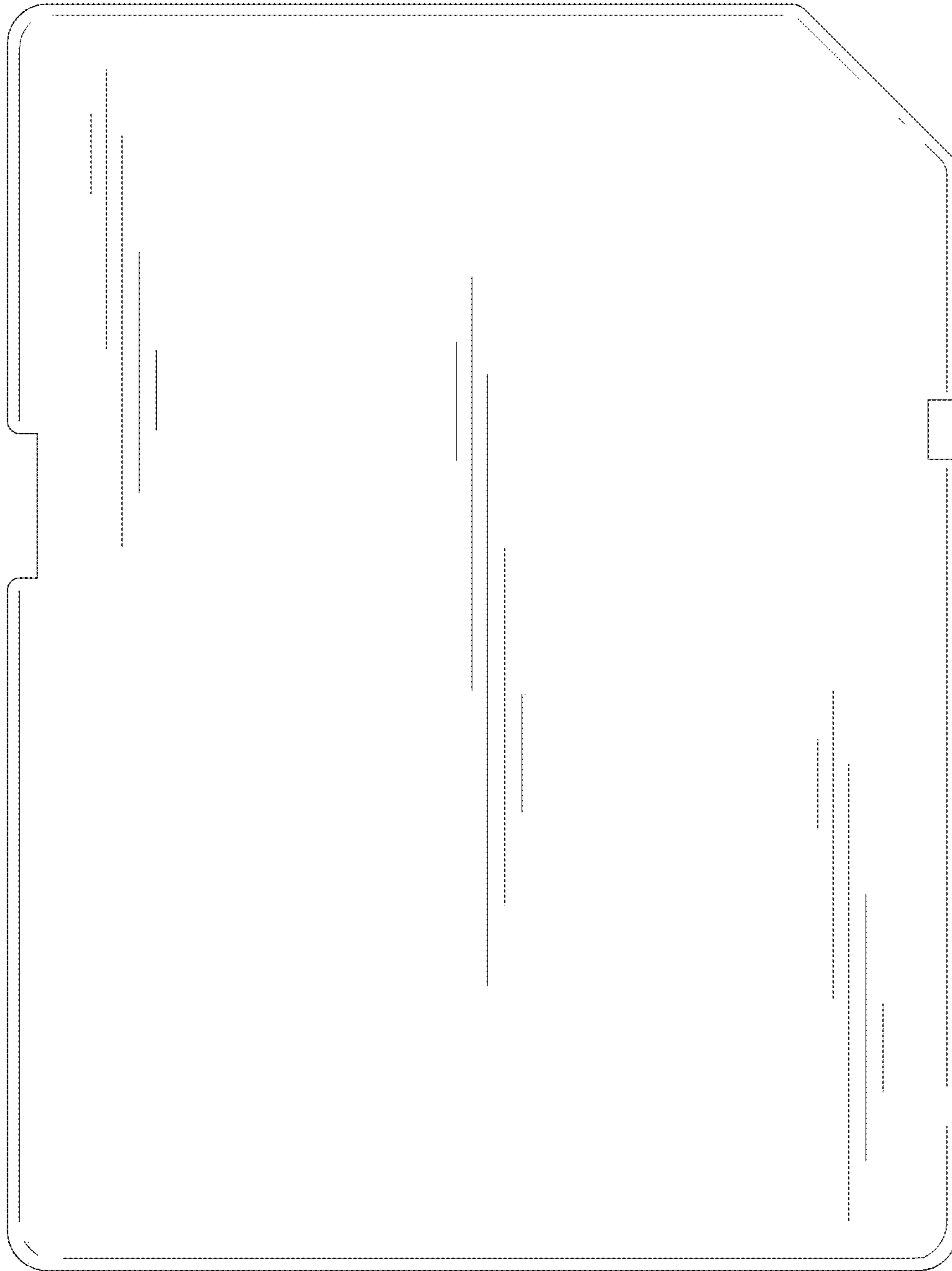

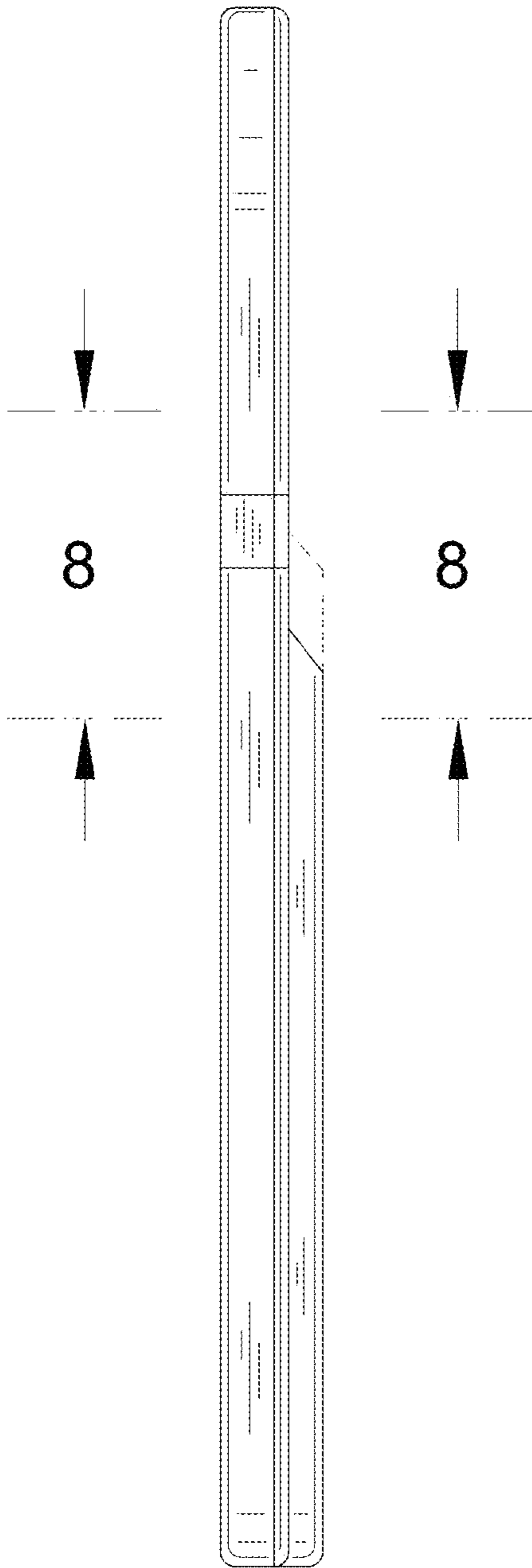

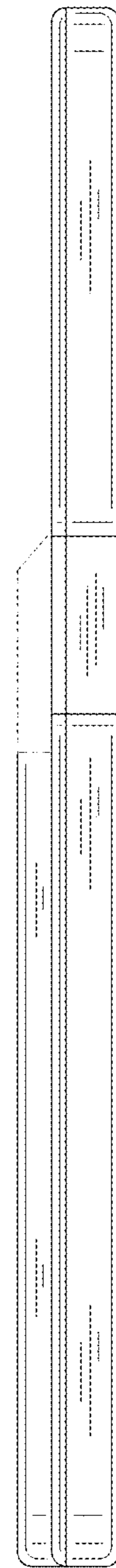

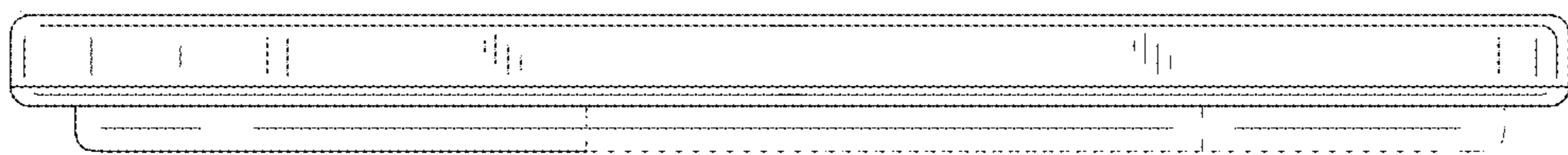

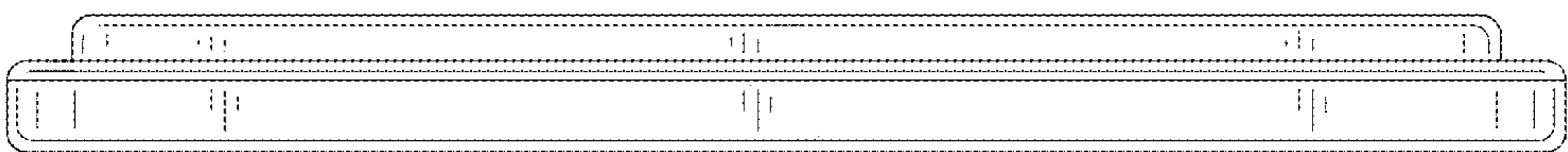

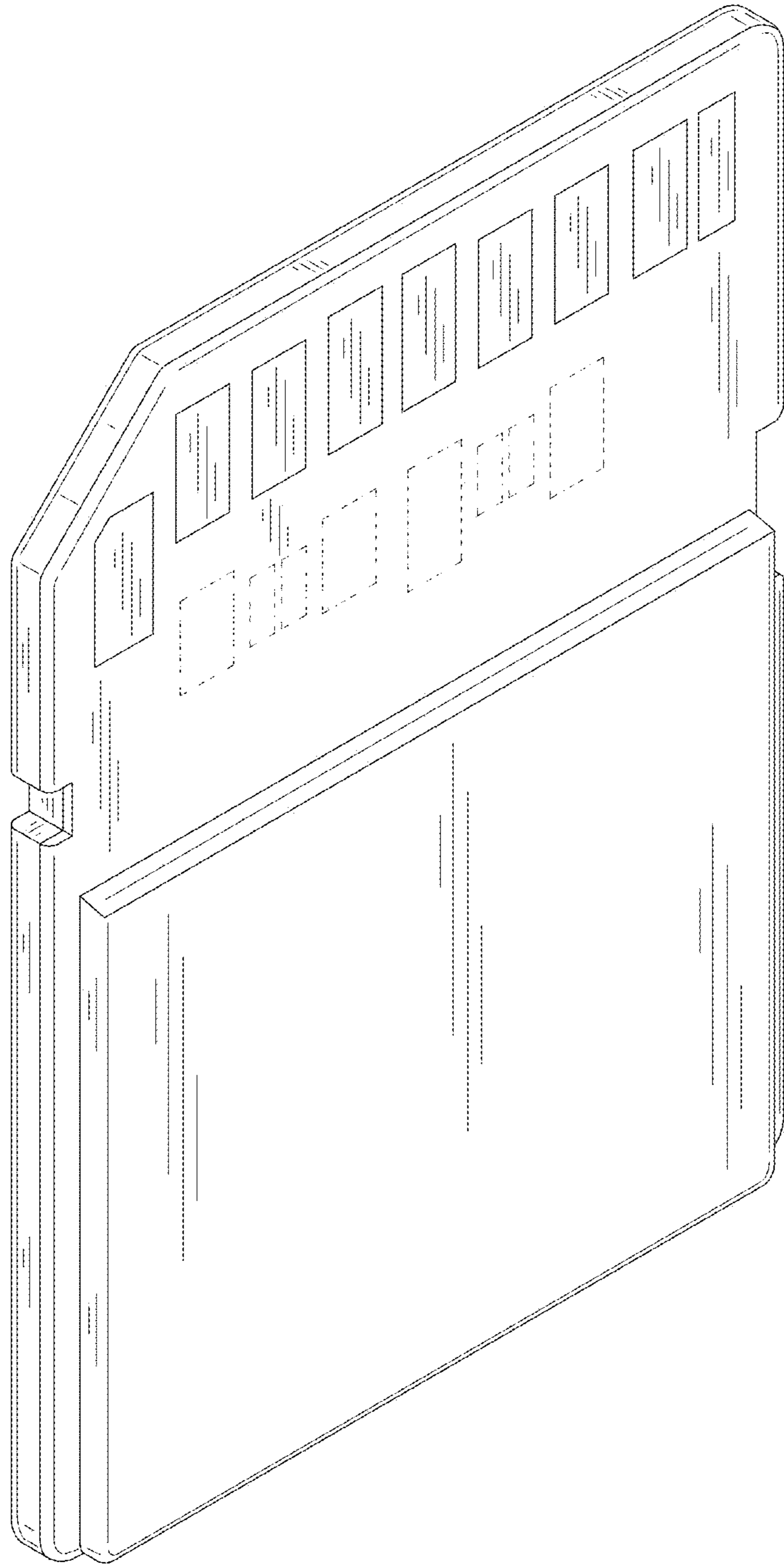

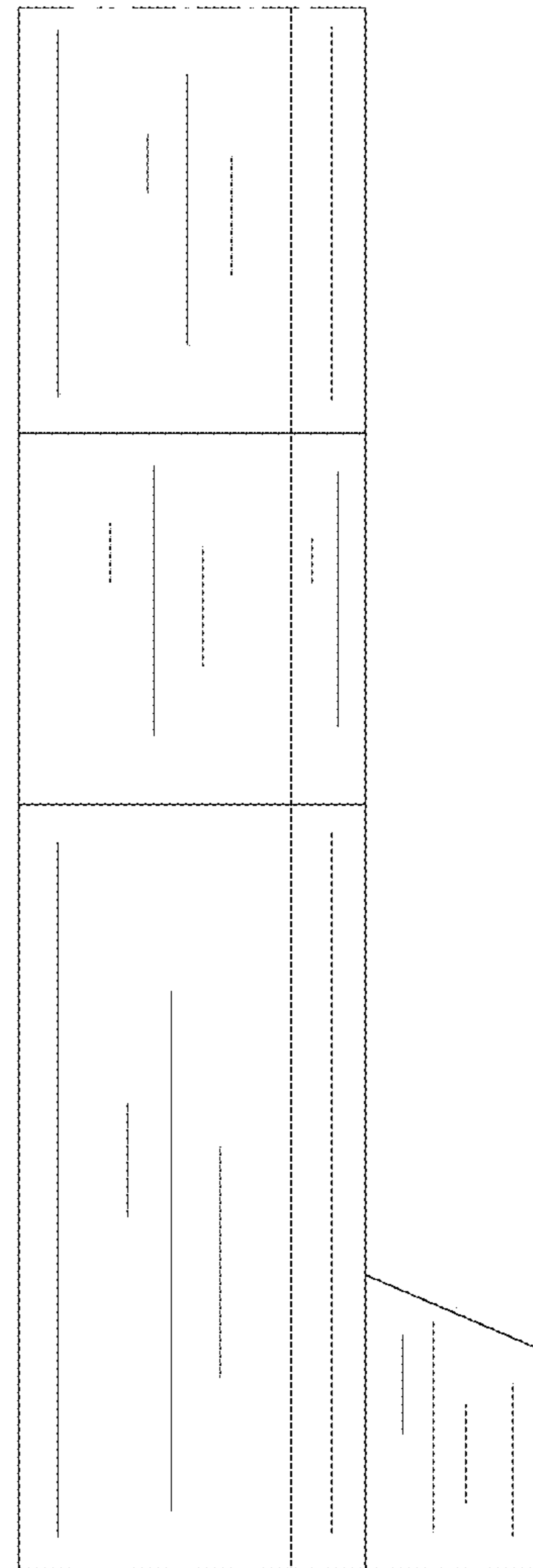

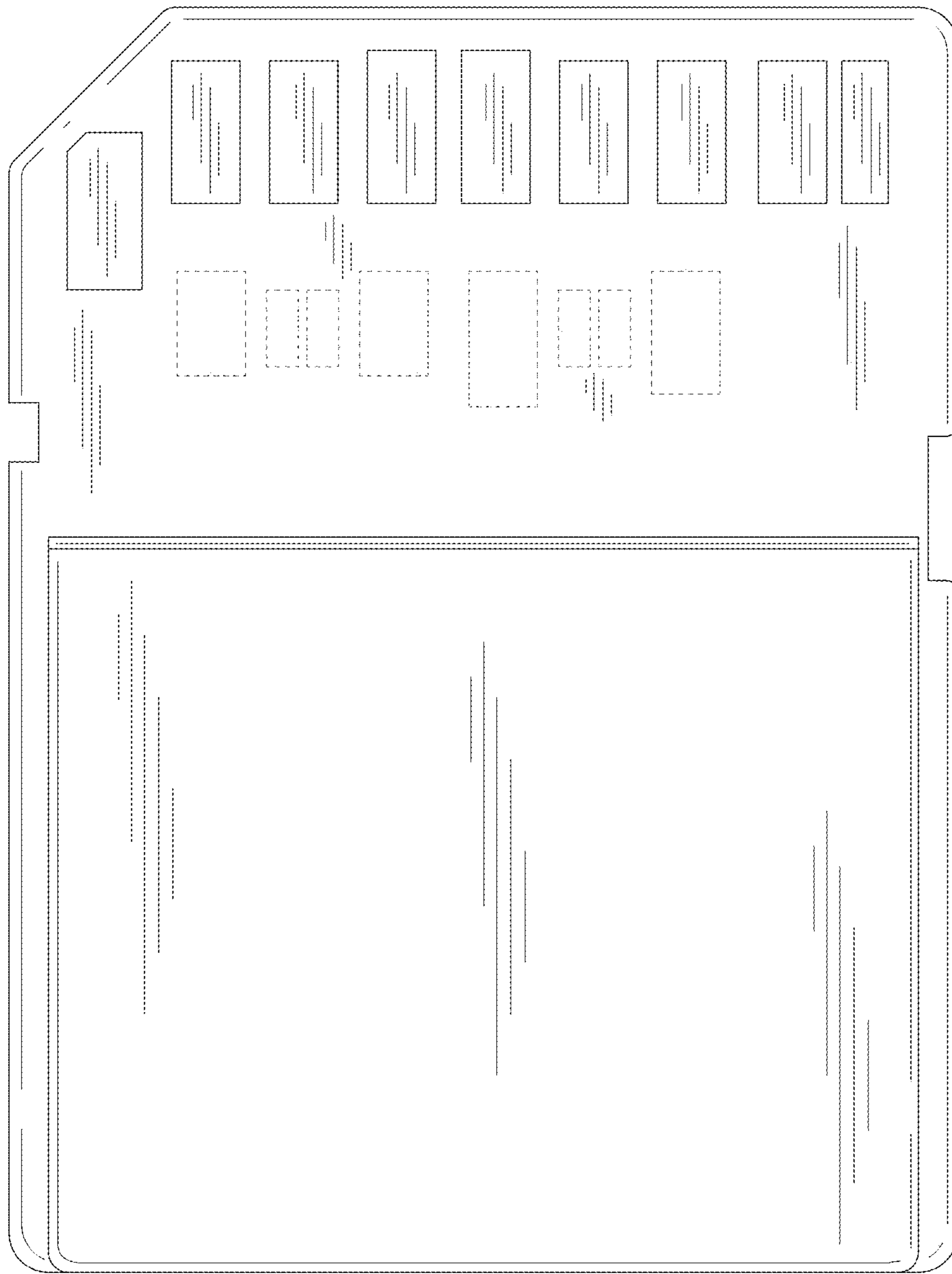

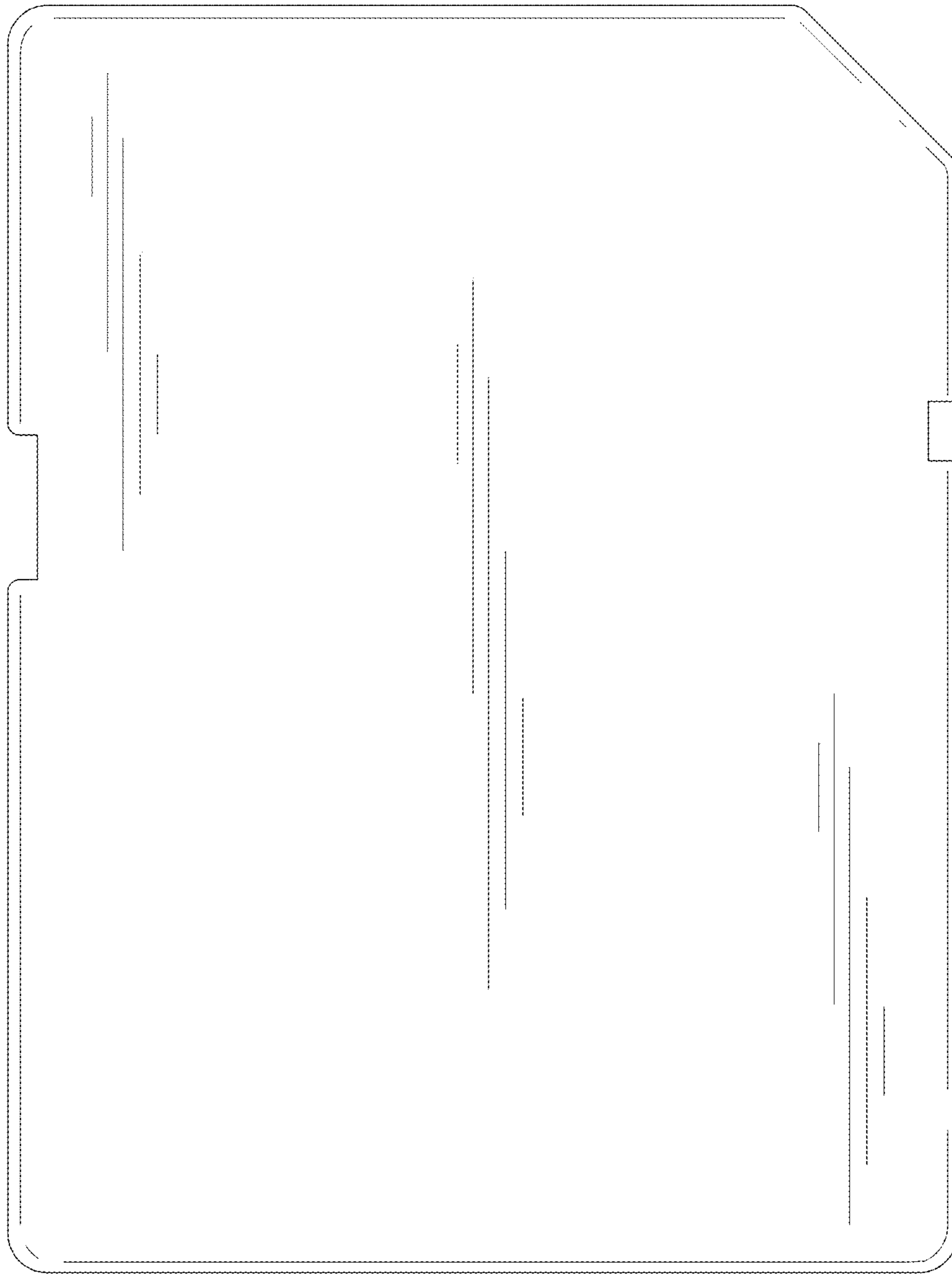

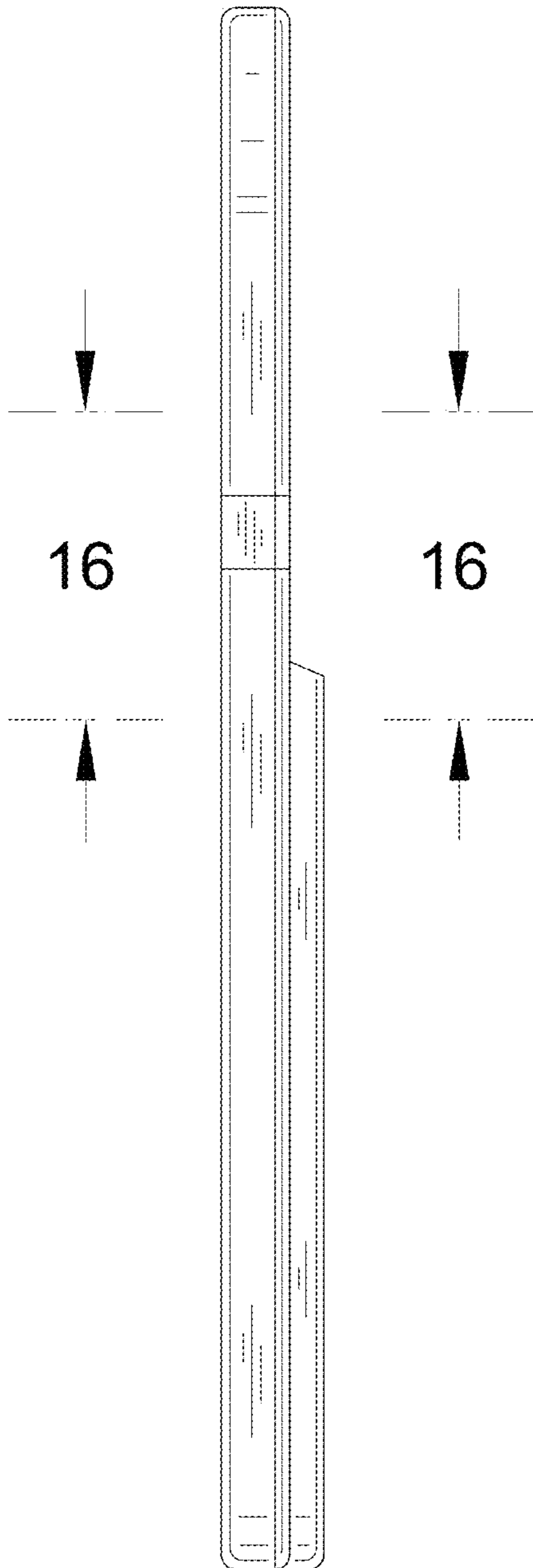

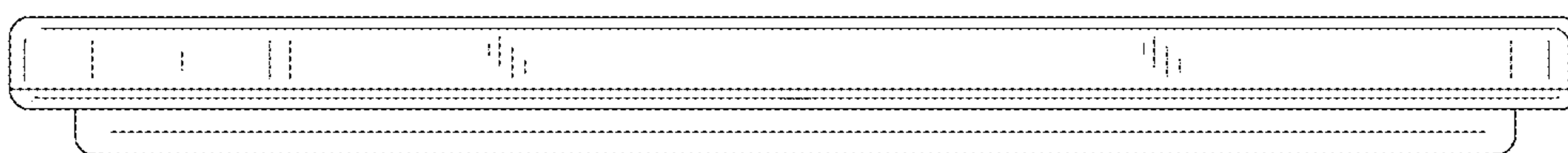

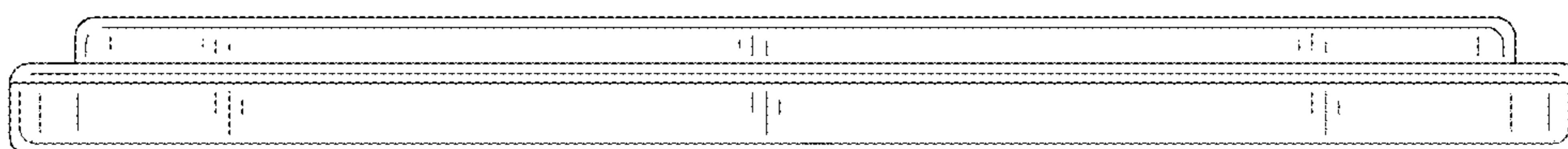

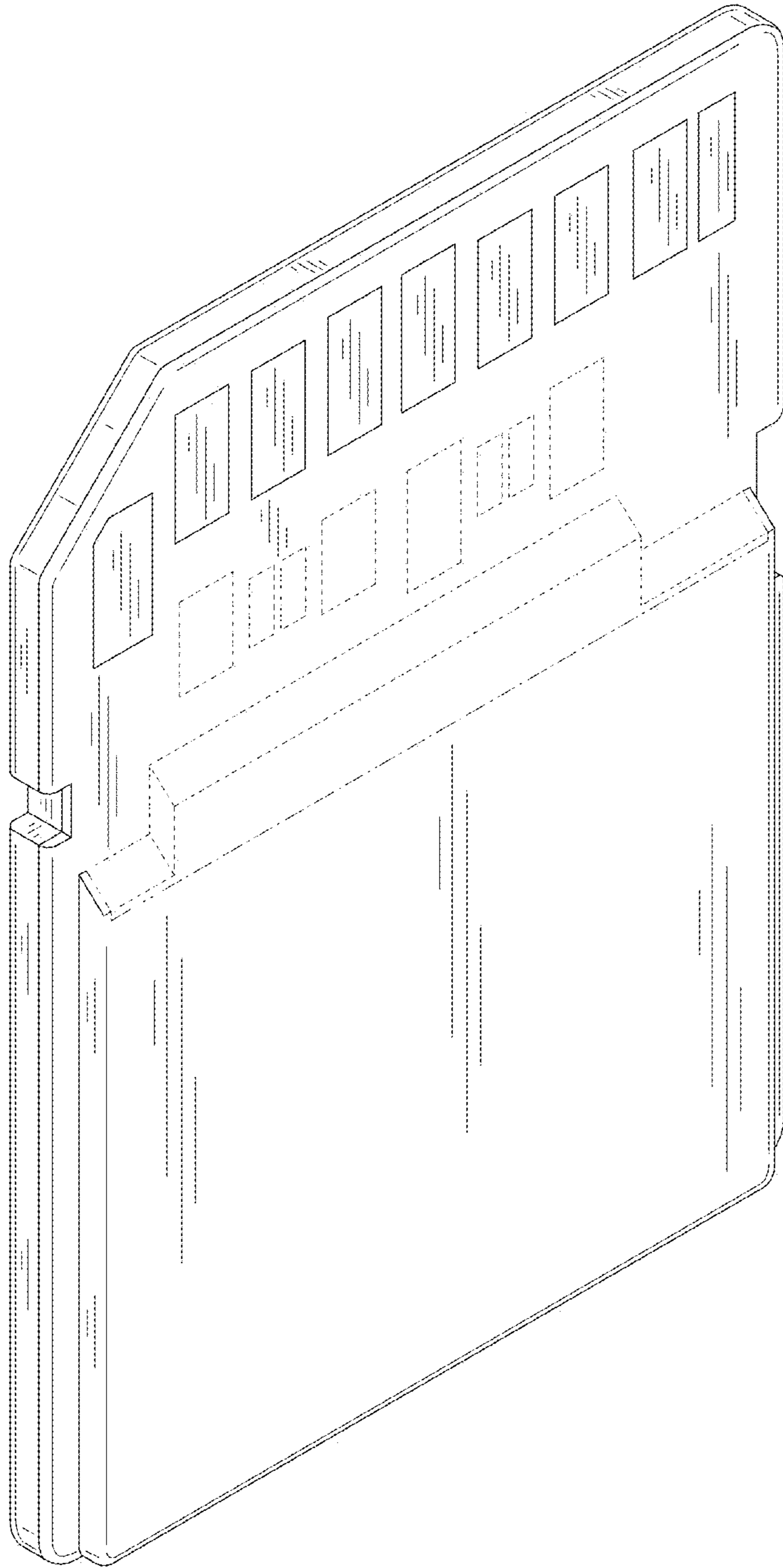

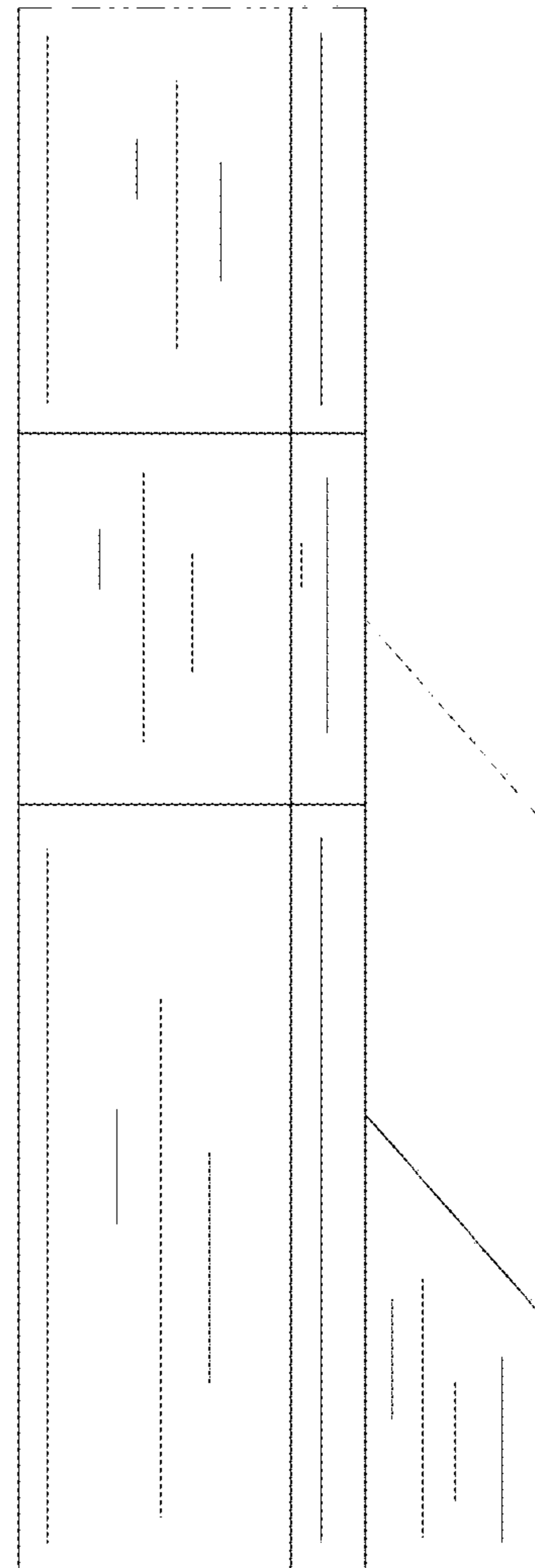

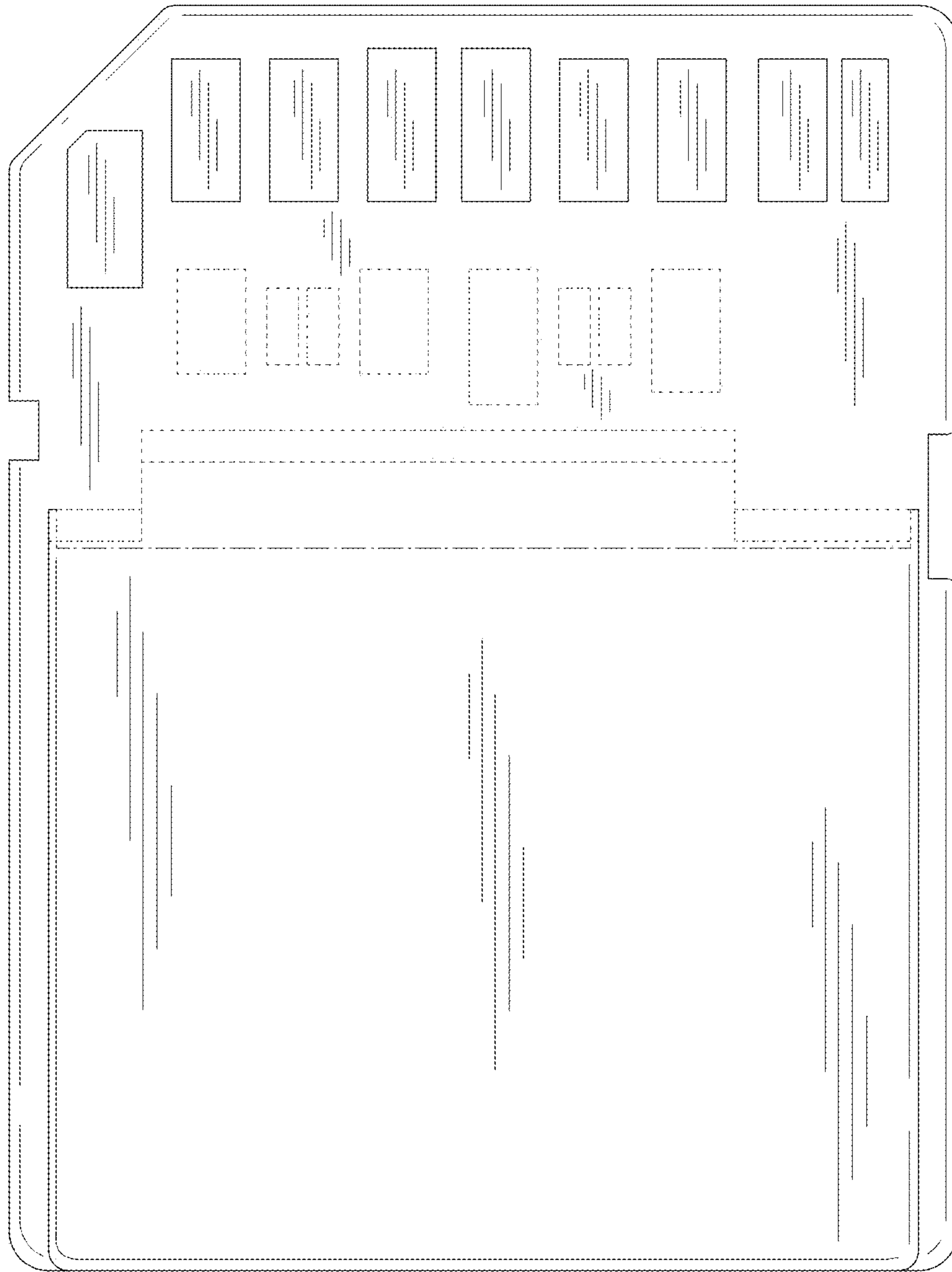

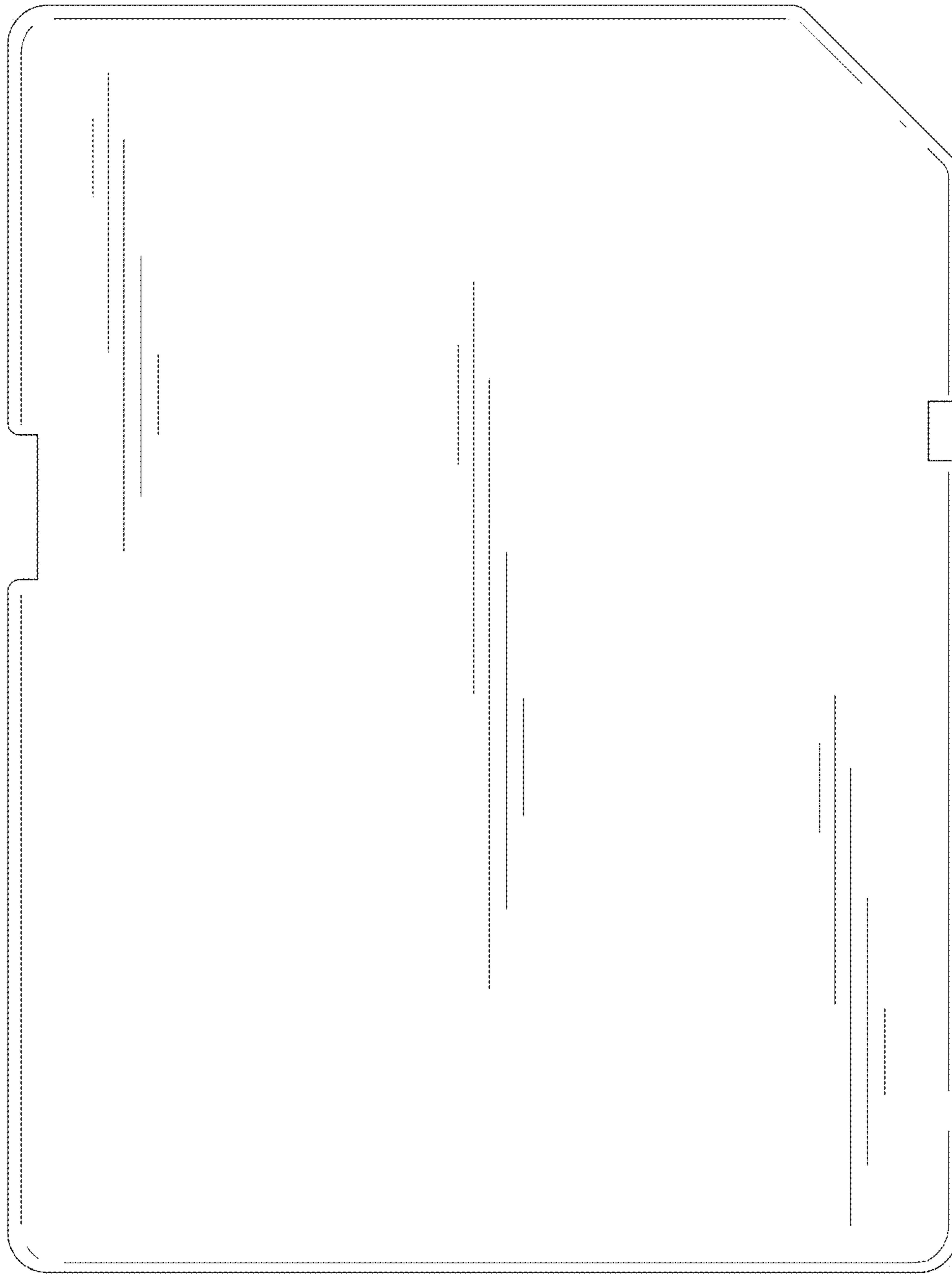

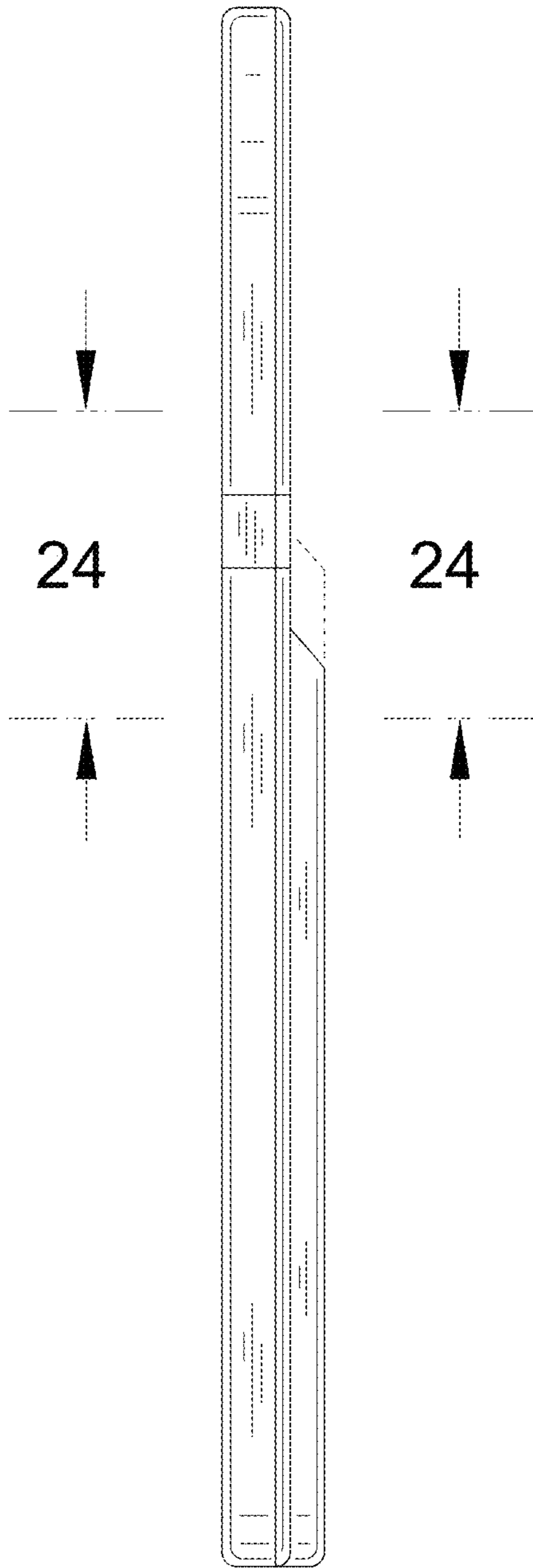

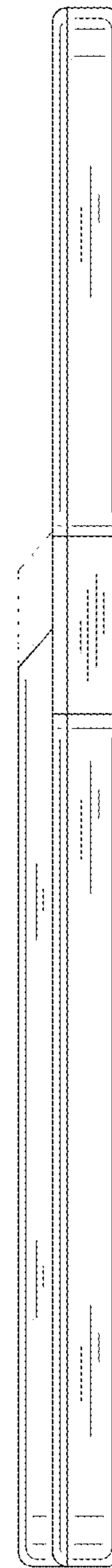

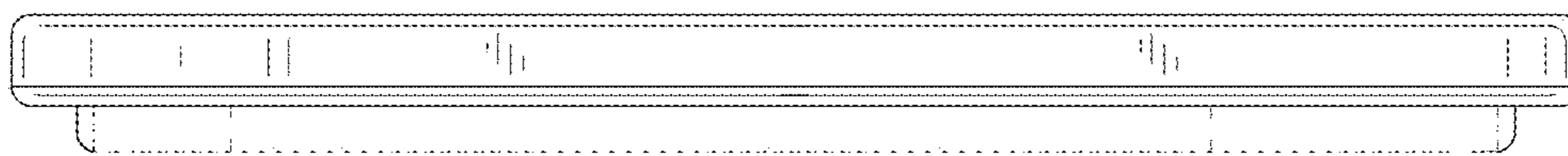

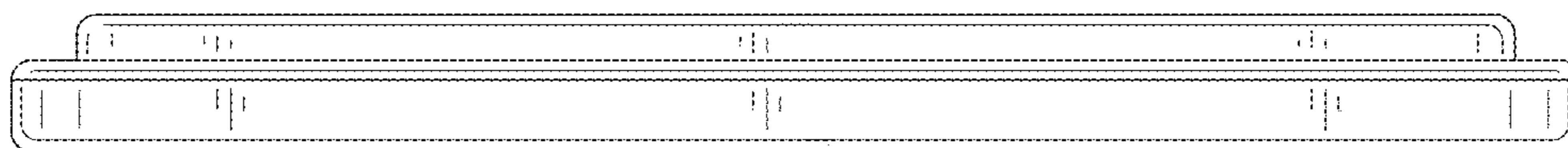

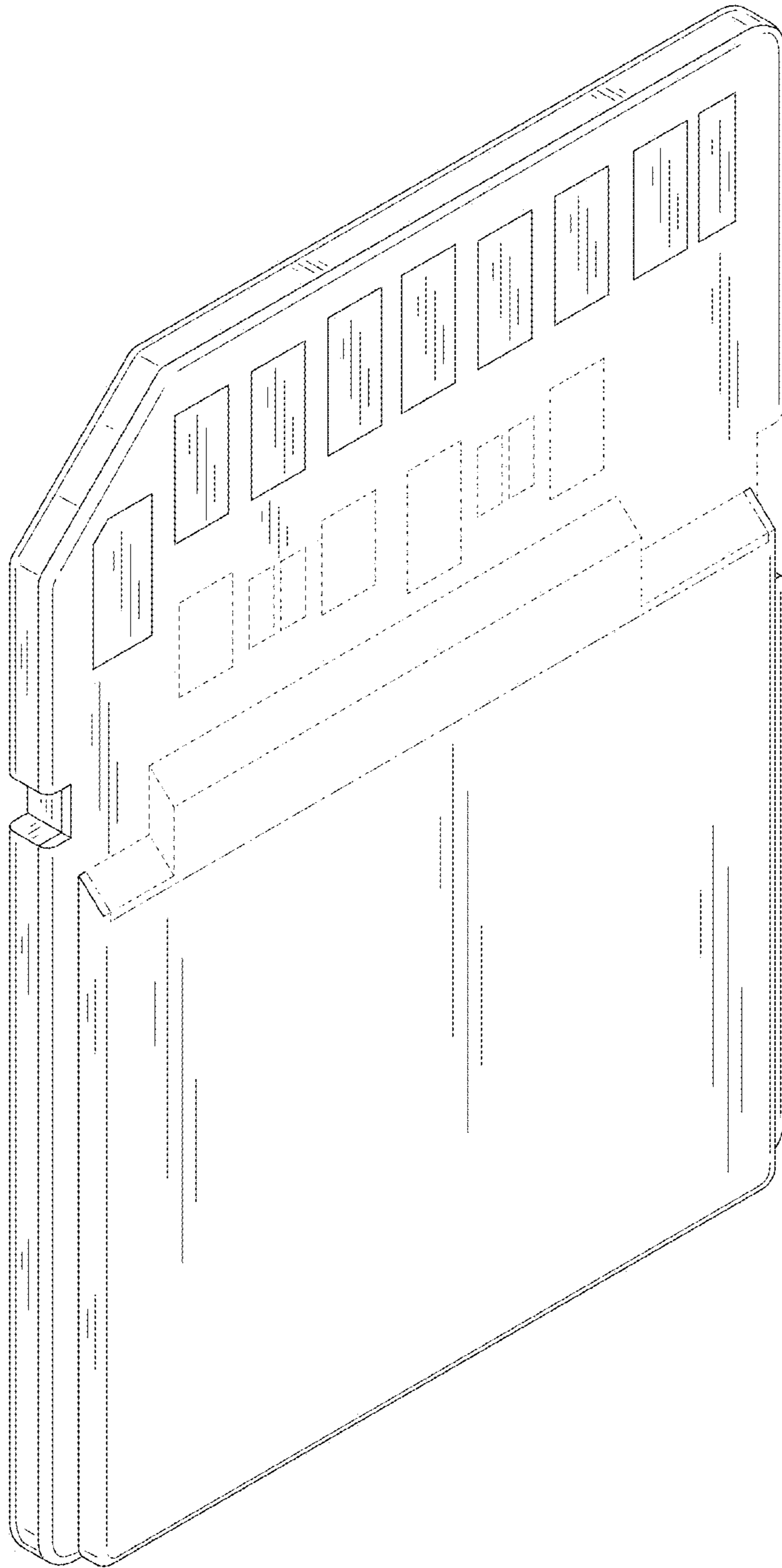

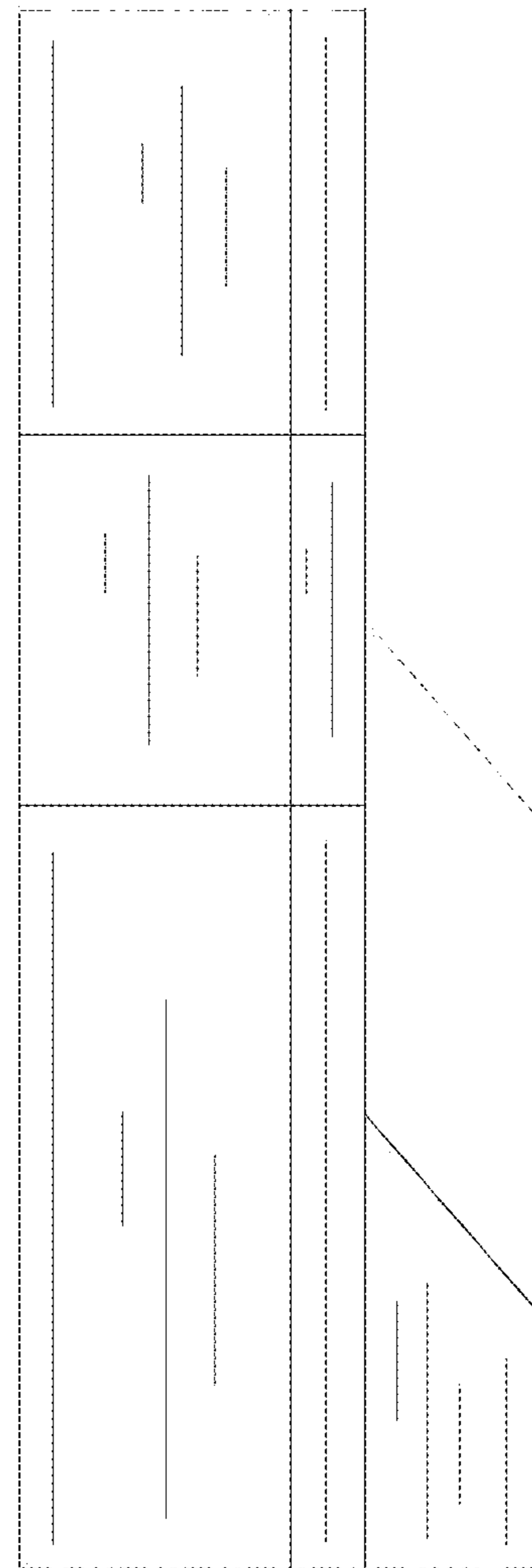

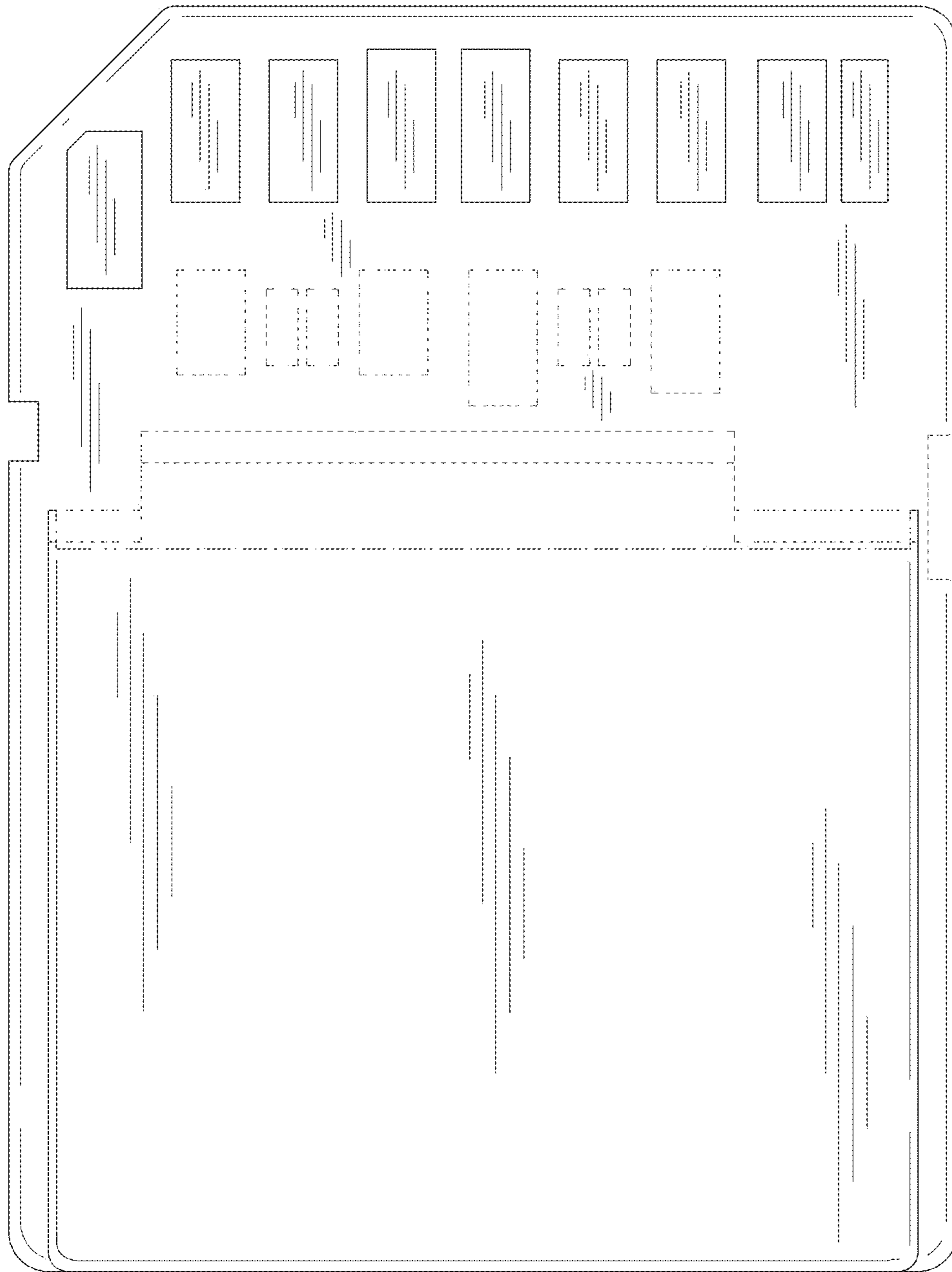

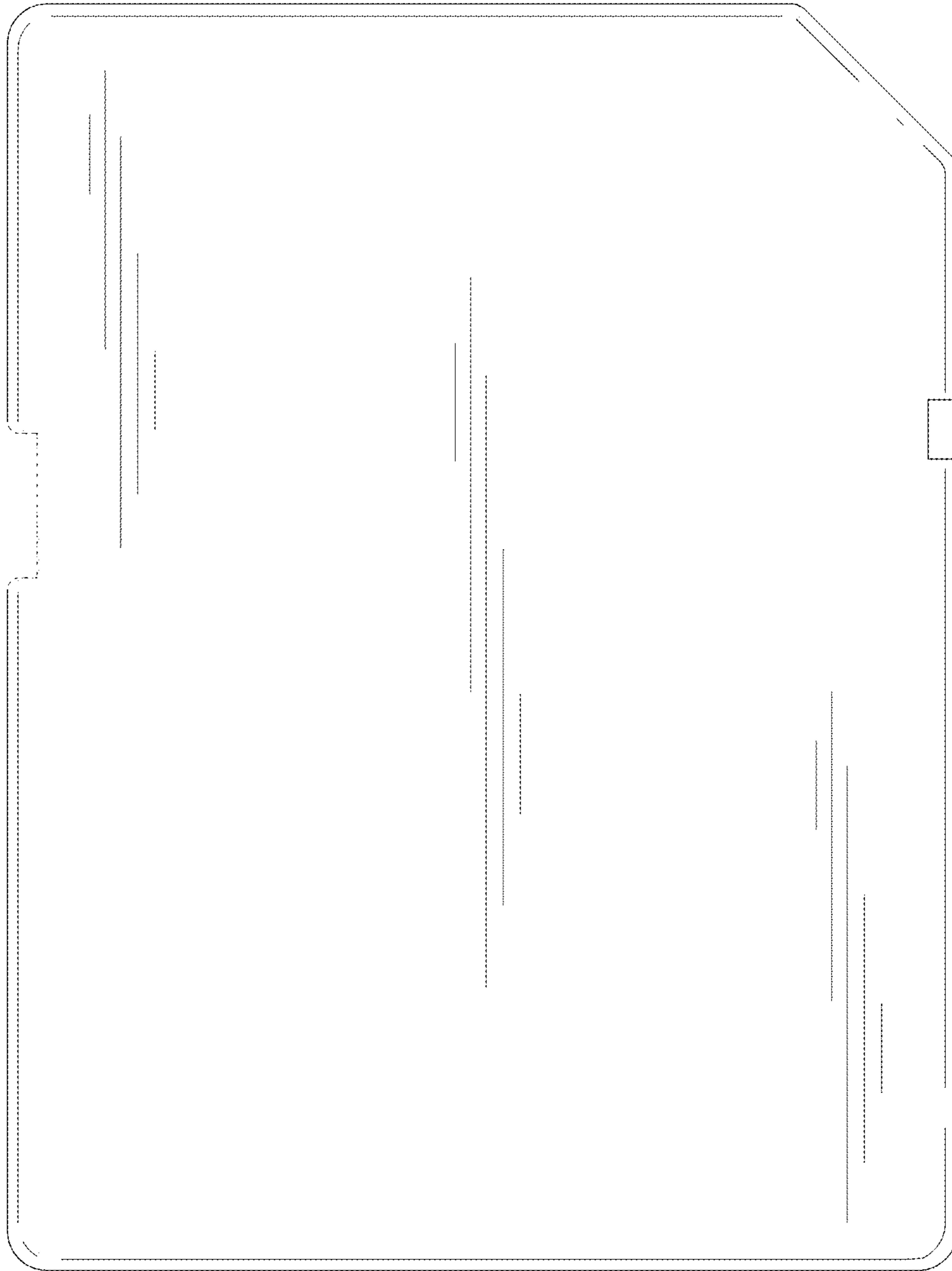

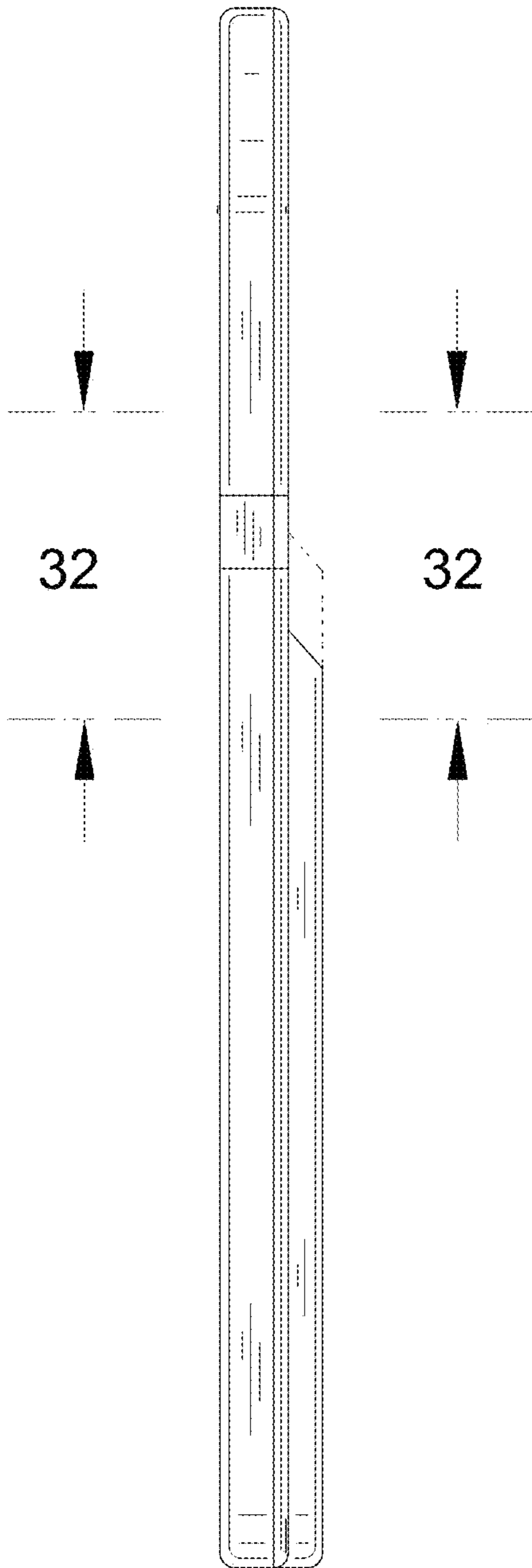

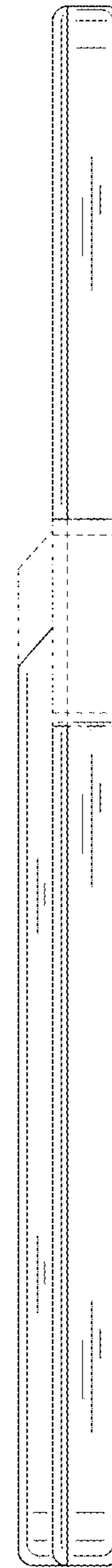

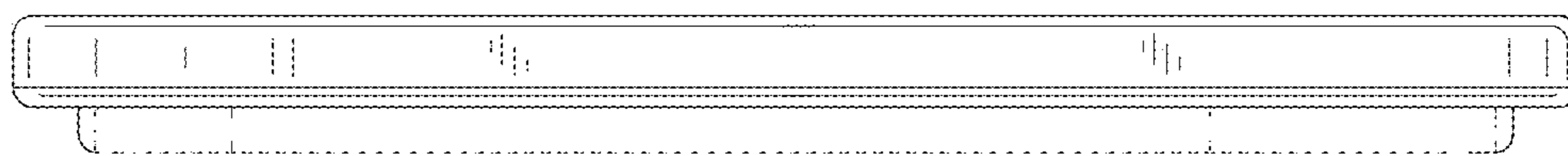

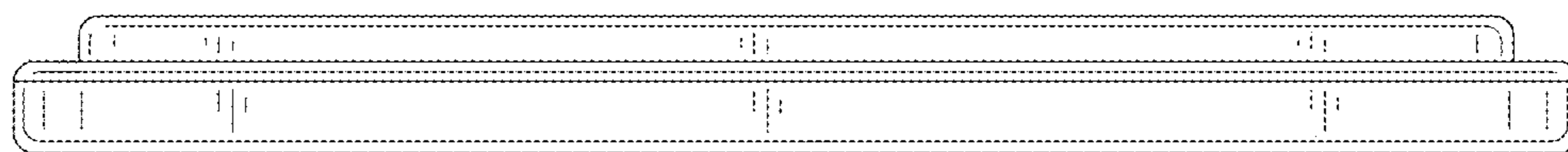

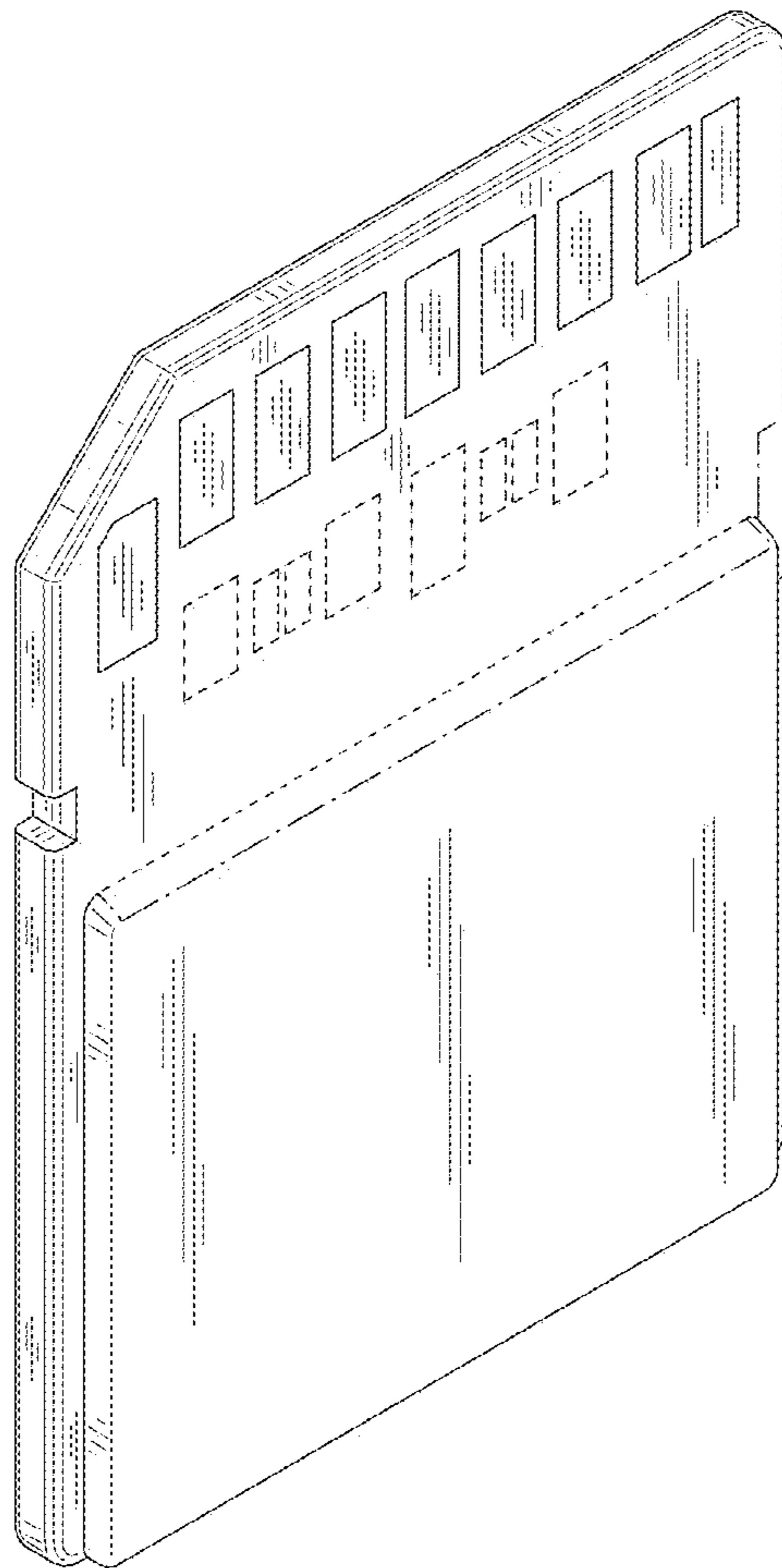

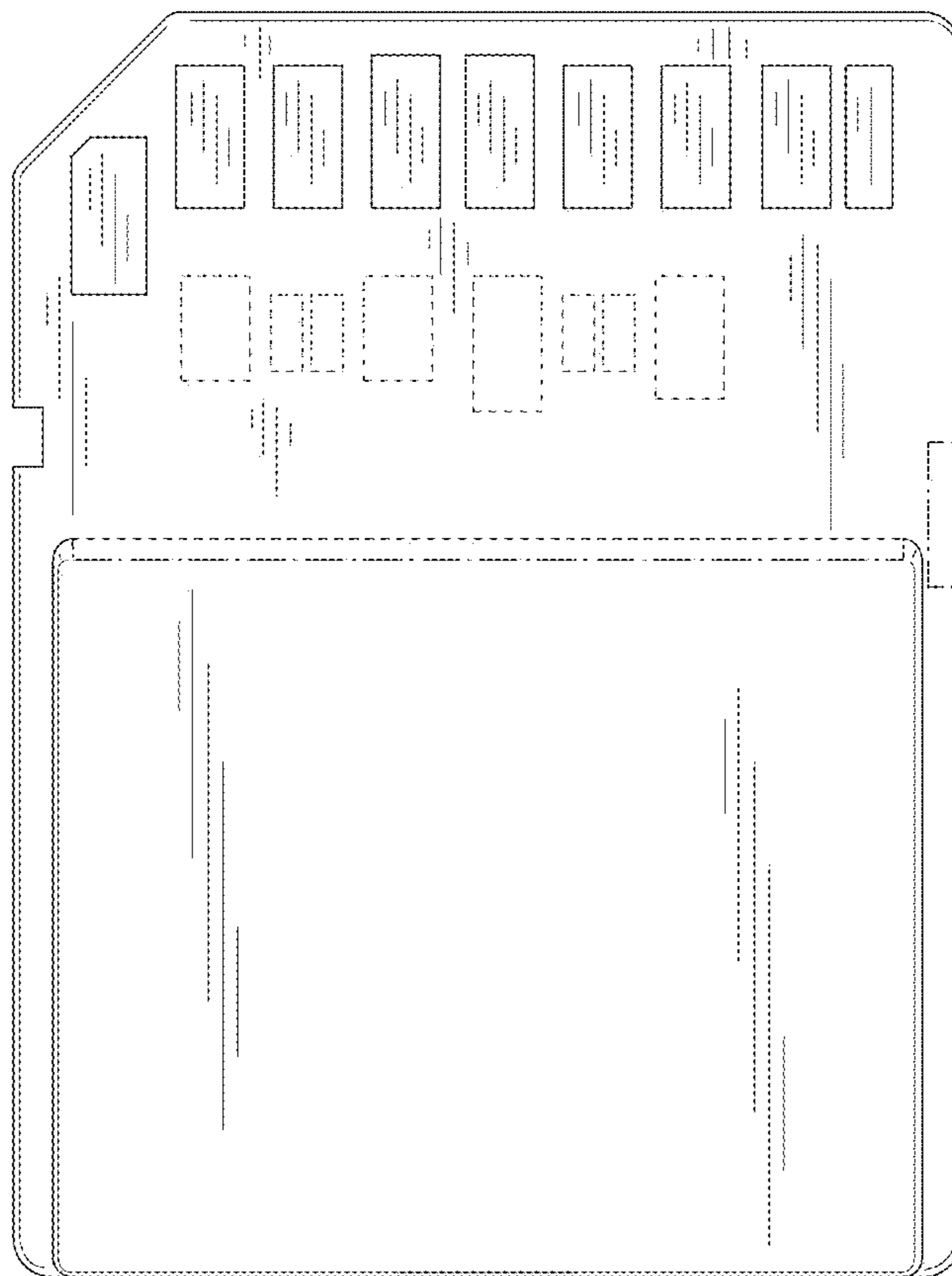

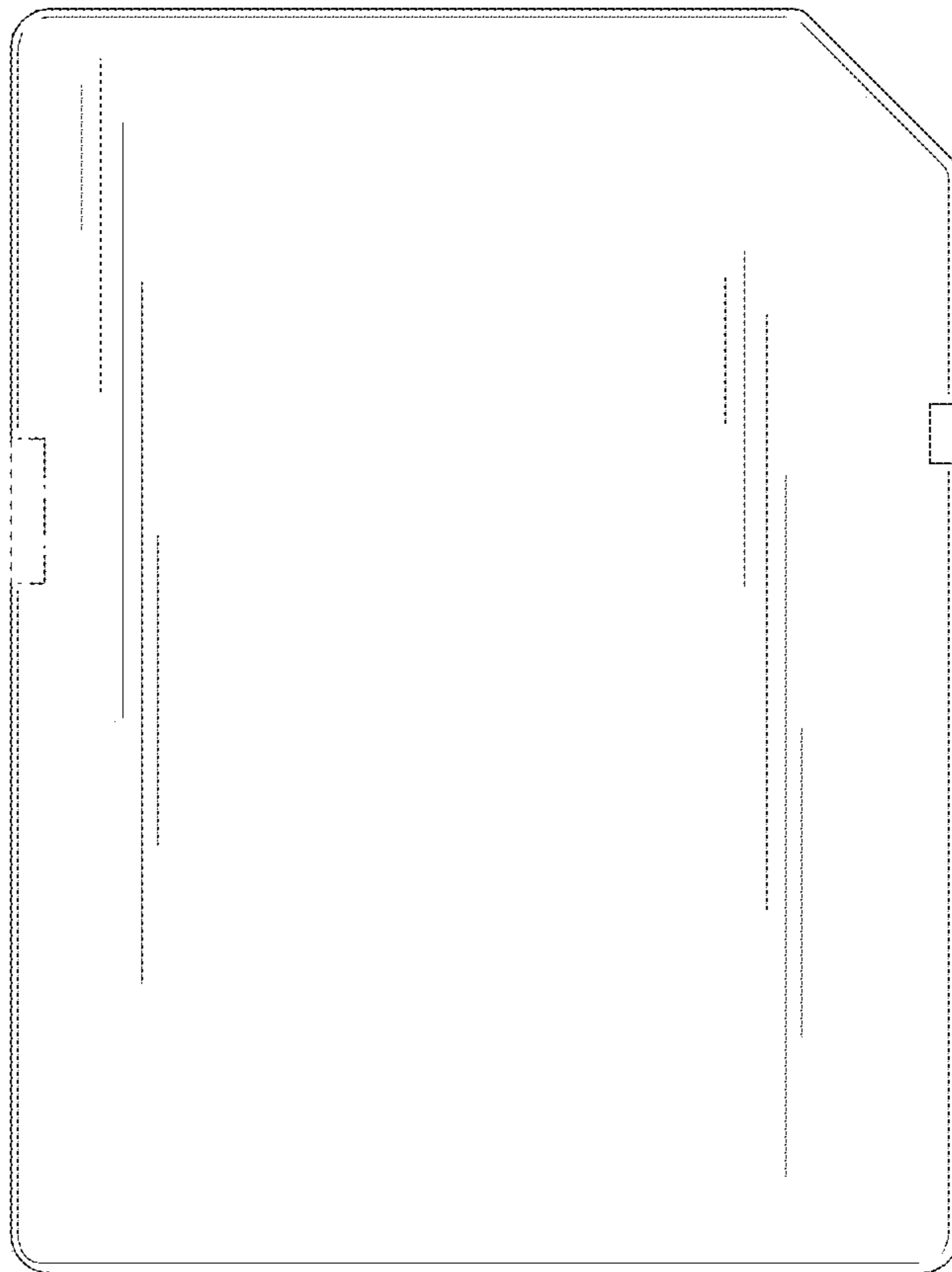

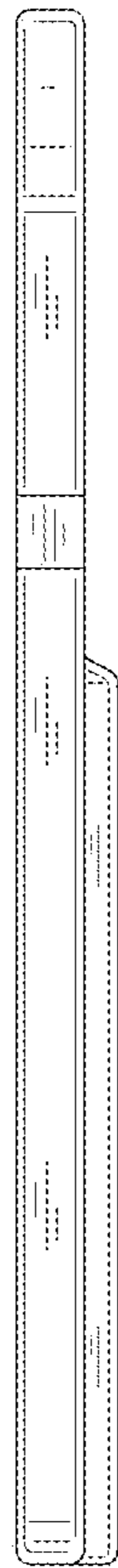

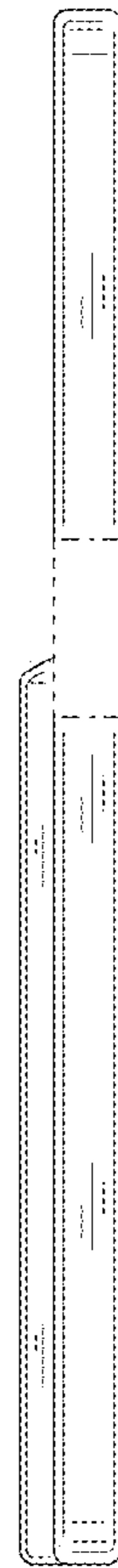

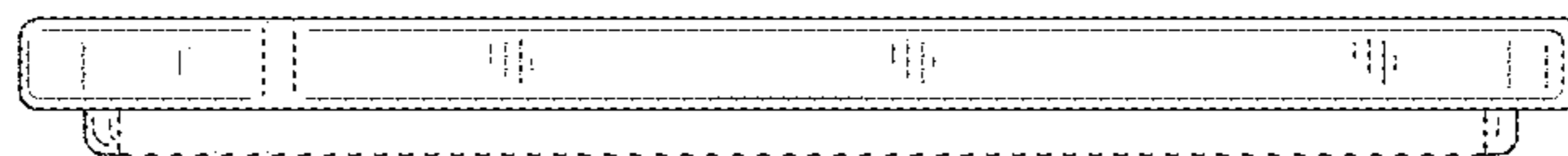
