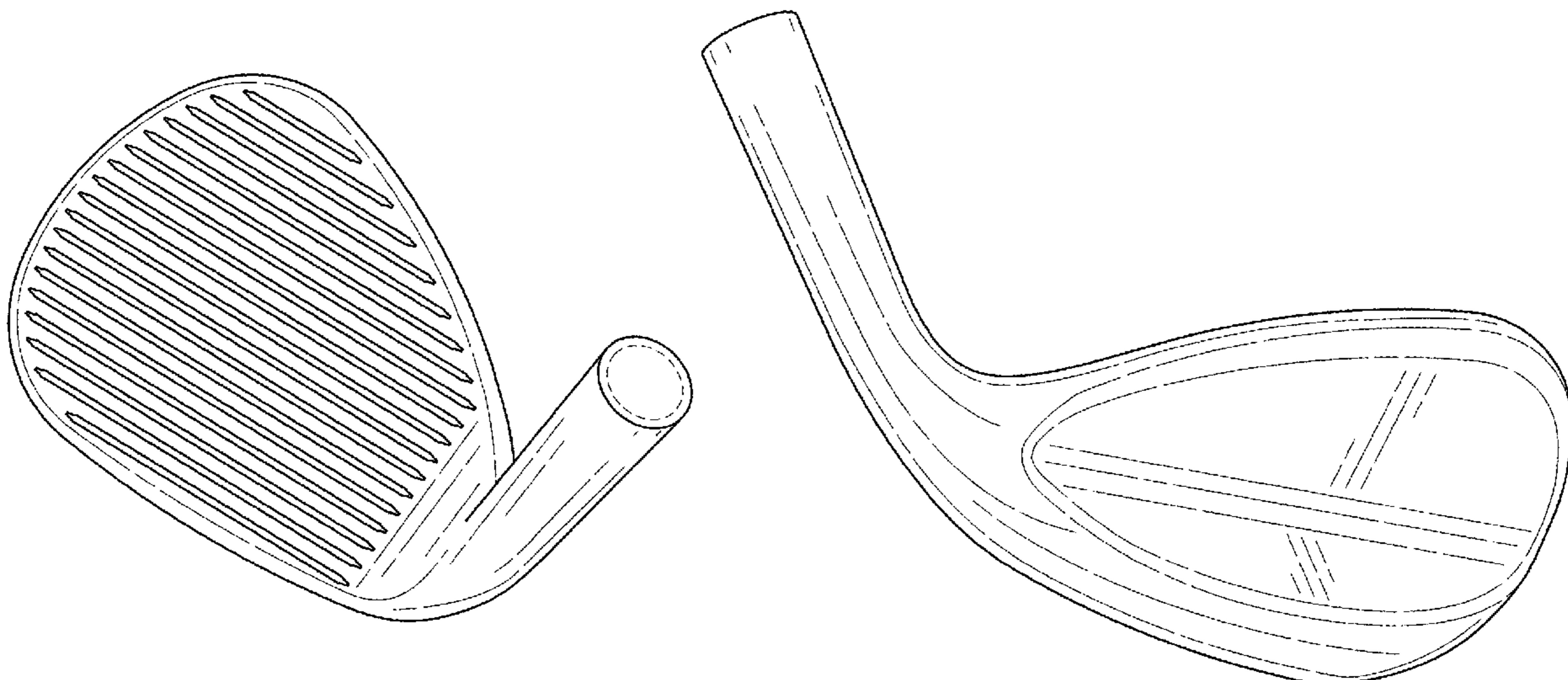
(57) **CLAIM**

The ornamental design for a golf club head, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a golf club head; FIG. 2 is a bottom perspective view of the golf club head of FIG. 1; FIG. 3 is a top view of the golf club head of FIG. 1; FIG. 4 is a bottom view of the golf club head of FIG. 1; FIG. 5 is a front view of the golf club head of FIG. 1; FIG. 6 is a rear view of the golf club head of FIG. 1; FIG. 7 is a heel side view of the golf club head of FIG. 1; and, FIG. 8 is a toe side view of the golf club head of FIG. 1. The broken lines shown form no part of the claimed design.

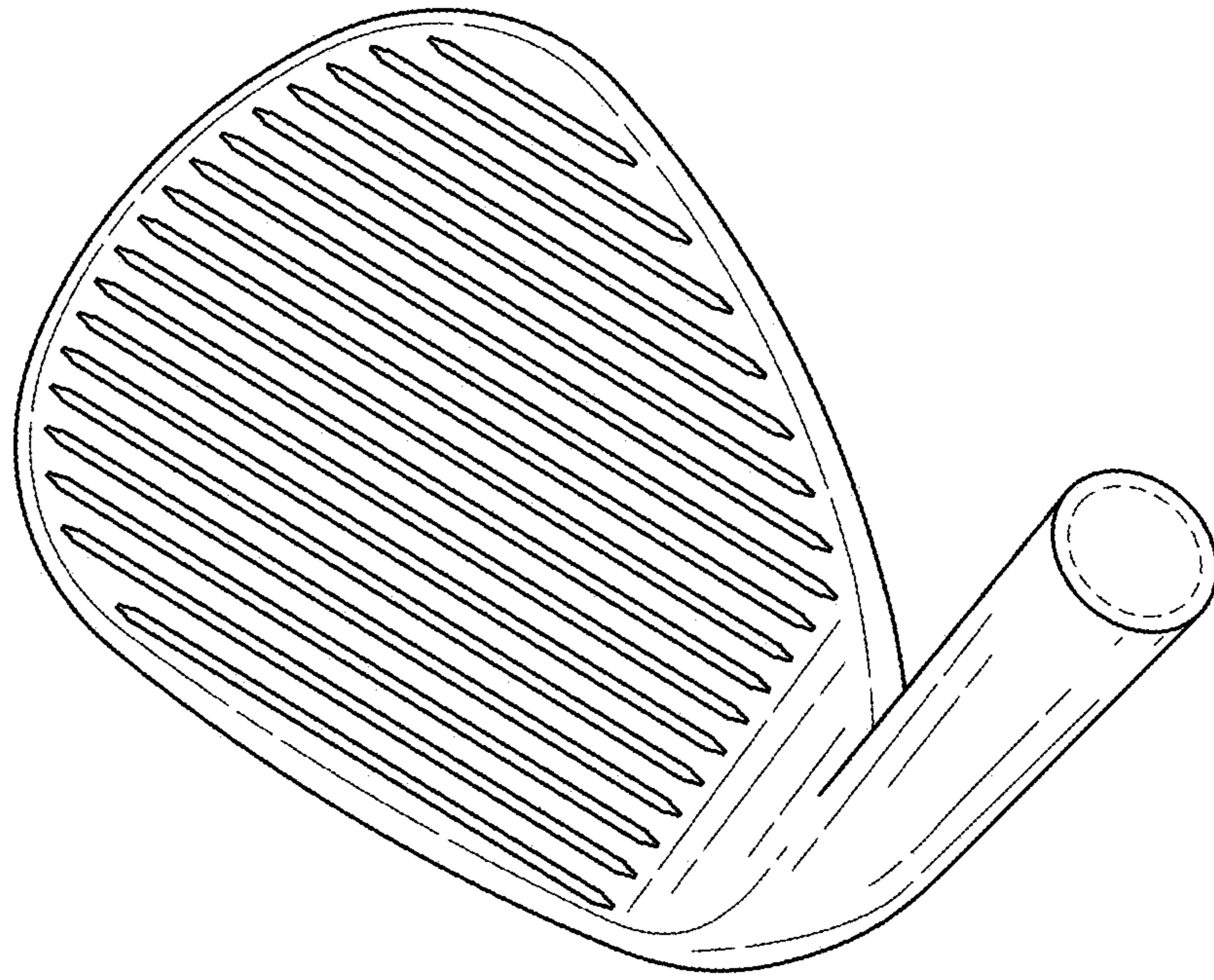

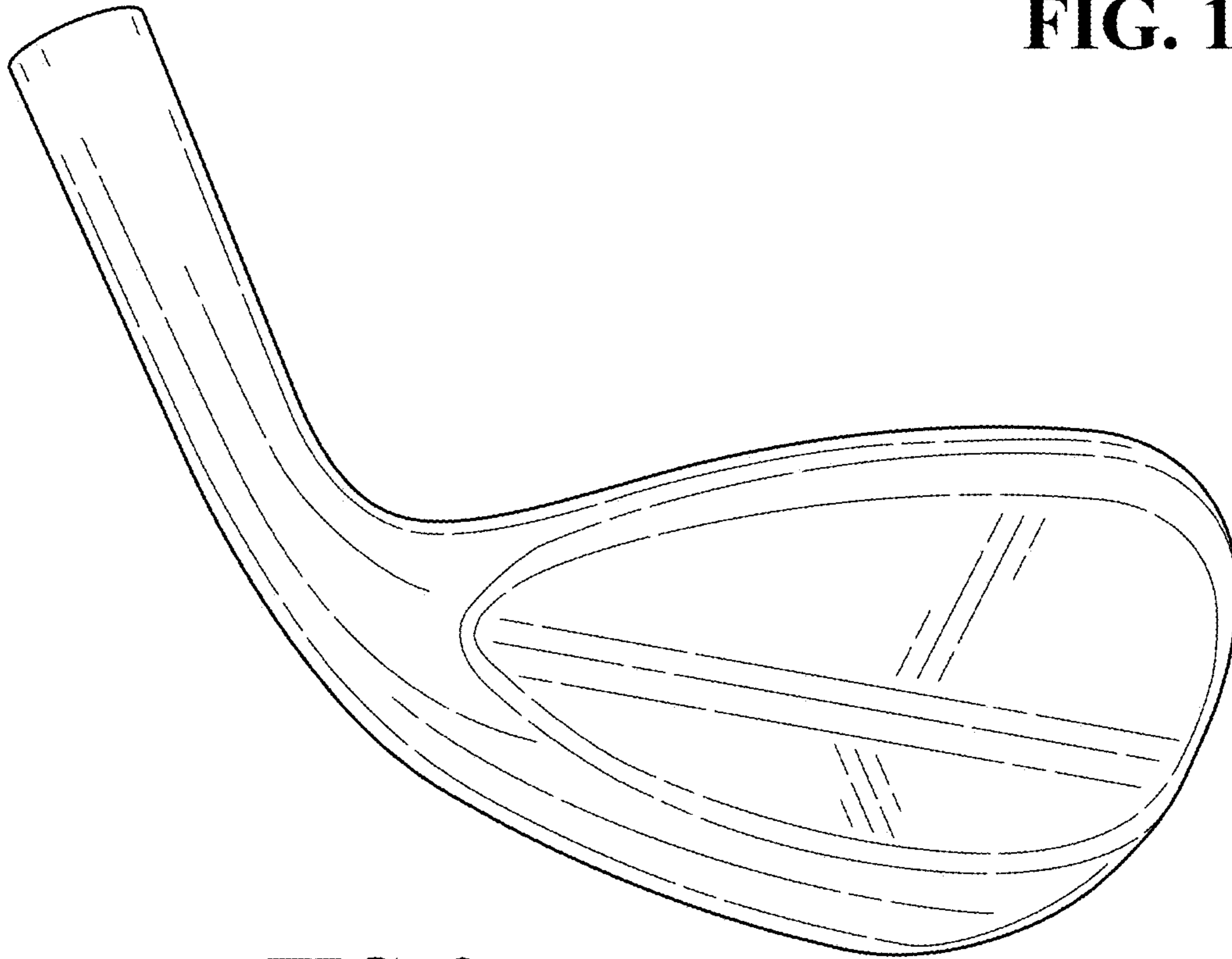

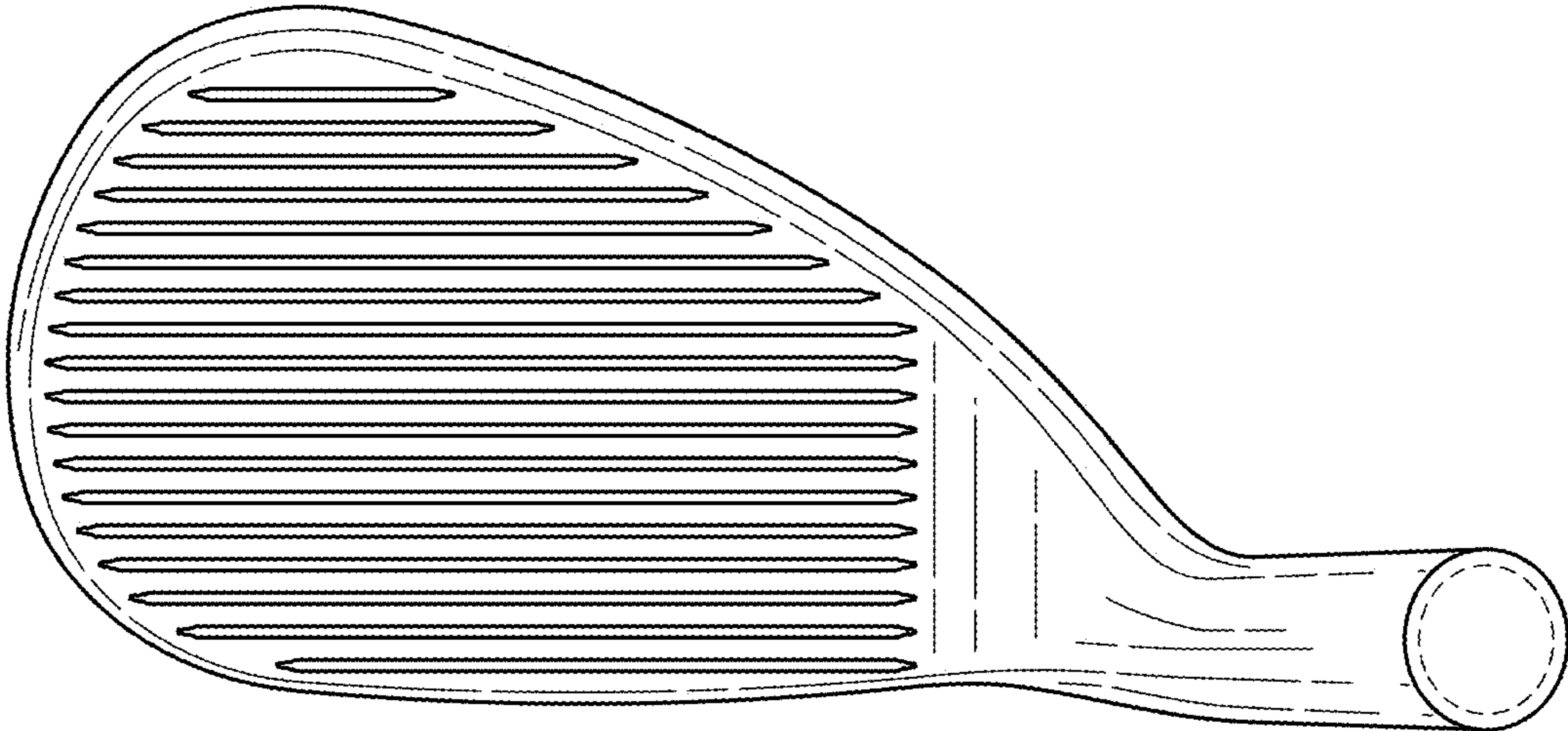

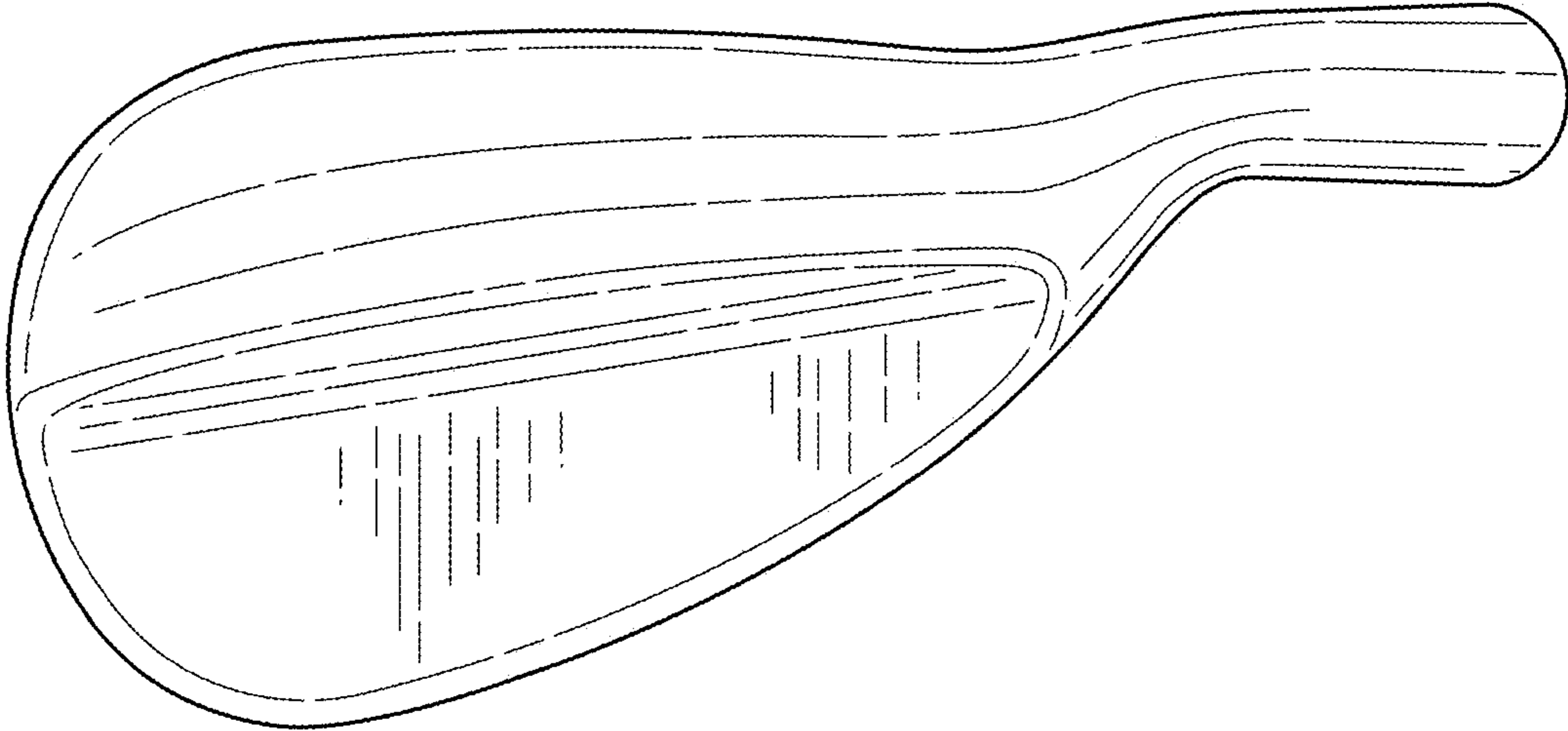

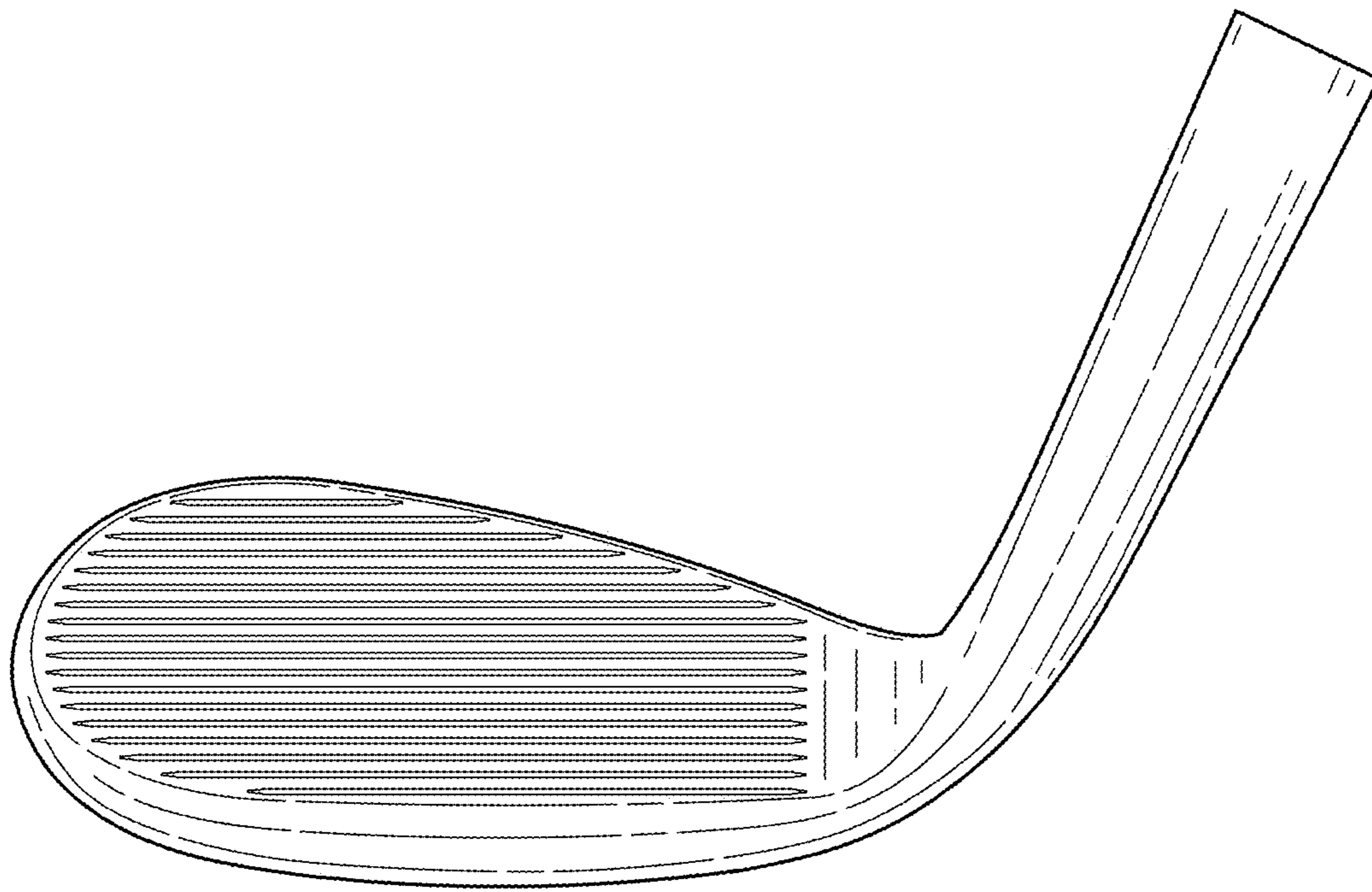

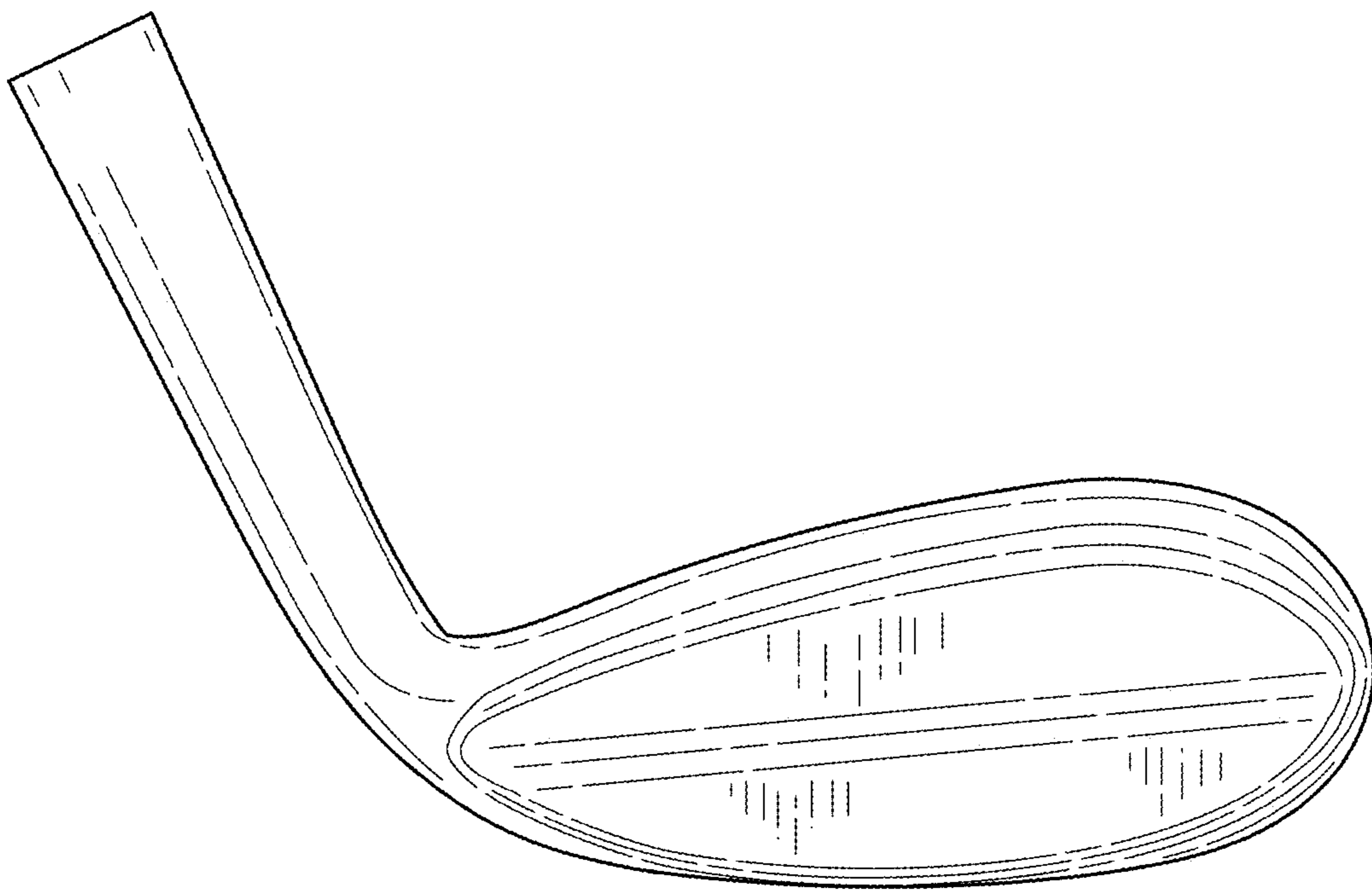

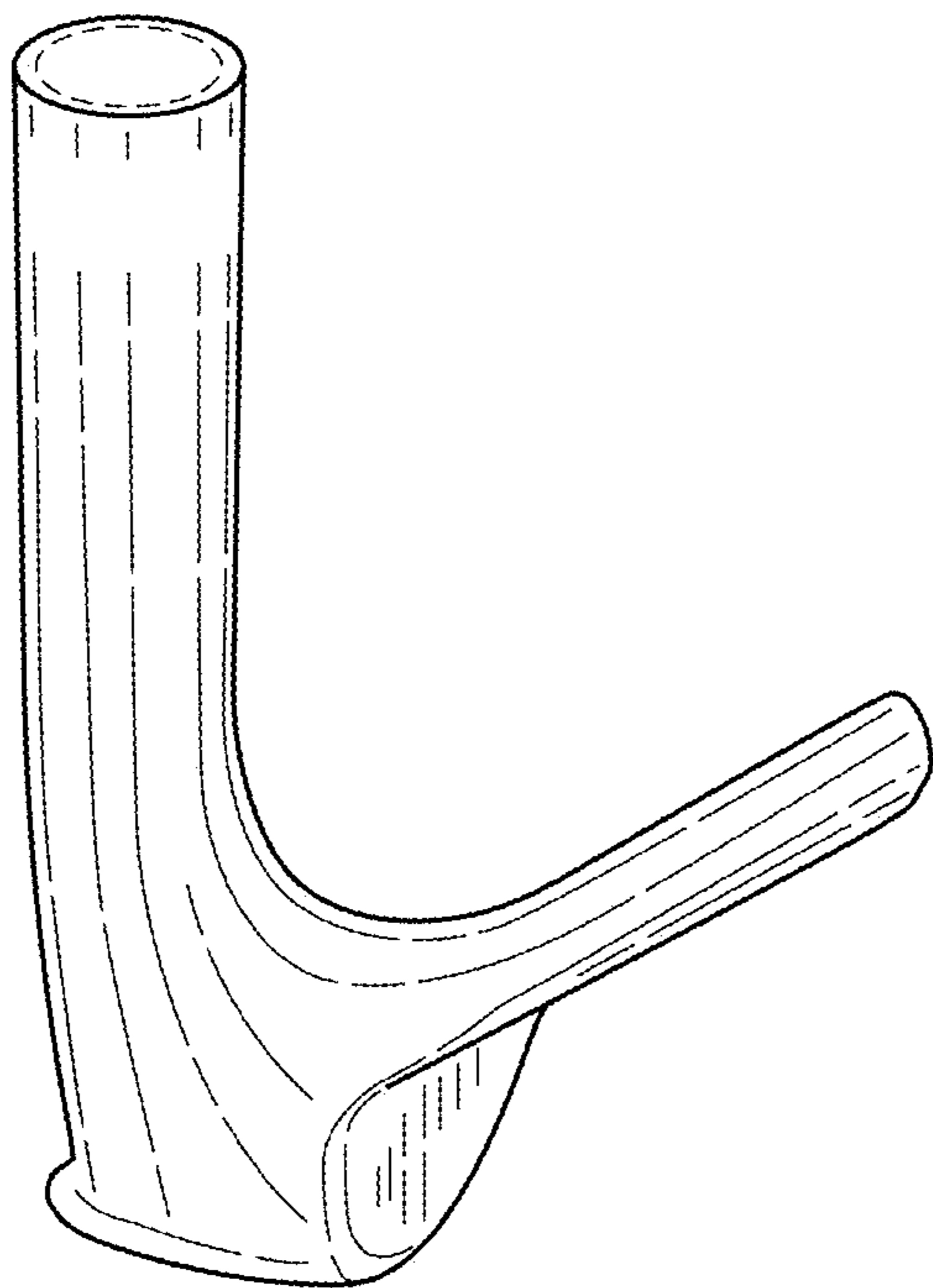

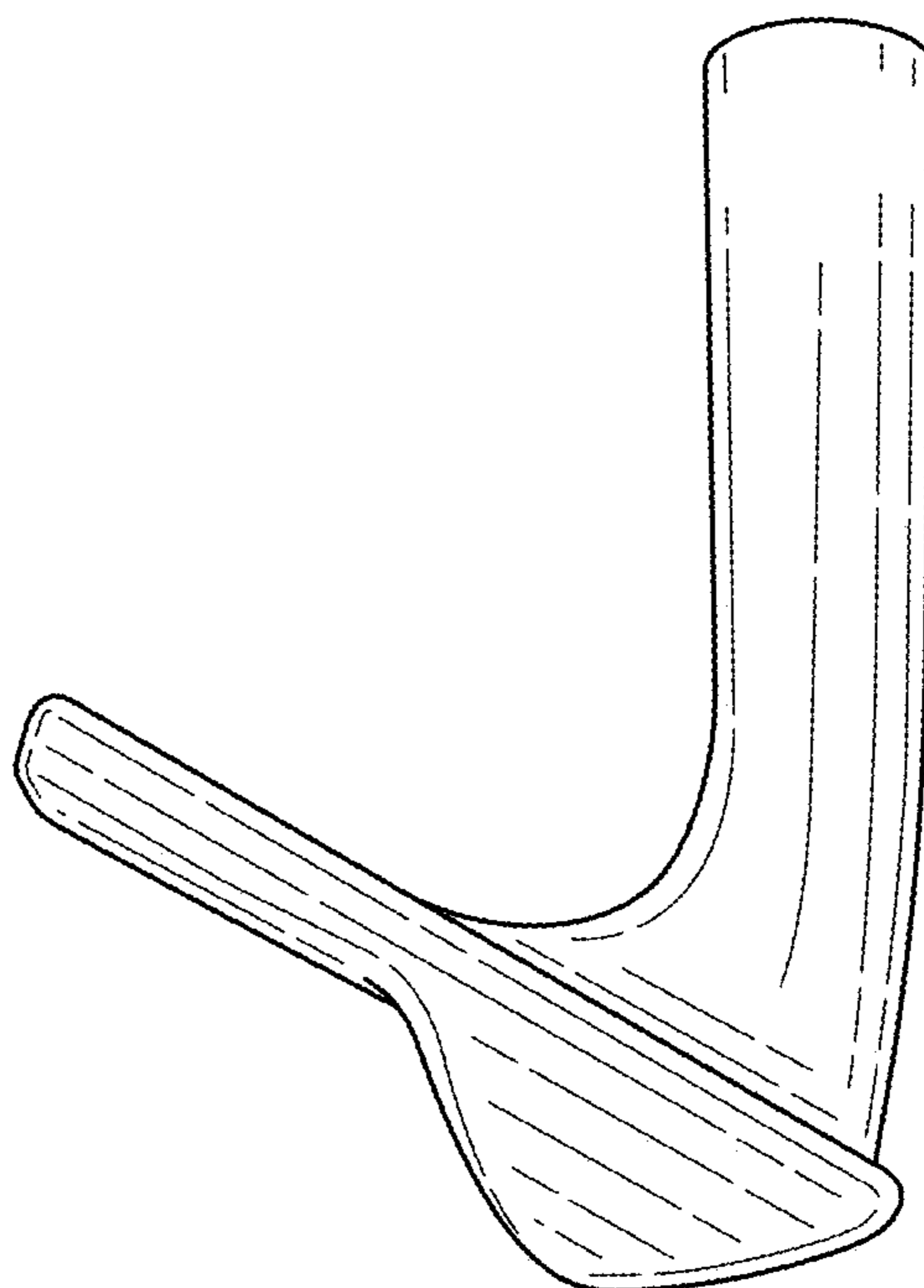
