(57) **CLAIM**

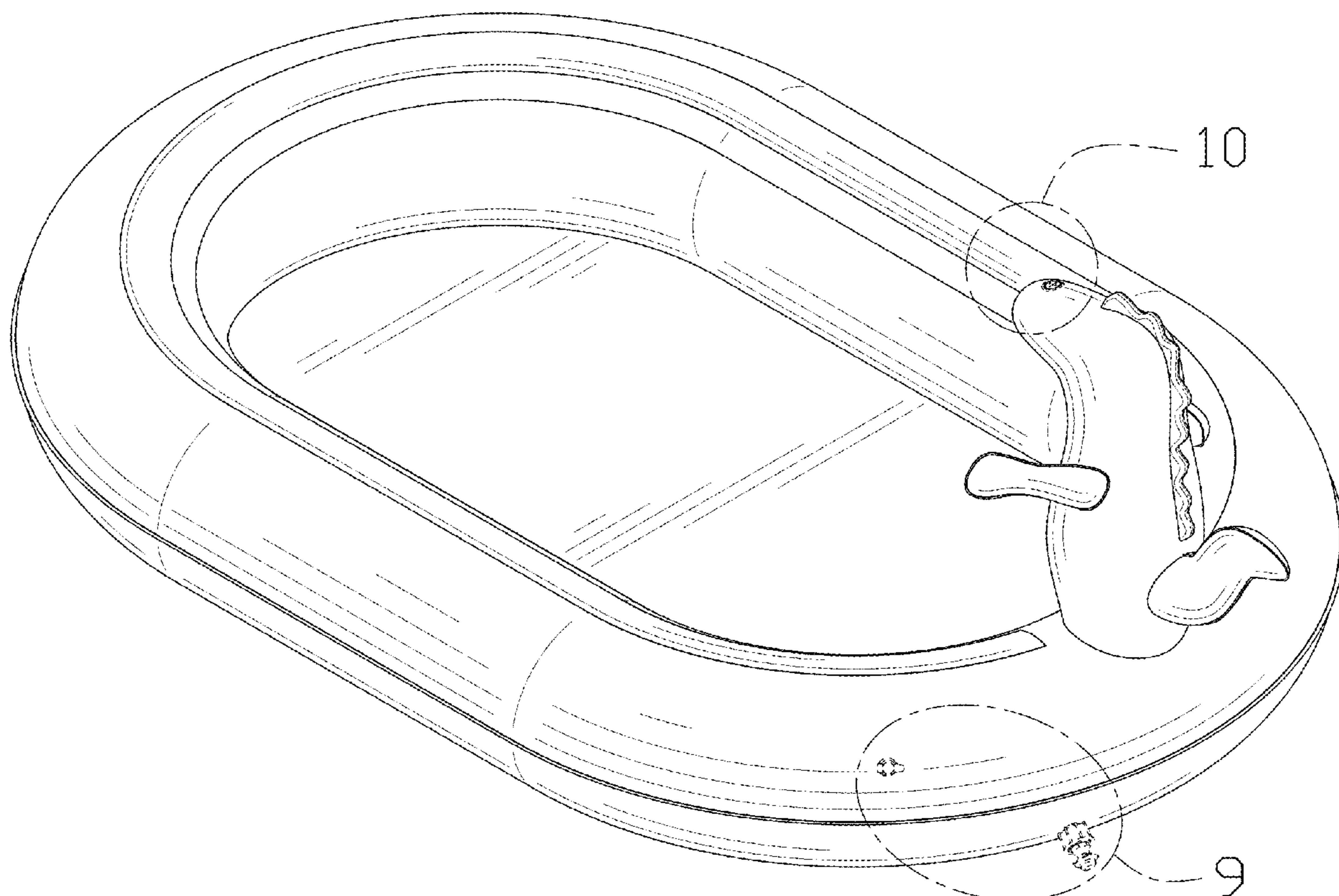
The ornamental design for a dinosaur inflatable fountain, as shown and described.

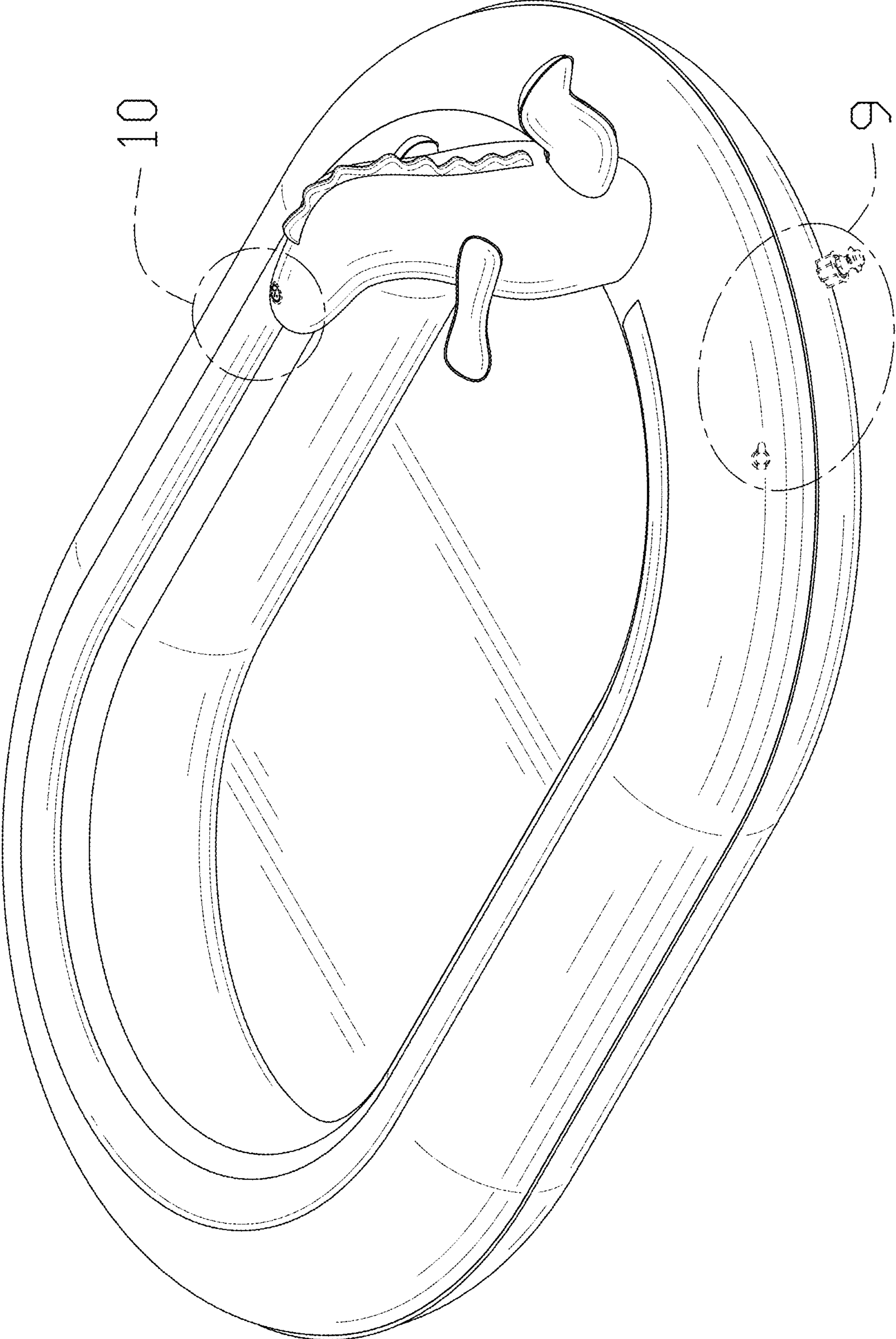

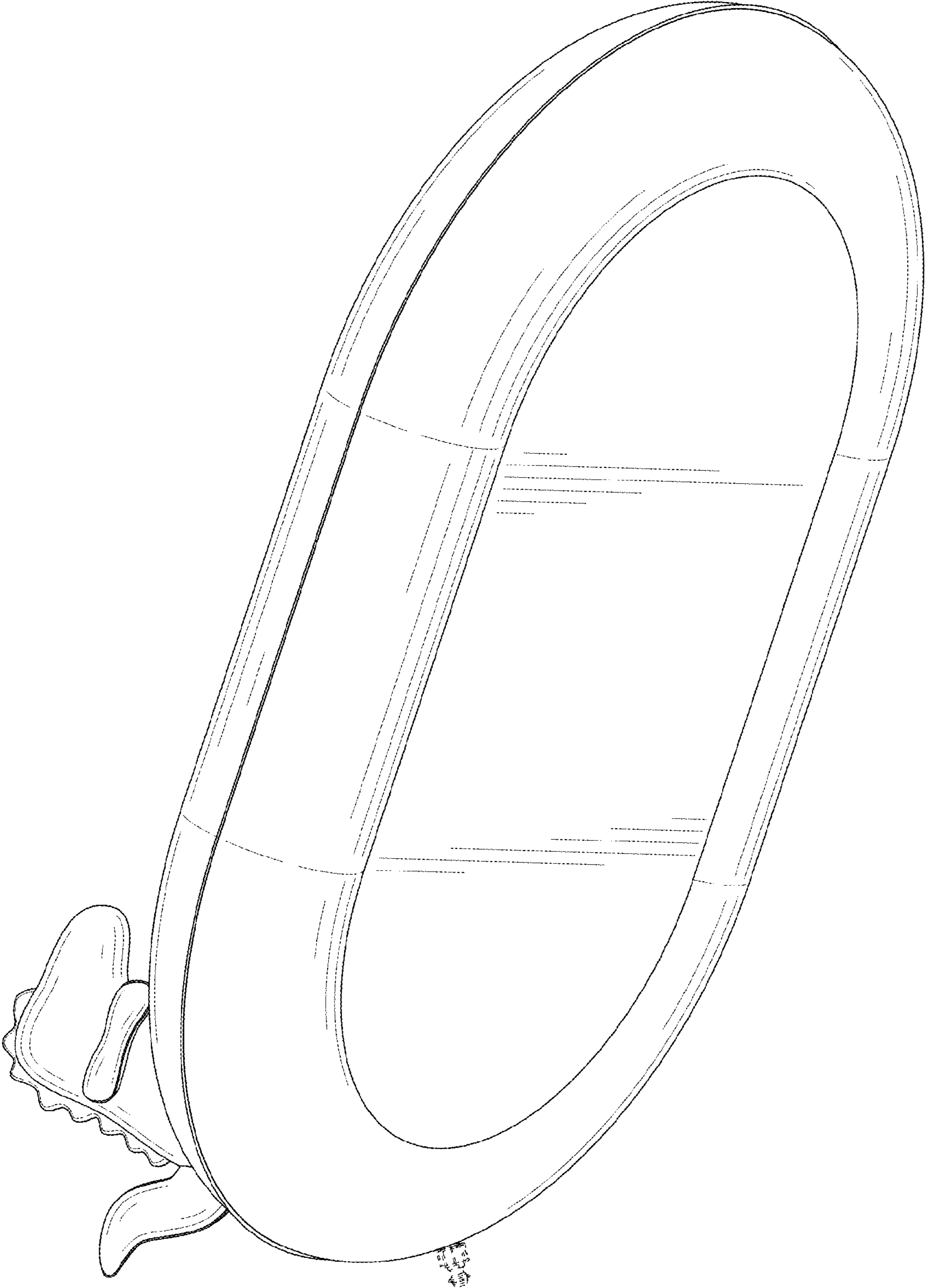

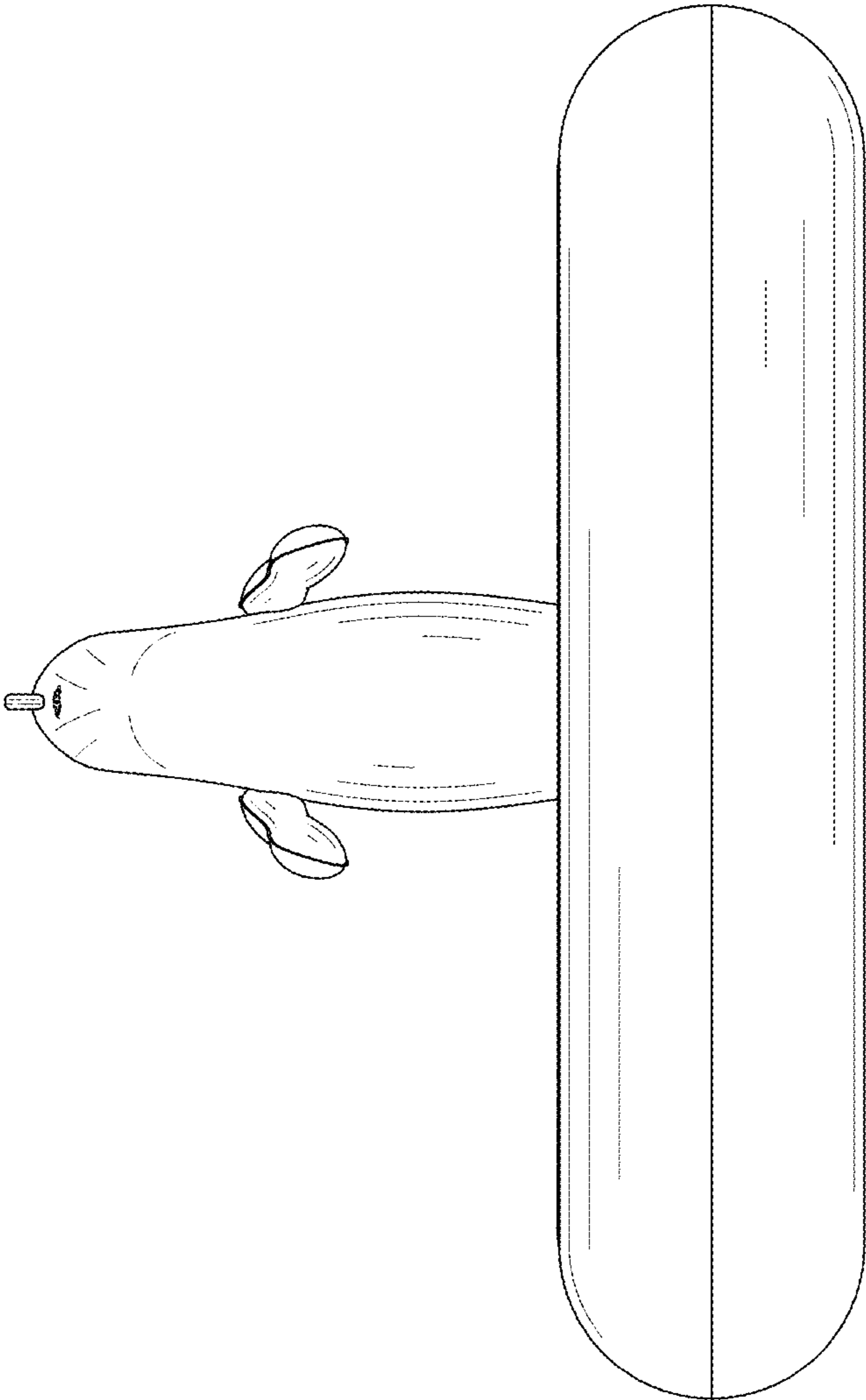

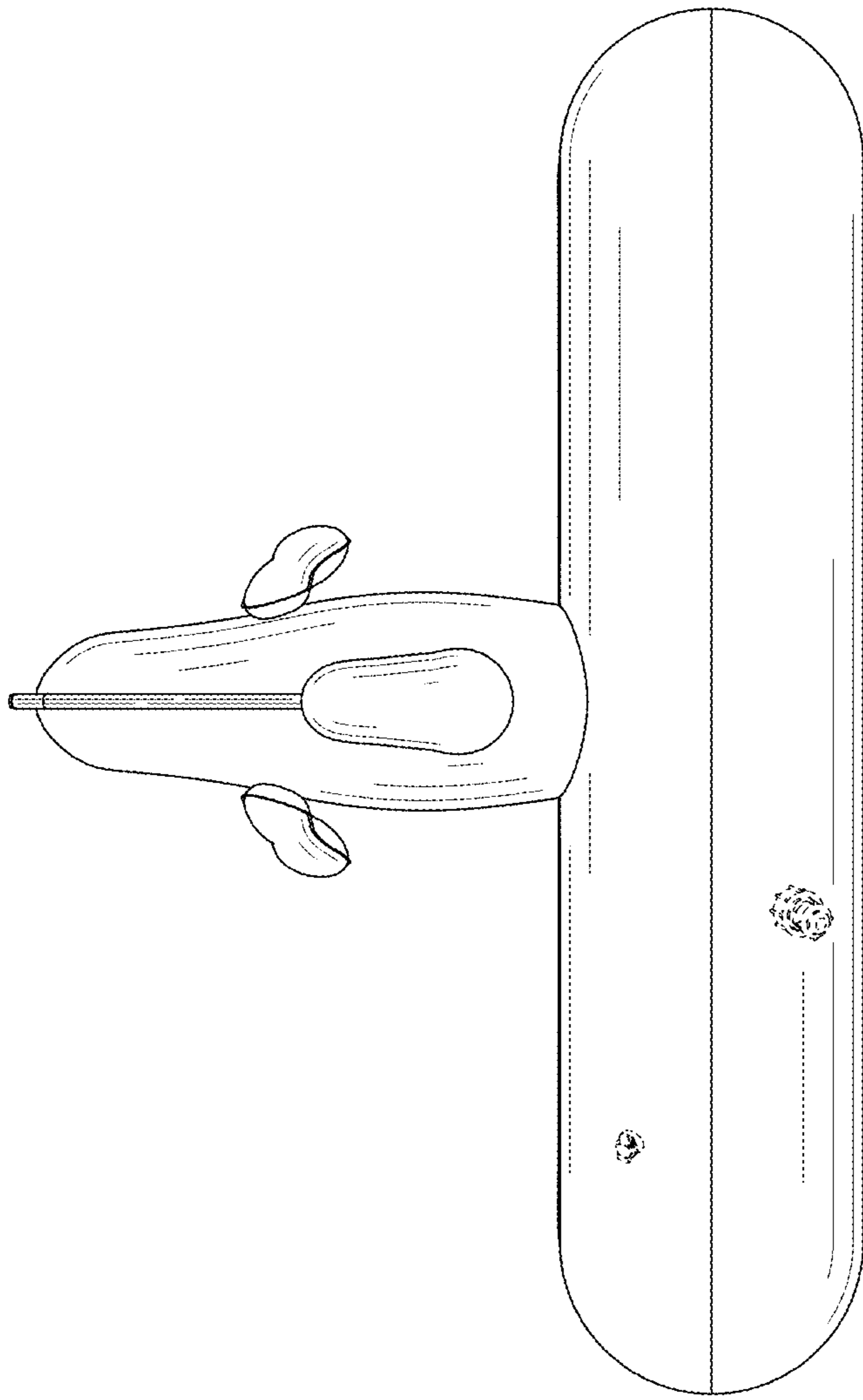

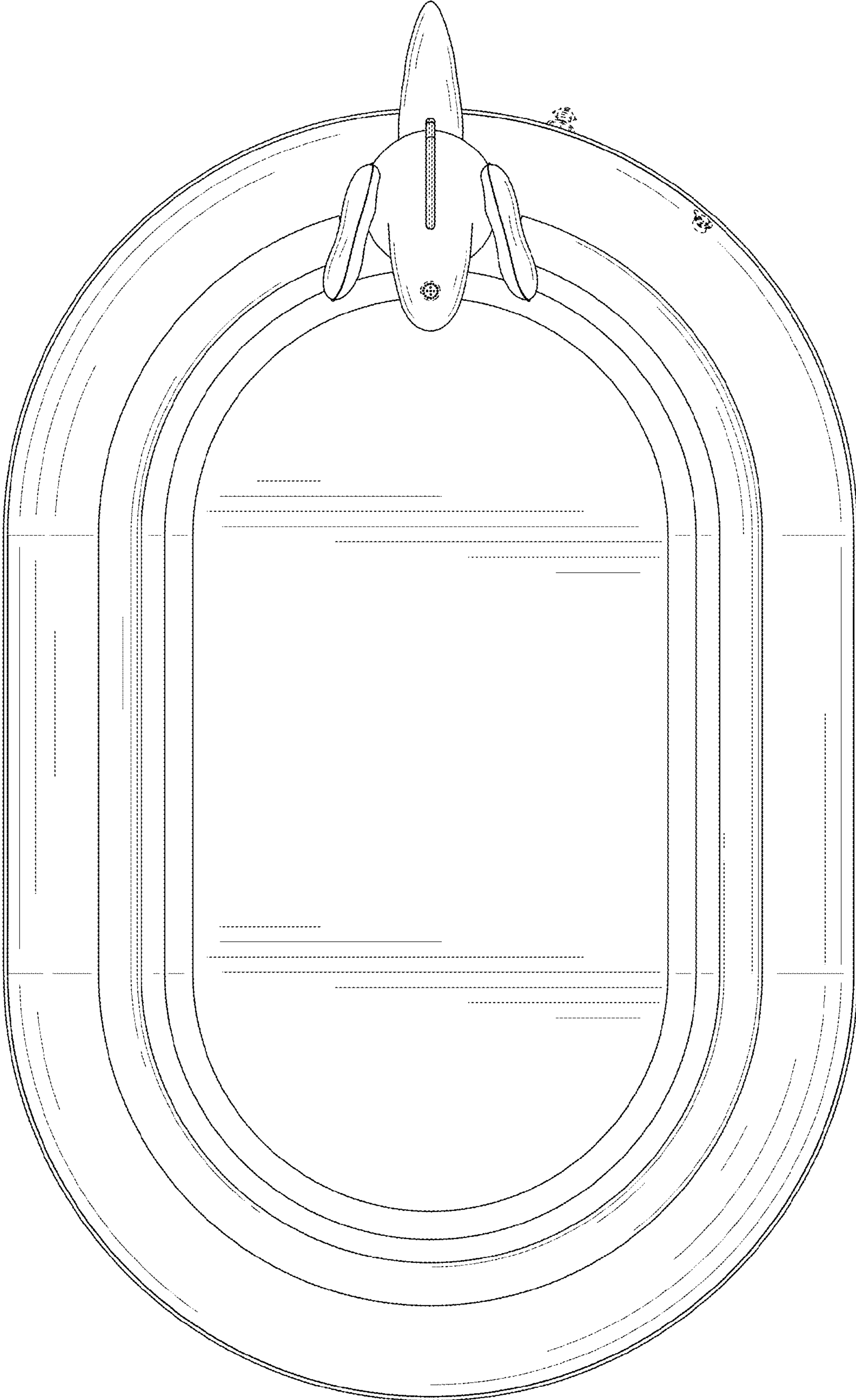

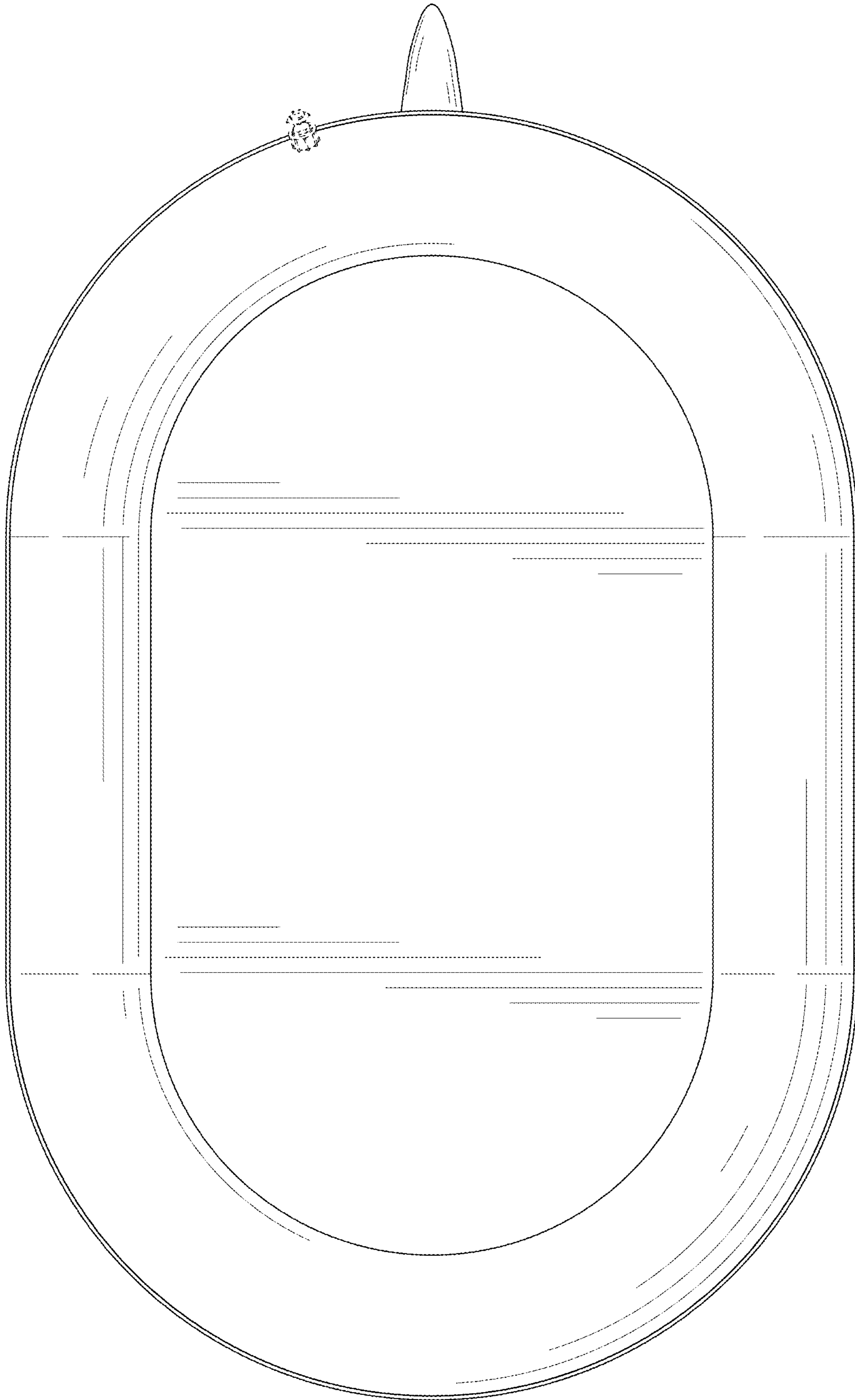

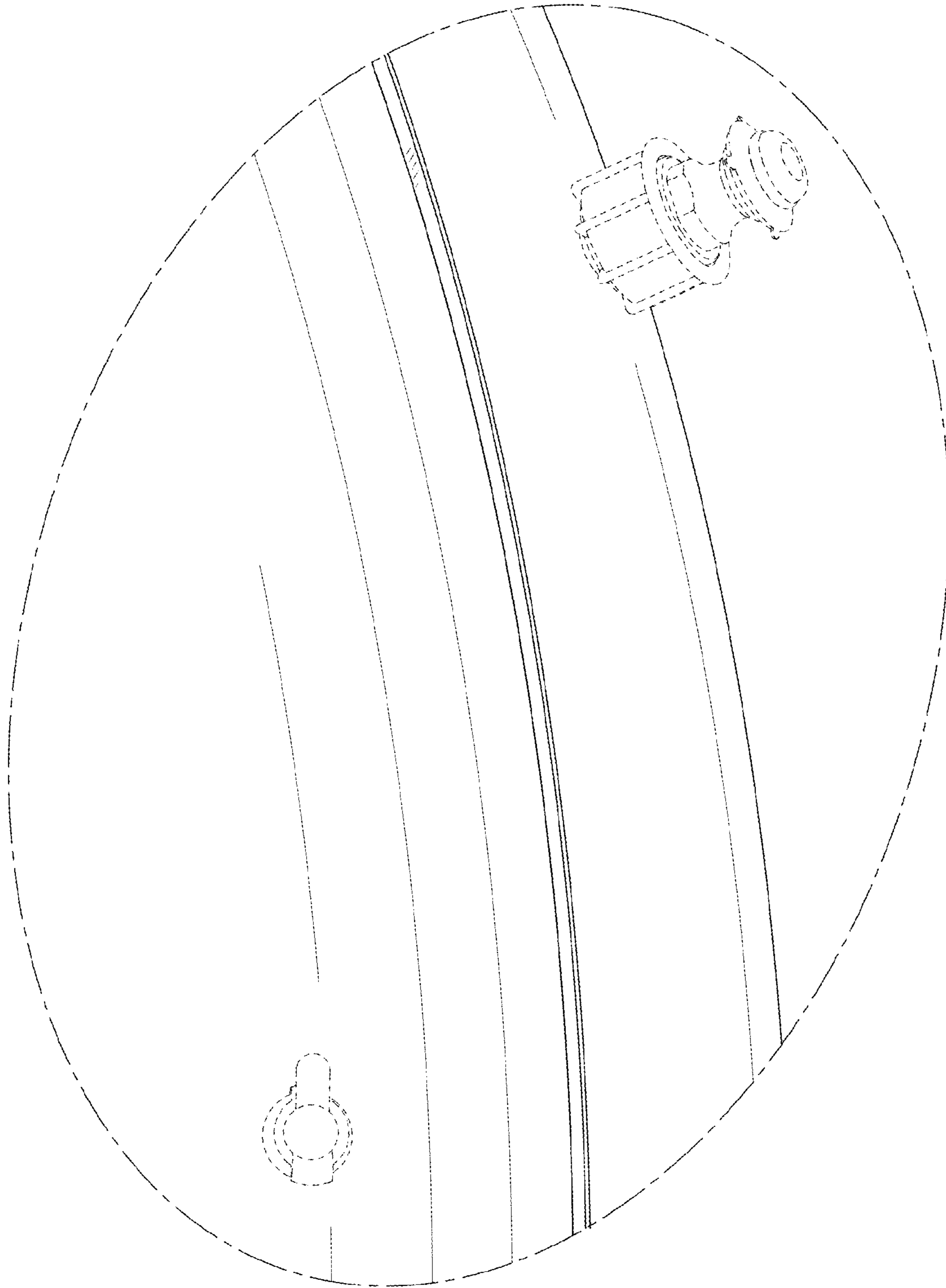

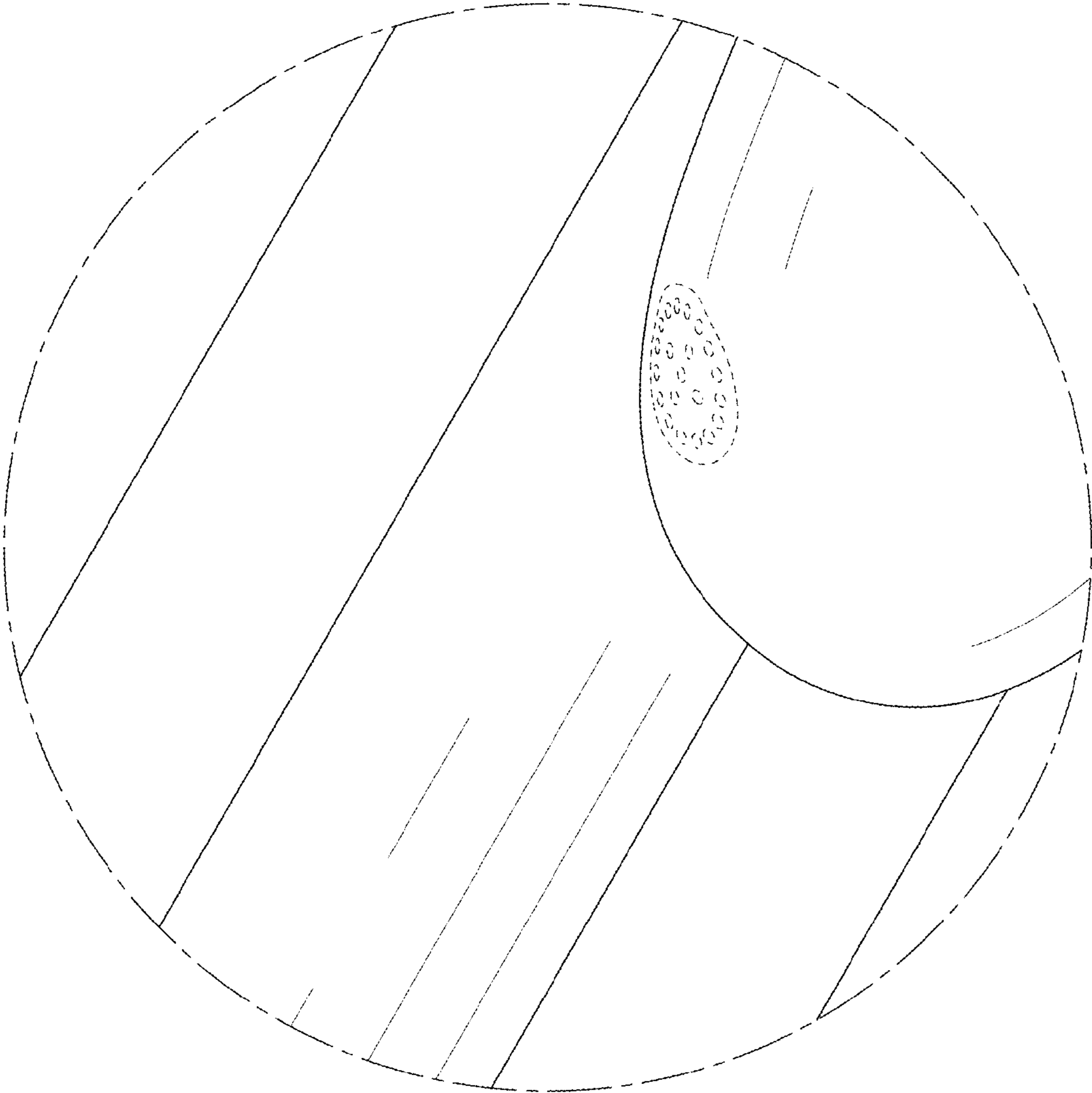
