DESCRIPTION

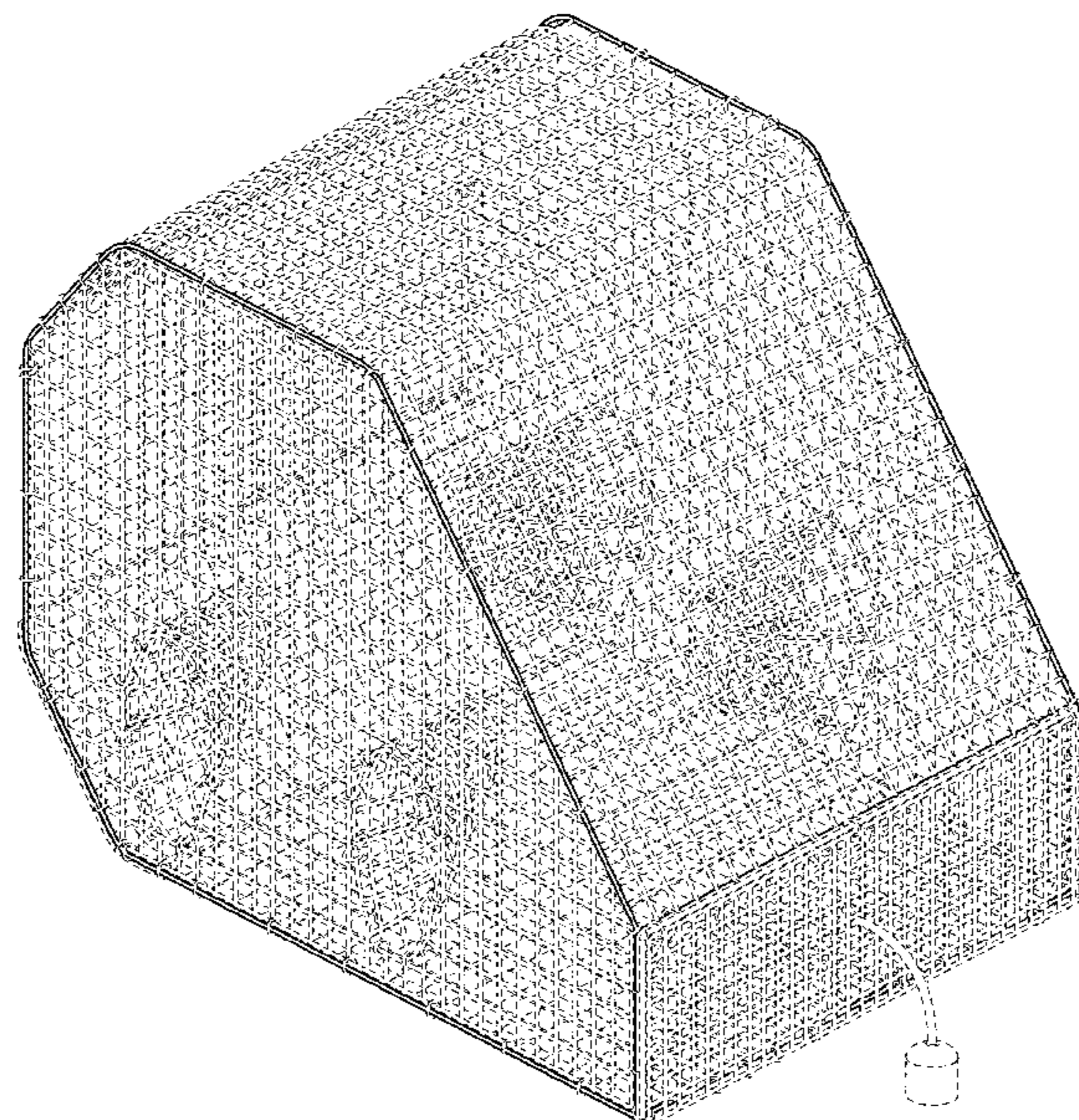
FIG. 1 is a perspective view of a crawfish trap of our new design.

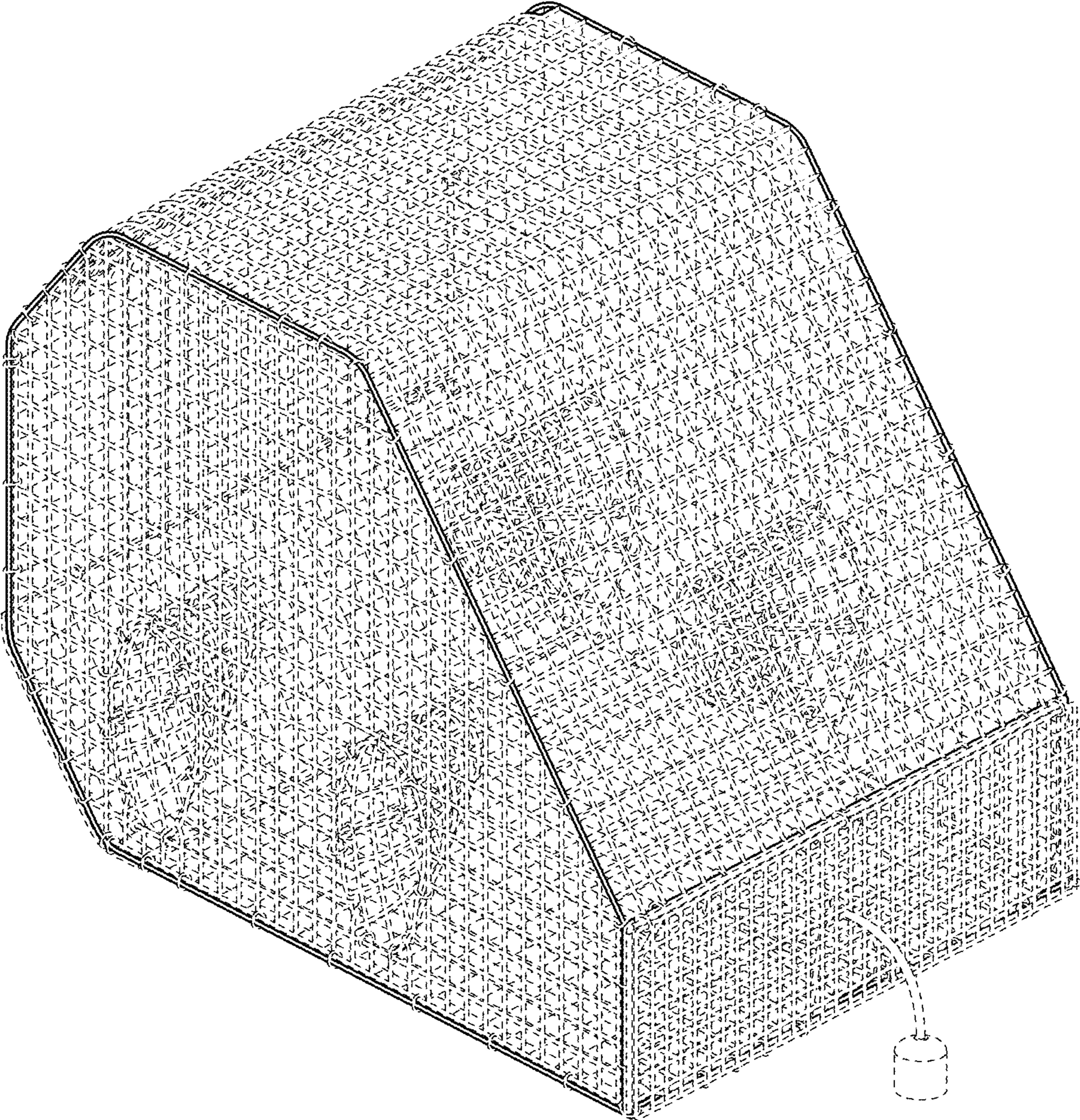

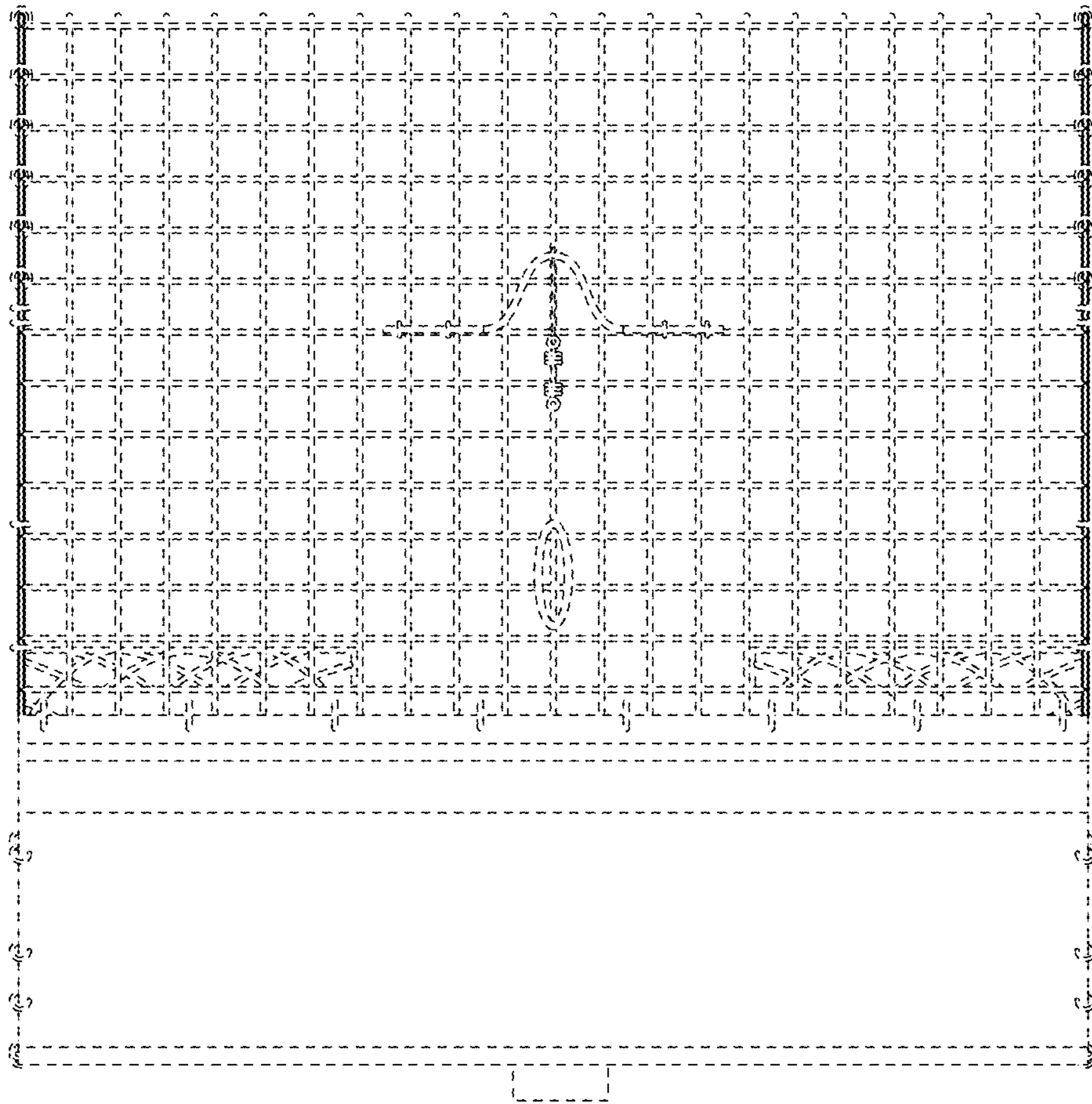

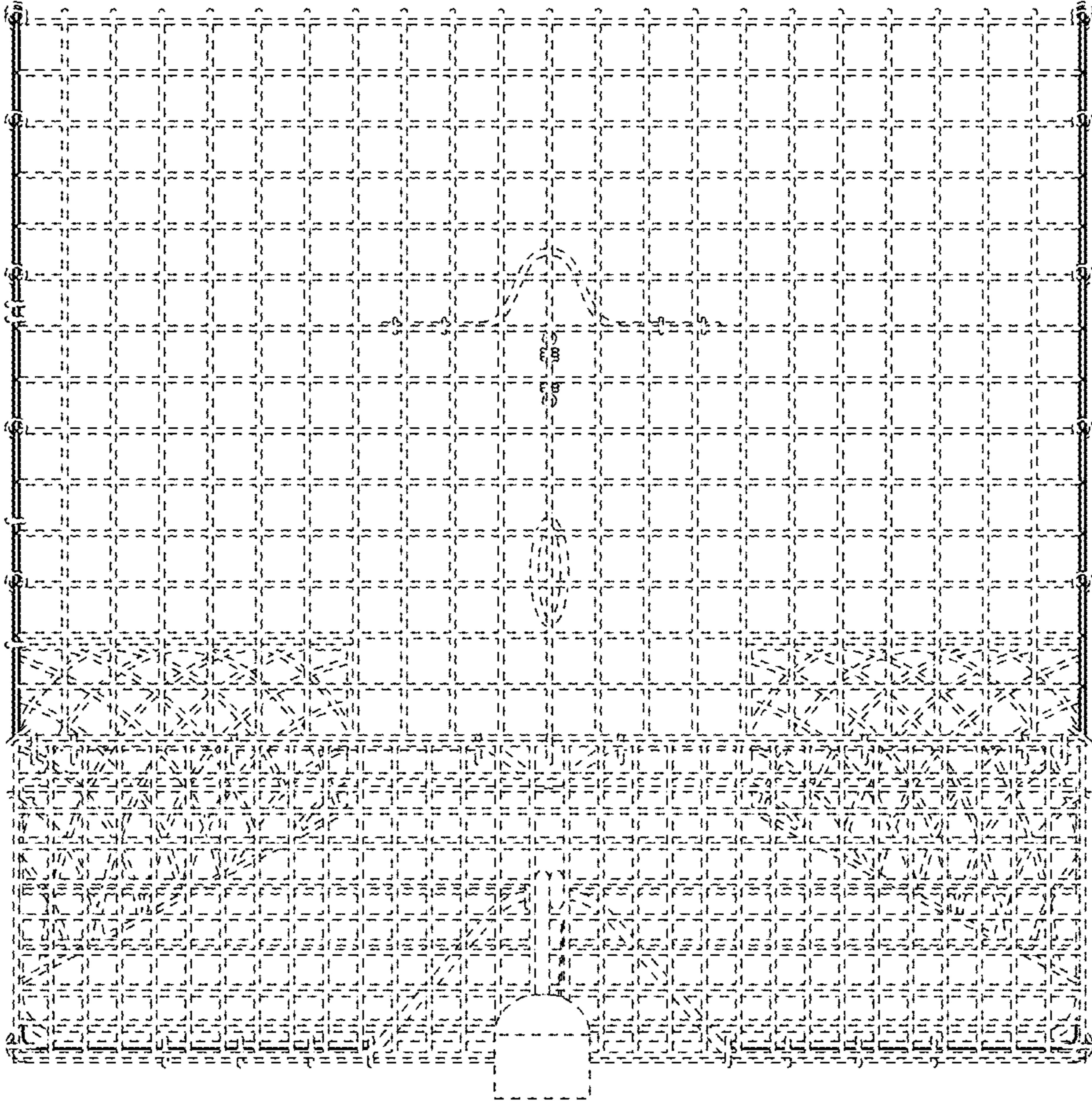

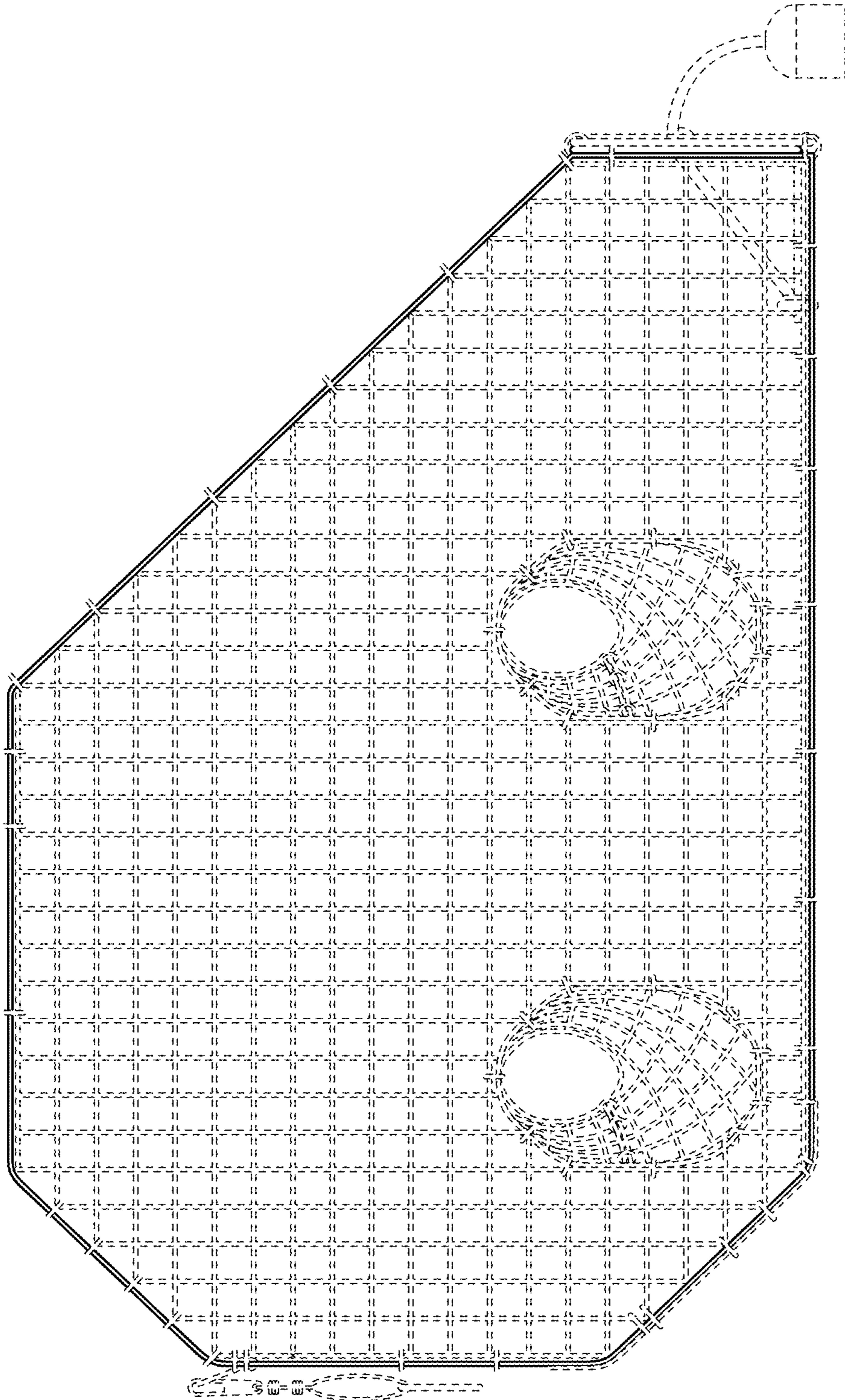

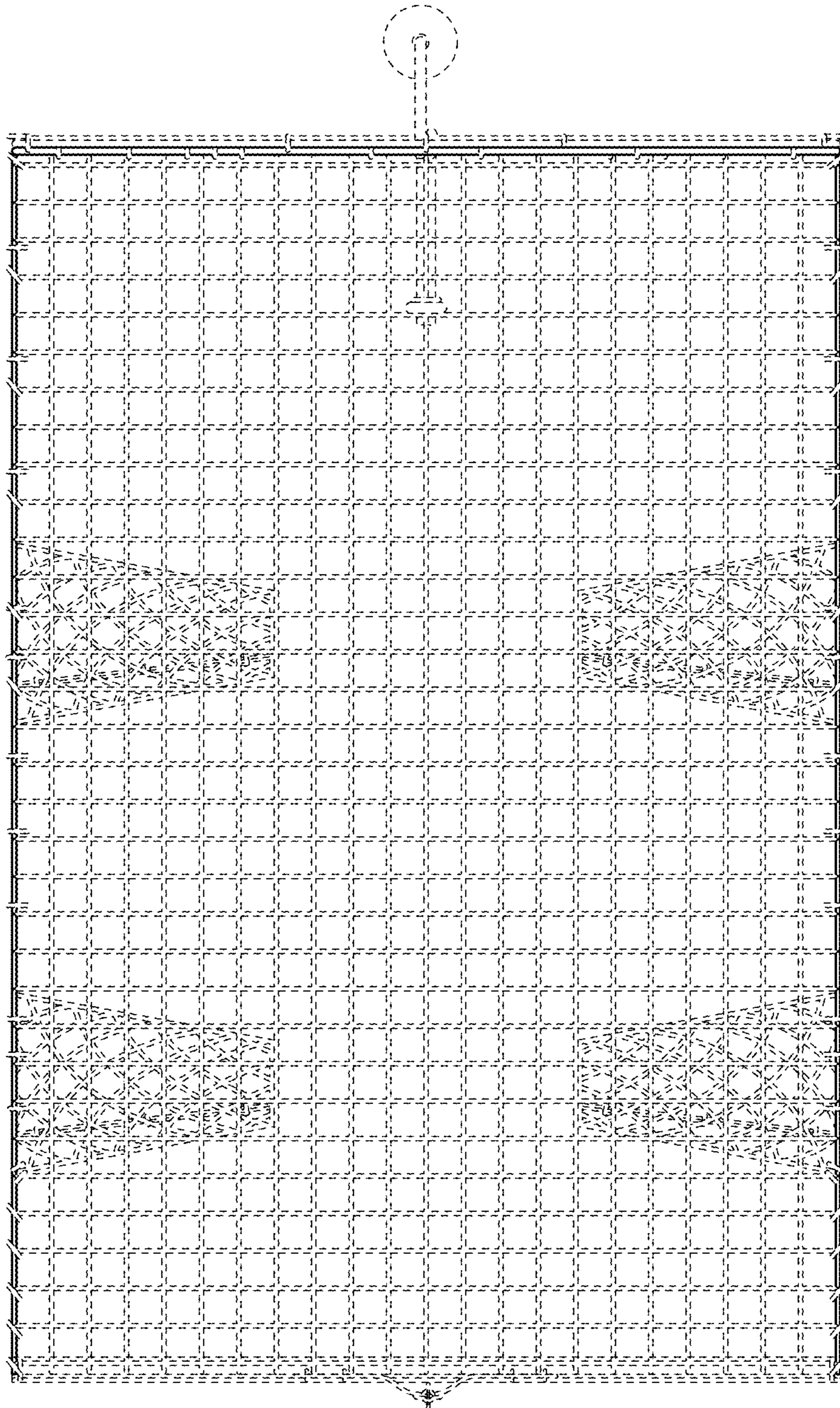

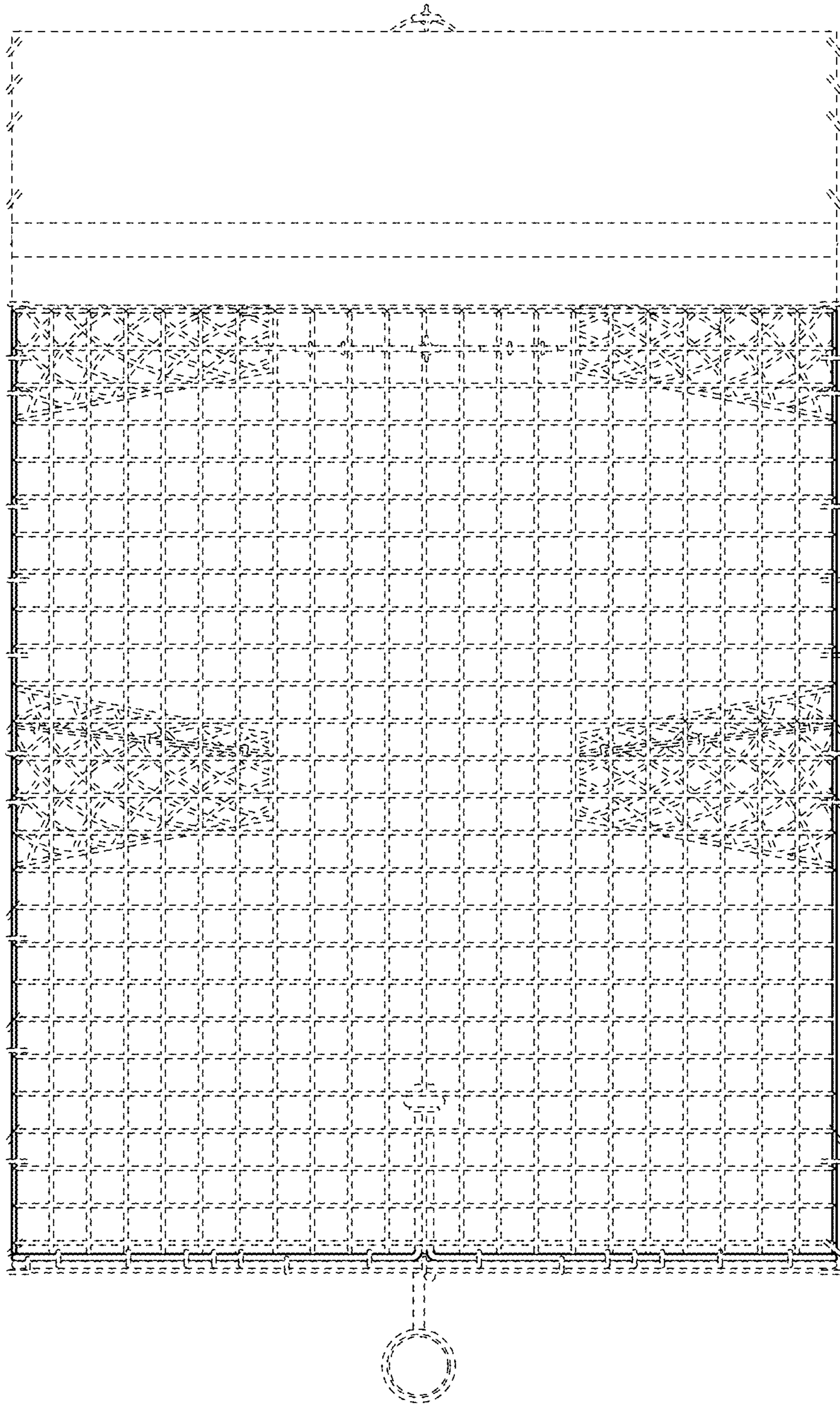
