(57) **CLAIM**

The ornamental design for a sink drain hair catcher, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a sink drain hair catcher according to the present invention and shown in an exemplary environmental installed over a sink drain;

FIG. 2 is a top perspective view of the sink drain hair catcher of FIG. 1;

FIG. 3 is a front side elevation view of the sink drain hair catcher of FIG. 1, the rear side elevation view, left side elevation view; and right side elevation view are identical to the front side elevation view;

FIG. 4 is a top plan view of the sink drain hair catcher of FIG. 1;

FIG. 5 is a bottom plan view of the sink drain hair catcher of FIG. 1; and,

FIG. 6 is a bottom perspective view of the sink drain hair catcher of FIG. 1.

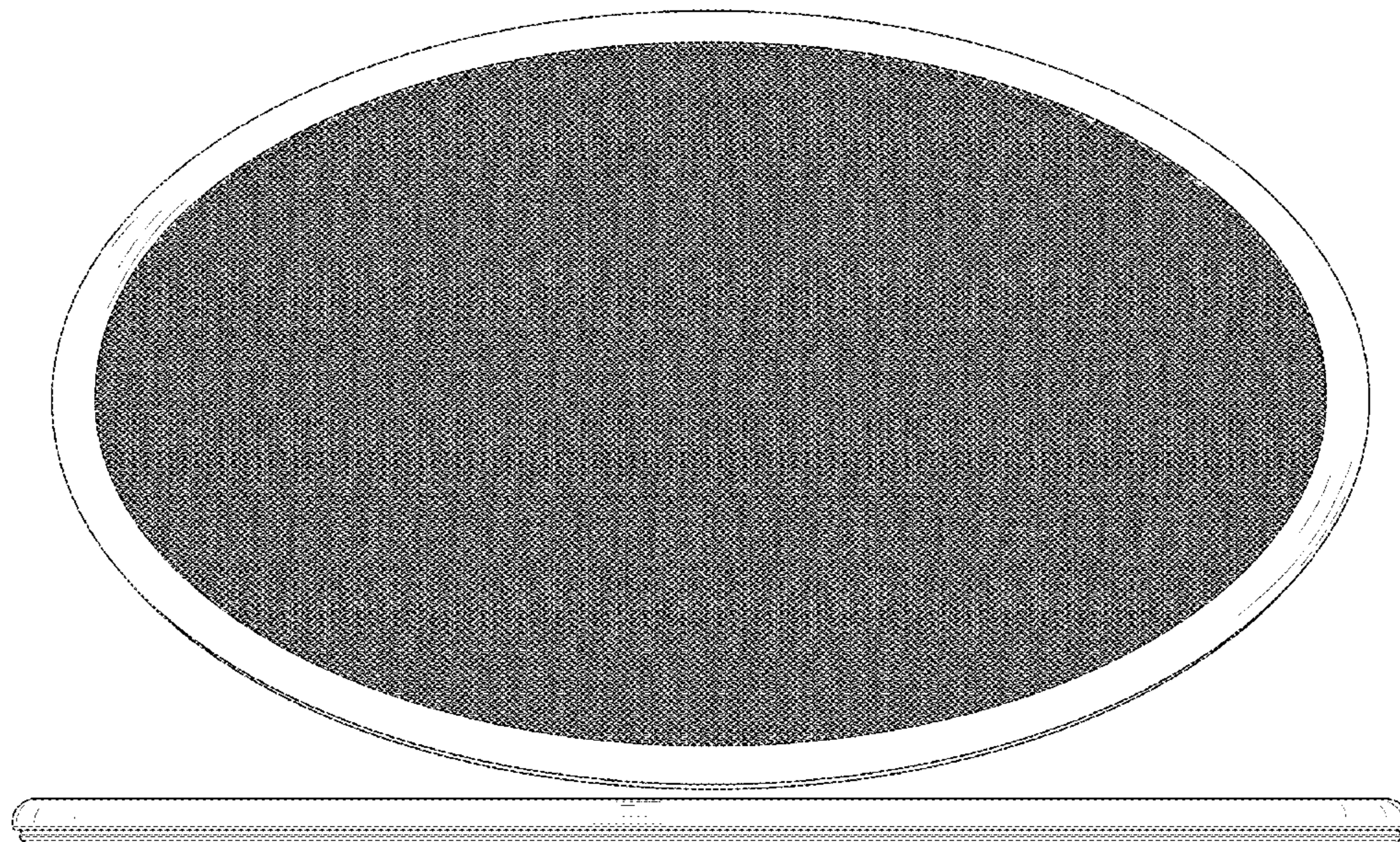

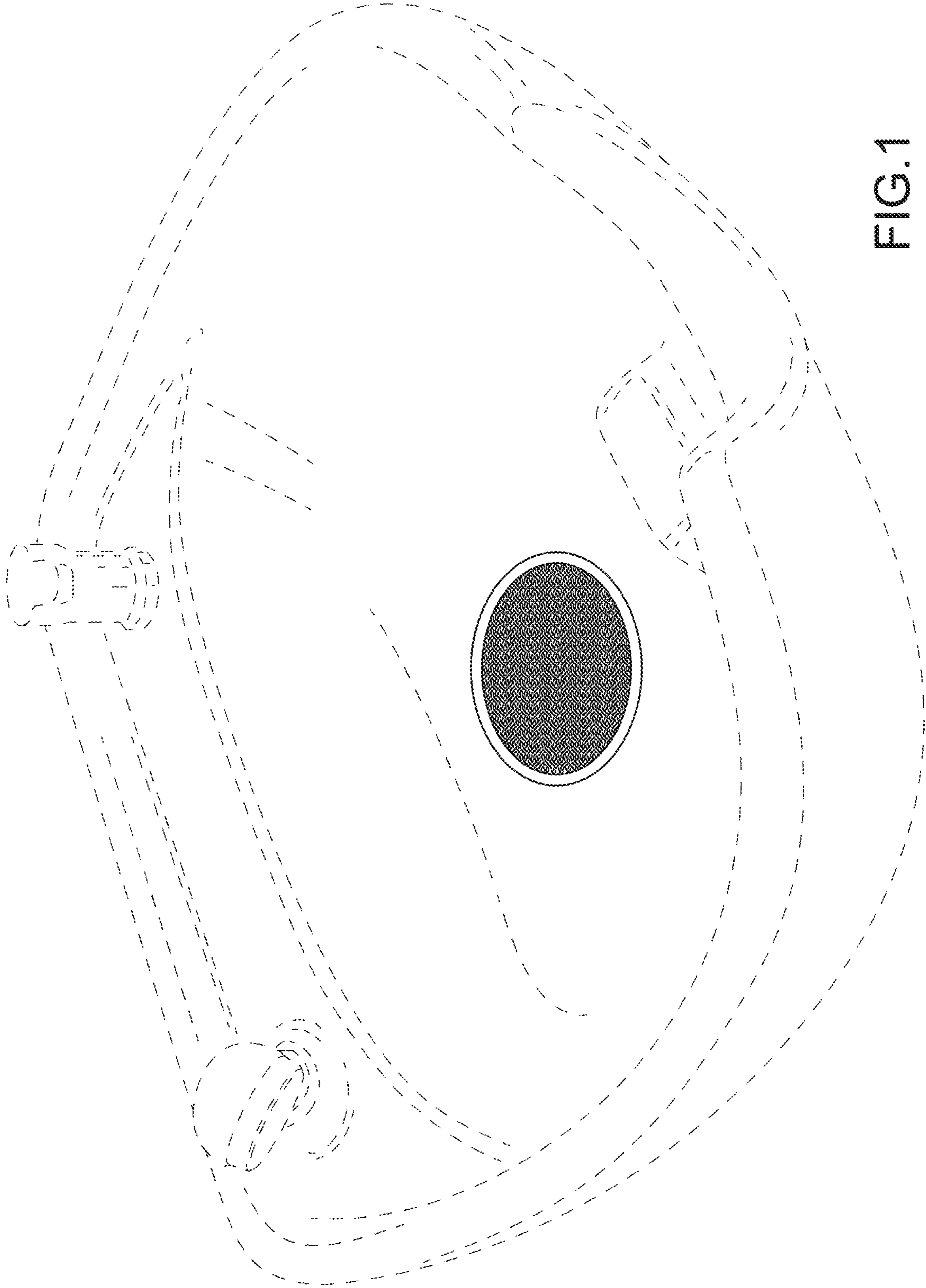

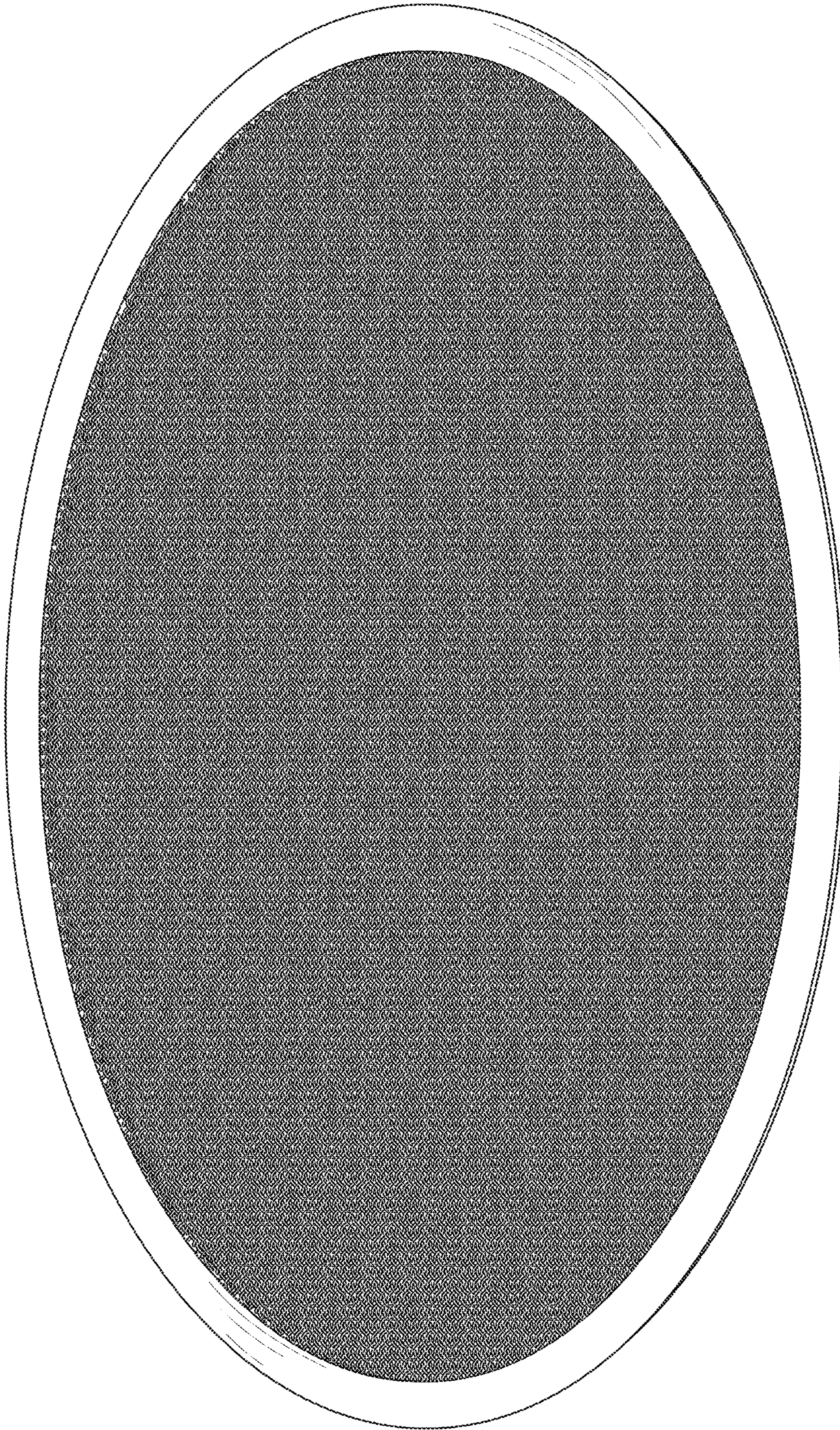

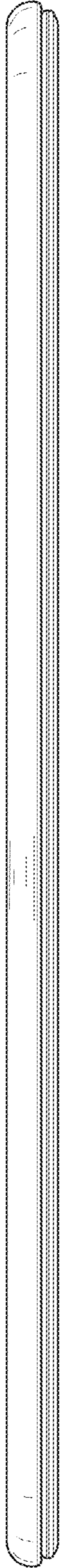

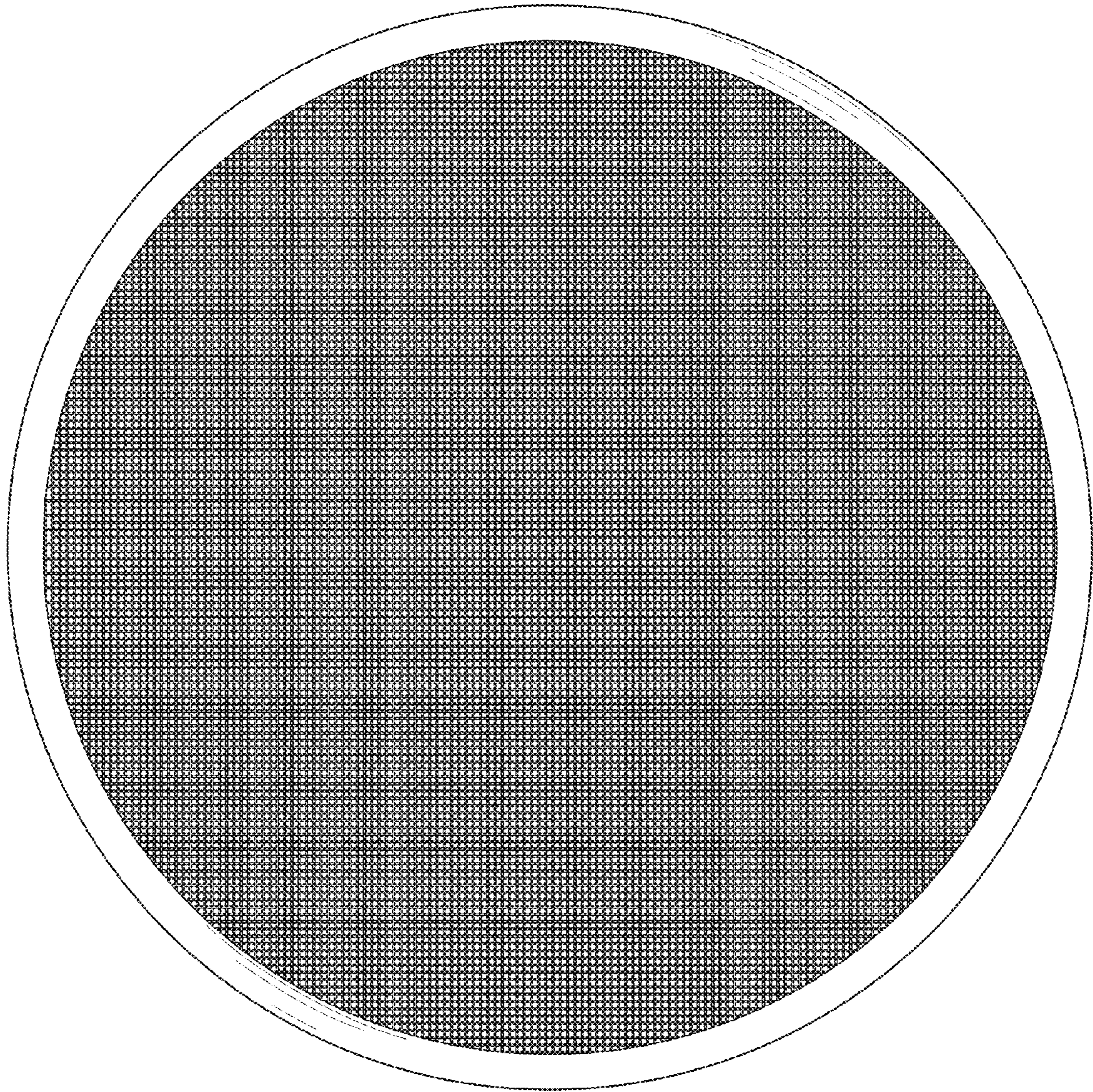

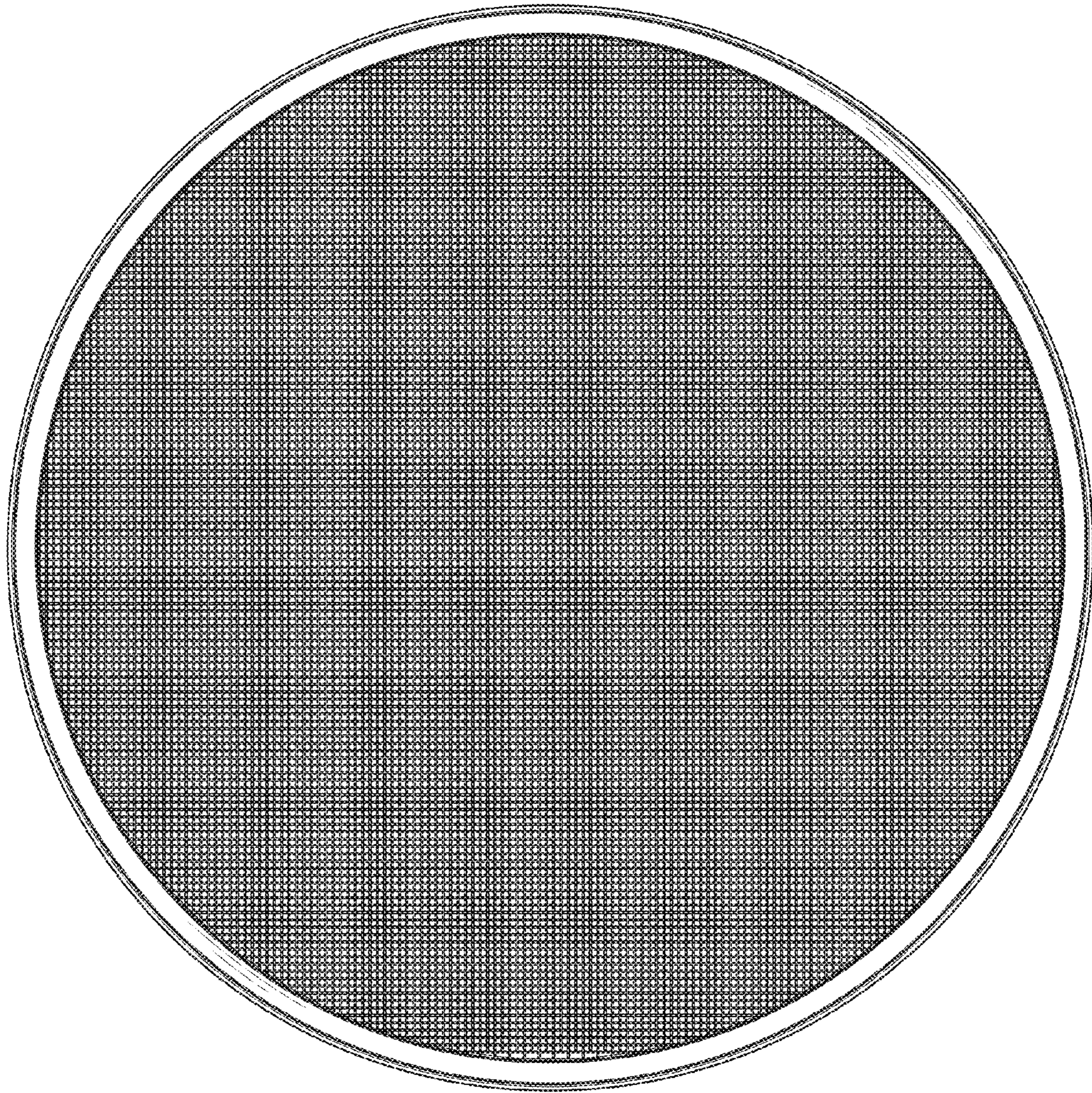

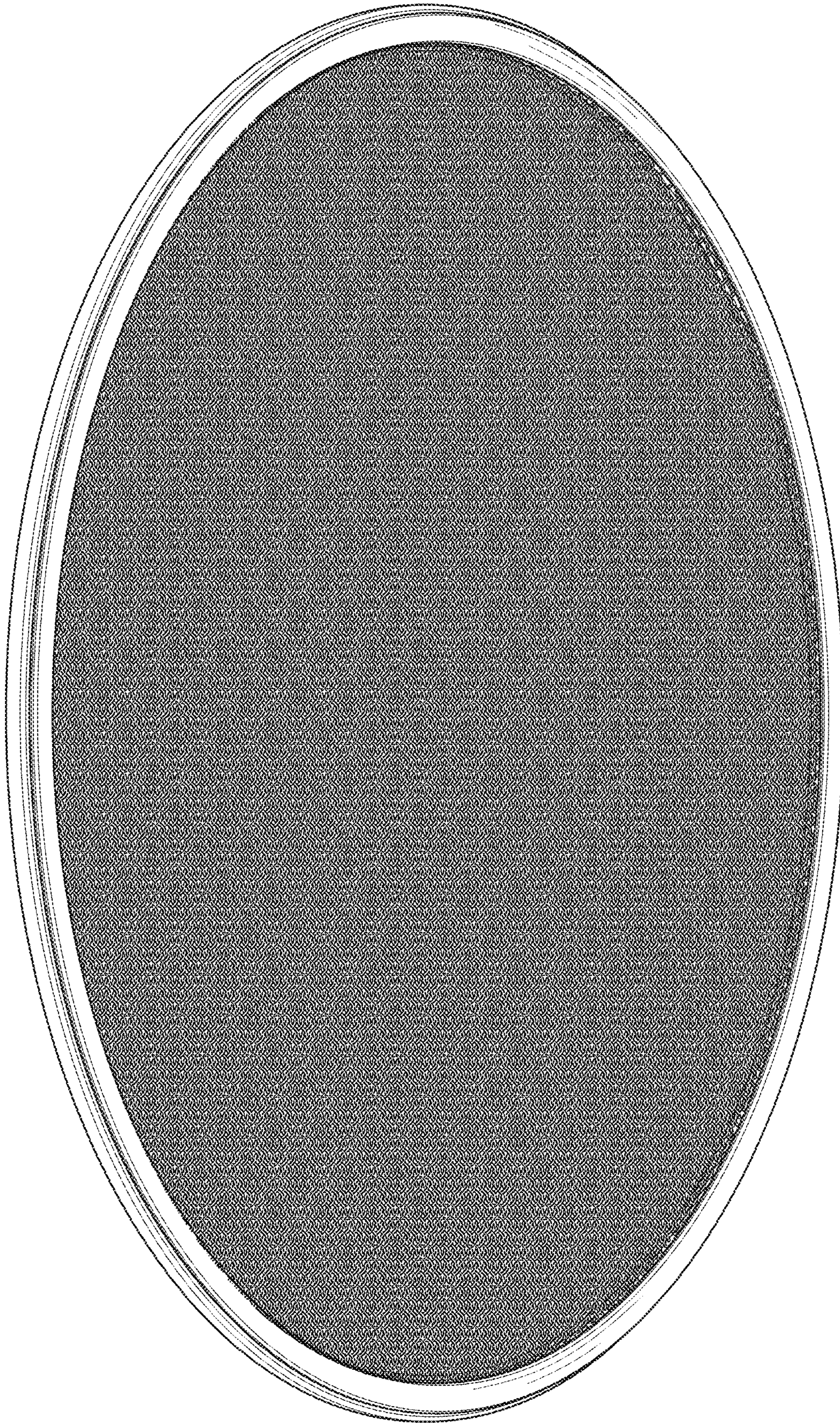
